Police responded to a serious two-vehicle collision occurred on the morning of Saturday, 7 September, in East End. The two occupants of one vehicle have been confirmed dead while the driver of the other was not injured.

The serious two-vehicle collision which occurred shortly after 3:00 on

Saturday was on Sea View Road in the vicinity of High Rock Drive, in East End, and involved a car and a truck. The two occupants of the car were found unresponsive and the driver of the truck was not injured.

Cayman Airways successfully diverted to Orlando International Airport

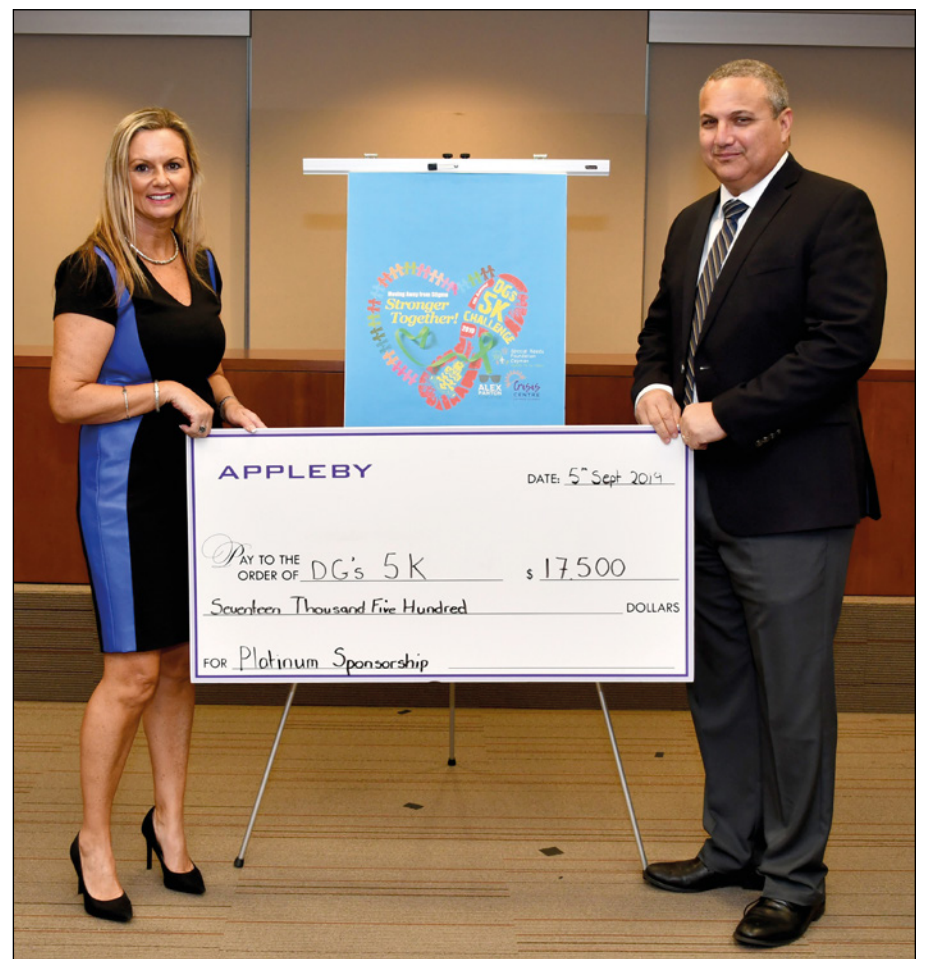
Cayman Airways Limited (CAL) has confirmed that flight KX792 destined to New York (JFK) from Grand Cayman on Sunday September 8, 2019, was diverted to Orlando International Airport (MCO) following a smoke indication in one of its cargo holds.

The Flight, under the command of Captain Frederick Whorms and assisted by First Officer Adrian West, departed Grand Cayman for New York (JFK) on schedule at 3:30pm (EST); approxi-

EDITORIAL

Improving Standards in Our Schools

When we think of schools our minds often focus on excellent leadership from our Principals, good teaching and teamwork from our teachers, the ethos and "climate" that makes a school feel welcoming, the safety and well being of our students and, significantly, how our students are performing in their learning.

The recent annual report published by the Office of Education Standards focuses on these matters. It is a well presented, very readable document which zeros in on both strengths and weaknesses of several government and private schools including some pre-schools.

The fact that the Ministry of Education is willing for these findings to be shared publicly indicates its willingness to continue to aim for improvements in all schools and to celebrate successes in the education sector. Indeed, the Minister's opening statement refers to nurturing sustainable relationships that will positively impact education. This approach is vital.

Some schools and parents will feel pleased with the results. Others inevitably will feel concerned that there is still much to be done. This fact should now drive each and every school to identify its strengths and weaknesses and seek to address these findings, improving where there are needs and building on successes.

Sound teaching and learning and educational achievement are the business of schools. Good practice, excellent curricula and sound guidance must be their aim. It is not always easy to understand and quantify when a

student is "turned on" to learning but we all know who or what inspired us in our past. Now we are also aware that the early years are critical to student learning and success.

Children the world over are naturally very inquisitive. As parents do we take the time to answer the questions that they ask us about the world around them? The role of the community is also a vital link. Do we visit libraries and museums and promote a culture of learning in our homes? Do we use our elders and the expertise of seniors to help build links with our culture and religious heritage? These all play a supportive role in educating our youth and developing their critical thinking skills, moral education and literary appreciation.

Often we are told to look for "low hanging fruit" which we can grasp and see immediate effects. This will have a positive effect on a school. However, the big issues such as literacy, numeracy, science, the arts, physical education and technology are all critical to student learning and can sometimes take more time to develop, review and refine.

Schools need to continue to look at good practice in other schools. They can borrow successful teaching strategies and share excellence. This report should also be a continuing point of greater collaboration for all schools.

Students, teachers and parents as well as the Caymanian community are all part of a school's success. At the start of this school year we must all aim to make Cayman's schools our nation's pride. 🌐

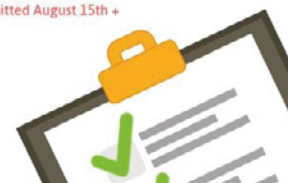

THE HORNS OF A MORAL DILEMMA

Have you heard of Euthyphro? No; that's neither a country nor a newly discovered planet. It is the name of a character in the writings of the ancient philosopher Plato. Picture this scene: Socrates is waiting outside of the Athenian court building to face trial for supposedly leading the youth of Athens astray when he encounters Euthyphro who is looking forward to his day in court for an entirely different reason; he's going to court to seek the death penalty for his own father. The dialogue between these two has produced for us one of the most profound questions — actually considered by philosophers as a dilemma — in debates and discussions of ethics and morality. The question is this (now put on your thinking cap and digest this slowly): Are right actions right because God commands them, or are right actions commanded by God because they are right? This was the question posed to Euthyphro by Socrates. Do you see the subtle but important difference here? If we go with the first option, that some actions are right simply because God says they are right, we may find ourselves accusing God of being arbitrary in determining what is right and what is not right. On the other hand, if we conclude that right actions are commanded by God because they are right, that would suggest to us that God is not the final authority in matters of values, ethics and morality, but just like us, he in some way has discovered what is right and has passed that on to us.

— is the conviction that the character of God as revealed in the Bible, as well as his nature as revealed there, leads us to believe in a God who is completely good in his being (character) as well as omniscient in nature. In other words, we would accept that the God of

the Bible is not a capricious God who arbitrarily sets down moral rules simply because he can, but that the rightness of his commands are based on the fact that they are objectively good and right, independent of how individuals or cultures may feel about them. To put it simply, most Christians would conclude that right actions are exactly that because God commands them, and that this is because God himself is good and therefore only commands what is good. Of course there are those who will argue against this; this is why the question is referred to as the "Euthyphro dilemma".

The relevance of this "thinking point" is to draw our attention to the fact that we are living in a culture that apparently has chosen neither horn of this dilemma, but instead have promoted themselves as the final arbiters as to what is right and wrong. The end result of this approach to ethics and morality is a sort of moral relativism that rejects not only religion as the basis for right and wise actions, but rejects reason itself as the basis for decision making. For example, whereas marriage was based on the self-evident reality of human heterosexuality, a fact that even the most primitive human understood from the textbook of nature, today we are faced with the arbitrary notion that marriage can be whatever one wants it to be. Forget religion, science and nature. Right is what we want it to be! What is most disheartening about this approach to morality is that this delusory approach to community life is fast gaining approval and legislative approval in western cultures.

This leaves me with the task of revising the "Euthyphro dilemma" to fit today's moral chaos: Are right actions right because the Courts command them, or are right actions commanded by the Courts because they are right? (Pastor Alson Ebanks) 🌐

Obviously, this dilemma has very long and sharp horns, so much so that we can't come anywhere near giving them justice in this little essay. But it does lead us to think about why we believe what we believe about what is right and what is wrong. Are there objective or absolute grounds for deciding what is right; or are values, morals and ethics entirely up to each individual or each culture? And if the latter is the case, whose morals should we then follow; or is it "every man for himself" as we used to say?

Clearly one of the things that those who opt for the first choice in this dilemma has going for them — at least from the Judaeo-Christian perspective

mately an hour and a half into the flight, an emergency was declared following a warning light indicating the presence of smoke in one of its cargo holds; the aircraft landed safely at MCO at 6:17pm (EDT).

With the uncertainty of what was causing the indication, the 103 passengers on board and 5 crew evacuated the aircraft through the emergency over-wing exits and the deployed door chutes/slides.

Emergency personnel, including paramedics, were on site to assist and treat passengers and crew if needed. All passengers and crew were cleared to the terminal without the need for further medical attention and were provided with accommodations and a replace-

ment flight has been arranged for Monday September 9, 2019.

Whilst an investigation is in progress, there is no evidence at this time of any actual smoke being present in the cargo hold.

"We are extremely mindful that this emergency landing and evacuation was a very distressing event," commented Cayman Airways President and CEO, Fabian Whorms. "On behalf of Cayman Airways, I offer a most sincere apology to our passengers for having to experience this emergency landing and evacuation, which was necessary in the interest of the safety of our passengers and crew. We have removed the affected aircraft from service indefinitely in order to accomplish the required repairs."

Due to the aircraft being removed from service some necessary changes were



made to the airline's flight schedule for Monday September 9, 2019, as follows:

- KX793, scheduled to depart JFK at 8:45am will now depart at 7:30pm.
- KX2606, scheduled to depart GCM at 6:05pm will now depart at 10:10pm
- KX2607, scheduled to depart KIN at 8:10pm will now depart at 12:10am
- KX200/201 will now be operated on Tuesday, September 10, 2019 instead.

All other flights are expected to operate on schedule. Passengers on affected flights will receive updates on their new flight times via email and text messages.

Registrar Speaks to NPOs on AML/CFT Risks

The Registrar for NPOs (non-profit organisations) addressed dozens of charitable organisations on their money laundering, terrorist financing, targeted financial sanctions and proliferation financing risks at an information session on Thursday, 5 September at the Government Administration Building.

Last Thursday's meeting also featured presentations from other Government agencies, namely the Anti-Money Laundering Steering Group, the Financial Reporting Authority and the Financial Crime Investigations Unit within the Royal Cayman Islands Police Service.

'Based on their unique purposes and activities, these NPOs were invited in for this targeted outreach session to educate them on these risks', said Paul Inniss, the Head of Compliance at General Registry.

'This session will help these NPOs to fulfil their administrative duties in compliance with local laws and global standards for anti-money laundering, countering the financing of terrorism, targeted financial sanctions and proliferation financing', he said.

Mr Inniss facilitated the session, alongside Ben Evans of Financial Transparency Advisors (FTA). The Ministry of Financial Services has contracted FTA to assist with Cayman's preparations for

the 2020 CFATF (Caribbean Financial Action Task Force) review of Cayman's anti-money laundering and counter terrorist financing regime.

Government is working to address the Caribbean Financial Action Task Force (CFATF)'s March 2019 assessment of Cayman's AML/CFT regime. The report outlines certain recommended actions to be taken by the Cayman Islands to strengthen the AML/CFT regime. The jurisdiction is under a one-year "Observation Period" by the FATF, ending Feb-

ruary 2020, in which it is expected to correct strategic AML/CFT deficiencies. The FATF will review the progress made by the Cayman Islands and, at its June 2020 Plenary, determine if the recommended actions have been taken.

As of 1 September, there were more than 450 churches, sports clubs, philanthropic organisations and communi-

ty groups registered with Government. These entities, more typically referred to as charities, fall within the scope of the Non-Profit Organisations Law, 2017. The law was enacted in accordance with international standards to strengthen the Cayman Islands' regime to counter money laundering and terrorist financing. 🌐

Man Charged with Aggravated Burglary After Being Detained by Occupants of Residence

Shortly after 3:00AM on Tuesday 3rd September, officers were dispatched to a report of a burglary at an address off Smith Road, George Town. A man had entered the residence and was discovered by the occupants. The

man attempted to flee but was caught and detained by one of the occupants, who held him until the officers arrived. Several items were recovered from the man, including a knife and drug utensil.

The man, age 39 of George Town, was arrested and has been formally charged with Aggravated Burglary, Consumption of Cocaine and Possession of a Utensil Used in the Consumption of Cocaine. He is appearing in court tomorrow morning, 5 September.

The occupant of the house sustained minor injuries while detaining the man and was transported to the Cayman Is-

lands Hospital for treatment and subsequently discharged.

Detective Superintendent Peter Lansdown of the RCIPS Criminal Investigations Department says, "While we always urge members of the public to exercise caution and avoid putting themselves in harm's way in situations such as this, we wish to acknowledge the homeowner for his courageous actions during this incident." 🌐

Man Arrested for Resisting Arrest & Assaulting Police Following Single-Vehicle Collision

At about 1:00AM on Sunday, 1 September, officers conducting patrols on West Bay Road in the vicinity of Governor's House observed a vehicle travelling at a high rate of speed towards West Bay. Officers attempted to follow the vehicle but soon discontinued due to the rate of speed at which it was travelling. The officers resumed normal patrol duties, and, a few minutes later, came upon a single vehicle collision on Yacht Drive, just off the Yacht Club Roundabout. It was discovered that the vehicle involved was the same one that the officers had observed earlier on West Bay Road. Officers spoke to the driver of the vehicle

and detected the strong scent of alcohol on his breath. As a result, the man was breath tested with a result of .131%.

Officers attempted to arrest the man, however he resisted and a struggle ensued. Officers eventually deployed pepper spray in an effort to subdue him, and were able to take him into custody. One of the police officers received minor injuries during the struggle, and was treated at the hospital along with the man. Both were subsequently discharged.

The man, age 23 of George Town, was arrested on suspicion of DUI, dangerous driving, resisting arrest, and assaulting police. He is currently on bail. 🌐

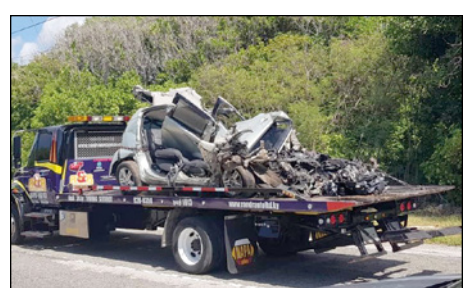

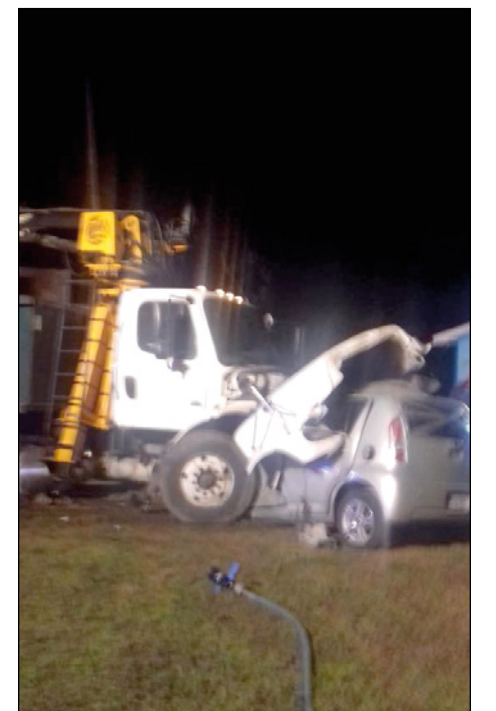
The Department of Environmental Health later confirmed that one of its vehicles was involved in that fatal accident.

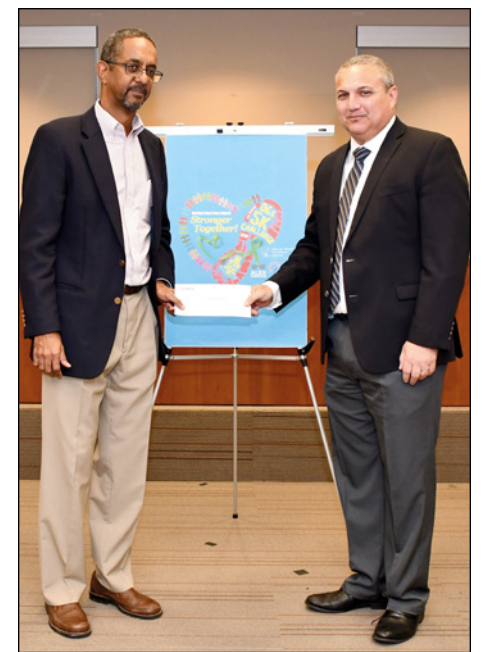

Trinbago Knight Riders have their sights set on making history in the latest series of the annual Caribbean Premier League. This is the seventh staging of the CPL and promises to be the most exciting. The Riders won their first two matches as did last year's runners-up Guyana Amazon Warriors.

The Knight Riders - who opened the defence of their T20 crown against St Kitts & Nevis Patriots - are bidding to secure an unprecedented hat-trick of titles.

An all-round show by New Zealander Jimmy Neesham helped the Riders beat the Patriots in the first match at Queen's Park Oval, Port of Spain, Trinidad last Wednesday.

Batting first, Knight Riders scored 152 for 7 with captain Kieron Pollard top-scoring with 47 off 32 and Neesham and Denesh Ramdin scoring 33 each. Neesham then picked 3 for 18 from 2.4 overs to bowl Patriots out for 141 in 19.4 overs, sealing victory by 11 runs.

It was a comfortable win for the Riders who beat the Jamaica Tallawahs by 22 runs in their second game. The War-

riors beat St Lucia Zouks by 13 runs in their first game and then St Kitts & Nevis Patriots by eight wickets.

Here's an outline of the star-studded teams in the CPL that runs for another five weeks.

Barbados Tridents

Last year: Sixth

The Tridents, who finished bottom of the table in 2018 after winning only two of their fixtures, hope for better fortunes. On paper, they should certainly do better - the squad includes West Indies skipper Jason Holder, along with versatile wicketkeeper-batsman Shai Hope and left-arm quick Raymon Reifer. England batsman Alex Hales should add some explosive power at the top of the batting order, while the overseas contingent also includes Pakistan pacer Wahab Riaz and Nepal leg-spinner Sandeep Lamichhane.

Guyana Amazon Warriors

Last year: Runners-up

Still seeking their first title after finishing second twice in the past three years, the Warriors will again look to Shimron Hetmyer to lead their challenge. The West Indies left-hander was the tournament's third-highest run-scorer last season, hitting 440 runs at an average of exactly 40, and he is joined again by international team-mate Nicolas Pooran.

Of the overseas contingent, Pakistan all-rounder Shadab Khan lines up for Guyana, along with experienced compatriot Shoaib Malik and Australia's Chris Green, who returns after taking 10 wickets for the Warriors in 2018.

Jamaica Tallawahs

Last year: Fourth

Chris Gayle was one of the main factors behind Jamaica's two previous title victories - so they will

Last year: Third

Despite the departure of Gayle, the Patriots have another T20 titan stepping up to take over the captaincy in Carlos Brathwaite, who put in some memorable performances at the 50-over World Cup earlier this summer. Fast bowler Sheldon Cottrell, who picked up 11 wickets in last year's tournament, will send several more batsmen on their way with a military salute, assisted by West Indies team-mate Alzarri Joseph. South Africa's Rassie van der Dussen returns to the Patriots for a second season and the batting line-up should also be strengthened by the inclusion of hard-hitting Sussex batsman Laurie Evans.

Trinbago Knight Riders

Last year: Winners

Dwayne Bravo leads the defending champions - who certainly look like the team to beat again - with a line-up that also includes his brother Darren and Pollard, who averaged 47 for the Stars last season. New Zealand opener Colin Munro amassed more runs in last year's tournament - 567 - than anyone else and, although he misses the first three games due to international commitments, the Knight Riders have drafted in Lendl Simmons as his replacement.

hope the great entertainer can inspire a return to glory after persuading him to return home from St Kitts & Nevis. With the line-up also including another T20 veteran in Andre Russell and exciting young West Indies bowler Osane Thomas - who took 18 wickets last season - there should be no shortage of entertainment. New Zealand's Glenn Phillips, who scored more runs than any other Tallawahs batsman in 2018, returns alongside fellow Kiwi George Worker and Afghanistan left-arm spinner Zahir Khan.

St Lucia Zouks

Last year: Fifth

The Zouks, who competed in the tournament until 2017, are back as the result of a falling-out between the league organisers and the owners of their replacement franchise, the Stars. Neither of the St Lucia teams has ever won the competition and their hopes of mounting a challenge this time will be pinned on the island's best-known player, all-rounder Darren Sammy. The Zouks also include West Indies' John Campbell and the eye-catching Rahkeem Cornwall, while Sri Lanka all-rounder Thisara Perera features along with New Zealand's Colin de Grandhomme.

Anthony: I'll take back up role

Carmelo Anthony's search for a new home in the NBA continues despite him finally admitting he does not mind starting on the bench.

The 10-time All-Star's game doesn't fit in today's league's current model of ball movement and three-point shooting, most pundits say, which is why Anthony at 35 is desperate to find a home.

The view is that Anthony would probably have to join a veteran team with a veteran coach and show a willingness to accept a certain type of role.

After the 2017-18 season with the Oklahoma City Thunder, Anthony announced he didn't feel like a bench role was something he had to accept: "When I feel like I'm ready to take that role, then I'll take that role. Only I know when it's best for me to take that role. I'm not going to do that in a situation where I still know my capabilities and what I can do."

Conor McGregor has challenged Khabib Nurmagomedov after the Russian's victory at UFC 242 on Saturday night.

Unbeaten Nurmagomedov beat Dustin Poirier in three rounds with a rear-naked choke to extend his record to 28-0. McGregor hasn't stepped inside the octagon since his defeat to Nurmagomedov last October.

But after the lightweight champ's win over Poirier in Abu Dhabi, McGregor posted a message on Twitter which read: "Book my rematch for Moscow."

Nurmagomedov retorted with a swipe at McGregor: "Me and Dustin Poirier have showed MMA is about respect not trash-talking," he said. "This fight had so much respect unlike my last fight with that b*****t guy."

The fight between Nurmagomedov and McGregor at UFC 229 last year was marred by events immediately after as both camps were involved in a brawl. Nurmagomedov received a ninth-month suspension plus a \$500,000 fine, while McGregor was banned for six months and fined \$50,000.

Joshua changes lifestyle to regain title

Britain's Anthony Joshua says he has made significant lifestyle changes since his shock defeat by Andy Ruiz in June.

Joshua lost his IBF, WBA and WBO heavyweight titles as he was knocked down four times before a seventh-round stoppage in New York - one of boxing's biggest upsets. The pair will fight again in Diriyah, Saudi Arabia on 7 December.

"Boxing was always the easiest part for me. The struggle was always keeping my life in check," Joshua, 29, said. "There will be no aftershock after the first fight. I will be smarter. Getting knocked down was good."

"I have made some drastic changes, lifestyle stuff. Family, circles, what is important, priorities. The effort it takes to stay on the straight and narrow is challenging."

The pair faced off last week during an international media tour for the rematch with Ruiz - who fights under a Mexican flag - wearing a sombrero throughout the news conference.

Joshua vowed to regain his titles and insisted "stopping isn't in my DNA". The bout has attracted criticism since it was announced it would be in Saudi Arabia.

Human rights organisation Amnesty International has highlighted the country's "abysmal" human rights record. Heavy restrictions on freedom of expression and women's rights have been raised, as has the use of the death penalty for offences not recognised as crimes under international law.

The Kingdom has sought to stage sporting and entertainment events in a bid to attract visitors and move away from its oil-dependent economy.
