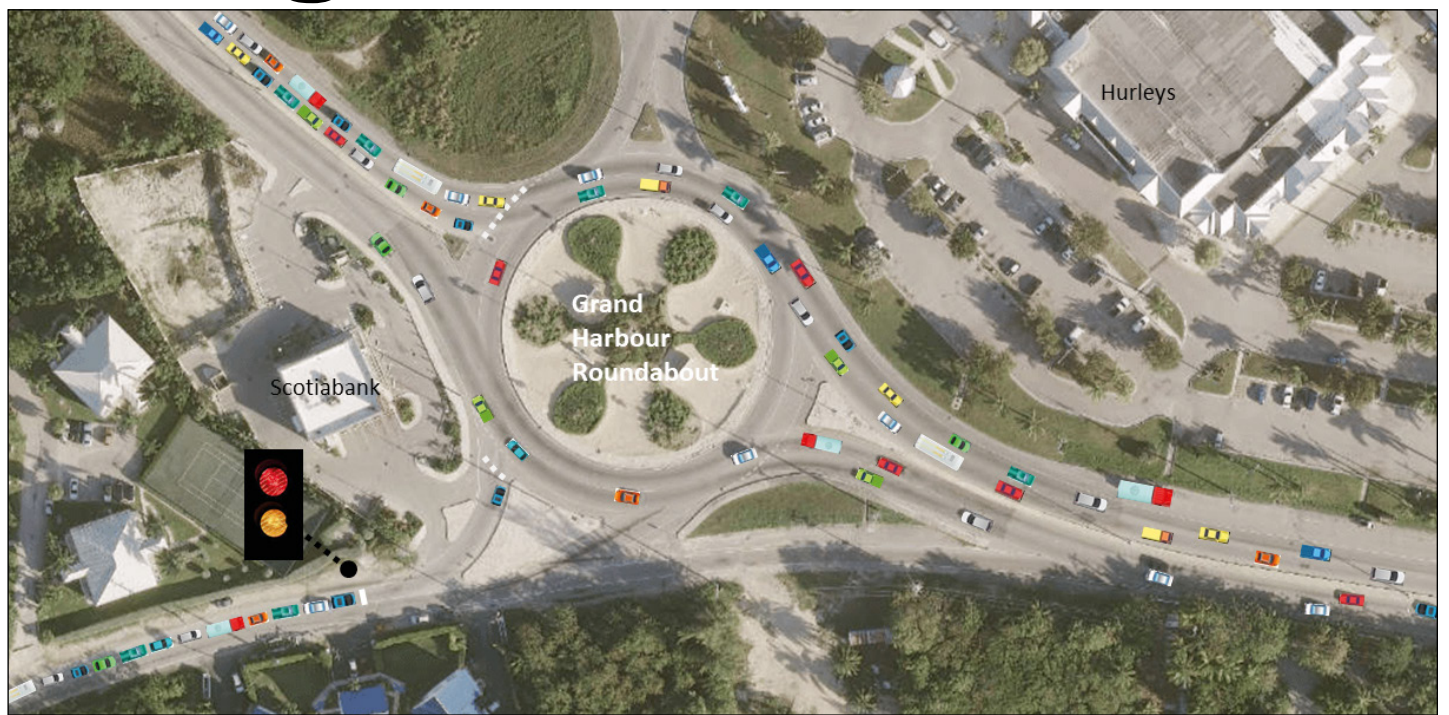
New Traffic Signal for South Sound

The National Roads Authority (NRA) will launch a traffic signal metering system in South Sound near Old Crewe Road, with the aim of easing traffic congestion on the Linford Pierson Highway during the evening peak periods.

The scheme is designed to regulate traffic flow at the Grand Harbour Roundabout, particularly during the evening rush-hour for commuters travelling east.

Since its construction in 2003, the Grand Harbour Roundabout has experienced significant traffic flow movements. NRA traffic counters recorded upwards of 40,000 vehicle trips per weekday along the main highway by Grand Harbour Development in 2018. During that same year, an average of 4,821 vehicles was recorded travelling eastbound through the Grand Harbour Roundabout in and around the 4:30 p.m. to 6:30 p.m. window.

The increased evening traffic is presenting the NRA with a new challenge. At present, motorists travelling east from single lane South Sound Road onto the roundabout have priority over motorists using the two eastbound travel lanes on Crewe Road. This forces them to give way to the right, creating traf-

fic queues extending back onto Linford Pierson Highway.

Because the resulting tailbacks cause delays to commuters on the main carriageway, the NRA will install a metering system on South Sound Road, which will

control the flow of traffic on this artery. This will enable an increased movement of traffic from the dual carriageway on Crewe Road onto the roundabout.

“The traffic meter is going to allow gaps in the eastbound evening peak

traffic flow on South Sound Road, that will in turn cause eastbound traffic on the main artery to flow through Grand Harbour Roundabout much faster,” says

After years of discussion, hard work and negotiation, last week the government announced that it had selected a preferred bidder to construct the cruise berthing facility and enhanced cargo dock in George Town.

The government was clear throughout this process that they would release details to the public at the earliest opportunity. Now that the preferred bidder has been selected, the need for strict confidentiality has ended, giving way to the announcement of the finer details and the project cost.

Following careful analysis of the options included in the proposal by the Ministry of Tourism, Port Authority, the Major Projects Office and industry partners and after approval by the Central Tenders Committee, the preferred

CI:GO App Available for Download

The Ministry of District Administration, Tourism and Transport is pleased to announce its new digital taxi fare calculator, CI:GO, is now available for download from the App Store and Google Play. The app can be found by typing "CIGO" or "Taxi Fare Cayman" in the search bar of the respective phone stores.

This free mobile app is a simple way for residents and visitors to quote their journey in advance. CI:GO allows users to drop a pin or enter the pickup and drop-off location of an intended ride, then specify the number of passengers and how many pieces of luggage. Based on the information provided, the app will calculate the fare in both KYD and USD dollars. Op-



tions include getting a breakdown of the fare, editing the trip, splitting the fare or getting directions.

All fares provided by the app are based on the newly introduced national taxi fare schedule that went into effect Friday 2 August at 12:01 a.m. The public is encouraged to provide feedback on the app as it is rolled out by clicking the feedback tab in the app.

bidder selected by government was announced to be a consortium called Verdant Isle Port Partners (VIPP).

VIPP comprises four companies in partnership and is led by local and trusted construction company McAlpine, marine engineering experts Orion Marine Construction Inc., and cruise industry partners Carnival Corporation and Royal Caribbean Cruises Ltd. Caymanians should know that together they offer considerable local and technical expertise and are familiar with projects of this nature and scale.

The bid that was selected by government comes in at CI\$196.5m and includes the enhanced and expanded cargo facility.

However, crucially the upfront cost of construction will be met entirely by the consortium, including any overspend that occurs. Government has offered no loans, issued no bonds and provided no guarantees to the Verdant Isle group. The total cost of constructing the cruise berthing facility and enhanced cargo facility – as well as the maintenance for 25 years – falls entirely on the consortium.

Verdant Isle will get their money over this time from a portion of the passenger fee that currently pays for tendering services. Passenger fees are paid by cruise lines for each individual passenger aboard. These fees are wrapped up in the cost of a cruise, in much the same way taxes are included in the cost of an airline ticket. What this means is that cruise passengers will be paying for the piers with the consortium merely advancing these funds for construction.

The deal that government has negotiated is certainly unique. It is rare for two cruise lines to join forces to build a single berthing facility and exceptional for cruise lines not to own or operate any retail space within the cruise terminal, which is the case in this instance. This is a win for Cayman!

But there are many other benefits. The planned facility will secure the future of the cruise industry in the Cayman Islands; it will protect the 4,500 jobs that are supported by cruise passengers; it will transform the George Town Harbour front and will finally put an end to Cayman's dubious distinction as the only Caribbean destination without berthing facilities.

CMEA takes Soca Monarch to CARIFESTA

Notch, whose legal name is Jean-Eric Smith is also the President of the Cayman Islands Music Association and is credited as being one of the progenitors of the Soca Monarch becoming a part of the CARIFESTA delegation; a development that came as a result of the CMEA working together with the Cayman Carnival.

Mr. Smith explained the importance of having our Soca Monarch as part of Cayman's musical offering.

"As you may know, the Soca Monarch competition was actually started by the CMEA. Most countries in the Caribbean

IN PRAISE OF INTOLERANCE

Should the police tolerate those who abuse all the rules of road safety and courtesy? Should our schools tolerate bullying by either obnoxious parents or antisocial children? Should we continue to tolerate the degradation and pollution of our environment by those motivated only by greed? And is it now supposed to be a virtue to tolerate immoral and unwholesome behaviours?

You may have observed, however (for it is quite evident) that in certain circles the concept of the pen being mightier than the sword has strategically been used to promote ideologies and immoral lifestyles under the artificially elevated value of "tolerance." Apparently all concepts of right and wrong must now bow to the supreme ethic of tolerance. Good wordsmiths among the promoters of immorality know that one quick jab with the word "intolerant" will permanently silence the majority of those who disagree with them. (And, God forbid that we teach our children that there is any value or attitude more important than tolerance.)

Of course, as you may have noticed, this supreme ethic of tolerance is quite one-sided. It is apparently quite appropriate for the supporters of blatantly sex-promoting parades and purveyors of a mutated reality about human sexuality and gender identity to call pro-family and pro-biblical ideologies intoler-

ant, and at times using highly abusive language, but (again) God forbid that those who oppose them dare express their views on these matters. Out comes the "intolerant" sword.

Sorry folks, it doesn't scare everyone. Some of us know that tolerance is a good thing in the right context, just as is intolerance. In case someone feels like pulling out the "Jesus was all about love" and tolerance sword, let me disabuse you of that notion. Here are his words to the church in Revelation 2:20: "But I have this against you, that you tolerate that woman Jezebel, who calls herself a prophetess and is teaching and seducing my servants to practise sexual immorality and to eat food sacrificed to idols."

Clearly the Son of God, who promoted and demonstrated love as the supreme ethic, sees no inconsistency between loving someone and being intolerant of their conduct. In truth, then, it is the antithesis of love to encourage or promote practices that are morally, socially and spiritually destructive to people for whom Christ died. BritCay helps bereaved parents launch new evacuation kits for families of sick children

This month will see the launch of a new initiative for families of sick babies and children being evacuated to seek urgent medical care overseas. Evacuation kits will be provided to the parents or guardians of evacuees in order to provide practical help and support in their time of need.

The kits were designed by Rich & Maya Lewis, whose son Leo was evacuated when he was just 3-days old, to give families access to medical resources unavailable here in the Cayman Islands. Drawing on their own experiences, the items in the pack have been curated to make an ordeal that no parent ever wants to endure, that little bit easier to cope with.

"Finding out that your child is so sick that you need to leave the country in a matter of hours is incredibly upsetting.

It's a situation no parent ever wants to find themselves in" Maya Lewis explained. "In a short space of time you have to pack and think of everything you might need to live in another country for an undefined period of time. It's terrifying"

With that in mind, the kit contains some basic essentials, as well as, a packing list and a hand-written letter of support from the founders. "We just want people to know that they're not alone, to stay strong and that we understand what they're going through."

The couple applauded British Caymanian Insurance Company Limited (BritCay) for ensuring that their own evacuation process went smoothly. "We were pretty confident that our policy would cover all of the costs of the evacuation and Leo would be able to get the medical

help he needed, at one of the world's leading children's hospitals in Miami," Lewis continued.

Both parents are now thrilled to have partnered with the insurer to offer this additional level of support.

"When we heard Rich and Maya's story we were immediately moved to assist," said BritCay Health Manager

The packs will be available to all families of babies and infants facing evacuation from the Cayman Islands Hospital's

Neonatal Intensive Care Unit and Paediatric Unit from August, regardless of insurer. They will contain a hand-written card from Leo's parents; a packing list; a USB charging extension cord; a note pad and pens; basic toiletries (toothbrushes, toothpaste, shower gel, shampoo, conditioner & face wipes); \$100 Uber eats voucher; water bottle; granola bars and a tote bag. 🌐

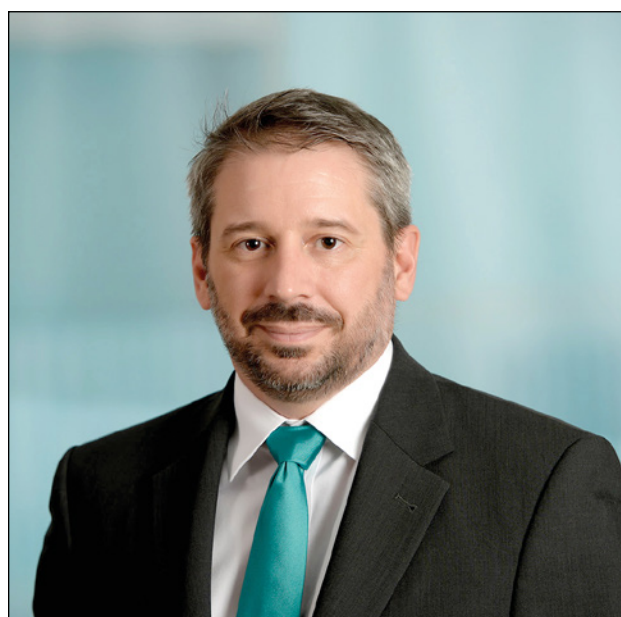

Hurley's Media Ltd. and Car City in partnership with the Health Services Authority (HSA) and Cayman Islands Blood Bank presented Cayman's first dedicated blood bank van on Wednesday, 7 August. The van will improve safety and ease the transport of essential equipment and materials for mobile blood drives.

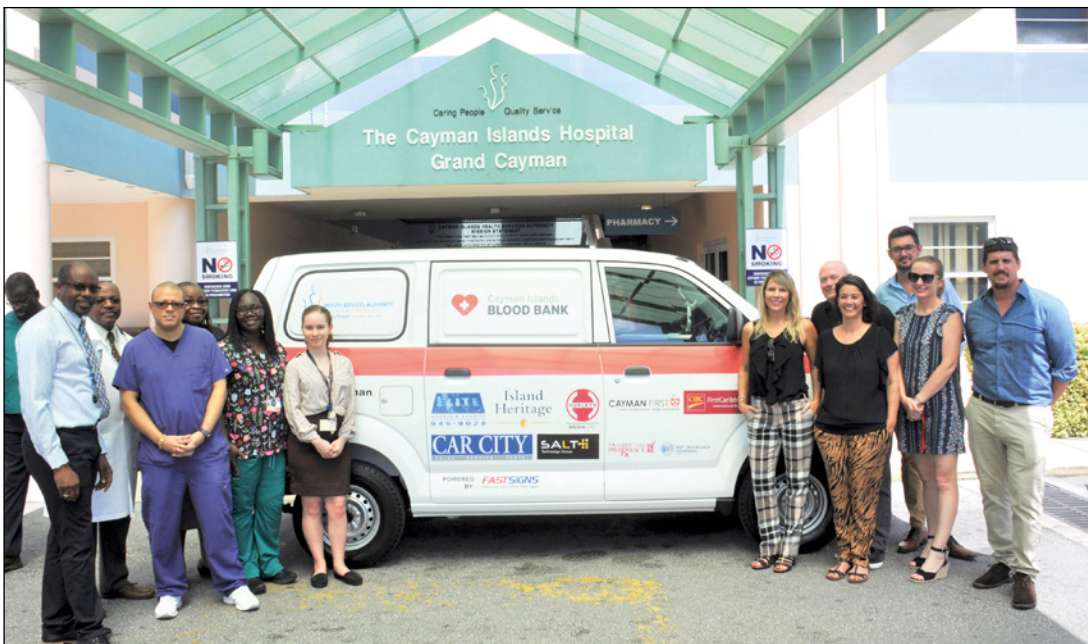
"Having a vehicle that is readily available and used exclusively to facilitate the collection of blood is a major milestone for the Blood Bank. As requests for mobile blood drives increase, this contribution will make a significant difference in how efficiently the blood drive process flows," said Blood Bank Manager Judith Clarke.

Over the years, with the increase of medical operations performed locally, such as cardiac surgeries, there is a greater demand for blood. The Cayman Islands Blood Bank will utilize the van for all mobile blood drives. Each of the van's corporate sponsors will host a public blood drive over the next 12 months in hopes of increasing the current donor pool from 2.5% to 5% of the population

South Sound itself experiences significant spillbacks during weekdays. However, AMD Howard notes that the congestion of South Sound Road is also partly caused by motorists using Old Crewe Road as a cut-through road during the evening peak. Motorists using Old Crewe Road as a shortcut will now also have to adhere to the new signal.

The traffic signal meter is expected to go live by Monday 19 August 19, 2019. The NRA notes that this is an interim solution, before more detailed plans for traffic relief in this area. The new metering signal will be placed further back from the roundabout and will include advance warning signs, a cantilevered signal head over the travel lane, and a painted stop bar designation in which motorists are required to stop.

The new signal will activate on weekdays (Monday through Friday) during

the evening peak hours only. The signal will cycle drivers through at intervals of 10 to 12 seconds. An illuminated red ball will signify that drivers are required to come to a complete stop. An amber ball signifies that motorists proceed with caution.

Such metering signals are quite common in the UK, Australia and U.S.A where they are used in various situations, including at roundabouts, and for regulating traffic joining the motorways at congested periods.

The NRA would like to thank motorists for their vigilance in observing and respecting the new metering system. The aim of this project is to ensure the Grand Harbour Roundabout will work more effectively, by restoring traffic flow priority to the major artery.

The new signal pole on South Sound Road will also soon feature the installation of the first set of electronic vehicle registration (EVR) detection devices designed to read the new drivers registration stickers and plates. 📍

Both persons have been further bailed to appear to appear in Summary Court on 20th August 2019.

THE OTs, BORIS JOHNSON AND BREXIT

With the United Kingdom locked in an acrimonious spat with the European Union - and internally - over Brexit, it's becoming well nigh impossible to find a space for the Overseas Territories amongst the pressing issues occupying the attention of the 'mother country' at present.

The situation is further complicated by the raft of new faces at the forefront of the British government preoccupied with Brexit; the process of the UK's exit from the EU.

On the surface, the fact that new prime minister Boris Johnson was a previous foreign secretary under whose portfolio the OTs 'resided', might be somewhat reassuring.

Prime Minister Johnson is no stranger to the OTs having personally - although some might argue, belatedly - jetting out to the Caribbean territories in the aftermath of devastating hurricanes in 2017 to personally hand out hurricane relief.

His subsequent commitment - before he abruptly quit the government of Theresa May - to ensure that hurricane relief, and more importantly preparation, are well in place after that experience might be paying off.

The standard UK naval disaster response presence in the Caribbean, especially for the OTs, has been 'beefed up' on the back of that.

However, while that might have been a direct result of Mr Johnson's intervention as foreign secretary, his position regarding the OTs as their prime minister is still an unknown quantum.

Prime Minister Johnson has not only inherited Brexit, which was the key fo-

cus of his near obsession with the top role.

He has also inherited the challenges of the relationship between the UK as the administrative power/mother country and its remnants of empire scattered across the globe - most of them in the Caribbean.

In his government, that challenge now sits squarely with his new foreign minister, Dominic Raab, an arch-Brexiteer, but whose take on where the OTs figure in that process is quite unclear.

It's noteworthy that there would have been an overlap between Prime Minister Johnson being in office as foreign secretary and the start of the most recent UK Foreign Affairs Committee's (FAC) parliamentary inquiry into the future of relations with the overseas territories.

By the time he demitted that role and set his eyes once again on the lofty prize of the prime ministership, the FAC had concluded its inquiry.

Its key recommendations met a firm rejection of its key findings by the Theresa May government via the office of the foreign secretary, at that time Mr Johnson's successor Jeremy Hunt (who was to become his main challenger for the role of prime minister).

Mr Johnson prevailed, Mr Hunt quit the post and the OTs now have their third foreign secretary in as many years.

The key and most controversial recommendations in the FAC's report, which were rejected by the previous Theresa May government (and Mr Hunt as foreign secretary) were; a demand that the OTs adopt same-sex marriage to a given timeline - with the threat of being imposed by imperial decree, and granting voting and elected rights to all British citizens in the islands.

Will those be revisited?

Another central issue that, despite objections from the British government was previously adopted by parliament, is the matter of the public disclosure of beneficial owners of companies registered in the OTs, especially in their lucrative offshore financial services sector.

That doesn't seem likely to get any push-back from the present Johnson administration.

There are other issues pending coming out of both the report and the annual Joint Ministerial Council (JMC) meetings between the OTs and their UK administrative counterparts.

And there were other aspects of the recommendations which, despite gov-

ernment supposedly being a continuity, is no guarantee of status quo.

In the last JMC plenary session, the British government - then the Theresa May administration - committed to:

- "reaffirmed the UK government's commitment to taking the Territories' priorities into account as the UK prepares to leave the EU, including in relation to funding, trade, the environment and education."

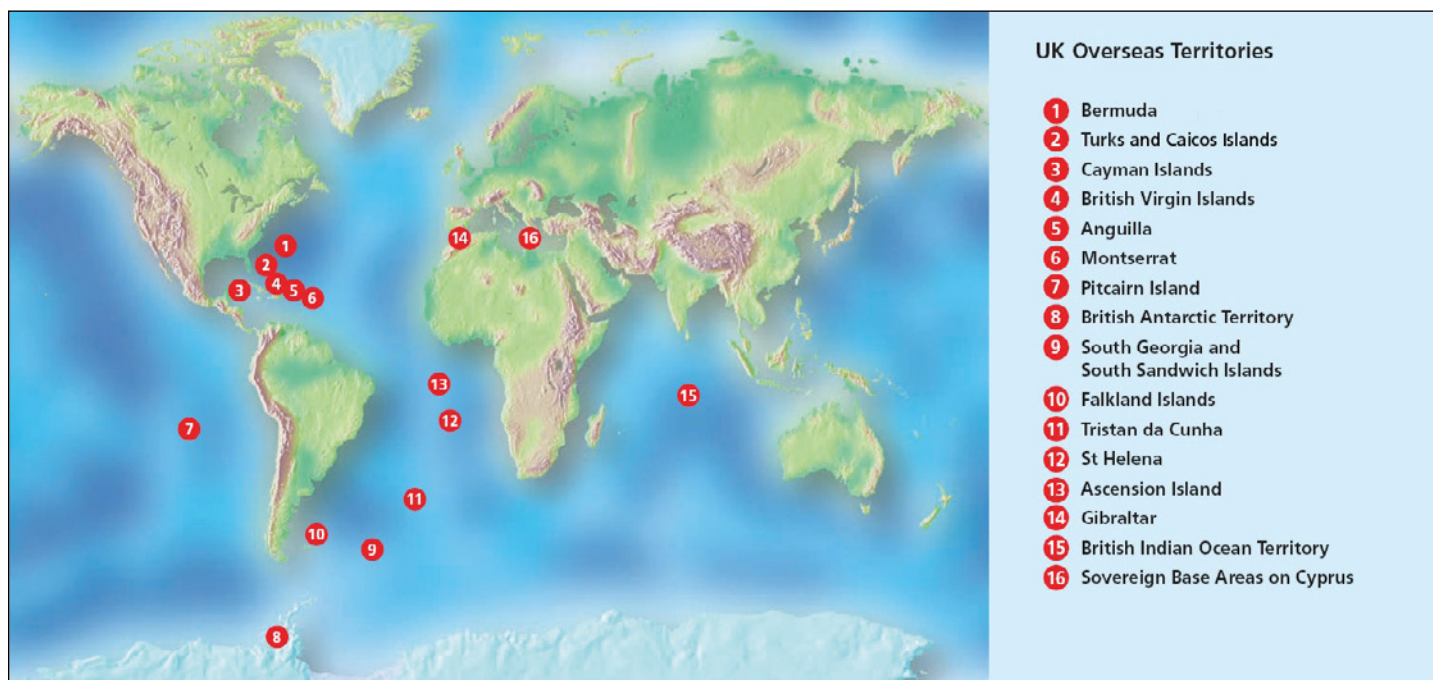
- and gave assurances that "in the unlikely scenario that we leave the EU without a deal, existing projects under certain EU funding streams will be guaranteed by Her Majesty's Treasury for the lifetime of those projects."

It is now highly likely that the UK will leave the EU without a deal following the political strategy trajectory of the Johnson administration and its current stalemate with the EU over Brexit.

The EU is adamant that it already has a deal negotiated over two years with the Theresa May government, and which included the UK's assurances to the OTs.

But with the Johnson government committed to a no-deal Brexit by the next deadline of October 31st on the Brexit calendar, the wildly shifting political sands, tides and affiliations, all against a backdrop of constitutional uncertainties, the issues for the OTs seem all but on-hold/status quo for the time being.

However, amidst all this, at least one thing is certain; Lord Ahmad of Wimbledon, widely considered as a champion or at least a sympathetic ear for the OTs, retains his position as Minister of State for the Overseas Territories...subject to change. 🌐

The JMU and AOU continue to do Vigilant Border Patrols

Just before 10PM on Tuesday 6 August, the Joint Marine Unit consisting of officers from the RCIPS and CBC, along with the Air Operations Unit were on border patrol duties.

About 11 miles off the shore of East End and within the Cayman Islands jurisdictional waters, the AOU spotted a boat that had one occupant and what appeared to be several packages on board. This raised the suspicions of the officers who then informed the Marine Vessel M. Luke. MV M. Luke made their way to the location using lights and siren and the vessel attempted to evade them, but was intercepted with the assistance of the AOU.

A search was conducted of the vessel and over 40 pack-

ages containing what the officers believed to be ganja was on board. The occupant, a 32-year-old-man of Cayman Brac was arrested on suspicion of Importation of Ganja along with other drug related offense. The vessel and its contents were seized and an investigation was launched into the matter.

The estimated weight of the ganja recovered from the vessel was in excess of 1200lbs and has an estimated street value of over \$1 million CI dollars.

The 32-year-old-man from Cayman Brac has since been charged and is expected to appear in court today on charges of Importation of Ganja and Possession of Ganja. 🌐
