Prospect and Red Bay constituents hear about road improvements

Constituents from Red Bay and Prospect packed the Seafarers Hall to hear Premier and Elected Member for Red Bay Hon Alden McLaughlin, and Hon Austin Harris, Elected Member for Prospect, along with Hon. Joseph Hew, Minister of Commerce, Planning and Infrastructure talk all about road and drainage improvements, and exciting plans for a new community park. Also present was the Infrastructure Ministry's Tristan Hydes, as well as Mr. Edward Howard, of the National Roads Authority.

Mr. McLaughlin, began the meeting by saying that, although they went under two different labels, Red Bay and Prospect were practically one community; a community that had found its identity and come together more and more over the last few years in particular. He praised the new community Whatsapp chat group, and encouraged all the residents to get on it. He assured those present that that NRA had a comprehensive plan to address concerns about rush hour traffic congestion, before introducing new plans for an extensive new

Tribute to the Late Ronald L. Kipp

Widely regarded as one of the pioneers who placed Cayman Islands diving on the map, Mr Ronald (Ron) L Kipp was a true visionary and his story, like our waters, is one of a kind.

Ron was first introduced to diving in 1971 and became a certified dive instructor soon after. His eagerness to explore the waters of the world led him to the Cayman Islands, where he instantly fell in love with our impeccable marine environment and would become a repeat visitor. A successful businessman with IBM, Ron left his position in 1980 and relocated to the Cayman Islands to become the owner of Bob Soto's Diving Ltd.

Ron's earnest passion for the sport, coupled with his foresight of the sport's potential, led him to begin modernizing and expanding his business while marketing the Cayman Islands as a world-class dive destination. Ron quickly became one of the largest dive operations in the Cayman Islands, building a PADI five-star operation and influencing scuba diving marketing at home and across the Caribbean region.

A natural leader, Mr. Kipp sought avenues to sustain the growth of the sport worldwide. He was an original member of the Dive Equipment Manufacturers Association (DEMA) Industry Organizing Committee and was elected to the



DEMA Board of Directors, where he served continuously longer than any other member in the organization's history. At home, Ron was instrumental in creating the first local scuba diving association and would later help to create the Cayman Islands Tourism Association.

Ron was a formidable businessman softened with a love for laughter and had a big heart through his active community and tourism efforts. His commitment to developing the sport for future generations cannot be trivialized. Because of his efforts and achievements, Mr. Kipp was inducted into International Scuba Diving Hall of Fame in 2012. Ron received one of the nation's highest recognitions in the Cayman Islands as a pioneer in Tourism at the 2017 Heroes Day celebrations.

The Ministry and Department of Tourism join the people across the Cayman Islands and around the world in mourning the loss and celebrating the life of one of the great tourism pioneers of our time. 🌐

park for the community to use: "So far we have purchased six parcels of land between Victory Avenue and Prospect Drive, for the establishment of a Community Park," he said. Members of the Lions Club of Grand Cayman had generously offered to contribute 150,000 dollars towards the project, he said. "The Government has agreed to give the Prospect and Red Bay Community Group a license to develop and operate the park on behalf of all of us who live here," he added, with an assurance that the Government support the project as far as possible too.

Mr. Harris spoke next, and thanked everyone who had stepped up to the plate to help him make the promised improvements to his constituency, including the NRA who had moved quickly to repave Mahogany Way, one of the immediate concerns. Some things, such as more speed bumps which had been requested along several different residential roads in the area, where still in the pipeline, he said, because of the requirement that at least three quarters of the residents must agree before the speed bumps are put in: "Again, that process might become easier if you are active participants one of the chat groups," he said.

There was much talk throughout the whole meeting of the concern over flooding, which has always been a problem throughout Red Bay and Prospect, and Mr. Harris thanked the NRA for their help in clearing drains, but also said that this alone wouldn't be enough: "It won't solve the problem because the high water table that exists in Red Bay and Prospect. We certainly can mitigate it," he said.

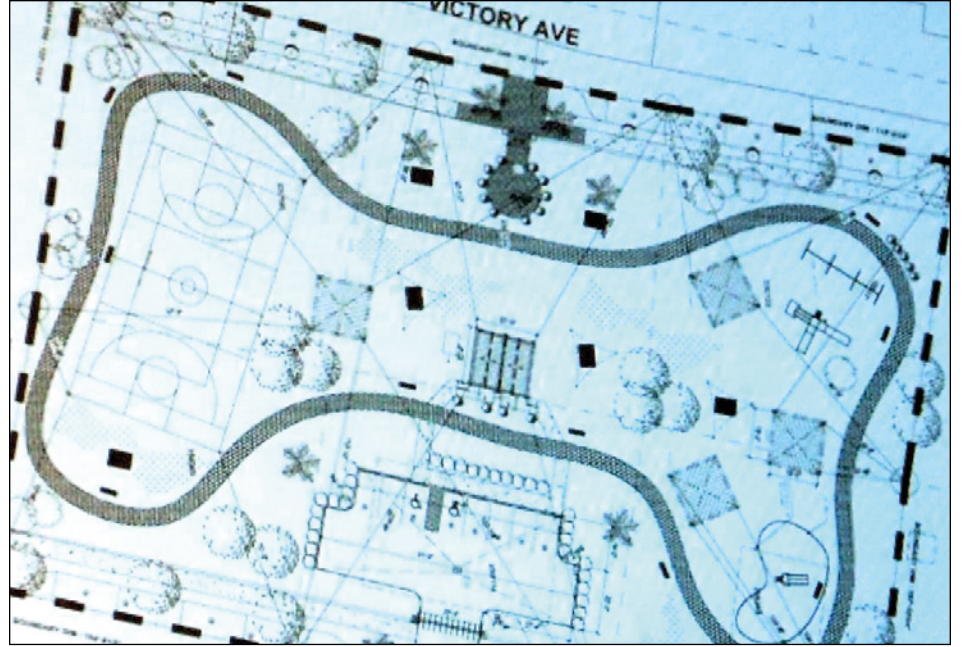
Infrastructure Minister Joseph Hew gave everyone an overview of the Ministries short, middle and long-term plans regarding the problem of traffic congestion: "We have to consider that we cannot simply continue to build more, and so we have to look at things like public transport," he said, and mentioned the possibility of 'hop-on and hop-off' air conditioned public transport for George Town and the Seven Mile Beach corri-

dor for the future. "I am happy to say that in January we will carry out a major Public Transport study, also have to take into consideration aspects such as the ease of vehicles being imported into Cayman...and encouraging persons to purchase bicycles motorcycles, electric vehicles, and in particular on the electric vehicles side, the smaller vehicles," he said.

Mr. Hydes spoke in detail about the new road widening plans pertaining to Shamrock Road in particular, as well as a number of other main roads affecting traffic flow throughout Red Bay and Prospect. Future improvements included adding new lanes in different places, including extensive areas of shamrock Road, on either side of the Grand Harbour Roundabout; and bigger, three-lane roundabouts controlled by stop lights. 🌐

Water Authority Adjusts Rates

Water Authority – Cayman announces an increase in the rates for water, sewerage and septage services. The increase of 1.46% is effective as of 1 July, and customers will see the rate adjustment reflected on their July bill, which will be posted at the end of this month.

OfReg, the regulator of the Energy & Utilities sector in the Cayman Islands, approved the rate adjustment and announced it on their website on 24 July 2019.

Under the adjusted rate structure, the fee for the first 12 cubic metres (m³) consumed each month, which is equivalent to approximately 3,200 US gallons, will increase by 7¢ per m³, from CI\$4.49 to CI\$4.56, and 8¢, from CI\$5.71 to CI\$5.79, on each m³ thereafter. In Cayman Brac, residential piped water customers will see an increase of 9¢, from CI\$6.12 to CI\$6.21, on each m³ and trucked water customers will see an in-

crease of 11¢, from CI\$7.66 to CI\$7.77, on each m³.

Sewerage rates are based on the assessed Sewerage Fixture Units (SFUs) for the service location in question and are calculated at a constant rate. This rate has increased from CI\$1.648 to CI\$1.672. The rate for septage disposal charged to septage truckers has increased from CI\$16.773 per 1,000 US gallons to CI\$17.018.

Director of the Water Authority Dr Gelia Frederick-van Genderen explains that the rate adjustment is necessary for continued investment in the Authority's water and wastewater infrastructure.

"The country is growing and developing at a rapid pace, and the Authority needs to ensure we not only keep up but also plan and build with the future in mind. The rate adjustment is necessary to invest in our infrastructure to ensure proper and adequate operations in the

years to come," notes Dr Frederick-van Genderen. "Keeping tap water affordable is part of the Authority's mission, and even with this increase the water we provide is still less than 3¢ per gallon," she adds.

The Authority's tap water is held to rigorous quality control guidelines and exceeds the guidelines set by the World Health Organization for drinking water quality. The Authority's internationally-accredited laboratory conducts more than 45,000 sample tests every year to ensure that the tap water in the Cayman Islands is safe to drink.

"We understand that rate increases are not something customers welcome, however, we encourage our customers to be aware of their consumption patterns and monitor their usage closely to manage their expenses and catch leaks early," explains Dr Frederick-van Genderen.



The Authority's website contains a variety of resources to help customers understand their bills, reading their water meters, and conserve water by reducing water use through smart home and landscaping habits. In addition, water-saving showerheads and faucet aerators are available free of charge at the Authority's headquarters.

OFREG APPROVES WATER AUTHORITY RATE ADJUSTMENT

OfReg approves the Water Authority rate adjustment of 1.46% effective July 1, 2019

The rate charged for water by the Water Authority will only increase a minor increase of 1.46% this year, to account for inflation. This small increase is less than two-thirds of what the utility applied for last year. This will represent a marginal increase of approximately \$1.50 per month for the average residential WAC consumer.

OfReg, the regulator of the Energy & Utilities sector in the Cayman Islands, has a responsibility to regulate the quality of the utilities provided to consumers but also to ensure that any rate adjustments permitted under the law are fair to both the commercial interests of the service provider and the consumer.

The Water Authority Regulations (2018 Revision) ("the Regulations") gives the Water Authority Cayman the

power to fix water, sewerage and septage charges. However, OfReg has a responsibility to first approve rate adjustments, within the scope of the Regulations, which state that the rates "shall be adjusted...". However, new regulations should come into effect later this year, and these regulations will state the terms and conditions by which future rate requests will be determined.

Currently, section 44(3) of the Regulations allows for the adjustment for inflation to take effect on the 1st of July annually and are calculated based on a predetermined formula that combines the Cayman Islands Consumer Price Index (CPI) and the US Producer Price Index. The Regulations also state that the base price adjustments be submitted to the Auditor General for independent verification no later than 15

May of each year. The Auditor General has confirmed that the data included in the calculations provided by the WAC are correct and OfReg has crosschecked this information.

Mr. Gregg Anderson, Executive Director Energy & Utilities at OfReg, commented on the process behind the rate adjustment: "The Cayman Islands, as a small island nation, cannot provide the economies of scale that would be required for a more competitive environment in the utilities sector. Therefore, our job is to regulate the quality of the services provided to consumers, as well as to maintain oversight of the rates that utilities can charge, within the confines of the law. The transparent and thorough process produced a result that balances the needs of customers and the company."



The rate increases will take effect as at 1 July 2019 and will be reflected in July bills which will be issued in early August.

Carnival dates finalized

On Tuesday 23rd July, 2019 written communication addressing the proposal of Cayman Carnival dates was sent to a stakeholder for review. After this communication was distributed amongst the wider spectrum of the stakeholder's membership, the response received was not in favour of hosting the Grand Cayman and the Cayman Brac road parades on the same weekend; one being held on the public holiday and one on the Saturday of that long weekend.

The purpose of the discussions which have been ongoing for some time, was to make better decisions about how Cayman Carnival could best model from the successes of regional partners in hosting a unified carnival and creating an outstanding experience.

Through many helpful submissions, the Ministry of Culture has taken into consideration the following regarding the disseminated proposed dates: the first weekend in May fell in line with the Bahamas Carnival and would leave Cayman Carnival competing for the same international tourism dollar; the second weekend in May fell on Mother's day and it was thought would generally not support travel and the third weekend conflicted with the Bracchanal Carnival, and did

not facilitate residents and tourists being able to participate in both events.

During the discussions the long weekend in June was also explored however, this was met with concerns as this is when the Queen's birthday weekend is to be observed and George Town would be closed down for the annual parade.

"This was not an easy task and required many proposals and counter-proposals with stakeholders and vested parties. At this time we believe we have gained the majority buy-in and have made final decisions to accommodate the start of 2020 bookings," says Honourable Dwayne Seymour, JP – Minister of Health, Environment, Culture and Housing.

The dates will be as originally announced: 1st weekend of May Junior Carnival, 2nd weekend of May Cayman Carnival and 3rd weekend (Discovery Day) Bracchanal.

"The Ministry will continue to listen to our stakeholders on an annual basis and make adjustments as necessary. We would like to thank all parties for their submissions, communications and the healthy discussions that have led to this decision. We encourage all to try to make these dates work and a look forward



to continued Carnival success for the Cayman Islands," concluded Minister Seymour.

Commenting on the appointment Minister for Health Dwayne Seymour says that the Ministry is excited to have a new CMO in post, who will help to drive forward Government's healthcare agenda.

"Dr. Lee is a truly world class medical professional. He is exceptionally qualified to take on a leadership role at this level and to help the Ministry team deliver Government's promise of improving access to quality, affordable healthcare", Minister Seymour remarks.

Prior to serving as the pain specialist at the Health Services Authority (HSA) from 2012 until 2018, Dr. Lee spent 10

years as a Consultant in Pain Medicine at the National Hospital for Neurology and Neurosurgery, University College London Hospitals, in the United Kingdom.

He is affiliated with a number of professional organisations in the UK. These include: Fellowship of the Royal College of Physicians, Fellowship of the Royal College of Anaesthetists, and Fellowship of the Faculty of Pain Medicine (Royal College of Anaesthetists).

In addition to policymaking, Chief Officer Jennifer Ahearn notes that the CMO plays an important statutory role in several laws and regulations that impact security and immigration as well as health.

The position is also the focal point for the Cayman Islands participation in international health conventions, and a liaison to the Caribbean Public Health Agency, the Pan American Health Organisation, Public Health England and similar regional and international bodies.

"As Chief Medical Officer Dr. Lee will be developing the country's approach to monitoring the standards of our healthcare systems. He will also be one of our foremost advocates as we work to engage Caymanians and residents in national public health matters like the reduction of preventable illnesses", Ms Ahearn explains.

A published author with over 100 publications, reports, presentations and au-

ditions to his name, Dr. Lee has been involved in medical management and implementation of quality standards throughout his career. He has been closely involved in the development and implementation of professional medical guidelines, for example, through the National Institute for Health and Care Excellence in the UK.

Describing himself as excited to be starting his new role, he adds, "It offers a wonderful opportunity to develop healthcare systems on the Islands that will positively impact the lives of people here in both the short and long term".

Ministry Presents Annual Reports for Statutory Authorities in the LA

The Ministry of Financial Services presented annual reports for the Auditors Oversight Authority (AOA), Cayman Islands Stock Exchange Ltd (CSX) and the Cayman Islands Monetary Authority (CIMA) to the Legislative Assembly, which started on Wednesday, 24 July.

The reports and financial statements for the three statutory authorities were tabled on Wednesday, as part of the sixth meeting of the LA's 2018-2019 session, in accordance with the Public Management & Finance Law (2018 Revision), with the fiscal year for each authority ending on 31 December 2018.

The Auditor General issued unqualified opinions after completing audits of their financial statements. The unqualified opinions essentially mean that the Auditor General has determined the financial positions of each authority have been fairly presented.

"The reports detail the important contributions these authorities make to the

regulation of our financial services industry', Financial Services Minister Tara Rivers said. "Their efforts add positively to the reputation of the Cayman Islands as a leading international financial centre that caters to sound business".

The AOA report details the authority's latest enforcement efforts, its representation at the annual plenary meeting held by the global governing body for audit regulators, its collaborative work with European Union counterparts, its ongoing engagement with local stakeholders and the search for a Caymanian managing director, as the current director is set to retire next month.

The CSX report shows the exchange declared and paid a dividend of C\$820,000 to the Cayman Islands Government for the financial year.

The CIMA report speaks to the authority's financial performance, its regulatory work to improve the banking sector and to enhance Cayman's anti-money laundering and counter-financing of ter-

rorism regime, its statistical overview of various financial services industry sectors, its engagement with international

bodies, its efforts to hire additional staff, and its supervisory work for affected entities. [f](#)

Statement on Progress against CFATF Recommendations

Mr. Speaker support for the Cayman Islands Financial Services Industry remains one of the key priorities for this Government.

The conditions that attracted financial services providers to these shores still underpin our success today - our adherence to the framework of English Common Law, our tax neutral status and our strong economy and stable and financially robust government.

Our Financial Services Industry remains strong and resilient. Like many of our competitors the Cayman Islands as a jurisdiction has seen the increasing need to upgrade our regime to ensure that we are compliant with the various supra-national bodies. Indeed the view of Government is that as a world leading financial services centre we have an obligation to ensure that our regulatory regimes are also world class. And so over the years the jurisdiction, Government and industry partners, have responded to the evolving regulatory landscape and have put in place the necessary regulatory frameworks.

Some of these measures have been necessary as Cayman plays its part in the global fight to combat money laundering and to counter the financing of terrorism. Others have been required to enable tax authorities in other countries to access information they need in order to ensure compliance with their own taxation regimes.

I do not need to tell this House, Mr. Speaker, how many long hours we have spent in this House as numerous bills have been passed into law. Nor do I need to remind our partners in the industry how many long hours have gone into working up the detail of those bills in such a way as to meet regulatory requirements while still maintaining the space for creativity and innovation that is the hallmark of financial services in this jurisdiction.

So it is, once again, Mr. Speaker that we are here at this meeting of the House to consider yet more necessary changes to our legislative framework. Some 11 bills are now before the House, each dealing with some aspect of our anti-money

laundering and counter financing of terrorism regime.

Others will speak to the details of those bills, Mr. Speaker, but taken together they represent a robust response by this Government to the recommendations made by the Caribbean Financial Action Task Force in its March 2019 report. As such, they are an important part of our country's efforts to ensure we remain compliant with international standards and I therefore commend them to the House.

Significantly, however, the CFATF's recommendations do not just cover the legislative framework for regulation. For the first time, they have moved on to cover the effectiveness with which the legislation is being implemented. We certainly understand the rationale for ensuring that not only do we as a jurisdiction have the required regulatory framework, but that we also have the mechanisms and people to ensure that the framework is effective and can be proven to be so.

And so, this Government is determined to respond positively to these recommendations dealing with effectiveness as we are doing in keeping the legislation itself up to date.

Doing so requires a response from across government and partner agencies including the Royal Cayman Islands Police Service. A Ministerial Sub-Committee, which I chair, has been created to oversee the work of the agencies and we have established a Financial Crime Focus Group to ensure coordination and cooperation at the operational level between law enforcement agencies. That Group will make recommendations to enhance the quality of work related to the use of financial intelligence, and the investigation and prosecution of financial crime.

Together we are working through the detailed action plan that we published at the end of April and which responds to all 63 of the CFATF's recommendations. We have appointed a National Coordinator to assist with the coordination between agencies, committees and all stakeholders involved in the implementation of the action plan.

The commitment of the Cayman Islands to this process has also been

demonstrated by the funding of additional resources, over 100 new positions, for agencies agreed during the March sitting of the Finance Committee. This includes the strengthening of the dedicated Anti Money Laundering Unit at the Cayman Islands Monetary Authority and a dedicated cross border Money Laundering and Terrorist Financing Task Force within the Royal Cayman Islands Police Service (for which an interim team was put in place in April). All told we will be investing several million dollars more to further strengthen our regulatory regime. It is important to note that this will not be a one-off expenditure.

We are now monitoring the results of the actions that we have put in place and we remain committed to taking any further action that may be necessary as we ensure we rise to the challenge that the CFATF has given us.

Inevitably when dealing with effectiveness, it will take time before we are able fully to demonstrate that the measures that we are putting in place are working. However, I expect to be able to demonstrate progress as part

of the CFATF Enhanced Follow Up Process, when submissions are made on 24th September, 2019, in relation to both technical compliance (legislative amendments) and effectiveness. This CFATF report will be presented at the November 2019 CFATF Plenary meeting to be held in Antigua.

I am sure that Members on all sides, Mr. Speaker, will recognize the importance of this work for the future of our Islands. Make no mistake, this Government will take the action necessary to ensure that our legislation is robust and that it is effectively implemented.

I have said previously in this House and elsewhere that Cayman does not want or need to deal with those who would seek to hide money or use it for illegitimate purposes. Our efforts in improving the effectiveness of the implementation of our world-leading legislation to protect the integrity of our financial services will mean that we can demonstrate to the world that anyone attempting to use Cayman for such illegitimate purposes will be caught and dealt with to the fullest extent possible under the law. Over 1000lbs of Ganja Seized From Drifting Vessel by JMU



On Wednesday, 24 July, the RCIPS was alerted to a vessel adrift some miles off the coast of Grand Cayman. Officers from the Joint Marine Unit supported by the Air Operations Unit deployed to locate the vessel.

At about 4:30PM a vessel was located approximately 50 miles east of Grand Cayman and appeared to be drifting. Joint Marine Unit officers aboard the MV Mark Luke came alongside the vessel and observed what appeared to be a substantial amount of ganja in numerous packages on board.

Two males, both Jamaican nationals, ages 59 and 33, who were aboard the vessel were arrested on suspi-

cion of drug trafficking, and the vessel and its contents were seized.

The packages are estimated to contain over 1000lbs of ganja with an estimated street value of up to \$1Million KYD.

The men remain in custody as investigations continue.



Single Vehicle Collision on Crewe Road

Just about 11:20PM on Wednesday 24 July, police attended a report of a motor vehicle collision that took place on Crewe Road, George Town, between Clarence Drive and Belmont Close.

A white Ford F-150 Truck was being driven by a 28-year-old man of Bodden Town, when the driver of the vehicle lost control and ran into a chain link fence and wall belonging to two separate residences on Crewe Road.

The man did not complain of any injuries to the police and no

other vehicles or persons were involved in the collision.

The man was arrested on suspicion of driving under the influence of alcohol following a roadside breath test, as well as several other driving offenses, including driving without insurance and careless driving.

After being booked into custody, an intoxication test was carried out and the results were .212, over double the legal limit.

The man was later bailed pending further investigations.

Recently RCIPS officers joined with staff from the Department of Commerce and Investment and the Cayman Islands Fire Service to conduct checks of liquor-licensed premises in George Town.

The objective of the checks was to determine whether the establishments were meeting the requirements of their liquor licenses, and in particular safety regulations. The checks were carried out by Senior Trade Officer Leith Bodden from the DCI, Acting Senior Divisional Fire Prevention and Investigation Officer Darnley Scott from the CIFS and Police Inspector Courtney Myles of the RCIPS.

Five establishments were visited and four of the five were found to have issues that needed to be addressed. Some of these issues were corrected immediately, while others are being followed up by the relevant inspectors.

"We are quite happy with how Friday's safety checks went," said Inspector Myles. "All of the establishments we visited demonstrated their willingness to work with us and comply with any necessary changes."

"The requirements attached to a liquor license are there primar-

ily to ensure the safety of all the patrons who visit the establishment," said Claudia Brady, Head of Compliance and Enforcement of the DCI. "It's our collective responsibility to ensure that those requirements are being met, which is why regular checks are so important."

"Prevention is better than cure," said Officer Scott. "We at the Fire Service would like to commend and thank the LLB business owners and management for their continued cooperation, commitment and support regarding fire and life safety. The compliance of Fire Service requirements is a vital role in safeguarding our community"

The checks will continue throughout the year, with the next scheduled to take place next month.



Serious Assault at Liquor License Premises on Mary Street

Just after 5:30AM on Thursday, 25 July, police were informed of an incident that took place in the parking lot of a liquor licensed premise located on Mary Street, near the intersection with McField Lane. Several people were engaged in a brawl in the parking lot that later resulted in two men sustaining stab wounds.

The men are currently hospitalized, but are believed to have sustained non-life-threatening-injuries and are stable at this time.

The incident is being investigated by the Criminal Investigations Department and de-

tectives are appealing to anyone who may have been present and witnessed what took place during the altercation to come forward and speak with the police.

Caribbean States Prepare to Battle Illegal Fishing

Eighteen border control officers from seven Member States of the Caribbean Regional Fisheries Mechanism (CRFM) are currently undergoing a four-week training course in Fisheries Prosecution and Interdiction, organized by the Barbados-based Regional Security System (RSS) in collaboration with the CRFM Secretariat, the Government of Barbados, and the British Royal Navy's Fisheries Protection Squadron.

The course is expected to improve the skills and competencies of authorized officers responsible for enforcing the Fisheries Acts and Fisheries Regulations, and supporting administrative policies.

Participants are increasing their ability to function in an operational environment and in accordance with best practices based on the CRFM's Prosecution

and Enforcement Manuals for CARIFORUM Member States: Volume 1 – Fisheries Prosecution Manual; and Volume 2 – Fisheries Enforcement Standard Operating Procedures Manual.

The participating officers, who have border security and fisheries prosecution responsibilities, will become more knowledgeable of the correct procedures to follow while enforcing the laws under their Fisheries Acts and Regulations.

They will also become better able to prepare for trial proceedings where offences are committed in violation of the Fisheries Laws and where illegal, unreported or unregulated (IUU) fishing is perpetrated.

IUU fishing is a major concern for the region, since it undermines efforts to conserve and sustainably manage fish-

eries resources and furthermore jeopardizes food security, livelihoods, and foreign exchange earnings from fisheries.

The training, being held at the Paragon Base of the Barbados Defence Force, brings together officers of the Antigua and Barbuda Defence Force Coast Guard; Antigua and Barbuda Fisheries Division; Barbados Coast Guard; Royal Barbados Police Force Marine Unit; Barbados Fisheries Division; Commonwealth of Dominica Police Force; Royal Grenada Police Force Marine Unit; the St Kitts-Nevis Defence Force Coast Guard; Royal St Lucia Police Force Marine Unit; and the Royal St Vincent and the Grenadines Police Force Coast Guard.

The course was jointly funded by the European Union through the 10th EDF



Project and Regional Security System (RSS). The RSS is an international agreement for the defense and security of the Eastern Caribbean region. The seven member nations are: Antigua and Barbuda, Barbados, Dominica, Grenada, Saint Kitts and Nevis, Saint Lucia, and Saint Vincent and the Grenadines.

Dominica: Strengthening Primary Care with a New Cadre of Community Health Workers

In Dominica, an island with a population of just over 70,000, change is underway to transform the health system into one that focuses increasingly on primary health care, is people- and community-centred and is better placed to achieve universal health coverage and access (or Universal Health, as it is known in the Region of the Americas).

The Pan American Health Organization, the regional office of the World Health Organization (PAHO/WHO) has been working with the Dominica Ministry of Health and Social Services to undertake a thorough assessment of the health system, and specific recommendations are now being implemented.

One example of this is the cadre of 27 new community health workers (CHW) who graduated from a training programme in September 2018, and are now starting work in communities to support health services at the primary level.

In 1978, at the time of the Alma Ata declaration, the Dominica health system was a model for primary health care, but over the past several years the primary health care system grew weaker faced with resource constraints and a greater national focus on hospital care. Unfortunately, the population's health situation in Dominica worsened following Hurricane Maria, which devastated the island in September 2017. This has had a significant impact on human resources for

health and the operation of community health centres, several of which were destroyed or made non-functional.

A systematic approach to strengthening the health system and primary health care services was required. Japanese grant funding through the UHC -Partnership supported a comprehensive assessment of the Dominica health system after Hurricane Maria. The PAHO/WHO technical team was comprised of seven persons focusing on various strategic aspects of universal health coverage and access. The team conducted the assessment in association with the Dominica Ministry of Health and Social Services and the National Health Commission during 2018 and early 2019.

It culminated in a comprehensive report which argued strongly that UHC in Dominica will only be achieved through strengthening primary health care and simultaneously addressing weaknesses within the health system relating to governance, health financing, resource allocation and management, and ensuring an integrated approach to health services delivery with intersectoral and community participation. The report made several high-level recommendations to implement action during 2019-2020.

The training of the CHWs was just one of the more urgent recommendations for health system strengthening. The skills-based training of CHW in

Dominica intends to address the shortage of health personnel and increase the capacity to deliver people-centered care within community settings and multidisciplinary teams. All this greatly strengthens primary health care.

The Ministry of Health and Social Services in collaboration with PAHO and with the support of Japanese funding through the UHC Partnership, has trained a cadre of 27 CHWs. The CHW training was conducted by skilled and experienced Dominica-based nurses in collaboration with the Ministry of Health and Social Services and WHO / PAHO. The curriculum was developed by the course instructors and vetted and approved by PAHO.

The six-month programme took place at the University of the West Indies Open Campus in Dominica, and comprised 13 subject areas and Basic Clinical Skills.

Minister of Health and Social Services Dr Kenneth Darroux congratulated the graduates on the successful completion of the programme. He said that the training was conceptualized in-order to respond to the need for increased human resource capacity in the health sector.

"Taking into consideration the constantly increasing demand on our health services both quantum and quality and juxtaposing this against available resources human and otherwise, you can

appreciate that today's ceremony is a step in the right direction towards narrowing this ever-widening gap," he said.

Bertisha Bertrand spoke on behalf of the graduating class. She said that on starting the course she had very little knowledge about the role of a Community Health Aide. She is pleased to also now have a more in-depth awareness of the meaning of health.

"The course was a great opportunity to achieve clarity on health, the community and what makes a community, how it functions and what can affect its functionality. Health is broad and has many areas which taught us that we have to adapt to different personalities and to different environments. The course has produced 27 qualified foot soldiers for their respective communities and by extension the primary health care service in Dominica," Bertrand said.

Jamaica Activates Ebola Response Plan

Jamaica's Ebola Virus Disease Response Plan has been reactivated on the heels of the World Health Organization (WHO) declaring as outbreak of the deadly disease in the Democratic Republic of the Congo, a Public Health Emergency of International Concern.

The response plan was implemented in 2015 in the midst of an outbreak in West Africa. And Minister of Health and Wellness Dr Christopher Tufton said it was being put into action to increase awareness and educate stakeholders.

During a Statement to the House of Representatives yesterday, he said his Ministry is undertaking specialized training and retraining of relevant stakeholders, including Immigration and Customs personnel, Port Health Staff, Public Health Departments, Clinical Care Teams and all persons who may handle specimen.

Also, surveillance at points of entry to the island through sensitization and screening will be enhanced, and clinical protocols for management and infection control practices are being reviewed.

"We are also reinforcing our laboratory response capabilities and preparing isolation areas at our public health facilities. Back in 2015, we had procured Personal Protective Equipment, which were distributed to hospitals. We also put in storage emergency stock at the Ministry's Central Stores. We are now doing an inventory of these items and additional

items will be procured as required," Dr Tufton said.

The Health Minister sought to assure the public that the response arrangements are in place to enable an appropriate response in the event that the Ebola virus is introduced to the island.

Earlier this week, the Ministry of Health and Wellness in Barbados said it was reviewing and updating its Ebola Plan to ensure authorities are able to respond effectively if the need arises.

Minister of Health and Wellness Lt. Col. Jeffrey Bostic met with the Ministry's senior officials as well as representatives of the Bridgetown Port, the Grantley Adams International Airport and the Queen Elizabeth Hospital to review the status of preparedness.

The action by Caribbean nations also follows advice the Caribbean Public Health Agency (CARPHA) gave to regional countries to enhance disease surveillance at their ports of entry and health facilities.

Ebola is a rare but severe and oftentimes fatal illness in humans. Since 1976, there have been 10 outbreaks.

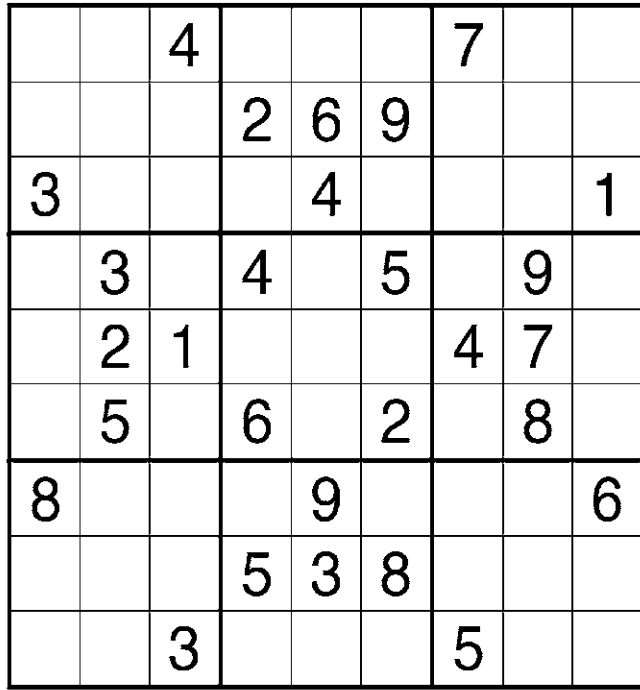

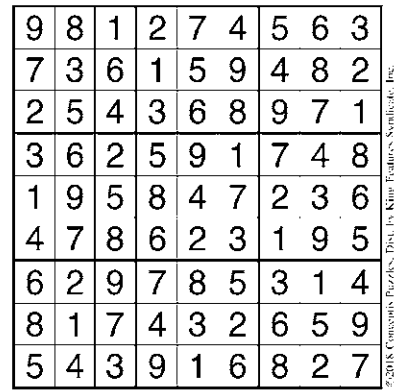
