

Harbour Walk: a new mini Camana Bay breaks ground

Ground was broken last week on a brand-new development for Grand Harbour, said to be a mini Camana Bay for this growing end of the island at Red Bay. Sixty-two residences named Harbour Walk are about to be constructed, with completion set for July 2021. Being built with the aim of attracting young professionals and also those looking for an investment opportunity with promising returns expected on rentals, Harbour Walk will be a collection of one bedroom, one bedroom plus den and two-bedroom units, with a starting price of CI\$293,000.

The development is set to be more than just a collection of homes, however. Polly Legge, the Investment Coordinator at Harbour Walk, CityVest, IRG, said there was a range of particularly interesting amenities that owners could



Unprecedented Numbers Vote at Legal Practitioners Association AGM

Earlier this week, the Cayman Islands Legal Practitioners Association ("CIL-PA") held its first Annual General Meeting to appoint a new democratically elected council.

Nearly 400 CIPLA members participated in the vote at the elections demonstrating the importance of the new association as a representation of the local legal profession.

Seven members of the local legal community have been elected to council with a pre-requisite that the majority of members must be Caymanian, and two of whom must be sole practitioners or lawyers practising at law firms with fewer than 10 lawyers.

David Collins, the newly elected President of CILPA commented, "We were very pleased with the high turnout at our first AGM held earlier this week. CILPA now has over 500 members meaning that around 80% of the legal profession here in the Cayman Islands are now members. This bodes very well for the future development of the profession and the level of support and commitment that we have is greatly appreciated."

Wanda Ebanks, the newly elected Secretary of the CILPA added, "I am honoured to have been elected amongst such an esteemed group of my profession. Council understands that the work now begins and we look forward to engaging and collaborating with our fellow members to help drive forward CILPA's mandate on behalf of the profession".

CILPA was formed in October 2018 and is the professional body representing attorneys in the Cayman Islands. CILPA has also been designated by the Cayman Islands Government as the AML supervisor for attorneys, a critical role for the association and the profession. Over the next two years, CILPA will focus on the development of its supervisory and representative capabilities, including supporting smaller law firms and sole practitioners.

LA Bills to Further Enhance Cayman's AML/CFT Regime

Government is presenting 11 bills, to further strengthen Cayman's anti-money laundering and counter financing of terrorism (AML/CFT) regime, to the Legislative Assembly on Wednesday, 24 July. There will also be two separate bills to handle administrative matters for the Auditors Oversight Authority (AOA) and the Cayman Islands Monetary Authority (CIMA).

During the fifth meeting of the 2018-2019 session, these AML/CFT-related bills will be debated in the LA:

- Banks and Trust Companies (Amendment) Bill, 2019;
- Trusts (Amendment) (No. 2) Bill, 2019;
- The Companies (Amendment) Bill, 2019; The Limited Liability Companies
- (Amendment) Bill, 2019;
- The Limited Liability Partnership (Amendment) Bill, 2019;
- Mutual Funds (Amendment) Bill, 2019;
- Insurance (Amendment) Bill, 2019;Building Societies (Amendment)
- 8ill, 2019;Cooperative Societies (Amend-
- ment) Bill, 2019;
- Money Services (Amendment) Bill, 2019:
- Trade and Business Licensing (Amendment) Bill, 2019

Financial Services Minister Tara Rivers noted that ten of the bills are being presented by the Ministry of Financial Services

'These bills will strengthen our already extensive AML/CFT regime. The Government is committed to addressing the recommendations outlined in the CFATF fourth round mutual evaluation report to further cement our standing as a responsible and responsive jurisdiction in the global fight against money laundering and terrorist financing', Minister Rivers said.

The Banks and Trust Companies (Amendment) Bill, 2019 is intended to ensure that appropriate transparency measures, such as disclosure requirements, are in place for trusts. For the purpose of Basel II, Pillar 3 Market Disclosures, the bill also would empower CIMA to require a licensee holding a licence, in order to establish a banking business or a Cayman banking group, to make public disclosures.

The Trusts (Amendment) (No. 2) Bill, 2019 seeks to insert provisions into the Trusts Law (2018 Revision) that: require trustees and the Registrar of Trusts to share information on registered trusts with other competent authorities; provide sanctions for failure to provide competent authorities with required information; and empower Cabinet to make regulations.

The Companies (Amendment) Bill, 2019 is intended to require a company's basic information, including a list of directors, to be maintained and publicly available. The bill also puts forward stiffer penalties for failure to comply with beneficial ownership obligations under the law.

The Limited Liability Companies (Amendment) Bill, 2019 would ensure that all basic information, including a list of directors, for limited liability companies (LLCs) is publicly available. The bill also would impose sanctions to companies for failure to maintain up-to-date information.

The Limited Liability Partnership (Amendment) Bill, 2019 is similar to the

companies and LLC bills as it would require all basic information on a limited liability partnership (LLP) to be available at the LLP's registered office. The bill also puts forward stiffer sanctions for failure to maintain up-to-date beneficial ownership information.

The Mutual Funds (Amendment) Bill, 2019 and the Insurance (Amendment) Bill, 2019 would sanction licensees, who also provide company management services, where they fail to maintain current beneficial ownership information for their clients. The mutual funds bill also calls for auditors and other professionals who become aware of this failure to notify the relevant authority.

The Building Societies (Amendment) Bill, 2019 and the Cooperative Societies (Amendment) Bill, 2019 would prevent persons from holding (or being the beneficial owner of) a significant controlling interest, or holding a management function, in a financial institution if they are suspected of criminal activity.

The Money Services (Amendment) Bill, 2019 would require money service businesses to monitor their agents' compliance with their AML/CFT programmes and ensure these businesses meet AML/CFT requirements.

Cayman's AML/CFT regime would also be affected by the Trade and Business Licensing (Amendment) Bill, 2019, being put forward by the Ministry of Commerce, to amend the Trade and Business Licensing (TBL) Law to require the TBL Board to consider an applicant's compliance with AML/CFT obligations

before licences are granted, renewed or revoked.

The bills are intended to help address the Caribbean Financial Action Task Force (CFATF)'s March 2019 report on Cayman's AML/CFT regime. The report outlines certain recommended actions to be taken by the Cayman Islands to strengthen the AML/CFT regime. The jurisdiction is under a one-year "Observation Period" by the FATF, ending February 2020, in which it is expected to correct strategic AML/CFT deficiencies. The FATF will review the progress made by the Cayman Islands and, at its June 2020 Plenary, determine if the recommended actions have been taken.

If the degree and quality of progress made by the Cayman Islands do not sat-

isfy the recommended actions, the FATF will issue a public statement regarding the jurisdiction's AML/CFT deficiencies, develop an action plan, and monitor progress against the action plan.

In June, Cayman's AML/CFT regime was strengthened by the passage of the Proceeds of Crime (Amendment) Law, 2019; Securities Investment Business (Amendment) Law, 2019; and the Directors Registration and Licensing (Amendment) Law, 2019.

Outside of the AML/CFT-related bills, this month's LA meeting also will see debate over the Auditors Oversight (Amendment) Bill, 2019 and Monetary Authority (Amendment) (No.2) Bill, 2019.

The Auditors Oversight (Amendment) Bill, 2019 seeks to amend the financial year of the Auditors Oversight Authority Law (2017 Revision) to align with the financial year in the Public Management Finance Law (2018 Revision) and remove inconsistencies.

The Monetary Authority (Amendment) (No.2) Bill, 2019 also seeks to amend the financial year in the Monetary Authority Law (2018 Revision) to align with the financial year in the Public Management Finance Law (2018 Revision) and eliminate inconsistencies. In addition, the bill proposes to authorise CIMA as the facilitator of business continuity and disaster recovery, following a natural disaster, with the power to exempt any affected person or class of persons from any relevant regulatory provisions for a period and under such conditions as CIMA deems suitable.

"Harbour Walk residents get access to a rooftop with open air gym, jogging track, swimming pool and lounge areas, and there is also a rooftop wine and tapas bar," she explained. "We are also looking to reduce our carbon footprint, with geothermal air conditioning, solar panels, electric car charging points and green parking areas."

Ms Legge said that in many ways Harbour Walk will be a mini Camana Bay, "in terms of quality and amenities and its mixed-use nature, bringing in amenities and services which aren't currently available off of the Seven Mile Beach corridor," she stated.

Popular Camana Bay-based gym Anytime Fitness will be providing 24/7 options and the development will feature shops, offices, a restaurant and a café.

One of the biggest issues facing residents of Red Bay and heading east is the horrendous traffic jams that they generally encounter at peak times of the day. Ms

Legge said that the developers would be doing their bit in working with Government to try and alleviate the issue, which can only be compounded should the population of this area increase further.

"We are discussions with the Ministry in relation to possible traffic enhance-

ments in the area and are supportive of any practical initiatives they propose," she said. "A partnership between Government and local developers/landowners is the best way to achieve a solution here and we are fully supportive of such an approach."

lency the Governor, Mr. Martyn Roper attended and spoke to recruits on the first day of a 21-week training course for 11 new Customs and Border Control (CBC) officers.

The new recruits will be trained in a wide array of subjects including, but not limited to; the relevant laws, interviewing techniques, statement writing, the collection and handling of evidence, the fundamentals of the international import/export/transhipment process, inclusive of invoicing, fraud as well as the physical control and restraint of persons.

On the completion of the course the officers will be posted to a variety of roles within the new CBC organisation.

CBC is currently going through a transformation to bring together the former roles of customs and immigration, and to focus the organisation on serious and

organised crime threats, including the smuggling of narcotics, firearms and serious financial crime.

New procedures and techniques are being introduced to enable CBC to operate on an intelligence led basis with the assistance of new technology and cooperation from the airlines.

It is hoped that the new procedures will lead to faster processing of passengers at Owen Roberts International Airport and clarify the procedures for arriving passengers, including the discontinuation of customs declaration forms for passengers with no goods to declare.

The Governor also witnessed a training exercise by CBC's K9 Unit as they searched the Customs warehouse for contraband. The Unit has recently acquired a number of new dogs from the UK which are trained to detect a host

The Minister for Health, Environment, Culture and Housing, Hon. Dwayne Seymour stated "it is always inspiring to see young Caymanians pursue a career serving the people of the Cayman Islands in whatever way they can."

MRCU Director Jim McNelly, PhD echoed this, adding "I am proud to see the next generation of Caymanians become part of our team and help to continue the MRCU's commitment to researching, surveying and controlling the mosquito population across our islands."

The three Caymanians join 13 other DPOs in the MRCU team. Each is responsible for managing the surveillance and treatment of mosquito populations within a specific geographic area across the islands.

For the first time, this approach includes a dedicated person permanently responsible for Little Cayman. In the past, the island's mosquito population was managed through ad-hoc requests.

Their first two weeks as DPOs consisted of an intensive training programme designed to get them up to speed on all surveillance and control-related aspects of their new role.

Mosquito surveillance will form the largest part of their daily duties. Training included techniques for checking the aquatic stages of mosquito development; taking, maintaining and recording field samples and performing residential, swamp and pasture inspections.

As part of control training, the new recruits were taught safety procedures for spray application and which spray formulations are most effective at controlling mosquito populations under different conditions.

The new faces come as two veteran MRCU employees were promoted to Senior DPOs after 55 combined years with the unit.

Marcus Grizzel, who started with the MRCU in 1987, and Leonardo Rodriguez, who started in 1995, have been in their new roles since February this year. ③



Cayman physicians complete doctorate course offered by the HSA

Three physicians of the Cayman Islands Health Services Authority (HSA) have obtained their Doctorate of Medicine in Family Medicine at the HSA, which is accredited by the University of the West Indies (UWI) as a postgraduate training facility for the doctorial level degree.

By completing their degrees Drs Glaister Bell, Carmen Martinez and Lorna Jackson have all advanced from being junior physicians to consultant physicians in the practice of Family Medicine.

Accredited by the UWI four years ago, the four-year programme offered by the HSA provides high quality postgraduate medical education to physicians through core clinical rotations across different specialties within the HSA.

"Family medicine specialty is the branch of medicine that concerns all family members from birth to end of life and entails the holistic care of individuals continuously and comprehensively," Dr Bell said. "We were trained by a highly skilled and experienced faculty that was always ready to provide us with expert and proficient guidance. The course modules covered every aspect of paediatric, adult and community medicine ensuring that we were capable of meeting the growing demands of our diverse patients. We believe that this programme is the way forward for all junior doctors who envision family medicine as their goal and passion."

"The discipline of Family Medicine is gaining prominence as a vehicle for promoting effective primary health care," said HSA's Medical Director Dr Delroy Jefferson, who initiated the accreditation process. "This degree aims to strengthen primary care by developing competent family physicians who are empowered to become leaders and advocates for the future of the profession. The programme will enhance the skills of our doctors allowing them to develop into expert family physicians whose approach will provide continuous, coordinated, comprehensive and cost effective care to patients and the community."

The physicians complete a large percentage of their studies on-island and the remainder at the UWI campus in Jamaica. "The course can be very demanding because you have to balance your studies along with your personal life, and while working full-time as a physician," said Dr. Martinez. "Nonetheless, everything we have learnt has been current, valuable and has broadened our experience and knowledge, which will help us to enhance the quality of care we deliver to patient."

"Through this challenging programme we were enlightened to the process of obtaining evidence based medicine, which is very important in the imple-

mentation of best practices in modern day medical treatments," Dr Jackson stated.

Many physicians after completing their Doctorate of Medicine seek advanced and a more concentrated training through a fellowship. Likewise, Dr Martinez has accepted a fellowship to pursue her Masters in Hematology at the University of Chester in the United Kingdom for a year beginning 1 September.

All physicians entering the Doctorate of Medicine programme at the HSA have obtained their first level Medical Doctor degree. The Doctorate of Medicine is a doctorial level and specialised degree, equivalent to a PhD. Upon completion of the first two years, the student receives an advanced diploma and after the final two years, they receive their Doctorate of Medicine degree.

Currently there are eight physicians at the HSA registered in the Doctorate of Medicine, Family Medicine programme. Of these physicians, Drs Dominic Caudeiron and Maeve Ulett were successful in obtaining the Advanced Diploma in Family Medicine, with Dr. Caudeiron receiving a distinction. Both physicians are progressing to the Doctorate of Medicine.

Drs Anna Matthews and Paul Williams, physicians in family medicine, serve as facilitators for the current students





ing your hurricane preparedness kit is something that should be done well in advance. These ten things should have been acquired, before long lines and shortages kick in.

Water

One of the first things to sell out in stores in the face of potential hurricane landfall is water. Water sources can be contaminated by flooding, and services can take time to be restored. Agencies recommend a gallon per person per day with a 3-day minimum and a 2-week preferred time frame. Don't forget pets; a 50-pound dog will need as much water as a human.

Cash

While many financial institutions have learned from past storms and prepare for demand with an influx of cash to local ATMs, waiting until the last minute to pull emergency cash can mean waiting in long lines and seeing availability disappear. Once the storm hits, power and network connections can fail, leaving bank customers with no way to access their money.

Hygiene Supplies

If a hurricane makes landfall, and power and municipal services are inter-

Hurricane season has started. Creat- rupted, staying clean is the best way to stave off disease. Toilet paper is an obvious choice, but also stock up on wet wipes, hand sanitizer, and any other necessary hygiene products as well as extra diapers and baby wipes if necessary. Paper towels, disinfectant wipes and other cleaning supplies can help make surfaces safer after flood and wind driven rain cause contamination.

First Aid Supplies

Medical centers may be swamped with more critical cases, so being able to effectively administer first aid can help you get through small injuries until more help is available. Besides Band-Aids and antibiotic ointment, stock cold packs, heat packs, Ace bandages, gauze, and medical tape. If you have any old wrist, ankle, knee, or back braces, shoulder or elbow slings, crutches, or a wheelchair, make sure they are easy to access. If you don't need them a neighbor might. Don't forget to swing by the pharmacy to check on prescriptions and stock up on over the counter medications.

Batteries

Another item to quickly drop in supply as demand rises is batteries and other energy sources. Batteries can be used to power flashlights, handheld



radios, diabetic testing and monitoring devices, and more. Adding a few pocket size power banks can help you and your family keep mobile devices on and connected, and solar power chargers can be used once the sun comes out again to help charge small items. If you opt for a generator, shop early before local stores run out and don't forget a safe storage system for fuel.

Gasoline

Even if you don't need to power a generator, you may need to evacuate. Such a trip can be long with a lot of stop and go traffic that burns excessive fuel. Keeping your vehicle(s) well fueled in advance of a storm can help you avoid lengthy waits at gas stations, potential price gouging, and the possibility of a gas shortage. ③

Jet Ski Used by American Couple that Went Missing in Barbados is Recovered Off Guadeloupe

The French Navy confirmed over the weekend that a jet ski bearing the registration number of the one that an American couple was riding when they went missing in Barbados last month, was found off the coast of Guadeloupe.

But there was no sign of the missing duo, Oscar Suarez, 32, or Magdalena Devil, 25.

The dispatch from the French authorities to the Barbados Coast Guard stated in part:

"Be informed that this Saturday July 6, at 1645Z, the French navy ship Ventôse has localised the jet ski registered $162\mathrm{H}$ (see attached pictures), in position $15^{\circ}53.82N - 061^{\circ}40.43W$. This is in Guadeloupe, between les Saintes islands and Guadeloupe (see map), 305°/Pointe à Vache/2.7 NM. It seems to be the jet ski involved in your search and rescue operation, concerning two US citizens (Mrs. Magdalena Devil and Mr. Oscar Suarez). Can you confirm this is the missing jet ski? We have tasked (a) French rescue boat to recover it and tow it."

Prime Minister Mia Mottley and Minister of Tourism Kerrie Symmonds were informed of the discovery and a statement from the government said local authorities would make contact with the families to inform them of the development.

Devil and Suarez, who were visiting Barbados from New Jersey, rented a jet ski at a beach on the west coast of the island on June 24 for a half-hour ride, but never returned.

Last Monday, Prime Minister Mottley met with the couple's families at Ilaro Court, her official residence. She expressed regret at the unfortunate events and invited them to return to the island anytime over the next year at Government's expense, if it would assist them in bringing closure to the matter.

Police investigations into the disappearance continue. 🌎

Another Record **Year Of Tourist Arrivals Projected** for Barbados

Barbados is on track for another re-

cord year of tourist arrivals.

That disclosure came recently from Chief Executive Officer (CEO) of the Barbados Tourism Marketing Inc., William

"The BTMI is already reporting 324,551 arrivals for 2019, which is four per cent above the same period for 2018. The UK grew by 9.6 per cent over 2018, and the US, which has been showing consistent increases, is up 7.5 per cent over last year.

"Other successes were recorded in the Caribbean, Central and South America, and also Germany...who we are watching closely, as we welcome a new Lufthansa service this October," he said.

Speaking to 60 tour operators from the UK and Ireland, the CEO highlighted the island's attractions, including its newest ones, the Rum Vault at Colony Club Hotel, St. James, and the St. Nicholas Abbey Heritage Railway tours, in St.

He also mentioned Barbados' newest accommodation, which opened this month, Abidah by Accra, an adult only boutique hotel located in the southern parish of Christ Church. 🏈



Jamaica Expecting to Benefit From Cannabis Reforms Relating to Cannabis in US and Europe

Director of the Cannabis Licensing Authority (CLA), Delano Seiveright says emerging reforms in the United States and Europe relating to cannabis are exactly what Jamaica needs to benefit from the lucrative medical marijuana industry.

Seiveright, who recently returned from Great Britain where he joined some 80 panellists from countries across the globe at a Cannabis Europa Conference, said the stakes are too high for Jamaica not to be prepared to be a huge part of an estimated US\$100 billion global medical marijuana market.

He said it is also important that the traditional local growers are given the opportunity to transition into the medicinal cannabis sector, where they are able to position themselves to capitalise on "what will be an inevitable boom".

"We are all here on the strength and hard work of our traditional growers. Those are the growers who ensured that we have a brand Jamaica, in relation to cannabis and we as a body (CLA) will be doing all in our power to ensure that those who still operate in the tradition-

al industry can transition into the legal cannabis industry," Seiveright added.

He said that in a number of states in the USA and also in Canada, medicinal cannabis has already taken on a life of

its own and has been generating billions of dollars annually towards those econ-

"We see what is happening in the United States where Illinois just became the latest State to legalise marijuana," Seiveright said.

"A number of US attorneys general have also been lobbying the United States Treasury Department to loosen banking laws that are hostile to cannabis growers. As our Minister of Industry, Commerce, Agriculture and Fisheries Audley Shaw, keeps saying, Jamaica cannot afford to miss this boat," he said.

Minister Shaw, at a function in Montego Bay, St. James, recently, said that in addition to being in solidarity with the US attorneys general, the Jamaican Government will be using all its diplomatic channels to lobby the United States Treasury Department to deal with the problem of de-risking, so that "our cannabis farmers can have access to services from our local banks".

Seiveright said his visit to England has only served to reaffirm his belief that Jamaica can be a pioneer for cannabis reform globally.

"Everyone is coming around to the benefits to be had from being a part of medicinal cannabis," he said.


