
# Cross border cooperation needed to combat crime

The Cayman Islands welcomed Commissioners of Police from all over the Caribbean last week, hosting the 34th annual general meeting and conference of the Association of Caribbean Commissioners of Police, of which there are 25 member states across the Caribbean. The four-day event took place at the Grand Cayman Marriott Beach Resort and focused on the theme of improving regional policing effectiveness in a changing world.

Following an opening ceremony and parade, the Commissioners considered the first topic of the agenda, policing in a digital age. Lieutenant Colonel Michael Jones, Executive Director of the Caribbean Community (CARICOM) Implementation Agency for Crime and Security (IMPACS), spoke on the topic of transnational organised crime, which he said was a growing threat to regional security in this digital age.

Mr Jones spoke about the challenges the Caribbean faced, stating that, in this regard, that while the digital age brought huge benefits with its global reach bringing everyone to the same level, technology that could do good could also do evil. Illustrating the reach of the internet, Mr Jones said that 56.8 per cent of the global population, or around 4.4 billion people, had access to the internet, which was becoming viewed as

a basic human right. Referring to the potential crimes this connection exposed people to, he said: "It's not just a national problem; it knows no boundaries." This was of particular pertinence to the Caribbean as this region had the fourth largest internet usage penetration globally, he advised.

The digital age, or Internet of Things, as he termed it, was found in all facets

### **COURTS DO NOT** HAVE THE DUTY TO REDEFINE MARRIAGE

In the recent (and only) judicial review case regarding same-sex marriage, the Honourable Chief Justice made two rulings: one, that the present marriage law of the Cayman Islands is discriminatory against persons of the same sex who wish to marry each other, and two, that the marriage law should be changed to accommodate such wishes. What is most noteworthy here is that in order to redress the assumed discrimination, the C.J. proceeded to redefine marriage in order to eliminate future discrimination. On a matter of principle, however, this approach sets a very dangerous precedent in local jurisprudence. If this ruling is left to stand, it would logically endanger every other law in which the legislature has wisely decided that some level of just and reasonable discrimination needed to be exercised (after all, discrimination is a neutral exercise, not necessarily a negative or malicious one). Laws relating to immigration, voting rights and the holding of public office, as well as participation in commercial enterprises, and others that are designed to protect Caymanians from indiscriminate and unfair actions from foreign persons or enterprises could very well be ruled as discriminatory and then redefined by the courts to remove the purported discrimination.

Courts have neither a duty nor right to redefine categories or domains in order to accommodate petitioners whose requests cannot be met under the prevailing provisions of the laws with respect to those categories. The duty of the courts is to interpret the law as it stands in relation to the existing categories to which the law applies. For example, the courts do not have a duty, nor do they have the right to change the

definition of legal residency (or Caymanian Status) in order to provide 'rights' for expatriates who wish unrestricted entry and domicile in the Cayman Islands. In the same way, the present definition of marriage excludes certain "rights"—such as the right to multiple spouses, the right to child marriage and the right to marry someone of the same

Furthermore, marriage as it has been commonly ( and universally) understood was not based on some arbitrary definition by a legislature or court, but was based on the natural understanding of marriage as a legally protected social entity for the promulgation of the human family, which is the basic and foundational unit of society. It is not tradition that has given us marriage as we have known it for centuries, but common sense aligned with nature. The arbitrary redefinition of marriage by the courts is therefore an unhealthy act of social engineering by a public body that has neither the duty nor right to exercise such power.

# Cross border cooperation needed to combat crime

of business, with most businesses using some form of ICT or internet capabilities. This made the problem more complex because of the different domains in which crimes could be committed: over land, sea, air or cyberspace. This begged the question therefore, why there was not more cooperation in policing operations trying to apprehend transnational organised crime, he said.

#### **Changes needed**

The law itself was in need of amending because the UN Convention on Transnational Organised Crime (November 2000) to which law enforcement adhered, stated that three or more individuals were needed to form an 'organised criminal group' acting together with the aim of committing serious crime described within the Convention. This was

difficult to follow when dealing with issues such as radicalisation. For example, where a single individual overseas was trying to coax someone on the Caribbean into joining a terrorist organisation, as this person would not fit into the definition of three or more persons.

Another example was the unlawful political influence that could be exerted over voters in a country. Mr Jones said some member states were required to remove posters on voting days so as not to unduly influence voters, but he questioned whether that ban reached social media such as Facebook.

"How do you police that?" he questioned, "Especially when it's done anonymously."

While current legislation was all well and good when addressing traditional cyber security threats, Mr Jones questioned whether hybrids of such threats were covered, for example if someone deliberately hacked into an individual's pacemaker, he asked whether that be considered attempted murder. The Caribbean was lagging behind on many aspects of policing the issue and it needed to be looked at holistically and not separately, he said.

The Caribbean was no stranger to cyber organised crime, with Jamaica reporting \$100 million lost to cybercrime in 2016. This was a conservative estimate because not all cybercrime was reported, he advised. ATM skimming ran through the entire region, Mr Jones confirmed.

Vulnerabilities occurred within business, with the public sector showing greater vulnerability than the private sector, he explained. Fundamental systems needed to be harmonised across the region, Mr Jones said, citing the Eastern Caribbean Central Bank's establishment of cryptocurrencies for the

OECS as an issue because many of these countries did not possess regulations to control the use of cryptocurrencies in member states, underpinning the fact that further legislation was needed.

A big regional challenge was that criminals were adapting faster than governments, he advised.

#### **Solutions**

Member countries needed to consider enhanced intelligence information sharing, build international cooperation and allocate appropriate responses to the issue. Mr Jones urged member states to have a component within their national budget which could be used for international cooperation. Members also needed to strengthen their interdiction, investigation and prosecution capabilities and form a coalition to develop a cyber security plan of action to increase resilience for members.

# Culture and Heritage Policy Moves Forward

The implementation of the first national Culture and Heritage Policy and Strategic Plan (CHPP) 2017-2026 takes a step forward, as the policy committee reconvenes to develop the Costed Operational Plan.

The CHPP, which was approved by Cabinet and tabled in the Legislative Assembly in early 2017, sets out the policy directions for the culture and heritage sectors for the next 10 years. The policy aims to protect and preserve aspects of Caymanian heritage, nurture and foster cultural expression and support the further growth of all creative industries in the Cayman Islands.

The committee has reconvened to begin the process of developing the Costed Operational Plan (CoP), which will set out the blueprint for executing the policy and ensuring the necessary resources are made available.

"I'm pleased to be moving into the next phase of the Culture and Heritage Policy and Strategic Plan," said Minister for Culture Hon. Dwayne Seymour. "While the policy does an excellent job of outlining the principles and objectives to support the cultural expression of our people, we will only see the benefits when we implement it. The creation of the Costed Operational Plan is an essential step to doing just that."

Committee meetings will take place monthly to identify the short-, medium- and long-term priorities for the CoP. In addition, the Ministry of Culture will be holding meetings with various stakeholders to gain their insights.

The stakeholder meetings will be conducted with special interest groups in the business, tourism, and education sector; with people of various demographics and by district. Meetings have already been held with several stakeholders including the Economics & Statistics Office, the Farmers and Artisans Market and the Ministry of Education.

"Public engagement was an important part of developing the policy and

strategic plan," notes Ministry Chief Officer Jennifer Ahearn. "Engagement will continue to be an important element of the policy's implementation because at the end of the day this is a policy for the people and we want to make sure everyone has a voice and is heard."

"Operationalising this policy has now become critical to ensure the transfer of skills of boat building and thatch crafting from the older generation to the younger set, and also to ensure preservation our built heritage, among other important aspects of the policy" added her deputy Nancy Barnard.

Updates on the progress of the Culture and Heritage Policy and the aligned CoP will be provided to the public, as well as notices of engagement opportunities. The costed plan is expected to the completed later in 2019, at which point the focus will shift to implementation.

### UPDATE: CIFS Extinguishes Brush Fire in Lower Valley

The Cayman Islands Fire Service (CIFS) has confirmed that the brush fire which occurred in Lower Valley yesterday (Wednesday, 22 May 2019), is no longer burning.

After more than four hours of battling the flames and working in multiple areas to contain the fire, CIFS officers were able to successfully extinguish it at around 6 p.m. last night.

Fire personnel arrived on scene at 2:30 p.m. yesterday, and remained there hours after the fire was out to conduct perimeter checks and ensure there was no re-ignition or further threats.

Thanks to inter-agency support from the Royal Cayman Islands Police Service and its infrared drone technology, fire officers were able to formulate an effective fire-fighting strate-

gy to tackle any hotspots before they became a threat to the surrounding community.

The cause of the fire is unknown. No injuries occurred as a result of the incident. •

Those areas of cooperation include the Constitutional reforms being negotiated with the United Kingdom Government and the work that the National Security Council is doing to make our Islands safer.



# Cruise Port Referendum (CPR): 5,300 signatures collected | Petition to be delivered to Cabinet

### THERESA MAY QUITS BUT THE BREXIT PROBLEMS REMAIN

Her voice cracking in an uncharacteristic display of emotion, British Prime Minister Theresa May on Friday announced her resignation bringing to an end her turbulent Brexit-laden three years in office.

With the pain of defeat etched on her face, despite the stoicism of her departure speech, Mrs May announced that she will resign as leader of the Conservative Party on June 7th.

She will, however, stay on as Prime Minister until such time that her successor is chosen.

It's clearly a case of Mrs May jumping before she was pushed as she was looking down the barrels of an ultimatum from the powerful 1922 committee of backbenchers for failing to deliver Brexit or some acceptable form of it.

The process to replace her as Conservative Party prime minister will begin the week after she gives up the party's leadership.

It's worth pointing out what Mrs May has, in fact, resigned from.

While leader of the Conservative Party is almost inextricably linked to the office of Prime Minister, Mrs May will stay on in the role for however long it takes her party to decide on a leader.

It's not quite clear how long that would take, nor what decision-making powers Mrs May will continue to hold and wield in the interim.

There are several important ceremonial events coming up over which she will officiate.

The main one is the visit of the President of the United States, Donald Trump and the D-Day commemoration.

The timing of what is essentially the first steps of her own exit coincidentally, or perhaps strategically, allows her to be in office in full, rather than some semblance of a caretaker capacity, to meet the US president on his upcoming state visit to the UK.

But even that could be tricky as Mr Trump, not known for his diplomatic skills, could very well slip into an 'I-toldyou-so' mode.

He has been a constant critic of Mrs May over her handling of Brexit, which has been her undoing.

The US leader has been an ardent supporter of Mrs May's arch Brexit rival, Nigel Farage, whose newly formed Brexit Party was expected to trounce both the Conservatives and Labour parties in last week's European parliament elections.

Mrs May also has other pre-arranged prime-ministerial engagements coming up, including Brexit-related meetings with the EU and meetings in Japan.

#### THE BREXIT EFFECT

The days leading up to her resignation announcement must have been nerve-racking for the outgoing Prime

Her practised outward persona - or facade - of being steely, tenacious and determined, seemed to be fraying by Wednesday evening when British media

caught her in a vulnerable moment. A published paparazzi photo (no doubt of high value by now) shows what appeared to be a teary-eyed Mrs May in the back of her official car.

Behind the steely facade, her critics say is a leader at the ends of her political career, doggedly trying and repeatedly failing to orchestrate her legacy.

By Thursday, the European parliamentary election day in the UK - that shouldn't have been as the UK should have already left the EU - new writings had appeared on the wall. In fact, a series of them.

It was reported that Mrs May was, despite advice against it, going to make a fourth attempt to seek UK parliamentary approval for the deal she has struck with the EU.

She had already brought to the parliament three times before only to have it rejected all three times, one of those by the largest margin said to be in British parliamentary history for a sitting prime min-

In addition to her attempt to coax or even ram it through parliament, her efforts to seek a politically unorthodox accommodation with the opposition Labour Party, and even take her deal on a glad-handing tour of the UK to directly win over British hearts and minds to it, have all been futile.

By late Thursday came another change that Mrs May had shelved plans for a fourth attempt at getting parliamentary approval for her deal.

By Friday morning, the 37 resignations from her government over Brexit

had risen to 38. It had been hinted that she would make an announcement on Friday

morning. When that announcement came mid-morning Friday, her determined defence of her achievements in office was only overshadowed by the failures

she omitted. Mrs May chose only to admit that she was unable to get parliamentary support for her Brexit deal.

At the end though, the impenetrable wall of stoicism she had built around

Betrayed by her voice and the pain of defeat etched on her face, Mrs May's tough exterior was on the verge of dissolving into tears before a global audience.

It was a touching moment. She stepped back from the podium and took the first steps away from power as she strode back into her office, defeated by

The Conservative Party has been in near disarray and much of that blame is

placed squarely on the shoulders of Mrs May. The Labour Party is not doing much

better either. It's leader Jeremy Corbyn is battling growing doubts about his leadership.

That makes the outcome of the EU parliamentary elections unusually important this time as a gauge of the state

of British politics. It could be an indicator of how the choice will go when the Conservatives set about selecting a replacement for

That person is now expected to be in place by July before parliament goes on summer recess.

One thing is clear, however; internal divisions over Europe have claimed the career of another Conservative Party prime minister.

The key question now becomes what will a new Prime Minister do?

What options would he or she have? Outgoing Prime Minister May had at one time declared "no deal is better than a bad deal" but had to ditch that mantra under pressure from inside and outside her party, in the face of demands for a

better deal. But "no deal is better than Mrs May's deal" is known to be an option favoured by at least three of the known contenders for her job.

Whoever wins the leadership vote whenever that is held - will have until October to try for a better deal than Mrs May's which will mean attempting to reopen divorce talks with the

If that fails, to borrow from the Atlantic hurricane season limerick it will be 'October all over and 'no deal' will automatically kick in... unless her successor goes for that option earlier.

Until then, anyone of Mrs May's alternating slogans will still be available to recycle - more in deed and not just mere

- "Strong and stable leadership"
- "Brexit means Brexit"
- "No deal is better than a bad deal" (?)

### LIAT Loses Appeal and Must Pay Dismissed Employee More Than US\$1.5 Million

Regional airline LIAT has failed in its efforts to avoid paying more than US\$1 million to a former employee in the United States Virgin Islands (USVI) who was forced out of the company, after almost five decades of employment, because of his age.

The Antigua-based company had appealed a decision by a jury in February to award William Cherubin US\$1,551,320 in damages. But Justice Douglas Brady of the USVI Superior Court has dismissed the appeal and ordered the airline to pay the money.

Cherubin took the cash-strapped airline to court claiming he had been fired because of his age – contrary to LIAT's claim that it was because of poor performance –, which was in contravention of the Virgin Islands Civil Rights Act which prohibits discrimination of employees on the basis of age.



He was 71 years old when he was dismissed on June 4, 2015, without notice, with the company accusing him of violating company policy on three occasions. During his 47 years at the compa-

ny, Cherubin had risen from a job as a ticket agent to manager of ground operations

Justice Brady said in his ruling that "the totality of the trial evidence was

sufficient to permit a jury to inference that LIAT's proffered reasons [for Cherubin's dismissal] were false".

"Evidence of Cherubin's emotional pain and suffering following his termination was sufficient that the Court cannot find that the jury's verdict was seriously erroneous as against the clear weight of the evidence," he said.

"Accordingly, the Court will not interfere with the jury's award and LIAT's motion for a new trial will be denied."

During the trial, it had been disclosed that four years before Cherubin was fired, LIAT offered employees over the age of 62, including Cherubin, a retirement package in exchange for their voluntary resignations.

Cherubin's supervisors had urged him to take the offer, telling him he was over the typical retirement age. But he decided to continue working.

### Medical Marijuana Products Approved For Importation in Barbados

The Ministry of Health and Wellness has approved five marijuana-based drugs to be placed on the National Drug Formulary, the list of affordable generic and brand-name medications offered by the Barbados Drug Service (BDS).

The BDS will procure the medications and doctors will be able to prescribe

them. But there will be no smoking allowed

News of this came yesterday from Minister of Health and Wellness, Lt. Col. Jeffrey Bostic, who said the decision followed recommendations from the Barbados National Drug Formulary Committee.

He made it clear that the smoking of marijuana would not be part of the process since there was no scientific evidence to suggest that there were any benefits in terms of ailments.

"The Drug Formulary Committee made a strong recommendation on this...so that was ruled out from day one, and that was presented to Cabinet and it was accepted, and we are going to stay with that until any other information is made available to the ministry to suggest otherwise," he explained.

The Health and Wellness Minister told the audience that the training seminar was mandated by

Cabinet in order to ensure that high standards were set as the project advanced.

He said that he had been made aware that there were stores in Bridgetown that were already selling the products.

"Let me say that I will be issuing a warning this week, a reminder of the law, and after that, we will enforce the law in its fullest to ensure that such persons come to a Christian under-

standing of right and wrong. The laws are not to be broken," Bostic said, stressing that certification and training were essential parts of the process.

He noted that while the Ministry of Health and Wellness was responsible for this aspect of the project, the major part of the project would be overseen by the Ministry of Agriculture, since it was government's intention to get involved in every aspect, including cultivation,



production, marketing, and research and development.

"And, I give the assurance that the average Barbadian will not be excluded from this process.... Persons who might have been ostracized and even criminalized in the past are being included in this process, as we try to map out the direction that we are going to go with this industry," Minister Bostic added.

# Jamaicans Face Prison Time if Caught Wasting Water As Drought Continues

People who waste water in Jamaica, amid an ongoing drought, could be fined or face time behind bars.

The National Water Commission (NWC) has moved to make it a prosecutable offence to either waste water or use excessive amounts of its potable water for non-essential purposes.

In a prohibition notice published in the newspapers yesterday, which takes effect on Friday, the NWC said that more stringent water conservation measures must now be observed and the limited potable water that is available should be reserved for essential uses such as drinking, cooking, washing, bathing and sanitation.

Some of the breaches of the prohibition order are using NWC-supplied water in drought-affected areas for: watering of gardens, lawns, grounds and farms; refilling of tanks, ponds, or swimming pools and/or for use other than

normal domestic services; washing of vehicles by the use of a hose; watering or washing roadways, pavements, paths, garages; and any purpose which may require the use of a considerable or excessive quantity of water.

Persons who break the law may be prosecuted; and if convicted, they are liable to a fine imposed by the parish courts or imprisonment for up to 30 days if they fail to pay the fine.

NWC Corporate Communications Manager Charles Buchanan said the prohibition order is intended to send a signal to the population that not only is it not right to waste water from an already limited supply, but it is also now illegal.

"We're hoping that it will serve to persuade persons to do the right thing and in instances where persons persist in doing the wrong thing, we would have the force of law to support us in taking action against them," he

Meantime, the Government has allocated an additional J\$100 million (US\$743,496) for the trucking of water and distribution of tanks to parishes affected by the current dry spell, including Kingston, St Andrew, Portland, St Mary and St. Elizabeth.

Prime Minister Andrew Holness made the announcement during the sitting of the House of Repu

sitting of the House of Representatives yesterday.

"The NWC will continue to spend on trucking of water and (provide) water tanks to the most affected parishes," he said. Prime Minister Holness further informed that the Minister without Portfolio in the Ministry of Economic



Growth and Job Creation, Hon. Pearnel Charles Jr., has been instructed to meet with the Members of Parliament and Councillors of the affected parishes, to work out trucking schedules for communities, with emphasis on critical services such as the hospitals, health centres and schools.

### ILO Urges Region to Embrace Free Movement

The head of the International Labour Organization (ILO) is urging Caribbean Community (CARICOM) countries to embrace immigration and quickly rid themselves of a "toxic" anti-immigration stance

ILO Director-General Guy Ryder told the Barbados Today online newspaper that although the time is ripe for ramped-up free movement of workers, the notion is surprisingly unpopular.

He pointed out that given Barbadian concerns that workforce levels are unsustainable given an aging population, immigration was one of the fixes that should be seriously considered.

But Ryder suggested this negative attitude to immigration was by no means limited to the Caribbean but had now become a global reality.

"Here is one of the paradoxes of our time and we are seeing it across the board. At a time when the economic case for more liberal migration has never been stronger because we will all benefit economically from more liberal and permissive migration, the political and social obstacles to migration seem to be growing," he said.

Ryder explained that several regional leaders, including Prime Minister Mia Mottley have highlighted this as a concern, which is hindering the obvious solution to underpopulation and aging population facing several Caribbean countries.

"This is becoming a toxic issue and people are becoming very defensive. In my view, I think we have to reconsider how we react to this unhelpful toxicity throughout the migration mobility process," he said.

"I met with the Prime Minister of Barbados yesterday who noted that in the Caribbean we are totally underpopulated but yet we are seeing this type of resistance and nervousness to increased migration."

Last August, the longstanding visa requirement for Haitians coming to Barbados was lifted.

But the early stages of the visa-free entry from CARICOM's poorest member state did not go smoothly, as many Haitians made the journey to Barbados in search of work. Some ended being stranded in the country after promises of jobs failed to materialize. Critics blamed the lifting of the visa requirement for the problem.

Earlier this year, Minister of Home Affairs Edmund Hinkson, who holds the immigration portfolio, unveiled Government's plans to enhance the labour force by addressing the island's

immediate need for skilled people through a policy of "managed migration".

He said that the island, however, would not be open to "those who are going to be a drain on our economy or public purse", but would be welcoming "those who are productive, who have skills. We need more young people in this country in their most productive age".

Ryder strongly supported Government's stance on immigration but not-

ed that in order for it to be effective, there needed to be buy-in across the board.

He said: "The fact of the matter is that where skills shortages exist at a certain location, one way of compensating is simply to facilitate labour mobility. This could be restricted to the CARICOM region or it could be extended globally. However, we need to get over this reticence thinking towards migration." (Barbados Today)


