## Opposition Leader calls for Cruise Port Contingency Plan

With the latest Tourism Department figures showing a bumper year for cruise ship passenger arrivals in 2018, surpassing the trend of steadily increasing annual figures, the Leader of the Opposition the Hon. Ezzard Miller has expressed concerns about the lack of information on interim arrangements for processing of passengers should the cruise port project materialize as proposed.

At the same time, Mr. Miller hastened to underscore that "the Op-

The results from the survey, which also focuses on youth mental health issues, will be revealed in the opening key note presentation and will form discussion points on a series of topics surrounding risk factors of mental health throughout the symposium.

# Community Policing Department Holds Crime Prevention Workshop in Bodden Town

Community Policing Officers in the Bodden Town District (Beats 3, 4 and 5) came together in the North Sound Gardens community last Sunday, 27 January, to talk about neighbourhood security with residents during one of the Community Policing Department's first crime prevention workshops of 2019.

"It is our intention to hold this kind of educational meeting in each community policing beat this year," said Chief Inspector Everton Spence, who manages both the Community Policing and Traffic portfolios. "The field of crime prevention and reduction is always developing, in terms of technology and methods, and we want to share these developments with residents along with the crime trends we are seeing on the islands and in their area."

During the presentation officers demonstrated new and compact alarm devices for home and property as well

as "pin" alarms that can be worn while exercising outside to enhance personal safety. Alongside demonstrations of new technology, officers also emphasized the importance of neighbourhood watches to reduce crime and also improve the quality of life in an area.

"Devices and alarms, while effective, are no substitute for active and watchful neighbours when it comes to crime reduction in an area," continued Chief Inspector Spence. "The connectedness and watchfulness of a neighbourhood makes it harder for suspicious and criminal activity to go unnoticed, which is what criminals count on."

"Since spring of 2017, when Bodden Town had a high burglary rate, several new neighbourhood watches have been launched, bringing the total number in the district to fourteen," said PS Cornelius Pompey, head of the Bodden Town Community Policing sector, "and we have seen burglaries drop through-

out the district. While significant arrests were made, I have no doubt that more active watches in communities also contributed to this crime reduction."

# Leader of the Opposition Calls for Cruise Port Contingency Plan

position absolutely opposes the cruise port project, fully expects the referendum will be supported by the required number of signatures, and firmly believes that the opposition to the port project will win when the referendum is put to the vote."

However, Mr. Miller said it was important to call attention to "yet another aspect of Government's failure to communicate" that could add to what he views as "another potentially serious consequence":

"So far," Mr. Miller elaborated, "Government has said nothing about how they plan to mitigate the impact of the dredging and complex construction activities for the proposed cruise ship port on the disembarkation, processing and return of passengers to ships, as well as passengers' ease of access to landside recreational arrangements," Mr. Miller said, adding: "How that management aspect that could have markedly adverse impacts on the future of the industry will be addressed has to be a concern for the industry and the population as a whole and should be addressed."

Continuing, Mr. Miller said: "At the very least, we need an explanation by Government on how the disembarkation and re-boarding of passengers will be handled over the two-to-three years of works—if the project sees the light of day."

In the meantime, Mr. Miller continues to refute the key argument advanced for the necessity for the port—that tendering is not feasible for the debarking and re-boarding of passengers, especially for the larger ships.

"It is clear that cruise passengers continue to be successfully tendered, an arrangement that will apply when one of the largest cruise ships in the world, the 5,700-passenger mega ship by MSC Cruise Line, the MSC Meraviglia, anchors in Cayman waters in November as scheduled, Mr. Miller said.

"The trend of the increasing numbers of cruise-ship passenger arrivals and the tendering of the mammoth Oasis

class ship later this year," Mr. Miller said, "undermine Government's argument that tendering poses an overwhelming threat to the continued wellbeing of the cruise industry."

As for any claim that dockside disembarkation of cruise passengers is more efficient than ferrying passengers by tender, Mr. Miller referenced the 11 August 2015 Environmental Assessment Board's review of the Environmental Impact Assessment (EIA) undertaken by W. F. Baird and Associates, consultants commissioned by the Government.

On page 20 of the board's review, under the heading of "Tendering vs. berthing," the board reported that the EIA had considered "two scenarios for disembarkation rates, one with four Carnival Magic-sized vessels at berth and a second, with two Carnival Magic-sized vessels and two Oasis-sized vessels at berth."

The board reported that the EIA had concluded on page 310 "that for both of these scenarios, the disembarkation rates with cruise berthing facility is within the range of passenger-disembarkation rates achieved with tendering, i.e., cruise berthing will not result in a quicker rate of disembarkation."

In addition, the EIA noted that passengers disembarking at berth would have longer walking distances, ranging "from approximately 1,200 to 1,800 feet, as compared to approximately 450 feet with existing tender operation."

Another disadvantage from cruise berthing identified by the EIA and reported by the board, is the "lag time which can result from the berthing of cruise ships."

Mr. Miller nevertheless went on to clarify that he is as much in support of the cruise industry as he is of the stay-over visitor sector, but he was concerned that scarce investment resources be placed where the returns would be of greatest value to the people of the Cayman Islands.

This was specially so, he said, "given that berthing will not add any additional time on shore—but could actually re-



duce shore time—which is mainly what cruise passengers care most about."

With regard to the business case for investing so massively in the cruise port despite these disadvantages, Mr. Miller pointed to the latest available statistics that show that revenue from stay-over passengers continue the long-established trend of exceeding by far the spend by cruise passengers: The latest estimate of cruise passengers' annual spending is US\$199.9 million, compared to US\$680 million for stay-over visitors, a ratio of more than one to three, respectively.

At the same time, "There is no question that we do want to protect the cruise industry," Mr. Miller said, adding that an-

other serious consequence of "this risky project is a scenario that mismanagement could result in cruise ships deciding to reroute to bypass Cayman, with its potential for an eventual decline in Cayman's cruise industry," Mr. Miller said.

"While the Opposition remains opposed to the project and do not believe it will become a reality, the lack of information on the interim management for the disembarking and re-boarding of cruise passengers is definitely another big concern joining all the others, including costs, and environmental and business impacts," Mr. Miller said. "It would be really ironic that the costliest investment resulted in the gravest of consequences." 🌐

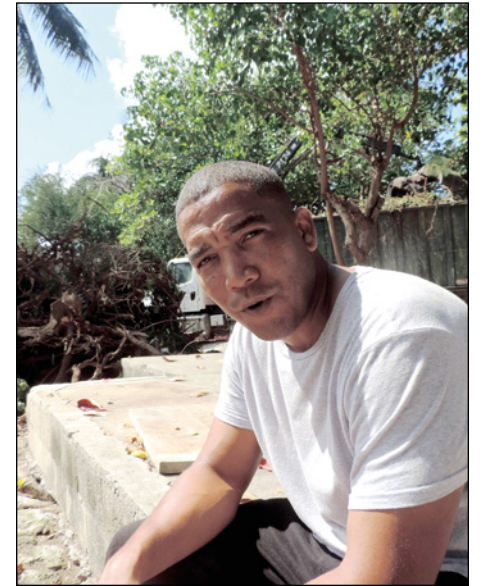

## JMU Assists Paddle Boarders in Distress

Shortly after 7:00PM on Thursday, 31 January, the 9-1-1 Communications Centre dispatched officers to a report of persons in distress in the water off West Bay Public Beach. Two persons were on a paddle board drifting out to sea and were having difficulties returning to shore. Officers from the Joint Marine Unit also deployed to assist in M/V Typhoon.

The persons on the paddleboard were able to communicate with officers on shore via mobile phone, and were instructed to turn on the phone's flashlight in order to make it easier for the JMU officers to locate them. They were subsequently located by the officers and transported safely to shore.

"This incident shows how easily one can get into a dangerous situation while participating in water-related activities, even something like paddle boarding," said A/Superintendent Brad Ebanks, "That's why it is always advisable to carry some means of communication with you as this is one of the tools that will help ensure your safety."

## Update: Police Request Public assistance to locate missing man

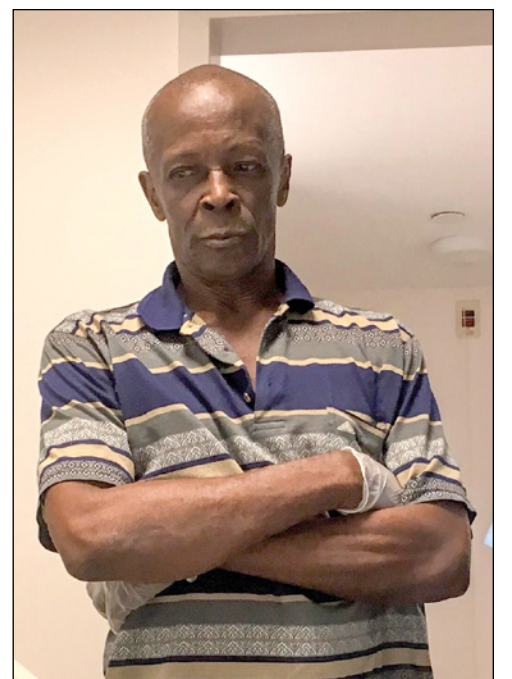
As of Friday afternoon, 1 February, Mr. Whitely's whereabouts remain unknown. At this point in the investigation, with several enquiries conducted, it has been determined that the last confirmed sighting of Mr. Whitely was on **Boxing Day, 26 December, 2018**. Previous information that he was sighted on Seymour Road in mid-January has been determined to be incorrect.

Eral Keith Whitely, age 72 of George Town, was last seen sometime on or near Christmas Day, 25 December, 2018, in the vicinity of Brushy Avenue in George Town, which is located in the area off Godfrey Nixon Way. He has not been seen since.

He is described as being of slim build, dark complexion, about 5' 10" in height and is bald. He typically wears baseball caps and glasses, with a white t-shirt, blue jeans and sneakers. A picture of him is attached. There are indications that he may have been sleeping in abandoned vehicles in the area.

The Police are concerned for Mr. Whitely's welfare and are conducting urgent enquiries in an effort to locate him.

Police continue to appeal to anyone who may have seen Mr. Whitely in the last two weeks or has any information about his whereabouts to please contact the George Town Police Station at 949-4222.

## Cuba rebuilding after tornado

Cuba was badly hit by a devastating tornado last week with at least four people dying and hundreds injured but construction has already started to repair thousands of homes.

The construction of houses for the people affected in Havana by a tornado on Jan. 27 started on Saturday.

According to the Council of Ministers, works began in several places in the Cuban capital, while the assessment of damages in houses continues.

President Miguel Diaz-Canel and Construction Minister Rene Mesa said that of 3,513 houses damaged so far, the technical data for 2,873 was prepared. This survey is fundamental for the acquisition of materials for reconstruction.

Mr Diaz-Canel emphasised that the procedure offices for the purchase of construction materials work efficiently to a high standard and great urgency.

Energy and Mines Minister Raul Garcia reported that the power ser-

vice was practically restored, and only some cases remain without electricity and they will be solved in the coming hours.

In the case of telephone services, Communications Minister Jorge Luis Perdomo said at the meeting of the Council of Ministers that 65 percent of land lines had been restored.

Mr Diaz-Canel repeated his call to maintain permanent contact with the people affected by the tornado, to explain the progress of the recovery and listen to their problems. 🌐

## Filipinos heaviest internet users

Filipinos are the world's heaviest internet users, particularly on social media.

A new report has revealed the world's heaviest internet users are in the Philippines, where people spend an average of 10 hours and two minutes a day online in 2018.

Brazil were second with 9:29 internet usage, followed by Thailand (9:11), Colombia (9:00), and Indonesia (8:36).

The Digital 2019 report, created by social media management platform Hootsuite and digital marketing agency We Are Social, found that the worldwide average amount of time spent online was six hours and 42 minutes a day.

People in the US averaged 6:31 compared with 5:52 in China and 5:46 in the UK.

Of the countries surveyed, people in Japan spent the least amount of time online, averaging just 3:45.

Unsurprisingly, social media accounted for a significant amount of time spent on the internet. In the Philippines, peo-

ple spent an average of 4:12 on social media platforms every day, while the global average was 2:16. Again, the lowest social media use was in Japan, where people devoted an average of just 36 minutes to scrolling.

Facebook was the social media platform Filipinos tended to use the most, with over two million joining since October 2018.

Overall, there are 76 million internet users in the Philippines, and all of them are on some form of social media. Seventy-two million Filipinos access them via a mobile device. 🌐

## Honduran lawmaker on trial

Days before Honduras' elections in 2017, a former high-ranking official in the national police, Maria Luisa Borjas, held a news conference at which she read from government investigative reports about three high-profile killings. Now, as an opposition lawmaker, she faces the possibility of a fine and, more significantly, the loss of her seat in Congress when she went on trial Monday charged with defamation. Her alleged crime was essentially naming names — the suspected "intellectual authors" of

a slaying contained in one of those reports — in a country where the powerful have long enjoyed impunity.

Honduras and other Latin American nations have been criticised by international organisations for years for their criminal defamation statutes, which are powerful tools allowing elites — often lawmakers themselves — to silence critics.

Ms Borjas has a long track record of calling out corruption, starting with the police force's own ranks when she ran

its internal affairs unit. "It's a political persecution and they want to set a precedent so that nobody dares to denounce absolutely anything here," Ms Borjas said. "People say, 'Well, if they do this to a deputy, what could they do to me?'"

In another case last month, the country's Supreme Court rejected a bid for a new trial by journalist David Romero, who has been an outspoken critic of President Juan Orlando Hernandez. The justices upheld a 10-year prison sentence given Mr Romero in 2016 after he was convicted on several counts of defamation

for his reporting on the wife of a former attorney general. Honduras' constitution guarantees its citizens the right to honour, and defamation is considered a crime against a person's honour. 🌐

## UK to deport Caribbean residents

The UK Government plans to restart deportation charter flights to the Caribbean this week have been attacked as "brutal" and "a scandal" by leading Labour politicians.

The Home Office said a flight to Jamaica will take off carrying out the enforced removals of foreign national offenders. About 50 people could leave, according to reports. They are said to include people who went to the UK as children and parents with British children.

The charter flight will be the first since March 2017, before the Windrush scandal when it emerged dozens of people had been wrongly deported from the UK by the Home Office.

A spokesman for the Home Office confirmed the plan. David Lammy, the Labour MP for Tottenham, said the deportation charter was an insult to the victims of the Windrush scandal.

"Britain stopped deporting British criminals to Australia in 1868," he said. "This forced repatriation is a scandal in itself, but to re-commence it before the compensation scheme for the Home Office's previous abuses has been rolled out is an insult to the victims who have already been false-

ly deported or detained by their own government.

"I have met many Windrush citizens forced into petty crime precisely because of the government's hostile environment outrageously stripping them of their rights to work, healthcare, housing and benefits."

The shadow home secretary, Diane Abbott MP, called for full transparency over the "brutal" chartered flight deportations.

"Ministers need to quickly confirm whether these individuals are British citizens," she said. "We should not deport our own citizens or deny their rights." 🌐

## Canada diplomats pull out of Cuba

Canada has announced it is removing up to half of the Canadians at its embassy in Cuba after another diplomat was found to have fallen mysteriously ill.

Canada has confirmed 14 cases of mysterious health problems since early 2017. Twenty-six American embassy workers in Cuba have also been affected, suffering a range of symptoms and diagnoses including mild traumatic brain injury, also known as concussion.

Canada announced in November it was considering all options regarding its embassy in Cuba after a 13th case was confirmed. Canada is going from about 16 positions for Canadian staff at the Havana embassy to around eight.

Canada ordered the families of diplomatic staff in Cuba to return home last April. The 14 Canadians affected includes diplomats and some of their family members. A senior Canadian government official said that the latest case involves a diplomat who

arrived in the summer and reported symptoms on Dec. 29. The official said recent confirmed cases demonstrate that these incidents are still ongoing.

Canada will continue to have an ambassador in Havana and officials said full consular services will be available to Canadians. But officials said other programmes may be adjusted in the coming weeks and diplomatic staff from outside Cuba might assist.

Cuba is a favourite tourist destination for Canadians and the Canadian government said there is no evidence of any related ailments among travellers. 🌐



# Irving hints at Celtics exit

Kyrie Irving is not guaranteed in re-signing with the Boston Celtics, despite his public promise to do so. The NBA deadline is on Thursday and Irving's apparent change of mind is one of the biggest talking points.

No wonder on Friday in Madison Square Garden, Knicks fans were chanting, "we want Kyrie," and those chants might not have been in vain. Only a week ago, it felt like Irving remaining with the Celtics was set in stone after the press conference in October where he announced he was staying. Now, after a particularly memorable period of NBA news, everything looks up in the air for the Celtics.

It stems from Anthony Davis whose agent announced that the young centre was seeking a trade from the New Orleans Pelicans. This immediately led to speculation that Davis's camp was forcing a move to the Los Angeles Lakers. One piece of news that bolstered this belief was that the Boston Celtics couldn't trade for him while Irving was still with the team. It seemed the timing of Davis's request was because he knew he couldn't be traded to Boston before the deadline because he had no interest in playing there. One of the reasons for that? There was a growing feeling around the league that Irving might not be so willing to re-sign there after all.

At first, it was easy enough to dismiss these rumours revolving around Irving, since they didn't really emerge until Davis made his trade request public. It was

easy enough to chalk it up to trade deadline chatter, possibly coming from teams hoping to land the disgruntled Pelican. Then, days after the Davis news, the New York Knicks made the shocking decision to trade Kristaps Porzingis to the Dallas Mavericks which meant the Knicks had freed up space to add two maximum contracts over the offseason, reheating their interest in acquiring Irving, who can – and probably will – opt out of his current contract over the summer.

As it happens, the day after the Porzingis trade, the Celtics were heading to New York to play, of all teams, the Knicks. This was the perfect opportunity for Irving to reassure fans that his priority was staying in Boston. That is, well, not exactly what he did. When asked point blank about his plans, Irving replied, "ask me July 1." He also expressed frustration that he was expected to answer such questions now, at one point saying, "at the end of the day, I'm going to do what's best for my career, and that's just where it stands. That's just where it stands."

This unexpectedly combative press conference led to a massive commotion among Celtics fans. It didn't matter that, during the brief round of questioning, Irving reiterated that Boston was still his number one option saying: "I still have confidence in Boston and what they can promise for the future and what they have in terms of our pieces."

Nothing could shield fans from the reality that something had changed in

the relationship between Irving and the Celtics. Now, the Celtics' entire long-term plan looked like it was built under a not-so-solid foundation.

It looks as frustration is the main reason Irving is reluctant to commit long-term to the Celtics. He is playing the best basketball of his career - but it hasn't translated to wins. The Celtics are, in theory, more talented than the team that reached Game 7 of the Eastern Conference finals without Irving and Gordon Hayward last season. But Boston are in fourth place in the East, getting there only after Friday's win thanks in part to the Indiana Pacers

plummeting after losing Victor Oladipo for the season because of a torn quad tendon.

Irving's frustrations have spilled over to other members of the team. He has repeatedly aired his grievances with Boston's young players Jayson Tatum, Jaylen Brown and Terry Rozier and through the media, including after a loss in Orlando last month. It was after that loss that Irving confronted coach Brad Stevens in the huddle for not calling the potential game-deciding shot for him, and Hayward on the court afterward for passing the ball to Tatum instead of him. 🌐

## Holder must sit last Test out

West Indies captain Jason Holder will miss the final Test against England after being banned by the International Cricket Council, but at least the Caribbean side are comfortable in the knowledge that they have already secured the series.

The brilliant all-rounder will serve a one-match suspension for his side's slow over-rate in the 10-wicket win in the second Test in Antigua. The third Test in St Lucia starts on Saturday, with West Indies 2-0 up in the series.

Holder will be sorely missed, not just for his leadership but he is the leading run-scorer with 229 at an average of 114.50.

He has been a central figure in West Indies securing a first series win over England since 2009, and their first over any side other than Bangladesh and Zimbabwe since 2012.

Holder was named man of the match after making an unbeaten 202 and taking two wickets in the 381-run win in the first Test, a performance which took him to the top of the ICC rankings for Test all-rounders.

The 27-year-old Barbadian claimed 4-32 to help bowl England out for 132 in Antigua on Saturday before West Indies sealed victory with two days to spare.

He missed the second Test in New Zealand in December 2017 after being banned for a slow over-rate offence. 🌐

## Bolt is NFL record holder now

Usain Bolt may be finished from the track, but he is still lightning fast. The 32-year-old Jamaican tied the NFL's fastest 40-yard dash and he was super chilled about it.

The retired Olympian tied the NFL's record for the fastest 40-yard dash, clocking in at 4.22 seconds, and he wasn't even wearing specialised running spikes. He did it in sweatpants and casual sneakers.

Bolt is at a crossroads in his life. He recently gave up on his dream of becoming a professional footballer, saying "the sports life is over" for him.

The eight-time Olympic gold medallist was unable to agree a contract with Australian side Central Coast Mariners last year after a trial.

He made his debut for the Mariners in September and scored twice in his second trial match. Despite the goals – one well-taken, one a tap into an empty net – and a clear improvement in his level

of football fitness between those two games, serious questions remained over his general play and ability to turn into an elite athlete in a second sport.

He turned down an offer from Maltese club Valletta, reportedly because the club could not afford his wage demands, and also spent time training with Norwegian team Stromsgodset and German Bundesliga side Borussia Dortmund.

Bolt, who retired from athletics in 2017 and still holds the 100m and 200m world records, said he does not regret trying to become a professional footballer.

Bolt, who won Olympic sprint gold medals in Beijing, London and Rio, said he would now focus on his business ventures.

"I'm just doing many different things ... the sports life is over, so I'm now moving into different businesses. I have a lot of things in the pipeline, so as I say, I'm just dabbling in everything and trying to be a business man now." 🌐

# Latin America and the Caribbean Will Need 23 Million Health and Education Professionals by 2040

Latin America and the Caribbean will need approximately 12 million teachers, 3 million doctors and 8 million nurses by the year 2040.

This is what 'Education and Health: The sectors of the future?', the second issue of the Inter-American Development Bank (IDB)'s The future of work in Latin America and the Caribbean series, says in its projection of the demand for social sector professionals in 24 countries in the region.

"Our study shows that, even in the framework of the fourth industrial revolution, we can expect the number of teachers, doctors and nurses in Latin America and the Caribbean to continue growing at great speed," explains Marcelo Cabrol, manager of the IDB Social Sector.

"Our methodology allows us to know that, for example, a third of the teachers that will be needed in 15 years, and almost two thirds of the doctors and nurses, are people who have not yet begun their working life. Faced with this reality, the key is to ensure that these new professionals have the skills and training they need to be the teachers, doctors and nurses of the future," says Cabrol.

The study's projections are based on a series of variables specific to these sectors. In the case of education, the school-age population, school enrolment rates and the number of children per teacher are considered. For the health sector, the number of doctors is estimated with respect to the aging population that will exist in the coming decades, as well as the proportion of nurses for each doctor.

In addition to presenting projections for the future, the study Education and health: The study analyzes the evolution of the employment of teachers, doctors and nurses in Latin America and the Caribbean over the last four decades.

"These three occupations have been growing significantly in the region, but the most remarkable thing is that the jobs in education and health are, in comparison with other sectors, of good quality," explains Marcelo Cabrol.

Thus, the publication not only shows evidence that the income of teachers, doctors and nurses in Latin America and the Caribbean has grown significantly in recent years, but also that these professionals are more likely to receive a pension in old age than other professionals such as engineers, lawyers, journalists or accountants. In addition, women represent the majority of social sector workers, and the gender wage gap is substantially lower in these occupations than in others.

"While, in our region, women with post-secondary education still earn on average 28 per cent less than men, in education and health this difference is around 10 cent," says Cabrol. 🌐

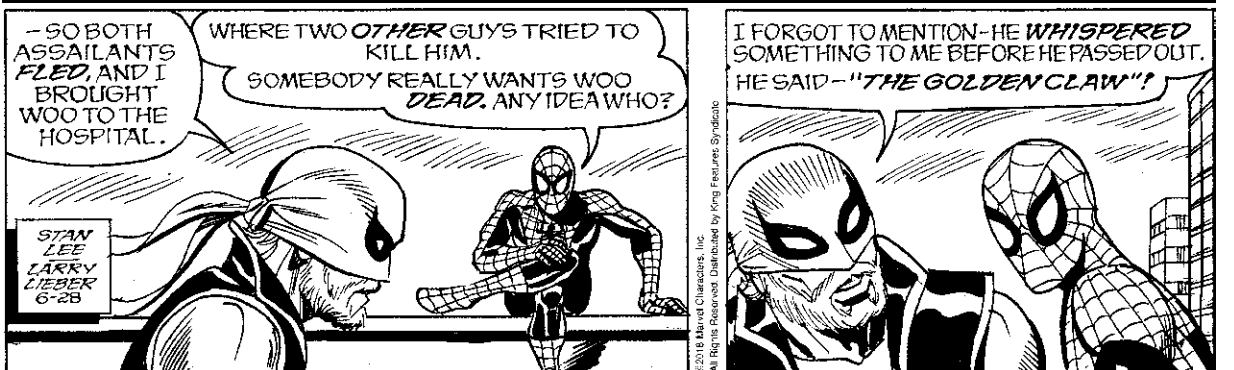
