

The Impact of the US Interest Rate Increase

The Federal Reserve Bank (The FED) on December 19, 2018, announced that it would raise the range for its benchmark interest rate of 2.25 – 2.50%. This is the ninth recorded increase since the Fed began to raise rates in December 2015.

Interest rate increases produce ripple effects on the means by which businesses and consumers access credit to run their operations and manage their finances. Consumers inevitably pay more for funds to make purchases and businesses encounter higher cost to maintain and/or expand their operations as well as to fund payroll and other employee costs. An increase in the Feds rate instantly drove a rise in the Prime Rate, which signifies the credit rate that banks offer to their most credit-worthy clients. The prime rate is the foundation on which other types of consumer credit are grounded, as a greater prime rate means that banks will increase fixed, and variable-rate lending costs when gauging risk on less credit-worthy businesses and consumers. Case in point, all of Cayman's local Class "A" banks, the latest being Cayman National Bank have announced CI\$ and US\$ Prime interest

Cayman Islands Government statement on The Netherlands blacklisting

The Cayman Islands Government regrets that the Kingdom of The Netherlands has chosen to break from other EU Member States to pursue a "blacklist" of 21 jurisdictions, including the Cayman Islands, based solely on the criteria of having a lower corporate tax rate than any EU Member State.

This "blacklisting" does not take into account Cayman's demonstrated adherence to international standards for tax transparency, or participation with the OECD's BEPS Inclusive Framework, and ignores our engagement with the EU's Code of Conduct Group over the last two years to address their concerns regarding economic substance.

The Cayman Islands Government regrets the unjustified "blacklisting" and rejects it as wholly lacking in fairness and credibility. It is unfortunate that The Netherlands has chosen to attempt to



divert criticism of its own tax practices by attacking the legitimate tax regimes of other jurisdictions.

Putting aside this unfortunate action, the Cayman Islands continues its longstanding commitment to adhering to global standards, and to working with the global community to improve their effectiveness.

DEH Working Double Shifts to Remedy Collection Schedule

The Department of Environmental Health (DEH) is working double shifts today (Thursday, 3 January 2018) through Saturday, 5 January, to address delays in garbage collection in George Town and the Eastern Districts.

As a result the Department expects to return to its normal garbage collection schedule beginning in West Bay on Monday, 7 January. Officials say additional shifts will be added if need be to meet this goal.

Delays in the schedule arose in late December when three trucks had to be taken out of service. The vehicles are currently awaiting parts to be shipped from overseas. DEH is currently working with the Department of Vehicle and Equipment Services to ensure that repairs take place as quickly as possible.



rates increases respectively from 5.25% to 5.5% effective January 7, 2019.

As a consumer an interest rate hike mainly affects you because, when you get a loan you're going to pay more interest. Contrarily, money market and credit deposit (CD) rates rise because of the increase in the prime rate. Theoretically, that should increase savings among businesses and consumers since they can earn a higher return on their savings. However, debt holders may opt to settle their financial obligations to offset the higher variable costs related to credit cards, car and home loans or other debts.

Credit card interest rates immediately follow increase in the prime rate. The Bankrate's latest 3-month trend have rates hovering at 17.59%. Any loan that's linked to a benchmark, e.g. an adjustable rate mortgage (ARM), for example, would rise immediately. Although fixed mortgage rates, savings, certificate of deposit (CD) rates, usually move with interest rate hikes, it's not a direct correlation. 1-Year CD rates for \$25,000 average about 0.88% and 5-Year CD rates average about 1.46% depending on the bank/institution. Consumers should shop around to find the best offers.

Interest hikes are generally good news for banks themselves as it tends to increase their profits. However, for the rest of the business sectors the opposite occurs as an interest rate eats up profitability. Their cost of capital for business expansion increases - bad news for small and medium-sized businesses (SMBs) when profit margins are already being squeezed.

Furthermore, increased borrowing costs usually affects consumer spending. Higher credit card rates and higher savings rates due to better bank rates generates a decrease in consumer impulse buying. Therefore, an interest rate increase could produce reduced revenues, smaller profit margins and greater costs – a potentially toxic mix.



Businesses can adapt to interest rate changes to guard against negative effects and capitalise on positive ones. Interest rates can be an indicator to either grow your business or retrench it.

With the Federal Reserve Bank projecting fewer and more gradual increases in bank rates in future years, it is important that businesses act now by reexamining their business plans and funding strategies, in order to limit the impact rising interest rates could have on them.

Since interest rate hikes have a widespread effect so individuals too should plan accordingly such that they limit the impacts on themselves. P

Why You Need Risk management

Business growth requires a solid foundation that includes prudent risk-management. The principle is simple - Normally, when you cut your risk, you cut your losses and increase profits.

One of most important things SMEs (small to medium-sized companies) can do to avoid risk of failure is to create a risk management plan that recognizes risks and adopt procedures to handle them. Not doing so is like heading out to sea in an unseaworthy ship – meet bad weather and you will be spending more time trying to stay afloat than sailing, diverting essential resources from the main business.

The list of business risks is large and risks are generally categorised under regulatory risk, market risk, credit risk and environmental risk but there are a few that are mainly predominant among SMEs. These include:

Bad debtors; Negative cash flow; Inventory risk; Strategic risk; Property and equipment risk (machinery and equipment failures); Personnel (high staff turnover, loss of key staff members, security of data and intellectual property); Theft; Cyber risk; Fraud; Natural But some risks are particularly difficult to manage, especially for small companies, and usually involve a human factor. Three especially problematic areas are:

- Fraud
- Human capitalCyber risk

Fraud

Fraud is increasing within SMEs. The incidence of fraud has increased worldwide since the global financial crisis, and SMEs are being increasingly targeted. While poor internal controls can be blamable, these can still be a slight defense against the dedicated thief. The time to be most cautious is when household debt servicing ratios rise and during times of decreasing GDP.

Human capital risk

Companies that manage people well are poised to beat those that don't by 30% to 50%, so human capital risk is a big issue for SMEs. Bad hiring selections translate to poor customer service; revenue and marketshare losses; competitive disadvantage; higher production costs; brand risk; and legal liability. Great workplaces, superior leadership, good life work balance and cross training are all strategies SMEs can use to target the human-capital weaknesses of big companies. Then there's an issue that's incredibly important, such as insurance--specifically, "key man" insurance.



Key man insurance is simply life insurance on the key person(s) in a business. In a small business, this is usually the owner, the founders or perhaps a key employee or two. These are the people who are crucial to a business--the ones whose absence would sink the company. You need key man insurance on those people! The reason this coverage is important is because the death of a key person in an SME often causes the immediate death of that company. In a tragic situation, key man insurance gives the company some options other than immediate bankruptcy.

Cyber risk

Cyber risk is another beast. Some banks offer firewall services for customer credit-card details and many SMEs are using these cyber shelters. Alternately, best practice is to stay current with cyber risks; train staff, ensure software is updated, establish a strong policy on BYOD (bring your own device); use strong passwords; have a strict employee transition policy and be careful of strangers appearing as delivery men or utilities servicers. Increasing numbers of companies offer support in this field and many security specialists hold seminars for SMEs. (?)

Luckily for SMEs, entire industries have been established to help manage risks such as human, property and equipment risk and workplace safety (the insurance industry) and bad-debtor risk (the factoring industry, rating agencies and debt collection agencies).

April

May

The measured accumulation of 1.2 inches for the month was 4.58 inches below the 30 year average for July of 5.78 inches.

August

Weather charts indicate that an upper level low pressure system produce an area of cloudiness and showers over the northwest Caribbean over the Cayman area on August 3rd 2018. The system produced an accumulation of 1.31 inches on August 3rd 2018 as measured by the Cayman Islands National Weather Service at the Owen Roberts International Airport.

28-30

Weather charts indicate that a cold front moved across the Cayman area on November 28th 2018. The system supported fresh northeast winds and rough seas from November 28-30th 2018. The Cayman Islands National Weather Service issued a marine advisory for the system for the period.

The total measured accumulation of 2.39 of an inch is 3.66 inches below the 30 year average for November of 6.05 inches.

December

Weather charts indicate that a strong cold front moved across the Cayman area on December 21st 2018. The system supported fresh to strong northwest winds and very rough seas from December 20-31st 2018. The Cayman Islands National Weather Service issued marine warnings for the system for the period. The Port and west coast of Grand Cayman was battered by large waves resulting in flooding of the main roads leading to road closures along portions of the capital.

The total measured accumulation of 1.56 inches is 1.23 inches below the 30 year average for December of 2.79 inches.

The total measured accumulation for 2018 was 43.45 inches or 12.75 inches below the 30 year average. The driest month of the year was February with 0.29 of an inch recorded and the wettest was September with 13.50 inches recorded. The annual rainfall graph can be seen below.



The Cayman Islands National Weather Service issued flood warnings for the event.

Weather charts indicate that a broad area of low pressure formed west of the Cayman Islands on May 23rd 2018. The Cayman Islands National Weather Service issued marine warnings for the event and measured a rainfall accumulation of 0.71 of an inch on May 23rd 2018.

Last Monday, 31 December, the RCIPS conducted 1,400 persons made use of the service in Grand Cayintensified traffic enforcement operations aimed at combatting drunk driving and other dangerous behavior on the road during the New Year's Eve celebrations.

As a result of these operations, there were four arrests made for DUI on the morning of 1 January. Three of these arrests came as a result of proactive traffic stops, while one person was arrested following a single vehicle collision. At least one person arrested had a breathalyzer reading of over twice the legal limit.

The RCIPS once again partnered with the National Drug Council in support of the New Year's Eve Purple Ribbon Bus Campaign. According to the NDC, over man, while several others did so in Cayman Brac.

"We are grateful to the members of the public who chose to ride the Purple Ribbon Bus," said Inspector Ian Yearwood, Head of the Traffic and Roads Policing Unit. "By taking advantage of the service and choosing not to drink and drive, they helped to make the roads that much safer for themselves and other road users."

Overall, 47 arrests were made for DUI during the holiday season, including those arrests made on New Year's Day.

"Safety on the road is always our number one concern when we conduct our traffic operations," added



Inspector Yearwood, "and we are pleased that once again we were able to greet the new year with no serious injuries or road fatalities following New Year's Eve celebrations. The victim suffered various abrasions, along with lacerations to her eyes, and was taken by private vehicle for treatment. A LIFE-CHANGING CHRISTMAS GIFT: SURGERY **REPAIRS GUATEMALAN BABY'S HEART**

A toddler from Guatemala celebrated Christmas with a new chance at a normal life after surgery in a Cayman Islands hospital to correct pulmonary valve stenosis, a congenital heart defect.

Nicolas Garcia-Granados was admitted at Health City Cayman Islands with the serious heart condition, and immediately underwent a six-hour openheart surgery that was highly successful.

Baby Nicolas was born with a rare genetic condition called Noonan Syndrome, characterized by distinctive facial features, short stature, heart defects, bone malformation, and other symptoms that affect the quality of life and the patient's development.

Due to this syndrome, the baby was born with a severe pulmonary valve stenosis (narrow pulmonary valve) and he also had a hole in his heart.

"When Nicolas was born he was very pale, he was practically blue, it seemed that he didn't get enough oxygen to his lungs, in fact he never cried", said Carlos Garcia-Granados, the patient's father.

this procedure was not successful and his doctors determined that Nicolas required a delicate open-heart surgery that was unavailable in his home country.

Nicolas's family began their journey to find a caring and affordable hospital that could perform his complex surgery. The options included the United States (with a high budget of US\$250,000), Colombia, Argentina, and the Cayman Islands. According to the family, the final decision wasn't really a matter of cost; it was more a matter of destiny.

"Since the first contact we made with Health City, the staff was very friendly, without complications, but the decision was really made thanks to the recommendation of a friend who brought his baby to this hospital with a serious condition in his heart. The baby had a diagnosis of 72 hours to live, and here they saved his life. That's why we decided to come to Cayman," Nicolas's father said.

Upon his arrival at Health City, Nicolás was evaluated by Dr. Sripadh Upadhya, Senior Pediatric Cardiologist, who confirmed the child's serious health condition, and stated that he needed an openheart surgery.

However, just before Christmas, he received life-changing surgery at Health City Cayman Islands, and will not need further operations to live a healthy life

ic and Vascular Department in Health City performed the six-hour procedure, which solved all of Nicolas's heart problems by closing the hole in his heart and correcting the pulmonary valve stenosis. "The procedure was highly successful. Nicolás recovered surprisingly fast. He will be able to live a normal life and will not need any other surgery in the future," Dr. Sripadh confirmed. Baby Nicolás's relieved relatives expressed their gratitude to Health City Cayman Islands. "The days went by so fast that it was amazing for us to see him recover so quickly. We feel blessed to be together ... We want to thank God and this hospital for all they have done for us," said Nicolas' mother Stephanie Rodriguez.









