

## Celebrate Veganuary in Cayman!

'Veganuary' has caught on in leaps and bounds in recent years, a global movement that encourages people to turn their backs on meat and dairy just for January, in the hope that it will inspire them to become vegan for good.

According to The Vegan Society, if the world went vegan, it could save eight million human lives by 2050, reduce greenhouse gas emissions by two thirds and lead to healthcare-related savings and avoided climate damages of \$1.5 trillion. They say that interest in veganism increased seven-fold in the five years between 2014 and 2019, according to Google trends. Other sources say that veganism in the United States has grown 600 per cent in the three years

## Government Proposes Changes to Cayman Islands Funds Regime

As the demonstrated leader in the global investment funds industry, the Cayman Islands is making legislative changes to enhance the oversight of open-ended and closed-ended funds.

The changes being put forward by the Cayman Islands Government seek to modernise regulation for open-ended funds, i.e. mutual funds, and close-ended funds, i.e. private funds, in the Cayman Islands. The changes would provide additional surety and transparency for investors and managers of Cayman Islands investment funds, while better aligning with best market practices, enhanced anti-money laundering and other key regulatory standards.

The Private Funds Bill, 2020 (the "Private Funds Bill") and the Mutual Funds (Amendment) Bill, 2020 (the "Mutual Funds Bill", together the "Bills") reflect and seek to adopt similarly sensible and commercially responsive regulation that has been the mainstay of the Cayman Islands open-ended funds regime, and seek to maintain the Cayman Islands' position as the preeminent jurisdiction for investment funds.

The Bills were drafted in consultation with a working group comprising Cayman-based funds professionals, including accounting, audit, administration, governance and legal firms and associations to provide operational and industry perspectives. The Cayman Islands Monetary Authority (CIMA) was also consulted by the Ministry of Financial Services as part of the process.

### Summary of the Bills

The Mutual Funds Bill would require those funds not previously covered under the existing Mutual Funds Law, specifically those funds with 15 or fewer investors capable of appointing or removing the operators, to register with CIMA and be subject to regulation.

Under the Private Funds Bill, private funds would also need to register with CIMA and be subject to regulation. Specifically, the Bill would require private funds to have appropriate and consistent internal procedures for the proper valuation of their assets. In keeping with what exists currently for mutual funds under the Mutual Funds Law, the Private Funds Bill would also require that a private fund be audited annually by a CIMA-approved auditor in accordance with international audit standards and have proper custodial and cash monitoring processes.

The publication of the Bills signifies the Government's intention to update the investment funds framework while staying mindful of industry realities. The goal is to ensure that the Cayman Islands continue to effectively compete at a high level, allowing for innovation and market development, based on a regulatory framework that effectively supervises the industry and strengthens investor confidence in Cayman Islands fund vehicles.

## Government to Further Enhance Cayman's Beneficial Ownership Regime

The Cayman Islands Government is presenting three bills to further refine and improve the jurisdiction's beneficial ownership regime.

During the next meeting of the Legislative Assembly, the following bills will be debated:

- The Companies (Amendment) Bill, 2020
- The Limited Liability Companies (Amendment) Bill, 2020
- The Limited Liability Partnership (Amendment) Bill, 2020

The bills provide clarification to the definition of beneficial owner and corporate service provider responsibilities. Additionally, the available exemptions and powers of the Registrar of Companies have been examined and addressed. These changes will strengthen the beneficial ownership regime in the Cayman Islands.

# Referendum question tweaked

Cabinet has agreed and gazetted a slightly revised question for the national referendum on the proposed cruise berthing and enhanced cargo port project to assist in resolving any concerns with the referendum question.

Shirley Roulstone, a member of CPR Cayman, filed for and was granted leave to pursue judicial review of the Government's process in relation to the holding of the referendum. As a result, the referendum has been delayed until after the decision of the court.

One of Ms Roulstone's claims was that the Government's proposed referendum question "Should the Cayman Islands continue to move forward with building the cruise berthing and enhanced cargo port facility" was not neutral.

Submissions made by Ms Roulstone's legal counsel recom-

mended that the word "proceed" would be acceptable in place of "move forward" and the words "enlarged" and "refurbished" would be acceptable in place of "enhanced".

In its final meeting last year on 17 December, Cabinet took the view that whilst there was nothing wrong with the original wording, it would none-the-less be pragmatic to tweak the wording in order to help save time and costs in the case.

The revised question on the referendum ballot will therefore be: "Should the Cayman Islands continue to proceed with building the cruise berthing and enlarged and refurbished cargo port facility?"

The new wording was published in the Government's public gazette, available online, on the 18th of December, 2019.

## Cash Turned over to the Police, Owner Located

Just before 5:45PM on Tuesday 7 January, a member of the public attended the George Town Police Station and handed over a container with a significant sum of CI cash in several different denominations. It was reported that the container, which was found in the area of Camana Bay, was lost by the owner who was

headed to the bank at the time. Police were able to identify the rightful owner of the cash and it has since been returned to him. ## Statement on Arrest

Investigators from the Anti-Corruption Commission arrested an individual on Thursday morning in connection with an ongoing investigation and previous arrests made on 19 September 2018. Responsible for investigating serious allegations of corruption the Investigators arrested the 43 year old male, from the Bodden Town area, on suspicion of committing the following offences:

1. Breach of Trust - contrary to s.13 of the Anti-Corruption Law (2016 Revision); and
  2. Being Concerned in an Arrangement (Money Laundering) - contrary to s.134 of the Proceeds of Crime Law (2014 Revision).
- He has been detained for questioning at the Prisoner Detention Centre (Fairbanks). The investigation continues therefore no further details will be released at this time.

# US AND IRAN: Still on the brink

A few days ago the President of the United States, Donald Trump, took to Twitter, his preferred communications tool, and tweeted "all is well".

It was in response to a ballistic missile attack by Iran on a military base in Iraq used by American forces.

That attack followed the US killing of Iran's top commander Qassem Suleimani (also spelt Qasem Soleimani) by the US a few days before.

No Americans lives were reported to have been lost in the Iranian retaliation.

On that basis primarily, President Trump assessed that all was well.

But is all really well?

The United States and Iran appear to have stepped back, at least for the time being, from the brink of an all-consuming military conflict.

While trigger fingers still appear to be itchy, the sobering spectacle of a passenger jet going down in flames, reportedly a casualty of the belligerence between the two sides, has given pause for reflection.

It may yet lead to a further uptick in tensions as Iran insists that it was not responsible for the shooting down of the aircraft and is refusing to hand over the flight recorders.

One hundred and seventy-six people including Canadian and British citizens died in the incident.

Prime Minister Boris Johnson, President Trump, Prime Minister Justin Trudeau of Canada and other Western leaders have suggested that information available to them indicate that the plane might have been shot down accidentally by Iranian missile fire.

Iran had launched a wave of ballistic missile attacks on military bases in Iraq used by American forces as retribution for the killing of General Suleimani.

Iran had also threatened to attack Israel and Dubai as part of its retaliatory action and had vowed to restart its nuclear programme in defiance of assertions by President Trump that the US would not "allow" Iran to have a nuclear capability.

Prime Minister Boris Johnson has called on Iran to desist from further attacks on the US.

"Iran should not repeat these reckless and dangerous attacks but must instead pursue urgent de-escalation," he said in parliament.

Mr Johnson also repeated his condemnation of the actions of the slain Iranian general saying General Suleimani had "the blood of British troops on his hands."

What appeared to be a few days ago to be a perfect storm of aggressive circumstances with war a most likely outcome, has somewhat morphed into a perfect opportunity to resolve the longstanding rift between the two nemeses.

But is that wishful thinking a thought too far?

From the abysmal lows of their tit-for-tat, cat and mouse game to what now seems, to quote a BBC journalist, "a confluence of cock-ups", the consequences are too dire to contemplate.

But they must be faced.

The world waits for the next salvo in the seeming, for the moment, mainly verbal war of attrition between the two belligerents.

Amidst calls for a de-escalation of tensions, every utterance hinting at a dialling-back of their rhetoric is more often than not accompanied by excessive breast-beating, veiled and even open threats.



A lot is at stake beyond the belligerence.

The risk of military conflict between the two nemeses remains 'a real and present danger' even to those countries not directly involved but who are more than likely to suffer the effects.

The British government has despatched two battleships to the Strait of Hormuz to protect UK-flagged ships in the vital sea lane for world oil shipments.

Any disruption in the strait which washes the shores of Iran would have serious knock-on effects on world oil prices with consequential global economic impact.

The result down the global economic 'pipeline' for countries such as the Cayman Islands could be severely disruptive, if not devastating.

With the belligerent face-off between the US and Iran now threatening to ensnare other countries, the world has now entered a new period of uncertainty.

All is far from well. Although they have been forced to step back from the edge, this is brinkmanship on the brink.

Who will be the first to blink? For the moment though, in the present stand-off, a fragile calm hovers under a dark cloud of palpable tension.

## Where to eat

Bread and Chocolate in George Town is an obvious starting point for vegans as their entire menu is vegan, so diners can be assured that everything they order is meat and dairy free. Breakfast, lunch and dinner are all plant-based and with items such as their breakfast scramble, sunshine pancakes, island bowl, shepherd's pie and black bean tacos, you honestly don't miss the meat.

Island Naturals is another popular choice, not just for vegans but also for vegetarians (an important distinction in that vegetarians don't eat meat or animal products but they do eat dairy and eggs) as well as those who just want to follow a healthy diet. Their emphasis is on eating nutritious, chemical-free, high quality ingredients and they offer a wide-selection of food for those with special diets, vegetarians as well as vegans. For breakfasts, vegans can enjoy oatmeals and açai bowls or a breakfast wrap which can be served as a wrap, over quinoa or over a bed of spinach. Notable lunch/dinner options include a buddha bowl, Thai crunch salad, spicy pan-Asian bowl, and a black bean and avocado wrap.

Owner Lindsay Allen says: "The cafe offers a convenient location to grab, breakfast, lunch and dinner making a more balanced and healthy lifestyle easier than ever."

Dining as a vegan can be problematic if you are dining in a group that wants to eat at a mainstream restaurant, but some restaurants in Cayman are rising to that challenge.

Italian restaurants have traditionally not had a huge vegan offering aside from a bowl of pasta in a tomato sauce, but Le Vele, situated on the waterfront in George Town, has been responding to the growing trend and now offers a strong selection of vegan offerings, including their Sunshine pizza with cashew paste, kale, roasted peppers, tomato confit and avocado.

Owner Paolo Cognolato says: "We also have vegan curry and our house-made

Unusually for an Italian restaurant, Le Vele also caters to those who cannot eat gluten, with gluten-free pasta and pizza options available.

Grand Old House, situated on South Church Street, is a lovely spot for lunch or dinner and the chefs there are tuning into the vegan movement with their vegan curry.

Manager Dunja Yeap says: "At Grand Old House we love to welcome vegans and our chefs are always happy to consider a vegan composition of the guest's choice. Our chefs can really prepare 'a la minute', depending on availability, to our guests liking."

If you want to prepare your own vegan menu at home, Cayman's supermarkets have lots of great options.

With the recent opening of their new Camana Bay store, Foster's has been

able to increase the number of specialty products they offer, including those suited to people on a vegan diet.

Foster's Marketing Senior Manager, Julian Foster, says fresh produce is an obvious starting point when thinking of a vegan diet.

"Our range of fresh fruit and vegetables include organic and locally sourced products, that are essential for a balanced diet," he advises. "We also stock meat alternative products from Beyond Meat, which include sausages and burgers, both fresh and frozen. We've also expanded our vegan product selection in our freezer department, with meals, snacks and ice cream varieties offered for those on a vegan diet."

There are plenty of dairy-free options to traditional dairy, so vegans don't miss out.

# Vibrant Crop Creates Buzz

Fruit trees in the Cayman Islands have been blooming a bit earlier this year, surprising locals and residents and creating great debate in the community about what might be causing the premature bounty.

Theories have ranged from global warming to the fact that 2020 is a leap-year.

One theory that has been catching steam is that the decrease in green iguanas - known for their love of eating blossoms - has meant that the plants are coming back stronger than ever, after being stunted for many seasons.

A simple google search regarding fruit trees blooming in fall produces several scholarly results that would somewhat substantiate this claim; not the least of which comes from the New Mexico state University's website, where Extension

Horticulture Specialist Curtis W. Smith, Ph.D. notes

"Fall blossoming in fruit trees (and other spring flowering trees and shrubs) can occur if the tree is stressed during the summer. While stressed, the tree may become dormant, and then when the weather moderates, if conditions are just right, the tree comes out of dormancy and flowers as if it were spring-time. The trees do not usually expend all their blossom buds at this time, so there should be more flowers next spring, and hopefully fruit."

Agronomist at the Cayman Islands' Department of Agriculture Claudette Bowen noted that she did not feel fruit trees were baring early; necessarily.

She explained that given a few weeks here or there, some of the trees being discussed as early bloomers this year

- such as nam doc, as well as what are known as 'Jamaican apples' - usually are known to bare at this time of year. Though she accepted that guavas had somewhat surprised her too.

"I think environmental conditions are very favorable and we've had some rain recently, which is not overly common for December. If trees are very healthy and do not have scales or white flies, and there is adequate or abundant water and sunlight it could mean that they are responding to that."

She added that some of the crops could in fact be late crops as well.

"I've seen them around. some plants may have 'come-in' later this year but nothing really convinced me that it was something that was out of the ordinary," she noted.

At the Farmer's Market, near Bobby Thompson Way, the sentiments were mixed, with many patrons noting that


they were surprised to see mango, guava and apples this time of year.

In 2018 the Cayman Islands implemented a programme to cull the invasive green iguana that plagued farmers for years, with over 1 million of the creatures being taken out during the programme.

It remains to be seen how crops will respond over time, though farmers say they are relieved for there has been a marked decrease in the animal's numbers.

The latest green iguana survey, carried out by the DoE in August, indicated that the cull appears to have made a big difference in the overall picture, with population numbers dropping more than 90% since last year's count.

Earlier surveys, done over the previous five years, had shown that the green iguana population had increased fivefold from 2014 to 2018, from about 254,000 to about 1.3 million. 🌱


## Dominica rated highly for ecotourism

"The visit by the largest cruise ship in the world, Royal Caribbean's Symphony of the Seas, to Falmouth in May is also another feather in our cap. Yes, the cruise numbers have not been exactly where we would want them to be, but there are signs that things are about to change."

## Trinidad filmmaker petitions for star director

A Trinidadian filmmaker has launched a petition asking award-winning English filmmaker Sam Mendes to make a film in TT, the home of his grandfather.

The petition on change.org was created by award-winning filmmaker, actor and screenwriter Teneille Newallo ('The Cutlass', 'Bazodee', 'Mangroves').

She said that Mendes recently won the Golden Globe award for Best Director for his film '1917'. She pointed out that in his speech Mendes, whose directorial debut 'American Beauty' won him the Academy Award and Golden Globe for best director, dedicated the win to his Trinidadian grandfather Alfred Mendes, novelist, short-story writer and World War I veteran.

Sam Mendes also directed the James Bond films 'Skyfall' and 'Spectre'. Newallo said TT filmmakers and actors have been working diligently to make films at an international level,

but it is more difficult in TT, as the professionals are cut off from the rest of the film industry. She added that being cut off also made it difficult to get international representation, which leaves world-class talent unrecognized.

"Additionally, there is not much financial support without an international celebrity attached to a project. We Trinidadians have so many stories to tell that can only be told by Caribbean people living here. We have so much talent to share but we need just one opportunity to break into the international industry."

## St Lucia adds 'tourism fee'

St Lucia plans to introduce a "tourist accommodation fee" on hotels, guesthouses, villas, apartments and Airbnb stays to fund destination marketing and development.

From April 1 visitors will be charged a nightly rate of US\$3 on accommodation costing up to \$120 a night, and \$6 on accommodation priced beyond \$120.

Accommodation sourced through sharing platforms such as Airbnb or VRBO will be subject to a 7 percent tourist accommodation fee on the full cost of the stay.

Funds accrued via the charges will be used to finance destination marketing activities by the Saint Lucia Tourism Authority in key markets, including the UK and Europe.

"The business of promoting a tourism destination is becoming increasingly challenging and highly competitive as countries worldwide try to capture a greater share of the growing tourist market," said an SLTA spokesman.

"Given this, it is now common practice for countries to finance marketing of their tourism product through an

accommodation fee or levy paid for by stay-over visitors."

Its budget currently stands at US\$35 million a year, which the SLTA says is modest in comparison to more established destinations with greater resources, which include other Caribbean nations. St Lucia's proposed fee structure is like the Maldives.

The cash will also be used to support village tourism and local product development, and for other destination management purposes.

St Lucia currently attracts around 350,000 stay-over visitors annually and is targeting 541,000 by 2022. The SLTA also wants to increase airlift to the island.

## Grenada wants Indian med students

Grenada's St George's University, the leading international medical school in the Caribbean, is offering Indian medical students the chance to study to be a medical doctor.

The lack of spaces in Indian medical schools is well documented and is leading to many potential students looking abroad for the chance to qualify in their chosen field.

St George's University is now the second largest source of doctors for the entire US workforce and its 20,000 graduates comprise physicians, veterinarians, scientists, and public health and business professionals. An MD course at St George's University provides ambitious students with the chance to study and work in multiple countries as part of their training.

In addition to the university campus in Grenada, SGU also allows its medical doctor students to apply to complete up to 50 percent of their degree in the United Kingdom at Northumbria University in Newcastle. The academic program in the UK is identical to the program delivered in Grenada - with the same content, examinations, and schedule.

## Guyana cranks up for oil wealth

Guyana is on the cusp of great oil wealth development and wants everyone in the diaspora to return home to contribute to growing the economy.

Guyana is celebrating its historic oil discovery of half a billion barrels and Minister of Finance Winston Jordan wants oil and gas Guyanese professionals to return home to fill job openings.

Jordan said expatriates were welcome to return to their homeland and apply for these positions without any restrictions.

"I tell Guyanese to take a page out of the Jamaicans' book, you don't have to give any reason to come to a place where you were born, it does not mat-

ter where you live, this is your home," emphasized Jordan, adding, that the country's oil industry should be a special lure to come home.

He is excited that Guyanese citizens will enjoy its new wealth "will benefit from the cradle to the elderly".

LIAT has appointed a new chairman of the financially strapped airline in former Barbados Prime Minister Owen Arthur as chairman.

Antigua and Barbuda Prime Minister Gaston Browne said Arthur would replace Jean Holder, who retired in December after 16 years.

Browne said that he believes that Arthur is the right person for the job, given his history of fighting for the Antigua-based airline, whose major shareholders are the governments




