Lack of Court room space an urgent issue

In his report at the opening of the Courts last week, Chief Justice Anthony Smellie implored Government to make the expansion of the Courts a priority as the new decade progresses.

The Chief Justice spoke of his relief last year that the Government had bought the Scotia Bank building for the use of the Courts. He was relieved, he said, because he had been

reassured that by mid-last year, they would have commissioned two more "long overdue" courtrooms in that building, to be dedicated to criminal trials, one of which would serve as the base for the Court of Appeal when in session.

"The clear stated priority was to tackle the backlog of criminal indictments," he advised.

However, even though the courtroom project would only have involved a simple reconfiguring and fitting out of internal space within the building, he said that had not been achieved and in the meantime the building had been partially occupied to relieve space shortage for admin staff and training.

"The fact of the matter is that the Judicial Administration may not under-

take the courtroom project without the permission of the Planning Department, and input of Public Works and Lands and Survey who hold title to all Government buildings," Chief Justice Smellie advised. "We therefore call upon our colleagues from these other agencies to recognise the urgent need for these courtrooms

Kearney Gomez is new Chairman of Port Authority Board

The Ministry of District Administration, Tourism and Transport is pleased to announce the appointment of Mr. Kearney Gomez as Chairman of the Board of the Port Authority of the Cayman Islands (PACI), for a period of four years, commencing 2 January, 2020.

Mr. Gomez is a retired civil servant whose career began in the early 1970's during the advent of the Regional Cadastral Survey & Registration Project and the establishment of the Lands and Survey Department.

In 1980 Mr. Gomez moved into the Portfolio of Agriculture, Lands and Natural Resources where he served as an Assistant Principal Secretary and shortly thereafter was appointed to the post of Principal Secretary. He was also appointed as Supervisor of Elections at that time and remained in those positions until his retirement from the civil service in 2013.

During Mr. Gomez's long career he was instrumental in the creation of several Government Agencies as well as the establishment of Marine Parks. Notable amongst these is the Water Authority, Department of Environment, Lands and Survey, 911 Emergency Communications, Street Naming and Property Numbering,



the Elections Office and the National Weather Service.

Mr. Gomez also played a significant role in the introduction of a considerable number of infrastructural projects during his tenure. These include the creation of the Port Container Terminal, the new Government Administration Building, the Mail Sorting

Youth Services Unit Hosts College Week Activities

Next week, high school students enrolled at private, and public schools throughout the Cayman Islands will have the opportunity to interact with local and overseas college recruiters as part of College Week activities that will take place through a partnership between the Youth Services Unit (YSU), Cayman Academy and Home Gas Ltd.

As part of the week's activities, a series of college fairs will be held at Cayman Academy, Clifton Hunter High School and South Sound Community Centre that will target students in year ten onwards.

To close the week's activities, the YSU and Cayman Academy will then host an information session for parents of prospective students at the Grand Old House on Thursday at 6:00 PM.

Acting Head of the YSU, James Myles outlined the purpose of the fairs. "The fairs are aimed at inspiring young people, some of whom may not have previously thought about college to consider tertiary studies as an option."

He lamented the number of Caymanian families that are still awaiting their first college graduate twenty years into the new millennium and re-

affirmed the YSU's commitment to the youth.

"The YSU is intent on preparing young Caymanians to become leaders who are looking toward the cutting edge of being top innovators and leading in global change."

The fairs will involve a mix of local, regional and overseas higher learning institutions. Local institutions will include the University College of the Cayman Islands (UCCI) and the Inspire Cayman Training Centre. Representatives from regional institutions St George's University (Grenada), University of the West Indies Cave Hill Campus (Barbados) and Northern Caribbean University (Jamaica) will also be present to engage with the students in addition to representatives from overseas tertiary institutions New England Institute of Technology (USA), Ontario Tech University (Canada) and The University of Law (UK).

Booths will also be set up by the YSU and the Scholarship Secretariat to provide additional support to students and their families.

and not to allow too much red tape to humbug progress.”

It was vital that the Courts had more space because they now have the largest number of indictments ever awaiting trial, he said.

Chief Justice Smellie made the position clear when he said: “It is of utmost urgency that these two court rooms are available no later than May of this year. So far as the Administration can drive this initiative, we will be engaging a project manager especially to work with the other agencies to have these court-rooms installed by May.”

The Summary Courts

The chronic lack of courtrooms continued to also hamper the work of the Summary Courts, the Chief Justice stated, and they were much impacted by this situation.

The Chief Justice said that the work of the Summary Courts covered several jurisdictions: The Criminal Courts; Traffic Court; Civil Court; Family Court and Coroners’ Court.

“Given the large number of cases coming before the Summary Courts, they must convene every day in all their main divisions - criminal, traffic, civil, family and, at least weekly, in coroners. This means that our five full time Magistrates and two acting magistrates need courtrooms on an ongoing basis. Currently, they are forced to rotate sittings throughout the day,” he explained. “Yet over the years, only one fully equipped courtroom has been regularly available to the Summary Courts.”

As a result, if the Court of Appeal sat, that got priority, followed by a court room used for indictment trails which then got priority over the Summary Court, which often then had to be



bumped with no accommodation then available for it.

The Chief Justice said the disruption that this caused to an already fragile listing system ought to be obvious to everyone and could not be allowed to continue.

“After many years of explaining this problem, one is obliged to think that any lingering reservations about the need for dedicated courtrooms for the Summary Courts can only be the result of lack of understanding,” he stated.

Government, he said, had committed itself to the building of a new Court-house which would address these problems and the similar needs of the Grand Court and Court of Appeal, into the foreseeable future. The project was of crucial importance to the administration of justice in the Cayman Islands and it was imperative that it be allowed to proceed. 🌐

Chamber elects new Council for 2020

Woody Foster is the new President of the Cayman Islands Chamber of Commerce. He accepted the top leadership role at the organisation's annual general meeting held at the Grand Old House restaurant on Wednesday, 8th January.

He becomes the first son of a Past President (the late David Foster who held the position from 2000 - 2001) to be elected to this high office. He thanked members for their vote of confidence and pledged to address the key issues that matter most to them and the community.

Economic Growth and Education were among the key topics that he highlighted in his acceptance address as issues of utmost importance for 2020 and the future of the Cayman Islands.

or dhyana, and yoga asana, we are able to serve ourselves better by creating space for spiritual realisation, thus building a community of well-intentioned, loving, and healing seekers of Truth and Goodness," she says. "As human beings, we are universally connected – to each other and to nature. One yogi at a time, one pose and one body at a time, we hope to create a shift that encourages more love and support in the world."

As well as undertaking the challenge, participants are also invited to undertake weekly reflection sessions.

"During these reflection sessions, our instructor leads will guide subgroups of

challengers through short meditation, reflection, and journaling prompts so that the qualities of yoga that are practiced on the mat can also be carried into life off the mat," Hally explains. "The challenge has resonated well with everyone, not only because it helps to create the foundation for a strong and steady practice, but also because it's created our strong and supportive community."

Yoga for all

If you are thinking about taking up this yoga programme, no matter your ability and time available, Hally says anyone and everyone is invited to join the challenge.

"The 40 days runs from 13th January to 22nd February, but only 30 classes are required to complete the challenge. Since the only requirement is to attend 30 classes, someone can sign up on 23rd January and attend one class a day to complete the challenge," Hally advises. "Otherwise, they can also double up on classes in one day to still have some days off. We have a diverse number of classes on the schedule that would enable doubling up without burning out mentally, spiritually, and physically. For example, you can go to a powerful vinyasa class and stay for a slow flow, yin, or restorative class right after, so you'd get the benefits of an energising and strengthening class as well as a calming and restorative class."

US Denies Wanting to Extradite Senior Jamaica Government Minister

The United States has denied rumours that it's seeking to extradite a member of the Jamaica government.

The denial yesterday came on the heels of social media reports that the Donald Trump administration had officially requested the extradition of a minister to face the courts. It had been rumoured that efforts were being made to extradite Daryl Vaz, Minister without Portfolio in the Ministry of Economic Growth and Job Creation, whose US visa had been revoked late last year.

In a tweet yesterday, the US Embassy in Jamaica sought to put those rumours to rest.

"Contrary to social media rumours: There is no extradition request(s) for any Minister of the Jamaican Government from the United States Government. The Jamaican Government has been very cooperative with the United States Government on these matters," it stated.

Minister of Foreign Affairs Kamina Johnson-Smith replied to the tweet, saying: "Many thanks for your clarification! Much appreciated."

The tweet was also reposted by Prime Minister Andrew Holness, who suggested that the opposition People's National Party (PNP) was behind the rumours.

"The PNP operatives who have been carrying rumours and fake news should know that the era of social media is not just for those who would seek to use it negatively, more so it is a tool for transparency, clarity and integrity," he said.

Vaz, who is also the Member of Parliament for West Portland, speaking on Nationwide Radio last week, described the claim of him being the subject of an extradition request as "the usual politricks",

as he charged that political activists were behind the rumour.

As for the revocation of his visa, Vaz, who previously has US citizenship but revoked it in 2008, said there has been no change in the status of his visa but he was continuing to pursue the matter vigorously.

The correspondence he received from the US Embassy last year had informed him that "subsequent to the visa issuance, information has come to light that you

may be ineligible for a visa. If you would like to travel to the United States, you must reapply". Vaz had said then that if he was unable to secure a visa, he would resign from the Cabinet as he would not be able to carry out his ministerial functions.

News about his situation broke in early November last year, when it was also revealed that the visas of PNP Vice President, Phillip Paulwell, some businessmen and some senior police officers were also revoked.

US Puts Even More Restrictions on Air Travel to Cuba – Charter Flights to Nine Cuban Airports Banned

Less than three months after suspending commercial flights to airports in Cuba outside Havana, the United States Government has suspended all public charter flights as well.

Charter flights will only be allowed to Havana's José Martí International Airport, and even then there will be limitations.

US Secretary of State Michael Pompeo said in a statement that the flights were "suspended until further notice" by the US Department of Transportation (DOT), at his request.

Nine Cuban airports currently receiving US public charter flights will be affected.

"Public charter flight operators will have a 60-day wind-down period to discontinue all affected flights. Also, at

my request, DOT will impose an appropriate cap on the number of permitted public charter flights to José Martí International Airport. DOT will issue an order in the near future proposing procedures for implementing the cap," Pompeo said.

He said the action "will prevent the Cuban regime from benefitting from expanded charter service in the wake of the October 25, 2019, action suspending scheduled commercial air service to Cuba's airports other than Havana".

Pompeo added that the suspension would "further restrict the Cuban re-

ble support for dictator Nicolas Maduro in Venezuela".

"In suspending public charter flights to these nine Cuban airports, the United States further impedes the Cuban regime from gaining access to hard currency from US travellers," he added.

Cuba's Foreign Minister Bruno Rodríguez has described the new measure – which marks a continuation of President Donald Trump's rollback of the easing of restrictions by his predecessor Barack Obama – as a "serious violation of human rights and freedom of travel of US citizens and hinders family reunification".

13 Political Parties to Battle for Power in Guyana Elections; But a Prime Ministerial Candidate Drops Out of the Race

Thirteen political parties are set to contest the March 2, 2020 polls, based on submissions made on Nomination Day. But one of them is now looking to find a Prime Ministerial candidate after the man who was running for the position pulled back because of dual citizenship.

The Guyana Elections Commission (GECOM) will later this week give the official approval of the lists. But all 13 parties are expecting they will get the nod.

Among those contesting the polls is Change Guyana, whose chairman and Prime Ministerial Candidate Nigel Hinds yesterday announced he would no longer be participating in the elections because of his dual citizenship status.

Under the Constitution, Hinds is barred from holding a seat in the National Assembly because he is also a US citizen. And he told local media that he would maintain that citizenship because he had health issues – diabetes and kidneys functioning at 50 per cent capacity – which he felt would be better dealt with at healthcare facilities in the US.

He told Newsroom Guyana that during a routine medical check-up last November, he learned of the health developments and did not want to "risk doing

the kinds of interventions that might be needed and getting the right medication" in Guyana.

"The truth is, Guyana's health system is in a decrepit [state] and really represents the worst health system in the English-speaking Caribbean," he told the media house.

"It is unrealistic to compare the medical facilities and treatment available in the United States with what obtains in any Caribbean country and more so Guyana."

Meantime, the ruling A Partnership for National Unity+ Alliance for Change (APNU+AFC) coalition, led by President David Granger and with Khemraj Ramjattan as its Prime Ministerial candidate, will be contesting the polls in all 10 administrative regions for both the general and regional elections.

The People's Progressive Party (PPP), with Presidential candidate Irfaan Ali and Prime Ministerial candidate, (ret'd) Brigadier Mark Phillips will also be contesting all regions in both elections.

Following the two larger parties is the United Republican Party (URP) with Presidential Candidate Vishnu Bandu. The party leader did not announce his running mate for this year's poll. URP will also be contesting all regions in both the general and regional elections.

Unlike the URP, newly formed party, A New and United Guyana (ANUG) will only be contesting the coastal regions. Presidential candidate Ralph Ramkaran said Regions 1, 8 and 9 are out. A Prime Ministerial candidate was not announced. ANUG reportedly split from the Federal United Party (FED-UP) a few hours before the list of candidates was submitted to GECOM last Friday.

A group of young Guyanese under the banner of The New Movement (TNM) is being led by Presidential candidate Dr Ashley Kissoon and Prime Ministerial

candidate Dr Gerald Forde. They will be contesting Regions 3, 4, 5, 6, 8 and 10.

Another young party, the Citizen Initiative (TCI) led by Rhonda Ann Lam, will be seeking votes from Regions 2, 3, 4, 5, 6 and 10.

Meanwhile, Change Guyana will be contesting in all regions except 1, 7 and 8, according to Presidential candidate Robert Badal.

The Berbice based FED-UP party will only be contesting the regional elections in regions one and two, while the Liberty and Justice Party (LJP) led by Lennox Shuman, will only be contesting Regions 1, 2, 4, 7, 8 and 9.

The People's Republic Party with presidential candidate Timothy Norton will be contesting all regions except 7, 8 and 9, while the Organisation for the Victory of the People led by Gerald Pereira will only be contesting in Region 4.

The Guyana National Service Party (GNSP) is led by Arthur Fredricks, while the National Independent Party's (NIP) presidential candidate is Saphier Husain.

At the close of nomination day activities last Friday, GECOM's Chief Elections Officer (CEO) Keith Lowenfield noted that the process was smooth and GECOM is continuing its work.

"The tasks to be completed are (now) internal. The parties will be made aware after the submission has pronounced on the submissions I will make to the commission for approval or non-approval," he said.

Lowenfield used the opportunity to encourage citizens to use this period to ensure their biographic data is correct on the Revised List of Electors currently posted in their respective polling division.

Former Barbados Government Minister Found Guilty of Money Laundering Charges in US, But An Appeal is on The Horizon

A former politician and a senior minister in the Barbados Government is now awaiting sentencing in the United States after yesterday being convicted of laundering bribes paid to him by executives of the Insurance Corporation of Barbados Limited (ICBL) to secure government contracts.

After two hours of deliberation at the end of a four-day trial in the Eastern District Federal Court in New York, a 12-member jury unanimously found former Minister of Industry, International Business, Commerce and Small Business Development Donville Inniss guilty of conspiracy to commit money laundering, as well as laundering US\$16,536.73 on April 17, 2015 and US\$20,000 on April 18, 2016, through his friend's company in the US.

The 54-year-old Inniss, who is a US legal permanent resident with a home in Tampa, Florida, remains on bail pending sentencing.

According to the evidence presented at trial, between 2015 and 2016 Inniss took part in a scheme to launder into the US, just over US\$36,000 in bribes that he received from high-level executives of ICBL, while serving as a minister and a Member of Parliament under the previous Democratic Labour Party (DLP) administration. In exchange for the bribes, he leveraged his position as the Minister of Industry to enable ICBL to obtain two insurance contracts from the Barbados government to insure over US\$100 million worth of government property.

The bribes helped ICBL win contracts that paid more than US\$93 million in net profits.

To conceal the money paid to him, Inniss had it sent to a US bank account in the name of his friend's dental company, Crystal Dental Lab, in Elmont, New York, even though that company had been dissolved since 2004. The money was then transferred to one of his US bank accounts.

The trial evidence further showed that Inniss used a personal email account to communicate with an executive from ICBL in connection with the bribe payments and the laundering of the money through the dental company.

"It can't be disputed that ICBL sent \$36 000 to Crystal Dental Lab for consultation services which were never provided; it can't be disputed that the money was for Inniss; and it cannot be disputed that ICBL sent the money to secure Government contracts. That alone should be enough evidence," prosecutor David Gopstein had told the jury, which heard the case before District Judge Kiyo Matsumoto, during closing arguments yesterday afternoon.

Although not disputing the money transfers, Inniss' lawyer Anthony Ricco argued that the evidence did not support its view that they were bribes.

It is on that basis that he told reporters, after the jury delivered the guilty verdicts, that he would be fighting the conviction.

"I plan to appeal and challenge the decision based on the insufficiency of the evidence. The trial is just step one of what could be many...Justice is a long road and we're built for it," Ricco said.

The defence attorney also took issue with the fact that Inniss, a former Barbadian official, was being tried in a court in the US.

"We have a case where an American jury is judging a Barbadian official from the mindset of an American. Can you imagine what would have happened if an American official had been arrested in Barbados and tried in Barbados? It's unheard of," he said.

The US Justice Department a year ago also charged ICBL's former chief executive officer, Ingrid Innes, and its former senior vice president, Alex Tasker. The two, who are not in US custody, were

charged with one count of conspiracy to launder money and two counts of money laundering, in a superseding indictment unsealed on January 18, 2019.

The Justice Department said ICBL had cooperated with the investigation, voluntarily disclosed to the US government the payments to Inniss, enhanced its compliance programme and internal accounting controls, and fired individuals involved in the misconduct. It received a prosecution declination under the FCPA Corporate Enforcement Policy and also handed over the US\$93,940.19 in the illicit profits it earned from the scheme.

Jamaica Government Moves to Get More Traditional Ganja Farmers into Medicinal Marijuana Industry

Minister of State in the Ministry of Industry, Commerce, Agriculture and Fisheries Floyd Green says emphasis will be placed on increasing the number of community groups of traditional growers participating in a programme that aims to prevent and eliminate the illicit cultivation of ganja and channel the process through legal streams.

The 1998 Action Plan, adopted by the United Nations General Assembly, provides for the inclusion of such a programme – the Alternative Development Programme – through specifically designed rural development measures consistent with sustained national economic growth.

"What we will be doing in 2020, is looking for more community groups of traditional growers that we will engage and provide the technical support for them to transition into the medicinal marijuana industry," he told the House of Representatives.

"Already, we have a group from St Ann that has approached us and a group in Kingston and a group from south west St Elizabeth."

Green also mentioned that a cannabis pilot project has started in Accompong, St Elizabeth.

"We have gone in there with the team to provide technical support. The programme focuses on community groups, so it starts with a group of ganja farmers, and we would have gone in and provided the seeds, provided reduced requirements and we have gone through a learning process. I would say the pilot has been a success," he said.

The State Minister noted that from the pilot in Accompong, new guidelines have been developed for the initiative.

"Some of the things that we have realized is not because we have traditional growers; it means they are growing to the specifications and the standards that are needed for the medicinal marijuana industry. And, as such, we have taken those learnings and we have now developed some guidelines for the alternative development programme," he said.

Green further informed that some 44 pounds of ganja have been sold from Accompong into the medicinal marijuana industry.

"We are now looking to move from the one acre that we started with to go into 10 acres of cultivation. We also met with the farmers from Orange Hill in Westmoreland. Again, we had some challeng-



es getting the pilot off the ground, largely because of identifying suitable land that can be used and land that is owned that we can utilize for the purpose of planting ganja," he said.

The Alternative Development Project is being implemented as a strategy to transition traditional cannabis farmers

from an illicit framework into the regulated environment as a means of promoting sustainable economic development and poverty eradication.

It is also aimed at providing access to quality-controlled cannabis for medicinal purposes, in keeping with government policy.

Barbados Government Hires Law Firm to Help it Dig for Corruption

Attorney General Dale Marshall says the government is digging to find evidence of corruption at several state entities, and has promised that when the proof is unearthed, some people will face the courts.

Marshall assured that Barbadians will get it the "blood" they're seeking, once investigations by London-based law firm Fulcrum Chambers Ltd. are completed.

He said the Mia Mottley-led administration had engaged the services of the "very reputable law firm" which "has specialized in doing corruption and bribery cases both in England, the United States and other parts of the world", and the firm had completed a three-month scoping study.

That study, the Attorney General said, examined the financial dealings of state enterprises and other departments to identify those areas where there is prima facie evidence of corruption, so as which would inform a more in-depth and intensive investigation stance to be taken by the Government.

He said the consultants from Fulcrum are expected to deliver their report to the Government early next month.

"I know that Barbadians want blood, I suppose," Marshall said. "They want to know that some people face the courts,

and I guarantee, some people will face the court. They have to face the court, but you don't carry to court a man based on hearsay, you carry a man to court based on proof."

The Attorney General gave the assurance as he led off debate on the Integrity in Public Life Bill in Parliament which would be relevant to members of Cabinet including members of the House of Assembly and the Senate; Permanent Secretaries; heads of departments in the public service and holders of public office of the same grade as that of heads of departments; chairpersons of state-owned enterprises; chief executive officers, general managers and other executive heads of state enterprises; magistrates; the Director of Public Prosecutions; the Auditor General; and members and senior officers of the Integrity in Public Life Commission.

Breach of the legislation can result in sentences ranging from BDS\$5,000 (US\$2,500) or two months in prison or both, to BDS\$20,000 (US\$10,000) or two years in prison or both.
