## **NTCI Members Vote to Formally Oppose Cruise Facility**

For first time in its 33 year history, the National Trust for the Cayman Islands (NTCI) held an Extraordinary General Meeting, (EGM) on 9th January at the George Town, Yacht Club in order for its membership to vote on a historical issue.

The vote centered around the organization's official public position regarding a controversial cruise berthing facility currently being proposed by the Government in the Cayman Islands.

During the Meeting, the National Trust members unanimously voted for the organization to have an official stance against the port project, noting:

"The National Trust is determined to carry out its mandate to protect and preserve the historic, natural and maritime heritage of the Islands as defined in Section 4 of the National Trust Law.

"It also wants to remind the public of the Constitution Order 2009 which states the Cayman Islands 'will be a country that respects, protects and defends its environment and natural resources as the basis of its existence' and 'a Country that manages growth and maintains prosperity while protecting its social and natural environment'.

Previously, the NTCI were neutral on the issue pending a proper Environmental Impact Assessment, but the organization said in a statement, "...with information not forthcoming, the lack of meaningful consultation, the National Trust decided it had to call an EGM to solicit the feedback of its membership and take a -(official)- position."

After a brief presentation by wildlife and underwater photographer and Woman Divers Hall of fame member Ellen Cuylaerts, NTCI legal counsel John Harris and Executive Director Nadia Hardie, provided an update on the National Trust's legal position as Intervener in the Shirley Roulstone vs CIG judicial review on the Cruise Berthing Port set down to be heard on the 22nd January 2020.

The EGM was well attended by Trust members and over 65 proxies were also submitted. A Resolution was passed unanimously enabling the National Trust to formally oppose any development of a Cruise Berthing Port in George Town Harbor which would jeopardize its endangered and protected species of coral and marine life and which would be inconsistent with the provisions of section 41 of the National Conservation

Representatives for the National Trust said the non-profit had consistently called for full disclosure on the potential environmental impacts of the Cruise Port project as well as for meaningful consultation with the public since the new design changes, so as to allow voters to make an informed decision when voting at the People Initiated Referen-

The National Trust for the Cayman Islands is presently seeking an injunction - via the Cayman Islands courts/ judiciary - against the government to stop a vote that could mean acres of coral in George Town will be removed. If successful, the injunction would give time for a more current Environmental Impact Study to be done before any vote would take place.

# Cayman's Supervisors Receive Specialised AML/CFT Training

The training, held 8-10 January 2020 at the Grand Cayman Marriott Beach Resort, was led by Ms Glenda Leben, Supervision Advisor for the CFATF (Caribbean Financial Action Task Force). The training was organised by Cayman's Anti-Money Laundering Unit (AMLU).

Ms Leben began the training with an overview of key definitions (money laundering, terrorist financing, proliferation financing), as well as the roles and functions of the Financial Actions Task Force (FATF) and the CFATF. She also provided

tive regulatory supervision for financial services and other designated business- Immediate Outcome 3, related to the ef- The training concluded with a simulafectiveness of AML/CFT supervision.

> "Out of the 11 (Immediate Outcomes for Effectiveness of AML/CFT Systems), Immediate Outcome 3 focuses on supervision and how AML/CFT supervisors may be able to use this information to facilitate and enhance their approach to risk-based supervision," Ms Leben reminded the group.

> She also noted, "Immediate Outcome 3 requires supervisors to appropriately supervise, monitor, and regulate financial services and DNFBPs - designated non-financial businesses and professions - for their compliance with AML/CFT requirements. And this compliance is to be in line with their respective risk profiles."

DNFBPs include lawyers, accountants, realtors, dealers in precious metals and

The Methodology for Assessing Compliance with the FATF Recommendations and the Effectiveness of AML/CFT Systems is the global standard for AML/CFT, while the CFATF assesses and monitors compliance with the recommendations in the Caribbean region. 🏵

In an interview with The House magazine, an independent publication covering the British parliament, Mr Penrose explained:

"What I am suggesting is they should be at least offered the chance to have an equivalent kind of devolution settlement that has already been agreed and negotiated with Scotland, with Wales and Northern Ireland."

The Overseas Territories would then become "equal elements" of the UK with the "same status" as Scotland, England, Wales and Northern Ireland.

"They would send MPs to the Westminster parliament here, they would have their own devolved governments like the Welsh Assembly or the Scottish Parliament, but it would just mean that it would be constitutionally stable, properly integrated, modern status for these overseas territories.

"It would show that we are committed to being a global nation post-Brexit."

Mr Penrose argued the proposals would provide more "constitutional stability" surrounding the Overseas Territories, with the UK currently in dispute over Gibraltar with Spain and the Chagos Islands with Mauritius.

He rejects any suggestion that the move would be a return to Britain's imperialist past.

"People might make that argument but because we are offering and suggesting that these territories become equal parts of the United Kingdom, it's hard to make an imperialist argument about this at all. It is clearly something that is talking about equal status."

Mr Penrose said it would depend on the devolution settlement as to whether the Overseas Territories, such as the British Virgin Islands and the Cayman Islands, are subject to the same tax regime as the rest of the UK.

#### FOREIGN AFFAIRS COMMITTEE INQUIRY

This issue in its broad context what MP John Penrose is proposing was addressed, albeit inconclusively, in the 2018-2019 inquiry into future of relations between the UK and the OTs conducted by the FAC.

While he takes the route of the OTs being "invited", the onus is also - and probably more - on the territories themselves to actively pursue the issue.

The FAC in its report titled 'Global Britain and the British Overseas Territories: Resetting the relationship', noted that "the elected leaders and representatives of the OTs that appeared before us had mixed views on sending MPs to Parliament.

"Some members of the public also told us in writing that it is time to rethink the principles of Parliament's relationships with the OTs.

"We are aware that many people in the Overseas Territories feel that they do not receive the attention in Parliament that they might expect and that the Foreign Affairs Committee has not carried out a major OTs inquiry since 2008."

But it also flagged that; "...given the competing pressure of other policy areas, and the requirement to scrutinise the whole gamut of the Foreign Office's work, it is difficult to envisage another major OTs inquiry in this Parliament."

As stated by the FAC, "this fails to do justice to the range and complexities of the issues facing the OTs, individually and collectively.

Mindful of this it concluded: "We believe the time is right to give serious consideration to establishing a formal mechanism by which members of the Foreign Affairs, Justice, International Development, EFRA and other relevant Committees are able collectively to scrutinise the UK Government's administration of, spending on and policies towards the OTs."

#### RIGHT TIME FOR A CHANGE

But that was before the 2019 UK snap elections and the inauguration of the new parliament.

Some of the OTs have also had elections since then, and in others, elections are pending.

Given the UK's own election outcome, new parliamentary committees being constituted, and importantly, the reality of Brexit at the end of this month, it might the ideal time to revisit this particular issue.

Mr Penrose has a valid point and its worth examining to its fullest extent via an agreed method to determine the 'will of the people' of the OTs (i.e a referen-

dum), or a vote in the respective OT parliaments/assemblies by their elected representatives.

The UK parliament would also need to have a say.

Whether the OTs having representation in the UK parliament is by invitation or request, this particular issue ought to be put to 'the stress test'.

It seems only logical, fair and democratic that the OTs have a direct voice in the British parliament on matters of the 'united kingdom that they are a part of and which affect them, and not just seen as mere attachments or just distant, detached appendages.

Distant they might be, but detached they are not and appendages they aren't.



# McGregor may fight Money again

Combat sports gains more attention, revenue and media coverage every year and the fact that the top protagonists are increasingly cross-pollinating make it even more interesting. For example, Conor McGregor returned to the octagon in style at UFC 246 as he beat American fan favourite Donald "Cowboy" Cerrone in just 40 seconds in Las Vegas. Now McGregor may return to boxing for a rematch with Floyd "Money" Mayweather Jr.

McGregor, 31, came out on top after one of the most spectacular performances of his career. Two of UFC's most popular fighters went toe to toe in the main event at the T-Mobile Arena, but the Irishman was too fast and too powerful for the 36-year-old veteran.

Afterwards Tyson Fury, who is training for a rematch with Deontay Wilder on Feb. 22, claimed McGregor should now seek a rematch with Mayweather.

Fury attended UFC 246 and said McGregor, who trained as a boxer before moving into mixed martial arts, should fight the money man again. McGregor lost by 10th-round TKO to Mayweather in 2017 and has spoken of a rematch with Mayweather, as well as fighting Manny Pacquiao.

Mayweather took to Instagram after McGregor's win hinting at a possible 2020 rematch between the boxing and MMA stars.

The bout between Mayweather and McGregor was more competitive than expected, but Money came through

some early trouble to cruise through the final rounds. There has been relatively little talk of a rematch, but 42-year-old American's social media post may change that.

"If he wants to be a boxer, if he wants to do boxing, do it," Fury said. "I thought he'd done quite well against Mayweather. He'd done as good as anybody else has done, really. He was catching Mayweather with some good shots.

"I think it's great for boxing and great for combat sports," Fury continued. "If McGregor fights Pacquiao or Mayweather, it creates a big show in Las Vegas. It creates jobs for people.

It brings money to Las Vegas, money to America. It brings tourism to the country. I think it's very, very good for sports in general."

Fury has made forays into professional wrestling and talked about a future involving fights outside of boxing. Fury also addressed the potential of fighting in the UFC himself, and the challenge presented by current UFC heavyweight champion Stipe Miocic. He would be willing to step outside his comfort zone, Fury said, but added that he'd require some special circumstances.

"I don't want to go into an MMA fight, rolling around the floor and all that, no.

But I would fight one of their champions in small gloves. Maybe in a cage, but with boxing rules. After I beat Wilder next month, I'm going to have a sit-down with Dana White]and we're going to go for it, run some numbers and see if the fight makes sense."

If McGregor stays in MMA, a shot at the welterweight title, held by Kamaru Usman, or a bout with the UFC's "BMF" champion Jorge Masvidal would allow him to continue at his new weight class of 170lb, while he has made no secret of his desire to face Khabib Nurmagomedov in a rematch for the lightweight belt.

# Sunshine Girls hope to lift World Cup gloom

Jamaica's Sunshine Girls netball team are competing in England this week hoping for better results than they achieved in the World Cup last year.

Head coach Connie Francis said her team is "hungry" for success ahead of the Vitality Netball Nations Cup in England, which started on Sunday and runs for a week.

The four-nation tournament comprises of world champions New Zealand, England and South Africa. Matches are at Motorpoint Arena in Nottingham, Arena Birmingham and the Copper Box Arena in London.

The Nations Cup is Jamaica's first competitive outing since a series of dispiriting performances led to their fifth-place finish at the Netball World Cup in Liverpool, England, last July. Jamaica believed they could win the tournament.

The inevitable coaching shake-up followed, and in October, Francis, who previously guided the senior Sunshine Girls between 2007 and 2011, was brought in as Marvette Anderson's successor.

The 12-member squad named for the Nations Cup comprises seven players — Jhaniele Fowler, Shanice Beckford, Jodi-Ann Ward, Nicole Dixon, Khadijah Williams, Shamera Sterling and Kadie-Ann Dehaney — who featured at the World Cup.

The less seasoned quintet of Shimona Nelson, Gezelle Allison, Shadian Hemmings, Latanya Wilson and Shannika Johnson have a combined 12 Test caps.

# Giannis feels punished by flops

Giannis Antetokounmpo is just under 7ft tall and weighs around 240lbs and he feels that smaller opponents are using his size and power to their favour.

The reigning NBA MVP is one of the league's more physical players, which you would think would work to his advantage, however Antetokounmpo, 25, thinks that often the opposite occurs and he is punished for his strength, while weaker players that flop are re-

warded with foul calls. Despite this perceived imbalance though, Antetokounmpo doesn't plan to alter his approach.

"It's kind of hard because in the NBA, the way it's built, they want you to flop," he said. "It wants you to be weak, kind of, because sometimes I think when you're strong and you're going through contact, they don't call the foul. But when you're flopping and kind of going into the contact and throwing the ball out, they're just going to call foul, but that's not who I am, that's not what I'm gonna do.

"I'm just gonna try to power through contact. It's going to be where if a guy grabs me or pushes me, I've got to show it more, but I think I've done a better job

of showing it more so the refs can see that the guys are holding me, pushing me and just being physical."

The Milwaukee power forward's coach, Mike Budenholzer, agrees with his superstar's assessment.

"I think it's a huge concern," Budenholzer said. "If and when players are falling before contact, there's speed and knees and legs that are basically putting Giannis in a dangerous place."

Antetokounmpo isn't the first player to feel that his size and strength work against him in the league - just ask Shaquille O'Neal - but it will be interesting to see if his public comments about the issue alter the way that he is refereed.

## Ronaldo's work ethic is amazing

Cristiano Ronaldo is in the twilight years of his career but is still a formidable athlete at 34 because of his incredible discipline. Yes, he is extremely vain and self-centred, but the Portugal captain's dedication and ambition are as intense as when he emerged as a tricky teenage winger.

This has helped him become an instant success with Juventus as he continues to sparkle in his second season in Italy. CR7 joined the Italian giants from Real Madrid for \$105 million in 2018 on a four-year-contract. And after a tricky start to his new venture, he scored 31 goals in 47 games in all competitions in his debut season.

This campaign he has netted 16 goals in 23 games - registering in each of the last six.

But behind the scenes it takes a lot of hard work. From his diet, to exercise routine to sleep and rest, Ronaldo leads the most disciplined of lifestyles. He can eat up to six meals a day, with fish a big part of his diet.

Swordfish, tuna and braised cod are particular favourites. He regards chicken as "magical" due to its high protein and low-fat content.

For breakfast Ronaldo will eat ham and cheese and low-fat yoghurt or may wolf down avocado toast for snacks during the day.

Lunch No.1 could consist of chicken and salad, while No.2 might be fish - maybe tuna with salad, eggs and olives. Dinner will see him with meat or fish, maybe breaking them up in two separate sittings.

Steak, swordfish or the Lisbon speciality of Bacalao a la Brasa - a mixture of braised cod, onions, thinly sliced potatoes and scrambled eggs should see him through till bedtime.

Once tucked up, Ronaldo will ensure he has eight hours of sleep each night. That's in addition to up to five naps during the day.

Speaking about rest, the Portuguese superstar said: "Proper sleep is really important for getting the most out of training.

"I go to bed early and get up early, especially before matches. Sleep helps muscles recover which is really important."

Clearly the gym and intense exercise is a huge part of Ronaldo's life - as shown by his incredible muscle definition and speedy recovery from injury.

The forward follows a Pilates-based routine that focuses on resistance work to strengthen his core. He is also a big fan of swimming, often taking to the pool with son Cristiano Jr.

For all his niggles and knocks sustained on the football pitch, Ronaldo invested in a \$55,000 Cryotherapy chamber.

Standing in the chamber for around three minutes, liquid nitrogen freezes Ronaldo to between minus-160 and minus-200 degrees Celsius. Cryotherapy beats muscle soreness and reduces swelling, inflammation or sprains.

He puts mental health alongside physical health as being key to being happy on the pitch as well as off it.

This involves spending quality time with his family partner Georgina Rodriguez and his four children Cristiano Jr, twins Mateo and Eva Maria and Alana Martina.

He has been teetotal for at least 15 years - not only because of the adverse effects on his diet, but also because his father's death at the age of 20 was alcohol related.

### Former Medical Student Found Guilty of Threatening to Kill Trindad's Police Commissioner and Wife

A medical school dropout who threatened to behead the twin-island republic's top cop and kill his wife, more than a year ago, has been released on a bond to keep the peace and be of good behav-

Mahindra Ramdath, 35, who was charged with the misuse of a telephone contrary to Section 106 of the Summary Offences Act, was sentenced in the Port of Spain Magistrates Third Court after being found guilty of making the threats against Police Commissioner Gary Griffith and his wife, Nicole Dyer-Griffith.

Ramdath had made the death threats when he called the E999 hotline on Wednesday, November 21, 2018 around

He had said: "I want to summon Gary Griffith for defamation of character against me tomorrow in court, or else I will call him and chop off he (expletive) mother (expletive) head. How you like that? And kill he wife Nicole Dyer... huh mother (expletive)."

However, Ramdath's call was traced and he was arrested at his home just two and a half hours later.

After his first court appearance on the charge, he was sent for a psychiatric evaluation.

Ramdath has now been bonded to a sum of TT\$10,000 (US\$1,482) to keep the peace and be of good behaviour for two years.


Several death threats had been called in against Commissioner Griffith around the same time of Ramdath's, and the police chief had challenged those who wanted him dead to "stop calling and come...find me".

"It seems that some are trying to make themselves famous by threatening to kill me, but instead of grand charging and boring us, I would ask them to stop calling and come. They could find me. I promise to make them famous," he said at the time. •

It added that it was unfortunate that as the country enters the elections season, the issue of a well-deserved increase in wages and salaries for public servants, who, under the previous People's Progressive Party/Civic (PPP/C) administration were financially impoverished and subjected to poor working conditions, should be twisted into a blatantly false claim.

"It is worth recapping that this latest increase in the minimum wage represents an overall increase of 77 per cent the A Partnership for National Unity/ Alliance for Change (APNU+AFC) coalition took office in 2015. This is a tangible demonstration of the government's commitment to building a Good Life for All Guyanese, as we enter the Decade of Development," it said.

"The Ministry wishes to exhort the reporters of Citizens Report to become more acquainted with the tenets of good reporting, rather than pander to their handlers and do a disservice to their readers," the ministry's statement add-

More than 300 local and international delegates attended the conference at Baha Mar on Monday, and pledges included: initiatives in homebuilding and repair; educational assistance; renewable energy partnerships; relief aid; grants; direct assistance to storm victims; parks restoration; loans and financing.

"These pledges are an important step in the ongoing reconstruction and rebuilding of areas affected by Hurricane Dorian, so that we may rebuild stronger and with more resilience," said Prime Minister Dr Hubert Minnis.

"We are grateful to domestic and international partners, including foreign governments. We look forward to other possible contributions to help in our recovery efforts."

As a follow up to the conference, the United Nations Development Programme (UNDP) and the Government will issue a detailed account of the commitments made disaggregated by sectors and stakeholders.

Hurricane Dorian hit Abaco and Grand Bahama in September 2019. With maximum sustained winds of 185 miles per hour, and gusts of 220 miles per hour, Dorian was the strongest storm to hit The Bahamas. It was also the second strongest storm by wind speed recorded in the Atlantic.
