CAYMAN RAMPS UP CORONAVIRUS PREVENTION



Cayman nationals and returning residents who have recently returned from visiting mainland China, or are planning to return will now be placed in quarantine for up to fourteen days since counting from the date they left departing mainland China.

With the immediate effect, the government of the Cayman Islands is stepping up measures to safeguard the territory against the spread of the Novel Coronavirus by placing restrictions on persons who have been to China recently.

Cabinet has approved that the 2019 novel Coronavirus (2019-nCoV) be added to the Schedule of Notifiable Diseases of the Public Health Law (2002 Revision).

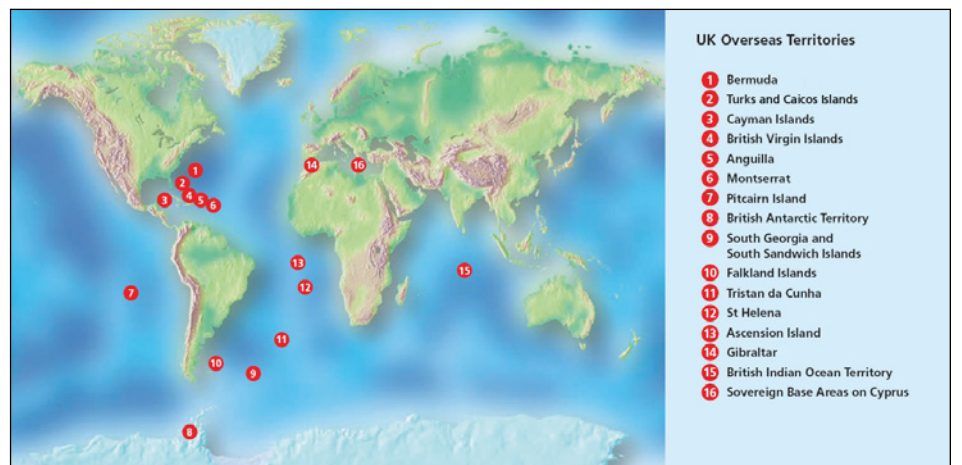

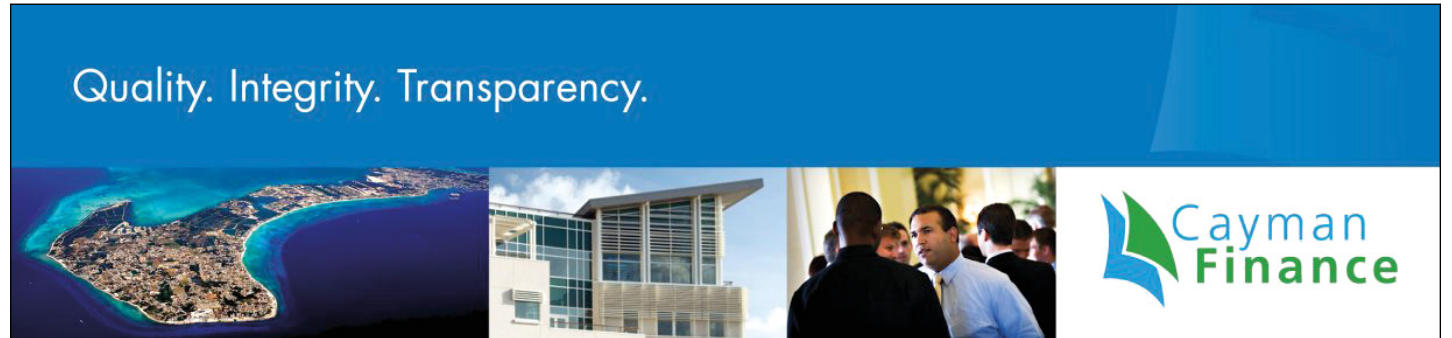

Online AML Learning Platform Now Available for Industry Members

The Cayman Islands Government, with support from Cayman Finance, has developed online learning modules relating to anti-money laundering, countering terrorist financing, and countering proliferation financing (AML/CTF/CPF).

These free, self-paced, on-demand lessons are available for persons in the financial services industry and in designated non-financial businesses and professions, such as lawyers and realtors. The objective is to reinforce Cayman's effective practice of the FATF (Financial Action Task Force) global standards, by facilitating the cascading of knowledge of AML/CTF/CPF throughout all levels of industry.



"The modules allow industry to further enhance their compliance with Cayman's framework, which is based on the FATF standards," said the Attorney General, the Hon. Samuel Bulgin, QC.

Each module is followed by a short quiz to solidify the learnings.

"I thank Government's National Co-ordination Team that is assisting the Anti-Money Laundering Steering Group (AMLSG), and the competent authorities who supervise various sectors of our industry, for prepar-

ing and narrating these short videos," he said. "I also thank Cayman Finance; and Government Information Services, which produced the bulk of the videos."

Added Ben Meade, Cayman Finance's Communication and Public Relations Manager, "We are pleased to be able to have our eLearning platform used as a vehicle to disseminate this important information. Like Government, industry is committed to maintaining and enhancing the Cayman Islands' position as a leading international financial centre."

The modules provide an overview of financial crime, including Government's structure and CFATF (Caribbean Financial Action Task Force) process; risks in the Cayman Islands for lawyers, accountants, realtors, non-profit organi-

sations, and dealers in precious metals and stones; and the obligations of financial services businesses.

"Industry members can choose the modules that best fit with their responsibilities, or complete them all," said Justine Plenkiewicz, Deputy National Coordinator for the AMLSG, who coordinated the modules' production.

"The aim of the online learning platform was to make information easily accessible to anyone who works with the Cayman Islands' AML/CFT/CPF framework, whether they are based here or overseas."

As more content is developed, industry members will be notified when new modules are added to Cayman Finance's e-learning platform.



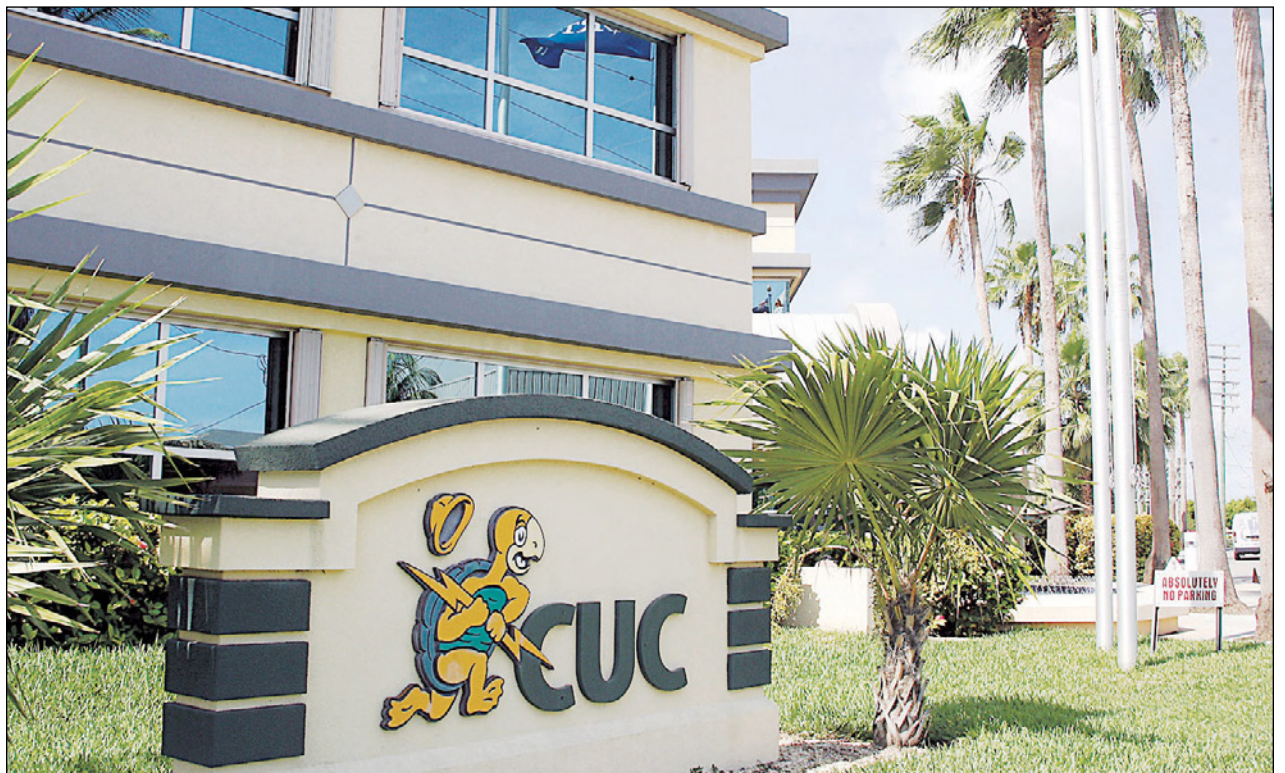

Added the disease to the schedule reflect how seriously the government is taking the issue and it gives the authorities additional powers under the law to manage outbreaks of certain diseases.

A release from the Department of Health says where persons are placed into quarantine will be determined by the Medical Officer of Health. It may be in their homes in some circumstances.

Visitors to the Cayman Islands who have travelled to mainland China within the last fourteen days will be quarantined under observation for fourteen days at a location to be determined by the Medical Officer of Health.

The Department of Health is also increasing surveillance and observation of any person with a relevant travel history to, from, or through mainland China suspected to be suffering from the novel coronavirus in the Cayman Islands.

According to the statement, "that will also involve the removal of persons to a place in which they will be quarantined during the incubation period (up to 14 days)."

Officials say the numbers of people with a relevant travel history to mainland China who require quarantine is likely to be small.

At this time, the restrictions announced do not apply to Hong Kong and Macau.

Regarding the heightened preventive measures now being implemented, Minister for Health, Hon Dwayne Seymour, JP, MLA said, "We appreciate how seriously this matter has been taken and the expeditious actions undertaken to help us safeguard the Public."

"It is important, however, that we all continue to do our part."

Hon Seymour urges all to "remain vigilant and take personal steps to protect our own health, and be reminded of cough and sneeze etiquette, to wash our hands often and to avoid close contact with people who have symptoms of a respiratory illness."

The Ministry of Health, Public Health officials and the management of the Health Services Authority have confirmed that at this time there are no cases of the novel coronavirus in the country.

Public Health officials and the management of the Health Services Authority continue to assure the public of their capability to manage any imported cases of the novel coronavirus.

They have also stated that national contingency plans will be activated as needed.

Cabinet has approved a budget of up to \$100,000 for the quarantining measures.

Two shelters have been identified that will be able to house persons as a first step, should this need arise.

For visitors who might need quarantine, designated hurricane shelters will

be used, although alternatives may be selected.

Food and drink, toiletries and internet access will be available.

Locally, families will generally tend to their own personal requirements but where this is not possible, Public Health staff will be able to purchase and deliver groceries to the residence.

The Department of Health says, "It is our goal to ensure those quarantined are comfortable, well attended by Public Health staff, and have access to outside communication such as internet access."

Persons without any symptoms but whose relatives are quarantined in their home are advised to maintain the recommended advice about simple infection control measures.

Those include frequent hand cleansing with soap and water, or an alcohol-based hand sanitizer and covering the nose and mouth when coughing or sneezing.

Persons who are quarantined must not have any physical contact or exposure with anyone apart from the controlled exposure to Public Health officials - this is part of the home quarantine requirements.

Families who have travelled together would be quarantined together.

If a child needed to be quarantined in their own right, this would be considered on a case by case basis.

The new regulations enacted by the government mean that persons currently being asked to stay at home under quarantine are legally required to do so.

Other than by phone, contact with people with a relevant travel history is not permitted until after the period of quarantine.

Public Health Cayman stresses that these measures need to be followed by all concerned to reduce the risk of any potential spread of the novel coronavirus disease in the Cayman Islands.

BREXIT'S NEXT STEPS: CARIBBEAN OTs PERSPECTIVES

One thing is certain though; all of the OTs seek clarity.

That is expected to take shape when the OTs leaders and UK government officials meet in March for what would be their first formal get-together since Prime Minister Boris Johnson took office in December.

A series of rapid Brexit-related political changes in the UK towards the end of last year meant that the annual Joint Ministerial Council (JMC) summit had to be deferred.

The UK government under then-prime minister Theresa May and now under its current leader Boris Johnson has set out to assuage any fears of the OTs being left in a lurch as a result of Brexit.

Cayman Islands Premier Alden Mclaughlin has said that with the UK no longer in the EU "there could be some challenges in terms of ensuring there is a level playing field and fair consideration of the Cayman Islands' efforts as it relates to EU-driven financial services initiatives."

Speaking recently in the Legislative Assembly he referred to an undertaking from the British government to look into areas where the UK could assist the territory with its direct lobbying of the EU on issues of specific interest.

This is the main would revolve around the Cayman Islands lucrative, globally-recognised offshore financial centre.

The OTs have been beneficiaries of EU funding programs and ease of travel to the EU under the UK's membership of the bloc.

The issue of funding is of particular relevance to Montserrat which has been the beneficiary of EU programs, the most recent being infrastructure funding covering part of its port development project - paid for mainly by the UK, and tourism promotion.

Montserrat has been heavily reliant on UK and EU funding ever since suffering severe economic disruption and

social displacement caused by the catastrophic of its Soufriere Hills volcano over a 15-year span starting in 1995.

The island's new Premier, Easton Taylor-Farrell, has spoken of the need for some specifics on how the vital EU funding gap for his island will be filled by the UK, especially after the current EU funding round expires.

Regarding funding especially, the British government of Prime Minister Johnson has repeated a commitment by the previous Theresa May administration that; "projects for the OTs under these funding streams will continue to be covered by the EU for their duration."

Looking at opportunities possibly arising from Brexit, Montserrat's Premier Taylor-Farrell said that with the planned upgrade to the island's port facilities, his government is exploring having Montserrat as a springboard for British companies developing further trade with the Caribbean.

His British Virgin Islands counterpart, Andrew Fahie, has similar concerns over funding, plus he also wants to maintain direct contact with the EU in several areas.

In an extensive statement on Brexit and its implications for the BVI, Mr Fahie addressed, among other areas, the BVI losing its Associate Status in the EU as one of the Overseas Countries and Territories (OCTs) directly associated with the bloc and EU funding.

"This is very unfortunate since the BVI is eligible for little other development assistance," he stated.

Premier Fahie said he has had talks with UK government officials "to get clarifications and assurances on the implementation period and upcoming UK consultations with the Overseas Territories on their priorities for negotiations with the EU."

He said, "It has been made clear to the UK that the BVI wishes to retain as many of the benefits and privileges that we currently enjoy with the EU, including

visa-free travel and tariff and quota-free trade, among other things."

The British Virgin Islands Premier also pointed out that, "in terms of replacement EU funding, he has officially recommended to the UK that it create a Sustainable Development Fund for all Overseas Territories from which to fund climate change, biodiversity and sustainable energy projects."

"This is particularly important," he noted, "since the BVI is not eligible for funds elsewhere."

Like the Cayman Islands and Montserrat, the BVI has indicated an interest in exploring opportunities for international trade presented by Brexit as the UK seeks out new trading partners.

The BVI leader said his territory will continue to be fully engaged with the EU on a range of areas including, the EU list of non-cooperative tax jurisdictions, membership in the Overseas Countries and Territories Association (OCTA) as an Associate Member to maintain a political presence in Brussels.

The BVI is also seeking Associate Membership in CARIFORUM, the Caribbean's negotiating body on EU matters and Premier Fahie said once that is approved, "we will begin to engage the EU on various matters involving trade and development alongside our Caribbean neighbours."

Premier Sharlene Cartwright Robinson of the Turks and Caicos Islands had previously outlined how her territory could benefit from Brexit.

"We believe that with the UK leaving the EU, there's an opportunity for the UK to have that direct funding with us, she stated in an interview with the UK's Guardian newspaper.

"We feel this is a good opportunity for a straight face-to-face relationship with the UK.

The Turks and Caicos leader said: "Looking at post-Brexit, there is going to be a lot of flight capital and we're standing ready.

"We know there are a lot of opportunities for business people here. I know we can benefit because after the UK

leaves the EU it will be more welcoming in that sense."

In the case of Anguilla, speaking recently during a forum on 'Whither Anguilla in Brexit', Premier Victor Banks asked: "What is all the fuss about?"

"Will Brexit impact our progress towards a greater level of autonomy and self-reliance? Will it change our colonial relationship? Will it change the social, economic and historical relationship that we have with territories of EU Member States with whom we have borders? Like St. Maarten-St. Martin as well as St. Barths?"

According to Premier Banks, "If none of the foregoing is going to change then Anguilla will be heading towards the same goals and aspirations for our national development that we have embraced before Brexit.

"However," he added, "if the issues prove challenging, in any new agreement/arrangement there will be good reason for Anguilla to accelerate its movement towards constitutional advancement and economic transformation/development."

Meanwhile, for Bermuda the issue also seems less concerning.

In an interview last December with the UK's Sky News, Premier David Burt outlined his territory's position:

"Bermuda is less affected than some other overseas territories as we do not receive aid from the European Union," he stated.

"Additionally, we have relations with the European Union that are outside that from the United Kingdom.

"As I said there are only two countries in the world that have regulatory equivalence with both the EU and the United States, being Bermuda and Switzerland."

"That is something that Bermuda has outside of Brexit, and after Brexit that's something that the United Kingdom will have to get on its own," the Bermuda Premier said.

The UK and the EU will now move to the next phase which is negotiations on a trade deal. That of itself will hold implications for the OTs, deal or no deal. 🌐

New concrete parrots being created

David and Kathy Quasius have been coming to stay at their lovely house North Side from their home in Wisconsin for more than 20 years. In 1998 Mr. Quasius was just catching up on a few home repairs using concrete, when an idea struck him: "Maybe I could make a concrete turtle," he said to himself. Sometime, not too long afterward, he started making more and more animals out of concrete, so that now when you drive along Old Robin Road all kinds of wonderful concrete animals greet you from his front garden. Some of them are normal-size, like the shark, the agouti the Mahi-Mahi (which seems to be jumping right out of the sandy ground as if out of water) or the crocodile (which is still pretty big, actually). Others are super-sized, like the giant land-crab and the scorpion, and the octopus: "I call it Jurassic Park, Cayman," Mr. Quasius said.

Everything in the park is themed around Cayman's wildlife, and the only thing missing, really, was Cayman's national bird, the parrot. Taking up the story, Mr. Quasius said: "I finally decided that I was going to do a Cayman Parrot. Then I got a call from Ron Hargrave the Chef from Tukka restaurant, and he said: "Dave I'm doing a parrot sanctuary and I would like to show you what I've been doing for the last year," so I went there. His idea is to bring in the kids so they can learn about Island life. It's wonderful." Mr. Quasius was only too happy to offer a pair of concrete parrots, perched on a concrete tree, to complement the two he is going to make for his park. Each pair is going to

be perched on a concrete tree, "Probably an almond tree, because Cayman parrots like almonds," Mr. Quasius said.

Both pairs which were begun a couple of weeks ago are nearing completion now. "The most important and time-consuming part is getting the metal armature, which supports the sculpture, right," Mr. Quasius said. He makes the armature out of strong rebar, which he has to bend and cut to shape. On top of this, he uses standard metal mesh used for masonry finishes. "The first coat is a scratch-coat, then I finish off with one or

two more coats of cement," he said. The final coat is very carefully finished, to provide as close-to-life a texture of the real animal's skin, or in this case, feathers, as possible. When I went to visit, they were still not finished, but were taking shape nicely. Mr. Quasius has also donated some nice sculptures to the Botanic Park: the huge cement Iguana which greets you when you begin driving down the park's driveway is one of his, as is a lovely little crocodile emerging from one of the park's many ponds. "I am going to have to find time to mend the Iguana,

because it developed a crack during the earthquake," he said.

"People ask why I do it, and I say, well its two things: I can often see families with kids coming here, and the kids love it. I call it Jurassic Park Grand Cayman because of course everything is super-sized, and I let them climb around on the animals and do whatever they want. The other thing is when we are sitting out there, we get to meet people from all over the world. I have met a thousand people in the park, and they come and chat every day."

Fatal Jet Ski Collision off Seven Mile Beach

A red Honda Civic collided with a green Chevrolet which was waiting to turn right onto the eastbound lane of Shamrock Road. The Civic then travelled left into oncoming traffic on the eastbound lane and collided with a white Honda Accord which was travelling eastbound.

Emergency services attended the scene and the occupants of the Chev-

rolet and the Honda Accord were transported to the Cayman Islands Hospital to be treated for minor injuries.

The driver of the Honda Civic left the scene of the accident and was later transported to the Cayman Islands Hospital for treatment for serious but non-life-threatening injuries. The driver, a man age 29 of West Bay, was later arrested on suspicion of leaving the scene of an accident. He remains in hospital in stable condition.

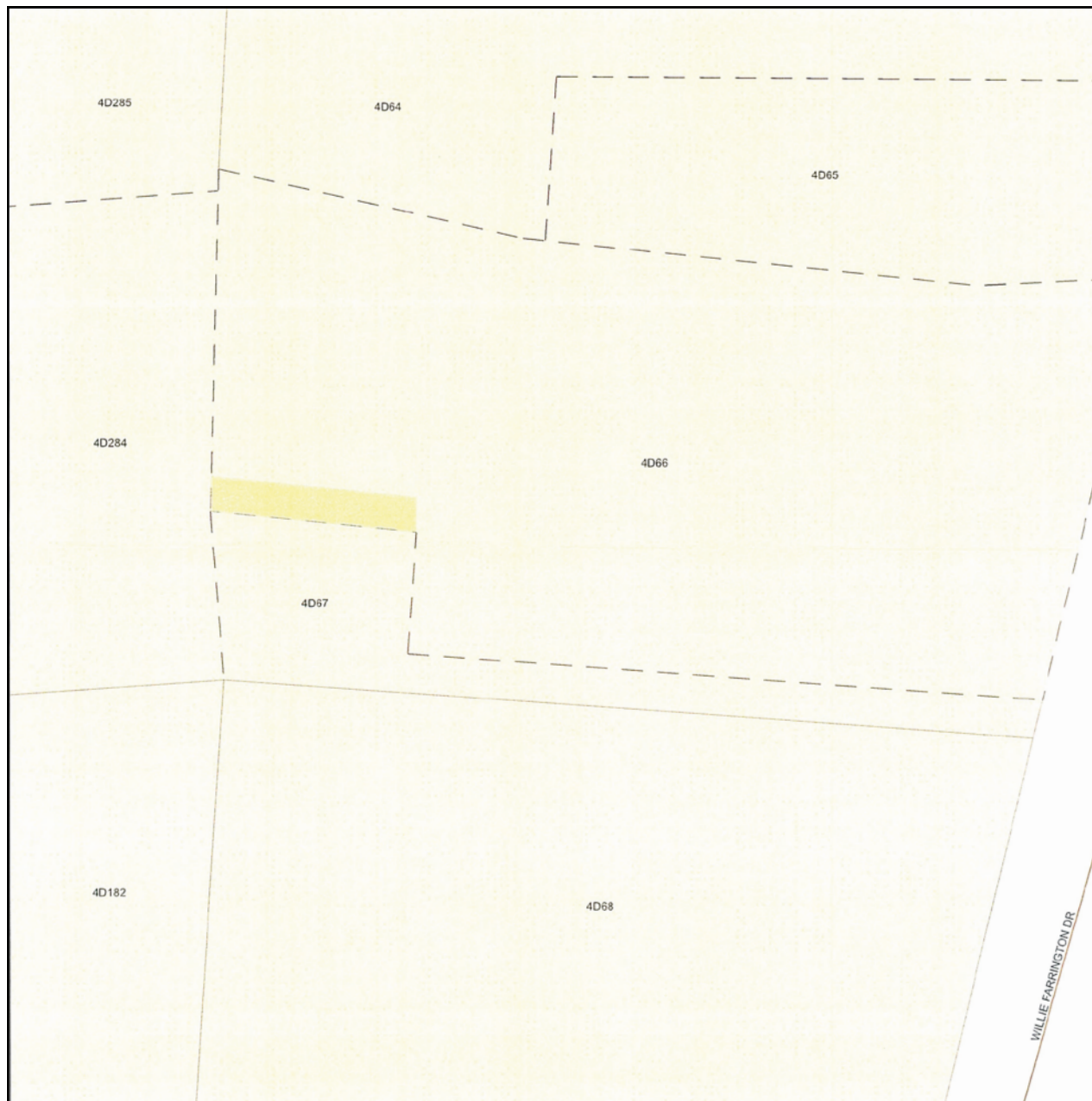

On Sunday, Cayman's elite dressage athlete, Jessica McTaggart took an important step on the road to international competition when she rode her horse Loris 7 in the FEI Intermediate 1 test for the first time ever, scoring an impressive 65.23% at the first National Dressage Show of the season, which was held at the Equestrian Center. The FEI Intermediate 1 test is the harder of the two tests that McTaggart will need to ride in order to obtain a qualifying score to compete at the next Central American & Caribbean Games which will take place in Panama in 2022.

McTaggart was clearly pleased with her ride, "While there are a few things we still need to work on, overall I couldn't have asked or expected more from Loris. He is an amazing horse that continues to develop with time."

The Cayman Islands Equestrian Federation (CIEF) flew in Bill Woods, a USEF "R" judge from Ocala, Florida, for

the competition. Other highlights from the show include newcomers Sandra Gowrie and Nadia Thompson who competed for the first time at a CIEF Dressage show. Marley Trench also debuted her new horse, Gitana RDL, on whom she won both of her classes and the award for Junior High Point Champion. McTaggart was named Adult High Point Champion for her ride on Bandalero.

The second of the four National Dressage Shows scheduled for this season will take place at the Equestrian Center located on the Linford Pierson Highway on March 29th starting at 8:00am. As always, spectators are welcome and admission is free.

ORIA Airport reopened Tuesday morning

The runway at Owen Roberts International Airport resumed full flight operations on Tuesday, 11 February 2020, at 7:00 a.m.

Runway operations were suspended yesterday at 3:23 p.m. as a result of partial damage to a temporary asphalt ramp placed on the evening of Sunday, 9 February 2020 as part of the runway rehabilitation project currently underway to strengthen the runway. Safety inspections and controlled observations by airport engineers were carried out immediately following the incident, in which the temporary asphalt ramp was "lifted" as a result of aircraft blast. Works were carried out yesterday evening to repair the temporary ramp and to ensure the permanent pavement was not affected. The runway was closed for approximately two and half hours, reopening at 5:55 p.m. yesterday evening with a re-declared distance, allowing limited flight operations to resume.

Additionally, the Cayman Islands Airports Authority's project team and the contractor met last night to discuss and agree enhanced methodologies to be used in the construction of tempo-

rary ramps to prevent a reoccurrence throughout the remainder of the project.

"We had a slight set-back yesterday on flight operations but took immediate action to address the situation and to secure the runway, only resuming flight operations after safety inspections and controlled observations indicated it was safe to do so," said Albert Anderson, Cayman Islands Airports Authority CEO. "I want to thank all teams involved in yesterday's operations and last night's works for their continued commitment to the highest standards of safety and operational excellence."

The runway rehabilitation project entails the runway to be milled to a nominal depth of 25mm to remove the existing runway grooves, paint and rubber deposits, and then 180mm of hot mix asphalt will be placed on the runway in a series of three paving lifts. At the end of each night's production, a temporary asphalt ramp will be placed on the runway to account for the difference in the elevations of the new and existing pavement, and temporary paint striping will be installed. After

the final lift of pavement is completed, the runway will be grooved and final markings placed.

Works on rehabilitating the runway began in early February 2020 and will

take approximately five months to complete. The works will require the runway to be closed nightly to all aircraft movements, between the hours of 10:00 p.m. and 7:00 a.m.

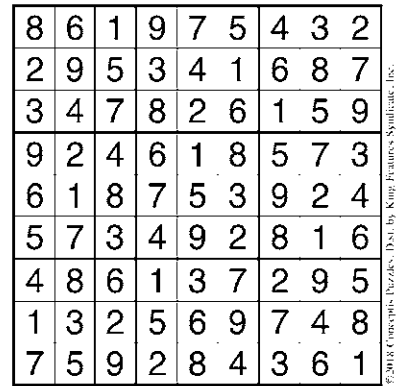
