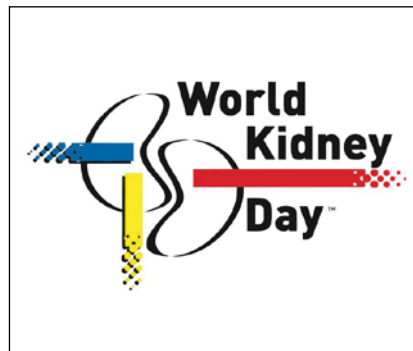

Premier praises firefighters' handling of dump fire

Hon. Premier Alden McLaughlin praised the firefighters who had managed to get one of the biggest fires in living memory under control in just 24 hours. "I want to start by thanking Chief Walker and Mr. Simms and the entire fire service for the tremendous job they have been doing. I was with them for about five hours last night and this area looked like hell. It has improved incredibly since then. The risks that they take in order to ensure that the rest of us can live comfortably is something that many of us take for granted. It is only in situations like this that we realize how truly valuable they are. They've done an incredible job," he said.

The Premier was joined by Fire Chief Paul Walker was joined by Department of Environmental Health Head, Richard Simms and Detective Superintendent Pete Lansdown of the RCIPS, Monday 9 March to update the public on the progress in dealing with one of the biggest dump fires in living memory.

The fire, which had become a raging inferno on Sunday night because of the strong winds, had been contained and was under control on Monday morning. But

Jamaica today confirmed its first imported case of the new Coronavirus (COVID-19).

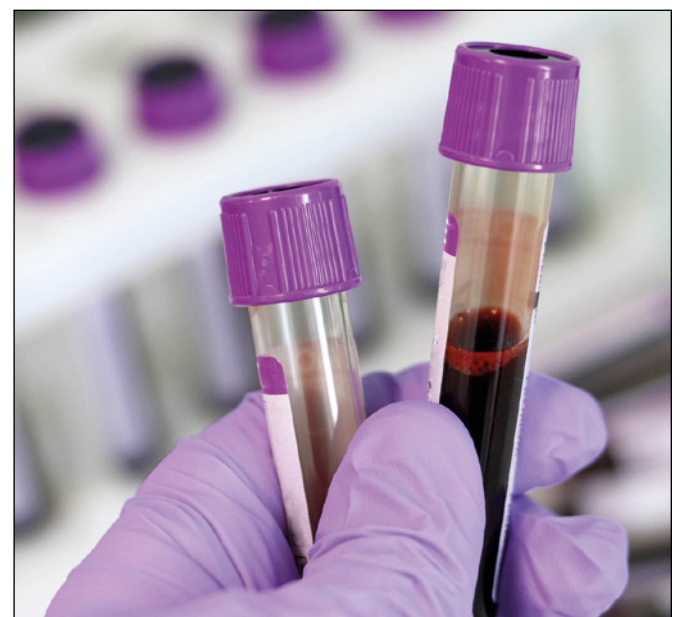

In a statement issued a short while ago, he said the woman arrived in the island on March 4 and presented to the public health system yesterday and has been in isolation since then.

First Cayman COVID-19 Samples Sent Testing

The individuals in question are citizens of the Cayman Islands, and one visitor.

The nationals have been self-isolated in their own homes and are being monitored by Cayman Public Health officials.

The visitor is an inpatient at Health City Cayman Islands who was admitted for a cardiac event, but has subsequently developed respiratory symptoms typical with cardiac recovery.

However, health officials say that out of an abundance of caution that person was also placed in isolation while test results are awaited.

The samples were sent to CARPHA on Monday, the agreed schedule for sending infectious material by courier between the Health Services Authority and the CARPHA laboratory.

The results are expected within six days.

Medical Officer of Health, Dr Samuel Williams-Rodriguez assures the public that the persons under isolation are being actively monitored by health care professionals and pose no existing risk of onward transmission.

Dr Williams reminds that this is just a precautionary test and notes that in countries with reported cases, the number of negative test results is higher than positive results.

The Public Health Department is in daily contact with all of them and they have agreed to comply with the conditions of their isolation while the results from CARPHA are awaited.

He also urges Caymanians, residents and visitors continue to practice preventive hygiene as a key safeguard against the new coronavirus.

Recommended measures include; regularly washing hands with soap and water and using alcohol-based hand sanitizer if soap and water are not available.

Covering coughs and sneezes with a tissue if available, or flexed elbow as necessary, and maintaining social distance (that is three to six feet of distancing between two people).

"These things may seem insignificant," Dr Williams says but stresses that "they have been proven to prevent infection."

"A simple way to remember your personal responsibility in mitigating the impact of COVID-19," he advises, "is to 'Catch 'em. Trash 'em. Contain 'em.'"

Meanwhile, given the global spread of the coronavirus, Chief Medical Officer Dr John Lee urges members of the public who have flu-like symptoms and feel there is a risk they may have the disease, to contact the HSA at flu@hsa.ky or via the flu hotline 1-800-534-8600.

Officials say that testing for COVID-19 in the Cayman Islands should be available within the next two weeks through the Health Services Authority.

Public Health Cayman says this will augment pre-existing testing capabilities through CARPHA.

Dr. Ivan Eubanks Selected by U.S. Department of State for Prestigious English Language Specialist Assignment

The U.S. Department of State announced the selection of Dr. Ivan Eubanks of the University College of the Cayman Islands for a three-week English Language Specialist project focusing on developing the national writing curriculum for universities across Pakistan, in collaboration with the Pakistani Higher Education Commission. Dr. Eubanks is part of a select group, as his project is one of 130 that the English Language Specialist Program supports each year.

Dr. Eubanks is Assistant Professor of Media Studies and Director of UCCI TV at the University College of the Cayman Islands. He served for eight years as Editor in Chief of the Pushkin Review, an international, bi-lingual, peer-reviewed journal. He has also served in an editorial capacity for Educational Studies, WR, and other publications. He has extensive training in curricular design and writing pedagogy, and has trained university faculty and administrators in those areas in Pakistan, Russia, Mexico, Hondu-

ras, and the U.S. In Pakistan, he will work with the Higher Education Commission and faculty from around the country to develop a sequence of three academic writing courses that will be required of all college and university students as part of the national curriculum.

HSA offers free health screenings for World Kidney Day

In celebration of World Kidney Day (WKD), the Cayman Islands Health Services Authority (HSA) will be providing free health screenings on Thursday 12th March from 8:00am – 1:00pm in the Cayman Islands Hospital Atrium. Screenings include blood pressure, glucose, cholesterol, height and weight measurements and urine test for those ones that have hypertension and high glucose levels. All members of the public are invited.

Celebrated every year on the second Thursday of March, World Kidney Day's global theme is "Kidney Health for Everyone Everywhere – from Prevention to Detection and Equitable Access to Care" with the aim to increase awareness of the importance of our kidney health and reduce the impact of kidney disease and its associated problems worldwide.

"Persons with diabetes, hypertension and a family history of kidney disease have a higher risk of developing chronic kidney disease (CKD), said Dr. Iheonunekwu Nelson, HSA Internist/Nephrologist. "However, it is important for everyone to take a vested interest in their kidney health as CKD affects 1 in 10 persons globally".

"The severity of chronic kidney disease varies from patient to patient, however this is an incurable disease and can lead to lifelong dialysis. Locally, we have the resources to provide early detection, treatment and management. We currently provide hemodialysis to 67 patients in our Dialysis Unit and in 2018 we had a crude mortality of 9 percent. Our dialysis unit caters to all local dialysis patients and visitors with 11 beds operating six day per week."

The screening acts as a primary prevention measure and offers those who believe they are at risk of kidney-related illnesses the opportunity to learn more about preventive behaviours. Attendees will be able to speak to a variety of clinicians including nurses, a physician and dietitian.

On Thursday evening a special presentation on chronic kidney disease prevention by HSA internist Dr. Raymonde Rohan-Moving will take place from 5:00-6:00pm in the Hibiscus Conference at the Cayman Islands Hospital. The presentation is open to the public and will offer Continuing Medical Education



(CME) credits to medical professionals who attend.

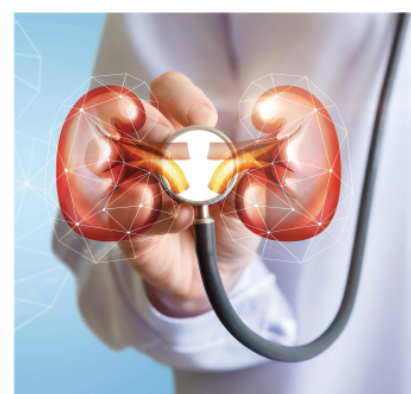

the constant plume of black smoke had caused a virtual gridlock of George Town's main roads, closure of Esterley Tibbetts Highway, and previously led to several hundred residents from the nearby Lakeside condo as well as the Walter's Road area, to be evacuated.

Mr. Walker said: "I am immensely proud of my colleagues from Cayman Islands Fires Service who have worked tirelessly over the past 24 hours at a challenging fire on our landfill site. Working with colleagues from the Department of Environmental Health, Hazard Management, the National Roads Authority and the Ministry for Home Affairs and Financial Services. We've had

a real team approach to, in the first 24 hours, stopping this fire spreading from beyond the boundaries of the landfill site which we have done successfully. Of course, I understand the local impact on businesses and residents, and offer an assurance to the residents and the businesses in this vicinity that we will bring this fire under control and extinguish it as soon as we possibly can.

"But this is a challenging fire, and the wind conditions we have got here are fanning smoke, and the fire is spread over three fronts, and we are working on those three fronts to extinguish it. We have put in place a risk-assessed opening of the North Bound Carriageway of the Esterley Tibbetts Highway and that will be in effect from 4pm to 6.30 this evening.

Mr. Simms said: "We are doing our utmost best to ensure that this fire is kept under control and we also want to assure everyone that our normal operations in terms of regular collection of garbage continues, so if there is a little delay in terms of collections, please bear with us but we will do our best to continue operations. I would like to thank the overwhelming support and assistance that's been poured out to us from the private sector; We've had people coming and offering their heavy equipment their excavators, front-loaders, as well as their dump trucks.

Mr. Lansdown said: "We were notified of this fire at 4pm on Sunday afternoon and the officers made a very

quick assessment and established it was dangerous for any vehicles to go north or south on the carriageway and close both roadways. Soon afterwards, we established that sparks and embers were potentially going to cross the road and could have caused a major hazard to the residents of Lakeside. The smoke was quite thick, and could have caused respiratory problems to the residents and I made the decision to evacuate Lakeside. I am very proud of the response: four or five hundred people left the lakeside area, and they were offered the services of the Red Cross Shelter. I am very proud of Mr. Webster, of Mr. Webster's busses, who very graciously offered the assistance of his vehicles to assist with moving people out.

Landfill Fire Update at 12pm on Tuesday, 10 March

Landfill Fire Update at 12pm on Tuesday, 10 March 2020.

The Cayman Islands Fire Service (CIFS) crews continue to make steady progress in tackling a fire at the George Town Landfill site.

Colleagues from the Department of Environmental Health are assisting with excavating, damping down and capping the areas affected in order to reduce smoke and extinguish the fire.

As anticipated, through the process of excavating, controlled flare ups have occurred which have been extinguished quickly by crews.

The next operational strategy meeting will take place on site at 4pm. A decision will then be made as to whether the smoke has subsided enough to safely allow Lakeside Apartments and Watler Road residents to return home this evening.

The next update will be shared after 4pm today.

BREAKING NEWS: Jamaica Confirms First Coronavirus Case

Dr Tufton said that based on her travel history and symptoms, health professionals had suspected COVID-19, the virus which originated in Wuhan, China and has spread to more than 100 countries.

"A clinical sample was collected and sent to the National Influenza Centre,

where laboratory tests confirmed the diagnosis today at approximately 11:00 am. The patient and family members have been informed.

"The patient's infection was travel-related. However, steps are being taken to prevent the risk of community spread," the Health Minister said.

A health team has been sent to the home of the patient for assessment and initiation of public health measures; all possible exposed persons are being identified and traced, and there will be a meeting of Ministry officials and members of staff at the hospital and the necessary interventions put in place.

As of yesterday, there were 109,577 confirmed COVID-19 cases and 3,809 deaths globally.

The Jamaican case is the first in the English-speaking Caribbean. A few others have been recorded in the Dominican Republic, Martinique, Saint Martin and St Barts. 🌐

Injunction Blocking Declaration of Election Results in Guyana Stays in Place

A week after Guyanese went to the polls to choose a new government, Chief Justice Roxane George yesterday upheld an injunction blocking a winner from being declared, amid concerns about electoral laws being breached.

The injunction, filed by Reez Holland, a supporter of the main opposition People's Progressive Party/Civic (PPP/C), was granted last week by High Court judge, Justice Navindra Singh to prevent the outcome of the March 2 vote being declared until the legal process of verification of results in Region Four, Guyana's largest electoral district, is complied with.

The court action came after the Returning Officer for Region Four, Clairmont Mingo, only allowed the verification process for Statements of Poll for 421 of the 897 polling stations. The unverified results put the incumbent A Partnership for National Unity-Alliance for Change (APNU-AFC) coalition in the lead over the PPP/C by just over 59,000 votes. The opposition has alleged fraud in the counting and verification process.

In maintaining Justice Singh's injunction and ruling that the court can invoke is supervisory responsibility to ensure that the correct procedure is followed, the Chief Justice said she would begin hearing the case tomorrow to decide whether to direct Mingo to complete the verification process in the presence of party agents and local and international observers.

While attorneys for the applicant had argued that the court had jurisdiction to hear the matter, lawyers representing the Guyana Elections Commission

(GECOM) contended that the applicant had been premature in going to the court since the issue could only be addressed via an election petition after the results of the vote were declared.

However, Justice George said in her ruling that a court cannot shirk its duty and "shelter behind the contention that an elections petition should be filed when the case clearly does not so warrant".

"As such, having found that there is prima facie evidence to support the court having jurisdiction to hear this application, the respondents must be given a chance to be heard in response through any evidence they may wish to file," she said.

Although disappointed with the ruling, attorney Roysdale Forde who is on GECOM's legal team said they would comply with the order and review all options available at this stage.

"We remain resolute in our position that the declaration of the Returning Officer is a valid declaration made and we will return to court," he said.

The law makes provision for the official declaration of results to be made within 15 days after the holding of elections, and GECOM's lead lawyer Senior Counsel Neil Boston said he is confident that the Chief Justice will rule before that time expires.

Boston, Forde and Robin Hunte are representing the country's elections body in the matter while the PPP/C is represented by Trinidad and Tobago Senior Counsel Douglas Mendes along with local attorneys Anil Nandlall and Sanjeev Datadin.

Meantime, GECOM said in a statement issued yesterday that it is "unfortunate how things have escalated" and insisted that it intended to abide by all legal and procedural requirements to conclude its work.

It also sought to explain the decision by Chief Elections Officer Keith Lowenfield to prepare his final report on the results of the elections and write to GECOM Chairperson Retired Justice Claudette Singh on Saturday seeking a meeting approve that report, although the injunction preventing the declaration of results was in place.

"The recent action of the Chief Election Officer indicating to the [GECOM] Chairperson and Commissioners that his report in the relation to the final declaration was completed was not intended to disregard the court proceedings, but rather apprising the Chairperson of the completion of the document and that she may convene a meeting at her convenience. In relation to this matter, no meeting was scheduled," it said.

"GECOM remains resolute in the fulfillment of its constitutional and statutory obligation." 🌐

Teen Killed During Post-Election Unrest in Guyana; Lawmen Warn Protesters Against Unlawful Acts

An 18-year-old who was among a crowd of people protesting alleged fraud in the recent general and regional elections was fatally shot by police while attacking lawmen with a cutlass, the Guyana Police Force (GPF) said.

Sewdat 'Devon' Hansraj of Back Street Cotton Tree Village, in the rural West Coast Berbice region, was among hundreds of people who had taken to the streets in his community last Friday to demonstrate against the move to declare results from Region Four from the March 2 polls.

In a statement issued the following day, police said it was after clearing barricades set up on Cotton Tree Public Road that officers had come under attack by a group of men armed with cutlasses, wood and pieces of iron.

According to the GPF, the police discharged their weapons in the air to disperse "the very hostile and aggressive crowd" around 7:40 p.m., but when their bullets were expended they had to seek refuge from the crowd and it was during that time that Hansraj chopped two officers. The teen was subsequently shot by another policeman.

The injured officers and civilian were taken to the New Amsterdam Hospital where Hansraj was pronounced dead on arrival.

The GPF said yesterday that five officers injured in violent protests in the country were recovering and receiving counselling.

Meantime, police have issued a stern warning to protesters not to engage in unlawful acts.

They said that while they have maintained a posture of restraint, the actions of protesters have led to injuries to lawmen and damage to private and State property, and several children have also sustained minor injuries.

"The Force respects the inalienable rights of citizens, visitors and inhabitants of the State of Guyana to engage in peaceful demonstration on issues of concern to them," the GPF said, but stressed that "when protest activities degenerate into public disorder, infringing on the rights of other citizens and putting the protection of life and the safeguard of property at risk, the Guyana Police Force will as a consequence, take appropriate and condign action against all offenders." 🌐

Immediate Quarantine for Visitors to Barbados Now Extended to Anyone Arriving From Any Part of Italy

The Barbados Government has expanded its quarantine protocol to apply to passengers arriving in Barbados from all of Italy.

Previously, only persons arriving from three districts in northern Italy were impacted by the 14-day quarantine requirement related to the coronavirus, COVID-19 outbreak.

But Acting Chief Medical Officer Dr Kenneth George says that based on the latest available information from the World Health Organization (WHO) and the Centres for Disease Control and Prevention (CDC), the decision was taken to require all arrivals from Italy to report to Port Health at the ports of entry and be sent to immediate quarantine.

As of yesterday there were 5,883 cases in Italy and 234 deaths - the largest number of cases and deaths in Europe, which is one of Barbados' main tourism markets.



Health officials said the type of quarantine in which a person who arrives from Italy is placed will be determined by the level of risk of exposure. Low risk

individuals will be sent to home quarantine while moderate to high risk individuals will be sent to mandatory quarantine.

Additionally, the Ministry of Health and Wellness has advised residents of Barbados against all non-essential travel to Italy with immediate effect.

Meantime, the Ministry disclosed yesterday that three passengers aboard the Italian cruise ship Costa Magica, who were exhibiting respiratory symptoms and suspected of possibly having COVID-19, were found to be negative after being tested in Barbados.

The ship had docked in the island after being denied entry in Tobago, with a total 2,307 passengers and 962 crew. Those included 417 Italians who would have boarded the vessel between February 28 and March 6.

The tests were conducted on board the ship by a public health team. None of the passengers or crew was permitted to disembark in Barbados. 🌐
