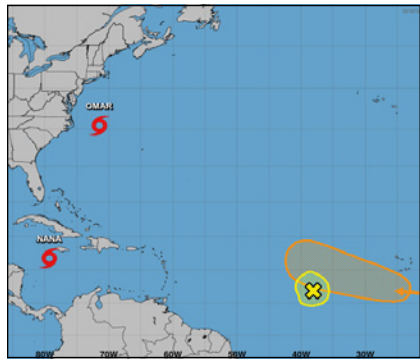

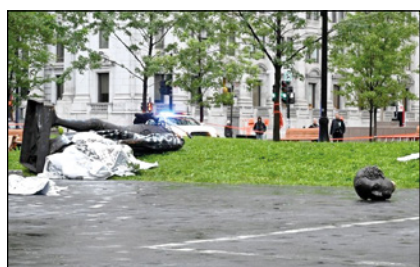

NEW CENTRE FOR SMALL BUSINESS OFFICIALLY OPENS

Announcing that Cabinet has approved a further medium-term economic package for the small business sector, Hon. Minister for Commerce and Infrastructure Joey Hew on Tuesday officially opened the new Cayman Islands Centre for Business Development (CICBD).

Located at the Baytown Plaza on West Bay Rd, the CICBD was already operating virtually since March this year, responding to the needs of small businesses during the pandemic.

Now its doors are open with the centre providing a variety of support services for small and medium-sized enterprises (SMEs).

Initially, 300 small businesses assessed as competitive post COVID-19 will be the beneficiaries of the programme announced by Mr Hew.

IN SEARCH OF A HAPPY MEDIUM

After an intensive round of media appearances and a series of meetings on the controversial Domestic Partnership Bill, HE Governor Martyn Roper was due to assent to what was expected to be known as the Civil Partnership Law this weekend.

His virtual and in-person shuttle diplomacy round of consultations locally, and with his bosses at the Foreign and Commonwealth Office might have smoothed some feathers, but others remain ruffled.

While the over-arching issue surrounding the legalisation of same-sex relationships in Cayman - including same-sex marriage - has

been a long-running saga, the debate focused on Domestic Partnerships (or Civil Partnerships) has been short and intense.

The Governor's assent - itself shrouded in controversy - might to a degree close a chapter on this tussle over human rights, the constitution, societal morals, culture - and what constitutes acceptable forms of public displays of affection in Cayman.

It could also be the start of a new discussion about social transformation, adaptability, acceptance and tolerance.

What is certain is that views are deeply entrenched and are not likely to change overnight...or to be more practical, over the days to come.

This debate over civil/domestic partnerships has thrown wide open a broader examination of the sweeping array of legislation impacted by this new law, the powers ascribed to the holder of the post of Governor, as well as issues of culture in Cayman's multi-cultural cosmopolitan community.

It has been stressed that the new civil partnerships law is not limited to same-sex partners in that it is accessible to heterosexual couples as well who might not be keen on having their relationship - and crucially any agreed or legally-defined obligations to each other - cemented under the banner of a formal religious ceremony.

Clergy are not required to officiate over the exchange of vows and the existing Marriage Law, rooted in Christian principles, remains intact and untouched.

A related issue over the recognition of same-sex marriage in Cayman, from which the domestic/civil partnership issue in Cayman is derived, is due for hearing by the Privy Council.

There is a point of view that whichever way the Privy Council rules will impact the law now coming into force.

With an election also in the offing, we accept that the debate may very well simmer for some time yet. The hope is that it has already reached its boiling point and has not boiled over. Cayman knows how to keep a lid on things.

One thing is certain; this issue is historical and its implications are far-reaching.

Like all 'partnerships' a happy medium must be found to co-exist, and we are convinced that in this case, in Cayman it already exists.

Possibly amongst the most profound comments heard during the passionate debates triggered by this issue, were those by persons 'who knew people who are gay and never had a problem with them anyway'.

Perhaps the 'happy medium' has been there all along.

Open Letter Of COGC H.E. on the DPB

The Executive Council of the Church of God Chapels in the Cayman Islands wishes to go on record publicly to express its disappointment and distress with the announcement made on Wednesday, July 4 by the office of His Excellency the Governor in which the democratically-wrought result in our Legislature of a hugely significant moral and social issue has been over-ridden without due regard to the wishes of the majority of Caymanians, and one which—if actions proceed as announced—will in law accord morally and socially deviant lifestyles the same standing as the morally and socially constructive institution of marriage between a man and a woman.

This Council regrets having need to publicly express its opposition to the announced planned action by the office of His Excellency, and while wishing to make clear that in so doing it has no intention of impugning the character to the Governor, we stand resolutely with the divinely-given model of marriage and the moral principles that protect the family.

We propose that it is ill-advised for governments to cater to social experiments that innately dilute and devalue the proven socially-constructive institution of marriage, irrespective of the source of guidance or compulsion to so do.


We acknowledge that governments, major corporations and international institutions have caved-in to the shaming and harassing tactics strategically-utilised by the radical LGBT+ movement in order to achieve their goals, and that such tactics have pressured into existence activist courts and judges, resulting in arbitrary rulings that have undercut the authority of national legislatures.


We further declare that our position on marriage and sexual morality are based on the biblical ethic of love for both individuals and society as a whole, and refuse to allow those who oppose the Christian worldview to control the discourse and categorise our position as being hateful. NEW CENTRE FOR SMALL BUSINESS OFFICIALLY OPENS

It will be funded out of the remaining micro and small business grant set up by the government to assist SMEs through the economic downturn.

"With the launch of the CIBDC, we are working in a concrete and targeted way through a new phase of support that will benefit Caymanians and our economy," Min. Hew stated.

It's been observed that small businesses are the backbone of any economy, and the official opening of the CIBDC is seen as an essential component of what Cayman needs to get its economy moving again after COVID 19.

Small businesses, (employing a dozen people or less) and micro businesses (staffed by up to four people) account for well over a third of Cayman's workforce.

RECOGNITION OF SMES

According to the Commerce Minister, "The establishing of the Cayman Islands Centre for Business Development is an acknowledgement by this government of the importance of small businesses here in these islands."

"The Global pandemic has made the Centres mandate of improving and proving the economic value of small businesses in the islands even more urgent," he added.

Since it was first set up, the CIBDC's business advisors have been conducting daily virtual coaching and training sessions focusing on business continuity for the many micro and small business owners impacted by COV ID-19.

Those sessions focused on areas such as cash flow management, business impact

analysis, and transitioning business online for entrepreneurs who need to redesign or retool their business models.

The Centre also coordinated Government relief measures which were allocated to support the micro and small business grant programme, a low-interest loan programme, as well as technical and training programmes.

Mr Hew pointed out that over the past months, the government has allocated over \$14 million to support micro and small businesses.

"We extended the small business support programme, and temporarily waived trade and business licensing fees for new businesses and renewals as well as late fees with a total value of \$375,000."

The new phase of support for small and micro businesses will cover wage, digital enablement, commercial rent assistance, business process innovation grants and customised business continuity plans for micro and small businesses across the islands.

Several hundred small and medium-sized enterprises (SMEs) have already benefited from the funding, services and expertise offered by the CIBDC.

According to one observer present at the opening ceremony, new businesses are vitally important after a crisis like COVID - 19 which disrupts 'business-as-usual,' as they can quickly fill new market niches. They are seen as "the seedlings of tomorrow's economic forests and like all seedlings, they need to be protected, nurtured, and watered." "And that's precisely what CIBDC does," it was stated during a tour of the agency's facilities.

Commerce and Infrastructure Joey Hew said, "One of Government's major strategic priorities is harnessing the creativity of Caymanians to build innovative and sustainable businesses so as to increase global competitiveness."

"Today with the opening of this location we are able to realise this goal with space that will integrate offices for business advisors, a training room, and a residential business incubator that will

house up to 12 start-ups for a period of up to two years, free of charge to them."

A MAJOR INITIATIVE

Hon. Premier Alden McLaughlin called it "a major initiative of our government."

In commending Min. Hew for bringing it to fruition, he declared:

"We are very pleased that the minister has managed, despite all of the challenges of COVID 19, to open the Centre today. You find that without the training and the support most start-ups just never survive beyond the initial stage because the people involved, while they are very good at what they do, whatever service they provide or whatever product they produce, they don't necessarily know how to run a business."

Premier McLaughlin the CIBDC address that problem. "This will provide them with that kind of structure and training and the opportunity for creation of skills in business development."

AN IDEA WHOSE TIME HAS COME

Director of the CIBDC, Althea West-Myers said the Centre's opening has been long in the making.

"Today we are heralding an idea whose time has come," she stated.

"The critical role that Cayman's SME's will play in bringing these Islands back to global competitiveness cannot be overstated. For the economy to survive and thrive, the sector and the ecosystem in which it exists must be stimulated. It is not surprising therefore that the establishment and promotion of small businesses have been given strategic importance by this government."

The CIBDC director urged the small businesses to avail themselves of the services available to them through the agency.

"They just have to recognize they are in need of some kind of help some kind. We are open to all small businesses and every small business in the Cayman Islands can benefit from our services. We like to think that we take it from the concept stage to market." 🌐

Sale of Fidelity Pension Plan

Meanwhile, the press release adds that RF Holdings Limited, the parent company of RF Group, acquired Fidelity Pension Services (trustee and administrator of the Fidelity Pension Plan) on 31 December 2019.

The Bahamas-based RF Group is said to have provided accounting and administration support services to the Fidelity Pension Plan since its inception in 2004.

Fidelity says although payment of pension contributions can still be accepted by Fidelity Bank, it is unable to handle any queries related to a member's holdings in the Fidelity Pension Plan.

Recently, Fidelity was forced to apologise for delays in processing pension payouts under the Cayman Islands Government's (CIG) COVID financial relief early pension withdrawal scheme.

The company had cited internal administrative arrangements as part of the reasons for the delay.

It said then that Fidelity new parent company, RF Group, had officially taken over the management of the Fidelity Pension Plan on May 1st 2020, the same

day the changes to the Cayman Islands Pension Law came into effect.

Sale of Fidelity Insurance

Fidelity Insurance is also affected by the divestment.

Royal Star Assurance and Guardian General Insurance jointly acquired Fidelity Insurance on 30 September 2019.

Fidelity Insurance has acted as a local agent for both insurance companies for over 20 years providing an array of health insurance solutions to local companies and their employees.

Tuesday's statement said although payment of insurance premiums can still be accepted by Fidelity Bank, it is unable to handle any queries related to

any policies held through Fidelity Insurance.

Work Being Carried Out on Miss Lassie's Home

Mind's Eye, the historic home of Caymanian visionary artist Gladwyn "Miss Lassie" Bush, is currently undergoing some maintenance, the Cayman National Cultural Foundation (CNCF) has advised. Specifically, the wooden windows and doors of the main house have been temporarily removed for re-colouring and are expected to be back in place later this month where they will once again showcase the brilliance of Miss Lassie's work, or 'markings', as she called them.

Miss Lassie's House is an authentic turn of the century Caymanian wattle and daub structure located at the intersection of Walkers and South Sound Roads. It was built by her father and grandfather, who started to work on it in 1878. During the artist's lifetime, because of the seaside location of the property and the vagaries of weather, her "markings" on the wooden windows would fade after a time and she would often touch them up or repaint them as inspiration stirred her. When CNCF took possession of the property a few years after her death, the original windows were stored away for conservation and safekeeping, but the Foundation had Ms. Lassie's creations on the windows and doors reproduced by local artist Sue Howe in 2013. Ms. Howe has once again been commissioned and is in the process of recoloring those reproductions so that they retain their uniquely striking appearance. The openings have been shuttered in the meantime for protection in the event of a storm.

"As Miss Lassie said many years before her passing, "The weather plays havoc with my markings", explained Henry Muttoo, CNCF Artistic Director. "When she was alive, she was able, when the

necessity arose or her vision changed, to repaint or alter the images on her windows. This added new lustre and longer life to her paintings and also helped preserve the wood. Now that Miss Lassie is no longer with us in the flesh, the images she left must be preserved as faithfully as possible. That is why CNCF has engaged Sue to copy Miss Lassie's original window and door images onto the newly built ones, before the weather takes further toll and flaking begins. Sue did a terrific job on the replacement windows when the house was first conserved and opened to the public and, because she is so familiar with the construction of the images, she has been invited to repaint the images a second time."

"It is a great honour to once again be working on Miss Lassie's historical house," said Ms. Howe. "I'm very excited to be able to revisit the original pieces with new eyes and stay as close to her work style and subtle colour variation as possible, and to capture still more depth of colour and detail of the shaping of her markings. I want to bring these replicas a further richness and detail, and just really celebrate how much complexity even the most seemingly simplest of designs holds."

She continued, "It's amazing the number of new things that appeared to me this time around. I do love how familiar the pieces feel to me, like visiting a friend you haven't seen for a long time. It is a wonderful and magical location to be in, and I really appreciate the opportunity to be able to work where she lived. That really adds something for me."

Ms. Howe thanked Henry and Marcia Muttoo, and the CNCF Board, management and staff for their support



and confidence in her as well as Steve Hawley and the Phoenix Group for their body of work over the years, and for their continued support and interest in the project.

CNCF offers guided tours of Mind's Eye - The Visionary World of Miss Lassie for the general public and for students by appointment only. Although suspended due to COVID-19, tours are expected to resume soon.

She was also a recipient of the Cayman National Cultural Foundation's Heritage Award. Her work is documented in the 156-page art book, My Markings - the Art of Gladwyn K. Bush, published by the Cultural Foundation.

Her work is in private collections in England, the United States, Jamaica, South Africa, Germany and the Cayman Islands, and in the collection of the American Visionary Arts Museum in Baltimore, Maryland. Miss Lassie passed away on Monday, 24 November 2003 at the age of 89.



POLICE NEWS

Police Carry-Out Operation in Kaibo and Rum Point Area

Concerns from the community regarding drug activity and other anti-social behaviour has lead the RCIPS to organize a joint operation in the Kaibo and Rum Point area of North Side, which took place on Sunday 30 August.

Officers from various units including the K-9 Unit, Air Operations Unit, Firearms Response Unit, Community Policing Unit, and Operational Support Unit as well as officers from the Cayman Islands Coast Guard, all came out to support the uniform branch of the Eastern Districts to conduct searches on vessels as well as in the surrounding area. The heavy police and support presence also served to disrupt drug use and other anti-social behaviour, including loud music and traffic offences such as DUI and speeding.

"Members of the community expressed concerns to the police

about an increased presence of loud music, drug usage and other nuisances in this area, especially on Sundays and in particularly after the softening of the Covid-19 restrictions," says Inspector Fernando Soto, Area Commander for the Eastern Districts. "The operation was successful as we were able to disrupt a number of illegal activities resulting in a few arrests. As part of our ongoing efforts to reduce the incidence of crime and ensure the safety and well-being of the community we will conducting operations on an ongoing basis."

The operation resulted in three drug-related arrests being made throughout the time period that officers were present, and drug related searches in two other districts. All parties have been bailed to return pending further investigations.

Police Service Vehicle Involved in a Collision

Just after 11:15AM on Monday 31 August, the Firearm Response Unit was travelling along West bay Road in the vicinity of Marsh Road, West Bay, when they received an emergency call to attend a report at an establishment located at Governor's Square. During the course of their re-

sponse, a collision occurred between to the service vehicle and private vehicle.

Neither the officers nor the occupants of the private vehicle reported injuries as a result of this collision.

The matter is currently under investigation.

Police Appeal for Witnesses in Fatal Stabbing

Police have now confirmed the identity of the victim in the fatal stabbing which occurred at the Strand on Canal Point Road, on Saturday morning, 29 August.

He is Lionel Ricardo Pars, age 27 of George Town.

The RCIPS expresses condolences to the family of the victim.

Detectives are aware that several people were present at the time the incident occurred, which was shortly after 3:30AM. Several videos taken by persons at the scene have been circulating anonymously, and detectives are urgently appealing for anyone who witnessed the incident to come forward.

"The laws of the Cayman Islands require us to produce best evidence. Videos circulated anonymously, as they are now, are very difficult for us to use as evidence," says Detective Superintendent Peter Lansdown of the Criminal Investigation Department. "We have a man in custody and we desperately need witnesses, people who were in the Strand on Friday night/Saturday morning, to do the right thing and come forward."

middle of pouring concrete on a suspended floor slab. Needless to say, the measure couldn't have come into force at a worse time!" Polly confirmed.

That being said, the management team continued to work from home throughout the lockdown, refining the design, sourcing materials and tendering Mechanical, Electrical, Plumbing, Solar, and Geo-thermal contracts and also contributed to efforts by the Contractors' Association and a team of development stakeholders to advise the Government on procedures to be adopted for construction site management under Covid 19 suppression protocols.

The project was deemed essential to the economy by the Government on May 21st during the first wave of opening up of major development sites and was granted exemption from curfew movement restrictions. The site was prepared for remobilisation with a raft of Covid 19 prescriptions: signage, employee health

questionnaires, daily health checks, dedicated personal protective equipment, new wash stations, dedicated dining area and every employee attended Health City for Covid 19 screening.

"We are now working diligently to reschedule works and recover the time lost due to the lockdown and have been very successful in winning back lost time with a number of strategies," she confirmed.

This has not been an easy task, with material supply chains having been sporadically and unexpectedly disrupted, especially with Cayman's supply of cement being halted in August. Cement supplies ran out and the casting of concrete was suspended for a week.

"However, our team has responded excellently working to recover this lost time by working weekends and into the night," Polly stated.

Other issues with supply and pricing have also caused problems but the team has still managed to achieve the pricing they need and guaranty the on-time



delivery of the project. Polly confirmed that local providers had done an excellent job in keeping the site open.

As a result of all these strenuous efforts, the main building structure is back on schedule for completion in October 2020, with the roof currently under construction.

Windows and doors have been ordered to complete the building envelope in the coming months, framing of the residential apartments, commercial and retail units is on track for the first quarter of 2021 and completion following in the fall of 2021.

Crucially, Covid 19 has not diluted or diminished the ambitions of the stakeholders to deliver the project and the accompanying amenities to the Grand Harbour community. Nor has it dampened the enthusiasm of tenants for the development.

"All of the originally conceived amenities/shops and restaurants are on board, and several have been enhanced. The development will now feature four exciting food and beverage operations including a top-quality restaurant, café/bakery, vegan café and rooftop cocktail and tapas bar," Polly stated.

She added that they have seen heightened interest in purchasing property at

Harbour Walk post-Covid and advance leasing of commercial and retail space is also buoyant.

"We've sold three HW Residence units post-Covid and now have only four remaining from 62. The reality is that the recent crisis has reaffirmed peoples' understanding of the inherent value, resilience and stability of Cayman's real estate market. A common theme we have seen with many of our recent buyers is that they are looking to diversify their investment portfolio and they see innovative projects such as Harbour Walk as an ideal opportunity for income generation and appreciation," she said.

Cayman's overall strategy to beat Corona has paid off, she believed.

"We need to give credit to the success that the Government has had in controlling and preventing the spread of the virus, which has bolstered the value of Cayman's real estate, not only locally but internationally. In recent conversations with IRG - International Realty Group, the listing broker for Harbour Walk's residential and commercial units, the team have discussed the heightened levels of enquiries they have received from international buyers who are increasingly recognising Cayman as a safe haven," she said.



EYE ON THE STORMS

Just over a week ago Hurricane Laura swept by on its way to slam into Louisiana, Hurricane Marco fizzled out but soon thereafter, Tropical Storm Nana quickly developed this week.

All of these storms were in relatively close proximity to Cayman and all a reminder that we are now at the peak of what is a record-breaking hurricane season.

The 2020 season is already halfway through the list of allocated storm names available with weather experts saying that it's a confirmation that this year is meeting forecasts for a very active season.

The United States National Oceanographic and Atmospheric Administration (NOAA) now says the number of named storms could surpass the yearly

average of 12 storms with a possibility of between 19 and 25 storms developing.

Predictions of an "extremely active" season have increased from 60% to an 85% probability.

Thirteen named storms have already formed. Arthur, Bertha, Cristobal, Dolly, Edouard, Fay, Gonzalo, Hanna, Isaias, Josephine, Kyle, Laura and Nana).

Four became hurricanes. At the time of going to press, two more weather systems had rolled off the coast of West Africa into the Atlantic Ocean.

An average hurricane season produces around 12 named storms, 6 hurricanes and 3 major hurricanes.

Further compounding the situation are a disastrous pandemic and debilitating global economic uncertainty.

Mid-August to mid-September is considered the peak of the Atlantic hurricane season which means that we are now at the 'peak of the peak'.

Colorado State University hurricane researchers have cited very warm sea surface temperatures and very low wind shear in the tropical Atlantic as main factors for the increased storm activity this year.

They are expecting 12 to become hurricanes, five of which will reach major hurricane strength (Saffir/Simpson category 3-4-5) with sustained winds of 111 miles per hour or greater.

Locally, the Cayman Islands National Weather Service (CINWS) has said that the second half of the season tends to produce very powerful hurricanes some of which form in the western Caribbean

- where the Cayman Islands are located.

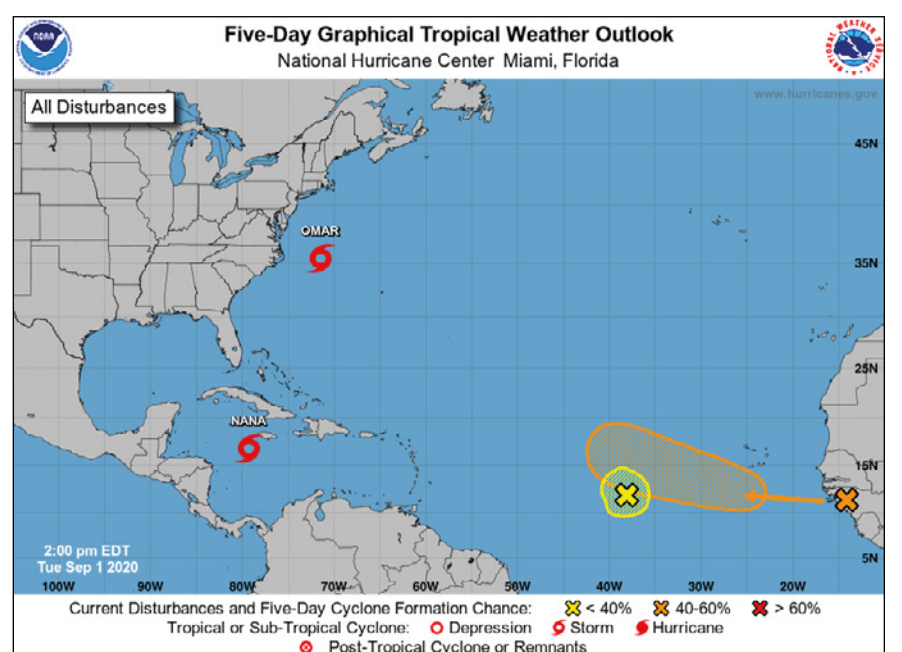
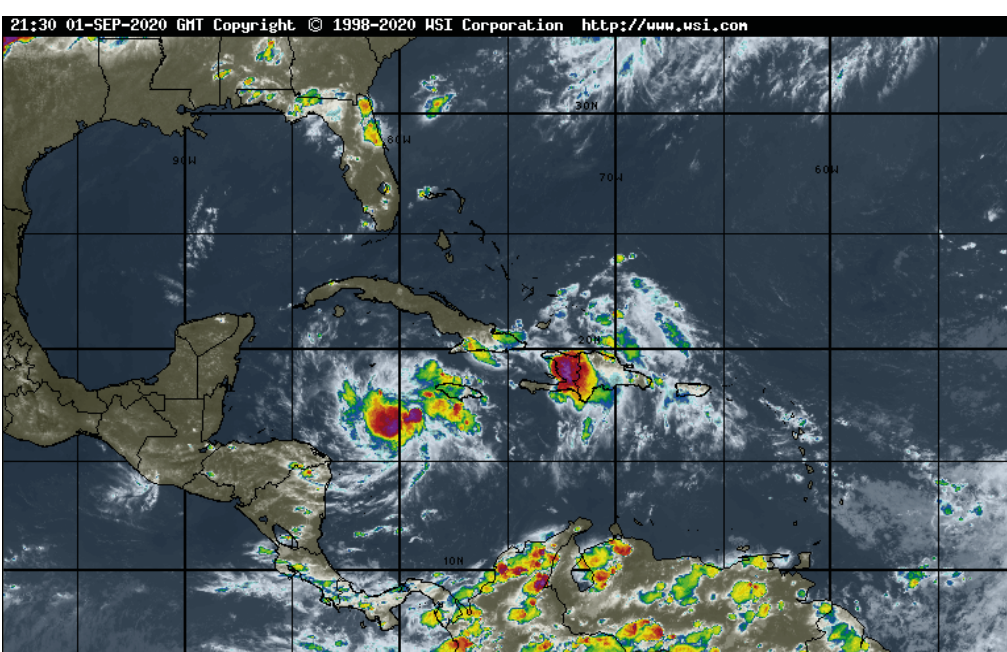
In a release earlier in the season, the CINWS had explained that there are three main challenges with these storms at the peak of the hurricane season and some late-season occurrences.

These are; short warning times, erratic paths, and the potential for rapid intensification.

The CINWS cautions that residents not aware of the late-season climatology of the region may get caught out preparing for a weak storm but which can rapidly develop into a major event.

"As a result residents should always be prepared for the impact of a major storm especially in the latter part of the season," the agency advises.

The hurricane started on June 1st and ends on November 30th.

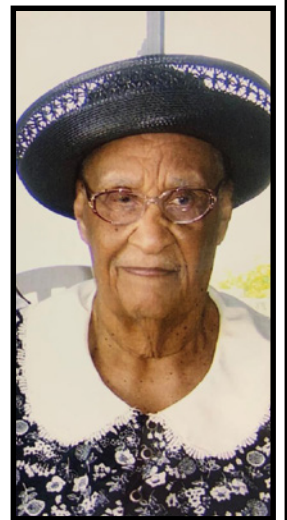

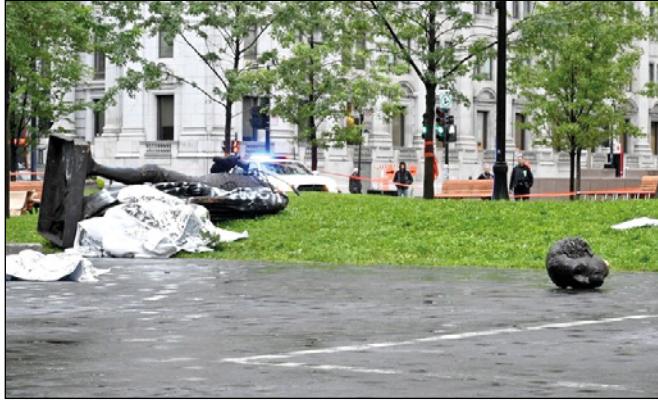

Trudeau condemns statue vandals

Prime Minister Justin Trudeau has condemned the toppling of a statue of Canada's first prime minister in Montreal by anti-racism activists, saying a focus on improving society today, and not historical wrongs, will best advance the fight for equality.

John A Macdonald was Canada's PM for 19 years between 1867 and 1890, and has been applauded by historians for nation building but also criticised for the forced assimilation of indigenous peoples, described in a 2015 commission's report as "cultural genocide".

His bronze likeness, erected in the downtown Montreal park in 1895, has often been targeted by vandals over the years, but on Saturday a group of hundreds protesting against racism and police brutality tore the statue off its pedestal and decapitated it.

Trudeau told a news conference he was "deeply disappointed by the vandalism" and said he recognised the frustrations of Canadians over the slow pace of addressing systemic

discrimination and racism in society, which his liberal administration has vowed to tackle.

He said: "But we are a country of laws. And we are a country that needs to respect those laws even as we seek to improve and change them, and that those kinds of acts of vandalism are not advancing the path towards greater justice and equality in this country."

The destruction of the monument provoked a flurry of angry reactions, including from the premier of Alberta, Jason Kenney, who offered a new home for it in the western province, as well as nods to the protestors from many who view it harshly as a reminder of Canada's colonialist past. 🌐

Shock as TV stations closed down

TV stations in the Philippines that were critical of President Rodrigo Duterte have not had their licences renewed which has caused immense controversy.

Anchor Dhubie de Guzman has been the face of a popular news show in the northern Philippines for more than a decade. Now the closure of his regional station – and dozens of others countrywide – has left him out of work.

He is among hundreds of journalists to lose their jobs at ABS-CBN as the broadcasting giant – a critic of Duterte – slashes its operations after advertising revenues were ravaged by the loss of its free-to-air licence in May. The closure of 53 regional television and radio stations that broadcast in six languages will deprive millions of Filipinos of their main source of local news and entertainment.

"It's painful," de Guzman, 43, said after presenting the final TV Patrol North Luzon in a studio 240km (150 miles) from the capital Manila. "You do your job responsibly, you do your share to change the life of ordinary people, then at the end of the day you lose your platform to do that."

Congress last month rejected ABS-CBN's application for a new 25-year franchise and a Supreme Court petition over the issue was dismissed.

ABS-CBN, which is owned by the wealthy Lopez family, has broadcast continuously since 1953 except between 1972 and 1986 when it was seized by dictator Ferdinand Marcos – who Duterte admires.

Duterte has a history of clashing with media outlets critical of his policies, including his controversial drug war that has killed thousands of people.

While he has denied any involvement in Congress's decision to reject ABS-CBN's application, he had previously pledged to block its licence renewal. 🌐

Venezuela to pardon political opponents

The Venezuela government has pardoned more than 50 opposition politicians, including 20 legislators who had been accused of conspiring against President Nicolas Maduro, as the country heads toward parliamentary elections scheduled for December.

The effort on Monday signals that the ruling Socialist Party is seeking to boost participation in the upcoming vote, which part of the opposition had vowed to boycott on the grounds that it is rigged.

Those pardoned via a presidential decree include legislator Freddy Guevara, who sought asylum in the Chilean diplomatic residence, as well as Roberto Marrero, who had served as chief of staff to opposition leader and congress chief Juan Guaido.

"We hope that these measures taken by the Bolivarian government help maintain the democratic focus of all of these political actors," Information Minister Jorge Rodriguez announced.

Many of those mentioned participated in a failed 2019 rebellion that sought to persuade members of the military to drop their backing for Maduro but ultimately

failed to sway top commanders. Some of those pardoned are imprisoned, while others have sought diplomatic asylum or are in exile.

Opposition leaders say Maduro's 2018 re-election was fraudulent, and have recognised Guaido as the legitimate president. More than 50 other countries, including the United States, followed suit.

"Maduro isn't president and I'm not a delinquent," wrote lawmaker Americo de Grazia, who was mentioned in the decree. "If you want to contribute to peace, give Venezuela a pardon from your usurpation of power."

The measure made no mention of Leopoldo Lopez, one of the opposition's most high-profile leaders, who was jailed in 2014 for leading protests against Maduro and is now living in the Spanish diplomatic residence. 🌐

Honduran prisons very dangerous

Prisons in Honduras have seen an alarming rise in killings in the past year.

Since November 2019, at least 55 killings have taken place inside Honduras' prison system, according to InSight Crime's count of murders by inmates reported in local media.

The most recent killings occurred on Aug. 6, when three suspected Barrio 18 gang members were found strangled in La Tolva prison, east of Tegucigalpa, Proceso Digital reported.

Digna Aguilar, a spokeswoman for the National Prison Institute (Instituto Nacional Penitenciario), told InSight Crime in a text message that the area of the prison where the crime occurred only houses "members of the same gang." For this reason, authorities say the massacre likely had to do with an internal conflict among Barrio 18 gang members.

La Tolva prison was also the scene of a riot in December 2019 that left five suspected MS13 gang members dead. Another 37 alleged gang members were also murdered that month during riots in El Provenir prison in the capital Tegucigalpa and Tela prison in northern Atlántida department.

The country's prisons currently hold more than twice the number of inmates they were designed for, and international organisations, such as the United Nations, have expressed

concerns about the violence in such facilities.

In 2017, InSight Crime confirmed in an in-depth investigation that Honduras' prisons had transformed into powerful incubators for organized crime groups. In a San Pedro Sula prison, for example, jailed MS13 and Barrio 18 gang members were able to continue their activities and use violence to exert control, all without interference from officials.

The government later closed the jail that same year. But the violence has persisted even in maximum-security prisons built specifically to curb gang control. 🌐

Cuba relies on dollar even more

Cuban government policy is relying even more on the US dollar back while the CUC takes a dive.

Cuba has three currencies circulating, but most Cubans receive salaries in only one, the regular peso CUP. The CUC was originally introduced in 2004 and is what most tourists use on the island.

Most stores selling in CUP or CUC have empty shelves as the government prefers to stock its new dollar stores. This benefits Cubans with family abroad and the government itself, whose military has a monopoly on retail sales.

The CUC, once on the par with the US Dollar, appears on its way out and people want to convert them to dollars. The dollar is now trading on the street for 1.50 CUC and in some cases even more.

If basic products were available in the Army's stores selling in CUC, the currency wouldn't be so unpopular.

But the reality is that the only stores well-stocked are those selling in US dollars on bank cards.

Economists believe that of the two Cuban currencies, the old peso, which exchanges at 25 to one CUC will survive. They also see the once despised dollar playing an ever-greater role in the government's survival economics.

With Cuba closed for months to tourists and Cubans living abroad, the flow of dollars into the country plummeted. With the surge of new Covid-19 cases, especially in the capital, dollars will soon be even scarcer. 🌐

Rashford continues UK food campaign

Footballer Marcus Rashford has formed a taskforce with some of the UK's biggest food brands to try to help reduce child food poverty.

The 22-year-old Manchester United forward successfully campaigned to extend free school meals this summer from the government after raising over £20 million (KY\$22.3m) from private sources to keep the campaign going. The U-turn enabled about 1.3m children in England to claim vouchers over the holidays, with the support working out as about £15 (\$17) a week for each child.

He has spoken about his own experiences of using a food voucher scheme as a child and was praised for pressing the government into a U-turn on the issue. He has written to MPs, outlining the help he feels some families still need.

The group of supermarkets, businesses and charities – including Aldi, Asda, Co-op, Deliveroo, FareShare, Food Foundation, Iceland, Kellogg's, Lidl, Sainsbury's, Tesco and Waitrose – have formed a taskforce and backed proposals from the National Food Strategy, an independent review of UK food policy.

Rashford said he was "confident" the group could help change lives "for the better". Speaking to BBC Breakfast, he said the move to extend free school meals over the summer had been a "short-term solution" to stopping children from going hungry, but it "wasn't going to work in the long run".

"We had to think about the best way to do it, to think about how these families can eat long term and not have any issues," he said.

Rashford is hoping that, with a bigger team of experts around him, he might be able to help more children. 🌐

Messi's move is a messy problem

The possible availability of Lionel Messi as a legitimate transfer target has shaken world football but his destiny seems to change daily.

Barcelona's 8-2 demolition by Bayern Munich in the Champions League quarter-final was surely the definitive end of Barcelona's dominance, which began in 2008 with the appointment of Pep Guardiola as manager and ended last weeks when the fated burofax was sent.

Messi is some prize, and every club of a certain size has probably sucked pencils and jabbed at calculators to try to work out if they could attract the great man to their club.

Manchester City are his obvious suitors. Pep Guardiola hasn't won a Champions League title without Messi in his team, Messi has won just one Champions League since Guardiola left Barcelona.

Both want to win at least one more Champions League and Guardiola manages a team who want to win their first Champions League. It's not the hardest equation in the world.

The thought of Kevin de Bruyne assisting Messi against, say, Brighton, West Brom or Aston Villa is an absolute delight.

But adding Messi to City doesn't really solve the issues that saw Liverpool finish so far ahead of them last season.

Guardiola's team scored 102 goals in the Premier League in 2019-20 but it was their defence that let them down on too many occasions.

For all of City's attacking brilliance they have only once had a player score at least 25 in a Premier League season (Sergio Aguero in 2014-15). Messi has scored 25-plus league goals in every single season since 2009-10.

City are ready to offer the 33-year-old Argentinian an incredible KY\$470million over five years if he leaves Barcelona, reports claims.

Speculation regarding his future intensified over the weekend after Messi snubbed coronavirus testing in Barcelona.

Messi has spoken to Guardiola and told him he believes he can win two Ballon d'Or titles at the Etihad.

Reports are that City would pay him a \$240m bonus after three years in Eng-

land, where he would then join sister club New York City.

The only snag for Messi to go anywhere - as Juventus, Chelsea and Paris Saint-Germain are all interested - had been hoping to leave the club on a free transfer this summer due to a clause in his contract, but La Liga have dismissed his claim, keeping his \$650m release clause intact.

Spanish media have stated that City are lining up an \$90m bid for Messi, while also offering Barca Bernardo Silva, Gabriel Jesus and Eric Garcia.

CPL has won new admirers

The Caribbean Premier League has been rewarded handsomely for staging the tournament when many other sports and leagues have been unable to because of the global pandemic.

The CPL in Trinidad has put itself in a superb position to take advantage; games are live-streamed on both YouTube and Facebook, as well as being carried on traditional broadcasters in the UK, Australia, India, South Africa and the United States.

They partnered with Sunset+Vine, one of the leading sports content production firms and splashed out on internationally recognised voices for the commentary in anticipation of increased interest. Games have even been moved forward to morning start times locally to reach primetime hours in India. The action has been as entertaining as ever although there is a lack of atmosphere in the empty arenas. Nevertheless, it has all paid off financially and prestige wise, attracting new admirers to sports hungry fans.

James even talked about the possibility of leaving the bubble on Friday night. They are reflecting the mood and attitude of many players who have been in the bubble for over 50 days.

Like many, James is struggling being away from friends and family and maintaining all his business and community projects. "I've had numerous nights and days thinking about leaving the bubble," the Los Angeles Lakers star admitted. "I think everyone has. I don't think there's one person that has not had a mind that said 'oh, I've got to get the hell out of here.' ... It probably crosses my mind once a day. For sure."

Kyle Lowry and Serge Ibaka revealed they almost left the bubble to use their platform to the fullest extent.

"We were close," Ibaka said. "We were very close. But as a group, we figured things out. We stayed here, and we're here for a reason, not only to play basketball but to use our platform to try and change things out there."

Lowry said players were ready to bounce out of Orlando if the NBA didn't agree to several commitments in support of their causes.

"I think we (the Raptors and other NBA players) were seriously considering leaving," Lowry said. "I think that would have been in serious consideration."

The NBA and the players' union agreed to resume playoff games Saturday after the two sides came to an agreement to enact commitments in the name of social justice and voting awareness.

The league essentially shut down earlier in the week after the Milwaukee Bucks refused to take the floor for their game against the Orlando Magic in wake of the shooting of Jacob Blake. The NBA followed up by postponing several other games throughout the week.

Crawford and Brook will be exciting

Boxing purists are excited by the prospect of one of the best matches of recent years.

Kell Brook has been offered \$1.4 million to challenge WBO welterweight Terence Crawford in November.

Unbeaten Crawford, 32, has been searching for an opponent having not fought since beating Egidijus Kavaliauskas last December.

Promoter Bob Arum was negotiating with 41-year-old legend Manny Pacquiao, but fears that will have to wait until fans can be allowed back into venues.

The 34-year-old Brit's rival Amir Khan last year snubbed a grudge match to instead face the welterweight champion in a \$4.5m payday which he lost in round five.

Crawford had been vocal about not fighting amid the coronavirus pandemic where fight purses have taken a hit following the loss of ticket sales.

But Brook's promoter Eddie Hearn confirmed talks are underway between himself and Top Rank to finalise the world title fight.

Former UFC light-heavyweight champ Jon "Bones" Jones has finally announced he is moving up to heavyweight. Jones believes he's a better choice than Francis Ngannou for champ Stipe Miocic's next opponent. And he's ready to welcome Brock Lesnar back to the UFC.

Two weeks after vacating the UFC light-heavy title, Jones has pitched a title shot for his first heavyweight fight, arguing he's a much more attractive opponent than Ngannou, who's been promised the next crack at Miocic.

Jones took to Twitter to lay out his case in a series of tweets. Six-foot four-inch Jones has recently been bulking up in preparation for his move up to heavyweight. He relinquished the belt after a dispute over pay with UFC President Dana White as he teased a potential fight with Ngannou.

The consensus No. 1 light heavyweight of all time was most recently seen in the cage fighting Dominick Reyes, whom he defeated via unanimous decision to notch the third defence of his third reign as champion.

Jones apparently picked up on recent news about former heavyweight champ Lesnar, who recently became a free agent after another stint with the WWE. Jones previously toyed with the

idea of a fight against the pro-wrestling champ.

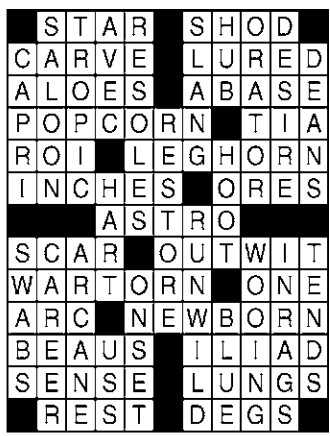
Ngannou recently took to Twitter to encourage Jones to join the big boys.

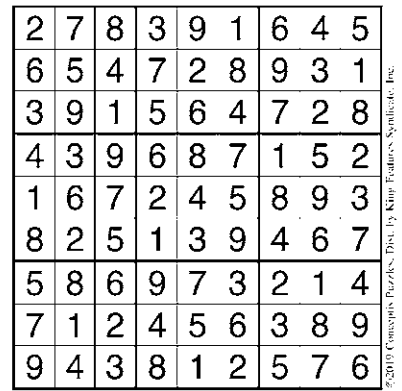

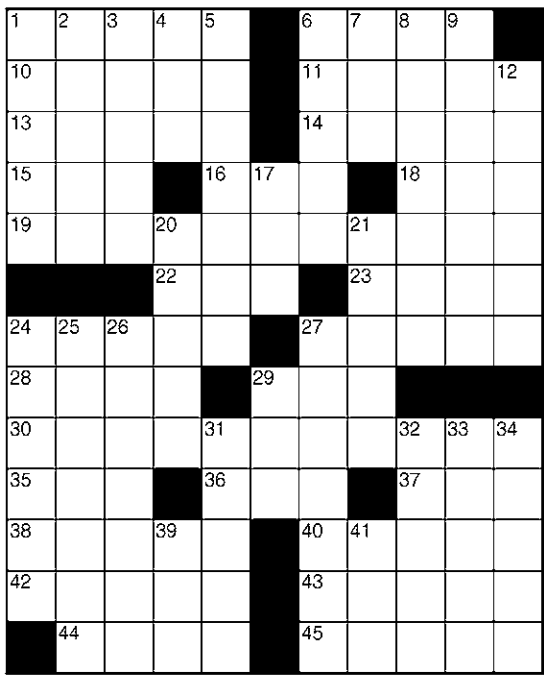

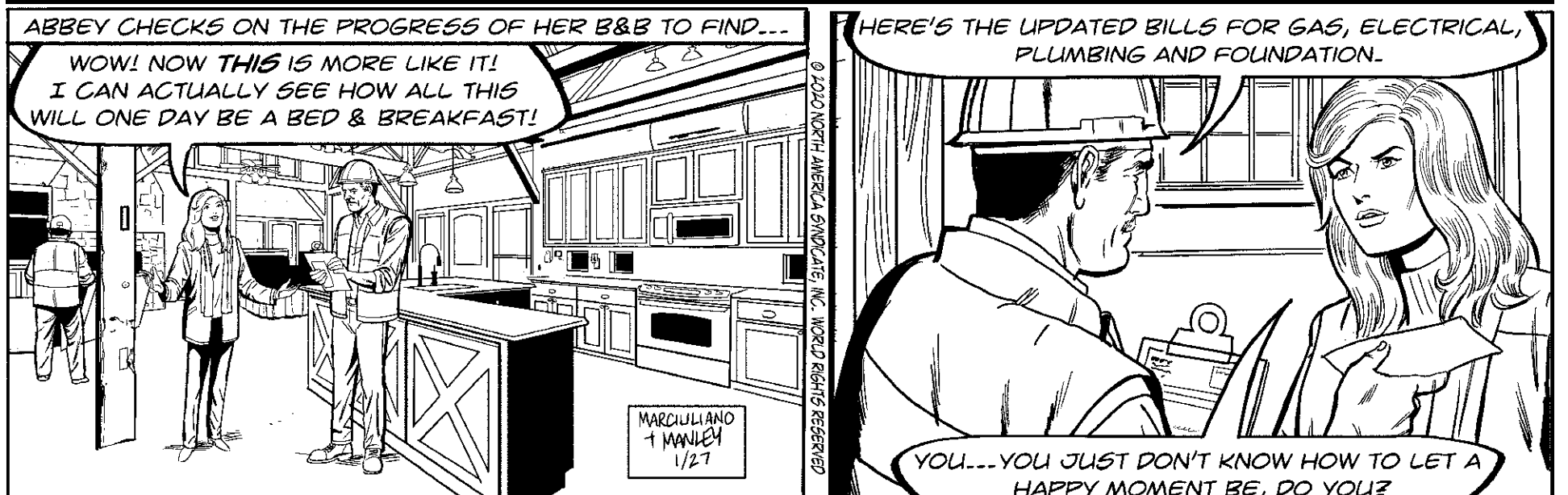
