## CAYMAN WEATHERS STORM ETA

Damage is being assessed and services restored after Cayman's second brush with storm Eta in a week.

The islands were inundated with heavy rainfall for several hours along with strong winds and rough seas as Tropical Storm Eta storm passed a little over 100 miles to the north-east on Saturday.

At the start of the week Eta had swept by the local area on its way to becoming a major hurricane slamming into Central America before heading back across the Caribbean Sea and again passing uncomfortably close to the Cayman Islands.


## Upgrades to airfields almost complete

Despite bad weather hampering efforts, work to complete the six sub projects that make up the Airfields Upgrades Project can finally see a light at the end of the tunnel, with completion not too far off.

A whole host of improvements have been undertaken since November 2019 by the Cayman Islands Airports Authority (CIAA) to the Owen Roberts International Airport (ORIA) on Grand Cayman and

the Charles Kirkconnell International Airport on Cayman Brac which are helping to improve service, operations and safety standards. The Airfields Upgrades Project is in addition to the redesign and expansion of the ORIA's terminal, which was completed in July 2019.

## THE HEALING OF AMERICA

When world leaders, including British Prime Minister Boris Johnson, started congratulating US President-elect Joe Biden, it was seen as a signal of the pressing need to rebalance the equilibrium in international relations which has gone out of kilter during the Trump administration.

While the official confirmation of the outcome is pending, the plaudits suggested a sigh of relief and global recognition that the Biden-Harris ticket had indeed won both the popular vote and the Electoral College.

On Saturday the state of Pennsylvania called the defining result of the Electoral College votes to give Mr Biden

## EDITORIAL

## Remembrance Day

Remembrance Day (sometimes known informally as **Poppy Day** owing to the tradition of the remembrance poppy) is a memorial day observed in Commonwealth member states since the end of the First World War to remember the members of their armed forces who have died in the line of duty. Following a tradition inaugurated by King George V in 1919, the day is also marked by war remembrances in many non-Commonwealth countries.

Remembrance Day is observed on 11 November in most countries to recall the end of hostilities of First World War on that date in 1918. Hostilities formally ended "at the 11th hour of the 11th day of the 11th month", in accordance with the armistice signed by representatives of Germany and the Entente between 5:12 and 5:20 that morning. ("At the 11th hour" refers to the passing of the 11th hour, or 11:00 am.) The First World War officially ended with the

signing of the Treaty of Versailles on 28 June 1919.

The tradition of Remembrance Day evolved out of Armistice Day. The initial Armistice Day was observed at Buckingham Palace, commencing with King George V hosting a "Banquet in Honour of the President of the French Republic" during the evening hours of 10 November 1919. The first official Armistice Day was subsequently held on the grounds of Buckingham Palace the following morning.

During the Second World War, many countries changed the name of the holiday. Member states of the Commonwealth of Nations adopted Remembrance Day, while the US chose Veterans Day.

In its wake it has left many streets flooded, downed power lines and trees, caused rough seas and disrupted many services.

A government statement on the situation on the Sister Islands said with the All Clear for Cayman Brac and Little Cayman no structural damage has been reported.

Some flooding was experienced on both islands and both are still experiencing gusty winds with bands of cloud passing through, and some light rain currently.

There were short power outages on both islands but all power has been restored.


Both the Aston Rutty Centre Shelter and the Noah's Ark Pet Shelter on Cayman Brac have now closed.

It said Deputy District Commissioner Mark Tibbets thanked emergency personnel and all residents who adhered to Government warnings and helped to keep the Cayman Brac and Little Cayman communities safe.

"Authorities on Cayman Brac and Little Cayman are still asking all persons to remain off the roads as much as possible. This is to facilitate the work of damage assessment, and debris removal where necessary," the statement said.

It also stated that in those areas of Grand Cayman where debris is still be-

ing cleared drivers are asked to exercise extreme caution.

Motorists are also advised to be mindful of road closures that are underway to facilitate clean-up efforts.

Members of the public are also asked to keep away from the coasts and shoreline as dangerous waves continue to affect the Cayman Islands. A marine warning was still in effect due to the likelihood of rough seas.

In a post on his Facebook page Hon. Premier Alden McLaughlin said he was "very happy to hear that the All Clear has now been given for the Sister Islands."

Giving a first-hand account of the storm's impact on Grand Cayman, he wrote: "I took a drive out once the all-clear had been given in Grand Cayman to have a look at some of the areas impacted by Tropical Storm Eta."

Mr McLaughlin reported that he saw "lots of flooding, some downed power lines, and trees uprooted."

In commending the emergency services, the Premier urged "everyone to continue to be safe, stay off the roads and away from the water."

Also in a social media post on the passage of the storm, HE, Governor Martyn Roper thanked the emergency responders "for a lot of hard work in challenging circumstances."



# Upgrades to airfields almost complete

CIAA CEO Albert Anderson said they were very pleased with the progress they had made to date given the complexity of the work, the amount of manpower the project had required, while at the same time keeping disruption to the airfield to a minimum.

Vital improvements have included the rehabilitation of the existing runway surface to increase its strength and durability, a runway extension, a new parallel taxiway, the filling of the ponds within the airfield perimeter, establishing an airfield perimeter road, and expanding the aircraft parking ramp in an easterly direction to provide additional aircraft parking.

Due to unanticipated increased aircraft activity at ORIA in the first two quarters of 2019, a decision was made to bring forward additional airfield improvements identified in the airport's Master Plan 2032 (the blueprint for future airport development) that were originally scheduled to start some time

in the future. These improvements, anticipated at costing around \$12.8 million, include increasing ramp space at the General Aviation Terminal to cope with demand for additional general aviation aircraft parking, a partial parallel taxiway from the east end of the runway to the apron to improve efficiencies of the runway for takeoff and landing, and an extension to the commercial apron to provide additional aircraft parking.

These additional improvements are set to bump up the overall cost of the airfields' improvements to a total of \$47.2 million. In order to raise funds to pay for the improvements, the CIAA went out to tender for a loan of \$12.4 million plus an overdraft facility of \$8.5 million to add to existing cash available to execute the Airfield Upgrades Project. The CIAA advised that it was currently negotiating the contract for this loan with a local bank and expects to finalise the transaction once Foreign and Commonwealth Office approval is received. In the meantime, Government is providing a bridging loan to the CIAA.

"We are currently within the \$45.7 million budget dedicated to the Airfield Upgrades Project and on track for completing the project scope by the end of 2020," said Mr. Anderson. "During these

unprecedented times, we are most grateful for the dedication and support of our partners, staff and traveling public as we strive to deliver a world-class airport experience from take-off to touch down." 

## Kids Encouraged to Run for Fun

The 2020 Milo Kids Fun Run takes place on Sunday, 6 December as part of the Intertrust Cayman Islands Marathon. One of the largest primary school running events on island, the fun run is also sponsored by the Ministry of Sports and is free for both public and private school students between the ages of five and 11 years old. The 2019 race brought out a little over 300 kids.

Organisers say that the event will be just as safe as always and they are hoping kids will enjoy the chance to participate in a year where so much has been cancelled for them. As usual, the kids will get to cross the main event's finish line, end their half-miler just like mom and dad, and then receive their medals and enjoy snacks courtesy of Milo.

"Parents and kids can feel confident that they will be safe at the Kids Fun Run as always. We will be well within the limits set by Public Health relating to gatherings, and as usual we stagger our starts slightly for the benefit of the younger runners which will allow for some social distancing," said Rhonda Kelly, Co-Race Director. "As the name implies, this event is always a fun one for both the kids and the adults. We look forward every year to seeing a sea of green t-shirts crossing the finish line, and this year we think it will be even more meaningful after a very challenging year for our youngest participants."

The Kids Fun Run was introduced in 2007 to inspire kids to begin thinking about health and fitness choices from an early stage. Participants cross the same line finish line as the adults after an approximate 0.7-mile run. The Kids Marathon log encourages children to keep a record of their activity leading up to the Kids Fun Run, completing a full marathon (26.2 miles) at the end of the run in December. The first 25.5 miles of the marathon can be done by running, walking, swimming and playing sports. Kids can have their parents, P.E. teachers or another adult sign their log verifying that they have completed each mile.


runner's bib, t-shirt and a Milo bag. The run begins at 10:30 a.m. at the front of the Government Administration Building on Elgin Avenue.

# Cayman Turtle Centre prepares to re-open to the public

Following the passage of Tropical Storm Eta and announcement of an "All Clear" from the Cayman Islands Government, staff at the Cayman Turtle Centre (CTC) will be preparing the park for re-opening to the public on Wednesday 11th November.

The Centre will be closed on Sunday 8th November while CTC's maintenance team continues their survey of the entire park and while work progresses to put systems and facilities back in place and reset to be ready for guests. The Centre will also remain closed on Monday 9th and Tuesday 10th November, in accordance with its regular opening hours.

"Safety is our top priority before, during and after any storm such as this," Mr. Tim Adam, CEO, said. "Those animals that were placed in temporary hurricane-proof housing will now be carefully returned to their normal homes."

"A site inspection will be completed to check everything for soundness and safety before we re-open to the public." Mr. Adam added.

"We look forward to opening Cayman Turtle Centre to the public again on Wednesday 11th November from 10:00 AM, once the restoration and resetting process is complete." ☀

# CLEVELAND CLINIC UNVEILS TOP 10 MEDICAL INNOVATIONS FOR 2021

*Top clinicians and researchers present transforming medical advancements and new award to recognize healthcare innovation*

An up-and-coming gene therapy for blood disorders. A new class of medications for cystic fibrosis. Increased access to telemedicine. These are some of the innovations that will enhance healing and change healthcare in the coming year, according to a distinguished panel of clinicians and researchers from Cleveland Clinic.

In conjunction with the 2020 Medical Innovation Summit, Cleveland Clinic announced the Top 10 Medical Innovations for 2021. Now in its 18th year, the annual Medical Innovation Summit is organized by Cleveland Clinic Innovations, the development and commercialization arm of Cleveland Clinic.

The list of breakthrough technologies was selected by a committee of Cleveland Clinic subject matter experts, led by Will Morris, M.D., executive medical director for Cleveland Clinic Innovations, and Akhil Saklecha, M.D., managing director of Cleveland Clinic Ventures.

Here, in order of anticipated importance, are the Top 10 Medical Innovations for 2021:

## 1. Gene Therapy for Hemoglobinopathies

Hemoglobinopathies are genetic disorders affecting the structure or production of the hemoglobin molecule – the red protein responsible for transporting oxygen in the blood. The most common hemoglobinopathies include sickle cell disease and thalassemia – which combined affect more than 330,000 children born worldwide every year and more than 100,000 patients with sickle cell disease in the United States alone. The latest research in hemoglobinopathies has brought an experimental gene therapy, giving those who have the disorder the potential ability to make functional hemoglobin molecules – reducing the presence of sickled blood cells or ineffective red blood cells in thalassemia to prevent associated complications.

## 2. Novel Drug for Primary-Progressive Multiple Sclerosis

In individuals with multiple sclerosis (MS), the immune system attacks the fatty protective myelin sheath that covers the nerve fibers – causing communication problems between the brain and the rest of the body that can result in permanent damage or deterioration and eventual death. Approximately 15 percent of people with MS experience a disease subset known as primary-progressive, characterized by gradual onset and steady progression of signs and symptoms. A new, FDA-approved therapeutic monoclonal antibody with a novel target is the first and only MS treatment for the primary-progressive population.

## 3. Smartphone-Connected Pacemaker Devices

Implantable devices like pacemakers and defibrillators deliver electrical im-

pulses to the heart muscle chambers to contract and pump blood to the body. They are used to prevent or correct arrhythmias – heartbeats that are uneven, too slow or too fast. Remote monitoring of these devices is an essential part of care. Traditionally, remote monitoring of this device takes place through a bedside console that transmits the pacemaker or defibrillator data to the physician. Though millions of patients have pacemakers and defibrillators, many lack a basic understanding of the device or how it functions and adherence to remote monitoring has been suboptimal. Bluetooth-enabled pacemaker devices can remedy these issues of disconnection between patients and their cardiac treatment. Used in conjunction with a mobile app, these connected devices allow patients greater insight into the health data from the pacemakers and transmit the health information to their physicians.

## 4. New Medication for Cystic Fibrosis

Today, more than 30,000 people in the United States are living with cystic fibrosis (CF) – a hereditary condition characterized by thick, sticky mucus that clogs airways and traps germs, leading to infections, inflammation and other complications. CF is caused by a defective cystic fibrosis transmembrane conductance regulator (CFTR) protein. A class of drugs called CFTR modulators correct the protein's action, but medications developed prior to last year had only been effective in a subset of people with certain mutations. A new combination drug, FDA approved in October 2019, provides relief for patients with the most common CF gene mutation (F508del) – estimated to represent 90 percent of individuals living with the disease.

## 5. Universal Hepatitis C Treatment

Classified as a "silent epidemic" by the CDC, hepatitis C has emerged as a major public health issue in the U.S. Infection with the hepatitis C virus can lead to serious, life-threatening health problems like liver failure, cirrhosis and liver cancer. With no vaccine for the virus, patients have been limited to medication, but many treatments were accompanied by adverse side effects or only effective for certain genotypes of the disease. A new, approved fixed-dose combination medication has vastly improved hepatitis C treatment. More than 90 percent effective for hepatitis C genotypes one through six, the therapy represents an effective option for a wider scope of patients.

## 6. Bubble CPAP for Increased Lung Function in Premature Babies

Underweight and frail, babies born prematurely often require specialized care – including ventilation for those

with infant respiratory distress syndrome (IRDS). For IRDS, infants are commonly administered surfactant during mechanical ventilation, a practice that can cause lasting lung injury in preterm infants and contribute to the development of chronic lung disease. Unlike mechanical ventilation, b-CPAP is a non-invasive ventilation strategy – delivering continuous positive airway pressure to newborns to maintain lung volumes during exhalation. The oscillating, rather than constant pressure, plays a role in its safety and efficacy, minimizing physical trauma and stimulating lung growth when administered over a prolonged period.

## 7. Increased Access to Telemedicine through Novel Practice and Policy Changes

COVID-19 saw increased adoption of telemedical practices as clinicians needed to conduct patient visits online. An increasingly virtual care model and increased consumer adoption came by way of fundamental shifts in policy at both the government and provider level. Since March, state and federal regulators have moved quickly to reduce barriers to telehealth, understanding that these new tools can speed access to care while protecting healthcare workers and community members. These measures opened the floodgates for telehealth, allowing for new programs and the expansion of existing networks.

## 8. Vacuum-Induced Uterine Tamponade Device for Postpartum Hemorrhage

Characterized as excessive bleeding after having a baby, postpartum hemorrhage is a devastating complication of childbirth, affecting from one to five percent of women who give birth. Mothers experiencing postpartum hemorrhage may require blood transfusions, drugs which may cause dangerous side effects, long uncomfortable procedures, and even emergency hysterectomy with loss of fertility. Non-surgical interventions directed at the site of bleeding has been limited to balloon devices that expand the uterus while compressing the site of bleeding. But the newest advancement is that of vacuum-induced uterine tamponade – a method that uses negative pressure created inside the uterus to collapse the bleeding cavity causing the muscle to close off the vessels. The vacuum-induced device represents another minimally invasive tool for clinicians as they treat the complication and provides a low-tech solution that is potentially translatable to developing countries with low resource availability.

## 9. PARP Inhibitors for Prostate Cancer

About one man in nine will be diagnosed with prostate cancer in his lifetime. While there has been progress in

the last decade, the disease remains the second-leading cause of cancer death among men in the U.S. PARP inhibitors – pharmacological inhibitors for cancer treatment – block proteins called PARP that help repair damaged tumor DNA in people with BRCA1 and BRCA2 gene mutations. Though known for their success in women's cancers, two PARP inhibitors have been demonstrated to delay the progression of prostate cancer in men with refractory cancer and DNA repair pathway mutations. Both were approved for prostate cancer in May 2020.

## 10. Immunologics for Migraine Prophylaxis

Migraines affect more than 38 million people in the U.S. – an estimated 12 percent of the adult population. For some time, multi-purpose drugs like blood pressure medications, antidepressants, anti-seizure drugs and Botox injections have been used to prevent attacks. However, not developed specifically for migraines, these methods have been met with mixed results. In 2018, new medications were developed to help head off migraine pain. The class of drugs works by blocking the activity of a molecule called calcitonin gene-related peptide (CGRP), which spikes during a migraine. Actively prescribed in 2020, this new FDA-approved class of medication is the first to be specifically designed for the preventive treatment of migraine, marking a new era of migraine therapeutics.

At next year's Medical Innovation Summit, in addition to the annual Top 10 list, Cleveland Clinic will present a new award in honor of its rich history of innovation and advancements in healthcare delivery. The inaugural prize will be awarded to a team, organization or individual who has made a significant contribution to healthcare delivery with a focus on one or more defined areas. Details will be released in early 2021.

# BIKESHARE SYSTEM PROVIDED FOR CIVIL SERVANTS

The Ministry of Commerce, Planning and Infrastructure has partnered with Cycle Cayman to provide five bicycles for use by civil servants as part of a free 3 month trial BikeShare programme, which will run November 1 to January 31.

The BikeShare programme forms part of Energy Cayman, the Ministry's twelve month campaign to embed energy efficiency into the Cayman community.

The five bicycles will be available at the Government Administration Building staff entrance for civil servants to utilise during the initial trial. Six docks will be provided to accommodate an additional bicycle which may be ridden from one of the other Cycle Cayman locations.

Civil servants can sign up on the Cycle Cayman app using their government email address to unlock the bikes and will also be able to use any of the bikes

provided by Cycle Cayman around the island.

Minister of Commerce, Planning and Infrastructure, Hon. Joseph Hew said, "Following the success of 'Car Free Day' in 2019, which included the use Cycle Cayman bicycles, we decided to make their bikes available for a longer period of time to encourage alternative transportation, particularly amongst civil servants.

"The National Energy Policy (NEP) encourages the use of non-fossil burning vehicles as an alternative mode of transportation. One of the strategies of the NEP is to encourage encouraging cycling as an alternative mode of transportation by creating bike friendly amenities where practical and to assess the public's inclination to use them," he said.

Energy Policy Coordinator Kristen Augustine stated, "We applaud Cycle Cayman for taking the innovative step of creating an automated BikeShare sys-

tem in Cayman and we look forward to our partnership with them by providing bikes at the Government Administration Building. We believe the BikeShare system will provide convenient, easy access for those who can use a bike for a quick trip within George Town for a meeting or to run an errand.

"We are working with the George Town Manager to determine additional locations to place bikes in George Town. We also want to encourage other businesses to consider providing free access to the Cycle Cayman BikeShare system for their staff," she said.

The Ministry will be launching a George Town Shuttle 'Park and Ride' project in the near future which will work in conjunction with the BikeShare system as people will be able to take a bus to George Town and have bikes available for short trips during the day.

Cycle Cayman is an automated BikeShare system with locations at Camana

Bay, at the Regatta Business Park and by the George Town Craft Market. Bikes can be taken from docks at any of its five solar powered stations and returned to any other of its stations in the system. Members of the public can also use the bikes by signing up and creating a paid account via the Cycle Cayman app.

The Ministry's Energy Cayman initiative is to promote energy efficiency and conservation methods to residents and businesses in the Cayman Islands, while encouraging a sustainable lifestyle through responsible and innovative energy supply and consumption. It has been launched to meet the goals in the Government's National Energy Policy which includes 70% of electricity generation from renewable sources by 2037.

It is our office's pleasure to report the outcome of these discussions and developments with travellers scheduled to travel between the UK and Cayman tomorrow and the weeks ahead. And we wish to thank the FCDO for their responsiveness and close communication with our office, as usual."

# Legal Services Bill, 2020 Out for Public Consult

The Cabinet has approved the Legal Services Bill, 2020 (the "Bill") which has been submitted to the Legislative Assembly to be dealt with at the next meeting subject to the Bill having a 28-day public consultation period.

The Bill was gazetted Tuesday, 27 October 2020 in Legislation Gazette No. 79 of 2020 and can be accessed at <http://gazettes.gov.ky/portal/pls/portal/docs/1/13022505.PDF>.

The Bill is aimed at modernising how the legal profession in the Cayman Islands is regulated.

The practice of law in the Cayman Islands is currently regulated by the Legal Practitioners Law (2015 Revision) that was first enacted in 1969, over half a century ago.

Although there have been numerous amendments over the years to the Legal Practitioners Law (2015 Revision) to reflect the evolution of the practice of law in and from the Cayman Islands, the fact is that the current framework is inadequate to regulate the contemporary nature of 21st century legal profession operating in the Cayman Islands with a significant international component.

The number of attorneys and the nature of law practice in the Cayman Islands have changed significantly over the decades to the point of rendering the current Legal Practitioners Law almost obsolete, hence the need for a new Law.

In order to assist the general public to better understand the provisions of the Bill, an Executive Summary explaining each clause of the Bill has been published as supplement 1 of Extraordinary Gazette No 89, today Wednesday, 28 October 2020 which can be accessed at <http://gazettes.gov.ky/portal/pls/portal/docs/1/13022519.PDF>.

the clear majority of the 270 votes needed to cross the line...and into the White House.

He was also expected to add further electoral College Votes giving him an even wider margin over 'sitting president' Donald Trump.

But with the incumbent still refusing to accept the outcome as it stands, a flood of legal challenges claiming voter fraud and administrative flaws will be the next hurdle to clear.

A defiant Mr Trump has resorted to block-letter tweets proclaiming his victory and claiming that the election was "stolen" from him without so far presenting any substantial evidence to back up his allegations.

Mr Trump himself had also claimed victory even before highly reputable media and other agencies started reporting that Democrat Mr Biden his vice-presidential running mate Kamala Harris had secured more than enough of the votes to take control of the White House.

Mr Trump's team have stated that he doesn't intend to concede which opens another.

It adds another sordid chapter to the already sour tone of the 2020 US Presidential election.

But, while Mr Trump and his team were wallowing in the disbelief of their defeat, incoming president Mr Biden and vice-president-elect, Kamala Harris, were preaching a message of national healing and unity in a victory rally in his hometown of Wilmington, Delaware.

In stark contrast to the tension, vitriol and animosity which has marked - and marred - the campaign, the rally streamed live to millions across the United States and globally, reflected a festive tone of visible relief in cities and states across the country - and further afield - that this chapter might now be over.

In a plea and personal commitment to lead the nation in its healing, president-elect Biden declared: "I pledge to be a president who seeks not to divide, but to unify; who doesn't see red states and blue states, only sees the United States."

"It's time to put away the harsh rhetoric, lower the temperature, see each other again, listen to each other again. To make progress, we have to stop treating our opponents as enemies."

Mr Biden also reminded: "The work ahead of us will be hard, but I promise you this: I will be a President for all Americans — whether you voted for me or not.

"I will keep the faith that you have placed in me."

Vice-president-elect Kamala Harris told the cheering crowd that, "When our very democracy was on the ballot in this election, the very soul of America at stake and with the whole world watching, you ushered in a new day for America."

"You chose hope and unity, decency, science and yes, truth - you chose Joe Biden as the next president of the United States. And the road ahead will not be easy but America is ready, and so are Joe and I," she affirmed.

By all accounts, this has been one of the most tumultuous and divisive election campaigns in recent US history with high and low political drama waged in the midst of an ongoing deadly COVID-19 pandemic.

But it will also be remembered for making history in a positive manner by breaking new ground and setting new records.

Coming out of this election, America gets its first female vice-president who is also the first person of colour in that office. Vice-president-elect Kamala Harris, is of Jamaican and Indian heritage.

Mr Biden who is 77 years old will be 78 before he is sworn-in as expected in January making him the oldest person

to assume the presidency. His birthday is November 20th.

There are other records in the voter turnout although the final tally is yet to be announced.

Mr Biden has to date secured over 74 million votes, a record for a US presidential candidate, breaking that previously held by former president Barack Obama, with whom Mr Biden served two terms as vice-president.

The incumbent - and outgoing - President Trump has topped the historical Republican presidential vote count with around 70 million votes, although four million less than his 2020 challenger.

According to some preliminary estimates, 239 million people were eligible to vote this year, of which nearly 160 million cast their ballots.

The overall turnout was 66.9 per cent, the highest since 1900 which saw a 73.7 per cent voter turnout.

In a late development, a White House official, speaking on condition of anonymity, said Donald Trump 'will accept the result of a free and fair election'.

How that was to be interpreted was still not clear as a clearly bitter Mr Trump was still insisting that the Democrats were trying to "steal the election" and has not to date withdrawn threats to challenge the outcome in court. 

## Government Schools Re-Open on Tuesday, 10 November 2020. Savannah Primary School Scheduled to Re-open on Monday 16 November 2020

The Minister for Education, Youth, Sports, Agriculture and Lands (MEYSAL), the Honourable Julianne O'Connor-Connolly, advises that following the effects of Tropical Storm Eta, all Government Schools will re-open on Tuesday, 10 November 2020, with the exception of the Savannah Primary School which will re-open on a later date of Monday, 16 November 2020.

A post-storm assessment conducted by the Department of Education Services' (DES) Facilities Unit and Government School Leaders revealed that several schools were impacted, primarily, by leaks and damage to vegetation and fencing. The work required to

address the minor damage will not impact teaching and learning.

The Savannah Primary School was significantly impacted by downed electricity and telephone pole lines, damage to several areas of the roof, air conditioning units, fencing and the canteen area. As a result, the Savannah Primary School will remain closed to allow for the necessary repairs to be undertaken and is scheduled to re-open on Monday, 16 November 2020. During the school closure, students and teachers will switch to remote learning. School staff will communicate with students and parents in this regard.




