Cayman's traffic seems to be a perennial problem; the growing population and

growing economy means more and more cars and trucks and busses on the roads, and that means more congestion, sometimes even nightmare two-hour holdups

Cold Front brings rough seas to Cayman this week

The National Weather Service have advised that strong north to northeast winds and rough seas will affect Grand Cayman from late Sunday as a cold front becomes stationary over the Cayman area and its associated high-pressure system builds over the southeast US.

Radar images show scattered showers northwest of the Cayman area moving towards the southeast.

Partly cloudy skies with cloudy spells and a 30% chance of showers are expected Monday through Thursday with winds from the Northeast at 20 to 25 knots with higher gusts.

The sea state is forecasted to be Rough with wave heights of 6 to 10 feet and a Marine Warning remains in effect though Thursday


The temperature will range for 78F in the day to 73F at night bring cool Christmas like weather to the Cayman Islands.

Sports women encourage more female participation

In celebration of International Women's Day, which took place on Monday 8th March, a gathering of some of Cayman's finest female athletes assembled at the South Sound Squash Club where each spoke about their path to the top of their field.

Club Manager Marlene West said the event, called Women in Sports, also gave women and in particular, young women, the chance to play squash and other games while at the same time encourage great socialising, shopping and take in the powerful messages and experiences the panelist had to share.

"This event is to celebrate all things women but with a focus on sport," she advised. "We encouraged women and girls and also men in support to attend and each had the chance to try the sport of squash, browse the shopping items on offer or simply have a nice social. Some of our top female squash players were on court teaching the basics, playing some fun games and generally having a good time on court."

Ms West said that it was particularly important to showcase the game of squash to young women as she said most young players who were working their way up through the game in Cayman were boys.

Internationally successful sports women held a Q&A with those in attendance, including Olympic swimmer

Lara Butler, England women Rugby Union team member Mercedes Foy, Track & Field Olympian and Commonwealth Games gold medalist Cydonnie Mothersill, martial arts and World Body Building Federation winner Carla Yee Sing, Island Games Basketball gold medalist Dionne O'Garro, Marlene West, Cayman's top female squash player who has won many medals for her country, 2nd VP Cayman Islands Netball Association Katherine Gow, and CrossFit's Wanda Brenton, who has represented Cayman internationally in Volleyball and Crossfit. The event was moderated by Meita Day, Sports Coordinator for Women at the CIG Department of Sports, who is an accomplished sports woman and Cayman's first ever medalist at the CAC Games in Taekwondo.

"Our panelists shared issues they had faced, such as how they kept motivated after an injury, their most challenging experience whilst competing, their training schedule, and what it was like for them playing sports at that level being a woman," Ms West said. "Sports on the island is growing – there is an endless amount of activities and scholarships in sports for young people now. It is important that young people realise what options they have and the life values they can learn by playing a sport at a highly competitive level."

In particular, she hoped more young women would be encouraged to get involved in sports.

Grand Cayman Chosen for Multi-Film Production Project

Filming Begins Next Week

Beginning next week and over the next few months, a series of feature films will be filmed in Grand Cayman. Circumstances around the world with the global Covid-19 pandemic have hindered film producers for the past year. The Cayman Islands attracted the attention of William Santor and the team at Productivity Media as a locale where film production could take place in a safe and sophisticated environment.

During the past few months, Santor worked extensively with the Cayman Islands Government's Ministry of International Trade, Investment, Aviation and Maritime Affairs, the Film Commission, Workforce Opportunities & Residency Cayman (WORC), and Customs & Border Control to arrange and facilitate a multi-film production deal between Productivity Media and Darius Films. A fourth film will be produced between Productivity Media and Balcony 9.

The cast and crew have complied with Government's stringent and mandatory quarantine and testing measures that have stopped community transmission of Sars-CoV-2, the virus that causes Covid-19, in the three Cayman Islands. While here, they will be building local capacity and expertise by hiring local Caymanians, to train and develop their skills with practical hands-on experience.



Welcoming the producers, cast and crew, MITIAMA Chief Officer Eric Bush stated: "I am delighted that the Cayman Islands has become a true contender in the highly competitive arena of global film production. This multi-film project will contribute immensely to Cayman's growing film industry."

Bush continued, "The producers' choice of the Cayman Islands for these films showcase its world class sophistication, which combines global talent, modern infrastructure, amazing natural assets and true uniqueness of this British Overseas Territory."

Santor echoed that sentiment: "We are delighted to announce this first-ever multi-picture collaboration with the Government of the Cayman Islands. Their vision to develop and foster a robust film industry is very exciting, while offering a safe and secure place for production in these unprecedented times. We will shoot four feature films in the Cayman Islands - three with our partners at Darius Films and a fourth film planned with Balcony 9. We're excited to get started with our first film, Blue Iguana, next week."



get better, for a while at least. But lots of road widening, extending (arterial roads growing from two to three lanes either way, and bigger, three-lane roundabouts in many places) as well as entire new connector-roads, that have been several years in the planning, land-purchasing, and preparation stages, paint the picture of an evolving comprehensive transport strategy. It isn't all just about accommodating new cars though, and the new picture includes what the NRA is calling 'Compete Streets Methodology,' meaning that the plan incorporates safe sidewalks for pedestrians, new crossings, cycle-lanes as well as a big outside-the-box rethink involving electric vehicles and shuttle busses for crowded town centres.

More than CI\$30 million has been budgeted for the new improvements, according to Infrastructure Minister, Hon Joey Hew,

and members of the media were invited to see the improvements in a big two-coach outing, with ministers including Infrastructure Minister Hon Joey Hew, Premier Hon. Alden McLaughlin, and Finance Minister Hon Roy McTaggart, along with top NRA officials.

The first stop was the site of the long-awaited extension to the Rex Crighton Boulevard (formerly the East West Arterial), the first phase of which will reach to the subdivision known as Woodlands. Currently the highway, which was begun in 2007, finishes abruptly at Hirst Road, But the plan has always been to make a road that takes the traffic not only from the Lookout Gardens area of Bodden Town (the aim of Phase Two) but ultimately all the way through to Frank Sound, enabling motorists to drive from the heart of the Eastern Districts all the way to

George Town without having to go onto the over-congested Shamrock Road. However, the National Conservation Council has raised hydrological concerns which have delayed progress, Minister Hew said. "We have been working with the National Conservation Council and we are very optimistic that we will be able to work with them, and continue the road into the Lookout Gardens area of Bodden Town. This is a matter of national importance for us, it's extremely critical, as it involves relieving some of the stress to persons in the East End district," he added, "but at the same time we want to be as environmentally sensitive as possible. However we can't delay this for years," he said. Minister Hew believes that the Conservation Council's concerns over the flow of water are able to be mitigated with the deployment of culverts and channels for the flow of water.

When the new road, which at this stage consists of clearance, levelling-out, and installation of drainage, utilities and compacting the base and sub-base and clearing less than a two-mile, 130 foot wide stretch reaches Woodlands, there will be two main roads, branching off from a roundabout, one heading south into Shamrock Road to Breadfruit Drive, and the other heading north into all the development of Newlands. The NRA will develop a new roundabout at Hirst Road as well as an intersection at Shamrock Road which will allow motorists from the east to easily access the highway as well as commuters from the Newlands area to have an easy and efficient travel. "Right now its two lanes, one heading east and one heading west, but we do have space for expansion.

Public and Private Sector Joint Initiative Established for Tourism Reopening Strategy

The tourism industry in the Cayman Islands has been among the sectors hardest hit by the COVID-19 pandemic due to the closure of borders. However, the Cayman Islands Ministry of Tourism (MOT) and Department of Tourism (CIDOT) have initiated a strategic development collaboration with tourism partners across all tourism sub-sectors to outline a joint initiative to prepare and activate the industry to reopen.

"Our dynamic tourism industry has been a pillar of the economy for the Cayman Islands since the 1960s—a source of pride for the country but also a significant area of Caymanian employment opportunities and a springboard for entrepreneurship for many Caymanian families. Prior to the pandemic, we were on a steady streak of ever-increasing success with year-over-year record breaking arrival statistics for both cruise and stayover tourism, which came to a halt in March 2020 as our government implemented the measures necessary to keep our country safe," shared Hon. Deputy Premier and Minister of Tourism, Hon. Moses Kirkconnell. "It is our ultimate goal to continue government's approach of putting the safety of our people first when the country reopens so this collaboration with our public and private tourism stakeholders will play a major role in accomplishing our future success story."

To maximize the success of the initiative, six meetings are being facilitated by



Ms. Tara Tvedt, strategic planner from the Cayman-based company SquarePeg Ltd. These action planning sessions have established an understanding of the ultimate goals of all stakeholders involved and identified a consensus and core agreement to ultimately develop a detailed tourism operational opening strategy.

President of the Cayman Islands Tourism Association and General Manager of The Ritz Carlton, Grand Cayman Mr. Marc Langevin, one of the 24 participants in this strategic development project, shared

"As we are getting closer to meeting the conditional vaccination level threshold set by the Government to reopen our destination to visitors, we are appreciative to be invited by the Ministry of Tourism to work collaboratively in defining the many complex tasks associated to the reopening to Tourism. I am impressed by the level of engagement, commitment and expertise provided by the various Governmental agencies, and various organizations representative in attendance and look forward to start a new era of collaboration

between private sectors and Government beyond the short-term reopening process, to rebuild and improve our Tourism successes."

Ensuring diverse representation in this working group was a key component in creating the participant list. The 24-person group represents all areas of the public and private sectors that are critical contributors to a successful tourism reopening strategy.

But the real focus now is to be able to take it all the way from here, all the way out to the Lookout Gardens," Minister Hew said.

Grand Harbour Connector Road.

The next stop was at the end of the clearing which will soon be the Grand Harbour Connector Road, which takes traffic off from the CUC roundabout at the Kings Sports Centre roundabout up into Grand Harbour, where there are so many new homes being built. "Part of the problem is the CUC roundabout doesn't have the capacity, because that is where everything is coming into, so we have to expand that, especially with the three lanes coming down from the east," explained the NRA's

Tristan Hydes. "The intention is really to link all the way through, and take it all the way across Red Bay and up to Admiral's Landing. Then the shamrock road will become a 'real highway,' so to speak, for people coming from the east. So this new connector can be the local road, for buses to drop of nannies in the area. Right now they are talking about building an overpass for pedestrians only over the 6 lane highway over there, out by Grand Harbour roundabout, and that is very expensive. So this road will have sidewalks, it will have bike lanes so pedestrians can actually use this all the way up. Its much safer," he said.

Samuel Jackson shares his vision in Red Bay

Samuel "Sammy," Jackson made his first appearance as candidate for Red Bay in the elections. He was joined onstage by MC for the evening, Theresa Pitcairn who told the audience of more than 100 that Mr. Jackson would "Share his vision," with them, and "Give them an opportunity to vote for him in April." Ms Pitcairn went on to describe Mr. Jackson: "Sammy is an exemplar of courage, who looks fear in the eye and calls it out," she said. Mr. Jackson was also joined by Johann Moxam and Chris Saunders, MP for Bodden Town West. Mr. Saunders said he had known "Sammy," for a long time, describing him as, "A great advocate and defender of the Caymanian people...I am going to ask you to listen to him and give him a chance."

Mr. Moxam described a "core group of independents working together," as he proceeded to demolish the idea that you can only make any impact if you belong to an established political party: "Nobody will have a majority," he said, "We understand the next government will be a coalition."

Mr. Jackson is a Lawyer by profession, with more than ten years working in the civil service, before working for a law firm. "I specialize in land real estate development and planning law ...my experience in this area has provided me with a particular expertise which I believe would be very useful if I became a parliamentarian,"

he said. "I have also over the past two and a half decades assisted in many legislative drafting initiatives, and I am eager to put those skills I have developed to work for the people of Red Bay and the wider Cayman community," he said.

"I Intend to be able to better represent you the constituents of Red Bay if you choose to let me," It is the first time Mr. Jackson has run for election, and he will be running against Premier Alden McLaughlin in Red Bay, although he comes from outside the constituency: "You might ask, 'How can someone who does not know this constituency well be helpful or useful to that community?' Well I have represented folks from all over this country over many years of (legal) practice so I know how that works. I simply have to spend the time, and go house to house and meet and greet as many people as I can," he explained.

"I believe the constituency of Red Bay deserves a Member of Parliament who

engages with the community beyond the election season; somebody who cares about the future of the district and the island as a whole. That is certainly what I intend to do. My approach will be to simply maintain an open line of communication with all of my constituents. I want to know what your views are; I need to know what your concerns are so I can inform my role as a parliamentarian on your behalf."

"It is my view that the people of Red Bay and the people of this country deserve better: To not be dismissed, not be sidelined or disenfranchised, and not be treated with disrespect, to not have your intelligence insulted and to not be treated like beggars," he said. You deserve to hold a parliamentary representative accountable for his or her actions, and inactions," he said. "You deserve to not be forgotten about while your representative bends over backwards to accommodate special interest groups, and foreign investors who

are readily provided with concessions and other special political favors, whilst you and your neighbors concerns are ignored and the future of people are compromised".

"We need to address the failures in our education system. "Our schools are failing our children and this is a recipe for disaster. We have children graduating from high school who do not have the education they need, like basic literacy skills, in order to make a living in the real world. We need to urgently find out why. We also need to create a legislative framework for recognition and support of technical and vocational trade schools. We need to ensure that when our kids graduate from such schools that they have the proper certification, and that they can compete in the marketplace, and that they are able to compete in a fair marketplace, and not with predatory pricing because of unqualified persons making themselves out to be qualified."

MP ALVA SUCKOO NOMINATED FOR RE-ELECTION IN NEWLANDS

Running again as an Independent candidate

Member of Parliament for Newlands Alva Suckoo was officially nominated on Monday, 1 March as an Independent candidate for re-election in the Cayman Islands General Elections slated for 14 April 2021.

He was nominated by his daughter Janelle Suckoo and Aliyah Christian, daughter of his reelection campaign committee member Richard Christian.

Following his nomination, MP Suckoo said, "I was honoured and humbled today to accept the official nomination as an Independent candidate in the 2021 General Election on April 14. I will be seeking re-election to my third term in office, after representing the people of Newlands for the past 4 years."

MP Suckoo was first elected to represent the single member constituency of Newlands in 2017, which marked the first elections in the Cayman Islands run under the "One Man, One Vote" system. He was first elected in 2013 to serve as a Member of the Legislative Assembly representing the former multiple member district of Bodden Town.

MP Suckoo has garnered the support of many of his constituency's younger voters, and his nominators reflected this demographic.

He said, "I was proud to be nominated by my daughter Janelle Suckoo and Aliyah Christian, daughter of my re-election campaign committee member Richard Chris-

tian. The young women who served as my nominators are representatives of the next generation of Caymanian leaders, and I am heartened by the support I've gained from young adults and new voters over the past four years, as well as the ongoing and stalwart support of my constituents of all ages."

Nominator Aliyah Christian gave her reasons for supporting MP Suckoo. She said, "For me I support Al, I think the top reason that stands out for me is that I saw politicians as kind of like unapproachable celebrities, but for him he is a very good listener, and someone who is open to supporting the youth, someone with a strong moral ground, which I feel is fading nowadays. And I think those are what stand out for me."

Her father, Richard Christian, described his experience with MP Suckoo and the impression made over the past eight years.

He said, "In 2013, I actually didn't vote for Al. COLOURS CARIBBEAN RESISTS REVIEW OF CIVIL PARTNERSHIP LAW

The regional rights organisation Colours Caribbean, though its local arm Colors Cayman, reports that it has "has taken steps to join as an interested party" in the judicial review brought by Kattina Anglin against the Governor.

Anglin, of the Christian Association for Civics (CAC), is challenging Governor Martyn Roper's recourse to Section 81 of the constitution to bypass parliament and unilaterally enact the Civil Partnership law.

Colours Caribbean which has engaged McGrath Tonner as local counsel and Travers Smith as London counsel says they are prepared to go as far as seeking to have the hearing adjourned if their demands are not met.

The organisation also says: "We've also asked the Governor directly at a meeting held in January that the Attorney General's Chambers be removed from representing the Governor in this matter, given the clear conflict of interest following the Attorney General's Chambers having historically fighting tooth and nail against equal rights for the LGBTQIA+ of the Cayman Islands."



Colours Caribbean says it has also requested that the Attorney General's Chambers is replaced by a Queen's Counsel from London to handle the matter given its "seriousness and the constitutional and conventional implication".

"We understand that Tom Hickman QC of Blackstone Chambers has been instructed to represent the Governor," it says.

Meanwhile, the organisation which champions LGBTQ+ rights, says it also wants the presiding judge, Justice Williams,

removed from the hearing on the basis that his "impartiality remains compromised".

Colours Caribbean says it remains unconvinced by correspondence it received from Attorney General Samuel Bulgin.

It is questioning what it alleges is "the secrecy" surrounding the decision of the Grand Court last November to agree to the judicial review, which only became public two months later.

"The Attorney General has indicated that the Chief Justice is undertaking an independent review by the engagement of an independent Queen's Counsel on this matter," it says.

However, Colours Caribbean insists that irrespective of this independent review, which it says it welcomes Justice William's impartiality remains compromised and that issue still needs to be addressed.

"Colours Caribbean respectfully requests that the Chief Justice, in light of the independent review he is undertaking, would also request, in the interest of justice, that Justice Williams step down from hearing this case pending the review," the statement concludes.

Caribbean Tree Planting Project protects Indigenous Trees

As part of the Caribbean Tree Planting Project, our members joined with Protect Our Future students from a variety of schools to remove more than 85 indigenous trees from a plot of land that is being primed for development in Westbay.

They teamed up with members of the National Trust, including Environmental Coordinator Cathy Childs to identify key trees and remove them with care so that these species can be preserved and propagated on other properties. The students would like to see more developers reach out to local farmers and community members prior to simply bulldozing their land. The students believe that a more sustainable model for clearing Cayman land should be enacted and enforced. Several of the students including the Cayman Ambassadors of the Project, Yasmin Elise, Marleigh Smith and Matt Gilmour coordinated the event in the hopes to educate other youth



and to also obtain donated trees that can be planted at local schools, churches, and businesses.

Projects such as these can help make Cayman more sustainable and also help mitigate climate change. Every time a piece

of land is cleared, we lose important species that are part of our heritage and culture. By protecting our trees, we protect our future.



COVID vaccination campaign opens for all of Stage 3



(25.5% of the estimated population) have received at least one dose of the Pfizer-BioNTech vaccine, while 8,805 have completed the two-dose course. "The Cayman Islands has been in an incredibly fortunate position to have been able to vaccinate its population so early on in the global campaign against Covid-19 disease."

Vaccination campaign changes and highlights:

- COVID-19 vaccine will be available to all ordinary and legal residents over the age of 16 (Stage 3) starting tomorrow Friday 5th March (starting with Surname A). Please see schedule for assigned Surname day.

- Vaccination Clinic Hours at ORIA - Monday - Friday 9am-12pm & 1:30-4pm; Saturday 9am-12pm & 1:30-3pm.

- For Dose 1, please fill out the consent form before arrival <https://www.hsa.ky/wp-content/uploads/2021/02/COVID-19-Vaccine-Consent-Form-2020-2021-FINAL-Feb.pdf>

- Everyone must present photo identification to receive the vaccine and demonstrate they are ordinarily and legally resident e.g. with initial permission to remain in the Islands for at least six months.

- Persons may come at **ANY** of the published clinic times for the following:

- Stage 1, Group A, B & C
- Stage 2, Group A, B & C
- Receiving Dose 2

- Persons who have received their first dose are reminded to get their second dose 21 days later or no longer than 12 weeks after the first dose.

- When receiving your 2nd dose, you **MUST** also bring along your vaccination card reflecting your 1st dose.

The Public Health Department announces the COVID-19 vaccine will now be available to all persons over the age of 16 starting Friday 5th March 2021. Persons will be vaccination in alphabetical order, starting with Surname A. The latest published COVID-19 vaccination schedule is available at <https://hsa.ky/public-health/coronavirus/>

The COVID-19 vaccination programme continues to administer Dose 2 vaccinations in conjunction with the latest rollout.

Governor Martyn Roper has confirmed that the UK will be sending a further 19,890 doses on the British Airways flight arriving on 11 March. Plans are also in place for another consignment to arrive from the UK towards the end of the month.

"Based on our current vaccine supply and the doses arriving in March, the Cayman Islands is now able to make this vaccine available to everyone over 16 years of age. Supply of vaccines remains a challenge globally, but the UK's continued support has enabled us to further open our vaccination programme. I encourage those that have not yet received their first vaccine to come forward to ensure we continue the work to keep Cayman safe."

Dr John Lee, Chief Medical Officer confirmed that Public Health has administered 25,408 vaccines and, of that, 16,603

- Doctors' notes and employer letters are no longer required for Stage 2.

- Vaccination cards are NOT to be laminated.

- Persons 60 years and older will be given priority.

- Facemasks are required.

"We are still urging all persons over 60 years old to come forward to receive the vaccine," said Dr Samuel Williams-Rodriguez, Medical Officer of Health. "Statistics show the older you are, the more likely

you are to have complications if you contract COVID-19. Therefore, it is even more important that persons in this age group get fully vaccination to protect themselves and those around them."

Dr Williams-Rodriguez confirmed that common side effects from getting the vaccine includes redness or soreness at the injection site, muscle aches, fever, headache, chills and tiredness. "Side effects from the vaccine are proving to be minor compared to the symptoms you could have if you are sick with COVID-19. The benefits of getting the vaccine far outweigh the risk of contracting the virus."

"Persons are urged to come at various times during the opening hours to help avoid long queues," said Dr Williams-Rodriguez. "The line moves quickly and one inside the airport you can expect the process to take 15-20 minutes, as we require everyone to rest at least 15 minutes after receiving the vaccination."

Individuals receiving their second dose are reminded that the date noted on the vaccination card for the second dose is the **earliest date** in which you can receive the vaccine. If you received your first dose at a District Health Centre you can receive your second dose at the airport.

If you are home bound and unable to attend one of the vaccination clinics, please contact the Flu Hotline 1-800-534-8600 or 925-6327 or your local HSA District Health Centre and arrangements will be made to with a Public Health nurse to provide your vaccine in the comfort of your home.

The public is reminded to **adhere to the published schedule** and plan to get the vaccine throughout the day, to limit congestion at the vaccination clinic.

POLICE NEWS

Four Men Charged for Drug Importation Offenses, 6 March

Just after 9 AM on Wednesday 3 March, officers from the Air Operations Unit were carrying out border protection patrols off the coast when they came across a vessel, approaching Grand Cayman. As the police helicopter approached the vessel, it changed course and increased its speed. The helicopter continued to monitor the vessel and observed the occupants throwing what appeared to be packages from the vessel into the water.

Assistance was sought from the Cayman Islands Coast Guard and the vessel was later located. Four men ages 28, 37, 40 and 59, all Jamaican Nationals, were arrested on suspicion of Being Concerned with the Importation of Ganja and other drug-related offences. They were taken to shore and into custody where COVID-19 protocols were followed and all tested negative. They were held in custody pending further investigation.



The discarded packages were located and collected as evidence. The contents were confirmed to be ganja and carried a weight of approximately 400lbs.

All four men have since been formally charged with Possession of Ganja knowing or having reasonable grounds to suspect that the drug is intended to be imported into the Cayman Islands and Being Concerned In the Importation of Ganja, both in accordance with the Misuse of Drugs Law (2017 Revision). The men will appear in court on Monday 8 March at 10 AM.

Serious Two-Vehicle Collision in Prospect

Just before 4:15 PM on Saturday 6 March, police and other emergency services were dispatched to a report of a two-vehicle collision involving a dump truck and a pickup truck.

The driver of the pickup was trapped in the vehicle and officers from the Cayman Islands Fire Service attended the scene and extricated the man, who was immediately transported to the Cayman Islands Hospital by EMS.

The driver of the dump truck was also taken to the Cayman Islands Hospital by a private vehicle.

One of the drivers is believed to have life-threatening injuries.

WHEN HARRY AND MEGHAN MET OPRAH

It's the media-event that's unbelievably rivalling coverage of a globally rampaging deadly pandemic.

And like the pandemic, Oprah Winfrey's interview with Prince Harry, and Meghan Markle, the Duke and Duchess of Sussex, will continue to reverberate for years to come. (They have still retained those titles but are no longer referred to as HRH (His/Her Royal Highness) after relocating to the US).

Oprah Winfrey's riveting, clinical and probing questioning of the couple - individually and together - was as much about the proverbial 'malice in the palace' as it was about a cultural disconnect and misplaced expectations.

BATTLE ROYAL

Explosive, jaw-dropping allegations of racism, being trapped in 'the system', and

suicidal thoughts make for a revealing, and for some an uncomfortable two-hour viewing.

Meghan Markle claimed that her then-unborn son's skin colour was raised by someone within the royal household - whom she declined to name - over his status in the royal household.

Her interview largely revolved around the question of whether she was 'silent' or was 'silenced' throughout what she came across as the ordeal of her time in the royal household.

For her husband, Prince Harry, born into British royalty, navigating the rigid formalities of royal life seems to have become more of an obstacle course after he met and married Meghan.

He expressed the view that his father and brother are trapped in what he described as 'the system', although recently Prince Harry was keen to make the distinction that he was only 'stepping back not stepping away' from the monarchy.



The disclosure that the couple actually had two marriage ceremonies came as a shock to many and adds to the divide of opinions in the aftermath of the Oprah Winfrey interview.

A dismal cloud of deja vu hangs over the current situation with the abiding memory of the high-profile life, divorce from Prince Charles - Harry's father - and tragic death of Prince Harry's iconic mother Princess Diana hovering in the background.

The Crown, or 'the firm' as Meghan Markle refers to it, echoing a phrase coined by Princess Diana during her own stormy relationship with the monarchy, is no stranger to scandals and accusations of double standards.

It's also not the first time that an American has been at the centre of a maelstrom that has shaken the institution to its core.

In 1936 King Edward VIII abdicated to marry the American socialite Wallis Simpson in echoes of Harry and Meghan's 'defection' 85 years later.

PALACE PUSHBACK

But a tell-all interview with its reality TV overtones is rife with consequences and the risk of leaving reputations tarnished in its wake.

It was the second time that the couple have given an interview with suggestions that something was seriously amiss in their relationship with the monarchy.

The pushback from the palace has already started. A formal response was expected to the Oprah interview which aired in America on Sunday night and was scheduled for the UK a day later.

Just days before, there were reports of 'a retaliation strategy' and threats of 'reprisals' from the palace.

Further, a curiously-timed accusation that surfaced just days before the Oprah interview claiming that Meghan Markle bullied her staff, portends what's likely to emanate from the palace in its wake.

And although not directly attributed to the palace, there was a suggestion that the interview should have been postponed as Harry's grandfather, Prince Philip, Duke of Edinburgh, is presently hospitalised with a heart ailment.

This casts the Oprah interview under a pall of a toxic, internecine war of attrition with each revelation and reaction.

THE MEDIA IN THE MIDDLE OF THE MUDDLE

The relationship with, especially the British press, was said by the couple as a defining factor in their decision to leave the UK, although they have had to face criticism about being calculating in their dealings with the media.

Against that background, two hours with Oprah Winfrey seems like therapy by comparison.

It's already breaking viewing records... and that's just in America the world's largest and richest media market.

The American network CBS is said to have paid a licensing fee of around US\$8 million to Oprah Winfrey's company Harpo Productions to air the special but that Harry and Meghan did not get paid for their appearance.

The couple is meanwhile developing their own media portfolio with reports that they already have lucrative contracts with Netflix and Spotify in the bag.

Separately, now playing on Netflix is the hugely popular award-winning fictionalised series, *The Crown* depicting life in the British monarchy.

Art imitates life and life imitates art.



CARIBBEAN BRIEFS

Barbados quick to give vaccines

Barbados is one of the Caribbean's leading covid vaccine distributors thanks to the donation of 100,000 doses of the Oxford-AstraZeneca vaccine from India. The Barbados population is 280,000.

It sparked a major vaccination effort in Barbados that resulted in approximately 12.5 percent of the population receiving their first shots in the past two weeks.

Frontline workers, including those in the tourism sector, were among those who received the first wave of vaccines.

In a televised nationwide address, Prime Minister Mia Mottley called it "a commendable start for a country that really did not have a lot in place for vaccination programme."

The vaccine rollout marked the fourth step in Barbados' COVID-19 management plan that hinges on contact tracing, public health protocols and Operation Seek

and Save. In the Seek and Save program, public health officials visit communities to try and locate individuals who could unknowingly be infected and offer them early healthcare measures.

The vaccines now are available to those over 18, and the government has signalled its intent to obtain more doses so that all residents could be vaccinated by the end of April or early May.

Guyana starts spending oil income

Guyana's national assembly passed the largest budget in its history in anticipation of its potential huge oil revenues at some G\$383 billion (KY\$1.50bn) last Thursday.

The budget was themed as, "A Path to Recovery, Economic Dynamism and Resilience," and was passed four days ahead of schedule despite the main opposition coalition walking out on discussions.

It includes funds to make improvements to infrastructure, education, health and provides direct benefits to citizens, Finance Minister Ashni Singh said after the budget was passed.

"There are investments contained there for roads, schools, medical centres, and so on, all intended to not only deliver services and quality of life, but gen-

erate economic activity, create jobs and increase income," Singh said.

The opposition were expected to make a legal challenge against changes made to the Fiscal Management and Accountability Act (FMAA) heard last Friday. Government officials suggested this is why the opposition parties walked out.


Currie is new Maroons leader

Jamaican Maroons have a new leader in Richard Currie who has promised to update the island's proud and historic community.

The Maroons descend from Africans who escaped from slavery in Jamaica and established free communities in the mountainous interior, primarily in the eastern parishes. Escaped Africans who were enslaved during Spanish rule over Jamaica (1493-1656) were the first to develop such refugee communities.

Currie, 43, was elected the new colonel of the Accompong

Maroons in St Elizabeth last month. He is the youngest person to become colonel. Currie polled 681 votes for victory over his closest rival, the incumbent Ferron Williams who amassed 400 votes. Currie led a campaign that focused mainly on bringing change to the Accompong Maroons, including infrastructure development and economic independence. He said: "I affirm I will represent Maroons with honour who are both home and abroad on the international stage amongst the family of nations."

Dominica invests CBI funds wisely

Dominica has commissioned two new health centres that will cost almost US\$2 million through funding by the Citizenship by Investment (CBI) Programme. Twelve health centres are to be constructed. These projects herald in a new era for the Nature Isle.

Healthcare has been high on the government

agenda recently. Dominica opens its state-of-the-art Marigot Hospital this week. The hospital, also funded by the CBI Programme, has a 75-bed capacity with high-quality services, including emergency care and a trauma centre.

Dominica recently revealed that construction on its first geothermal plant will be finished in 2022. The government is constructing over 5,000 weath-

er-resistant homes for its citizens, aligning with efforts to become the world's first climate-resilient nation, of which 25 percent have already been completed.

Ian Douglas, an MP for the Portsmouth constituency said: "From houses to hotels to health and wellness centres, road and bridges, sea and river defences, this country is being transformed one community at a time."

St Lucia honours Butch Stewart

St Lucia has added the late Gordon "Butch" Stewart as a posthumous recipient of the country's third highest honour, the St Lucia Cross, despite the entrepreneur being Jamaican.

The award celebrates the late Sandals Resorts International founder and chairman for his superlative imprint on the island's economy through three thriving resorts. He died in Miami on Jan. 4.

The announcement was made when the eastern Caribbean nation marked its 42nd anniversary of Independence on Feb. 22 and was officially presented on Sunday at a virtual ceremony in Castries, the St Lucian capital where Stewart first opened his Sandals Regency La Toc Golf Resort and Spa 28 years ago.

Since then the Jamaican hotel mogul added the Sandals Halycon Beach Resort
