# Governor urges booster take up to beat Omicron

Now that health officials have confirmed that the more easily transmissible Omicron variant of Covid-19 has been detected in Cayman, Governor Martyn Roper is urging everyone who is eligible to get a booster shot as soon as possible. Scientific evidence suggests that the booster shot is providing a good level of protection against people suffering severely with the virus.

People who are over 18 who had their second vaccine shot more than three months ago are all eligible for a booster and can get their booster at clinics around the island. See the following for the vaccine and booster clinic schedule: [www.hsa.ky/public-health/coronavirus](http://www.hsa.ky/public-health/coronavirus)

Governor Roper said that as 80% of the population had now received two vaccine doses, it put Cayman residents in a very strong position in protecting themselves against serious illness or worse from Covid-19. But that was not enough.

"Unfortunately, two doses of the vaccine alone does not give enough protection against catching Omicron. Studies are

showing that by far the best defence we have against Omicron is for those eligible to get the booster shot. Boosters increase immunity significantly and give you the best protection against serious illness, hospitalisation and catching the virus," the Governor said.

Governor Roper said if people had not had their booster shot, now was the time to come forward.

"My thanks to those who have already had their booster, please encourage your friends, family and colleagues to do the same. Boosters are literally life-saving and it is urgent that our booster take-up increases significantly," he confirmed. "I know many are concerned about getting sick following the injection. Some have reported mild symptoms such a sore arm or flu-like symptoms for one or two days after the vaccine has been administered. But please don't make that the reason you don't come forward for your booster."

The Governor said people needed to get protected now, before Christmas and before Omicron cases started to rise.

"Omicron is expected to become the dominant variant soon in many countries of the world and results of studies are showing that it spreads faster than other variants," he said.

A further batch of vaccines was arriving from the UK last week, for use as first, second and booster shots. The UK would continue to supply the Cayman Islands with

vaccines for as long as Cayman made use of the doses.

"Every adult across all three of our islands has to do their bit to protect themselves, our elderly, our children who are unable to get vaccinated and our community as a whole. I appeal to the community to inject more urgency into the booster roll-out," he said.

# PREMIER MOVES TO CONTAIN SUSPECTED OMICRON SPIKE

A sudden alarming spike in the number of suspected COVID Omicron cases over the weekend prompted an immediate response from Hon. Premier Wayne Panton urging residents to avoid large gatherings.

In an urgent statement on Saturday, December 18th, Premier Panton relayed that the Public Health Department had reported that a further 23 potential cases of the Omicron variant had been identified.

Of those likely cases, seven are in persons with no travel history which he said suggested local community transmission of the Omicron variant.

That news followed Friday's announcement which by then confirmed that a total of four cases of the Omicron variant, with a suspected 10.

This startling surge to a possible 27 cases in just a matter of days plus the likelihood of possible community transmission of the Omicron variant, has also led the Chief Medical Officer to issue an Emergency Order to cancel a large event planned for Saturday evening.

Reinforcing that order, Premier Panton stated:

"In light of this rapidly evolving situation, I want to appeal to members of the community to carefully consider your attendance at any large gathering and to adhere to all safety protocols. The Omicron variant is extremely contagious and we must do all we can to slow the spread."

He further advised that in keeping with global concerns about the increased transmissibility of the Omicron variant, Medical Officer of Health Dr Samuel Williams Rodriguez urges Caymanians, residents and visitors to strictly practice COVID-19 prevention measures, including handwashing, mask-wearing and social distancing throughout the Holiday Season.

Dr Williams said: "These simple guidelines, combined with the full vaccination course and booster, offer the best chance of protecting ourselves and those we love."

In a rapid response to the surging spread of the highly infectious Omicron variant, many countries have resorted to even more stringent measures to control the spread.

National lockdowns, travel restrictions, curbing public gatherings, vaccination passports and negative lateral flow tests are now being more rigorously applied already by some countries.

Some of these measures have met with protests with some people objecting to being vaccinated and having their freedom of movement curtailed.

In Cayman, which has just reopened its borders and relaxed some travel restrictions, it is known that in some circles there are suggestions to reintroduce testing on arrival for visitors and returning residents.

While the government has relaxed some travel restrictions to kickstart the tourism industry, the global explosion of the Omicron variant has forced it to enact a series of targeted regulations as a precaution.

These include additional quarantine requirements, having a PCR test in addition to the lateral flow (LFT), limited attendance to indoor and outdoor events to 100 and 250 respectively, a midnight curfew on bars and nightclubs until December 30th, and strict testing protocols to visit healthcare, homecare and prison facilities.

In his weekend address, Mr Panton made a direct appeal to appeal to residents and visitors.

"While it is the festive season and everyone is eager to enjoy socialising with family and friends, I want to appeal to all members of our community to carefully consider your attendance at any large gathering, that to be vigilant in adhering to all safety protocols."

## New regs to curtail Omicron spread

Government has introduced new Covid-19 regulations that affect travellers to Cayman and the hospitality industry and which, they hope, will protect Cayman's most vulnerable groups from getting this more highly transmissible variant of Covid. The new Omicron variant has already been detected in Cayman in one traveller from the US and is suspected in ten others. The new regulations took effect last Friday 17 December, and include notable changes to testing protocols, public gathering limits and bar/nightclub operating hours.

### Travel

The additional quarantine requirement for travelers from restricted countries from the previously issued regulations has been lifted in light of the current rate

of Omicron transmission globally. The new regulations also update the terms "departure" or "departure of the person's flight to the Islands" to allow travellers that have obtained a direct airside transit visa 24 hours in between their connecting flights to enter the Cayman Islands. Travellers who have direct airside transit visas are not allowed to leave the airport.

### Positive LFT testing

Public Health now requires persons who receive a positive lateral flow test (LFT) result for Covid-19 to also be tested via PCR. People who test positive, whether via a self-reported LFT or a Certified LFT, must take a PCR test at the next available opportunity. Testing for these persons takes place daily from 1-2pm at the South Sound Community Centre.



The public is reminded that it is mandatory to report a positive LFT result and to follow Public Health's guidance on isolation. Anyone who fails to report their positive LFTs are guilty of an offence and liable upon conviction to a fine.

Households of persons who have tested positive for the Omicron variant must isolate for a minimum of 14 days regardless of their vaccination status.

### Public meetings/gatherings

Large events of more than 250 people made possible by partitioned venues will no longer be permitted. Events must be limited to 100 people for indoor venues and 250 people for outdoor venues. There is no longer an exemption to exceed the public gathering limit if event organisers require attendees to utilise approved tests.

In addition, closing hours at bars and nightclubs will be reduced to midnight until 30 December, starting Friday, 17 December.

### Visitation to healthcare, residential home care and detention facilities

Anyone visiting a patient in a healthcare, home care or prison setting must either provide proof of a negative approved test, taken on the day of visit or administer an approved test at the facility before being granted admission.

# TOURISM OUTLOOK BLEAK IF SOME TRAVEL RESTRICTIONS REMAIN

The next few months are going to be 'make or break' for Cayman's peak tourism season - and the wider economy - if visitor arrivals continue to flatten.

The sobering conclusion was given by president of the Cayman Islands Tourism Association (CITA), Mark Langevin, in an assessment of the first month's business since the borders were re-opened on November 20th.

Appearing on last week's edition of the Caymanian Times programme, The Panel, Mr Langevin's assessment of the current situation is "crawling back instead of bouncing back".

Although interest among regular visitors and potential travellers remains high for the destination, one of the drawbacks is the inability of unvaccinated children to travel with their parents.

The government has said that it is reviewing this regulation.

"Right now, with the current regulation that does not allow the families to come back, it's clearly a problem and we have cancellation after cancellation," Mr Langevin stated.

Another area of concern is the current limited airlift into Cayman especially with American Airlines delaying their return until around February.

While other major carriers have begun returning and the national carrier Cayman Airways continues to add to its schedule, the CITA president says this remains a major hurdle as visitor passenger traffic is low.

"We looked at the composition of what is coming in and out and we are going to carry potentially much less than 10 per cent of all our load capacity for arrivals right until February when American Airlines comes back. And then eventually that might project us to 20/25 per cent of capacity we had before, and then later on we

will have 40 per cent in March if nobody gives up on us," he analysed.

"So that is going to also have a limitation on why we are only crawling back out of the situation we have."

Another point of concern revolves around who is travelling.

According to Mr Langevin, residential travel far outstrips visit arrivals at present.

"I went to a trade show last week in Europe. I came back and I pretty much knew everybody on the plane. What did that tell you? That plane coming back from Miami was occupied mostly by locals doing business potentially like me or whatever they were doing. But clearly indicates that there were not too many tourists on that plane. So we have a lower capacity."

Despite the slow pick-up in tourism as Cayman enters the peak season, Mr Langevin, who is also the general manager of the Ritz Carlton which has just reopened, says the focus is on the future.

Hotels and others in the industry have been looking forward to an increase in tourist business, especially into next year's US President's Day holiday and Springbreak.

But according to CITA president Langevin, whereas a month ago they were forecasting a gradual increase growing from 10 per cent and peaking at around a probable 60 per cent, that outlook may now have to be drastically revised downward.

"Unfortunately a month later, instead of growing we have decreased...We have lost what we had on the books because people realise that they cannot travel with their children."

He says one of the setbacks might be in the messaging and marketing of the destination as Cayman navigates its way out of the current COVID-19 restrictions.

"Instead of growing and sending a message that the destination is opening, there's the confusion," he stated, explaining that "the hardship(difficulty) is that when we communicate to our travellers what is required to come to Grand Cayman, it is actually reducing our ability to attract more people."

Mr Langevin disclosed that during a recent promotional trip to Europe he spent more time addressing questions about

Cayman's travel restrictions than actually promoting his hotel and the destination, a development which he felt was "unfortunate".

He summed it up this way: "Right now we have a major crisis that is not being addressed...Every day we are losing ground."

With bookings up to three months in advance, the CITA head and Ritz Carlton boss is sceptical about the outlook for the season.

"Because our business is booked for 60 days to 90 days in advance and right now we are so far behind that, I don't even know how we can catch up. And if we absolutely lose the opportunity especially President's Week and Spring break, I am going to tell you that for all the tourism industry we're not going to rebound."

In that scenario, the CIA president expressed a concern that tourism workers will be hit the hardest if the outlook continues to be bleak.

"The stipend workers are going to be staying stipends workers for the year because right now hotels are operating with what we have. But we need to bring back people to work and we need guests, so it's one of those vicious circles," he noted.

Mr Langevin's might however be alleviated as the Cayman Island Government (CIG) announced in the past few days that it is reviewing the policy of denying entry to unvaccinated children, one of the main

obstacles seen by the tourism industry to kickstarting the sector and saving the peak travel season.

# Ritz-Carlton reopens after C\$50 million renovations

After a break due to the COVID-19 pandemic and the slowdown in business, the Ritz-Carlton hotel officially re-opened on December 15, marking an anniversary exactly 16 years after first opening its doors here in Cayman.

Management of the 5-Star hotel used the Covid shutdown to extensively renovate and upgrade the already world-class facility to the tune of C\$50 million.

With funding from its operators, the Dart Group, the hotel's lounge, lobby and beach-bar and other parts of the operation underwent an extensive overhaul in preparation for its next phase of welcoming guests.

Referring to the difficult Covid no-travel period, Mr Langevin said, "While hotel owners across the globe decided to use their reserve funds to cover their loss, compromising their long-term investment, recovering ability, and even sacrificing guest-experience in the process, Dart showed its confidence in the strength of the Ritz Carlton brand, and the resilience of the Cayman Islands to come out of this period stronger than ever before."

He said it is certain this renovation will allow the iconic resort to stay the leader in the Cayman market and the region.

Hon. Minister of Tourism, Kenneth Bryan remarked that the reopening of the Ritz-Carlton has come at a perfect time.

She also observed that "the rooms have been refurbished with a Classic Cayman theme too, and all along the corridors are splendid carpets fringed by a Silver thatch palm motif. What more can you ask for?"

## CIPS Releases Three Stellar Stamp Issues

The Cayman Islands Postal Service will close out the year 2021 with an impressive issue of special new stamps that should gladden the hearts of dedicated philatelists as well as the general public.

The issue brings together three stamp issues that were set to be published during the last quarter: celebrating Her Majesty The Queen's 95th birthday, remembering His Royal Highness The Prince Philip, and commemorating Christmas 2021.

The releases are all the more precious given that printing and shipping delays for all three issues brought them to the Cayman Islands weeks after the target release dates in October and November.

Now, all three stamp issues are available for purchase at all Cayman Islands Post Offices. However, the First Day Cover (FDC) for the Prince Philip issue is the only one currently available since the

FDCs for the other two issues are still awaited.

The full set of stamps and First Day Cover for the Prince Philip stamp issue are available for purchase at the Philatelic Bureau located in the Seven Mile Beach Post Office on West Bay Road.

Commenting on the stamp issues, Postmaster General, Ms Sheena Glasgow said: "The Christmas season is always a special time for us at CI Postal Service. So, I am delighted that we have been able to release another Christmas issue and the Royal Family stamp issues are always popular in philatelic circles. Unfortunately, conditions beyond our control - and indeed of our suppliers

as well -- delayed the release of these new issues. Nevertheless, better late than never and we are pleased we could offer them in time for increased Christmas season mail."

The Postmaster General added, "Development work on our 2022 stamp issues is already underway so the Postal Service will continue to release stamp issues going into the future, as we have done in the past."

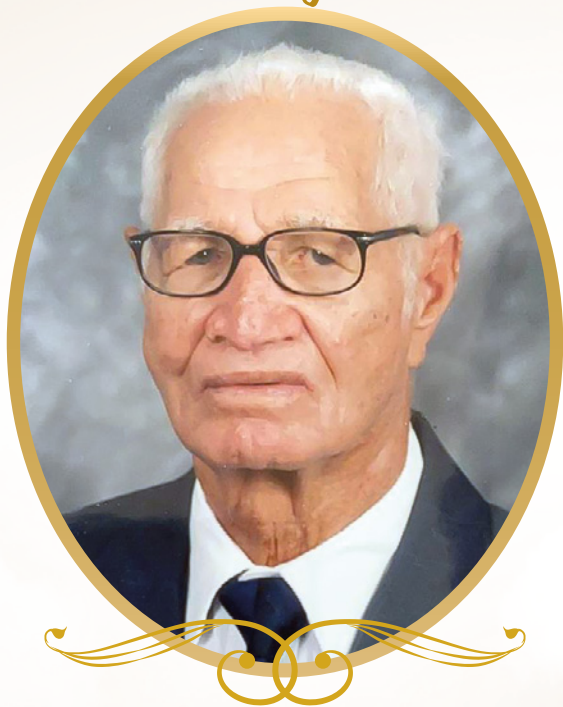

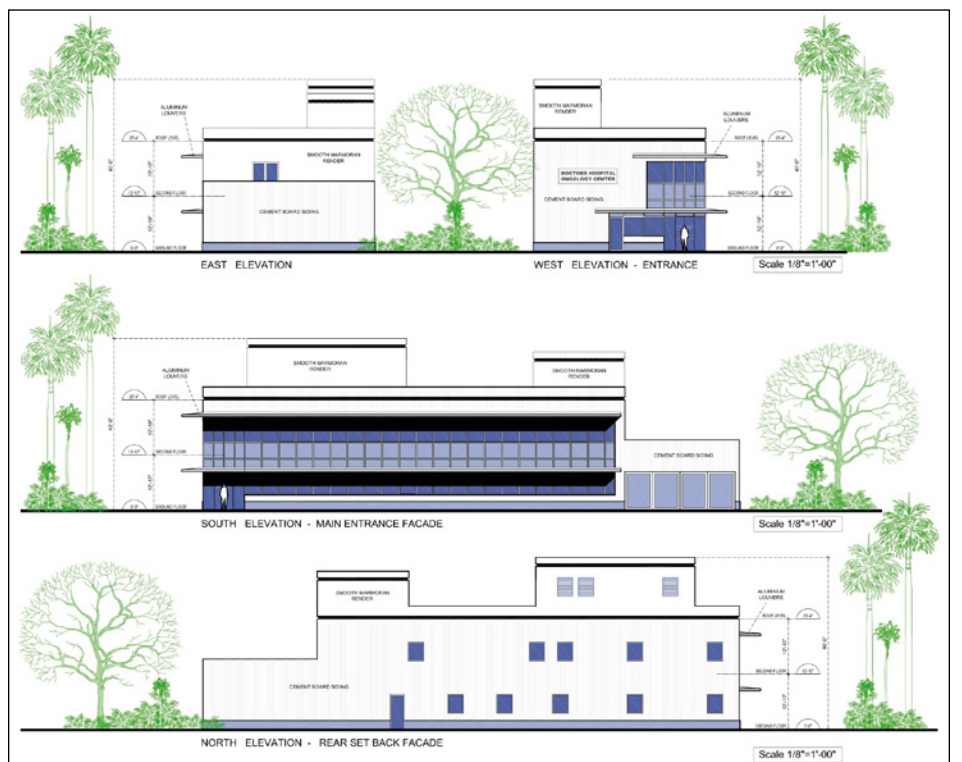

The Cayman National Cultural Foundation (CNCF) will be cleaning and sprucing up Miss Lassie's home in South Sound in preparation for Christmas. The annual event, called "Christmas of Yesteryears", reenacts the various activities that Caymanians would engage in years ago as part of their cultural traditions during the holiday season.

This year the CNCF staff and volunteers will descend on the grounds of Miss Lassie's home (also known as Mind's Eye) on Tuesday, 21 December from sunrise to noon where they will mix white lime to dress the house in a fresh new coat for the holidays; 'back' sand in traditional Caymanian thatch baskets and arrange it in neat piles; spread and brush the sand with rosemary brooms; pull weeds and perform any other necessary maintenance on the structure and compound.

"It is so important to our sense of identity as a nation that we keep hold of

these precious traditions and not allow them to fade away from our collective memories, either because of our inattention, or the fast pace of modern develop-

ment," said Henry Muttoo, CNCF Artistic Director.

Gladwyn K. Bush – Miss Lassie – was a fourth-generation Caymanian who started

painting at the age of 62 after what she describes as a visionary experience. Strong Christian themes run through her work, which she painted not only on canvas, but also on the walls, windows and furnishings of her home.

In 2009 after her death and that of her only son, the Cayman Islands Government purchased the property and vested it in the Cultural Foundation. Since that time, CNCF has meticulously restored and preserved the artist's home for the people of the Cayman Islands to experience an embodiment of their cultural and artistic heritage, to keep alive the memory of the artist as a National Cultural Treasure and, by its use, to educate, promote, develop and research Caymanian and intuitive art, culture and heritage.

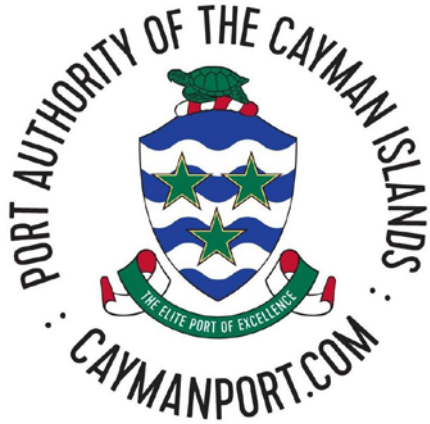
