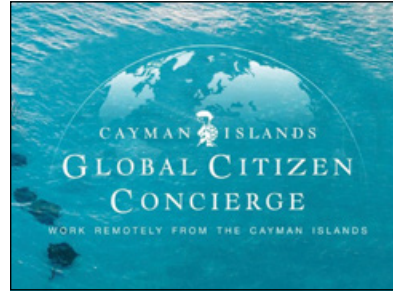

## George Town applies for city status

A total of 39 places in the world have applied to become cities, a prize that is on offer in a competition that is part of the Queen's 2022 Platinum Jubilee. While the majority of the places vying for the right to call themselves a city are UK towns, there are also some from British Overseas Territories and Crown Dependencies, including the Cayman Islands, Gibraltar and the Falkland Islands. In order to judge which places will be bestowed the honour, an expert panel will work with UK Ministers to make recommendations, before being approved by Her Majesty The Queen.

Winning city status can provide a boost to local communities and open up new op-

portunities for people who live there, as is the case with previous winners Perth and Preston where the local economies benefited from their improved national and global standing.

For the first time ever, British Overseas Territories and Crown Dependencies were eligible to apply for the title as part of the competition.

The UK's Chancellor of the Duchy of Lancaster Steve Barclay said:

"Today's announcement is a celebration of the rich and diverse communities which make up not only the United Kingdom, but

## Blood Bank donations needed

The Cayman Islands Blood Bank has announced a critical appeal for Type O positive blood. All eligible individuals are being asked to donate blood immediately, regardless of their blood type.

In announcing the appeal, Head of Laboratory and Blood Bank Services at the HSA, Judith Clarke says it is critical to have a healthy supply of Type O blood on hand. O positive blood is one of the most common types and therefore one of the most needed for transfusions.

Supply chain delays from the US due to the pandemic, has slowed the receipt of blood, therefore Cayman needs to increase our local blood donations to ensure we have adequate supply for patients when they need it.

Healthy volunteers are also encouraged to donate blood throughout the year to maintain a stable blood supply for the sake of patients' dependent on blood transfusions due to surgery or blood diseases. Men can donate every three months and women every four months.


It is not possible to contract COVID-19 through blood donation. The Blood Bank at the Cayman Islands Hospital takes every precaution to minimize the risk to blood donors, including appropriate physical distance between people and sanitization. Persons who have recovered from COVID-19 are also able to donate blood.

Donors are asked to follow these guidelines:

- If you are feeling any degree of illness, you should stay home and not attempt to give blood.

- If you have any reason to believe that you have had contact with a person suspected or confirmed to have COVID-19 within the last 14 days, you should not attempt to donate blood.

- If you have had any symptoms of fever or viral infection within the last 14 days, please wait until you have been completely symptom-free for two (2) consecutive weeks.

Donations can be made Monday -Friday from 7:00am-6:30pm, and Saturdays from 9am to 5:30pm at the Cayman Islands Hospital. Walk-ins are also accepted. Persons who have not donated before with the Blood Bank can take a brief eligibility test on its website before scheduling an appointment.

The Blood Bank will be closed on the upcoming public holidays: December 27, 28 & January 3, 2022.

# RCIPS Stress Patience on the Roads in Lead up to Christmas

HE The Governor, Martyn Roper and the Deputy Governor and Head of the Civil Service, Franz Manderson have lent their support to our Christmas road safety message in the attached voice notes.

This weekend, 18-19 December, was the third of the RCIPS Holiday Safety campaign, Winter Guardian, and the busiest yet for officers enforcing the road safety component of the campaign.

57 prosecutions were made, 28 speeding tickets issued, 27 for tint, and 2 DUI's. Officers also responded to 28 MVA's, one being a pedestrian on Smith Road who received serious but non-life threatening injuries.

"We know the lead up to Christmas can be a busy time. With only a few days to go and last minute Christmas preparations to organise, we want to stress to the community to please be patient and drive carefully on the

roads. We want to see everyone arrive home safely for Christmas", says Head of Traffic & Roads Policing Unit, Dwayne Jones.

"No one likes receiving a ticket, particularly at Christmas, but the police have an important role to play in making our roads safer for all road users, and our enforcement efforts help send a clear message to those motorists that choose to break the law", says Superintendent Brad Ebanks. "We will continue our multi-faceted approach with increased police enforcement and visibility in the lead up to Christmas and through to the New Year, not only on the roads but also within the community and commercial establishments, to help keep the Cayman Islands safe over the festive season."

## RCIPS Report Increase of Scams over Holiday Period

The RCIPS Financial Crime Investigation Unit has noticed a recent increase in scams and is providing the following information for community awareness.

The scams are usually sent to recipients via messaging services such as WhatsApp. Some of the recent scams that have been reported include the following scenarios:

- Advising of lottery winnings from prominent brands and requesting bank details or administrative fees to collect winnings
  - Purported cryptocurrency investments that use the names of public figures to entice people to invest
- If persons receive messages of this nature the RCIPS advise blocking the sender.

# SAFETY DURING THE CHRISTMAS SEASON 2021. HAZARDS TO AVIATION

The Civil Aviation Authority of the Cayman Islands (CAACI) would like to remind the public of the risks to aviation and public safety in general which come from the flying of small unmanned aircraft (also known as drones or unmanned aerial vehicles) kites, sky lanterns and firework displays which are received as presents or used as a part of the holiday festivities.

## Small Unmanned Aircraft (SUA)

Each operator is legally responsible for the safe conduct of each flight. Prior to each flight be sure that your drone is undamaged and all components are working. Drones must be kept within your direct sight at all times and it is your responsibility for avoiding collisions with other people or objects. Do not fly your unmanned aircraft in any way that could endanger people or property.

As a protective measure, "no-fly" zones, were introduced in February 2015 and it is illegal to fly an unmanned aircraft within 3 nautical miles of Owen Roberts International Airport (Grand Cayman), Charles Kirkconnell International Airport (Cayman Brac) and Edward Bodden Airfield (Little Cayman) without a specific written permission issued by the CAACI. In addition, a "no fly" zone has also been established around HM Prison Northward and it is illegal to fly an unmanned aircraft within 1 nautical mile of the Prison perimeter without the specific written permission of the Director of Prisons.

To operate your drone/SUA for commercial purposes, the operator must be in possession of a current permission issued by the CAACI. Permission will ensure the competence of the operator to provide a safe service and will require him/her to be medically fit and hold "adequate third-party liability insurance". Any organisation or individual undertaking commercial aerial work without such permission required may be guilty of an offence and liable on summary conviction to a fine not exceeding \$3,400. The application for a Permission to undertake aerial work

should be made on the application form which can be found at the following link: <https://www.caacayman.com/wp-content/uploads/LIST%20OF%20REQUIREMENTS%20FOR%20CAACI%20SUADRONE%20PERMISSION.pdf>

Any company requesting the use of a drone/SUA for aerial footage for commercial purposes should ensure that the operator is approved by the CAACI. A full list of all approved drone operators can be found here: <https://www.caacayman.com/wp-content/uploads/pdf/SUA-Operators.pdf>

The CAACI is responsible to the Governor, for the oversight of the use of Small Unmanned Aircraft (SUA)/drones in the Cayman Islands as identified in the legislation of the Air Navigation (Overseas Territories) Order 2013, Article 73. The above national regulations have been developed for the use of SUA/drones, in keeping with the legislation, and identify the requirements applicable to the operation of these aircraft in the Cayman Islands.

## Kites

The flying of kites in the vicinity of airports is potentially dangerous to aircraft particularly during the taking-off and landing phases. Not only is there a risk that the body of the kite could damage the aircraft or be ingested by a jet engine with possibly catastrophic results, but the control lines, sometimes made of high tensile steel wire on performance aerobatic models, can pose a significant hazard to propeller driven aircraft.

Article 71 of the (AN[OT]O 2013) effectively limits the height at which a kite can be flown to a maximum of 100ft above ground level (AGL) within a 3 nautical mile radius of an airport. Beyond this distance, a kite cannot be flown above 200ft AGL within the Cayman Islands.

The rules regulating kite flying may not be generally known and the purpose of this advisory is to provide the necessary information to allow the public to under-



stand the potential hazards to aviation and to enjoy this recreational activity within the limits established by law.

In order to protect the safety of aircraft, the operators of kites being flown above the heights specified are liable to be prosecuted and may have their equipment confiscated.

## Fireworks and Light Displays

Firework displays can vary from small domestic events to major commercial or ceremonial displays whilst light shows include all outdoor laser and searchlight displays. The associated risk posed by these events is increased when the activities take place in the vicinity of aerodromes, particularly during critical phases of flight including approach, landing and take-off. Organizers planning firework and light displays during the coming season are reminded of the legal requirement under Article 165 of the (AN[OT]O 2013) to coordinate their proposed events with the Civil Aviation Authority of the Cayman Islands (CAACI) in order to prevent potential threats to aircraft operations.

**Coordination with the CAACI is required for all firework activity that takes place within 3 nautical miles of an airport or under the approach and departure paths. Firework displays outside this area where the display height is expected to exceed 200ft above ground level must also be coordinated with the CAACI. Proposed laser and searchlight events within the same areas are similarly subject to coordination with and approval by the CAACI.**

Firework, Laser and Light displays which come into this category must be formally approved in advance by the CAACI and will incur the appropriate fee, as per the Air Navigation (Overseas Territories) Order Fees Regulation 2010.

## Sky Lanterns

Sky Lanterns are forming an increasingly significant part of community and individual celebrations in the Cayman Islands and the number and size of lanterns being released is increasing to a point where they can pose a hazard to aircraft.

Unlike other forms of recreational and celebratory activities including SUA and kite flying, firework displays and laser light shows, all of which can be controlled from the ground, sky lanterns cannot be controlled once released and the larger lanterns, some of which exceed 4ft in height and diameter, are able to climb in the prevailing wind to a height of several thousands of feet.

Many such products are described by the manufacturers or the retailers as being "bio degradable" inferring that they burn themselves out and leave no trace behind them. Whilst this may be true of successful launches over the sea, it is not necessarily the case of Sky lanterns which are blown back over the land. There are documented incidents in which fires have been started, property destroyed or damaged by the smoldering remains and of livestock injured from digesting bamboo or wire debris.

In addition, the risk to aviation is obvious and although there is currently no legislation in place to regulate the release of sky lanterns the need for caution and careful planning before a launch will be equally obvious.

Any individual or organization planning to release sky lanterns should consider their personal liability in the event that damage to property or injury to humans or animals is caused either by the release of a sky lantern or the debris generated by them.

also our friends further afield in the Falklands, Gibraltar and the Cayman Islands.

“It’s fitting that, as we look towards celebrating the 70 year reign of Her Majesty the Queen, we extend the competition to include those parts of the world which also hold her so dearly.

“City status is not only about local pride, it can deliver real levelling up benefits for businesses and the local area which is clear from the high number of applications. A sincere best of luck to all those who have applied.”

The competition is part of a series of planned celebrations to mark Her Majesty The Queen’s historic, 70-year reign.

Applicants were asked to talk about the distinct identity and community which they felt meant that their area deserved to become a city, as well as the royal associations of their area.

The UK’s Cabinet Office has also announced the 12 cities which are vying for Lord Provost or Lord Mayor status, including Newport and Perth who both previously won city status on The Queen’s Golden and Diamond Jubilees.

UK Culture Secretary Nadine Dorries said:

“Her Majesty The Queen’s Platinum Jubilee is an exciting chance for local areas to become cities and level up opportunities for all. As well as fostering local pride and potential, this competition is a great way to mark Her Majesty’s 70 year reign.

“I wish all entries the best of luck. 2022 is set to be a year of pride, celebration and coming together with the four-day weekend for the Platinum Jubilee alongside other blockbuster events including the Birmingham 2022 Commonwealth Games and Unboxed, championing creativity in the UK.”

Unlike previous Civic Honours competitions, an expert panel will work closely with Ministers to make their recommendations, before being approved by Her Majesty The Queen.

Chair of the Preston Business Improvement District in the UK, John Boydell, said:

“Preston winning city status brought attention to the city, from the buying public and from those thinking of investing in the city. I think it brought Preston to mind as a place to do business.”

The final decision will be taken in spring 2022 and announced shortly afterwards as part of The Queen’s Platinum Jubilee celebrations. The full lists of applicants can be found below.

## Two new board members for Cayman's literacy charity, Literacy Is For Everyone

Cayman's literacy charity, Literacy Is For Everyone (LIFE) has appointed two new members to its Board of Directors. Lynne Byles, founder and Managing Director of Tower Marketing, and Sam Nehra, HR specialist and Chief of Staff at Real Vision, join six incumbents. Their appointments come as the PACT government continues to invest heavily in education, committing over \$200 million to projects, including the introduction of nursery facilities for 3-year-olds at every public primary school.

"LIFE is so pleased to welcome these ladies to our team of committed Directors. Both bring a lot of experience and expertise to the table. Low literacy is a driver of inequality, which can pose serious socio-economic consequences. We are thrilled to continue to grow our organisation and empower future generations of the Cayman Islands," said Woody Foster, LIFE Chairman.

With the Education Data Report 2020, published by the Department of Education Services, showing a troubling discrepancy between the performance of boys and girls, with 63% of girls meeting national expectations, compared to 48% of boys, and the actual outcomes of Year 6 students falling significantly short of Cognitive Abilities Test (CAT4) predictions, education, and the importance of literacy as a gateway to learning, are being brought front and centre of the national agenda.

"All children have the right to literacy. Being able to read and write is the key

to accessing education and employment and to participating fully in society. I am delighted to join the board of LIFE to help advocate for stronger literacy outcomes for the children of Cayman," said Byles.

LIFE continues to expand its education and community outreach programmes into early childhood, a critical time of brain and language development for children aged birth to five years old. Recognising the importance of early childhood centres for children below the age of compulsory education, the Office of Educational Standards' 2019 Annual Report highlighted international research

demonstrating the critical impact of the quality of a child's early childhood experience on future academic outcomes and educational participation.

Commenting on her appointment, Nehra said, "I am passionate about supporting LIFE and the amazing work they are doing to ensure literacy is not seen as a taboo subject. It is one of the most critical foundations for any society wanting the best opportunities for their future generations."

# Active WORC Boards Taking Holiday Break

All of the statutory boards under the remit of Workforce Opportunities & Residency Cayman (WORC) will be taking a break for the holiday season, having been holding regular meetings since first convening in mid-November as per the Immigration (Transition) Act (2021 Revision).

WORC Deputy Director Sian Pairaudeau said, "Although there was an initial delay in meetings following the appointment of new board members, all boards have been active with applications being reviewed and processed in parallel with department administrators."

Between October and November, the newly-appointed members of the Work Permit,

Cayman Status & Permanent Resident, Business Staffing Plan, and Work Permit Cayman Brac & Little Cayman Boards received training on data protection sensitisation and cyber awareness, as well as going through a familiarisation process with board secretaries, relevant processes and policies.

The Cayman Status & Permanent Resident Board also received training on the permanent resident (PR) point system.

Mrs. Pairaudeau said, "We understand the impact on our customers while the boards were in transition, which included delays in the review and adjudication on some applications. However, the training process was necessary to ensure continuity and

timely processing of applications moving forward."

Additional training will run parallel to board meetings, which will resume in early January 2022 following the holiday break. Applications that can be dealt with administratively will continue to be adjudicated on as normal.

The regular weekly schedule of board meetings will resume in January with the Work Permit Board meeting every Monday, the Business Staffing Plan Board meeting on Wednesdays and some Fridays, and the Cayman Status & Permanent Resident Board meeting every Thursday. The Work Permit Cayman Brac & Little Cayman Board meets every other Tuesday in Cayman Brac.

# Global Citizen Concierge Programme Extended

The Global Citizen Concierge Programme has been extended for an additional year following Cabinet approval to amend the Immigration (Transition) (Global Citizen Exemption) (Amendment) Regulations, 2021 accordingly. The programme will now also allow for proof of additional means of income.

Under the new amendments, the programme is open for applications through October 2022 for participants to stay in the Cayman Islands for two years.

Applicants can now also include other sources of income such as annual salary, annual salary of spouse or civil partner, employment bonus of applicant, spouse or civil partner, income from investments of applicant, spouse or civil partner, share dividends of applicant spouse or civil partner and any other forms of recurring income of the applicant, spouse or civil partner.



The minimum annual income for an individual applicant to apply for the programme is US\$100,000 and the minimum annual income for a family of four is US\$186,000. A minimum income applies to applicants with up to five dependents and for applicants with five or more de-

pendents, the minimum annual income is left to the discretion of the Director of WORC.

The Global Citizen Concierge Programme launched in October 2020 to allow individuals and families who are employed and generate income outside of

the Cayman Islands to live and work in the Islands remotely.

The programme allows the approved applicants to travel in and out of the Cayman Islands as a Permanent Resident for the term of the contract.

The programme has generated US\$293,040 of direct revenue for the Department of Tourism, and it is estimated that about US\$5,000 per applicant is pumped into the local economy per month of their stay.

To date, 152 applications have been approved resulting in 334 people arriving as part of the programme. There are 23 applications representing 52 people currently awaiting approval to arrive.

All individuals entering the Cayman Islands via the Global Citizen Concierge Programme are required to be fully vaccinated against COVID-19.

# Clean Up and Campaign moves to Barkers

Last weekend Plastic Free Cayman, CayOcean, and the MCGI church joined more than 45 local volunteers to clean up Barkers Beach and support Protect Our Future's latest "Our Future is NOT single-use" campaign.

The event also included appearances from Cayman COP26 representative Ms. Dejea Lyons, as well as Mr. Martin Lancaster, Breast Cancer Foundation advisor and beach clean warrior, whose cleanup efforts have raised thousands of dollars for charity.

This holiday clean up marked Plastic Free Cayman's last beach clean of 2021. This year, the organisation removed more than 14,000 pounds (over 7 tonnes) of trash from Cayman's beaches. In

fact, since Plastic Free Cayman's establishment in 2017, more than 6,000 pounds (3 tonnes) of garbage, mostly marine debris, has been removed from Barkers National Park.

Protect Our Future co-leader Nic Corin commented, "It seems as though every time we go back to Barkers Beach the plastic pollution situation gets worse. We need to take action. It is our hope that Cayman will implement the single use plastic ban that was in the works two years ago."

After removing more than 500 pounds of debris this weekend, Chloe Bentick-Lalli, the Protect Our Future campaign leader added, "It's sad to see our National Park filled with plastic. Our future is not single-use, and we

need to wake up and engage in real action."

Of course, much of the marine debris does come from other nearby island nations, however, there is also a great deal of local litter, especially in Barkers.

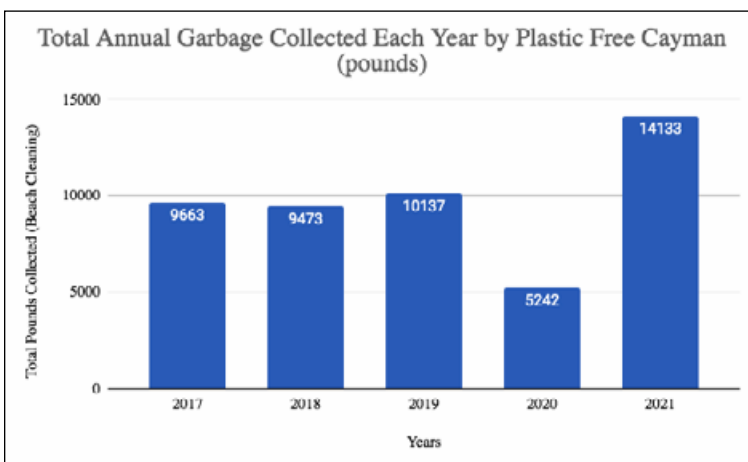
The leaders of Plastic Free Cayman fully understand the convenience of plastic in much of our daily lives, especially during the current global pandemic. Lateral flow tests, masks, and gloves are just a few of the single use plastics that continue to be a part of our current situation. However, this should not become an excuse for continuous local litter, a poor waste management system and inaction regarding the banning of unnecessary single-use items. Like the students of Protect Our Future, Plastic Free Cayman would like to see a future driven less by consumerism. Instead, our products should be part of a circular economy and more sustainable.

This marks Plastic Free Cayman's fifth year of cleanup efforts. As a nonprofit partnering with thousands of volunteers both locally and internationally, they have removed over 25 tonnes of waste from Cayman's beaches. up more than 30% from 2019. Clearly the problem is not going away, which is why a call to action is so important. In many

## Dominica adds to its eco-resort portfolio

Dominica's latest luxury eco-resort has opened over the festive season; Coulibri Ridge is a dramatic design, set on a hillside with spectacular views of the Caribbean Sea.

Coulibri Ridge has 14 rooms, ranging from studios to duplex suites, all of which have views of neighbouring Martinique and custom kitchens and recycled furnishings. Three of the suites have their own private plunge pools.

It is the latest addition to Dominica's growing portfolio of luxury hotels, that includes Secret Bay, the Cabrits Kempinski and the Pagua Bay House, among others.

Coulibri Ridge is set on a 200-acre site, with two pools, two dining rooms, a spa, a yoga pavilion, a conference room and property-wide, complimentary Wi-Fi.

It's the brainchild of Daniel Langlois, a Canadian software en-

trepreneur who became wealthy in film industry animation and special effects used in films like Jurassic Park.

The project has been in conception for several decades, with the idea of creating a self-sustainable, green resort. It is completely off the grid, using solar energy as its main source of power.

The opening of Coulibri Ridge is particularly well-timed, following the recent launch by American Airlines of the first-ever nonstop flights from the United States to Dominica.

## Antigua gives LIAT tiny Xmas cheer

Antigua and Barbuda dispatched EC\$2 million (KY\$610,000) to the LIAT court-appointed receiver for distribution to resident former LIAT workers on Monday. The payment is limited to former LIAT workers resident in Antigua and Barbuda.

This payment is intended to meet partial satisfaction of the cash component of the compassionate pay out which the Antigua and Barbuda Government has volunteered, though the government has no legal obligation to make any such payments.

The payment is intended to bring some Christmas cheer to those who have been unable to earn incomes since they were severed although they had re-

quested much more and the total owed is over KY\$40m.

Antigua and Barbuda, a 34 percent shareholder, has taken over operation of the airline since its collapse in April 2020. Barbados with 49 percent along with St Vincent and the Grenadines, Dominica and Grenada, make up the other major shareholding governments. Following LIAT's collapse Antigua and Barbuda, St Vincent and the Grenadines and Dominica agreed to write off debts owed to them by LIAT.

In June this year, almost 100 former Barbadian LIAT workers started receiving a promised EC\$2,000 (KY\$610) per month that would be repaid from any future severance payment.

## Cuba's vaccine program pays dividends

Cuba has vaccinated more of its citizens against COVID-19 than most of the world's largest and richest nations, a milestone that will make the poor, communist-run country a test case as the highly contagious Omicron variant begins to circle the globe.

Cuba has vaccinated over 90 percent of its population with at least one dose, and 83 percent of the population is now fully inoculated, placing it second globally behind only the United Arab Emirates among countries of at least one million people, according to official statistics compiled by 'Our World in Data.'

Unlike its Latin America neighbours who waited for wealthier countries to develop vaccines, Cuba took the initiative and developed its own. Infections and deaths from COVID-19 have plunged on the island in recent weeks, falling to less than 1 percent of their peak on Aug. 22, when fewer

than half its citizens were vaccinated. Nearly all of Cuba's children aged 2 to 18 have now been vaccinated with home-grown vaccines.

Schools have reopened and foreign tourists are again welcome. Hospitals and morgues, overflowing in August, appear to be operating at pre-pandemic levels.

## St Kitts is magnet for cruise ships

St Kitts and Nevis is one of the most sought after cruise ship locations in the Caribbean. Despite its population being only 53,000, it enjoyed five different ships docked at the Port Zante last Thursday.

The ships were Viking Sea, Royal Clipper, Silver Spirit, Allure of The Seas, Marella Discovery. Lindsay Grant, Minister of Tourism, said the rise in cruise ship calls to St Kitts and Nevis for December and for the next three months is a strong sign of cruise lines' trust in the destination.

In the second week of December, 21 different cruise ships called on St Kitts, bringing thousands of tourists and hundreds of job opportunities.
