

Message concerning Russia's invasion of Ukraine

It is with dismay and a heavy heart that I watched the news reports on BBC this morning of Russia's military operation in Ukraine earlier today.

War carries a tremendous humanitarian cost and is usually the worst possible action and least effective option. It is unacceptable that lives of soldiers and civilians have already been lost as a result of this invasion.

Additionally, this war presents a threat to the global economy, which is already reeling from its attempts to recover from the COVID-19 pandemic. We have already seen an increase in energy prices worldwide as oil rocketed past \$100 a barrel. If war continues, the prices could go up even more, affecting prices worldwide.

Here in the Cayman Islands we will almost certainly see higher fuel prices, which will in turn impact the prices on all goods and services, and therefore the general cost of living.

Instead of war, the Cayman Islands would prefer an urgent peaceful end to this situation. To us, war is not a viable solution. Indeed, the United Nation's Sustainable Development Goal No. 16 calls, in part, for peace.



At this time, the Cayman Islands Government Office in the United Kingdom is not aware of any Caymanians presently in the Ukraine. However, we will continue to monitor the situation as we continue to hope for a diplomatic and peaceful resolution. The Scholarship Secretariat has advised that we have no students on Education Council scholarships in Ukraine.

Our thoughts and prayers are with the innocent children, women and men of Ukraine as they face the fear of this unprovoked attack on their lives and their country.


The printed newspaper inserts are being augmented with online ads, radio public service announcements and radio talk show interviews to raise awareness.



SHOMARI SCOTT BECOMES 38TH CHAMBER PRESIDENT

Shomari Scott became the 38th President of the Chamber of Commerce last week at the Annual General Meeting. The Health City Cayman Islands Chief Business Officer pledged to assist small businesses to recover from the impact of the pandemic and to establish a trusting partnership with Government. He will work to alter the misconception that the Chamber is an elitist organisation, stressing that small businesses are the true drivers of the Cayman Islands economy, and the Chamber is an organisation of small business entrepreneurs.

"More than 75% of our 636 members employ fewer than 10 employees. These businesses have been impacted the most during the pandemic and we must do everything we can to assist them to recover and succeed," he stressed.

'We also must support Caymanian entrepreneurs in our schools and communities who are seeking to start their own businesses. We want them to become the next generation of wealth and job creators. The Chamber will evaluate its pro-

Scott reflected on the many successes of the Chamber over the years which included the establishment of the islands' first multi-employer pension plan in 1992, the Chamber Training Centre in 1995, the islands' first student mentoring programme in 2002, Leadership Cayman in 2010 and the award-winning Growth Matters animated video series in 2018. The Chamber has produced salary surveys, special reports, and economic studies and initiated many community programmes such as the annual Earth Day cleanup, fundraising charity golf tournaments, Cayman Crimestoppers, Resilience Cayman, and the Employee Assistance programme.



He described the list as impressive but noted the need for innovation.

"We must determine what's next for the Chamber so that small businesses and entrepreneurs will want to join and see true value in the programmes and services that we offer. In short, we need to reengage with our members and the community so that we understand what they want us to offer and deliver it," he said. SHIP AHOY! CRUISE TOURISM **RETURNS TO CAYMAN**

Cruise ships will start calling again at Cayman from next month

Confirmation came in a detailed press release on Friday afternoon (February 25th) that the first cruise ship in two years will arrive in port on March 21st, marking two full years since the borders were closed on March 22nd 2020 due to the COVID-19 outbreak.

The release from the Ministry Tourism and Transport, portfolio of Hon. Kenneth Bryan, said: "Following careful consideration of recommendations presented by the Ministry of Tourism to facilitate the safe return of cruise tourism, cruise ships are projected to return to the Cayman Islands from 21st March 2022, pending formal Cabinet approval and regulatory amend-

Mr Bryan emphasised that the government is giving as much advance notice as possible of the intent to restart cruise tourism on 21st March. "This is to allow cruise operators, businesses and employees enough lead time to prepare," he stated. "After two years of uncertainty there is finally light on the horizon, and I encourage businesses to start staffing up and making the necessary preparations to give cruise passengers a great experience when they arrive."

The Tourism Minister also said, "After a 2-year hiatus, the return of cruise passengers to the Cayman Islands will be a move welcomed by displaced employees and industry stakeholders, and represents the achievement of another significant milestone in the recovery of the Cayman Islands tourism industry.'

According to the Ministry of Tourism's recommendations, the resumption of cruise tourism will follow a phased approach similar to the process adopted for the reintroduction of stay-over air arrivals.

Phase 1 is slated to continue for a period of four weeks, to allow sufficient time for safety protocols to be evaluated and to identify what, if any, adjustments might need to be made.

The strategy for Phase 1 limits cruise passenger arrivals will be limited to 40% of previous passenger volumes - a maximum of 75,000 passengers during this

"Following the successful completion of that phase, and subject to Public Health approval, the 40% capacity constraint will be removed. However, effective public health protocols will be maintained, integrating the lessons learned during Phase 1," the statement explained.

Mr Bryan recently to recent high senior executives from the Florida Caribbean Cruise Association (FCCA) in high level talks about the return and future of cruise tourism in Cayman.

"The PACT Administration does not take the decision to reintroduce cruise tourism lightly," he is quoted as saying in the press release which names newly-appointed Chief of Strategy in the Premier's Office Pilar Bush - a former Director of Tourism - as the contact person.

"The fact remains that while the pandemic persists, all travel, whether by air or sea, presents a certain degree of risk. However, as we are seeing with stayover arrivals, our Island's high vaccination rate, coupled with having the right safety protocols in place, is allowing our tourism industry to recover," Mr Bryan added.

The release goes on to state that drawing on previous experience from the reintroduction of tourist air arrivals in the Cayman Islands, the Programme Board and various local government entities are reviewing regulations to ensure that appropriate mechanisms are in place to protect the public.

It said these are intended to take into account the unique characteristics of the cruise industry and the fact that cruise passengers are only in the jurisdiction for 6-8 hours on average and do not overnight.

Also during Phase 1 of the return to cruising, in addition to the rigorous safety protocols implemented by cruise lines, which include the requirement for passengers and crew to be fully vaccinated, the Cayman Islands Government says it has identified which cruise calls will be permitted, to increase the layers of public

According to the release, the (Interim) Chief Medical Officer, Dr. Autilia Newton, has also examined the health protocols of all cruise lines that operate under the Florida Caribbean Cruise Association (FCCA).

A key part of the protocols specific to the cruise sector stipulates that no COVID positive passengers, crew or their close contacts will be permitted to disembark the cruise ship in Grand Cayman, whether they are symptomatic or not.

Tourism Minister Bryan stressed that public health and safety remains a pri-



ority, saying that's the reason why the government is adopting a pragmatic, phased approach. "Our phased approach will ensure that residents and visitors are well protected as we welcome cruise passengers back to our shores," the Minister

Friday's press release announcing the return of cruise tourism points out that around the world cruise operations have been safely resuming, and public health

measures, such as pre-embarkation tests and wellness checks that comply with COVID-19 guidelines from the Centers for Disease Control and Prevention (CDC), are in effect.

It said individual cruise lines have also developed their own safety protocols that exceed CDC guidelines, and ships are now equipped with excellent medical facilities, including intensive care and isolation









CITA PRESIDENT CALLS FOR TOURISM STIPEND EXTENSION



President of the Cayman Islands Tourism Association, Marc Langevin, feels the government's stipend scheme for displaced tourism workers should be extended to support employees not yet back in full employment.

Mr Langevin was making his second appearance on the Caymanian Times weekly discussion programme, The Panel, when he made the suggestion.

"It is very important that government maintains the stipend to support those employees," he urged the PACT administration.

With the borders now fully reopened - and cruise ship calls now due to restart this month (March) - hotels and other sectors of the tourism industry are looking to gear up their operations to welcome guests.

However the CITA president said while he is optimistic about the outlook for the industry, at present they are facing several challenges including staffing numbers and even limited numbers of work hours and tips/gratuity earnings available the reduced staff currently on the job.

"We had a conversation last week with our employees and even if they come back to work right now, they still deserve to receive the stipend because they don't do the full 40 hours or 50 hours, explained Mr Langevin, who is also the general manager of the Ritz Carlton hotel.

He also relayed that there is anxiety among workers who are faced with making the judgement between returning to a job for which they might earn less due to fewer hours and tips and giving up a job they might have obtained during the slowdown in tourism. For them he said, the core calculation is making ends meet.

"There is a fear that if they go back into tourism, they're going to lose the job that they have right now," he said.

"They were very afraid because last week when they received notification that their stipend would be removed, they panic because they cannot pay their bills. And the danger would be that they could find another job because they are not returning to work right now (in tourism)... And they're not going to come as long as the business is not stabilized...until the hotel reaches a certain level."

According to Mr Langevin, low hotel occupancy rates at present mean that the industry is not likely to return anything resembling pre-pandemic status before the next peak season starting in November and rolling over to 2023. However, an increase in tourist numbers is expected for





Spring Break, the summer season and the return of foreign property owners.

Just recently, the PACT government announced an interim extension of the stipend programme reversing a previous decision that would have effectively suspended the scheme in last month.

Hon. Minister of Finance and Labour Chris Saunders had announced that tourism workers whose current earnings are still well below pre-pandemic levels are being considered for another uplift to help them 'make ends meet'.

"We do recognise that it will take some people a while to catch back to where they

were," he said referring to workers whose earnings are normally supplemented by tips and gratuities.

Mr Saunders had explained that even though some have returned to work, the tourism industry has not yet picked up to the point where their pay is on par with their previous earnings, despite working the same number of hours.

"As such, we are prepared at this point to go back to the Finance Committee and say to the Members of Parliament that it will need additional funding for especially for people in the cruise industry which will not be back at 100% of where it was," he stated.

Cases go down; Kids vaccines last weekend

In their Covid report for the week 13 to 19 February, the Ministry of Health and Wellness noted the numbers of positive Covid-19 cases were dropping since the previous weeks. During that week, there were 562 new cases of Covid-19. This was 417 cases less than were reported in the previous week of 6 to 12 February and the statistics showed a continued a decline in weekly new cases that had been evident since late-January, they said.

During the week of 13 to 19 February, 3,098 tests were conducted compared to 4,716 tests in the previous week and 6,810 tests during the first week of February. The number of people who have died remains at 17 as at 19 February.

Also during this week, there were 16 hospital inpatients going through George Town Hospital and Health City, as compared to 21 from the previous week


With regard to the most up-to-date statistics are concerned, Public Health advised that there were 71 new positive cases as of 21 February and 56 as of 22 February.

As of 22 February, there were 1,366 estimated active cases of Covid-19 in the Cayman Islands. Nine patients were hospitalised for Covid-related causes and of these, one was partially vaccinated and six were unvaccinated.

The Sister Islands also noted five new cases since the last report, bringing total cases there since the beginning of the pandemic to 525.

Police Investigate Fatal Accident on Saturday

On Saturday police and other emergency services were dispatched to Mangrove Avenue in the Prospect area to a single vehicle collision involving a black Honda motor car.

When officers arrived at the location they saw that the vehicle had collided with a fence column and the male driver, who is believed to be the only occupant in the vehicle, was still inside. Both Emergency Medical Services and the Cayman Islands Fire Service attended and assisted with extracting the driver from the vehicle.

The man showed no signs of life at the scene. He was transported to the Cayman Islands Hospital where he was pronounced dead by the attending doctor.

Investigators from the Traffic and Roads Policing Unit are currently investigating this incident and are seeking witnesses to come forward and provide information about how the collision took place.

COVID-19 Positive Traveler is Sentenced to Four Months Prison

NHDT Partners with Beacon Farms on Green Waste Project

The National Housing Development Trust (NHDT) has partnered with Beacon Farms to process green waste from the affordable housing development sites to compost for farmers, home owners and members of the public.

The project started last month when several loads of green waste from NHDT's North Side housing development site was trucked to Beacon Farms, a non-profit organisation located off Frank Sound Road that provides agricultural jobs for Caymanians recovering from addiction.

Minister of Planning, Agriculture, Housing and Infrastructure, Hon. Jay Ebanks, Board Members and General Manager of the NHDT Julio Ramos visited the farm recently and discussed the project with Beacon Farms' board director Scott Haugh and Chief Operating Officer Sandy Urquhart.

Minister Ebanks expressed his support for the programme noting that it will be a win-win for NHDT and members of the farming community. "We are very conscious of the environment and left as many trees as possible for buffer at the North Side housing site while using the green waste for composting to benefit as many people as possible, especially our farmers", he said.

He further noted, "We all know that organic amendments are essential elements to increase soil fertility which we are trying to do as part of good agriculture practices to bolster our food security".

In commenting on the project, Mr. Ramos stated that the plan is for existing and future NHDT homeowners to have access to good quality soil for their backyard gardens from the waste generated from the housing development sites. "The Trust is looking forward to other opportunities where both entities can partner on other initiatives that will be beneficial to our communities, he emphasised.

Mr. Urquhart welcomed the partnership with NHDT as Beacon Farms need a constant supply of green and brown waste to produce compost. The farm's composting facility has capacity to hold around 53 tonnes of material and uses industrial

chipping and shredding machines to accelerate the process.

"Partnering with NHDT to produce higher volumes of compost benefits agricul-

ture and our community. Our programme of social entrepreneurship at Beacon Farms aligns well with NHDT's mission to support people in need of assistance".

Census reveals Cayman's 2021 population figures

The 2021 Census survey preliminary report has been released and reveals that the total population of the country in 2021 stood at 69,656. Out of that total, 69,350 people were living in households and 306 were living in institutions such as prisons, dormitories and retirement homes.

These figures come from the first report to be published from the massive collection of data which took place from 10 October to 31 December 2021, with an additional three weeks in January 2022.

The overall response rate to the Census was estimated at 96.8 percent, with a non-response rate of 3.2 per cent which amounted to 958 households or approximately 2,300 individuals.

The non-institutional population in 2021 (69,350) grew by 26% over the

2010 Census count of 55,036. Caymanians made up 52.9% of the population, while non-Caymanians counted at 45.9%. The remaining 1.2% of those surveyed did not indicate their nationality.

Most people were living in George Town (49.6%) at the time of the survey, followed by West Bay (21.5%), Bodden Town (20.6%), the Sister Islands (3.1%), North Side (2.7%) and East End (2.5%). Compared to the 2010 population, Bodden Town recorded the highest growth rate at 35.3% and the other districts recorded double-digit population growth except for the Sister Islands, which saw a population

There were 44,635 employed, with Caymanians accounting for 19,444 (43.6% of total employment), while non-Caymanians were counted at 25,097 (or 56.2% of the total). The unemployed reached 2,676 or 5.7% of the labour force. Unemployed Caymanians were counted at 1,795, while unemployed non-Caymanians was counted at 873, resulting in unemployment rates of 8.5% and 3.4%, respectively.

The number of households in the Cayman Islands increased to 29,502 from 22,760 in the 2010 Census, while the average household size remained relatively stable at 2.4 people in 2021.

Final 2021 Census numbers are expected in June of this year.

Deputy Premier and Minister for Finance & Economic Development Chris Saunders said that having accurate population data was vital in public health situations.

"I'm incredibly glad that we took a cautious approach and asked for a re-estimate of the population prior to determining our Covid-19 vaccination targets," he said, stating it was important that government got it right to ensure the population was sufficiently protected prior to re-opening borders.

"We went with the higher updated estimate from the Labour Force Survey Fall 2020, which is estimated within a 5% margin of error, and the actual preliminary census population count of 69,656 falls well within this margin," he stated. "If you factor in the 3.2% of households that did not respond to the Census survey for one reason or another, the preliminary population will be slightly higher than the Labour Force Survey 2020 estimated upper band."

An overrun of the first edition of job listing inserts was distributed through the constituency offices of all PACT Members of Parliament.

While the print campaign is ongoing, efforts are also underjobs visible to individuals not registered on the Jobs Cayman portal. However, registration remains mandatory in order to apply for any of the advertised positions.

CAYMAN IMPOSES SANCTIONS ON RUSSIAN INTERESTS

The Cayman Islands has joined the British, American and other governments in slapping financial sanctions on individuals and companies linked to the Russian government in response to ongoing the attack on Ukraine.

The Cayman Island Monetary Authority has published a 'financial sanctions notice' dated 22nd and 24th February in which it currently lists eight persons of Russian nationality and twelve companies originating in Russia.

It advises that compliance with the order requires to "Check whether you maintain any accounts or hold any funds or economic resources" for the persons set out in the notice.

There's also a requirement to "freeze any such accounts and other funds or economic resources" and to "refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Governor"

According to the CIMA failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

This comes as the British government has unleashed a series of economic sanctions on the Russian government and financial constraints on businesses and persons close to the government of Russian President Vladimir Putin.

In its notice, the CIMA says it acting on notice it has received from the British government's Office of Financial Sanctions Implementation, HM Treasury.

Under Cayman Islands law, the Governor of the Cayman Islands is the competent authority for the implementation of financial sanctions in the Cayman Islands.

The Governor can however delegate authority to the Financial Reporting Authority(FRA) "for carrying out certain functions with respect to the implementation of targeted financial sanctions for terrorism, terrorist financing, proliferation and proliferation financing in the Cayman Islands."

While there is no indication of the amount of money or value of assets involved, the UK Overseas Territories along with London - and especially the UK's Financial District - have been extensively referred to by British MPs and in press reports as locations where Russian oligarchs have been investing or otherwise parking their wealth.

British Prime Minister Boris Johnson has unveiled what he called "largest set of sanctions ever imposed anywhere by the UK government" - targeting individuals including the Russian president and several of his wealthy supporters as well as their companies and freezing their assets.

He said more than 100 businesses and individuals will be tackled in total, including "all the major manufacturers that support Putin's war machine".

Further measures are expected in the coming days as the Russian attack on Ukraine intensifies in what the British, US European and other western governments have called an unprovoked and barbarous attack by the Russian government on Ukraine

There are also plans by the UK government to introduce legislation to restrict how much money Russian nationals can deposit and hold in UK bank accounts.

Blocking Russia from access to the SWIFT international banking transaction system is also being considered but needs the agreement of other governments.

The government will also ban all major Russian companies from raising finance on U.K. markets and prevent the Russian government from raising sovereign debt on the financial UK markets.

Mr Johnson has called the current crisis "a defining moment in European history, with global implications."

Despite weeks of denying that he planned to invade Ukraine Russian leader Vladimir Putin launched a vicious attack on Ukraine this week.

He later claimed that it was in defence of Russian-backed separatist regions in the



east of the country which he alleges have been under siege by the Ukrainian army.

Mr Putin has also been insisting that Ukraine should not be allowed to join the NATO (North Atlantic Treaty Organisation) defence and cooperation pact.

The NATO members countries have repeatedly stated that any such membership is not pending. But they have insisted that it is Ukraine's sovereign right as an independent country to seek such membership, and up to the NATO members to accept or decline.

The British, US, EU and other governments have condemned both the attack and the claims by the Russian leader, accusing him of executing a long-planned campaign to force Ukraine back under Russian influence.

With ominous threats coming from the Russian leader directed at countries backing Ukraine, it's feared that the already worsening military crisis could further escalate with potentially devastating global repercussions.





A group of Year 13 young people from Cayman Prep & High School spent a couple of extremely valuable hours down at the D Dalmaine Ebanks boxing gym, learning the art of Self Defense. Head of Year 12, Dan Baker, said, "Wen we were looking for feedback in which we could improve our pastoral care, a student in my form suggested we did self-defense, so I got in touch with the boxing club and we decided on organizing a sessions for the Year 12s and Year 13s. A lot of our students are going into the big wide world of universities in Britain, Canada and the US, so we feel that we want to kind of give them the skills of self-defense just in case they do get into kind of trouble in the future. We want to empower them and make sure that they have the confidence to deal with any such situation because otherwise we're doing them a little bit of a disservice."

Jasmine lambert-Wragg, 18, said, "I came here to learn something for when I leave for university because England is a completely different place from Cayman, and I know there's a lot more street violence that goes on compared to here. I just wanted to learn something useful, so that if someone would attack me, I would know how to defend myself so that I could get away and alert the authorities. I learned how to diffuse a situation before I got injured. If a person attacked me I can say, 'Back off!' and I can get in a 'ready' position. If they go to harm me I could push them away with a palm strike or a quick jab, and then just run."

Troy Oneil helped facilitate the session. "I took them through 'proper stance' which is pretty-much a boxing stance, with legs apart, strongest leg at the back, and hands up when you're talking, not up in an aggressive way, more in an assertive way. If anything happens from here, I am all

ready to block, defend, or punch, all that stuff. I also took them through trying to avoid confrontations which means don't be too aggressive, don't escalate a fight but also don't be too passive either. For example, if you bump into someone and they say, 'Hey you spilled my beer!' Then you can respond, 'it's alright, calm down, can I buy you a next one?' then, If that doesn't work you get more assertive and

say, "Listen, I think you've had too much to drink. Now back off - you're in my space." If they're still coming, then you have to do whatever you have to do to defend yourself. I also showed them some simple knife blocks too, because there are a lot of knifefights happening now."

Kayla Parsons, 18, said, "I came here to learn some self-defense for the reason we just don't know what's going to happen

in life and it's good to know how to defend yourself in the outside world. I really learned how to keep an attacker off me and how to defend myself, not to be the attacker, but to be the defender of yourself, and really to just keep away anyone who is trying to cause major harm to you like knife attacks and physical assault and anybody that comes up from behind, how to break free from them."
