## Success for hospitality careers fair

The long line of Caymanians and residents waiting to register outside the Ritz-Carlton Ballroom showed just how keen they are to get jobs in the Ritz-Carlton, Kimpton Seafire or Hampton by Hilton, the three hotels under Dart's portfolio. Now that covid restrictions are being lifted and the big airlines have resumed regular flights, demand at Cayman's top three hotels is taking off, and that means that they quickly need plenty of new, high-caliber staff.

than 80 different job titles representing well over 100 new jobs. "I'm looking for a job in retail," said Pamela, one of the applicants. "I have never worked in a hotel before." Lots of those who were applying were looking for a career-change.

Dart's President of Business Development, Jackie Doak said, "The turnout today

has really exceeded our expectations. The tourism industry and hospitality particularly have always had about a 30 percent Caymanian employment rate, but now it's time for the country and the hospitality companies and restaurants, to really start demonstrating the value of a career in tourism. It's a blessing that we are seeing such high levels of guests who want to come back to the Cayman Islands, but on

the other side we don't have the labor pool to welcome them all back, so we're constrained in the amount of guests that we can take, so are working very well with the ministers of labor and tourism in terms of how to get the labor pool to the level it needs to be, and also to get Caymanians engaged in the hospitality industry, and raise those percentages."

Deputy Premier Chris Saunders said, "At the end of the day once Caymanian people are able and willing to work they should be given the first opportunity. This confirms the government's position, that we know there are many people out there that are able to work and looking for work, and we want to give them an opportunity. Businesses need to demonstrate that they are willing to give Caymanians an opportunity. A work permit is a privilege, it is not a right, and they need to understand that as in any other country, the local population has to be given first opportunity."

General Manager for the Kimpton, Steven Andre talked about the kinds of people he was looking for. "Now that the island has opened up a little bit more and we are seeing the last of the major airline carriers coming back this month, we are looking for all the right people to help us continue. I think that The Seafire has established itself as a place with great customer service, so we want to find people who fit into that type of environment – they want to be high energy, customer-centric, they want to have a great relationship with their coworkers and help us achieve our goals."

Ritz Carlton General Manager Marc Langevin said, "I am very excited today. When we put our job fair together I was not confident on how many people would come, because we have done many job fairs over the last year or so, and not always having had the same success. Today it's a very different environment, our hotels are open therefore this will create more opportunity."

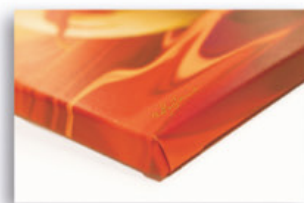

# Cayman welcomes back Delta Airlines

Premier Hon Wayne Panton, Deputy Premier Hon Chris Saunders, and Tourism Minister Hon Kenneth Bryan all came to give the passengers stepping off the big Delta Airlines plane a warm Cayman welcome, after the traditional two-water cannon salute, at Owen Roberts International Airport on Saturday 5 March. It's only been a couple of weeks since United and American Airlines were welcomed back to Cayman, and happened on the same day as a huge tourism jobs fair was held at the Ritz Carlton. It all spelled out that Cayman's tourism is not only back-and-running, but beginning a shift into a higher gear.

Marva Reid, Delta's Operations Service Manager for Grand Cayman said, "Today is the inaugural flight back to Grand Cayman after two years so we're very excited. From March till June we will be doing two flights a week, on Saturdays and Sundays. After June we will be doing daily flights, and of course when the winter season kicks in we will be offering many more flights pretty-much back to our regular schedule. Today the flight is coming in from Atlanta, Georgia, but we also offer services from Minneapolis and Detroit, plus there are occasional flights during the season from JFK. We are absolutely ecstatic to be back in Cayman today. It's important for our economy to have our visitors come in and turn back to a place

which they have enjoyed for many years," she said.

"I'd just like to say thank you guys for coming out and welcome Delta back it's been a long time coming we're certainly glad to be back," said Delta's Country Manager, Kevin Bolen. "We've always played an important part of the local community, and it's good to be back serving this community."

Tourism Minister, Hon Kenneth Bryan said, "Again this is another step in getting back to normal. I just had a wonderful story with a lady who was so excited to be back. She said when she first came to the Cayman Islands her husband proposed to her on the beach, and four days later they got married. And she's got a tattoo with

a Sir Turtle on her leg, just to show her commitment to the Cayman Islands. People really love the product, as a people as a country in respect to our environment and what we stand for, so I am so excited that we are really able to offer that product again.

We are just excited as the PACT administration to get our environment loose enough that we can have a productive tourism product. And I think that we are going to have to go down the road of loosening it more and more as we get safer and more comfortable with living with covid. The numbers (of new infections) are going down, which gives us the comfort of being able to move forward."

## Statement from HE the Governor on strong Caribbean support for the UN General Assembly resolution regarding Ukraine

On 2 March 141 Countries voted in the United Nations deploring Russia's invasion of Ukraine and calling for an immediate withdrawal of Forces. Within our region, Cuba abstained but every other Caribbean country voted to deplore Russian aggression. Only 5 countries voted against (Russia, Belarus, North Korea, Eritrea and Syria).

First time in 40 years the 'Security Council' has referred a crisis to the Assembly and only the 11th time an emergency session of the UN General Assembly has been called since 1950. The initial General Assembly resolution was co-sponsored by our Caribbean neighbours: Antigua and Barbuda, Bahamas, Belize, Dominican Republic, Grenada, Guyana, Haiti, Jamaica, Saint Kitts and Nevis and Trinidad and Tobago.

The situation in Ukraine is deeply worrying. As families shelter from rocket attacks, and

paratroopers drop on a Ukrainian city, and Tank columns are on the move, the number of refugees seem to be in the region of well over 1 million.

From our perspective in the Caribbean, it is worth acknowledging there were disturbing reports that suggested those with African or South Asian heritage or ethnicity were being discriminated against at the border. The UK Government - and others in this region - have received absolute assurances from the Ukrainian Government that this is not sanctioned and will not be tolerated, and that all will be treated equally.

The UK and all of us in Cayman support the Ukrainian people's right to choose their own destiny.

The UK has launched the largest package of sanctions in the UK's history - sanctions that we in Cayman have already brought into force. Cayman is supporting the international effort to cut

off funding for President Putin's war including banning aircrafts owned or operated by a person connected with Russia, or registered in Russia.

The Kremlin's unprovoked aggression has led the Russian people into a quagmire and, as demonstrated today, turned Russia into an international pariah. The world community now stands against them and in solidarity with Ukraine. The Russian government's attempt to conquer an independent state by force of arms, is an attack on the security and freedom of Europe but it goes far wider than that. It's an attack against the international order and its impacts, particularly if President Putin were to prevail, will be felt globally should dictators, and those who see themselves as the 'strong' set against weak neighbours, believe they can act with impunity.

We can all be proud of the Ukrainians who are resisting.

# Natalie Urquhart Honoured for Arts, Culture Contributions

National Gallery Director and Chief Curator, Mrs. Natalie Urquhart's outstanding contributions to arts and culture "in the Cayman Islands and the wider region" over more than 20 years have distinguished her as an extraordinary achiever in her field.

In recognition of her record, Her Majesty the Queen conferred on Mrs. Urquhart a British Empire Medal (BEM) in the 2022 New Year Honours.

Mrs. Urquhart thinks, feels, talks and writes about arts, culture and heritage, especially, with a passion that has characterised most of her years in the Cayman Islands' workplace.

She also excels in strategic planning, organisational leadership and revitalisation; and as the first professionally trained Caymanian art curator, has authored books, papers and articles, and led curatorial projects that have helped expand opportunities for arts and culture engagement in the community.

Mrs. Urquhart has the distinction of advising governments, organisations and bodies within the Cayman Islands, the Caribbean region, as well as international entities such as the United Nations Educational, Scientific and Cultural Organization (UNESCO) and the International Council of Museums (ICOM). She has firmly se-

cured the Cayman Islands' presence and leadership on a number of international cultural initiatives and organisations.

In fact, as the first Caymanian President of the Museums Association of the Caribbean (MAC) from 2017-2020 and present MAC board member, Mrs. Urquhart continues to strengthen links among Caribbean museums and heritage organisations, by fostering and promoting closer collaborations, training and networking opportunities amongst cultural and heritage sector professionals.

Notable among her myriad publications is her book titled *Art of the Cayman Islands*, a definitive tome, and the first formal outline, of local art history. Based on her curatorial research, the book examines the confluence of tradition, cultural heritage and collective memory that has impacted local contemporary art and artistic practice.

More importantly, the spin-off from the book was a series of exhibitions including *21st Century Cayman* (2010), *The Persistence of Memory* (2011), *Tidal Shift* (2015), *REVIVE - Contemporary Caymanian Craft* (2016); *Cross Currents* (2019), *Island of Women* (2020) and *Reimagined Futures* (2021).

Equally impressively, Mrs. Urquhart is the founder/creative director of Cay-

man Art Week, a project created in 2021 to help offset the impact of the pandemic on the creative sector and to create a platform through which to promote the art sector. The initiative aims to generate greater interest in local art, to stimulate more purchasing of local art and thereby enhance local artists earning capability.

Yet, for all her accomplishments including her double masters' degrees and an already impressive collection of awards, she remains down-to-earth, congenial personality and above all, humble.

Awards she has garnered include the Cayman Literary Award (2017); Cayman Islands Top Employer Award Winner (team leader) (2011, 2014, 2015 & 2016); and National Young Caymanian Leadership Award Recipient (2011). Additionally, she has been honoured with a number of National Arts and Culture Awards including Heritage Cross (2016); Star for Creativity (2010); and now in 2022, Gold Star for Creativity; Star for Creativity Certificate (for Cayman Art Week - her brainchild); and another Star for Creativity Certificate with the gallery staff for their digital programming initiative.

Mrs. Urquhart continues to provide her expertise as she has done over the years, on a number of voluntary boards and working committees, whether local, in the Caribbean, the Americas or the wider world. She believes strongly that culture can enrich lives as well as providing a critical platform through which to find shared values and social cohesion.

Commenting on the New Year's honours, she says with customary simplicity: "It's a true honour to receive this award and I am grateful and humbled by the recognition. I'm very fortunate to do work that I love alongside creative people who inspire me, and would like to extend my deepest thanks for their encouragement and support over many years. This award is also extremely motivating and will certainly inspire my work moving forward."

She also singles out her family and husband Mr. Alexander Urquhart along with the National Gallery team for their unwavering support. Her advice to young persons in the Cayman Islands is to "try and seek a career that you are passionate about and to be curious and open-minded in your work. Set your goals and believe in them and never let your failures stop you from moving forward."

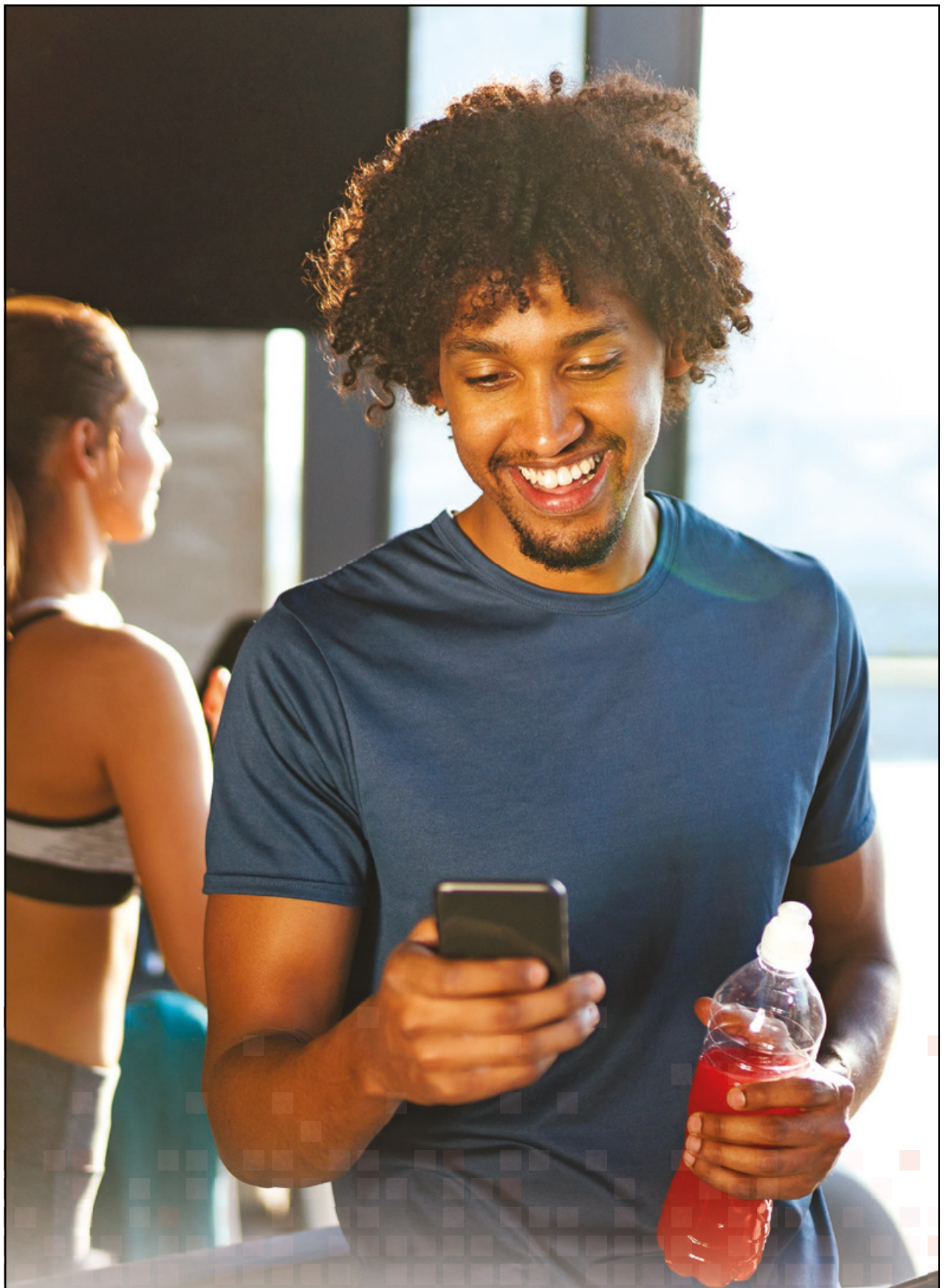

# Cayman LGBTQ Foundation President qualifies as a CPO

On the 28 September 2020, Cayman's Civil Partnership Law 2020 came into effect, a ground-breaking piece of legislation that enables same sex couples to form a civil partnership, thereby offering them the same rights under the law as an opposite sex couple, especially when it comes to the rights of children within the partnership. In order to effect same sex partnerships, a Civil Partnership Officer (CPO) must legally preside over the partnership, so Noel Cayasso-Smith, Founder and President of Cayman LGBTQ Foundation, has undertaken a training course and is now a qualified CPO.

Mr Cayasso-Smith was pleased that he is now enabled to bring same sex couples together, effectively in marriage.

"I am delighted to be able to offer same sex couples the chance to live together in a legally recognised civil partnership, which is so needed here in the Cayman Islands,"

he advised. "For too long now, the needs of the LGBTQ+ community in this area have been ignored and overlooked, so it is with great pride and pleasure that I can now legally unite same sex couples in love and unity in this way."

Mr Cayasso-Smith added that while he was excited to be able to provide this service to the local community, this was also a highly sought-after service by visitors who comes to the Cayman Islands in order to get married.

"Our LGBTQ+ visitors may now join together in civil partnership in our beautiful Cayman Islands just as any opposite sex couple has been able to enjoy for so long. I am very much looking forward to offering our visitors the chance to unite in this idyllic wedding destination," he said.

The mother of five was further celebrated with a birthday party, receiving a message from The Queen. Applied for by her loving family, the message now takes pride of place in the centenarian's home.

The framed and signed birthday greetings from Her Majesty were delivered by His Excellency, the Governor Martyn Roper at George Town Yacht Club on Saturday, 26 February. Festivities included a special cake, food, decorations, a surprise guest appearance by Aunt Sookie and Zekiel - who did a skit in her honour - and music from the Swanky Kitchen Band. Premier, Hon. Wayne Panton attended, as did Ms Vi's grandniece, Minister for Education, District Administration and Lands, Hon. Juliana O'Connor-Connolly, who gave the closing prayer.

Surrounded by friends and family members, including many of her 13 grandchildren and 15 great grandchildren, the former seamstress was in her element, according to granddaughter Raquel Parsons. Married to her husband the late Lester Brown for 58 years, Ms Vi took to being the centre of attention in her stride, with a hug and a word for everyone.

"Given that my grandmother is very lively, has a great sense of humour and used to love cooking and entertaining in her younger days, she really enjoyed the weekend's events, Ms Parsons added.

"She's a people person who says serving in her parents' mercantile shop in the Brac during her teens made her sociable.

"She's a living family tree who, when she is on form, likes nothing better than company who she'll regale with old stories, discuss politics and explain who is related

to whom," daughter Mrs. Darlee Ebanks noted.

When asked to what she attributes her longevity, Ms Vi says to "eat sparingly, don't drink and smoke, work hard and serve God."

Originally from Watering Place, Cayman Brac, the centenarian was born in the same month that the British granted independence to Egypt, and the same year that the tomb of Tutankhamun was discovered in the Valley of the Kings.

Just 10 years old when the Storm of '32 ravaged the Brac, Ms Vi vividly remembers the worst hurricane in Caymanian history. When asked how she was at her celebrations, the 100-year old and last surviving Mary and Eli Scott's 12 children said: I'm old but I'm not cold."

"Ms Vi represents a generation of Caymanians who were self-reliant and were very resilient in the face of real hardships. They were hardworking, god-fearing people who had a strong sense of identity and a love of kin," said Minister for Youth, Sports, Culture & Heritage, Hon. Bernie Bush.

"As a matriarch, she represents all the qualities that we most admire in our culture. I wish her a very happy belated birthday," he added.

When not celebrating landmark birthdays, the super senior likes nothing more than singing along to her Christian music channels, listening to the radio and watching Hallmark movies. Although a little arthritic, she also enjoys popping bubble wrap. "It's her version of Candy Crush," her granddaughter mused.

Though she spends more time at home in recent years, Ms Vi still attends church when able to. Ms Vi looks forward to spending more time with her grandchildren and great-grandchildren, including her three-month-old great-grandson Caleb.

# UK OVERSEAS TERRITORIES AT CENTRE OF RUSSIA SANCTIONS

As global economic pressure is ramped up against Russia for its ongoing war on Ukraine, Cayman and other British Overseas Territories are increasingly on the global front line - both figuratively and literally.

The imposition of sanctions in the OTs against Russia has come via directives from the British government as the administering authority.

“UK Government policy is for any UK sanctions to be given effect in the OTs,” an official document explains.

The objective is to strangle the Russian economy and to deny wealthy Russian oligarchs access to their funds and assets held in the OTs financial centres.

The British Foreign Secretary, Liz Truss, said that the UK Government was “working closely” with the Territories to implement the new sanctions.

British government documents point out that “the value and number of Russian assets in the OTs is unknown, as are those liable to be sanctioned”.

However, while the exact value of the targeted wealth is uncertain, it’s believed to run into billions of dollars.

The documents refer to estimates by leading organisations including Transparency International which has linked over £830 million (over US\$ 1 billion) worth of property in the UK’s OTs and Crown Dependencies to individuals close to Russian President Vladimir Putin or Russians accused of corruption.



Among the assets being targeted are financial instruments, real estate, luxury yachts and planes registered in the islands including Bermuda, the British Virgin Islands, Isle of Man and the Cayman Islands.

In 2020, in a report on Russian money in the United States, the Atlantic Council said that “traditionally” money has first left Russia via Cyprus, then “typically” is moved to the British Virgin Islands and the Cayman Islands, before being moved finally to the US and UK.

Already in the OTs, the respective governments and agencies have confirmed the sanctions are being applied.

The Cayman Islands Monetary Authority(CIMA) has published a list of persons

and companies which are being sanctioned with a stipulation reminding firms that act on their clients’ behalf of their obligation to comply with the measures.

In Bermuda, one of the largest global re-insurance centres with numerous yachts and planes on its register linked to Russian entities, the government has confirmed it will implement the sanctions. It says this is likely to “greatly impact” around 740 aircraft registered in the country that are used by Russian operators.

In the British Virgin Islands, Governor John Rankin confirmed: “The UK has introduced the largest and most severe package of sanctions ever imposed on Russia.

Those sanctions will also be applied in the BVI, cutting off access by Putin and the Russian banks to international finances.”

He also advised that “all aircraft owned, operated or chartered by a person connected with Russia or registered in Russia is banned from flying in the air space of the Virgin Islands.”

The OTs are concerned about the local economic impact of the conflict especially now that they are just emerging from the slowdown caused by the COVID-19 pandemic. Rising energy prices and their ripple effect is a major worry for the import-dependent islands.

Assessing the situation, the Premier of the Turks and Caicos Islands, Charles Washington Missick, said: “The Government anticipates that these Islands will no doubt be impacted by the rising energy prices which can have a trickle-down effect on the prices of food, commodities, goods and services.

Mr Missick who is the current lead Premier in the UK Overseas Territories Association(UKOTA) added that his government is looking into alleviating the impact on businesses and residents.

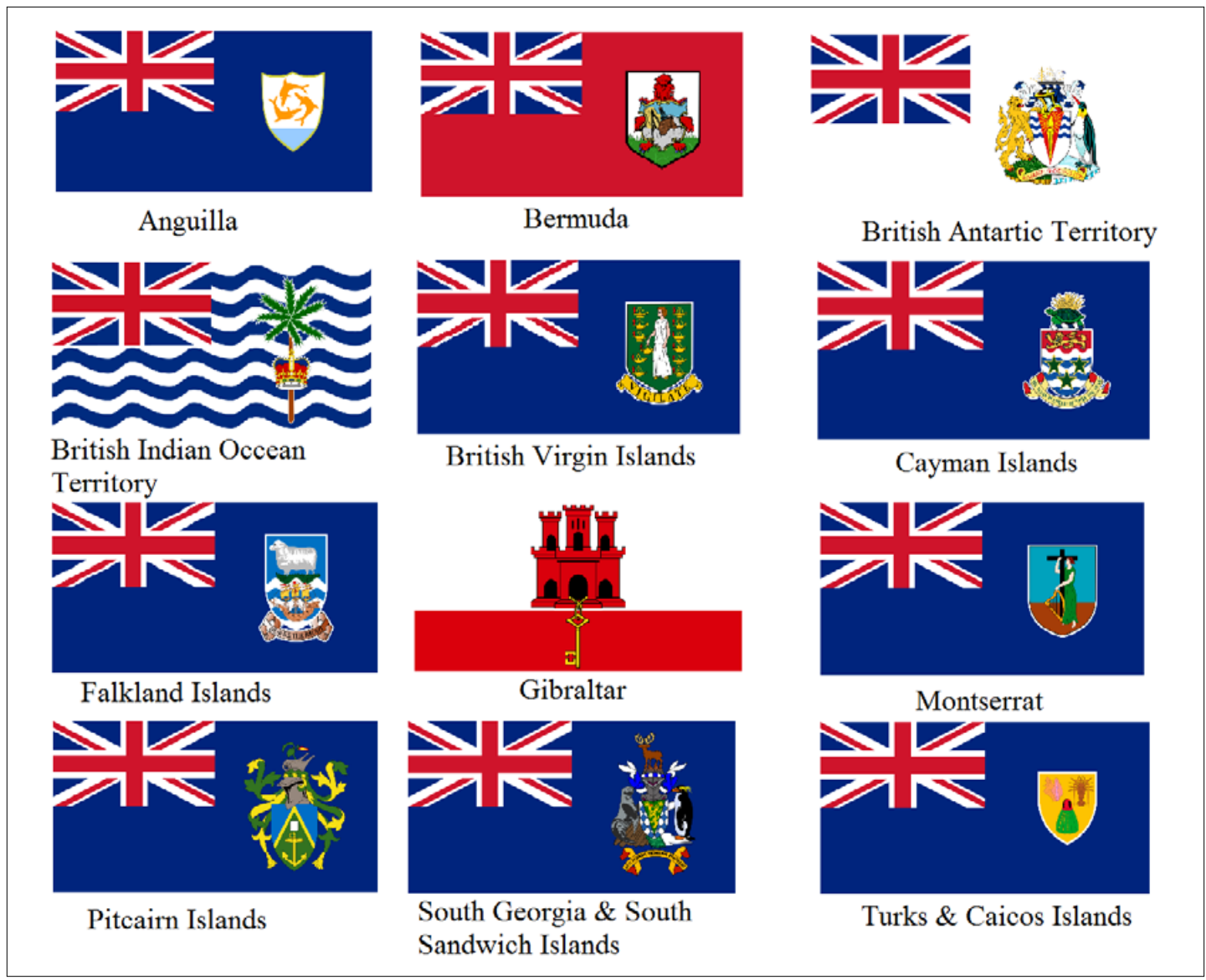
“The Government is deeply concerned about this turn of events and in response will need to intervene to lessen the negative impacts on residents of the TCI. Measures to ameliorate the burdens of households and small businesses in this environment are being considered.”

Cayman Islands Premier Wayne Panton is also concerned about the economic fallout from the conflict.

“This war presents a threat to the global economy, which is already reeling from its attempts to recover from the COVID-19 pandemic,” Mr Panton said. “Here in the Cayman Islands we will almost certainly see higher fuel prices, which will in turn impact the prices on all goods and services, and therefore the general cost of living.”

In making a plea for an end to the conflict, Mr Panton said: “Instead of war, the Cayman Islands would prefer an urgent peaceful end to this situation.”

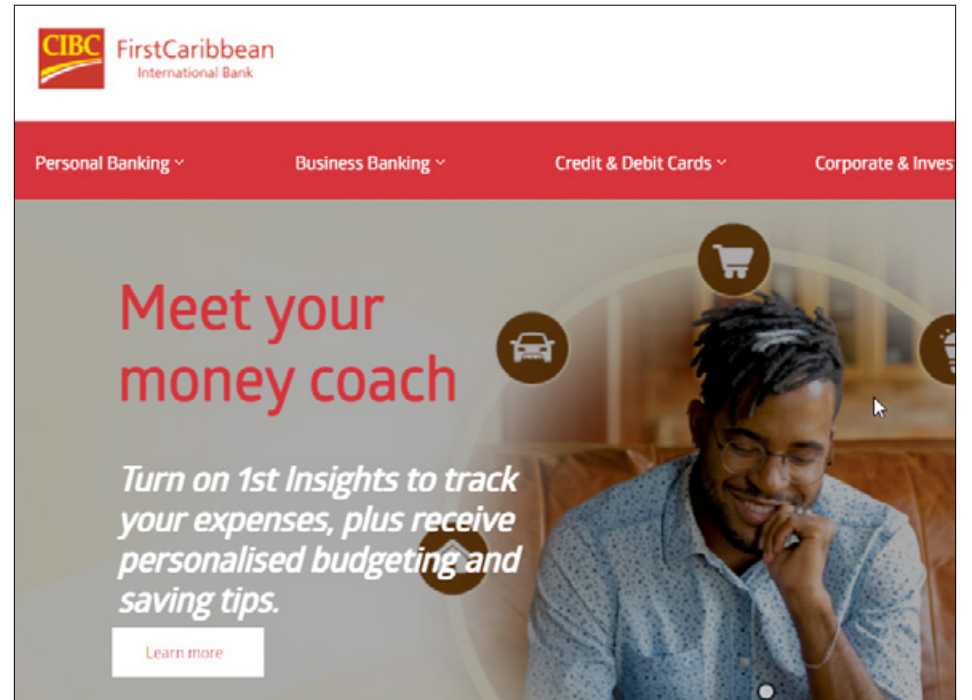

# Cayman Islands Red Cross launches Ukraine Crisis Appeal

The Cayman Islands Red Cross (CIRC) is launching an appeal to support the residents of Ukraine who are being impacted by the intensification of fighting in that country.

"Wars and war-zones create challenges that are different from those posed by other disasters, especially those with which we are familiar like hurricanes and earthquakes" explains CIRC Director, Jondo Obi. "The Red Cross Movement was born out of such conflicts, and as such our global structure is one that is able to support short, medium and long term humanitarian efforts in areas impacted by these types of disasters, as is Ukraine now."

The CIRC appeal will assist the global Ukraine Crisis Appeal launched by the International Federation of the Red Cross

(IFRC) and backed by the British Red Cross (BRC). The appeal will support the work of the Ukrainian Red Cross who is working on the ground with direct assistance from the International Committee of the Red Cross (ICRC), the arm of the Red Cross Movement tasked exclusively with protecting the lives and dignity of victims of armed conflicts and situations of violence. The appeal will also support the National Societies in neighbouring countries, such as Romania, Hungary and Poland, as they work to assist the 874,000+ persons who have fled Ukraine over the last six days.

Funds raised in this appeal will, among other things:

- Support families with food, shelter, first aid, medicine
- Support the work of reuniting separated families



- Support hospitals and healthcare facilities
- Repair vital infrastructure
- Help to repair homes, healthcare centres, schools and community centres in the long term

The ICRC will also be responsible for performing other duties, such as ensuring that dead bod-

ies are treated with dignity and increasing awareness about areas contaminated by unexploded ordnance. Unexploded ordnance is ammunition which has been fired, but has not functioned as designed and can be particularly dangerous as all the normal safety features have been disabled. This includes items like

hand grenades and missiles that failed to explode when intended but that can easily be triggered by mere touching or handling, such as that of a child who discovers it.

The Red Cross Movement has already mobilised thousands of staff and volunteers who are already providing life-saving assistance such as shelter, basic aid items, medical supplies, as well as mental health and psychosocial support.

## COVID-19 Vaccination Policy Statement from Interim Chief Medical Officer Dr Autilia Newton

Vaccination against COVID-19 remains our best tool to protect our residents from severe disease and death.

The best available real-world data on the protective effects of vaccine show extremely clear benefits for standardised vaccination regimes, **including boosters**, and that these protective effects are applicable to multiple variants of the virus. To date, none of the studies from which these data are derived allow for modification of vaccination regimes based on the results of antibody tests carried out at individual level.

Allowing the results of antibody testing to prescribe the need for vaccination, including booster, for any given individual, would go against best practice and evidence.

In the Cayman Islands, the Government is determined to follow recommendations based on best practice and evidence. As such it believes that the best and most effective way to protect the health of all residents, is through vacci-

nation, including the booster, regardless of immunity status, as may be described by any existing antibody testing at the individual level.

We therefore strongly encourage Caymanians and residents to take up the offer of vaccination, including the booster, through the booster and children (ages 5 to 11) vaccination campaigns currently being run across our islands.

## One new death but positive numbers nose-dive

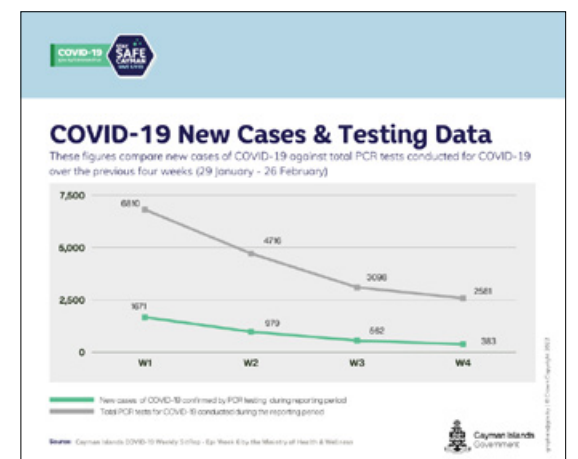
Just released information from the Ministry of Health and Wellness show that Cayman saw one more death due to Covid-19 in an unvaccinated person during the last week of February. This brings the toll of Covid-related deaths to 18 in the Cayman Islands since the beginning of the pandemic in March 2020.

During that same week there were 383 new cases reported by Public Health, a drop of 169 cases since the previous week of 13 to 19 February. As at the end of February, positive Covid-19 cases had declined by 77 percent over the previous four weeks.

Officials noted that 2,581 tests were conducted in the last week of February, compared to 3,098 tested the week before and 4,716 tests the week before that.

During the last week of February there were 17 hospital in-patients going through the George Town hospital and Health City.

The most recent figures released by Public Health indicate a continuation of



the downward trend of positive cases, with 41 being reported as of 1 March and 23 reported as of 2 March.

There are 774 estimated active cases of Covid in the Cayman Islands. Nine patients are currently hospitalised for Covid-related causes and of these, one is partially vaccinated and five are unvaccinated.

The Sister Islands also noted nine new cases since the last report, bringing total cases here since the beginning of the pandemic to 567.

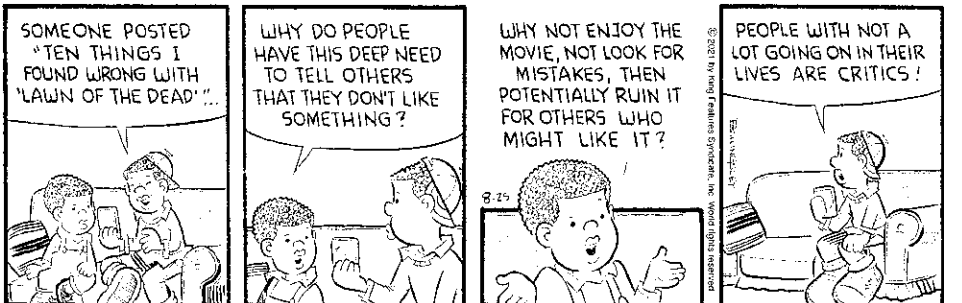

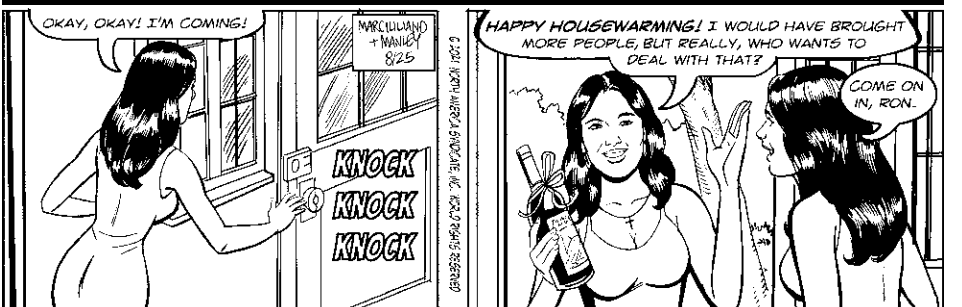
