

My view of you used to be a tourist's view. The view of an outsider looking in.

As a child, I swam on your world-renowned beaches. Walked your commercial strip that stretches all the way down seven-mile beach.

I ate dinner at all your fancy restaurants on the waterfront. I slept in the Westin where every single guest was an American.

When people asked me what I did over Christmas break, I would say I went down to the Cayman Islands and "had the best time". I wouldn't explain further, and wouldn't explain that I didn't just go for a cute little beach trip. I went to visit my family. And yes, I did stay at the Westin hotel and spend my days pretending to tan at the beach.

But, come December 25th, I went into the heart of West Bay; to where the hotels faded away. To where there are churches, primary schools and the typical one-story colorful houses. To where the ackee trees grow. I went there and I saw my dozens of aunts and uncles, and if I was lucky 10 or maybe more of my 25 first cousins. I went to West Bay and didn't eat fancy lobster from a waterfront hotel, but instead my grandmother's macaroni pudding. I ate curry chicken with rice and beans catered from Welly's Cool Spot, a hole-wall restaurant where the Jamaican men hang out and play dominoes from dawn to dusk. I went there and I said grace before Christmas lunch and listened to my mom and aunts gossip about the latest family drama over the sound of soca music.



But, after December 25th, I returned to your hotels. Returned to your commercial strip and bought souvenirs from Tortuga Rum Factory to bring home to my friends. I returned home and told my friends about only what I deemed the best part of my trip; the swimming in the crystal clear ocean and the hammocks in the cool breeze.

This summer, I got to experience you not through a hotel. Not the way a tourist does. I spent my whole summer with you. Living in a condo in West Bay Road, working at a preschool, and grocery shopping at Fosters Food Fair on Saturday afternoons. I came to realize that when you live on the islands you don't have time for the beach because you're too busy living in the real world. Although it is sunny almost everyday and it feels amazing to

be in your fresh air, the sound of bulldozers doing construction on the seemingly train of never needing hotel chains takes away from your beauty. I realized that even though July and August are the months when sea turtles come to shore to lay their eggs, many of them don't come anymore because the lights from your waterfront restaurants shine too bright and scare them away. I realize that while your lack of taxes is amazing on a two-week vacation where you want to order piña coladas on a daily basis, it is not amazing when you need to pay rent. I realized that your commercial strip is causing erosion on the beach and taking away from locals access to public beaches. I realized that although my little cousins were born and raised in

Cayman, they have far less access to your beauty than any American tourist would.

I used to only see your beauty, but since living with you I see your flaws. But, your flaws made me realize that part of your beauty lies within your problems. You have your issues, but they can be fixed. Although tourism is what runs your money and your industries, you have no balance or boundaries. Tourism is king and at the expense of all the people that call you home. You need to find your balance once again, and return your island to your locals. You cannot have people like me, who before living and working on an island, thought your only charm lay within your hotels and fancy restaurants. Your attraction is your natural beauty. Return it to those who deserve it.



Cox Lumber unveils rebar-bending marvel-machine

Hurricane-Proof Cayman is made of concrete and steel. Now Cox Lumber has brought a state-of-the-art computers and an impressive new machine to help in bending steel rebar to any specification required in a building's plans, cutting onsite construction times by up to half.

The huge new bright orange machine, housed in the Cox Lumber Center off Sparky's Drive in George Town, takes the big rolls of rebar, bending Rebar of sizes 3,4,5, and 6 to any configuration in a matter of seconds. What is even better is that Cox Lumber is able to take the final plans for a project, and their computer will work out exactly how much rebar is needed, where it will go, and how it will be bent.

"This machine because it will be a game changer for Grand Cayman," said Joe Shetler, Senior Vice President of Cox Lumber, "it will allow anybody to go into a project knowing the exact cost for their

project, and get it done quickly with engineered drawings that have been approved by the Planning Department."

"Our old machine could only do hoops and stirrups, that is, circles or squares, and then only with the smaller size 3 and 4 rebars, whereas this new machine is able to bend sizes 3 to 6, (up to about ¾ of an inch) which accounts for about 95 percent of residential construction, and around 65 percent of larger project construction."

Bending rebar onsite is time consuming and difficult, especially for the smaller residential builder who doesn't have access to the expensive, specialized machinery needed to do it efficiently, "With this machine, literally in about five seconds you get everything you want made. nobody else on the island can do that," said Cox's George Town Manager, Devin Clark, "They give us their fully detailed plans, and then we make new plans out of it telling where to put the rebar, and how much they need. We do it all for them. I send it to the detailers, and the

detailers put all the rebar together on it, and they send back a whole other statement that tells you how each piece goes, so it is like you are seeing it in 3D."

Marketing Director Dough Dodds said, "Local builders seem to be excited about it, especially about the shorter turnaround times." There is so much demand for the new machine, and the team that makes it all happen, that Cox Lumber has put machine operations on two shifts, with a total of eight workers, to clear the backlog of orders.

But it isn't just residential where this machine will be a huge help. The managers at Cox say that they anticipate it to greatly speed up construction times with some of the larger, high-rise projects which are on the horizon, too. Pointing to all the smaller rebars bent into circles, which hold the long lengths of thicker rebar together for big projects, Mr Shetler said, "This saves about 50 percent of the time onsite. Those (circles of rebar) are coming out every five seconds and there's 41 of those, so we can make all those little hoops in probably less than 2 minutes."

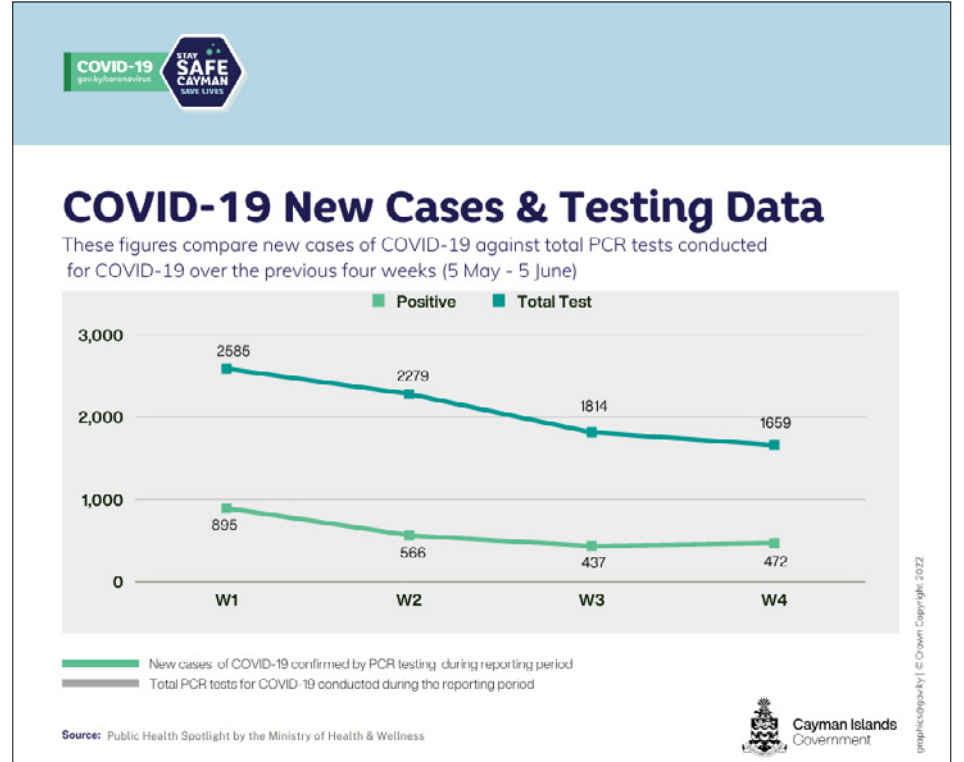
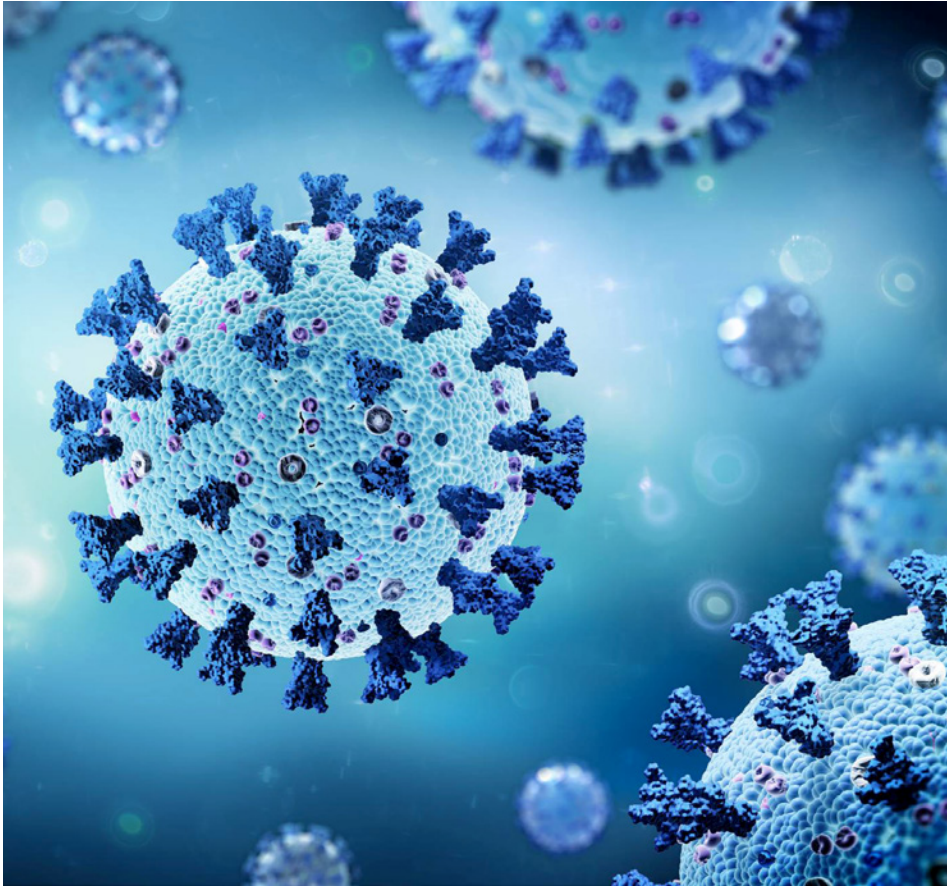

COVID-19 - Epidemiological Week 23

5 -11 June 2022 (Data as of 14-06-2022)



International Situation

Internationally, the number of new cases has continued to decline, with a 12% decrease from the previous reporting week. There has also been a decline globally in deaths, by 22%. The dominant variant circulating globally continues to be the Omicron variant, specifically the BA.2 lineage. However, the Omicron lineages BA.2.12.1, BA.5 and BA.4 are increasing in prevalence.

Cayman Islands Local Trends

All key indicators have increased in Epi Week 23, with a testing delay likely due to the Jubilee long weekend. The case rate has increased from 630 cases per 100,000 population to 681 cases per 100,000 population, with an increase in new cases of 8% (from 437 to 472). The test positivity has increased to 28% from 25%, and the number of PCR tests conducted has fallen by 9% (from 1,814 to

1,659). The spike in cases reported on 7th June most likely reflects a delay in individuals coming forward for testing over the bank holiday weekend.

Vaccination

During Epi. Week 23, a total of 61 children received the paediatric COVID-19 vaccine (26 first dose and 35 second dose), bringing the total of vaccines administered to children over the last two weeks to 114.

Hospital Admissions

Ten new admissions were registered during Epi. Week 23, again an increase on the previous week where seven new admissions were reported. Of the ten new admissions, seven were specifically caused by COVID-19 morbidity, with only three patients detected on screening. A total of 12 patients required inpatient treatment (no change from the previous week).

Key Message

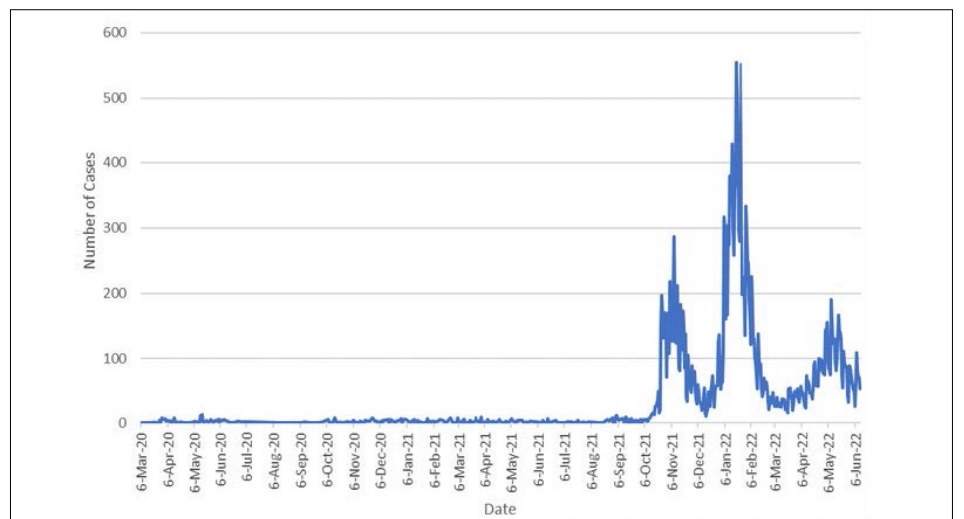
The decline in the current wave of infection has stalled with an uptick across many indicators, including COVID-19 new hospitalisations. Vigilance of preventative measures and continuation of testing is required to ensure community transmission decreases.

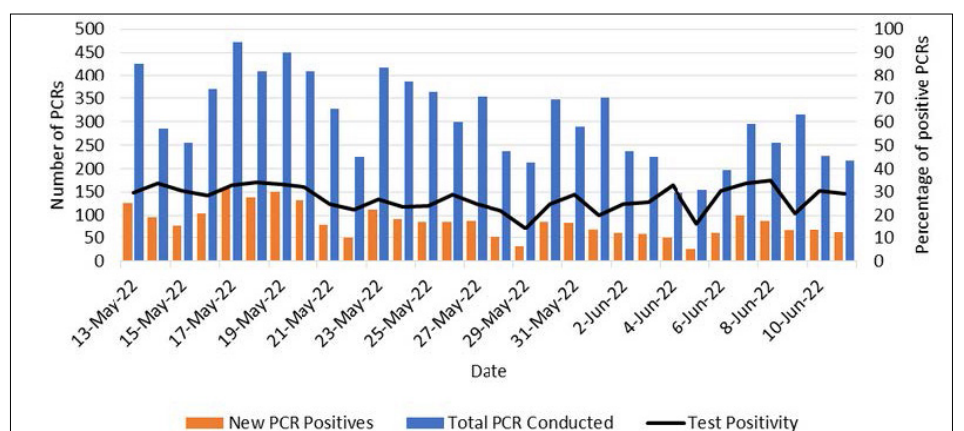
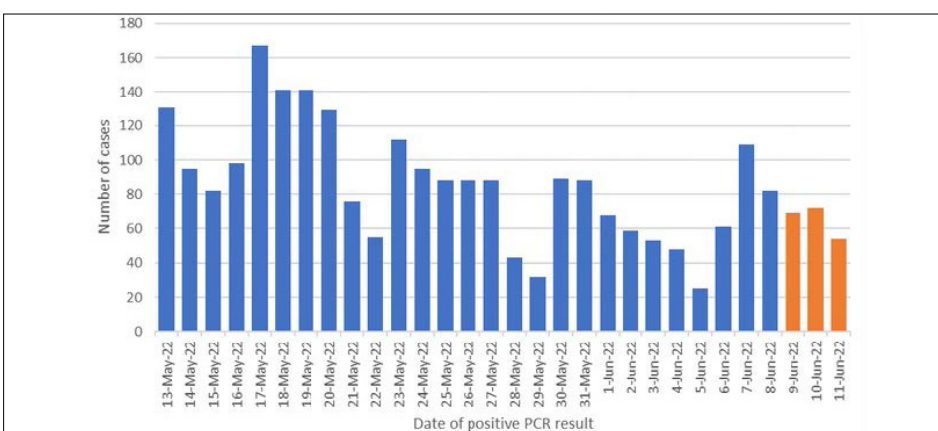

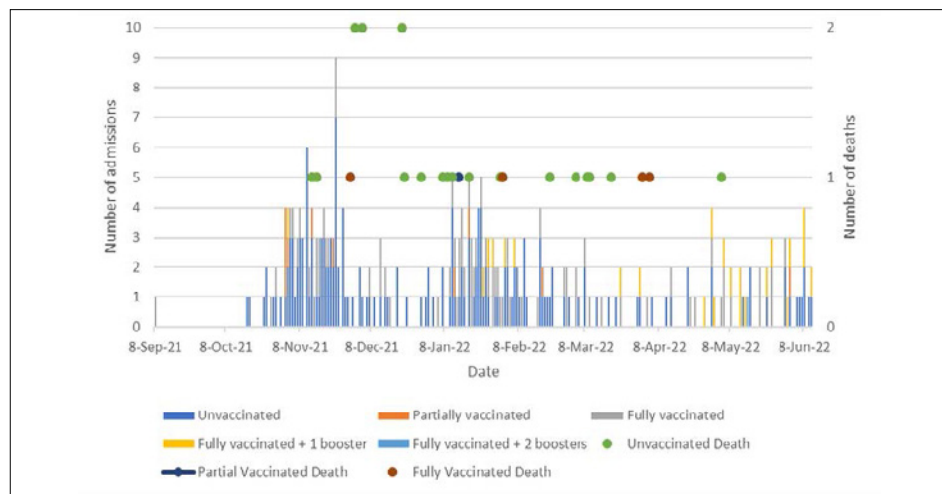
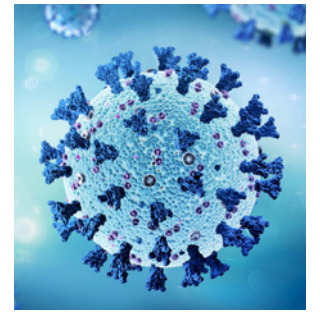

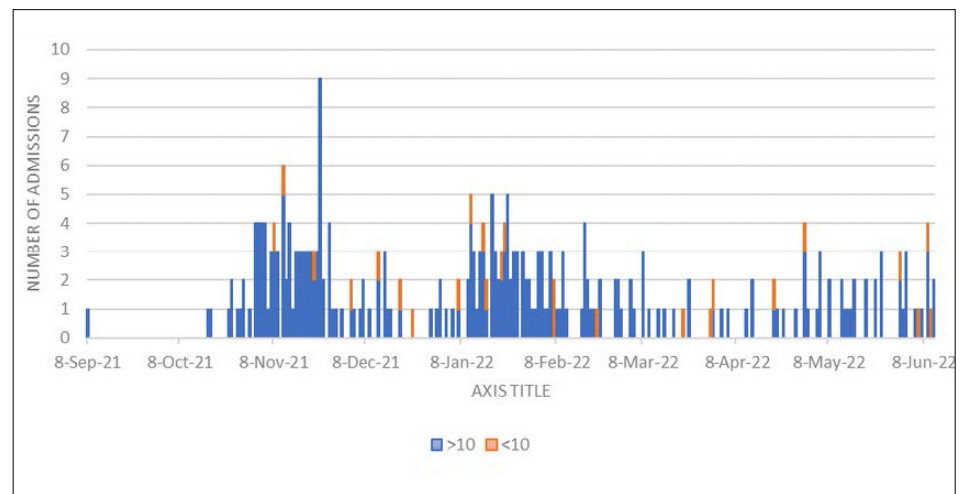

► Vaccine statistics for Paediatric Vaccine and 3rd Doses

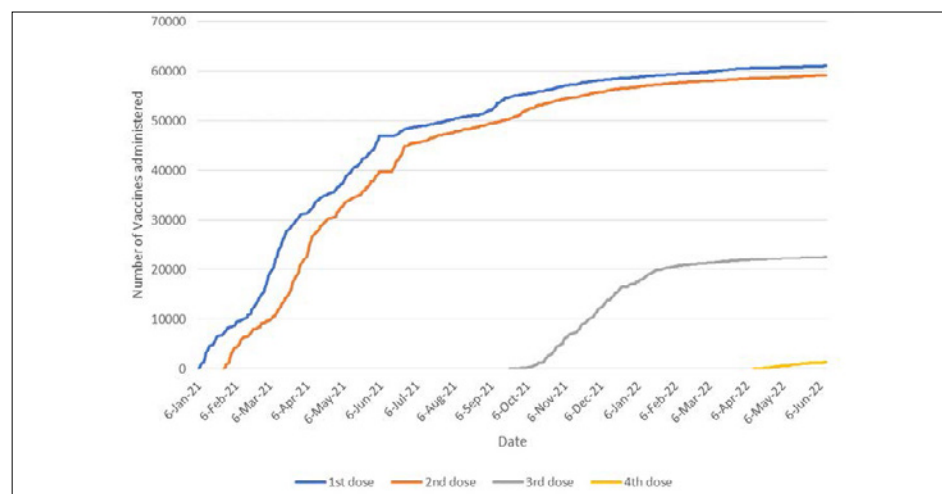


► Hospitalisations and deaths by vaccination status (since 8 September 2021)

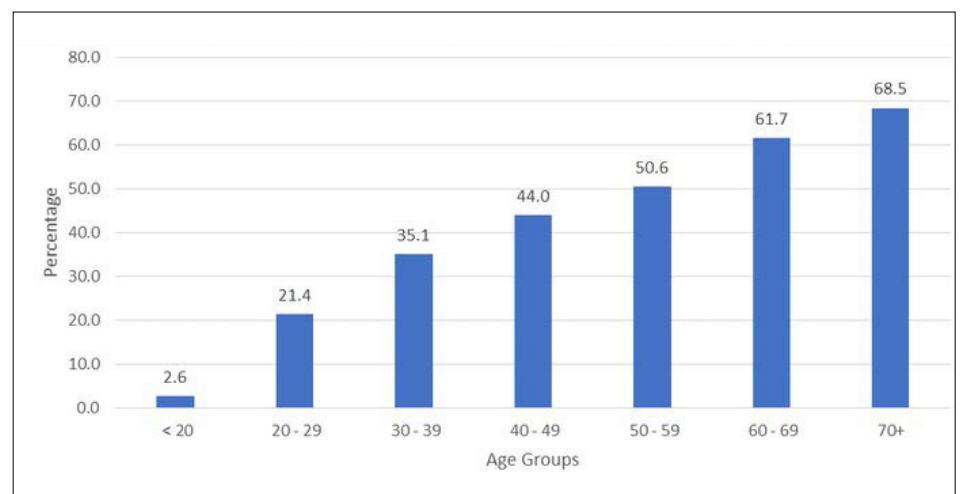


► Admissions stratified by those aged above and below the age of 10 (since 8 September 2021*)

Monkeypox

Overview

Since 13 May 2022, 1,258 laboratory confirmed cases of monkeypox have been reported to WHO from 28 Member States that are not endemic for monkeypox virus, across four WHO regions (data as of 8 June). There have been no deaths reported in non-endemic countries. The highest number of cases reported in a non-endemic country is the UK, and as of 8 June 321 cases have been reported there.

Most cases reported in non-endemic countries so far have presented through sexual health or other primary health services and have involved mainly, but not exclusively, men who have sex with men (MSM). Most confirmed cases with a travel history have reported travel to countries in Europe and North America, as opposed to countries

in West or Central Africa where the virus is endemic.

WHO report that there may have been undetected transmission for several weeks as cases without direct travel links to endemic areas have concurrently and unexpectedly been reported across several regions. So far, the clinical presentation of monkeypox cases associated with this outbreak has been variable. Many cases are not presenting with the classically described clinical picture. Instead, cases have more presented atypically including presentation of only a few lesions/single lesion; lesions that begin in the genital or perineal/perianal area without further spread, lesions appearing at different developmental stages; and the appearance of lesions before other symptoms.

WHO currently assesses the risk at the glob-

al level as moderate, however an emergency committee is convening to assess whether it is a public health emergency of international concern (PHEIC).

Cayman Islands

There are no known cases of monkeypox virus detected in Cayman Islands.

The Public Health Department is still awaiting the result from a sample sent to the Caribbean Public Health Agency (CARPHA), out of an abundance of caution, to be investigated for the monkeypox virus.

Cayman Islands now have the capacity to diagnose monkeypox at the Public Health Laboratory.

Cardiovascular Disease

Globally, the leading cause of deaths is cardiovascular diseases, which attributed to 32% of global deaths in 2019.

Cardiovascular diseases are a group of disorders of the heart and blood vessels, such as

heart attacks and strokes which are mainly caused by a blockage that prevents blood from flowing to the heart or brain.

There are several risk factors for cardiovascular disease, some of which are behavioural. These include physical inactivity, unhealthy diet, tobacco use and harmful use of alcohol. Addressing these risk factors has been shown to reduce the risk of cardiovascular disease with behavioural change such as reduction of salt intake in the diet, cessation of tobacco use, regular physical activity and eating more fruit and vegetables. There are other determinants and factors associated with cardiovascular disease including poverty, stress and hereditary factors.

Last year, in 2021, there were a total of 71 deaths due to Cardiovascular disease in the Cayman Islands.

Simple change law change means bars can play music on Sunday

A private member's motion was brought before Parliament last week by Sir Alden McLaughlin, Elected Member for Red Bay, asking for government to permit the playing of background music in bars on Sundays. Hotel and restaurant bars are allowed to play music in their bars but local bars, all of which are Caymanian-owned, are not permitted, under the law.

Sir Alden alluded to the fact that stand-alone bars which are Caymanian owned, like many small businesses, were still struggling to recoup the losses over the last few years of the pandemic and were reporting a loss of business on Sundays to hotels and restaurants which are allowed under the Music and Dancing (Control) Act to have suitable background music being played. As a result, he asked government to consider local bars to be granted the same freedom to play music on a Sunday, provided the music should not be heard outside the boundary of the establishment.

"I'm not sure what the rationale was at the time [of writing the law] for not permitting music to be played in stan-

dalone bars, but it now it is a complete incongruity because we have a situation where the bars and restaurants along the Seven Mile strip are allowed both to play music and to have dancing on Good Friday, Christmas Day or Sunday, but we have a situation where local bars - which are without exception all Caymanian owned - are not allowed to have even background music on a Sunday. It is causing a great deal of loss of business

to those establishments and complaints from their patrons," Sir Alden stated in Parliament.

There was no underlying premise for having the distinction between stand alone bars and restaurants and hotels, he said.

In response to the proposed Motion, Financial Services and Commerce Minister Andre Ebanks said the government was committed to modernising the legislation that impacted this motion.

"There are currently 58 licensed stand-alone bars and the legislation in its current form puts them at a disadvantage as compared to restaurants and hotels due to their inability to play music for their patrons on a Sunday," he acknowledged.

Minister Ebanks commented on the apparent piecemeal approach to the changes to the law on the issue in the past and said that seemed to be the reason why the issue had been overlooked, rather than any specific reason to prevent bars from playing music on a Sunday.

Government was taking a comprehensive look at the issue, taking into consideration all stakeholders and also measuring the noise levels permitted, he advised.

"We're taking a comprehensive look and in addition trying to modernise other areas that surround that legislation to take that forward so that we are not here a few years later and it still hasn't been addressed comprehensively, but, in short, we support the motion and we are working on the cause," he said.

While Sir Alden said he was pleased that they supported the motion, he pointed out the government had been trying to find a way to measure noise for the past 20 years.

"I fear that if that approach is adopted again, we are going to continue with this disparity and inequality because there are no prescribed noise levels in Cayman," he said.

Sir Alden feared that restaurants on Seven Mile would continue to be able to play music as loudly as they wished while local bars suffered, just for the sake of a small change to the law. The fact that the police appeared to be rigorously enforcing the law at the moment, which had up until now been somewhat overlooked, reinforced the disparity and therefore needed urgent attention, he said.

Opposition wants action on cost-of-living crisis

With prices going up across the board and even more price hikes on the horizon, the Opposition Leader Roy McTaggart has written to the Premier Wayne Panton and given a video address as to what the Opposition wants done to help ease the burden on the public.

Mr McTaggart took the opportunity to outline the Opposition's worries and their thoughts on how the economic impact might be mitigated during the recent sitting of Parliament. In the video, he accused the government of inactivity on the issue.

"I was most concerned that the Premier and the government, after six months without holding a meeting of Parliament, had gone almost two full days, Wednesday and Thursday, without saying a word about the current cost of living crisis facing the country until I asked the question on Thursday evening as we were about to adjourn," he stated. "A cost-of-living crisis that is having a severe impact on Caymanians and all who live here."

Citing the ESO's recent announcement that people had been paying 11% more for goods and services in the first quarter of 2022 and that that was going to

increase further, Mr McTaggart said people were struggling to cope with the reduced purchasing power of their dollars.

"Some who are being hit the hardest by rising prices are our pensioners, who are on fixed incomes with little or no ability to earn additional income," he pointed out. "They are hurting especial-

ly hard, and some may have to choose whether to buy necessary medicine or to buy food because they can't afford both."

In response to his questions in Parliament, the Opposition Leader said he hoped for some constructive ideas as to how the government intended to ease things.

"But instead, the Premier offered up a half-hearted attempt to list solutions that rambled on...There were future plans mentioned, but only two that may come soon enough to truly help our people," he said. "I was pleased to hear that many in the Civil Service will receive a 4.5% COLA to help them through the tough times. But most people in Cayman are not civil servants. I was also pleased to hear the Government mention plans to assist some people with electricity costs. We will wait to see the details and understand how much help it will provide for those who receive it."

However, the Opposition called for more to be done, including:

- extending the pension holiday for another six months
- discussing with CUC the possibility of minimising increases in electricity costs

- advising the Government-owned Water Authority not to increase water rates for at least six months

- speaking with Cayman Water and trying to persuade them to do likewise

- reducing the import duty on gasoline and diesel for six months and ensuring the savings are passed on by gas stations

- increasing the stipend to seamen, veterans and those entirely dependent on financial assistance from government

- and continuing the Covid tourism stipends.

Mr McTaggart said the Opposition addressed the concern of the Caymanian people straight on with the Government.

"Given the government's flurry of activity on social media since then in an effort to convince the public that they are acting, I know that the Premier now understands that the people and the Opposition are watching. So, he and the government will now have to work to bring some temporary relief from the current cost of living crisis by whatever means they can. I pray the government will act swiftly and decisively," he said.

Health City Cayman Islands partners with OceanMed to perform first robotic surgery in the Cayman Islands

Adding to its long track record of surgical firsts in the Cayman Islands and the Caribbean, Health City Cayman Islands continues to establish itself as a leader in the innovative delivery of medical care with the introduction of robotic assisted laparoscopic surgeries using the da Vinci X surgical system.

The first robotic assisted laparoscopic surgery in the Cayman Islands took place on May 7th at the Health City Cayman Islands hospital in East End through a partnership between Health City and local healthcare provider, OceanMed. The partnership will see OceanMed obstetrician and gynecologist, Dr. David Stone, utilize the da Vinci X robotic system to perform a wide variety of minimally invasive gynecologic surgeries, with the assistance of Health City specialists, gynecologist Dr. Pooja Monteiro and anesthesiologist Dr. Susan Paul.

"We recognize there needs to be a collaborative approach to healthcare delivery to provide the best clinical options for patients. Dr. Stone and OceanMed are the ideal partners to work with to expand the option of gynecological surgical options for our patients because of their track record of excellence," said Health City Clinical Director, Dr. Binoy Chattuparambil.

Dr. Stone said he was delighted to expand the surgical offerings to patients using the robotic surgical system. "As a gynecologist, the robot can assist me in performing resection of endometriosis, myomectomies (uterine fibroid removal), pelvic organ prolapse repairs, and hysterectomies through incisions smaller than the width of a finger. Robotic assisted minimally invasive surgeries reduce the potential for bleeding, lower the risk of infection, decrease the risk of injury to other tissue organs, reduce postoperative pain and result in shorter

recovery times when compared to open surgeries."

While currently offering the ability to perform these exclusive styles of minimally invasive gynecological surgeries, Health City is planning to broaden the scope of robotic assisted surgery to bariatric and gastrointestinal surgeries, as well as for urologic procedures.

"It is important that we continue to find innovative ways to deliver excellent

patient outcomes. That is why we are investing heavily in these modern technologies and systems, which have the potential to get patients back home to their loved ones faster. We anticipate being able to announce additional specialty areas that will benefit from use of da Vinci surgical system in the near future," said Health City Cayman Islands Chief Business Officer, Mr. Shomari Scott.

Dr. Stone noted that while other ap-

proaches may be performed successfully, the da Vinci X provides another tool for the surgeon to use for completing the task. "After having performed, procured, and assisted in hundreds of robotic assisted laparoscopic surgeries in the United States, I am truly grateful to have that option now here on island," he said.

From cutting edge surgeries to innovative procedures, Health City has brought many "firsts" to the Caribbean and the Western Hemisphere. Among them: the first LVAD (artificial heart pump) in the Caribbean; First CCM device implanted in the Caribbean (a minimally invasive implantable device that treats patients experiencing symptoms of moderate to severe chronic heart failure); the first ECMO patient in the Caribbean and only ECMO Centre in the Caribbean (ECMO allows blood to be pumped from outside the patient's body into an artificial lung that adds oxygen and removes carbon dioxide); the first surgery to correct Pentalogy of Cantrell (heart outside the chest) in the Caribbean; and the first arthroscopic Latarjet surgery in the Caribbean, USA and Canada (using a unique technique to restore stability to the shoulder joint).

Health City is currently in expansion mode with construction underway on a new US\$100 million super-specialty hospital in Camana Bay that will feature a specialized Cancer Care Centre with comprehensive and advanced oncology offerings, a neonatal intensive care unit, an emergency pavilion and critical care unit, and a multispecialty program that expands robotic surgery options. The new radiotherapy center aspect of the project is scheduled to open in late 2022 and the complete hospital a year later.

Ms Echenique said Minister Bernie Bush was unable to attend due to illness and was in particular upset at not being able to sample the mangos that were on sale at the event.



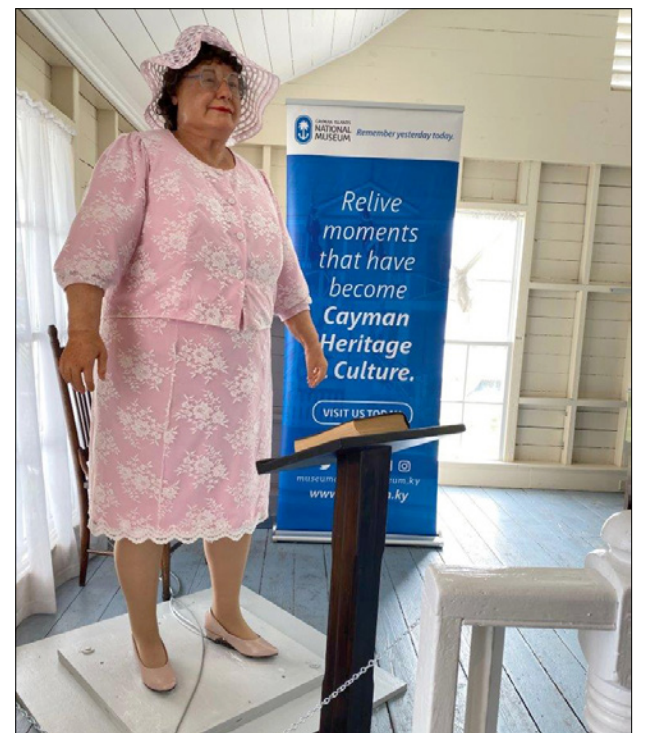

Plastic Free Cayman partners with media for cleanup event



This Father's Day weekend Plastic Free Cayman partnered with the Cayman Compass and several radio stations including Z99 and Rooster FM to host a microplastic and mangrove centered beach clean at Safe Haven. More than 50 local volunteers attended Saturday morning's clean up and over 630 pounds of local litter and marine debris were removed from the site.

It should be noted that this was the third major clean up event at Safe Haven this month. In total, more than 1,000

pounds of waste has been removed from the location in less than three weeks. This calls into question the need for a government-based clean up initiative, that could employ workers to maintain the health and safety of our local beaches.

Even with much of the focus centred on cleaning the mangrove areas, there still remains many microplastics throughout this ecosystem. In fact, crabs, worms and small fish are ingesting these plastics and even making them part of their habitats.

Aside from the marine debris washing ashore from countries like Haiti, Jamaica and the Dominican Republic, it was very clear from the clean up that local litter is still a major issue, with very little enforcement of Cayman's anti-litter law. In fact, two of the most common trash items found in the area just across from the Golf Club were beer bottles and condoms. Sadly hundreds of these items were collected by our volunteers. Trash they had no hand in creating.

This weekend's beach clean marks Plastic Free Cayman's 80th clean up event, with over 76,000 pounds of trash removed from Cayman's beaches on all three islands over 5 years. Since January of this year, PFC has removed more than 5,000 pounds of trash and are excited to continue their partnership with the Cayman Compass as they plan quarterly clean up events together to boost community awareness and outreach on the issue of pollution.

Public Advisory: RCIPS see Increase in Reports of "Sextortion"

Over the last two months RCIPS has seen a rise in the number of reported "sextortion" cases, which are usually linked to the sharing of indecent images on social media platforms, such as Facebook.

The term "sextortion" relates to the practice of trying to extort money or sexual favours from someone by threatening to reveal evidence of sexual behavior, including nude images.

The perpetrator will threaten release of images obtained from the victim, to the victim's family, work or contacts on social media. The perpetrator (in almost all cases from abroad) will demand payment in exchange for not sharing the images, and will often make contact with someone from the victim's friends list.

RCIPS advise the public to never share



indecent images of yourself online. Once these images are released, they are out of your control and can be freely shared on the internet. Furthermore, if you do find yourself a victim of this type of digital crime, do not pay a ransom, and delete all accounts that are linked to the perpetrator.

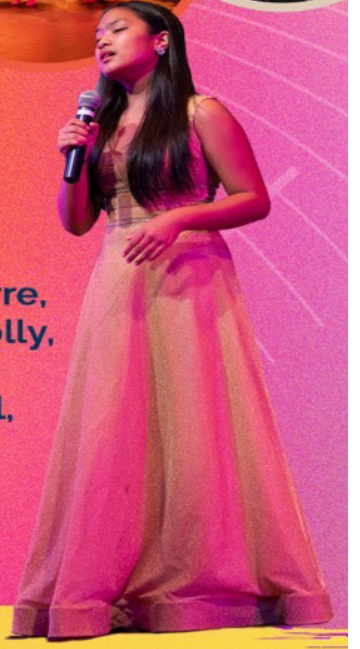
