It's been an immense undertaking and we are hoping that the community will rally round and support Pirates Fest by



The recent controversy surrounding the 2022 Miss Cayman Pageant has taken on a new twist, after this year's Winner, Ms Tiffany Connolly was recently asked by the pageant's Committee to refrain from making public appearances due to ongoing criminal charges in the Cayman Islands Courts.

With Ms. Connolly no longer able to make public appearances the Second Runner

Up in the contest, Ms. Hayley Grizzel was chosen as the representative aboard the inaugural flight of Cayman Airways to Los Angeles on 5th November.

It has since been announced that the Pageant's first runner-up will be representing the Cayman Islands at the upcoming Miss Universe Pageant.

"...the 1st Runner Up in the 2022 pageant, Chloe Doxey-Powery has been selected as the alternate who will represent the Cayman Islands at the Miss Universe Pageant in New Orleans on 14 January 2023", noted a statement by the Pageant's Committee.

The statement added that both Ms Doxey-Powery and the 2022 Miss Cayman Islands Universe 2nd Runner-Up, Hayley Grizzel, will continue to be active in the community as alternates for the titleholder Tiffany Connolly until further notice.

The decision to replace the Pageant's formal Winner for public appearances comes after weeks of public discourse surrounding whether she would be able to fulfill her international obligations in

light of her pending criminal charges.

As for now she is still the reigning Miss Cayman and has received a scholarship, as well as the stipend that comes with the title.

CIBC FIRSTCARIBBEAN CONTINUES ITS GREEN PUSH WITH NEW ELECTRIC CAR CHARGING PORTS AT MAIN OFFICES IN WARRENS

CIBC FirstCaribbean continues its green initiatives with the recent unveiling of electric charging ports at one of its main offices in Warrens with a further installation expected in a month at its Head Office.

Two EV stations have been installed so far allowing for use by two vehicles at a time at one office location with a further two to be installed at the Michael Mansoor Building, the bank's head office in Warrens. Provision have been made at both locations for additional charging ports in the future.

"This is another step along the road on our green journey which has included the introduction of paperless statements for all types of accounts and credit cards, the introduction of energy saving protocols in our offices and of course financing green initiatives at the retail and corporate level," said Chief Administrative Officer Neil Brennan.

He said the bank was "committed to maintaining strong environmental standards and conducting our activities in an environmentally and socially responsible manner that contributes to long-term value for our clients, employees, the communities where we operate, and our shareholders".

Brennan said the bank's Corporate and Investment Banking team continues to "blaze a



trail in sustainability-linked financing across the region, having arranged transactions totaling almost US\$500 million to date. Indeed, we are the largest commercial lender in the regional Renewable Energy sector with over US\$200 million in commitments made and counting".

He noted that for the "second year running our dedicated corporate team won the

Caribbean Renewable Energy Forum's award for Best Renewable Energy Financing, this is a true testament to their commitment and drive in this key area".

Last month, CIBC FirstCaribbean, working together with Credit Suisse and supported by The Nature Conservancy and the Inter-American

Development Bank, successfully closed a USD146.5 million dual-currency Blue Loan and Blue Bond for the Government of Barbados. This funding will, in part, allow Barbados to protect its marine environment and finance other environmental and sustainable development projects over the next 15 years.

Bars and boats get Sunday nod

Owners of small bars and boats will soon be allowed musical entertainment on Sundays thanks to a new law.

Cabinet has approved the Music and Dancing (Control) Amendment Bill, 2022 to give equal economic opportunities to owners of stand-alone bars and sea-going vessels on Sundays. The Amendment Bill was published in the Legislation Gazette on November 4.

At present, licensed stand-alone retail bars and sea-going vessels are restricted from playing background music on a Sunday. Owners appealed to the Ministry of Financial Services and Commerce, claiming they were losing out economically to restaurants and hotels on Sundays who are able to attract local and foreign clientele.

However, if passed by Parliament, the Amendment Bill will ensure the bars and boats, which hold valid licences, are able to operate too on Sundays. The Amendment Bill defines the bars which hold a liquor licence as those not located in a hotel and restaurant. This includes community and cul-

tural venues that operate bars when hosting profit-generating community events as well as music, dance and drama performances. Boats that hold liquor as well as music and dancing licences must be judged seaworthy by the Port Authority of the Cayman Islands.

André Ebanks, Minister of Financial Services and Commerce, said: "The Ministry consulted with local business owners and relevant public and private sector stakeholders in the preparation of this Amendment Bill. We were mindful of the potential added duties this may place on our enforcement agencies and the concerns raised by the local religious community.

"Ultimately, this Amendment Bill is intended to cause minimal disruption on Sundays, by allowing activity that is already taking place in the restaurant and hotel sectors to be extended to stand-alone bars and sea-going vessels. This will help to create a more level playing field and enable these sectors to generate additional revenue lawfully."

Hotels and restaurants are licenced from 9am-11:59pm while stand-alone

bars and sea-going vessels will open from 11am-11:59pm. The Bill stipulates that music in bars should be of a low, background nature and not heard outside the premises where it is played. Boats must be

at least a half mile out to sea before music can be played.

Minister Ebanks will present the Amendment Bill at the next sitting of Parliament the week of December 5.

Meeting for Liquor Package Licence Holders

The Department of Commerce and Investment is inviting holders of liquor package licences to a meeting on Tuesday, 29 November at Constitution Hall in downtown George Town.

The meeting, scheduled for 6pm until

8pm, will focus on liquor stores who have package licences and will address specific conditions for these licensees.




Chamber Golf Classic raises funds for Junior Achievement

Emma Woodhouse of TRAC Automotive dominated the course, taking home several prizes in the Women's category for both longest drive and closest to the pin.



Calling it "a small part of a bigger picture for tourism" Hon. Minister for Tourism Kenneth Bryan led the celebrations of the official launch of Cayman Airways Los Angeles route.

The newly launched service which took off on November 5th will see the national carrier's new nonstop West Coast service operating weekly from Grand Cayman flying out on Saturdays and returning from Los Angeles on Sundays.

According to Min. Bryan, "This exists as a result of this fight of my ministry and my department to diversify our markets to continue rebuilding tourism, to increase visitation, to inject money into our economy, so that our people can benefit from economic opportunities. We are committed, I am committed, and the Department of Tourism is committed to continue to work towards bringing new business opportunities because our people are depending on us."

Mr Bryan had previously noted that "since this new route to the City of Angels was announced, there has been tremendous interest, particularly by the tourism and business communities. I am confident that both the service and the competitive fares will be well received and I encourage travellers to book early to ensure availability," he added.

For its part, Cayman Airways has pointed out that as well as playing an important role in stimulating stayover visitation from the Western corridor of the United States, this route will also enhance air connectivity for persons travelling to and from South East Asia, making the Cayman Islands more accessible to other markets.

In a pre-launch statement, the national carrier promoted that "Inbound flight time is just five and a half hours, allowing travellers plenty of time to enjoy the islands' wellness, fitness, adventure and luxury amenities upon arrival."

"The good part about doing this is that you're affecting people's lives in one way or another, whether it's economic opportunities for jobs, whether it's building memories, or just servicing trade. All of it matters and I'm just happy to be a part of it and be the Minister to carry it out," Mr Bryan remarked.

Speaking for the airline, Cayman Airways President and CEO, Fabian Whorms disclosed that bookings for flights on the new route are already at a high level.

"Our flights are heavily booked all the way to January already," he reported.

It is also been emphasised that in addition, the LAX service provides a bridge between Cayman and one of the largest film hubs in the world – making it easier for LA-based production companies to utilise the Cayman Islands' strengths as a premier location for film, television, music video, photoshoots, and advertising productions.

"We are thrilled that our national flag carrier Cayman Airways is making it even easier for West Coast travellers to discover our renowned beaches, legendary dive waters, world-class restaurants, and welcoming community," Rosa Harris, Director of Tourism for the Cayman Islands had previously stated.

The Cayman Airways Los Angeles route will operate year-round once-weekly service from GCM to LAX on Saturdays and returning from LAX to GCM on Sundays.



JCPC opens its historical sittings in the Cayman Islands

In another historic first for the Cayman Islands and the Overseas Territories (OTs), the Judicial Committee of the Privy Council (JCPC) opens its sittings in the Cayman Islands on Tuesday, 15 November 2022. The four-day sitting will conclude on Friday, 18 November.

In addition to conducting hearings, the Justices will be engaged in several information-sharing initiatives designed to add value to the visit for the

Cayman Islands. These include a "Court Users" meeting, to be attended by a cross-section of legal practitioners; a meeting with senior high-school-aged students from St. Ignatius High, Cayman Prep High, and the "Dual Enrollment" programme at the University College of the Cayman Islands (UCCI). A similar meeting with students at the Truman Bodden Law School (TBLS) has been scheduled.

Teachers of the high-school-aged students have all reported an enthusiastic response from the students. "The students are very excited to be in attendance and have been working through their lunch-breaks this week to get prepared," said Mr. Daniel Baker head of Sixth Form at Cayman Prep. "I am sure the day will help motivate them to do well in their forthcoming exams and identify suitable career pathways in Law." This session of Ask a Justice

will be available to the three institutions via live stream to allow other students to view the session.

The opening of the JCPC Sitting on Tuesday will be preceded by an inspection of the Royal Cayman Islands Police Service (RCIPS) Guard of Honour at 9 am, in front of the Main Court of the Halls of Justice. That will be followed by the formal opening

Biographies of the Members of the JCPC Who Will Be Adjudicating Appeals in Cayman



► Lord Reed Supreme Court

President of the Judicial Committee and the Privy Council and the Supreme Court, The Rt Hon The Lord Reed of Allermuir

Robert John Reed, Lord Reed of Allermuir took up appointment as President of the Supreme Court on 13 January 2020, succeeding Lady Hale of Richmond. Upon this appointment, Lord Reed became a life peer.

Prior to his appointment as President, Lord Reed previously served as Deputy President of the Supreme Court from 7 June 2018 and was originally appointed as a Justice on 6 February 2012.

He studied law at Edinburgh University and undertook doctoral research in law at the University of Oxford. He qualified as an advocate in Scotland and as a barrister in England. He practised at the Scottish Bar in a wide range of civil cases, and also prosecuted serious crime.

He served as a senior judge in Scotland for 13 years. From 2008 to 2012 a member of the Inner House of the Court of Session, and from 1998 to 2008 a member of the Outer House of the Court of Session, where he was the Principal Commercial Judge.

As well as sitting on the Supreme Court and the Judicial Committee of the Privy Council, he is also a member of the panel of ad hoc judges of the European Court of Human Rights. Lord Reed is also the High Steward of Oxford University.

The Right Hon the Lord Lloyd-Jones, Justice of the JCPC and the Supreme Court

David Lloyd Jones, The Right Hon The Lord Lloyd-Jones, was born and brought up in Pontypridd, Glamorgan where his father was a schoolteacher. He attended Pontypridd Boys' Grammar School and Downing College, Cambridge. He was a Fellow of Downing College from 1975 to 1991. At the Bar his practice included international law, EU law and public law. He was amicus curiae (advocate to the court) in the Pinochet litigation before the House of Lords.

A Welsh speaker, Lord Lloyd-Jones was appointed to the High Court in 2005. From 2008 to 2011 he served as a Presiding Judge on the Wales Circuit and Chair of the Lord Chancellor's Standing Committee on the Welsh Language. In 2012 he was appointed a Lord Justice of Appeal and from 2012 to 2015 he was Chairman of the Law Commission. He was appointed as the inaugural President of the Law Council of Wales in October 2021.

Lord Lloyd-Jones first served as a Justice of the Supreme Court between October 2017 and January 2022. He was the first Justice of the Supreme Court to come from Wales. He stepped down as a Justice on 13 January 2022 after reaching the then mandatory retirement age of 70. On his retirement Lord Lloyd-Jones was appointed to the Supplementary Panel of the Supreme Court. Following the increase of the mandatory retirement age for judicial office holders from 70 to 75 in March 2022, Lord Lloyd-Jones successfully applied to be re-appointed as a Justice.

The Right Hon The Lord Briggs of Westbourne, Justice of the JCPC and the Supreme Court

Michael Townley Featherstone Briggs, Lord Briggs of Westbourne became a Justice of the Supreme Court in October 2017.

Lord Briggs grew up around Portsmouth and Plymouth, following his naval officer father between ships, before spending his later childhood in West Sussex. He attended Charterhouse and Magdalen College, Oxford. A keen sailor and the

first lawyer in his family, he practised in commercial and chancery work before being appointed to the High Court in 2006. He was the judge in charge of the extensive Lehman insolvency litigation from 2009 to 2013.

Lord Briggs was appointed as a Lord Justice of Appeal in 2013. He was the judge in charge of the Chancery Modernisation Review in 2013, and led the Civil Courts Structure Review in 2015 to 2016. In January 2016 he was appointed Deputy Head of Civil Justice.

Deputy President of the Judicial Committee of the Privy Council and the Supreme Court, The Right Hon The Lord Hodge

Patrick Stewart Hodge, Lord Hodge, was appointed Deputy President of the Supreme Court in January 2020. He was originally appointed as a Justice on 1 October 2013.

Lord Hodge was admitted to the Faculty of Advocates in 1983 and appointed a Queen's Counsel in 1996. From 1997 to 2003, he was a part time Law Commiss-

sioner at the Scottish Law Commission.

From 2000 to 2005 he was a Judge of the Courts of Appeal of Jersey and Guernsey, and Procurator to the General Assembly of the Church of Scotland. He was a Senator of the College of Justice between 2005 and 2013. In that role he was a Commercial Judge and the Scottish Judge in Exchequer Causes. He also served as one of the Scottish Intellectual Property Judges and as a Judge in the Lands Valuation Appeal Court.

The Right Hon The Lord Kitchin, Justice of the JCPC and the Supreme Court


David James Tyson Kitchin, Lord Kitchin, became a Justice of the Supreme Court in October 2018.

After studying Natural Sciences and Law at Fitzwilliam College, Cambridge, Lord Kitchin was called to the Bar of England and Wales in 1977. He became a Queen's Counsel in 1994 and was elected a Bencher of Gray's Inn in 2003. His practice covered all aspects of intellectual property including patents, trademarks, copyright, designs and trade secrets.

Lord Kitchin was appointed a judge of the High Court, Chancery Division in 2005

and Senior Judge of the Patents Court in 2007. From 2009 to 2011 he was the Chancery Supervising Judge for the Midland, Wales and Western Circuits and, during that time, was also a member of the Enlarged Board of Appeal of the European Patent Office. He was appointed as a Lord Justice of Appeal in 2011 and was the Lord Justice responsible for the supervision of intellectual property appeals.

Lord Kitchin is the Chair of the Advisory Council of the Centre for Commercial Law Studies at Queen Mary University of London and has been awarded an honorary LL.D. by that university. He is also an honorary fellow of Fitzwilliam College.

It is my pleasure to present to you the second monthly issue of our Public Health Spotlight.

As this publication evolves, our aim is to not only continue to make relevant information and data readily available to our community, but also to ensure that we draw the connection between the services and efforts offered by our departments and Statutory Authorities and Government Companies (SAGCs) and our broader goal of protecting and strength-

ening public health nationally.

In this issue we highlight the important public health issues that impact our men and boys specifically, given that the month of November highlights two observances focused on the health and wellness of boys and men.

While we are transitioning to living safely and responsibly with COVID-19, there is still much interest in the community about the COVID-19 related deaths.

For this reason, additional information on the COVID-19 related deaths has been provided to give the community more information on how COVID-19 deaths are recorded, the medical conditions present in COVID-19 related deaths which are known to have a higher mortality, and those medical conditions which are unlikely to have affected the outcome.

International Men's Day, 'Mo'vember, and Public Health: Connecting the Dots

Over the past few years Cayman's community has become well acquainted with the growing number of events that take place in November that focus on the health and wellness of men and boys.

'Mo'vember is a month long awareness, education and fundraising effort that focuses on men's mental health, suicide prevention, prostate and testicular cancer.

International Men's Day (IMD), November 19, celebrates the positive value men bring to the world, their families and communities, while highlighting men's well-being.

While traditional social and cultural norms are better understood within the context of how they impact the health, wellness and safety of women and girls, these efforts serve to highlight how such norms also have a detrimental effect on men and boys.

Suicide prevention is a key concern for both Movember and IMD due to the fact that globally the suicide rate for men is twice as high as for women, even though women are more likely than men to attempt suicide. How is this possible? Research has shown that male suicide methods are often more violent, which makes it more likely they can be completed before anyone can intervene and offer assistance.

Men also have a shorter life expectancy than women. Globally men tend to live for an average of 70 years, whereas women live for an average of 75 years.

Research also suggests that men could be less aware of their own symptoms and well

being, which is why in some nations men are twice as likely to suffer from illnesses like lung cancer and heart disease than women.

The economic and human cost to individuals, families, communities and society of suicidal behaviours, heart disease, lung cancer, and shorter life expectancy make all of these issues serious public health problems that need to be acknowledged, understood and addressed.

The Department of Counselling Services, via both The Counselling Centre (TCC) and the Family Resource Centre (FRC), offer mental health support to all residents of the Cayman Islands free of cost.

Everyone needs help from time to time. It is not a sign of weakness or failure.


Monkeypox Update

In the Cayman Islands, there remain to have been no detected cases of monkeypox.

Globally, there have been 77,934 laboratory confirmed monkeypox reported to WHO since the beginning of 2022 (data as of 2 November 2022). Over the past two months there has been a continual decline in reported cases to WHO. This year, there have been 36 monkeypox deaths reported to WHO.

89 registered deaths[1]. Cholera is a bacterial disease caused by *Vibrio cholerae*, and is transmitted through consumption of contaminated food or water.

The Pan American Health Organization (PAHO) has reported that as of 1 November 2022, Haiti reported 3,429 suspected cases of cholera including 399 confirmed cases. There have also been

In response to the outbreak in the region, the Cayman Islands will continue surveillance efforts to monitor for any suspected cholera cases. Currently, no cases have been detected.

COVID-19 Surveillance Data

October 2022 (data as of 1 November 2022)

Key points

Internationally: The number of COVID-19 cases reported to WHO has continued to decline over the past month, however as testing globally has declined this will be an underestimate.

Local trends: In the Cayman Islands, hospitalisations have continued to decline since the summer. There were a total of 10 COVID-19 patients admitted in October 2022, a 56% decrease from the 22 admissions during September. Reported admissions includes both patients admitted due to COVID-19 morbidity and patients admitted for other health reasons who were detected to have COVID-19 on admission screening.

One COVID-19 death has been reported during October 2022. The individual had underlying co-morbidities and had received their complete primary course of the vaccine but not received any boosters.

In Depth: COVID-19 Deaths

As part of the COVID-19 public health surveillance all COVID-19 deaths are reported. There is no internationally agreed definition of a COVID-19 death. The same definition for reporting is used for COVID-19 deaths as in the UK, which is any death in which the patient had a positive COVID-19 result in the 28 days prior to the date of death. During the pandemic, there have been 36 deaths which meet this definition reported by the COVID-19 national public health surveillance.

In addition to this, the Cayman Islands General Registry holds a record of all deaths on island, including those which have COVID-19 mentioned on the death certificate.

During the pandemic, there have been 31 deaths recorded on the death registry where COVID-19 is mentioned on the death certificate.

Comparing these two data sources:

o There are 29 deaths which are included in both the death registry with COVID-19 on the death certificate and the COVID-19 national public health surveillance.

o There are an additional seven deaths which are reported by the COVID-19 public health surveillance which do not have COVID-19 detailed on the death certificate.

o There are two deaths which have COVID-19 recorded on the death certificate, but do not meet the definition of a COVID-19 death in the public health surveillance.

Individuals who have been reported as COVID-19 deaths in the public health surveillance often had other medical conditions, commonly referred to as underlying co-morbidities. Some of these conditions may mean the patient is more likely to have a severe infection if infected with COVID-19.

The following tables present the frequency of other medical conditions that the COVID-19 reported deaths had. A patient may have more than one condition present. Two medical conditions have been removed to ensure patient confidentiality. Where the frequency of the medical condition across all reported deaths is less than five, this has been masked to prevent the risk of identifying individuals.

UN backs Cuba, but blockade stays

The United Nations General Assembly has for the 30th year in a row overwhelmingly voted to support a resolution demanding the end of the economic blockade imposed by the United States on Cuba, but Washington refuses to lift it.

Of the 189 countries that voted, only the US and Israel and two abstentions from Brazil and Ukraine did not back the lifting of the decades-long blockade which stretches back to 1959.

Cuba's foreign minister told the assembly that accumulative damages were estimated at almost \$1.4 trillion

at current prices. South Africa called the continued embargo a violation of international law and the UN Charter that could never be justified.

The resolution titled: Necessity of ending the economic, commercial and financial embargo imposed by the United States of America against Cuba, has been approved since 1992 as Cuba's top diplomat lamented the economic losses to his country where 11.3 million live under dire circumstances.

He mentioned supply shortages and long queues to buy essential goods and the obstacles posed to families and par-

ticularly young people and the increase in mass migration.

Cuban Foreign Minister Bruno Rodríguez Parrilla asked at the UN in New York: "What would Cuba be like today had it had those resources? What else could we have done? What would our economy be like? It's impossible to quantify the anxiety generated by blackouts and instability in the power system.

"It takes a toll on the lives of Cuban men and women and contributes to transnational organized crime and arms trafficking in persons."

He also called the US designation of Cuba as a "state sponsor of terror", imposed in the final days of the administration of former President Donald Trump, as unfounded while urging the US to heed the widespread call of the international community.

But the United States again rejected the resolution, focusing rather on human rights deficits in Cuba, after abstaining just once under the administration of former President Barack Obama in 2016.

The US Mission's Political Coordinator John Kelley, said: "The United States opposes this resolution, but we stand with the Cuban people and will continue to seek ways to provide meaningful support to them. We encourage this body to urge the Cuban government to

listen to the Cuban people and their demands to determine their own future."

Even if the current US administration voted in favour of the text, it would still require an act of Congress to eliminate the embargo – an impossibility given the current political divides nationally.

The US embargo was officially declared in 1962, but in reality Washington began imposing illegal unilateral sanctions almost immediately after the victory of the Cuban Revolution three years earlier, headed by the late Fidel Castro.

The UN commission noted that the Donald Trump administration imposed an additional 240 unilateral sanctions on Cuba, and that the Joe Biden administration has renewed the economic measures.

"The numerous United States sanctions produce real harm that obstructs the access of Cuban citizens to basic goods and violates their rights," the UN commission wrote.

These policies are an obstacle to economic, social and environmental development.

"In short, the numerous United States sanctions constitute the most severe and prolonged system of unilateral coercive measures ever applied against any country and continue to hinder the development of the potential of the Cuban economy," the UN statement concluded.


