# Premier's Hurricane Message 2023

The 2023 Atlantic Hurricane Season starts today – 1 June – and will continue until 30 November.

Over the next six months, every individual, family, business and community in the Cayman Islands must take steps to be prepared, stay vigilant, and look out for one another in times of need.

We are one year closer to the twentieth anniversary of Hurricane Ivan, which devastated Grand Cayman in 2004, and later this year will mark the fifteenth anniversary of Hurricane Paloma, which severely impacted our Sister Islands.

But these so-called 'once in a lifetime' storms are becoming more frequent. Over the past five years, hurricanes like Harvey, Maria, Irma, Ida and Ian have wreaked havoc across our region. Even when our islands are spared a direct hit, we feel the effects on our bank accounts as insurance premiums continue to rise. And our brush with Grace in 2021 taught us that even a Tropical Storm can cause significant damage.

Being prepared is one of the most important things we can do to protect our families, friends, homes and businesses during hurricane season. As the old saying goes: An ounce of prevention is worth a pound of cure.

So, if you have not already done so, now is the time to stock up on emergency supplies, and make sure you have a plan for your home or business.

If you're new to our islands or need a reminder, the Hazard Management Cayman Islands website – [caymanprepared.gov.ky](http://caymanprepared.gov.ky) – has all the information and resources you need to prepare yourself, your family, your home or business for a severe weather event.

I also encourage everyone to download the free National Emergency Notification System (NENS) mobile app. The NENS app allows Hazard Management to send emergency alerts straight to you by email, SMS text, or both. Log on to [nens.gov.ky](http://nens.gov.ky) to learn more and download the app.

The NENS app is a prime example of the many, official sources of information you

can safely rely on during an emergency situation.

We know how easily misinformation can spread during times of uncertainty. During a hurricane or other emergency situation, it is vital that you monitor official sources of information – such as Radio Cayman, Cayman Islands Government TV, Hazard Management, the National Weather Service, and the main Government website and social media pages.

Following Hurricane Ian, we developed a new protocol for WhatsApp voice-note messages so official messages can be shared via WhatsApp. We want to help you stay informed, especially when the situation is fluid and developing, but we need to make sure we are sharing verified updates. Misinformation, even if it is not shared intentionally, can waste time and resources, and put lives at risk.

Be vigilant, monitor official sources, and verify before you share.

Although we often think of strong winds and rain as the most significant threats during a hurricane situation, the sea can be especially treacherous. Even if your home is away from the high, crashing waves battering the coast, storm surge can cause severe, even life-threatening, flooding up to hundreds of yards inland.

It's important to know where the nearest hurricane shelter is to your home, and have

a proactive plan to evacuate if your home is at risk. As certain shelters have different guidelines for pets, for example, it is important to plan in advance.

I want to thank the many shelter volunteers who go through special training to ensure these essential facilities are able to provide safe shelter during an emergency.

I'm happy to announce that, by the time we reach peak Hurricane Season in September this year, Hazard Management is planning to have thousands of additional shelter spaces available.

I am also pleased to confirm that the Kearney Gomez Doppler Radar has been restored to full working order ahead of Hurricane Season. In addition to the radar – which allows the Weather Service and the public to monitor meteorological conditions as far as Jamaica – the Weather Service also uses the Cayman Islands Government's GOES-R satellite system to monitor and track weather systems further afield.

The Government recognises that efforts to increase short- and medium-term readiness must be combined with longer-term measures to enhance national resilience.

Earlier this year, the Cayman Islands Government published the first Cayman Islands Climate Change Risk Assessment – the most comprehensive review of climate risks and opportunities to the Cayman Islands undertaken to date.

We cannot keep ignoring the risks of climate change to our communities, our economy, or our environment.

Based on local, regional and global data, we know that there is strong evidence for an increase in the frequency and intensity of tropical cyclones since the 1970s in the North Atlantic. And projections suggest that strong hurricanes will become more commonplace in the Caribbean.

And this is just one of the climate impacts our islands are facing. Local tide gauge data shows sea level is rising. Local rainfall data suggests fewer but more severe rain events. Local temperature data shows our islands are about 2.2 degrees Celsius hotter than forty years ago.

The anecdotal evidence confirms these data points. Based on a survey the Ministry of Sustainability & Climate Resiliency conducted last year to evaluate local knowledge, attitudes and practices towards climate change – the majority of respondents reported noticing changes to local temperatures, rain patterns, storms, coastal erosion and plant growth.

Climate change is not a distant projection, it is an ongoing reality.

As part of our efforts to ensure our country can continue to sustain future generations of Caymanians, the Government recently launched the draft Cayman Islands Climate Change Policy for public consultation.

The policy includes three over-arching goals, seven policy objectives, and more than one hundred strategies designed to help ensure vibrant communities, a thriving natural environment and a robust economy for current and future generations.

At the beginning of this message, I urged you to be prepared, stay vigilant, and look out for one another.

Community creates country. And, in times of uncertainty, danger and need, we need strong, healthy and resilient communities more than ever.

So, Cayman, let's be prepared. Let's get our emergency supplies together, and let's encourage our family, friends and neighbours to do the same. Let's stay vigilant, monitoring official sources and verifying information before we pass it along. And let's look out for one another. Do not wait until after disaster has struck to meet your neighbours, or to find out who the elderly, disabled and vulnerable in your community are.

The only way we can get through hurricane season safely is if we work together.

Thank you, and God bless these Cayman Islands.

# Postal Service Issues New Stamps to Commemorate Royals

The Cayman Islands Postal Service has issued two new sets of stamps to commemorate Her Late Majesty Queen Elizabeth II and celebrate His Majesty King Charles III's accession to the British Throne.

The collectible philatelic issues of both stamp sets of stamps are now available at all post offices across Grand Cayman. They will be available in Cayman Brac and Little Cayman starting next week.

The stamps are available for purchase in

individual denominations at all post offices while the commemorative stamps sets can only be purchased at the Philatelic Bureau at the Seven Mile Beach Post Office, West Bay Road.

In the current issues, a set of five stamps pay homage to Her Late Majesty Queen Elizabeth II. The issue consists of stamps in 25 cents, 80 cents, \$1, and \$2 denominations as well as \$4 that is also highlighted on a souvenir sheet.

In the current issues, a set of five stamps pay homage to Her Late Majesty Queen Elizabeth II. The issue consists of stamps in 25a cents, 80 cents, \$1, and \$2 denominations as well as \$4 that is also highlighted on a souvenir sheet.

A first day cover issue will feature the four stamp images as well as another portrait of Her Late Majesty, who passed away last September ending the longest reign of any British monarch. A commemorative sheet, which highlights milestones from Her Late Majesty's life is also featured as part of the philatelic package. The first day cover is offered in two options, one with the stamp set and the other with the souvenir sheet.

The three stamps set for His Majesty's accession to the British Throne are available individually in 80 cents, \$1.50 and \$2 denominations. The first day cover offered with the stamps set features the 80c and \$2 stamps' images as well as another portrait of the reigning monarch. A commemorative sheet showcases His Majesty's life and his accession on his mother's passing. The souvenir sheet can be purchased separately.

Commenting on the new issues, Postmaster General Sheena Glasgow said, "We take great pride in bringing these two royal stamps offerings to the Cayman Islands and to the wider global public. While acknowledging that Her Late Majesty's stamps issue is a bittersweet release for us all at the Postal Service, we nevertheless are pleased to commemorate the late Queen in this way. Over the years, we have been deeply honoured to have featured the beloved Queen in a number of postal stamp issues to highlight her milestones that included her Platinum Jubilee. We believe the newest stamps issues are another fitting tribute to the passing of this global icon."

Ms Glasgow added, "Equally, our tribute to His Majesty King Charles III is an esteemed celebration of his accession, through which we have also highlighted salient points in his life. Collectors may wish to note that a stamp issue commemorating His Majesty's recent coronation is already in development."

The celebratory first day covers will be made available for purchase to members of the public after arrival.

# OfReg announces release of further 6MW of capacity to Distributed Renewable Energy Programmes on Grand Cayman

OfReg has announced the release of a further 6MW of additional capacity which will be extended to Distributed Renewable Energy Programmes including the Consumer-Owned Renewable Energy (CORE) and Distributed Energy Resources (DER) programmes. This follows the 3MW of additional capacity made available on 1 March earlier this year.

The 6MW completes the 9MW total additional capacity expansion plan that the grid can currently accommodate within technical operation limits. 1MW of this current release is being reserved for the Cayman Islands Government

Speaking on the release of the additional 6MW, OfReg Interim CEO, Mr. Peter Gough said, "We are pleased to confirm the release of this additional

capacity to consumer-owned distributed renewable energy programmes. This is another important step in managing the sustainability and stability of the national grid infrastructure and increasing Cayman's renewable energy power generation."

OfReg is committed to the long-term protection and sustainability of our critical national infrastructure such as our electricity grid. Grand Cayman's transmission and distribution grid is recognised as one of the most stable and robust systems, with one of the lowest outages rates, in the region.

Distributed generation programmes, such as CORE and DER, are a key part of delivering the long-term goals of the National Energy Policy (NEP) and continue to provide incentives for consum-

ers to generate energy from renewable sources."

Mr. Gough continued, "It is also good news for consumers, giving more households and small businesses the opportunity to connect renewable energy systems, such as small-scale solar systems or wind turbines, to CUC's distribution system and to reduce their monthly energy bills by generating their own electricity while remaining connected to the grid.

"We will continue to balance the opportunity for further expansion of renewable energy power generation by protecting those consumers who do not have renewable energy sources from being unfairly charged or disadvantaged."

The plan is for the capacity to be available starting on 1 July 2023.

# Health Screening Required for New Students

All students entering government or private schools in the Cayman Islands for the first time must have health screenings.

Noting that this includes students entering reception programs, School Health Coordinator Nurse Carvell Bailey-Able adds: "The Education Department mandates that these screenings must be completed before the new school year begins in September."

School entry health screening is essential to identify any issues early, so your child can achieve their full potential in school. The screening includes a growth and development assessment, screening for vision and hearing, a dental assessment, administering necessary immunizations, and obtaining a student's medical history.

Public Health Department staff will conduct the screenings, which are free

to all students. Health screenings will take place at the district health centers from 5 to 29 June 2023 for those entering schools in West Bay and the Eastern districts.

For all other students, health screenings will occur at John Gray High School Medical Centre (nurse's office) from 5 July to 18 August 2023.

Nurse Bailey - Able reminds parents and guardians that they need to accompany children to the health screening. They should also bring the child's immunisation record. Appointments can be made at the school the child will be attending.

"Vaccines will be offered to children whose immunisations are not up-to-date. A health screening certificate will then be issued, which is to be taken to the child's school," she explained.

Parents may have their child's health

screenings done by a private doctor as long as that doctor completes the school health screening forms provided by the Public Health Department.

The completed forms should be handed in at the John Gray High School Medical Centre (nurse's office) between 5 July and 18 August, from 8:30 a.m. and 4:30 p.m. Outside of these dates, the forms can be taken to the Cayman Islands Hospital's Public Health Clinic (Smith Road Centre).

Once the record has been received, a health screening certificate will be issued, which must then be taken to the school the child will enter in September.

# National Trust Wraps Up Jackson's Wall Excavation

Records have shown that the owner of the site, Mr. John Sheerer Jackson was paid out for six slaves during the emancipation claims of 1834 and other interesting facts about the Site.

As part of the excavation, the National Trust and Ms Petras, were assisted by other archaeologists in the community, who joined volunteers in the digging and sifting of the Sites's remnants.

Of the 12 Heritage Sites currently under the care of the NTCI, very little is known about the Jackson's Wall site, which is one of the National Trust's more "obscure" sites.

Most of the information on Jackson's Wall comes from the Hyrst records, which are somewhat vague and not corroborated.

The Site is said to have been built by a gentleman who was married to the 'Governor's' daughter at the time.

Historic Programmes Manager for the National Trust, noted: "The term governor

was a colloquial term back then and was not in relation to any official office.

"This exploration is giving us a window into the past and more insight into what the actual history of Jackson's Wall was."

After the completion of washing of the items, the next step is for some of the artifacts found to undergo further analysis, while much of the others will remain under the care of the National Trust to determine how to display them, once more research is complete.

Mr. Wilson explained that the excavation of the Site has turned up many important items including bones, bullets and other artifacts such as pieces pottery and other indicators that begin to tell the story of life on the grounds at the time of its inhabitants.

There was said to be a sheep farm on the land that comprises the area where Jackson's Wall is located, as the general Newlands area was part of the original Cayman Islands land grants.

The Site's proximity to the sea and the prominence of those who may have owned it, suggests that there may have been some relationship between Jackson's Wall and

Pedro St. James, which is on the opposite coast in relation to trade.

A QandA community meeting held at the International College of the Cayman Island by the National Trust sought to learn more from residents in the area - among who included Premier of the Cayman Islands, the Honourable Wayne Panton - about the site and to elicit their feedback regarding what they would like to see done with the Site after the excavation and research is complete.

The tentative plan is to turn the Site into a park, which would incorporate landscaping and benches so that students and persons in the community can enjoy the site, whilst learning more about their history.

Currently, there is interpretive signage at Jackson's Wall and any plans to develop the site further will incorporate an educational component based on the findings of the current research and archaeological undertaking, according to the National Trust.

According to Mr. Wilson, the Site may undergo another round of digs before any disturbance developing the Site may result in.

# Bulk Waste Collection Ends: 600 tons collected

This has also facilitated a greater preparedness by reducing the amount of debris that could be generated by any form of severe weather", said the DEH Director, Richard Simms.

The DEH is also reminding residents that following the completion of the Bulk Waste Collection Schedule on May 27,

2023, arrangements should be made by individuals to transport any additional waste to the landfills and that any illegal dumping and littering should be reported to the DEH or the Royal Cayman Islands Police Service (RCIPS). This unlawful practice can result in a penalty of 6 months of imprisonment and a minimum fine of \$500.

The George Town Landfill operates from 7:00 a.m. to 5:00 p.m. on weekdays, until 1:00 p.m. on Saturdays and is closed on Sundays. The landfill drop-off facility at the gate will remain accessible to the public and small vehicles 24 hours per day.
