Increase in local egg production

The National Egg Strategy (NEST), a key component of Government's plan to address the development of the domestic egg sector in the Cayman Islands, has moved

MEDIA STORM WATCHING AND ADVICE

The presence of the first named storm formed in the Atlantic for the 2023 Hurricane Season has given added credence to words of advice uttered recently on the Radio Cayman programme Business Buzz hosted by Anita Khan.

The discussion was about the role of the media in hurricane preparedness and the guest was the publisher of Caymanian Times newspaper Ralph Lewis.

Their sharing of experiences of past storms that have impacted or swept uncomfortably close to Cayman may have been prescient.

Currently churning in the Atlantic on a heading that is expected to bring into the Caribbean Sea is Tropical Storm Bret, the first named storm to form in the Atlantic for the 2023 hurricane season.

At the start of the season on June 1st, Tropical Storm Arlene formed in the Gulf of Mexico near Florida.

According to the US National Oceanic and Atmospheric Administration (NOAA), on the forecast track, Bret was initially heading towards the Lesser Antilles, possibly the Windward Islands, as a moderate tropical storm strength. It was forecast to slowly weaken after crossing the Lesser Antilles into the Caribbean Sea by the weekend.

And having a hurricane plan in place was the focus of the discussion between CT's Ralph Lewis and Business Buzz's Anita Khan in discussing the role of the media, especially during the hurricane season.

Commenting on a memory shared by the radio Cayman Business Buzz hist

about host about Hurricane Ivan which slammed cayman in 20047, Mr Lewis said: "We bring back those memories in our editions during this time to remind people of what can happen before we forget. We have short memories and that's when media comes in handy. Normally during the season, we have flashbacks with articles and photos to remind people how to prepare for hurricanes. What you should do on a regular basis, not just once but throughout the whole season."

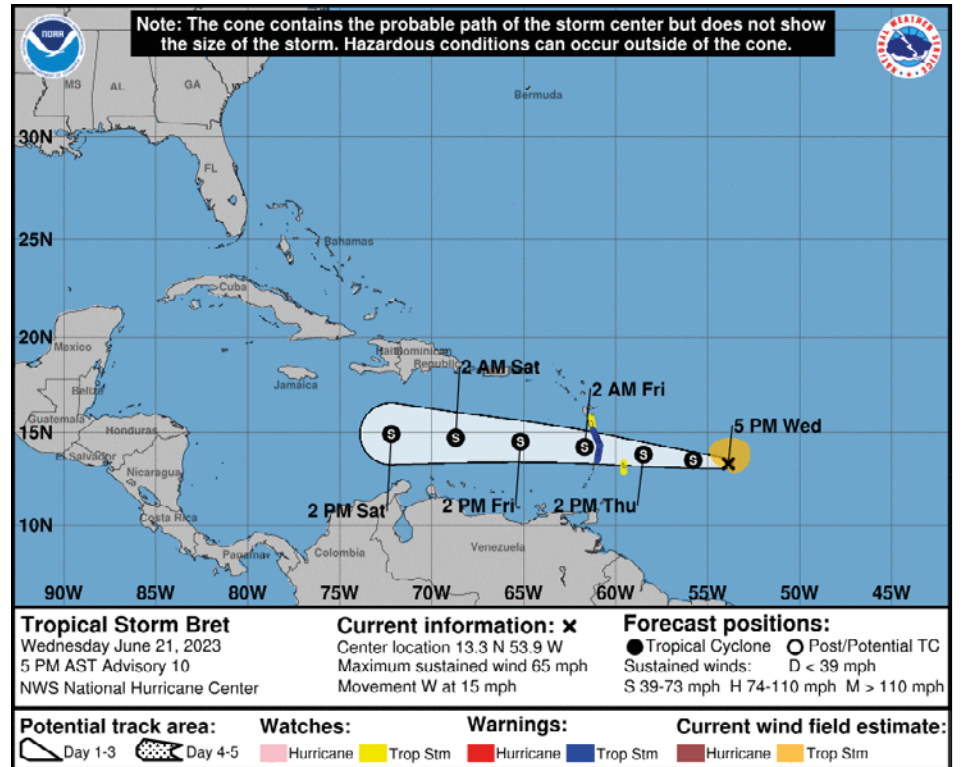
The disruption caused to personal and household budgets leading up to and in the aftermath of a storm was raised by programme host Anita Khan, to which CT's publisher Ralph Lewis, a former banker, offered this advice.

"Hurricanes don't know when it's payday... I'm not trying to scare people but this is reality," said. "There are many people out there who have it difficult as it is to feed their family on a regular basis. Hurricanes will add to that. And what you're going to do?"

Putting on his financial advisor's hat, Lewis advised that the best financial planning now is to have what he calls 'a hurricane fund' set aside and prioritise your spending.

"Think about cutting back on things. It's the holiday season and you may want to go overseas and have a nice vacation with your family. That's good, but put some of that money aside in case a hurricane comes this way.

"If you do have additional funds or surplus funds, please think about putting it



into a savings account now and leave that there for the next six months. Because one of the most important things is to have cash when a hurricane is coming and after. You will have some money to go buy some food because you're gonna need it."

In addition to personal hurricane financial planning, former bank executive Lewis also had some advice for businesses when prompted by Business Buzz's Khan.

"What I will say to any business owner or any senior official in the business, is stay calm. Someone has to be in control. You have to manage your emergencies well. Panicking does not help. And therefore if you're a business owner, start to focus now on 'how am I going to stick it out'.

And how you stay calm is being prepared and have a plan of action," he suggested.

"If you haven't done it yet, now's the time to sit down like I do, and put your hurricane game plan in place."

Meanwhile, back to Bret, forecasters say that regardless of its strength, the storm will bring a risk of flooding to the Windward Islands from heavy rainfall, strong winds, and dangerous storm surge and waves. However, as far as its further immediate outlook is concerned, the hurricane experts at NOAA say "Given the larger than usual uncertainty in the track forecast, it is too early to specify the location and magnitude of where these hazards could occur."

“Three Cheers for His Majesty!” said Her Excellency, Mrs Jane Owen, on His Majesty King Charles III first Commemoration Birthday Parade & Celebration, outside Government House on West Bay Road on Monday 19 June.

All the detachments of uniformed officers were there, including contingents from the Royal Cayman Islands Police Service, the Cayman Islands Regiment Cayman Islands Fire Service HM Cayman Islands Prison Service, and the Coast Guards. Youth organisations included the Girls’ Brigade, Scouts and Cub Scouts, Cayman Islands Cadet Corps, and the Seventh Day Adventist Pathfinders.

Honourable Premier Wayne Panton received the General Salute from the uniformed detachments, just before the official arrive of Her Excellency the Governor, Mrs. Jane Owen. Then there was the Royal Salute and breaking out of the Royal Standard. Pastor Torrence Bobb prayed a blessing upon the proceedings, and also upon His Majesty King Charles. Mr James Geary sang the National Song, Beloved Isle Cayman.

Caymanians Garth Arch and James Watler received MBEs (Member of the Most Excellent Order of the British Empire) from King Charles in the King’s first Birthday Honours list. Mr Arch, Managing Director of construction firm, Arch and Godfrey, received his honour for his services to

business, commerce and the community. He is also chairman of the Children and Youth Services Foundation of the Cayman Islands. Mr Watler is a retired civil servant and was president of the Civil Service Association for 10 years. He received his honour for his public service and for his services to education in the Cayman Islands..

Kings Honours were presented by Her Excellency Jane Owen. Recipients of Honours & Awards included Mrs. Cindy Scotland who received the Officer of the Order of the British Empire (OBE). She had been sponsored by Mr. George A. McCarthy OBE, JP, and Dr the Honourable Linford Pierson, OBE. JP.

Summer Deadline Approaches for Expiring Liquor Licence Holders

Persons with liquor licences on Grand Cayman, including those with music and dancing licences, that expire on 30 September are reminded to submit their renewal applications to the Department of Commerce and Investment (DCI) by 4pm on 7 August.

Applications will be heard at the Grand Cayman Liquor Licensing Board's annual meeting on 1 September. Renewals can be submitted online or in person, along with the relevant fees, at DCI's counter on the first floor of the Government Administration

Building between 9am and 4pm, Monday to Friday. Applications will not be accepted via email.

Expiring licences must be renewed at this annual session in order for persons to operate legally when the new licence period begins on 1 October. Licences approved at the Board's 9 June quarterly session will also need to be submitted for renewal at the annual meeting.

Licence holders are reminded it is the applicant's responsibility to seek onsite inspections from the relevant

Government agencies. While these inspections are to be carried out, the inspection reports are not required to be submitted along with the renewal application.

Suggested Hurricane Supply List

To prepare for the unknown, each home should have a 72-hour Disaster Survival Kit. You will need to pack some essential items to help you and your family survive, whether you stay at home or leave it during a disaster.

Ensure at least three days (72 hours) supply for each person. Do not forget pets where applicable! The following is a minimum suggested list of Survival Kit supplies:

Drinking Water:

- One gallon per person/per day in unbreakable containers, Avoid using containers that will decompose or break, such as milk cartons or glass bottles. A normally active person needs to drink at least two quarts of water each day. Hot environments and intense physical activity can double that amount. Children, nursing mothers, and ill people will need more.
- Don't forget to add additional water for mixing formula if you have children and for your pets. Rotate the drinking water each year.
- Food preparation and sanitation require another two quarts (minimum) per person daily.
- Purchased bottled water that has been sealed is best for storage. It meets FDA guidelines for food and is not as vulnerable to temperature changes as unsealed water
- **Tip:** Purchase water this year and use it for drinking next year. This allows for rotation on an annual basis and keeps the water fresh. **Yes water can go bad!**

Water for sanitation use:

- Store extra containers of water to be used for flushing toilets, cleaning, and bathing.
- Purchase water purification tablets (Halazone) to be used if you still have running water but are told to boil water before using it. This allows you to fill the bathtub and other containers without purchasing expensive drinking water.
- **Tip:** Keep plastic containers (milk jugs and other containers) and fill them with water when a storm threatens. You can put these items in the freezer to keep food cold longer in the event that the electricity goes out.

Non-perishable Food:

- Maintain at least 3-7 days of food for each member of the family.
- Small, preferably single serving cans (should not require cooking or refrigeration). Dried fruit, peanut butter and jelly, coffee, tea, soft drinks and pet foods.
- Ready-to-eat canned meats, fruits and vegetables.
- Canned juices, milk, soup (if powdered, store extra water).
- Staples – sugar, salt, pepper in water proof containers.
- High energy foods like crackers, granola bars, trail mix.
- Raw vegetables that do not need refrigeration.
- Fresh bread.
- Comfort/stress foods – cookies, hard candy, sweetened cereals, lollipops, instant coffee, tea bags.



- Sterno for cooking.
- Vitamins
- Food for infants
- Paper cups, plates, and plastic utensils
- Non-electric can opener
- Aluminum foil
- Plastic storage containers
- Lots of ice (you can freeze your water supply)
- Pedialyte (to restore hydration if needed)
- **Tip:** Purchase only items that you like to eat and would eat even without a storm. Rotate these items by using them Dec-May each year and purchasing new items Jan-May. This allows you to reduce the cost of buying items for a hurricane kit at one time and keeps the items fresh. Yes even canned goods have a shelf life!

Non-Prescription Drugs

- Aspirin or nonaspirin pain reliever, Benadryl, peroxide
- Anti-diarrhea medication, Antacid (for stomach upset)
- Syrup of Ipecac (use to induce vomiting if advised by the Poison Control Center)
- Laxative
- Activated charcoal (use if advised by the Poison Control Center)

Prescription Drugs

- Heart and high blood pressure medication
- Insulin (enough for a 30 day supply)
- Hearing Aid and extra batteries
- Prescription drugs
- Denture needs
- Contact lenses and supplies
- Extra eye glasses
- **Tip:** If your insurance will allow, get a 90 day supply of prescriptions and have at least a 30 day supply on hand. Do n't wait until a couple of days before a storm to go to the pharmacy for refills you may not get your prescription refilled; the lines are long and they run out of supplies very quickly.

Clothing and Bedding

- Include at least one complete change of clothing and footwear per person.
- Sturdy shoes or work boots
- Towels
- Rain gear
- Blankets or sleeping bags
- Pillows
- Hat and gloves
- Sunglasses
- Tent
- Lawn chairs

Entertainment

- Games
- Books
- Cards
- Extra batteries for games/Coloring books, crayons.

Miscellaneous

- Wind-up or battery-operated clock
- Paper, pencil
- Needles, thread
- Camping utensils
- Map of the area (for locating shelters) and returning to the area.
- Cash or traveler's checks
- **Tip:** Have enough cash to sustain you through a 2 week period. Without electricity, most businesses (if open) will not accept credit cards and may not accept traveler's checks.
- Emergency preparedness manual
- Citronella candles

Baby Needs:

- Special foods (enough for several days)
- Formula (enough for several days)
- Extra diapers
- Medicines (get a copy of prescription)
- Blankets
- Diaper Rash Ointment
- Baby Wipes
- Powder
- Bottles
- Pacifier
- Favorite toy/blanket
- Medicine dropper
- Diaper-rash ointment

Sanitation

- Toilet paper, towelettes, soap, baby wipes, liquid hand sanitizer
- Liquid detergent
- Feminine supplies
- Personal hygiene items (toothpaste, deodorant, shampoo etc.)
- Plastic garbage bags, ties (for personal sanitation uses)
- Plastic bucket with tight lid
- Household chlorine bleach, disinfectant
- Plenty of absorbent towels

First Aid Kit

- Assemble a first aid kit for your home and one for each car.
- Adhesive bandages various sizes - Sterile gauze pads (various sizes)
- Germicidal hand wipes or waterless alcohol-based hand sanitizer
- Non-latex gloves - Adhesive tape - Anti-bacterial ointment - Antiseptic spray
- Cold packs (non refrigerated type) - Scissors - Tweezers - Rubbing alcohol
- CPR breathing barrier, such as a face shield - Thermometer, Safety pins.

National Egg Strategy moves into operational mode to increase egg production

market share of local eggs, improve market access for all local table egg producers and certify egg farms across the Islands.

“Our vision is for a food and nutrition-secure Cayman Islands and a key part of making it a reality is to strengthen and grow our domestic supply of table eggs,” he said.

“After two years of significant progress in laying the foundation for a National Egg Strategy, we are ready to begin operating this vital programme. Our goal is to improve the market share of local egg producers by 40% in 4 years, and a 100% increase in egg production over the same period.

“The Cayman Islands Government has made the necessary budgetary allowance to support this important national project as it is key to our broad outcomes to enhance competitiveness while meeting international standards and future proofing us to increase resiliency,” Minister Jay Ebanks said.

The Ministry and the Department of Agriculture developed the comprehensive National Egg Strategy two years ago to support and upgrade production facilities and to implement a government-backed safety and quality certification programme for all egg farmers. The NEST moved into an implementation phase last year, with some important accomplishments on the road to achieving the goal of the programme:

- For the first time ever, food safety quality standards for egg layers’ operations were created (the Cayman Islands Poultry

Standards - Layer Operations 2022); an upgraded 2023 version will be published in the third quarter of 2023. This was achieved with the support of our local egg producers, Cayman Islands supermarkets and other stakeholders;

- A pilot group to test these standards was established with sixteen commercial farmers, whose farms are currently producing over 60% of local table egg production (a minimum of 200 birds each, representing a total of approximately 105,000 dozens of eggs annually). The ultimate aim is to certify all egg producers across the Cayman Islands;

- A poultry expert was recruited and onboarded to contribute to the formal documentation/procedures and to guide the farmers and support the expansion of this initiative to improve local egg safety and quality assurance thereby increasing consumer confidence in domestically-produced eggs;

- New egg cartons were designed and purchased to enable the national egg quality certification components of the programme;

- A part of the overall strategy is to improve the production systems used in local egg production. One of the key steps taken is the Ministry collaborating with the Public Works Department to produce a poultry house model that can be used by egg producers to start or improve their operations;

- The Ministry purchased several key pieces of equipment which will be provided to the pilot group farmers to help meet the standards and market requirement for the National Egg Strategy. There are other types of support that will be provided to

the pilot group members and the wider egg producers as the Ministry seeks to develop the local egg industry.

“Thanks to the cooperation and support of our local egg producers, and for the hard work by teams at the Ministry, the Department of Agriculture, and the NEST Technical and Advisory Committees,” Minister Jay Ebanks said.

“The National Egg Strategy is proving to be one of the most visible examples of our efforts to strengthen and modernise Cayman’s agricultural sector. The NEST is in full operational mode and we look forward to more and more Caymanians showing their confidence in the quality of this locally-developed food by choosing Caymanian certified eggs over imports.”

CIFA Welcomes Technical Director for Women's Football

Former Technical Director of Trinidad and Tobago Football Association, Dion La Foucade has been appointed Head Coach of the Cayman Islands Football Association's (CIFA) Women's National Football Teams.

A native of Trinidad, the new coach comes to the post in the Cayman Islands - which has been without a dedicated coach for some time - with years of experience in women's football and talent development.

During the press conference to introduce Coach La Foucade, he noted that it was a pleasure to be invited by CIFA to take up the mantle in relation to women's football and pointed out why the job resonated with his values.

"Upon speaking with them, they indicated that they wanted to take the programme to another level, in terms of developing the young people of the Cayman Islands, which is the most important part of what we do.

"Why you do what you do is crucial and that is what attracted me to the Cayman Islands," he noted.

"It's about touching young people's lives. They come for football but learn about life," he added.

With 37 years of experience in coaching, Coach La Foucade explained that his focus was not just on the senior women's team but that he would be looking at players from the 'grassroots level' up and the plan is for the programme to function like a conveyor belt to bring talent up through the ranks.

"Everyone deserves a chance and we want to give players the hope and the chance to make the National Team," he remarked, adding:

"We cannot guarantee winning, but what do you view as winning - pride for country, raising the bar of the when, where, how and why and inspiring them is important. Sport is a great vehicle for building better citizens."

As a result of Coach La Foucade's international exposure, it is hoped that the Cayman Islands' women's team will also be exposed to more competition, which CIFA officials explained is an integral part of Cayman's development.

"With the right investment in our programme we will get to a level where other teams in the region will want to play us," noted the officials on hand for the press conference introducing the new coach.

Part of structuring the revamped approach to Cayman's team development is identifying those women who are involved in several sports and working with the other sports teams to see how talent can best be utilised.

"We should not be fighting for players because different sports do help and so it will be an 'everybody in' approach. We can work together," said Coach La Foucade, who pointed out that it may be a matter of communicating with other coaches to work around commitments for other required activities for multi-sport athletes.

General Secretary for CIFA, Mr. Marcos Tinaco, explained that friends in the United Kingdom had first mentioned Coach La Foucade as a possible candidate for the coaching job in Grand Cayman.

"That was three months ago and our follow-ups gave us great assurance that he would be a plus for us. We are very impressed. We also believe strongly in spirituality and that was big part of his resume.

"We know that he had much better offers but what we are doing is from the heart and that is what attracted him to us. He really believes in helping young people," noted Mr. Tinaco.

CIFA is hoping for a long-term contract for the new new women's coach, with a view of 3 to 5 years.

Currently, Coach La Foucade is also pursuing a Post Graduate Diploma in Sports Management and has completed several coaching certifications at the FIFA and Concacaf levels.

Additionally, he has worked as the coaching director at FC Boulder (USA), the technical director of La Foucade Soccer Clinic, (Trinidad and Tobago), and the Head of Trinidad and Tobago National U17 Male Team.

Coach La Foucade will be responsible for the day-to-day running of the CIFA Women's National Programs which will involve training and preparing teams for international competitions.

He will also be charged with creating a sustainable women's football development programme that will encompass women's football at all levels.

With the recent success and growth of women's football in the Cayman Islands, CIFA officials said, the Association strongly believes the time has come for women's football to be appointed a designated coach.

"The Association is pleased to announce the appointment of Coach Dion La Foucade as the person who will be responsible for women's national football technical activities in the Cayman Islands," noted CIFA officials.

Financial Services Ministry Delegation Meets EU Stakeholders

Exchanging policy updates on anti-money laundering (AML), tax cooperation and industry sectors, while also forging deeper, proactive engagement with European stakeholders, were key outcomes of meetings between EU stakeholders and a Ministry of Financial Services and Commerce delegation, led by the Minister, the Hon. nocke, Head of Isle of Man Brussels Office; and other officers and advisors from the Isle of Man and the Channel Islands.

Minister Ebanks then travelled to Paris to join the Attorney General, the Hon. Samuel Bulgin, KC, at the Financial Action Task Force (FATF) Plenary, which commenced yesterday (19 June) and concludes on Friday, 23 June.

"During the Plenary, the Hon. Attorney General and I will speak before the Financial Action Task Force, as part of the process for FATF removing the Cayman Islands from the list of jurisdictions being monitored for anti-money laundering deficiencies," he said.

"Our country has come a long way, having satisfied 62 of 63 Recommended Actions toward this goal, and we will present our substantive progress in satisfying the last remaining action."

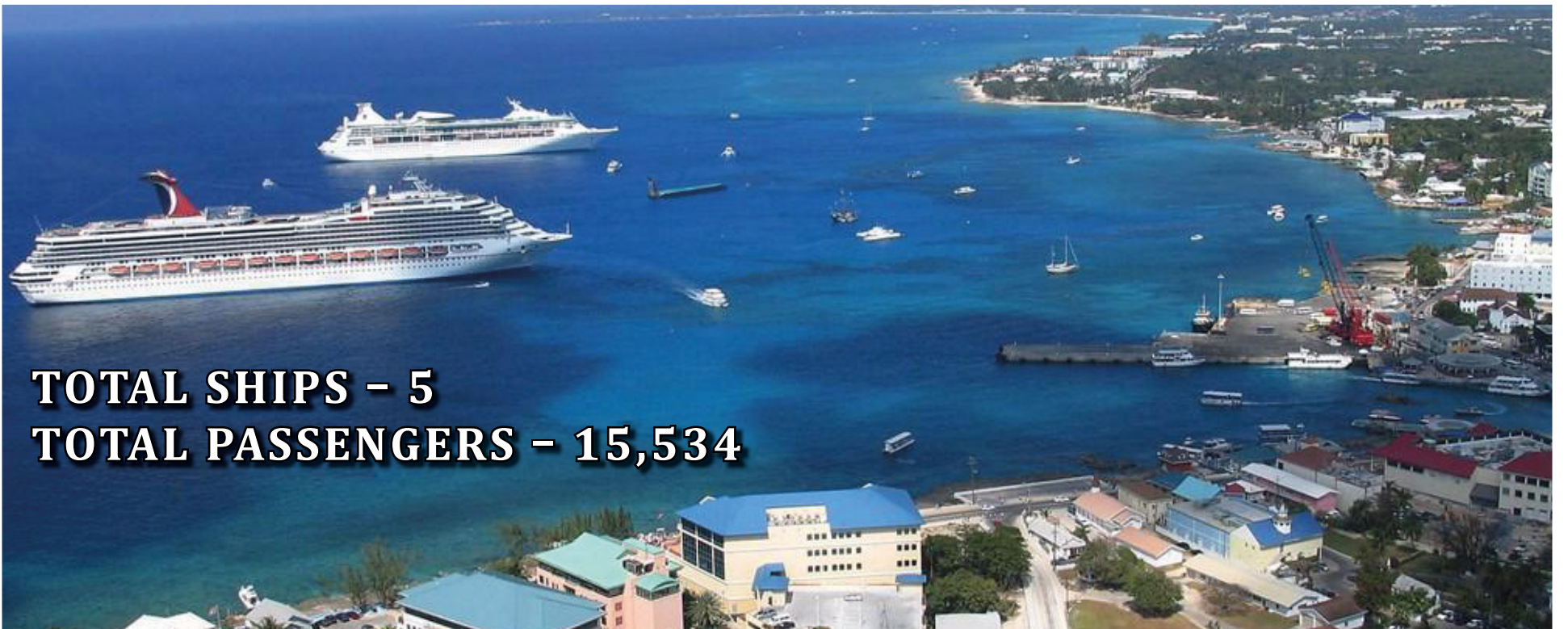

Certified intermediate trainers Ministry of Education (MOE) Senior Policy Advisor & Manager (Inclusion) Dr. Aidan Tumilty and Policy Advisor (Safer Schools), Mrs. Sheryl Williams-Patterson, facilitated the weekly sessions at the Clifton Hunter High School.

Mr. Rox Roy Geoghagen was one of the trainees. He shared, "Participating in the training sessions has improved my ability to de-escalate potentially harmful situations by staying composed, actively listening and using non-threatening language. I wholeheartedly thank the Ministry for providing these useful sessions."

Mr. Geoghagen and the other new trainees join more than 220 persons from educational institutions around the Cayman Islands that have completed

this training module since its introduction in October 2022.

The Ministry of Education recommends that at least one person employed at each school has specific training in de-escalation and safe handling techniques.

Acting Chief Officer Ms. Lyneth Monteith remarked, "At a time when the ability to de-escalate situations and safely manage an evolving or actual behavioural crisis is becoming increasingly important for those who work with children, I am pleased that we have been able to offer this critical training to even more of our education stakeholders."

Ms. Monteith continued, "By employing the least intrusive method to support our children and ensure their safety, we are better able to build relationships of trust and understanding with our students and find solutions for issues that may arise."

Feedback Requested on United Kingdom's Relationship with its Overseas Territories

The United Kingdom ("UK") Parliament's Public Administration and Constitutional Affairs Committee ("the Committee") recently issued a call for evidence in connection with the constitutional arrangements of the UK's Overseas Territories, including the Cayman Islands.¹ In fulfilment of its constitutional mandate, the Constitutional Commission now seeks to provide a contextual explanation for this request, along with links to additional resources to assist persons who are interested in making submissions.

Background

The Committee's call for evidence is premised on gaining a better understanding of whether the relationships between the UK and its Overseas Territories are fit for purpose. Noting that each of the UK's Overseas Territories are unique, the Committee's Chair, William Wragg MP, has advised that: "We recognise that there is no 'one size fits all' framework for relations between the UK and the Overseas Territories, but by better understanding how existing arrangements operate in practice, we can better assess whether they are satisfactory and appropriate in the 21st century."

This Committee has also acknowledged that this call for evidence is timely in light of the passage of the Sanctions and Money Laundering Act 2018, where the unusual step was taken by the UK Parliament to extend this Act to cover Overseas Territories as well as the UK. In the Cayman Islands, this precipitated constitutional discussions with the UK, which ultimately resulted in the Cayman Islands Constitution (Amendment) Order 2020 and some realignment of the way in which the UK Parliament and Government interacts with the Cayman Islands.

This initiative now presents a further opportunity to analyse and consider this relationship, which as the Committee's Chair, William Wragg MP, has also observed, is important because "... with no official representation in UK Parliament, these constitutional arrangements are often misunderstood or overlooked."

Scope of the Call for Evidence

The Committee is seeking evidence on how the UK Parliament and the UK Civil Service engages with the Overseas Territories; how the interests of the UK Overseas Territories are represented in the UK Parliament; and how the rights of British overseas citizens are protected.

Submissions addressing any or all of the following questions are welcomed:

- Are the UK's current constitutional arrangements as regards the overseas territories satisfactory in these processes?
- Are effective mechanisms in place for the interests of the Overseas Territories to be represented internationally?
- Are the rights and interests of British overseas citizens effectively protected by the current constitutional arrangements?

Biodiversity workshop to help prioritise local conservation efforts

An upcoming biodiversity strategy workshop will bring together local public, private and non-profit stakeholders to develop a unifying vision and strategic priorities for biodiversity in the UK Overseas Territories including the Cayman Islands.

The Cayman Islands Department of Environment (DoE) is leading the workshop in collaboration with visiting representatives from the Joint Nature Conservation Committee (JNCC). JNCC is the public body that advises the UK Government and devolved administrations on UK-wide and international nature conservation.

DoE Director Gina Ebanks-Petrie explained the JNCC has a long history of supporting local biodiversity action and coordinating opportunities for conservation across the UK Overseas Territories.

"This workshop comes at an opportune time, following the introduction of natural capital accounting to the Cayman Islands, and coinciding with efforts to develop a

national Climate Change Policy and an increased call from the local community to safeguard the ecosystem services our unique species and habitats have provided to our people for centuries," she said. "By bringing together local and international stakeholders, this workshop will help develop a unifying vision and strategic priorities for biodiversity to support our national conservation goals, and identify funding gaps that can be filled by Darwin Plus grant schemes."

Invitees to the workshop include representatives from more than 15 public, private and non-profit organisations.

During their visit the UK team, which includes a representative from the UK Department for Environment Food and Rural Affairs (DEFRA) which manages the Darwin Plus fund, will be visiting a number of the local projects benefiting from UK Darwin Plus funding. These include Blue Iguana Conservation (BIC), the DoE's sea turtle programme which is assessing the likely effects of climate change on Cayman's wild



sea turtles, and a Darwin Plus Local grant to a local naturalist working to preserve endangered endemic orchids.

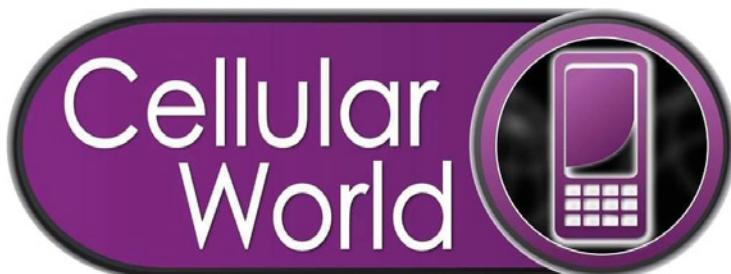

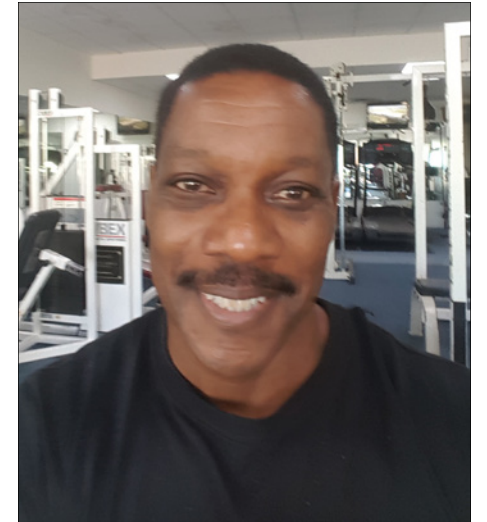
