

## **Electoral Boundary Commission Meetings**



The Electoral Boundary Commission will host a series of community meetings from July 4 to 6 to propose the constituency boundaries and provide insight as to how they are determined. The public is invited to attend and participate in the meetings by sharing their comments on the proposed boundaries. The Commission advised that of the 19 constituencies, 15 of these are affected by the proposed boundaries due to population growth experienced over the last 8

years. The districts of Bodden Town, and George Town to an extent, have been impacted the most. For countries that have adopted the single member constituencies it is common practice for these to be reviewed periodically in observation of population shifts.

Chairman of the Electoral Boundary Commission, Dr Lisa Handley explained, "The Commissioners have extensively reviewed census population data, toured the constituencies, and have held a series of public hearings to gather views from Caymanians about the process and potential outcomes."

There is a possibility that a voter's constituency may change should the proposed electoral map be approved by Parliament. In the event of this taking place, the Elections Office will advise the affected voters. Meeting Dates and Locations:

## SPEAKER OF PARLIAMENT HONOURS 134TH WORLD PARLIAMENT DAY, PAYS TRIBUTE TO CAPT. ELDON KIRKCONNELL

The Speaker of Parliament, Hon. Katherine Ebanks-Wilks, recognised the United Nations' World Parliament Day and its theme of climate change, through identifying the power of parliamentary governance on the same day that the Parliament paid tribute to the passing of former MLA Capt. Eldon Kirkconnell.

The United Nations celebrates the International Day of Parliamentarism each year on 30th June, the date on which the Inter-Parliamentary Union (IPU) was founded in 1889. The Commonwealth Parliamentary Association, of which the Cayman Islands is a member, also celebrates the date though refers to it as the World Parliament Day.

This year's theme as set by the IPU is Parliaments for the Planet, which focuses on the role of parliamentary legislatures in taking action to mitigate the dangers of climate change.

"I was pleased to see that the World Parliament Day included parliament's role in reviewing, debating, and improving policies around climate change," noted the Speaker. "Having recently returned from a Commonwealth Parliamentary Association conference on disaster risk management, I feel uniquely primed to lead Parliament into these important discussions on how to best support our country as we prepare for the challenges and changes of the future."

During the recent Meeting of the Parliament in April, the Government presented the Strategic Policy Statement for 2024-2026, which included a specific outcome of supporting climate change resiliency and sustainable development. Parliament serves as the arena within which policies can be debated, refined, and improved.

The Cayman Islands' legislature was formed on 2nd January 1832, just three days after the first assembly of elected officials met at Pedro St. James. Over nearly two centuries, the legislature has had a long history of Members who have served in public office to strengthen parliamentary democracy, pass and debate laws, and establish the constitution.

On this particular World Parliament Day, the Parliament honoured the passing of former MLA, Capt. Eldon Kirkconnell, OBE, JP, through hosting a formal Lying-in-State. Attended by Her Excellency the Governor Mrs. Jane Owen, the Honourable Premier Wayne Panton, and several other current and former Members, the Speaker noted the significance of parliamentary democracy through the service Capt. Kirkconnell provided to the Cayman Islands.

"Even as we mourn the loss today of an outstanding former Member of the Legislative Assembly, Capt. Eldon Kirkconnell," said the Speaker, "we also recognise with enormous gratitude his tremendous service to this country, especially today on World Parliament Day, when we pay tribute to the tremendous role of parliamentary democracy as a whole in maintaining public trust and engagement."

## MORE LEGAL WOES FOR MCKEEVA BUSH

By his own admission the 'senior politician' referred to by the Royal Cayman Islands Police Force in several recent press releases about an arrest on historical rape allegations, is MP for West Bay West McKeeva Bush, the former Speaker and former Chief Minister of the Cayman Islands.

In one statement dated June 28th, the RCIP said it "can confirm that a senior politician attended the Cayman Islands Detention Centre (on) Wednesday 28 June, and was arrested and formally charged with Rape and Indecent Assault, in relation to a criminal complaint of a sexual nature dating back to 2000. The accused appeared in Court this morning via Zoom."

Mr Bush has pleaded not guilty and is adamantly proclaiming his innocence.

The matter has been picked up by the international press, with the American ABC News reporting that Mr Bush told the Associated Press(AP) news agency in a statement that he 'rejected, denied and pleaded not guilty to what he called "this evil plot" and malicious accusation".

"Truth will come out. This is done by someone I never had any contact with," he asserted.

Cayman Islands Premier Wayne Panton has issued a statement on the matter saying the news of the charges against Mr Bush "has no doubt been met with concern across our community."

"These charges are serious," the Premier commented. But he noted that "given the sensitive nature of the same, the rights of the parties involved and the fact that matter should now be re-

garded as sub judice, it is inappropriate for me to comment further other than to say that I believe in the integrity of our judicial system and this is now a matter for the courts to address." Meanwhile, the Leader of the parliamentary opposition, Roy McTaggart who heads the People's Progressive Movement(PPM) party, is putting pressure on the Premier to remove Mr Bush from the parliament's Public Accounts Committee on the basis of his latest legal woes.

"We now ask whether Premier Panton intends to continue allowing Mr Bush to remain as part of the PACT Government, and sit on the government benches, and to also allow him to continue as a member of the Public Accounts Committee," the PPM leader said in a press release.

"Mr Bush is currently facing other serious charges against him involving two females," McTaggart said. "That case will be going to trial later this year. Also, in December 2020, Mr Bush pleaded guilty to a charge of disorderly conduct and two counts of assault on a female."

This is the most recent legal trouble faced by the former Speaker, ex-chief minister and long-standing MP for West Bay West.

He is facing trial after being charged earlier this year with disorderly conduct and assaulting a woman. In the ensuing political turmoil, Mr Bush formally relinquished the position of Speaker of Parliament after he was called on by Premier Panton to step down.

In 2020 he was convicted on charges of assault against a woman and received a 60-day custodial sentence suspended for two years and placed under a curfew.

## Saharan dust has pros and cons

The season's first plume of Saharan dust is arriving in the Caribbean from across the Atlantic, bringing beautiful sunsets and hazy skies. When clouds of dust billow off West Africa, they form what meteorologists call the Saharan Air Layer.

The annual peak period of the Saharan Air Layer, which started in West Africa at the start of the year, is now at its peak. This layer floats at altitudes between 5,000 and 15,000 feet. If the layer is dense enough, it can smother an emerging tropical storm like a blanket on a fire. Some of the dust is rich in iron and phosphorus, so when it lands in the ocean, it acts like a fertilizer for phytoplankton.


The plume hoists so much dust into the skies that some of it ends up in the

south-eastern United States. Its particles are so fine they can enter your bloodstream and trigger asthma and allergies. While Barbados is typically the first land mass Saharan dust reaches, the particles often travel further, even reaching the United States' Gulf Coast, as witnessed recently.

Activity typically intensifies around now until mid-August, according to the

National Weather Service. The Individual Saharan dust plumes have reached Florida, Central America and the Caribbean during the peak period and can even cover most of the Atlantic and the US.

While the current dust plume should bring seasonal concentrations of dust to the tropical Atlantic, it's largely underwhelming so for this time of year.

So far in May and June, outbreaks of Saharan dust have been at record lows throughout the tropical Atlantic going back at least 20 years, which has contributed to the exceptional ocean heat wave across the north Atlantic this summer.

The Saharan Air Layer is a mass of dusty and dry air that can be up to 2.5 miles thick and can start hovering at just 1 mile above the earth's surface.

A plume of Saharan dust moved into Cuba and The Bahamas recently. The pretty sunsets are formed when dust particles from the plume make the sky erupt in more vivid colours like orange, pink, and red during sunrise and sunset. They last longer, too.

Another positive of Saharan dust is that it helps keep tropical activity down. Its warmth, dryness, and strong winds typically suppress hurricane development and intensification. More specifically, it's extremely dry air weakens tropical disturbances and hurricanes by promoting downdrafts around the storm. Its warmth helps suppress the formation of clouds, too.

## Le Petit Bar Earns Wine Spectator Recognition

The space might be small as its name suggests, but Le Petit Bar punches way above its square footage when it comes to its wine list. Now this little wine bar in the Jacques Scott Marketplace plaza in West Bay is getting heavy-weight recognition overseas.

On Monday, 26 June, Wine Spectator magazine announced its 2023 recipients of it coveted "Restaurant Awards." Le Petit Bar earned the "Award of Excellence" and joined nine other Grand Cayman-based restaurants to receive Wine Spectator recognition for their wine lists.

In addition to more than 200 selections on its wine list, Le Petit Bar also has one of the most extensive wines-by-the-glass menus on Grand Cayman. Co-owner Shalico Christian said offering a large selection of wines by the glass is a key component of the Le Petit Bar business model.

"Having been involved in Cayman's hospitality industry for more than a decade, I was keenly aware of the lack of affordable

and varied wine-by-the-glass programmes here," he said. "Most of the restaurants and bars in Cayman only offer small selections of wines by the glass and they're usually mass-produced wines that aren't particularly interesting. Here at Le Petit Bar, we offer more than 30 different wines by the glass at various price points made from a wide variety of grapes from countries all over the world."

Le Petit Bar wine director and co-owner Christian Esser said he takes pride in selecting a wide range of interesting, high-quality wines.

"We have been open for only a little more than half a year, but our sister business, WineSchool3, has to offer a wide variety of wines for our students to taste," he said. "As a result of all the relationships we've developed to do that, we have been able to quickly curate a compelling list of more than 220 wines from all over the world for Le Petit Bar."

WineSchool3, which opened in 2014, is

the only educational organisation in the Cayman Islands that offers certificates related to wine knowledge through the London-based Wine & Spirit Education Trust. It uses Le Petit Bar as its "classroom" on Mondays and Tuesdays, the two days of the week when the bar is closed to other patrons.

Earning the Wine Spectator Restaurant Awards was not the only international recognition Le Petit Bar received recently. In the "Where to drink fine wines in the Caribbean" that appeared in The Times on 15 June, journalist Nina Caplan wrote about Le Petit Bar, mentioning both Esser and Christian. She particularly noted Le Petit Bar's wine-by-the-glass selection.

"It's an informal hangout with rum barrels for stools and a by-the-glass list ranging from white Burgundy to Cabernet Sauvignon made in Margaret River, Western Australia," she wrote.

## **Cayman Satisfies FATF Action Plan; Onsite Visit Authorised**

Having now fully satisfied the action plan given by the Financial Action Task Force (FATF), the Cayman Islands is eligible to be removed from the list of countries the FATF is monitoring for deficiencies in their anti-money laundering and countering the financing of terrorism (AML) regimes, subject to successful completion of an onsite visit by the FATF.

FATF announced its decision today (Friday, 23 June) following its plenary. The Attorney General, the Hon. Samuel Bulgin, KC; the Minister of Financial Services and Commerce, the Hon. André Ebanks; and the Head of the Anti-Money Laundering Unit, Mr Francis Arana, attended the plenary to represent the Cayman Islands and discuss progress made on the last of the three recommended actions in the FATF Action Plan.

As a standard requirement, the delisting process involves an onsite FATF visit, tentatively scheduled for late August or early September. During the onsite visit, FATF assessors will visit the Cayman Islands to meet in person with local stakeholders to assess the operation of our action plan in practice, and its sustainability.

An onsite visit report then will be presented at the next FATF Plenary, now scheduled for October this year, at which the Cayman Islands will receive confirmation as to whether it will be delisted.

FATF listed the Cayman Islands in February 2021. To be delisted, FATF required us to complete three recommended actions. These three actions were what remained from 63 actions, following a Post Observation Period Report to the FATF in February 2021.

"Satisfying all of the 63 recommended actions is a major step towards the Cayman Islands being delisted but, as is the case for other listed countries that met this milestone, there is one more step to complete, and all relevant stakeholders need to remain focused," Minister Ebanks said.

The Attorney General noted that preparations are already underway for the onsite visit of the Americas Joint Group - a subgroup of the FATF's International Cooperation Review Group (ICRG), acknowledging that "the FATF process is rigorous with reason. Its purpose among other things, is to ensure that local authorities can effectively deter, detect, investigate and prosecute serious crimes."

He and Minister Ebanks said the Cayman Islands looks forward to continuing our cooperation with the FATF Americas Joint Group during their onsite visit, in order to complete the last step of the delisting process. A final decision will be made by the FATF at Its October 2023 plenary.

## **Residents to Plan for Hurricane Season**

With the first month of the Hurricane season past without incident to the Cayman Islands, officials continue to encourage residents to have hurricane supplies and plans ready in preparation for the season.

Director General at the Cayman Islands National Weather Service (NWS), John Tibbetts said that storm forecasting will be somewhat challenging this season due to two separate dynamical events taking place. "The first dynamic is unusually warm sea surface temperatures in the Caribbean Sea which tends to lead to greater intensification of hurricanes. The second factor to consider are signs of an El Niño forming in the Pacific. El Niño refers to above-average sea-surface tem-

peratures across the east-central equatorial Pacific, whilst La Nina is cooler water temperatures in the eastern Pacific," he explained.

Mr. Tibbetts shared that predictions for an El Niño – La Niña cycle is not an exact science, however, the general expectation from the scientific community is that an El Niño will form in the coming months. He further noted, "At the present time, we don't know how strong that El Nino will be however, the presence of El Niño would be good news for the Cayman Islands as it tends to hinder tropical cyclone development. This happens as El Niño generates additional vertical wind shear and these strong upper level winds weaken tropical cyclones as the upper circulation is blown away from the low-level centre".

As the team at NWS and Hazard Management Cayman Islands continue to gather data, residents are reminded that every season is to be treated and observed with caution.

Residents are encouraged to visit www. caymanprepared.ky for information to assist with making preparedness arrangements for their families, homes, valued belongings and evacuation plans if necessary.

Experts at the University of Colorado have predicted that the 2023 season will be slightly below average in activity.

## **Cayman Brac Daycare Centre Scores 'Good' Rating by Education Inspectors**





The Ministry of District Administration and Lands announces that the Cayman Brac Daycare Centre has achieved a score rating of a "Good Early Years Centre" by the Office of Education Standards (OES) for February 2023 Cycle 2. Good is the second highest performance rating that a school can achieve in an OES inspection.

Minister responsible for District Administration and Education, Hon, Juliana O'Connor Connolly expressed, "Inspection frameworks are a central feature of different school evaluation systems worldwide which is important as we aim to position the Cayman Islands in the global economy. The inspection framework is organised around judgements using a fourpoint scale weak, satisfactory, good and excellent. While we strive for excellence in our schools, Good is the expected level for every school in the Cayman Islands, both public and private. I am particularly pleased about the improvement of this rating in a short period of time. It tells me that the systems and provisions are prioritizing and serving the needs of our people. That is what it is all about, that is the core principle of the work we do."

The Department of District Administration hosted an event in Cayman Brac to officially unveil a new building sign that conveys the 'Good' rating. The event was attended by Government officials, school staff, students and members of the community in celebration of the achievement.

District Commissioner, B.L. Mark Tibbetts who served as the Master of Ceremony expressed, "We are absolutely excited to celebrate the work of the staff and students of the Cayman Brac Day Care Centre, the District Administration team and of course the parents and guardians for their collaborative efforts which have resulted in the achievement of a Good rating from the Office of Education Standards. Following the 2020 OES inspection the Centre received a satisfactory judgement. The team took the judgement of a "Satisfactory" rating seriously, and went about assiduously working toward meeting the expectations. This required some self-evaluation of our weaknesses, and the implementation of training for staff to provide them with the skills needed to improve the Centre's operations, and strengthen teaching and learning. '

All educational institutions are inspected regularly by the Office of Education Standards. The purpose of inspection is primarily to support ongoing improvement in each school and also to provide rigorous, impartial and comprehensive information to all stakeholders regarding the quality of education both in government and private educational establishments.

In the Early Years Inspection Report, the Cayman Brac Day Care Centre under the management of Mrs. Neila Jones, received a judgement of "Good" in all three indicators towards ensuring effective teaching to support our student's learning. These three indicators are teaching, learning, and assessment. They also scored "Good" for Curriculum and for keeping students safe and always supported.

## **WORC** Operation Targets Persons Working Outside the Law



The Enforcement & Compliance Unit at Workforce Opportunities & Residency Cayman (WORC) continue their operations whereby enforcement inspections are carried out.

In partnership with the Royal Cayman Islands Police Service (RCIPS), the opera-



tion's purpose was to seek out persons or employers who are in contravention of the Immigration Transition Act.

The operation focused on inspections at a number of local bars in the George Town area and an air conditioning company. These inspections were deemed necessary due to information received and the proactive action of WORC officers.

The two separate operations found three (3) persons in violation which resulted in arrests for working outside the terms and limitations of their work permits. Acting Deputy Director Mervin Manderson stated "Nearing the end 2022, WORC Compliance Officers carried out a series of proactive operations which continued into 2023. Although we previously reported on the 2022 operations which resulted in arrests, persons and employers continue to carelessly breach the Immigration Transition Act. Employers are reminded to ensure their staff are working with valid permits and in the correct occupations."

He further stated, "Employers can complete an amendment application to capture separate work duties instead of allowing them to work outside of their permit terms."

WORC continues to investigate information received from the public and will execute operations when necessary to bring offenders to justice.

## **STOP THE CARNAGE ON CAYMAN'S ROADS!**



There's been an alarming spike in serious traffic accidents in Cayman, including road fatalities.

Already this year there have been five deaths in road accidents. In all, there has been a startling 37 deaths on our roads over the past three years alone.

Concerned about this worrying trend, the Royal Cayman Islands Police Service is stepping up vigilance and targeting the growing menace of drunk driving on the roads which is the cause of numerous road accidents.

The scale of the problem was addressed on the Caymanian Times radio programme and live-stream, Cayman Conversations with host Ralph Lewis, the newspaper's publisher.

Appearing on this edition of the program



discussing this issue of grave national concern were RCIPS Chief Superintendent Brad Ebanks and RCIPS Media Officer Jodie-Ann Powery.

"As we continue to get the population growth and the number of cars and drivers on the roads, we do expect to see an increase in motor vehicle accidents," said Chief Superintendent Ebanks.

According to police traffic analysis, peak hours for accidents tend to be in the morning, lunchtime and the afternoons. "We will see peak hours for four hours for minor to moderate motor vehicle accidents. Later in the night and into the mornings is when we tend to find more serious accidents."

Among steps being taken by the RCIPS to

'arrest' this situation is a combined strategy of enforcement and engagement, as explained by Media Officer Powery.

"Some of the things that we do to try to reduce the number of accidents is high visibility patrols, especially in those key times to discourage poor driving behaviour. And at night-time especially we hold what we call vehicle checkpoints. The public knows them as police roadblocks and these are also just specifically for deterrence."

To date for this year, the RCIPS reports that it has already issued more than 5000 tickets, 700 more than for the same period last year.

This points to the scale of the challenge facing the police and other authorities as they try to bring this problem under control.

The statistics become all the more worrying considering that for all of 2022, there were 234 arrests for DUI (driving under the influence) but so far this year the number is already up to 130. Traffic accidents are also on the increase with 1700 recorded to date for this year compared to 1400 for all of 2022, which was already a large number.

The RCIPS officials warn that offenders will be prosecuted to the full extent of the law for both serious accidents, repeat offences and other breaches of traffic regulations.

Reflecting on the 37 road fatalities from 2020 to 2023 including five so far this year," Chief Superintendent Ebanks lamented, "That is a massive, massive number of deaths



on our roads. So I want to appeal to the public that road safety must be everyone's primary concern. Safety for ourselves and safety of other road users is paramount."

And he had this sombre message for all road users in Cayman: "Before going out this weekend or any other weekend by night, please make plans to get home safely. If you plan to drive do not drink, and vice versa."

The Chief Superintendent said that drunk driving and speeding are the main contributing factors to road fatalities. He also disclosed that "as it stands now, road fatalities and firearm-enabled crime are the RCIPS's two major major concerns that we're dealing with."

He said the RCIPS is "going into it head on" with the hope that their efforts will curtail the carnage being witnessed on the streets of Cayman.

"So be careful. In other words, have discipline when you use the roads. In other words discipline and some consideration for other road users."

## **Armed Robbery at Savannah Gas Station**

Shortly after 10:00PM, Friday 30 June, officers responded to a report of an armed robbery at a gas station on Shamrock Road, in the vicinity of Homestead Crescent, Savannah, Bodden Town.

It was reported that two men entered the gas station store, one armed with a firearm. The man with the firearm guarded the door while the other man proceeded to jump the counter and take money from the cash register.

The men exited the gas station on foot in the direction of a church on Homestead Crescent.

The man with the firearm was described as 6' tall, wearing blue pants, black hoody, and

white gloves. The man that stole the money was described as 6' tall, wearing a black hoody, white gloves and blue and white pants.

The incident is under investigation and anyone with any information, or who may have witnessed anything suspicious in the area around the time of the incident, is asked to contact Bodden Town Police Station at 947-2220.

## Net gains at CAC

The Cayman Islands national netball team travelled to El Salvador to prepare for Monday's start of the Central American and Caribbean Games (CAC) Games.

Besides Cayman, the Games will feature Jamaica, Trinidad & Tobago, Barbados, Dominican Republic and St Vincent and the Grenadines.

Netball icon Lyneth Monteith, head coach of the CINA CAC squad, joined Caymanian Times publisher Ralph Lewis on his radio show Cayman Conversations just before she left with the squad to compete at the Jose Adolfo Pineda National Gymnasium in San Salvador, El Salvador. Ida Jane Ebanks is managing the team.

Monteith said: "This is a historic competition. For many years overtures have been made to have netball in the CAC Games. It is Olympic--sponsored. This is really historic, never before done, and the Cayman netball squad is one of those teams that will be playing. We are playing against some of the top five teams in the Caribbean. This is a tremendous opportunity for netball to be showcased."

The competition finishes on Friday, 7 July. Other sports such as basketball, rugby and swimming are staged as well as track and field. Unlike other international tournaments that allow expats to compete for their adopted nations, the CAC Games do not, so the Cayman team will comprise of only Caymanian nationals. As a result, this is a really young team with only one player aged over 21.

"The majority of them have been play-

ing together since Under-14, so I think that bodes well because we've had that continuity coming up," said Monteith. "It also bodes well for the Cayman Islands senior squad. Obviously, as persons age up you need to have persons to take their places. This is really what we're building now and I can see that will pay dividends in the future."

She added that she is "really excited by this young squad" because later on in the year there is a competition in Antigua where older netballers will be allowed to play which she thinks will create "a tight, cohesive, well-playing squad".

Monteith added: "I'm really excited now about what direction netball is going as we develop the younger ones and

also the grassroots so that we have that continuity going through."

The strongest teams in the region are Jamaica, Barbados, Trinidad & Tobago and St Vincent. Monteith believes that with further development Caribbean teams like the Cayman Islands can also be "a force to be reckoned with".

The exposure to playing the best nations in El Salvador will be an invaluable learning experience Monteith feels in terms of fitness, tactics and technique. Game play is the most vital aspect to improve, she said. "I have seen teams build from strength to strength. In 2019, just before Covid, we went out twice, to Isle of Man and St Maarten. We didn't do as well as we wanted in Isle of Man but we won the competition in St Maarten. That shows that the more you can hone your skills, the more you can raise it to the next level."

Ralph Lewis said that when he recently watched a practice session, he was impressed with the Cayman squad's commitment, discipline and work ethic. The umpiring will be in English but day to day interaction will be in Spanish. "That should be very interesting," Monteith smiled.


