

# PREMIER PRESCRIBES SPENDING CUTS

The emergence of a leaked government document in which Hon, Premier Wayne Panton has directed Chief Officers and Chief Financial Officers to rein in spending and consider areas of possible cutbacks, has sparked ripples of concern not just about the true state of government finances, but more importantly, the implications for the economy.

These concerns have been further underlined by a detailed statement from the opposition Progressives party in response to the Premier's leaked circular and its implications.

### FROM SURPLUS TO MINUS

The August 11th circular from Premier Panton innocuously titled Operating Expenditure Targets for 2023, states in part that "based on the current run rate of actual operating expenditure reported at June 30th 2023, the Government is on the path of exceeding the CI\$1.0 billion in operating expenditure in 2023 with further growth in expenditure for the 2024 and 2025 operating years."

Simply put, the government's spending at current levels, unless curtailed,

risks pushing the finances into deficit.

The spending reduction instruction follows the recent upbeat report on the state of government finances with a CI\$47.7 million surplus at the end of 2022 due to revenue totalling CI\$80 million more than expected in the November 2022 budget statement.

With the November 2023 budget just around three months away, that CI\$ 47.7

million surplus is being turned on its head with the PACT coalition seeking savings of CI\$ 47.1 million (or 8.5 per cent) effectively to balance the books by the time Budget Day rolls around.

This potential reversal of fortunes has not gone unnoticed and comes shortly after the government announced a series of spending increases and commitments. In a press release the Progressives leader, Roy McTaggart, stated: "The six-month financials indicate that at the half year, with a majority of government income already banked, only \$27 million in extra revenue has been received. That leaves a whopping \$32 million more that will be needed for Government to meet the Premier's new revenue target."

### **ECONOMIC IMPLICATIONS**

According to Mr McTaggart, this is now an issue that extends beyond the implications for government finances to potential risks to the wider economy.

"Let us dig deeper - the Government's latest figures suggest that growth in a key part of the economy is slowing," the Progressives (People's Progressives Movement) leader - and former finance minister - added.

"Last year, the Government boasted of significant surplus income from property and construction activity, making government finances more buoyant. Construction is known to be the third pillar of our economy. The Progressives have warned for months of an apparent slowdown in the sector."

With the PACT administration under Premier and Finance Minister Panton (who took over the role following the controversial departure of ex-finance minister Chris Saunders earlier this year), keen to balance the books by November, the opposition Progressives see the upcoming budget in November as critical.

"With question marks over the state of government finances and concerns over a large part of Cayman's economic prospects, the Government must take a long, hard look at its budget for 2024-25 that it will bring to Parliament before the end of the year," the opposition said

At the same time, the opposition party agrees with the move by the Premier to force his ministers to curb spending.

"The Opposition has consistently argued that the priority for spending needs to be support for Caymanians facing the cost-of-living crisis. Ministers seem more concerned about pursuing their pet projects. That must stop. There will be hard choices that have to be made. The Premier now seems to understand that, given his recent memo. We have repeatedly warned the Government of the need to prioritise their spending."

According to Opposition Leader McTaggart, to cut close to \$50 million in spending over the last four months of 2023 is a huge task.

"To achieve this, the PACT Government must show an unusual unity of purpose and collective restraint. Despite the huge ask, I do pray that the Premier can make it happen. The country does not need to enter a new budget period with concerns about a possible budget deficit for this year."

It has been observed that with the areas of cutbacks yet to be determined, the implications for businesses and others in the economy and society dependent on government contracts and payouts could be severe.

These include higher social support payments, increased funding of home repairs, the huge expansion to the Owen Roberts International Airport, and support for Cayman Airways as it expands its horizons

"It is important that Ministers/Official Members play a part in reinforcing this message to all of the agencies under their respective areas and take clear actions to restrict operating expenditure," stated the circular addressed to Cheif Officers and Financial Secretaries and copied to Ministers, Parliamentary Secretaries, and Caucus Members.

The opposition Progressives have pounced on this as expected, questioning the PACT coalition's revenue projections as unattainable and warning of the risks if corrective action is not taken.

The fall meant the turtle had turned onto her back and was therefore in need of assistance to get back up. The visiting family found her the next morning and managed to get the turtle turned right side up so she could make her way back to sea.


The DoE expressed their heartfelt gratitude to Bill, Debi and Anton Schneiderwind for helping the turtle, which they have named Naomi, make it safely to the sea, especially as the turtle weighed anything from 300 to 400lbs, so turning the animal over was not easy.

The DoE say if anyone finds a sea turtle in distress, call their 24/7 hotline anytime day or night on +1 (345) 938-NEST so that they can assist and log the incident.

Anyone considering plans to build structures, particularly along coastal areas, is invited to email the DoE's Environmental Management Unit on emu.doe@gov.ky early in the process. They can offer advice on how to build sustainably while minimising impact on native wildlife, like Cayman's nesting sea turtles.







# Suggested Hurricane Supply List

To prepare for the unknown, each home should have a 72-hour Disaster Survival Kit. You will need to pack some essential items to help you and your family survive, whether you stay at home or leave it during

Ensure at least three days (72 hours) supply for each person. Do not forget pets where applicable! The following is a minimum suggested list of Survival Kit supplies:

### **Drinking Water:**

- One gallon per person/per day in unbreakable containers, Avoid using containers that will decompose or break,l such as milk cartons or glass bottles. A normally active person needs to drink at least two quarts of water each day. Hot environments and intense physical activity can double that amount. Children, nursing mothers, and ill people will need more.
- Don't forget to add additional water for mixing formula if you have children and for your pets. Rotate the drinking water each year.
- Food preparation and sanitation require another two quarts (minimum) per person daily.
- Purchased bottled water that has been sealed is best for storage. It meets FDA guidelines for food and is not as vulnerable to temperature changes as unsealed water
- Tip: Purchase water this year and use it for drinking next year. This allows for rotation on an annual basis and keeps the water fresh. Yes water can go bad!

### Water for sanitation use:

- Store extra containers of water to be used for flushing toilets, cleaning, and bathing.
- Purchase water purification tablets (Halazone) to be used if you still have running water but are told to boil water before using it. This allows you to fill the bathtub and other containers without purchasing expensive drinking water.
- Tip: Keep plastic containers (milk jugs and other containers) and fill them with water when a storm threatens. You can put these items in the freezer to keep food cold longer in the event that the electricity goes out.

### Non-perishable Food:

- Maintain at least 3-7 days of food for each member of the family.
- Small, preferably single serving cans (should not require cooking or refrigeration). Dried fruit, peanut butter and jelly, coffee, tea, soft drinks and pet foods.
- · Ready-to-eat canned meats, fruits and vegetables.
- Canned juices, milk, soup (if powdered, store extra water).
- Staples sugar, salt, pepper in water proof containers.
- High energy foods like crackers, granola bars, trail mix.
- · Raw vegetables that do not need refrig-
- Fresh bread.
- Comfort/stress foods cookies, hard candy, sweetened cereals, lollipops, instant coffee, tea bags.
  - Sterno for cooking.
  - Vitamins
  - Food for infants
  - Paper cups, plates, and plastic utensils
  - Non-electric can opener
  - Aluminum foil
  - Plastic storage containers
- Lots of ice (you can freeze your water
- Pedialyte (to restore hydration if needed)
- Tip: Purchase only items that you like to eat and would eat even without a storm. Ro-

tate these items by using them Dec-May each year and purchasing new items Jan-May. This allows you to reduce the cost of buying items for a hurricane kit at one time and keeps the items fresh. Yes even canned goods have a shelf life!

### **Baby Needs:**

- Special foods (enough for several days)
- Formula (enough for several days)
- Extra diapers
- Medicines (get a copy of prescription)
- Blankets • Diaper Rash Ointment
- Baby Wipes
- Powder
- Bottles
- Pacifier
- Favorite toy/blanket
- Medicine dropper
- Diaper-rash ointment

### Sanitation

- Toilet paper, towelettes, soap, baby wipes, liquid hand sanitzer
- Liquid detergent
- Feminine supplies
- Personal hygiene items (toothpaste, deodorant, shampoo etc.)
- Plastic garbage bags, ties (for personal sanitation uses)
- Plastic bucket with tight lid
- Household chlorine bleach, disinfectant
- Plenty of absorbent towels

### First Aid Kit

- Assemble a first aid kit for your home and one for each car.
- Adhesive bandages various sizes Sterile gauze pads (various sizes) Germicidal hand wipes or waterless alco-
- hol-based hand sanitizer • Non-latex gloves - Adhesive tape - An-
- ti-bacterial ointment Antiseptic spray • Cold packs (non refrigerated type) - Scis-
- sors Tweezers Rubbing alcohol • CPR breathing barrier, such as a face
- shield Thermometer, Safety pins.

### **Non-Prescription Drugs**

- Aspirin or nonaspirin pain reliever, Benadryl, peroxide
- · Anti-diarrhea medication, Antacid (for stomach upset)
- Syrup of Ipecac (use to induce vomiting if advised by the Poison Control Center)
- Activated charcoal (use if advised by the Poison Control Center)

### **Prescription Drugs**

- Heart and high blood pressure medication
- Insulin (enough for a 30 day supply)
- Hearing Aid and extra batteries
- Prescription drugs
- Denture needs
- Contact lenses and supplies
- Extra eye glasses
- Tip: If your insurance will allow, get a 90 day supply of prescriptions and have at least a 30 day supply on hand. Don't wait until a couple of days before a storm to go to the pharmacy for refills you may not get your prescription refilled; the lines are long and they run out of supplies very

# MOE Welcomes New & Returning Educators for the Start of New Academic Year; Thirty-Seven New Caymanian Educators Recruited

The Ministry of Education on Friday (18 August) welcomed over 900 public school educators back for the 2023/2024 academic year.

"Today I extend a special welcome to our returning educators and the 137 new educators, of which 37 are newly qualified Caymanians, "remarked MOE Acting Chief Officer Ms. Lyneth Monteith as she delivered the official welcome remarks at the Annual Education Professionals Welcome held at the John Gray High School Gymnasium.

In welcoming the new Caymanian educators Director of Education Services, Mr Mark Ray, stated, 'Welcome home to the place you have chosen to form the most important bonds of your life."

He likewise thanked the returning educators for their continued service. "Your experience, expertise, insight, skills, talents, and most importantly, your love for our students are what we value the most. We thank you for returning and being here with us on this journey."

Also, in attendance was Acting Governor, Hon Franz Manderson. He emphasised the importance of meeting the

nation's educational standards and encouraged all educators to strive for excellence in educating the youth.

Mr. Manderson stated, "We are going to put a lot of faith in you to deliver for our children and care for our children. We expect you to be parents, confidants, mothers, and fathers; the children are not coming to you perfectly but we rely on you to do your best every day to improve their lives and deliver high-quality, world-class education to our children."

### **Specialist Math Teachers**

In her remarks, Acting Premier and

Education Minister, Hon. Juliana O'Connor-Connolly, announced the recruitment of 14 math specialist teachers for the 2023/2024 academic year.

Mrs. O'Connor-Connolly noted, "These 14 specialist math teachers are going into every primary school class, and they will be solely responsible for teaching math because that is their speciality, and we intend to see the next level of performance outputs greatly increase."

She also expressed gratitude to the recruitment team for their relentless efforts in fulfilling the staffing requirements of the Ministry in a timely fashion.

### New Digital Registration System

Mrs. O'Connor-Connolly also used the opportunity to announce the introduction of a new digital registration software called "Sign In App in schools starting from the 2023/2024 academic year.

"We will be implementing this programme in all schools as child safety has to be first and foremost and of paramount consideration," the Acting Premier remarked when referring to the software used to register attendees for Friday's event.

She thanked the ICT team for their assistance in implementing the programme and encouraged educators to help promote a smooth rollout throughout the schools.

### **Proposed Salary Increases**

The Acting Premier likewise recommended salary increases for several categories of educators, including assistant teachers, school leaders and their deputies, at the start of the 2024 calendar year.

Mrs. O'Connor-Connolly explained to the audience that the proposed salary increases were necessary because other categories of educators had already received salary increases in 2020.

She further stated, "It is time to complete that request for remuneration for educators."

Also on the agenda was the Health Services Authority's Dr. Delroy Jefferson, who delivered the keynote address. He underscored the importance of listening with patience and kindness in education. Dr. Jefferson urged educators to listen actively to improve their effectiveness. "Effective teachers don't only listen with their ears but also with their eyes, considering non-verbal cues and facial expressions," Dr. Jefferson remarked.

MoE Acting Deputy Chief Officer Mr. Adrian Jones gave closing remarks, and DES Deputy Director Mr. Elroy Bryan chaired the event.

Others in attendance at the event were House Speaker Hon. Katherine Ebanks-Wilks, Parliamentary Secretary for Tourism & Social Development Ms. Heather Bodden, Minister for Home Affairs, Youth, Sport, Culture & Heritage, Hon. ### 76 Air Conditioning Units Stolen



RCIPS Inform Public of Theft of 76 Air Conditioning Units

Around 1:00PM Thursday 24 August, police responded to a report of theft of 76 white 'Comfort Star' split air conditioning units.

The units were individually boxed and stored in two padlocked containers located on a vacant lot on Up The Hill Road, West Bay. The thieves have cut the padlocks to gain access to the units.

It was reported that the units were stolen sometime between the hours of midday, Thursday 17 August, and 12.30pm, Thursday 24 August.

The complainant estimates the value of the 76 units to be over \$14,000 CI.

A picture of the units is attached.

The units are likely to be shipped off island, or sold within the construction industry on island. The matter is under investigation and anyone with any information, or who may have witnessed anything suspicious in the area around the time of the incident, or might know the current location of the units is asked to contact CID at 949-4222, or 949-3999.

When this number is dialed, the caller

will hear the automated Cayman National Bank's voice greeting.

Police advise banking customers to always be vigilant and not provide any personal banking details over the phone to anyone claiming to be from your bank. Police further advise the public they should not call the specified fraudulent telephone number.

## Police Investigate Armed Robbery

Shortly after 7:30PM on Thursday , 24 August, officers responded to a report of an armed robbery that took place near the intersection of Rock Hole Road and Mary Street in George Town.

It was reported that shortly after 1:00AM, early that morning, a grey Honda Fit approached the victim and the occupants of the vehicle engaged the victim in conversation. The vehicle then drove off, only to return again shortly after. The passenger exited the vehicle brandishing a firearm, demanding a generator and power wash machine from the victim. After relinquishing the items to the men, they assaulted the victim and then drove off.

The passenger of the vehicle was described as dressed in full black clothing. Both men were wearing masks covering their faces.

All persons will be processed in accordance with CBC processing protocols.

## Police Warn Against Leaving the Scene of a Motor Vehicle Collison

On Tuesday 22nd August, around 6.20PM, RCIPS attended the scene of a motor vehicle collision involving a Dodge Ram truck and a cyclist on Esterly Tibbetts Highway at the junction with Snug Harbour Drive.

On arrival, officers observed a woman being attended to by medics, with what appeared to be blood on her arm.

It was reported that the collision occurred when the victim was riding her bicycle south along Esterly Tibbetts Highway and the driver of the truck drove out from Sung Harbour Drive and collided with her. The driver got out of the truck and stayed at the scene for a short time before leaving. He did not provide his details to the victim.

The police later identified the driver, and the incident is under investigation.

Police wish to remind the public that, according to the Traffic Act (2021 Revision), the driver of a vehicle is required to stop and provide their personal, vehicle and insurance information if they are involved in a collision where another person is injured or another vehicle or property is damaged. Alternatively, they must report the collision at a police station or to a police constable as soon as is possible, but no more than 24-hours following the collision

Persons who fail to do so may be arrested and prosecuted, which may result in a fine, imprisonment, or both upon Summary Conviction.

# CBC Makes Arrests and Seizes Vessel



The Cayman Islands Customs and Border Control Service (CBC) announces that on Sunday, 20th August 2023 an inbound commercial fishing vessel was boarded by Cayman Islands Coast Guard (CICG) officers and then escorted to the George Town Port by CICG.

The in-ward escort allowed for carrying out required vessel clearance protocols as established in the Customs & Border Control Act.

Between Sunday, 20th, and Monday, 21st August 2023, CBC and partner agencies conducted inspections of the vessel, its cargo, and crew resulting in the recovery and seizure of a significant sum of money along with four (4) packages containing a white substance, later

field tested revealing a positive result for cocaine.

Five foreign nationals (all males) were arrested and taken into custody in connection with the undeclared money and the importation of a controlled drug.

CBC Acting Director Bruce Smith stated, "This interception, arrest, and seizure is indicative of the dedicated CBC, Royal Cayman Islands Police Service (RCIPS), and CICG personnel and the strong collaborative spirit and good working relations that exist allowing the team to effectively respond to the tasks at hand."

He continued, "I commend all involved for their individual and collective efforts for maintaining focus and for their commitment to the ensuing investigation."


