These audits are the beginning of a service offering CUC hopes to launch soon.

Resilience Cayman Chairperson Jan Gupta said: "With the escalating cost of living, and the prohibitive cost of energy upgrades such as energy efficient ACs, the families that could benefit the most from better insulation and new ACs are the ones with the lowest financial means to do so on their own. This is where the CHEER programme comes in. Once we were selected by the Ministry of Sustainability and Climate Resiliency to deliver the programme, we reached out to CUC whom we have worked with previously for other community initi-

atives. I am grateful for CUC's support as they have offered to provide complimentary energy audits and energy monitors for this programme. CUC will assist us in identifying the sources of energy wastage in homes, and we can then work with our suppliers and contractors to replace or repair these appliances. CUC will also assist us to monitor the improvement in energy consumption for the months following the energy upgrades and we will be able to capture and share the impact of the CHEER programme with the Ministry."

Sacha Tibbetts, Vice President Customer Services & Technology, added: "CUC is fully supportive of the CHEER programme and its efforts to raise awareness for energy monitoring and efficiency. ## Natural gas suppliers sought

CUC are looking for qualification submissions from prospective natural gas suppliers in a bid to reduce the cost of energy production and reduce carbon emissions.

As part of the Cayman Islands National Energy Policy and CUC's Integrated Resource Plan, CUC said in a release they were committed to increasing the use of clean energy and reducing greenhouse gas emissions over the long-term.

In 2022, CUC began an infrastructure project to upgrade 68 megawatts of diesel generation to enable the use of natural gas as a fuel.

"Natural gas is a cleaner burning fuel than diesel and produces 30% less carbon emissions," they said. "The acquisition of a supply of natural gas will increase the energy diversity on Grand Cayman. This initiative will also assist the Company to ensure alignment with the draft revised 2023 - 2050 NEP policy targets, which calls for the majority of energy to come

from renewable and sustainable sources within the policy period."

As CUC and Cayman as a whole continues to grow and expand, CUC said they were delighted to launch this process in support of the transition to cleaner energy solutions.

trucks and other armored, all-terrain modes of transport.

Currently, there are 85 persons serving in the CIR, 7 of whom are full-time, while the others are reservists.


"Next year were are hoping to get to 125 personnel for maximum effect.



## Cabinet Approves Establishment of Asia Office in Singapore

During this week's meeting of Cabinet, the establishment of a Cayman Islands Government Asia Office based in Singapore was approved by Cabinet.

The office is being headed by the Government's Overseas Representative to Asia, Mr Gene DaCosta. After the required administrative filings have been completed, the office is expected to have a physical presence in Q4 2023.

Minister for Financial Services and Commerce, the Hon. André Ebanks, noted that the Asia office would promote all facets of the Cayman Islands, including (among other matters):

- establishing and nurturing strong public and private sector relations;
- creating effective communication between the Cayman Islands and key countries in Asia; and
- advancing financial services interests as well as all other areas of strategic interest to the Cayman Islands and generally enhancing the reputation of the Cayman Islands.

"The office will enhance the business development efforts of the Cayman Islands' financial services industry in the region and better capitalise on the many new business opportunities for the Cayman Islands that the Asian region has to offer. Singapore provides a relatively neutral position in the region, with very good flight connections



from which to launch business development efforts across Asia; a strong concentration of financial services firms, as well as a thriving maritime centre that has a synergy with the activities of our Maritime Authority," Minister Ebanks said.

Overseas Representative to Asia, Mr Gene DaCosta emphasised the efforts the Asia Office will make to develop and maintain strategic relationships in Asian jurisdictions such as Hong Kong.

"Having the office based in Singapore allows the Cayman Islands Government the

ability to quickly and effectively provide the necessary support our stakeholders in the region may require from time to time. Indeed, Hong Kong is a particularly important locale for us as it has longstanding, strong business relationships to Cayman. I'm expecting to have frequent inperson meetings in Hong Kong (likely quarterly visits at a minimum), alongside those that will occur in Singapore and other juris-

dictions in Asia," Mr DaCosta said.

The Cayman Islands Government Asia Office will be the latest public sector overseas office, with Government having a physical presence in London for decades and most recently in Washington, DC as of December 2022. Dr Tasha Ebanks-Garcia heads up the London office while Mr Chris Duggan is in charge of the North America Office.

Both the North America and Asia offices are under the remit of the Ministry of Financial Services and Commerce. Mr Duggan noted that since January of this year, his Washington engagements have yielded important governmental and private sector connections.

"We've implemented an extensive public and private sector engagement plan that has been successful in establishing and developing relationships with relevant congressional committees in DC, as well as in strengthening ties with relevant stakeholders within a number of key United States Government departments/agencies. The Minister, as part of his ongoing commitment to this mission, plans to travel again to Washington later this year to meet with key personnel from within these agencies and engage with key private sector stakeholders," Mr Duggan said.

Minister Ebanks reiterated the importance of the overseas offices in terms of advancing the country's interests and supporting Caymanians overseas.

"Our comprehensive and considered approach to establishing overseas offices have and will continue to underpin the strong links between Cayman and our key business regions, in this case Asia and North America. As they cultivate their operations, the offices shall promote our country's interests, initiatives and support, where appropriate, Caymanians residing overseas in these respective regions," Minister Ebanks said.

## FOI Hearing Decision 100: DOT sponsorship records must be released

An applicant under the Freedom of Information Act (FOIA) sought records related to partnership and sponsorship agreements made between the Department of Tourism (DOT) and various overseas entities for the purposes of promoting the Cayman Islands in foreign markets.

The request covered the years 2020-2022. The DOT granted the applicant some records, including various sponsorship or partnership agreements which were released with partial redactions. The

DOT withheld the business cases for these agreements stating that they contained trade secrets, and that their disclosure would harm the commercial value of the information and the commercial interests of the parties, therefore exempting them from release under section 21 of the FOIA.

The Ombudsman, Ms. Sharon Roulstone, found that the records which were withheld did not contain any trade secrets, nor did the disclosure of various business cases or agreements prejudice any com-

mercial values or interests. Therefore, the records were required to be disclosed in full, with exceptions for personal contact details and signatures of the private entities who were party to the agreements.

Ms. Roulstone also commented that there had been some procedural difficulties and lengthy delays in DOT's response to the FOI request.

"I cannot find any good reason for the slow and selective response the DOT gave to the applicant's request," the Ombudsman wrote in the hearing decision. "The final explanations for withholding some of the records were not given until more than a year after the request was made. This is not an acceptable way of answering requests under FOIA or of cooperating with my office."

The DOT has 45 days from the date of the decision to either release the remaining records or seek a judicial review of the Ombudsman's order to release the responsive documents. The Ombudsman also noted that this hearing decision marks the 100th hearing decision issued by her office, as well as by the former Information Commissioner's Office, since Cayman's Freedom of Information Act took effect in January 2009.

"The milestone of 100 hearing decisions since the FOIA was first enacted represents considerable time and effort by our Information Rights team. It is reassuring that Cayman's FOI process is still strong after all these years and that the Cayman public has kept an interest in their right to know," Ms. Roulstone said.

## John Gray student violence condemned

A shocking video of a violent altercation between students at John Gray High School has emerged this week, having taken place on Wednesday 13 September. The incident has been condemned by the Department of Educational Services.

The fight, graphically streamed on social media, appears to have been an assault on one male student by two other male students. They are seen punching the student while he tries to defend himself and, at one point, one of the two students making the assault is seen to be stomping on the victim's neck. Other male students are seen watching the fight and doing nothing to stop it.

DES Director Mark Ray said they were taking swift action in response to what he termed "this unfortunate incident".

Mr Ray said: "Upon receiving reports of the incident, school staff acted quickly to ensure the victim received medical attention. We extend our heartfelt support to the victim and his family and are committed to working with the school to provide counselling support to help him through this difficult ordeal."

Staff also called the police School Resource Officer, who apprehended and took the attackers into custody.

"In the interest of maintaining a safe and nurturing learning environment for all children, the school has decided to temporarily exclude the assailants from the school. Such conduct is unacceptable in our educational institutions, and we hope this action sends a clear message that violent behaviour will not be tolerated in our schools," he confirmed.

The DES Director encouraged all students to report incidences of bullying to a trusted adult.

"Your safety and well-being are our top priorities, and we are committed to taking all necessary measures to address and prevent such incidents in the future," he said.

Mr Ray urged parents to have open and honest conversations with their children about the importance of treating others with kindness and respect.

## Ministry lends support to John Gray

After the shocking incident circulated on social media of a violent assault by two John Gray High School students on another student, and their subsequent arrest, Ministry of Education and Department of Educational Services senior officials met at the school to support staff and reinforce the message that the incident did not define the government High School.

The team was led by Lyneth Monteith, the Acting Chief Officer of the MOE, and included HR Director Kimari Fletcher-Barrett, DES Director Mark Ray and Senior School Improvement Officer, Dr. Richard Wildman.

The DES Director issued a video message to address concerns over recent such incidents at the school.

He said the school consisted of caring dedicated staff and wonderful students. During the briefing, the government officials reminded the John Gray High School staff of the resources available to them including the employee assistance support

and they listened as the principal outlined the school's action plan.

Mr Ray said that in the coming days, student leaders' voices at John Gray High School would be heard.

"They will share essential messages on unity, responsibility and collaboration addressing regulating behaviours and bullying. These messages will be featured on the school's social media pages and shared across education platforms," he advised.

Mr Ray said they were also committed to increasing their collaboration with the RCIPS and other stakeholders to create a school environment where every staff member and student felt safe, supported and valued.

"With the unwavering dedication of staff, the support of parents other community stakeholders and the voices of our students we are fully committed to making that goal a reality," he stated.

He went on to say that the calls for collaboration and support were not limited to John Gray High School but indeed every government and



private school in the Cayman Islands.

"They are all our children and the country's future," he said.

## Police arrest escaped prisoner

Shortly before 7:30PM, Friday 15 September, police responded to a 911 call to service regarding a prisoner who had escaped the custody of prison officers while receiving medical treatment at the George Town Hospital.

On arriving at the scene, police officers pursued the prisoner and he was soon apprehended and arrested for Escaping

Lawful Custody. The prisoner was transferred to the detention center for processing.

A comprehensive investigation has been launched to ascertain the details of the escape. HM Cayman Islands Prison Service will continue to work closely with the Royal Cayman Islands Police Service on the investigation.

### Police Investigate Assault Incident at George Town High School, 14 September

At about 8:30AM yesterday, 13 September, officers responded to a report of an assault that had taken place at a high school gymnasium in George Town. It was reported that two students had assaulted another student, causing him injuries. The victim was

given medical attention at the school, then taken to hospital for treatment and subsequently discharged. The two juvenile males were arrested on suspicion of assault ABH. They have since been granted bail as investigations

## Man Charged with Seven Drug and Theft-Related Offenses

On Thursday, 7 September, officers in West Bay received a report of the theft of a bicycle. Officers later recovered the bicycle at an abandoned address in West Bay. The next day, officers attended the location and observed a man known to them who attempted to discard an item upon seeing the officers. Officers detained the man and recovered the item, which was a portion of suspected cocaine. The man, age 52 of West Bay, was arrested on suspicion of theft and possession and consumption of cocaine. Officers also found a piece of equipment in the man's possession, which had been reported stolen during a theft from a motor vehicle. The man was further arrested on suspicion of theft from a motor vehicle.

## TRINI...but not to de bone?

At a time when many countries are grappling with the thorny issue of immigration and citizenship, an almighty row has broken out in Trinidad and Tobago that casts the matter in the harshest glare.

Venezuelan Mileidy Materano was earlier this month crowned Miss Grand T&T earning her the right to represent the twin-island state at the Miss Grand International pageant in Vietnam on October 25th.

But celebration of her victory has been tainted by a backlash of anti-immigrant sentiment directed at her which has now spilled over from social media into reports of death threats being made against the pageant winner.

Much of the criticism is based on the fact that Ms Materano was not born in Trinidad and Tobago.

However, according to the local organisers of the pageant that doesn't matter.

Stolen Productions Ltd which has the franchise to stage the national pre-qualifier for the main event in October insists that their winner did not steal the title and that she met the criteria for participation.

"Our corporate sponsors, distinguished judges and pageant experts came together to orchestrate a show which we are proud to have put forward, representing the best of our beautiful twin-island republic and what our people have to offer on the international stage," SPL said in a statement.

On the direct controversy surrounding the selection of Ms Materano, the SPL declared that the judges decision was fair and final and they were sticking to it.

"While all of our contestants are crown-worthy, on the night of the final our esteemed judges and audience chose Ms Mileidy Materano as our Ms Grand Trinidad and Tobago. We at SPL stand behind the fairness of the judging process and the results. We stand in solidarity with our chosen winners," it affirmed.

However, that has not quelled the swell of vitriol targeted at the 29-year-old Venezuelan national who arrived in Trinidad and Tobago as a refugee in refugee.

She is said to have attained citizenship through sponsorship from a local business establishment. Ms Materano who has since set up her own business is said by the pageant organisers to have satisfied all the criteria for participation in the national event

Social media has been awash with debate and much criticism of the decision. While some have offered their support, many others have decried the decision insisting that it should have been given (and still should be awarded) to a contestant born in the twin-island state.

One of the main criticisms has been about Spanish-speaking Ms Materano's accent and reported lack of fluidity in English. However, she has hit back at her detractors defending her ability to converse in English as well as her native language, saying that she is multi-lingual unlike many of her critiques.

Given the appetite for controversy-driven topical calypsoes as a staple of Trinidad and Tobago's long-running and world-renowned calypso area, this issue is not expected to go away any time soon.

It feeds off the ongoing immigration debate in the country surrounding the mass arrivals of Venezuelan refugees into Trinidad and Tobago over the past few years fleeing harsh political

and economic conditions in their homeland.

Ms Marcano may be a citizen of Trinidad and Tobago, but

to some of her critics she does not meet the criteria of that anthemic David Rudder song, Trini To De Bone.


