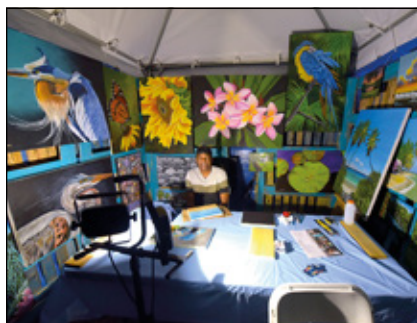

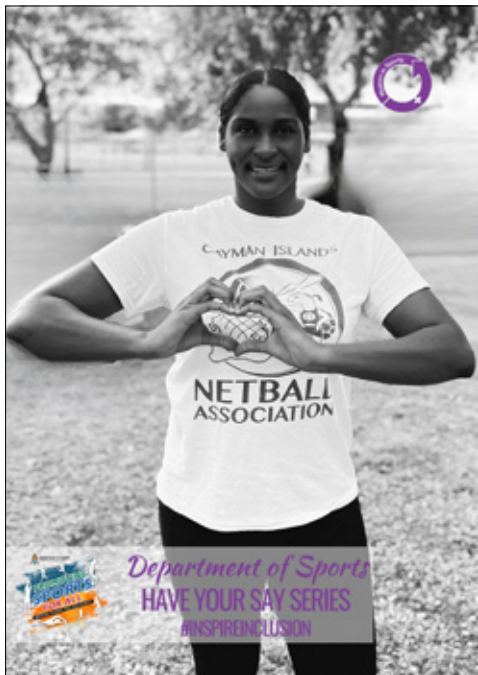

# New help for those in need

Support is now available for those who need immediate financial assistance, thanks to new laws that are soon coming into effect. The Needs Assessment Unit (NAU), working with the Ministry of Investment, Innovation and Social Development, has just announced a series of significant enhancements to the financial assistance programmes which are not only aimed at providing better support to individuals and households in need, making them align with the Financial Assistance Act, 2022. This means these new enhancements are implemented and delivered in the manner designed prior to official commencement of the new Act and associated Regulations.

One key change to how financial assistance is given is that people facing emergency situations can now receive immediate relief for one month, even if they are unable to provide all the documentation outlining their eligibility. This assistance aims to alleviate immediate financial burdens and ensure individuals have access to necessary resources during times of crisis, allowing them time to gather documents and apply.

A new one-time rental deposit programme is now also available, offering households up to \$3,000 to cover rental deposits, empowering families to secure stable housing arrangements. Responsibility for the care of the rental property lies with the household, enabling them to reclaim the deposit for future rentals.

To strengthen support, financial assistance amounts for accommodation, utilities, and food have been increased. The exact amount will be determined by the size of the household. Current clients who receive food support have already received this increase. People can now get up to \$3,000 for accommodation, up to \$600 per month for utilities and up to \$850 per month for food.

NAU has also expanded its services to include internet (up to \$100 per month), transportation (up to \$100 per month), and phone assistance (up to \$150 per month).

Current clients do not need to re-apply to implement these changes. Adjustments to increased food assistance amounts will immediately come into force for eligible clients. Other services will be adjusted as current approvals end or new applications are submitted so that the assistance provided covers the shortfall clients are experiencing.

New applicants should note that online application forms will include these new services as of Tuesday, 5 March, 2024.

In addition to the policy changes to financial assistance, NAU has also implemented a policy allowing older persons or older couples living with their adult children, adults living with their parents or those with permanent disabilities who are currently living with others, to apply for long-term financial assistance as if they were living alone.

This change means that these individuals will not need to provide financial information for other household members and their income alone will be used to determine the amount of financial assistance they may qualify for. Additionally, long-term financial assistance will now be provided to all qualifying individuals up to their deficit amount, with exceptions made for those with no other income.

To ensure equitable access to support, tiered income and savings eligibility criteria have been established, tailored to household size and composition.

Director of the Needs Assessment Unit, Tamara Hurlston said, "These enhancements represent a significant step forward in our joint mission to serve individuals and families in need across our community; from offering immediate relief to expanding services addressing essential needs such as internet, transportation, and phone as-

sistance, these changes demonstrate our collective commitment to providing comprehensive and meaningful support to those who rely on us."


Deputy Premier and Minister for Social Development, André Ebanks expressed gratitude for the collaboration and input received from the community. "The invaluable feedback received at the close of last year and during the development of the new Act and associated Regulations has guided our decisions; instilling confidence that these reforms will significantly improve the lives of those dependent on our services. For too long changes to financial assistance have been static or incremental one-offs that have not been community or data-driven. Given existing economic and societal pressures, it is time for more strident steps to help the most vulnerable in the community and provide stronger opportunities to enter the formal economy."

# Ormond Panton and the Struggle for Political Consciousness

Three Caymanians, Mr. Roy Bodden, Mr. Erren Merren, and Dr. Steve McField wrote tributes as part of the education thrust on Ormond Panton. In this series of articles, I present these tributes as written by these eminent persons who knew Mr. Ormond Panton well.

The tribute written by Mr. Roy Bodden is presented in three parts.

## Part Two

### Ormond Panton and the Struggle for Political Consciousness

#### Politics in Practice:

In September of 1961, Ormond Panton assembled a group of trusted men, prominent in Caymanian society.

These men were not members of the merchant class, rather they were men who can more accurately be described as 'of the solid middle class', known for their scrupulousness in business, their intellect, and their standing in the community. It is posited here that Ormond Panton saw in these men a reflection of himself. These men T.E. (Teacher) McField, Warren Conolly, Val Anderson and Anton Bodden were the core of what was to become a political party.

In the formation of this party, Ormond Panton applied himself assiduously and gave his personal attention to every important detail. To ensure he was working constructively, Ormond travelled to Jamaica to consult with Norman Manley on how to set up the party machinery. Upon his return to Cayman the original members were complemented by his nephew Colin Panton.

Satisfied that he had complied with his external advisor's suggestions and

with the loyalty and support of his chosen colleagues, Ormond Panton launched the Cayman National Democratic Party (CNDP), later the word "Cayman" was dropped from the name and it became known as the National Democratic Party, well before the next scheduled elections in November 1962. Its officers were:

Ormond Panton – President  
Warren Conolly – Vice President  
Anton Bodden – Vice President  
Evelyn Wood – Treasurer  
Mable Hurlston – Secretary

There was island wide enthusiasm, great expectation and the rank and file were pregnant with an excitement not previously experienced in Caymanian politics. The party executive embarked upon a series of island-wide public meetings held in the town halls of each district including Cayman Brac where two candidates Edon Kirkconnell and Burns Rutty joined his ranks. It was a campaign which yielded a resounding success, netting one thousand one

hundred, paid-up card-carrying members. The National Democratic Party made history and Ormond Panton was unquestionably the most popular politician in the history of these islands. His followers made a song, proclaiming their loyalty to him:

We will follow Ormond Panton

We will follow Ormond Panton

We will follow Ormond Panton, till we die.

This kind of loyalty and devotion is the material that many populists use to create 'cults of personality'. But Ormond Panton was not a Machiavellian, nor was he puffed up with ambition, that quality which popular account suggests was the demise of Julius Caesar. On the contrary, Ormond Panton's agenda was the party's agenda and that as I shall show was his undoing.

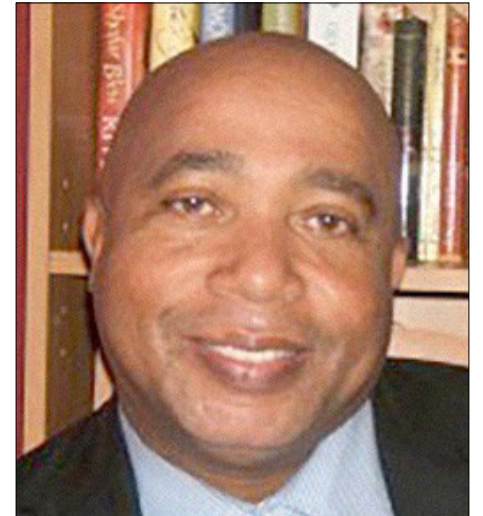
To begin to underscore this point, permit me to take a digression- an important digression in my view as it serves to show that neither Ormond nor his colleagues learnt from history. The National Democratic Party, although better organized, better funded and with an established constituency base, was not the first political party.

That fact of history belongs to the Cayman Vanguard Progress Party. Formed in 1957 by a group of prominent black persons, the leadership comprised of:

Warren Conolly - President  
William Nixon - Vice President  
Sydney Piercy - Secretary  
Florence Cayasso - Asst. Secretary  
Bertram Ebanks - Treasurer

In a letter to Commissioner Donald, the Cayman Vanguard Progressive Party (CVPP) informed Donald that the party had been duly registered with the intention of contesting the 1958 general election.

The winds of change were blowing in the Cayman Islands from 1950 but when it became clear that to the 'near white' merchant establishment that their dominance for political control was being challenged, "all hell broke loose". There followed a scathing and coruscating indictment of the party members and there were charges that Jamaicans were on the cusp of taking control of Caymanian politics. To

many Caymanians the threat of Jamaicans entering Caymanian politics was a trespass not to be tolerated. There was society wide opposition and in the meltdown which followed the 1958 elections the CVPP as an organization was decimated. Not one single member was elected and the organization as a political entity was relegated to the 'thrash heap' of Caymanian history. Complaints of fraud and corruption by the losing party carried no weight and the candidates on the CVPP tickets were left to wallow in the detritus of their best efforts. The merchant establishment had been challenged and the trespass was met with a high-handed reaction. It was a lesson which should not have gone missing on one so astute as Ormond Panton.

Why then did he fall so totally into the wake left by the foundered CVPP? **Was it because** Ormond Panton, being a Caymanian thought himself immune from that kind of punishments as there were no Jamaicans in his party hierarchy?

Or was it because Ormond Panton the man of political principles and a proponent of equality of opportunity expected his opponents to play by the same rules as he did?

I pose these questions in the shameless admission that Ormond Panton was my political hero. As a sixteen-year-old witnessing his political juggernaut roll into the Bodden Town, Town Hall Yard where Anton Bodden – a close cousin of mine and Evelyn Wood ("Miss Evie") two people whom I knew on his platform, I felt excited and even then I realized that I was witnessing history being made as Ormond Panton spoke.

I pose these questions – to let Caymanians realize that politics in Cayman is like the buildings Ormond Panton stated in his biography that he visited in London in 1961 "clean on the outside, but dirty on the inside".

I pose these questions too because posterity needs to preserve this history – the history of what frequently happens to those who expect that colonialism, and its sycophants are going to yield to any rules-based order than its own.

# NEW 45 PER CENT MINIMUM WAGE INCREASE SUBMITTED

A recommendation has been put forward to raise the minimum wage in the Cayman Islands to CI\$8.75 from the CI\$6.00 where it has been for the past seven years.

It comes in the final report of the Minimum Wage Advisory Committee and will now be considered by the government.

In a comprehensive 154-page document outlining the justification for the CI\$2.75 increase (45.8 per cent), the MWAC said it "considers this a fair wage that would be affordable to most employers and beneficial to low-wage employees."

It stated that there was unanimous agreement that the minimum wage rate should apply equally to all persons regardless of gender and immigration status.

"The minimum wage applies to all employees, including those in the domestic or household sector and by organisations legally defined as non-governmental, not-for-profit and charitable organisations, and employees (as defined in the Labour Law) of all ages."

The Minimum Wage Advisory Committee (MWAC) also recommends that for employers who pay gratuities and commission "no more than 25 per cent of the CI\$8.75 minimum wage may be paid by gratuities or commissions - at least 75% of the minimum wage rate must come directly from the employer - beginning July 2024 to June 2025.

It goes on to state that "after that, the gratuity contribution to the prevailing minimum wage will be reduced by 5 per cent annually, with the reduction occurring in July of each year until June 2029."

According to the MWAC, starting July 2029, there should be no gratuities contribution to the minimum wage.

For household employers of 'live-in employees' only, the MWAC says a maximum of 25 per cent in-kind credit should be applied to the new CI\$8.75 per hour (gross) minimum wage rate (CI\$2.19 per hour) for accommodations and utilities only.

There are also provisions for part-time employment of Caymanians aged 12 to 17 years old. They will benefit from a proposed school-age minimum wage of CI\$6.00 per hour. "This encourages school-age youth employment to improve work ethics, and discipline and gain experience, and encourages employers to hire young Caymanians for part-time employment opportunities," the MWAC said.

## LIVING WAGE vs MINIMUM WAGE

Chairman Lemuel Hurlston explained that one of the core issues they had to grapple with was whether to opt for a Living Wage instead of a Minimum Wage.

"A Living Wage is a wage that allows a worker to attain a socially acceptable living standard and this approach is typically not legally binding as a socially acceptable living standard is difficult to define legally. Alternatively, a minimum

wage protects against undue low pay and ensures a just and equitable share of the economic wealth to all, provides a minimum living for unskilled employed persons and helps to overcome poverty and reduce inequality."

He said the MWAC agreed that the concept of the living wage was outside of its mandate, and that the focus should instead be made on "the upscaling of Caymanians to increase their earning potential rather than mandating businesses to hire low-skilled staff at high cost."

## ECONOMIC IMPACT

The broad economic impact of increasing the minimum wage was addressed by Adolphus Laidlow, Director of the Economic and Statistics Office (ESO).

He outlined the main areas where the additional costs of paying the recommended new minimum wage are likely to be passed on to the public by businesses.

"What is likely to happen is that the firms with the highest costs are likely to try to pass it on if it's possible to pass it on because it may not be possible. It depends on competition in the marketplace as to whether you can pass it on or not."

The impact on the cost of goods and services is estimated to range from approximately 4 per cent up to around 23 per cent depending on the type of business.

Regarding the overall economic impact, ESO Director Laidlow said there was the potential for a 3.1 per cent inflation impact if companies decide to pass on the

cost to consumers and clients.

The MWAC said it differed with claims by some businesses that this could result in around 700 job losses. It said a more realistic figure would be in the region of 200.

## BALANCING ACT

"Setting the minimum wage requires a balancing act to ensure that there is economic stability but, at the same time, allowing people to meet their basic needs," the MWAC said.

Other details coming out of the report showed that the CI\$8.75 per hour proposed increase in the minimum wage will directly benefit an estimated 10,457 employed persons or around 18 per cent of the employed labour force.

The direct cost of the proposed minimum wage is CI\$51.5 million per annum, with businesses paying CI\$38.7 million while households will be responsible for CI\$12.8 million. Caymanians will receive CI\$13.2 million and non-Caymanian CI\$38.3 million annually.

The wide-ranging consultation involved the business community, employees, the public, civil society groups and advice from the International Labour Organisation (ILO).

The report was presented by Lemuel Hurlston - MWAC chairman, Adolphus Laidlow - Director of the ESO, Maureen Nabi - Director of the Business and Professionals Women's Club and Wesley Howell, Chief Officer in the Ministry of Labour and Border Control.



# Celebrating International Women's Day 8th March 2024

For more than a century, women have been specifically celebrated on 8th March with the day marked as International Women's Day. In 1911, the idea to celebrate women was first officially initiated, however the seeds of the idea came about in 1908, when 15,000 women marched in New York for better pay and the right to vote. In 1910, the idea was suggested during an annual event at the International Conference of Working Women in Copenhagen. The idea grew, with Austria, Denmark, Germany, and Switzerland all beginning to celebrate International Women's Day. In 1975, the United Nations started celebrating the day, eventually employing a specific theme each year. In 1996, the first theme was 'Celebrating the Past, Planning for the Future'.

**This year's International Women's Day 2024 campaign theme is 'Inspire Inclusion' under the hashtag #InspireInclusion.**

IWD is not country, group, or organisation specific; instead, it is a day of collective global activism and celebration that belongs to all those committed to forging women's equality, summed up well by a quote from world-renowned feminist, journalist and activist, Gloria Steinem:

*"The story of women's struggle for equality belongs to no single feminist nor to any one organisation but to the collective efforts of all who care about human rights."*

International Women's Day is powered by the collective efforts of all and inspires everyone to make International Women's Day a day to truly make a positive difference for women.

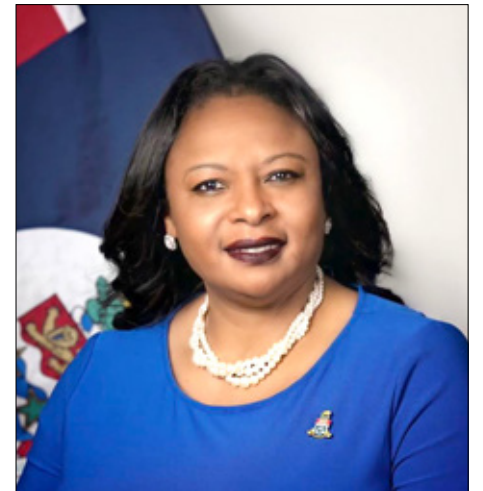

well as other crucial positions, all populated by women.

The **Governor of the Cayman Islands is Mrs Jane Owen** who was appointed to the Cayman Islands in December 2022, a long-serving diplomat and civil servant who had been HM Ambassador to the Swiss Confederation and non-resident Ambassador to Liechtenstein in the years prior to her appointment to Cayman. Before that, she was the Deputy CEO and Chief Operating Officer with UK Trade and Investment and prior to that she served as HM Ambassador to Norway. Governor Owen has also served in various roles in India, Japan, Vietnam, and the UK.

Since taking up her role in the Cayman Islands, Governor Owen has applied herself with gusto to Cayman life, scuba diving with the Department of Environment to understand more about Cayman's precious coral life, attending important fundraisers for worthy causes

such as Jasmine Palliative Care, and taking the time to understand community programmes such as one2onecayman which supports young people, among many other activities and events.

**Juliana O'Connor-Connolly, JP, MP** is a groundbreaking Caymanian, serving first as Cayman's first Deputy Premier and now first female Premier of the Cayman Islands. She also serves as the Minister for Finance & Economic Development, Education and District Administration and Lands and is the Elected Representative for Cayman Brac East.

She was elected to the Legislative Assembly (now Parliament) for the first time in November 1996 to represent the District of Cayman Brac and Little Cayman. In doing so, she became the first female to represent that district in the legislature. In 1997, Mrs. O'Connor-Connolly became Cayman's first female Minister and served until 2000 as the Minister of Community Affairs, Sports,

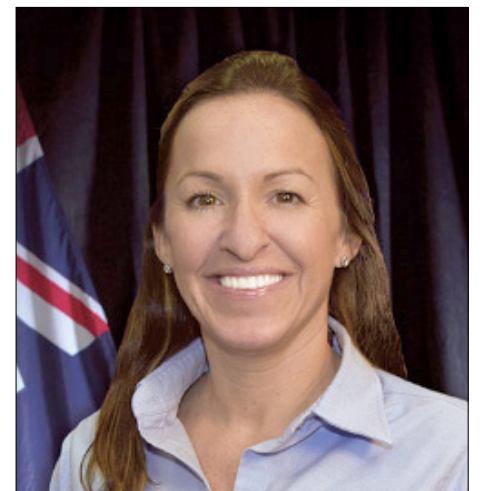

Women, Youth and Culture. She was an opposition backbencher for a short period before becoming the Speaker of the Legislative Assembly in 2001, making her the first female member of the legislature to do so.

Now in her seventh consecutive term as an MP, Premier O'Connor-Connolly is the longest-serving female Member.

Cayman's **Chief Justice, Margaret Ramsay Hale**, BSc (Econ)(LSE), LLB (UWI) was called to the Bar of Jamaica, 1991 and worked in private practice immediately afterwards, appearing as an advocate in a wide range of criminal and civil matters at all levels of the Court. She became the Crown Counsel, Office of the Director of Public Prosecutions in 1994 and, after furthering her career in

Jamaica, she moved to Cayman in 1998 where she was a Magistrate in Cayman's Summary Court for a decade, after which she became Chief Magistrate of the Cayman Islands. Following a stint as a Judge of the Supreme Court in Turks and Caicos Islands and then six years as that country's Chief Justice, Ms Ramsay Hale became a Judge of the Grand Court of the Cayman Islands in 2020 and the islands' first female Chief Justice in 2022. She also serves as an Honorary Benchler, Hon. Society of Gray's Inn.

Ms Ramsay Hale has participated in several engagements enriching Cayman society, including serving as a part-time lecturer in criminal law at the Truman Bodden Law School for a decade, as well as acting as a session leader in regional training workshops on criminal procedure reform, domestic violence and special measures for vulnerable witnesses under the aegis of the Commonwealth

Secretariat. She has been a participant in consultative seminars on the development of a model law on Judicial Service Commissions led by the Commonwealth Secretariat, Wellington, NZ and the Cayman Islands and a keynote speaker and panel presenter on issues bearing on the independence of the Judiciary, Commonwealth Magistrates and Judges Association conferences.

She has held a variety of high level positions in addition to the above, including Vice President for the Caribbean Region, Commonwealth Magistrate and Judges Association, Council Member of the Commonwealth Magistrates and Judges Association, a member of the National Drug Council of the Cayman Islands and Chair of Big Brothers Big Sisters of the Cayman Islands.

Other female leaders who are currently helping to shape the path of these islands include: Sabrina Turner, Minister

of Health & Wellness and Home Affairs; Katherine Ebanks-Wilks, Minister of Sustainability & Climate Resiliency; Heather Bodden, OCI, Cert. Parliamentary Secretary to Tourism and Social Development and Deputy Speaker; Barbara Conolly, Member of the Opposition; Gina Ebanks-Petrie, the Director of the Department of Environment; Rosa Harris, Director of the Department of Tourism; Paulinda Mendoza-Williams, the Director of the Department of Children Family Services; Danielle Coleman, Director of Hazard Management Cayman Islands; Cindy Scotland, Managing Director of the Cayman Islands Monetary Authority; Natalie Urquhart, Executive Director of the National Gallery of the Cayman Islands, Melanie Carmichael, Chairperson of the National Trust; Joanne Lawson, soon to be President of the Cayman Islands Chamber of

Commerce; and Sue Winspear, Cayman's Auditor General, among many more women currently in leadership roles.

## History of strong women

Cayman's history is filled with the names of strong women who worked tirelessly for the betterment of their country. They helped to create the foundations of the islands and helped move them towards the success story that the islands have achieved in the present day.

The Cayman Islands was granted its first written Constitution on 4th July

1959, with **Ms Sybil McLaughlin** playing a key role at that time, serving as Clerk of the Legislative Assembly and Executive Council. She became the first person to hold this post in the Cayman Islands and the first women to ever hold that position in the whole of the Commonwealth. Ms Sybil was made a National Hero in 1996.

In 1961, two years after women got the right to vote and run for office, **Annie Huldah Bodden** made history by being the first woman nominated as a Member of the Legislative Assembly where she served for three years. Then, in 1965 she ran for office for George Town and became an elected member of the Legislative Assembly, where she served until 1984.

Also, in 1962, **Mary Evelyn Wood** (known as Miss Evie) made history by being the first woman elected into the

Legislative Assembly. Miss Evie was made a National Hero in 2011.

**Irksie Leila Yates** was an early pioneer in health. Born in 1899 and passing away in 1996, Nurse Leila was a revolutionary nurse, midwife, and resident of West Bay, famously known for walking from her home in West Bay to George

Town every Monday and Friday to attend nurse training classes. She carried out her first midwifery case single-handedly in 1921 and continued to deliver more than 1,000 babies in their family home or in her own home before the

government opened its hospital in 1952. She never lost a baby or his/her mother. Nurse Leila retired in 1971 and was recognised posthumously as a National Hero of the Cayman Islands. She was also featured in the 'Pioneers in our History' Cayman Islands stamp collection.

**Miss Isabel Powery** was a leader in education. Born in 1910 and passing away in 1984, she was known as Miss Izzy and made significant contributions to the advancement of Caymanian society through education. Having begun her career as a teacher's assistant, in 1929 she opened her own private school-house where there was a strong focus on both academic success and discipline and practical, real-life lessons were also taught. She was known to be incredibly kind hearted and charitable and was a much-loved character in the Cayman Islands.

**Lucille Seymour** is one of the most celebrated Caymanian women in its rich history. A former teacher and education official, in the Cayman Islands Government, she was Permanent Secretary in the Ministry of Community Development, Sports, Women, Youth Affairs and Culture.

**Sharon (Marie) Martin**, was recently honoured with an MBE for her outstand-



ing services to education and the community. She is the former Principal of George Town Primary School and in her honour the school will be renamed the Sharon (Marie) Martin Primary School.

# Wymondham an Elite, Affordable Option for Boarding School

Parents in the Cayman Islands looking for the right boarding school for their children may have just found the perfect fit in Wymondham College in the United Kingdom.

The school is a State boarding school, which means it is more affordable than private boarding institutions, because State boarding schools provide free education but only charge fees for boarding.

Such schools also give priority to children who require boarding.

This unique designation means that the cost of attending Wymondham for boarding students is only £4,500 per term, which is considerably less than the £30,000 to £50,000 one might normally expect to pay for boarding school and traditional boarding school models.

Add to that the fact that in the Cayman Islands, the British curriculum is not always offered in private secondary schools and Wymondham becomes an even more attractive option for persons seeking to have their children exposed to the British system at the secondary level in a highly competitive environment that is conducive to learning.

There are already Caymanian students attending the Wymondham

boarding school and that number is steadily growing.

Wymondham Principal, Mrs. Zoe Fisher visited Grand Cayman along with her son Ethan, who is a student at the school, during the first week of March, 2024. Both she and Ethan were on a recruitment and promotional campaign for the school and spoke with the Caymanian Times about what parents in the Cayman Islands should know about all of their options when it comes to boarding schools, particularly those with the stellar reputation and attractive price point that Wymondham offers.

"Wymondham is the first school to achieve an 'outstanding' designation in all 9 categories of the Office for Standards in Education, Children's Services and Skills (OFSTED), Boarding and Education Inspection," not Mrs. Fisher.

The school also represented the United Kingdom in the Model European Parliament Debate, among many other achievements in academia, sports and extracurricular activities.

Founded in 1952, Wymondham is located in rural Norfolk (2 hours outside London) on 83 acres of countryside and features top notch facilities for sports such as rugby, soccer, swimming and cricket, in addition to first class learning and educational spaces and living accommodations

for boarding students such as gyms, reading rooms, restaurants, laundromats, and even a wellbeing garden.

There is also a Jazz band, a wind and brass concert band at the school.

"In October of last year (2023), we came to a boarding school fair here in the Cayman Islands and there was lots of interest," Mrs. Fisher remarked, adding that her sister had lived in the Cayman Islands previously and so she always knew that Cayman was a unique and special place.

As fate would have it, Mrs. Fisher then became the principal at Wymondham and never lost sight of the fact that the school could be a well needed alternative to broaden parents' options with regard to boarding schools.

"Lots of people were overlooking the UK for the US," she noted, explaining that interest in Wymondham is growing really quickly in the Cayman Islands and as a result she would be returning to Grand Cayman before the summer and again in November of this year.

"Choosing a boarding school is like buying a house. It has to feel right and I understand this from a personal point of view. In fact, I believe so much in the high quality of the school that my son is also a student at Wymondham," said Mrs. Fisher, who added, "As a 'Mum' I understand this.

13-year-old, Ethan Fisher spoke about what it was like to attend the school for him as a 13-year-old:

"There are loads of opportunities. I enjoy the high standard of studies and I play sports like cricket, and rugby. I also do swimming and have recently joined the baking club," he noted.

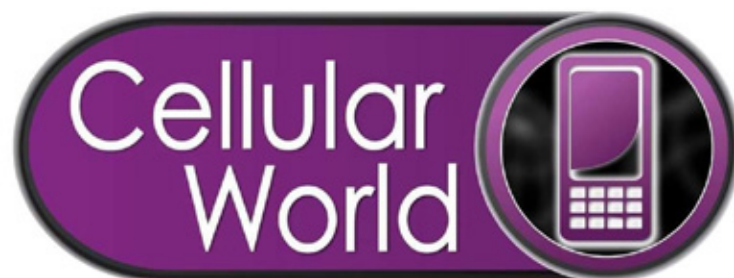
Boarding students at the secondary school range from ages 11 to 16 all live together, "so it feels like a family," explained Mr. Fisher. She added that the school has many different nationalities, with 1400 students attending the school in total.

"It's like living in a village, where children can become independent in a supervised setting. Their learning and development tends to become synchronised as a result and they all want to do well," said Mrs. Fisher.

Wymondham also has the largest Sixth Form in Europe, with over 400 students, of whom 200 are Boarding students and even features a cadet course with the largest contingency in England.

There are only two State boarding schools for prep school aged children and Wymondham is one of them, offering accommodation to students as young as 9 years of age.

Currently there are 30 students boarding in the Prep programme, with 400 Prep school student in total at the school.

A big part of eating for fat loss is keeping your metabolism going all day long with small, sensible meals and snacks. In theory, this is simple and easy: eat a little something every 2-3 hours throughout the day.

Unfortunately very few people do it right, resulting in frustrating weight gain.

The content of your snacks and small meals is of utmost importance. If you're eating the wrong thing every 2-3 hours then it's easy to gain weight quickly, rather than what you want, which is to drop fat and clothes sizes.

Let's jump into the 3 Steps to Snack Smart that I have for you today to keep you on track and burning fat all day long...

### Snack Smart #1: Watch out for added sugar.

Sugar is the biggest problem when it comes to fattening snacks, and so this needs to be the number one nutrient that you check. Your frequent snacks should contain very little, or zero, added sugars.

This is a pet peeve that I have: many

'health' foods have massive amounts of added sugars, which will destroy your results. Items like protein bars, jerky, dried fruit, green juice, and trail mix often have added sugars and preservatives that you need to watch out for and avoid.

Your snacks should have little to zero added sugars, and should be a nice blend of protein, fiber and complex carbohydrates.

### Snack Smart #2: Check the serving size.

When your snack comes in a package, after you make sure that it isn't filled with sugar, check the serving size. It's a popular technique for food manufacturers to give the nutritional facts for 2 or even 2.5 servings, on an item that you will likely polish off the entire package.

If the servings are more than just one then you'll need to do some quick math. Calculate the total calories, sugar, carbs, fat and protein. Make sure that the numbers line up with your target nutrition sums.

Always be aware of how many servings you are eating in a single sitting. Do the math if you're eating more than one serving – be honest with yourself!

### Snack Smart #3: Homemade and made-in-nature are best.

As convenient as packaged health snacks are, you will always see better results by eating whole foods found in nature, or snacks that you've made at home with real food ingredients. Even the healthiest packaged protein bar from the store is going to contain preservatives and additives that are completely avoided in homemade foods.

A handful of raw nuts, a piece of fruit with fresh nut butter, a hard boiled egg, a homemade fitness muffin (recipe below), some chicken breast on veggies or chopped flank steak on a salad are all better options than any packaged snack.

When possible, stick with whole foods found in nature and snacks and meals that you make at home.

## Cayman beats Jamaica – The Roar heard around West Bay

Wednesday, March 6, 2024 will come and go like any other weekday. Children will go to school, mothers and fathers will go to work – a normal Wednesday for most. But 30 years ago, on this very date, a legendary and truly remarkable sporting event occurred. An event that will forever be embedded in the minds and hearts of those spectators present at the Ed Bush Sports Field in West Bay that night, or those tuning in to Radio Cayman and every Caymanian sports enthusiast.

It was 9:30 p.m. and the Cayman Islands Senior National Football Team had just beaten mighty Jamaica 3-2 in the 1994 Shell Caribbean Cup Qualifying Zone to win the group and advance to the Finals in Trinidad.

Before we get ahead of ourselves and reminisce about the game, a brief history lesson is needed.

Following a spattering of good results and performances during the late 1980s and early 1990s under Winston Chung and then Ed Wilson, most notably a 2-2 draw with the touring Brazilian U-21 Olympic Team boasting a young Bebeto and others, a very unfortunate 2-0 defeat to Santos FC from Brazil complete with World Cup superstar Socrates, a draw with Southampton FC and Norwich FC from England and a draw with Borussia Dortmund from Germany, the Cayman Islands National Football Team had now reached the pinnacle of Caribbean football – a final showdown with the mighty Jamaicans.

After all, this was the National Team that Winston Chung had built and it was his dream to one day conquer the Caribbean beginning with Jamaica. Veteran players from the 1980s mixed with youngsters from the victorious Miami Classic Youth Tournament campaigns – the Cayman team was complete and ready.

For head coach Ken Fogarty and Assistant Coach Joscelyn Morgan, who had assumed the reigns earlier in the year, it was a tweak here, a tweak there and the team was ready – all the pieces were in place. Bring on the Jamaicans.

I distinctly remember the journey that evening from the Island House guest house on West Church Street where we stayed in West Bay to Rev. Blackman Road, to Stadium Drive and on to the Ed Bush Sports Field. Both sides of Stadium Drive and portions of

Rev. Blackman Road were lined with cars and as we approached the stadium, an unusual “buzzing” noise got increasingly louder.

As we pulled up to the rear of the grandstand and the doors of the bus swung open, the buzzing noise transformed into a deafening roar from the crowd as we disembarked and headed to the dressing room.

Red and blue flags and banners hung everywhere. For once, the famous Jamaican black, green and gold was shrouded in a sea of red, blue and white.

With the Wight brothers – David and Christopher – darting to and fro on the full to capacity main stand holding aloft the Cayman flag all the while ignoring the taunts of the Jamaican faithful, to Brent McLean complete with painted face incessantly beating a small drum, to the temporary broadcast booth erected across the field on the ‘pond side’ complete with “legends of the game” Lennie Hew and Renard Moxam, who would be providing play-by-play commentary for radio listeners island wide – the setting was complete.

Cayman had disposed of St. Maarten and the British Virgin Islands earlier in the group as had Jamaica. This clash would settle the group and the winners would book their passage to Trinidad.

With all the tension and excitement during the game, to me the actual game itself was mostly a blur but I vividly remember the three goals we scored and the heroics of our goalkeeper Cecil Walton.

To relive portions of this special event, we need to highlight certain sections from the article that appeared in the Caymanian Compass on Tuesday, March 8, 1994 written by then sports writer Paul Drury who splashed the headline “Cayman beats Jamaica!” across the back page.

The article began, “Cayman’s National Soccer Team made history Sunday beating Jamaica for the first time ever in senior competition. And what a spectacle it was!”

He continued, “This fabulous victory in front of a capacity crowd in the magnificent new Ed Bush Soccer Stadium marks a new era for Cayman soccer. It will go down in the annals of Cayman sports as one of the greatest nights ever.

Cayman’s captain and twin goal scoring hero of the night, Lee Ramoon, was

moved to shed tears of happiness and relief afterwards, and said emotionally, “We created history tonight!”

With the Shell Caribbean Cup Qualifying Zone trophy in his hands, he cried gleefully over the loudspeaker system, “This is for you Cayman! This is for you.”

Coach Ken Fogarty was “delighted” at this success and conceded “there’ll be no training tomorrow!” He added enthusiastically “it’s all down to the players and the supporters – we’ve never had support like this. We want to thank them, they were fantastic.”

Playing a part in the game and listening to the supporters relive certain events during the game, from all accounts, it was a very, very exciting game.

Cayman went ahead in the eighth minute thanks to a wonderful Lee Ramoon goal only to see Jamaica draw level in the 25th minute through Easton Smith. Lee grabbed his second with a ubiquitous chip over Jamaican goalkeeper Warren Barrett just before half-time to make it 2-1 and Carlos Welcome added a third early in the second half as he rose to power home an inviting cross from Rohan Clarke. Jamaica scored their second in the 80th minute off the boots of Donald Hewitt and the pressure was on.

Cayman’s goalkeeper on the night, Cecil “CI” Walton, had a remarkable game between the posts. He was truly outstanding as he managed to stop everything that was thrown at him and in my opinion, a performance like that has never been equalled by a Caymanian goalkeeper. He deservedly won the “Man of the Match” award following the game.

We held on for the last 10 minutes or so and at the sound of the final whistle, we had finally achieved what some said could never be done by a team from Cayman – we had beaten Jamaica at the



senior level.

Of course, there are those detractors who claim that it wasn’t a ‘great’ Jamaican team but with the likes of Warren Barrett, Hector Wright, Linval Webb, Easton Smith, Devon Ricketts, Altimon-te Butler, Donald Hewitt, Durrent Brown and Clive Smith, this was the best team Jamaica had and some of those players on that field that night, would go on to play a key role in Jamaica’s journey to and participation in the FIFA World Cup Finals in France in 1998.

The then Sports Editor Guy Harrison from the Compass summed the night up best for the supporters when he wrote, “I’ve heard many knocks against Caymanians for not supporting their football team. But Cayman showed up in force with flags and painted faces. The fans gave meaning to the home field advantage and the value of their support had no small part in the inspired play of Cayman. Yes, Cayman stood proud Sunday night like never before.”

So, for those of you who were there or who had their radios tuned in to Radio Cayman that night, if you come across one of the Cayman players, coaches or staff members this week who were on the field or on the sidelines that night, just tell them, “We will always remem-
