Red Bay Primary 2024 Inter-Primary Sports Champion

Red Bay Primary School was declared the winner of the 2024 Inter-Primary Schools Sports Meet held at the Truman Bodden Sports Complex from March 13 to 15.

The three-day competition, organised

by the Department of Education Services (DES) and the Department of Sports (DOS), saw Red Bay amass 376.3 points to edge out the defending champions Prospect Primary School (PPS), who finished with 331 points. Theoline McCoy Prima-

ry secured the third-place spot with 261 points.

Throughout the meet, spectators witnessed several exciting moments, in-

I write to correct the error in the Ministry of Youth, Sports and Heritage's announcement declaring turtle as the national dish of the Cayman Islands. Turtle although a popular dish, was not as widely available as we are led to believe, and therefore could not have been "national".

By the time the modern Cayman Islands came into existence turtle had long been extinct in the waters surrounding the Cayman Islands. As a matter of fact, turtles were even extinct in the waters between Cayman and the south coast of Cuba, where Caymanians fished after depleting supplies in our own waters. During its peak the turtle trade brought wealth to several, Caymanian entrepreneurs and for years there was a brisk trade in turtle between Grand Cayman, Key West and Tampa, Florida.

Caymanian turtle fishermen, having 'fished out' the surrounding waters then resorted to poaching turtle from waters surrounding the Miskito Cays. These Cays were territory claimed by Nicaragua. For most of the time Caymanian turtle fishermen successfully poached turtle in these waters but there were numerous occasions where Caymanian vessels were seized, and the crew imprisoned by the Nicaraguan authorities. Such incidents of-

ten necessitated the diplomatic intervention of the United Kingdom acting in the interests of the Caymanian fishermen. As Nicaragua complained of these incidents, pressure to discontinue the trade weighed upon the Caymanian fishermen and this pressure as well as a growing call for a ban of the trade brought a clamour for some alternate supply.

Some years before the eventual CITIES ban in the 1970's Cayman fishermen were able to procure limited licences from the Nicaraguan authorities to fish for turtle at certain intervals. Then after the Falklands War at the Convention on Trade in Endangered Species (CITIES) was held in Argentina, The Convention declared turtles an endangered species and imposed a worldwide ban on the trade.

To their credit, the Caymanian authorities had some years prior encouraged a group of foreign investors to pursue the experiment of rearing turtles in artificial conditions. This venture enjoyed modest success and although it demonstrated modest success, the worldwide ban stunted its growth, and we know well its current challenges. The experiment has never been able to meet the demand of the Caymanian market.

Turtle as a staple food, even before the ban was not widely available on Grand Cayman during all times. And even when it

was available, it was most easily procured in George Town or West Bay. In West Bay because that district produced the majority of persons involved in all aspects of the trade from mariners to ship owners and financiers.

George Town as well, had its share of those who, participated in the turtle trade, from entrepreneurs like the late Dr. Roy McTaggart, owner of a number of turtle schooners, including the now infamous Majestic. George Town also produced legendary turtle butchers like the late Lorraine Russell. Older generations of Caymanians will no doubt be able to recall the nights at the 'Old Market' where the turtles were butchered and sold. At such times, that venue was a veritable temple for the "Who was Who" among Caymanian men. It was a conclave rich with Caymanian culture and tradition as men like the late Ashley Godfrey, Neville Ebanks and their contemporaries would 'hold court' for hours on end.

For a brief time during the heyday of turtling the Cayman Islands Government operated a canning factory specialising in the production of turtle soup. This venture, for all its promise did not reach its full potential ... the result... a lack of a steady supply of turtle.

Of significance also, is the fact that history suggests that the turtle trade was not



significant in the lives of the people of Cayman Brac and Little Cayman as it appears to have been for those on Grand Cayman.

The popular dish throughout the Cayman Islands was and still is the "Cayman stew" or what folks nowadays call "run down". This dish, the ingredients of which was widely popular, even to the Seventh Day Adventists who did not eat turtle. This stew or "run down" was made with coconut milk, the 'breadkind' being cassava, sweet potatoes, bottlers, yam breadfruit all in one pot with fish or salt beef providing the protein.

It was a dish available and popular among folk from all walks of life. It was not dependent upon the turtle schooner's arrival from the Miskiti Cays, nor was it hampered by bad weather.

The Ministry of Culture is correct in naming swanky as the national drink, accompanying the (run down) fish or salt beef stew.

Individuals being nominated for Honouree must have made their contributions prior to 2013. Introduced in 2017, the

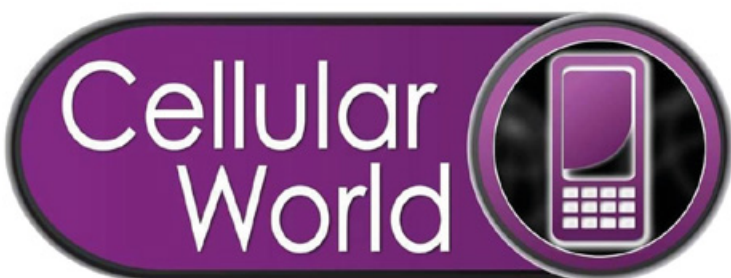

CINICO announces motor and home insurance policies with new look and website to mark services expansion

The Cayman Islands National Insurance Company (CINICO) has announced that with effect from today, 18 March 2024 it will be offering motor insurance to residents in the Cayman Islands.

A home insurance offering is expected to follow shortly in the second quarter of 2024. New branding and an updated website have also been launched to mark the expanded services offering in addition to existing health policies.

The availability of the new policies is part of the planned expansion of CINICO announced in April 2022 and has involved significant effort to expand the company's operational set-up. These plans will also see the introduction of new health insurance products later this year.

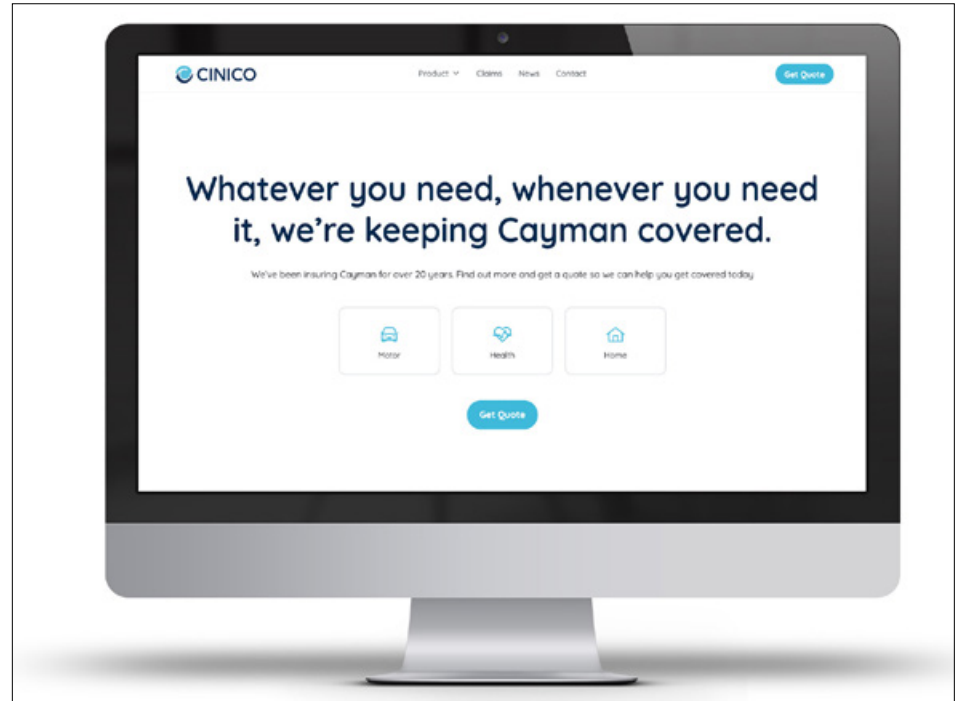
CINICO CEO Michael Gayle explained, "This is an important step not only for CINICO, but also for the Cayman Islands insurance sector's long-term sustainability. We are extremely pleased to be able to expand our product offerings to residents in Cayman with the introduction of motor and home insurance."

Mr. Gayle continued, "Part of our remit as the government-owned insurance company is to help ensure that the insurance sector is resilient, and the Cayman Islands has the insurance capacity available in the future to continue to be able to offer property insurance in particular."

Mr. Gayle, who is also on the Board of the Caribbean Catastrophe Risk Insurance Facility (CCRIF) noted that, both globally and regionally, insurance providers are struggling to provide home and property insurance due to the risks associated with hurricanes and other natural disasters.

"In some areas of Florida for example, we are seeing homeowners unable to obtain any cover at all," he explained.

Responsibility for CINICO falls under the



Ministry of Finance, which has supported the increased funding CINICO required for the product line expansion.

Premier and Minister for Finance Hon. Juliana O'Connor-Connolly said, "This is a significant moment for CINICO and the insurance sector in general in the Cayman Islands. CINICO's expansion of services is intended to provide options for residents in Cayman. The main challenge now is that in many instances, cover is not available locally at any price. CINICO's gradual expansion into the property insurance arena is intended to help fill the existing 'protection gap' that seems likely to widen in the future."

Financial Secretary Kenneth Jefferson said, "The overall objective of expanding CINICO's product range is not just to offer wider coverage for CINICO customers, but to play a role in raising the bar so all insurance consumers in Cayman will benefit, regardless of which company they are insured with. As a government-owned company, CINICO's main goal is to facilitate better and affordable insurance coverage for all residents of the Cayman Islands."

Of the new policies, Mr. Gayle said, "The new products are also, of course, designed to offer customers more choice in the insurance marketplace, with good cover and product innovations in both home and motor policies. Ormond Panton and the Struggle for Political Consciousness

Three Caymanians, Mr. Roy Bodden, Mr. Erren Merren, and Dr. Steve McField wrote tributes as part of the education thrust on Ormond Panton. In this series of articles, I present these tributes as written by these eminent persons who knew Mr. Ormond Panton well.

The tribute written by Mr. Roy Bodden is presented in three parts.

Part Three

Ormond Panton and the Struggle for Political Consciousness

A Pyrrhic Victory:

Ormond Panton and the National Democratic Party (NDP) won a resounding majority in 1962. Their rivals registered their party as the Christian Democratic Party (CDP) in an attempt to play upon the Caymanian penchant, with the hope of attracting followers who believed the party may have been founded on biblical principles and implying that the National Democratic Party had no such principles. This ploy did not work because Ormond Panton was far more persuasive than his opponents, the merchant establishment, whom the majority realized did not really help the poor and disenfranchised. The attempt to play on Christian principles proved not to be an advantage in the end as the elections were won by the NDP.

Beyond the glossy patina of the NDP victory on November 22, 1962 however, lay a toxic conspiracy which had its genesis in a public meeting held some time earlier.

At that meeting Jack Rose, the island's Administrator and Dr. Roy McTaggart, Ormond Panton's colleague in the NDP set the stage for Panton's political demise. History shows that at this meeting some kind of collusion took place between Dr. Roy and Jack Rose which turned out to be detrimental to Ormond Panton's efforts to bring political enlightenment to the voters.

Hannerz (1974) suggests that:

Election night (November 22, 1962) may have been Ormond Panton's finest hour, as he looked forward to extending his party's influence over a Legislative Assembly dominated by National Democrats [NDP]. But his hopes were soon dashed.

About a month after the election, on

Christmas Eve to be exact, Administrator Rose made public the names of his three nominees (Nominated Members) for the Legislative Assembly. Two of them were George Towners... Annie Huldah Bodden and Berkley Bush. The third was J.A. Ryan from Cayman Brac... not particularly endeavored to Ormond Panton. Jack Rose had flaunted convention and made these appointments without consulting Ormond Panton as convention dictated.

Postmortem:

It would have been an improbability for Jack Rose to have chosen without the collusion of forces opposed to Ormond Panton. As was previously mentioned, Panton did not have cordial relations with Jack Rose, and this became even more obvious during the so-called "Black Ball/White Ball" confusion, a meeting held to explain the alternatives Caymanians had in choosing their path after Jamaica went independent in August 1962. Jack Rose was blatantly racist in suggesting there were on two choices. The "Black Ball" choice meant aligning with Jamaica, which was about to go into independence, while the "White Ball" choice meant remaining with the colonial power, Britain.

Ormond Panton however, saw things differently and stated that there was a "Grey Ball" (representing a third choice) which for Cayman meant remaining with Britain but with 'internal self-government'. It took the intervention of Sir Kenneth Blackburne, the Governor of Jamaica,

to confirm that Panton was correct.

By that time however, the proverbial 'die had been cast'. Jack Rose made the nominations concrete, Dr. Roy leaving a foul-smelling trail resigned from the NDP. Ormond Panton was shattered and resorted to what any savvy political leader would have done – proposed that the majority NDP members resign en masse – thus forcing the Administrator to call new elections.

In so doing, Panton committed the fatal political flaw by not ensuring his membership tendered their resignations through him as party leader. He trusted their ethics, but in the end only his resignation was tendered, for although Dr. Roy also resigned from the Assembly at this time, he had left the NDP some while previously.

To return to the situation with Ormond Panton and the NDP members, it is impossible to detach oneself from the spectre of selfishness, self-preservation and disloyalty surrounding these members. Similarly too, one's suspicion must be aroused by Dr. Roy's resignation from the NDP.

Did he resign as a result of intra-party differences with Ormond Panton, and if so, what were they?

Did he resign because Duncan Merren having not been returned as an CDP member meant there was no need for him (McTaggart) to be in the Assembly since his business rival was no longer in a position of power?

Or did he resign because the possibili-

ty of Ormond Panton leading the Cayman Islands into Internal Self-Government had once and for all be removed? **And finally**, was Dr. Roy McTaggart hero or villain in the conspiracy to thwart Internal Self-government and by inference ruin Ormond Panton's chances of becoming Chief Minister, or was his role purely to secure his own economic advantage?

Irrespective of the answer one arrives at, certain conclusions are inescapable. Jack Rose used the age-old tactic of 'divide and rule' to maintain the colonial stranglehold over the Cayman Islands and it also calls into question Dr. Roy's conduct as statesman. The collective struggle which played out between Ormond Panton as a visionary, honest and self-sacrificing political leader and the reactionary forces of the merchant establishment still blazes a trail in Caymanian politics. Ormond Panton has left the Caymanian political scene, but his legacy of statesmanship, fairness, vision, and morality are the hall marks by which his memory is celebrated... and history has carved him in a respected space on the Caymanian pantheon of great leaders.

Readers are encouraged to explore further in such texts as Ulf Hannerz, **Caymanian Politics: Structure and Style in a Changing Island Society**, University of Stock Holm, Sweden 1974 and David A Martins, **Special Son: The biography of Ormond Panton**, Published by Pansons Limited.

Police Investigated Fatal Collision in Cayman Brac

At around 7.15AM Wednesday morning, 20 March, police and other emergency services were dispatched to a report of a motor vehicle collision in Cayman Brac.

Following initial investigations, the collision is believed to have taken place sometime between 2AM and 3AM and was a single vehicle collision with one female occupant who was pronounced deceased at the scene by an attending medical practitioner. The occupant was a 30-year-old woman from Mexico, who was living and working in Cayman Brac. Her next of kin in Mexico have now been informed of the incident and are being assisted by the police.

The RCIPS expresses its condolences to the family and friends of the deceased.

The incident occurred on South Side Road, West of Bluff Road in the vicinity of Beach Club. This section of road was closed while police complete analysis of the scene and has since been cleared with the assistance of the Cayman Islands Fire Service and reopened to the public.

Investigators are seeking the assistance of the public in ascertaining the circumstances of this collision. Anyone who may have seen or heard anything is encouraged to call the Cayman Brac Police Station at 948-033.

Police Investigate Robbery Incident in George Town

Just before 1AM on Sunday 17 March, police were dispatched to Fort Street where it was reported that a man had been robbed.

Officers attended and spoke with a man who had obvious injuries to his face and body. The ambulance attended the location and the man was transported to the hospital to be treated for what is believed to be non-life-threatening injuries.

The man informed the officers that he had been attacked by two men and a woman and that his wallet was stolen. In his wallet was a quantity of cash in both KYD and USD as well as a variety of bank cards.



Portable Generator Safety

Tips to ensure a safe Easter Weekend camping experience

Camping is an Easter Weekend tradition in the Cayman Islands and the use of portable generators to power electronic devices at camp sites has significantly increased over the years. CUC wants to ensure that campers are fully aware of the dangers associated with running portable generators and stresses the importance of taking every precaution when using generators to ensure a safe, fun and memorable camping experience is achieved. Here are some other tips to follow before operating generators:

- » **Always read** the manufacturer's manual to ensure proper use.
- » If you are using a portable generator for the first time, obtain advice from a qualified electrician on the safe operation of the equipment to prevent fires and electrical shocks.
- » It is recommend that you place the generator outside in a well-ventilated area away from your tents to avoid the carbon monoxide fumes from the exhaust, which could cause lethal poisoning. Protect the generator from direct exposure to rain or moisture by placing it under a canopy or makeshift cover. **Always keep it dry.**
- » **Never** refuel a generator while it is running or hot and always keep open flames away from the generator. Use a flashlight or battery lantern when refuelling at night. Unplug the generator output cord before starting it.
- » If your generator has been stored away for a while and not been used, have someone who is familiar with small engines (lawn mowers, etc.), do a detailed check and service of the generator before starting it.
- » If you are familiar with servicing small engines, follow these simple steps when testing your generator:
 - Drain the "old" gasoline from the tank;
 - Inspect the fuel lines for cracks;
 - Refill the tank with fresh gasoline and start it;
 - Run the generator for 15 minutes in an open area away from buildings, trees and bushes. Turn off the fuel valve and run the fuel line dry. After the engine stalls, turn off the run switch, change the oil, add fuel stabilizer to the gasoline, drain the carburetor float bowl (and sediment bowl, if installed);
 - While testing the generator, inspect your extension cords to ensure they are in good condition. Replace cords that are damaged;
 - Check for rust and replace crystallized plastic or rubber parts.

Act Against Violence and Discrimination in Sports

The Cayman Islands Football Association (CIFA) Executive Committee invited members of the public, along with representatives of the RCIPS and government ministers in a united stand against violence and discrimination to attend the "Act Against Violence and Discrimination in Sports" on Sunday, 10 March at the Truman Bodden Sports Complex. The event highlighted the importance of being united against violence and discrimination in sports.

During the meeting, CIFA's President Alfredo Whittaker, and General Secretary

Marcos Tinoco led everyone in a pledge: "The Cayman Football Family is proud of our country and sports in general, we will not allow the violence and any form of discrimination to bring shadows to our rich sports' history. We honor and are grateful for all individuals that are part of our sports' family and make football a special gift to our lives.

We condemn all forms of violence, racism and discrimination of any kind, and remain committed to a safe, inclusive and positive space for all involved in our beautiful game."

One of the Roma players, Tinashe, said, "It is a very good initiative, bringing together all the stakeholders to ensure that football is safe, and also emphasize that it is a family sport where everyone can come and enjoy in a safe environment."

Police Commissioner Mr. Kurt Walton said: "The shooter for some enraged insane reason thought it was OK to shoot into a crowd of 20-25 persons to hit his target, was beyond comprehension. So many persons were impacted that night: victims, players, spectators, which included parents and children. This dreadful occurrence has resonated throughout our entire community and must never happen again.

"However, we cannot allow the senseless actions of others to ruin for all the other sporting activities in Cayman. We must say no to violence as a country and as a community across various sectors we must stand up against, in particular, gun violence.

As police commissioner, I have given President Whittaker full assurance that he has my support, the support of my staff. Football must resume – there are too many young people who play this beautiful game and who actually need this game to look forward to a positive future."

"This incident Affected the whole of the Cayman Islands," said Hon. Sports Minister Isaac Rankine, "Want to assure the president that they have the Government's support, because, yes, football must continue. The lyrics to the National Song, 'oh land

of soft fresh breezes..." that is the reason why we are here today, to show support against the violence that was perpetrated a few weeks ago, and we cannot allow it to happen again

Minister for Tourism and Ports Hon. Kenneth Bryan said: "Sadly, there are not enough people here this evening which tells me that although every one of you has taken time out of your day to come and stand here and show your support, there should be thousands of people on this field this evening. It sadly also tells me that we have failed. When I say we, I mean all of us – we've failed as a community, as a government; we've failed as parents, we've failed as church leaders."

He said that now was a time, not to withdraw from supporting young people in their sporting endeavors, but to so more to support them.

"As an elected member, as a person who is in charge of the finances of the country and the policies that we do to affect peoples' lives, we are going to have to do better to make sure that our children are not vulnerable to this type of thing. But not only governments fix problems, the community fixes problems." He praised those leaders who had shown commitment by coming to the event. "Take time out this week and ask yourselves what more you can do, because giving up is not an option and love for this amazing sport football, we have too much talent in these islands and we cannot give up on those kids," he said.

JA hits fast \$1bn

Jamaica's immense popularity was confirmed in the first two months of 2024 after hosting one million visitors and earning US\$1 billion, building on a record 2023.

Jamaica's Minister of Tourism Edmund Bartlett made the announcement at a Caribbean Hotel and Tourism Association (CHTA) Caribbean Travel Marketplace press conference at the Jamaica Tourist Board's office in Kingston last week. The numbers highlight the impressive growth trajectory of the country's tourism sector.

Bartlett said: "I am particularly proud of the level of growth we have had post covid. Normally 2019 was used as our benchmark for growth, but 2023 is now that new benchmark as we broke two important barriers – welcoming four million visitors and earning four point two billion."

Along with the usual tourist attractions like Dunn's River Falls, the Bob Marley Museum and rafting on the Martha Brae River, the highly anticipated mounting of the statue of Usain Bolt, in Water Square, Falmouth, Trelawny is expected to

be very popular with the town's cruise shipping port. Bolt is the greatest sprinter ever and Falmouth is very proud of their global champ.

Bolt's statue, which will soon be unveiled, will be mounted on a platform at the new fountain in the historic town centre. The sculpture will be a replica of the one already mounted in Independence Park, St Andrew.

Bolt, the world-record sprinter and eight-time Olympic gold medallist, was immortalised in bronze with the unveiling of an eight-foot statue at Jamaica's National Stadium in 2017.

Jamaica recorded 612,000 stopover arrivals, which represents a 7.4% increase and 390,000 cruise visitors, which is a 29.7% increase. Total arrivals of just over one million represents an increase of 15.1%. The increase in revenue is an impressive 8.5%.

"We continue to work with our tourism partners across the globe to ensure that our tourism offerings remain top of the line. Jamaica provides unique and authentic experiences that keeps visitors keep

coming back," said Donovan White, Director of Tourism.

Jamaica will also host the 42nd staging of the most prestigious travel show in the region, Caribbean Travel Marketplace, from May 20-22 at the Montego Bay Convention Centre. The event is expected to attract 150 buyer companies and around 1000 delegates.

Cuban fury in rare show of defiance



► Cubans protested in Santiago

Cubans in their hundreds, so frustrated with chronic power blackouts and food shortages, staged a rare public protest on Sunday in Santiago, the island's second-largest city.

The island is facing its worst economic crisis for three decades, with large parts of Cuba being left without power for more than 14 hours a day. Videos on social media show people chanting "power and food".

Its president blames the situation on US sanctions, but critics say it is down to government mismanagement.

Since 1960, the US has maintained an economic embargo against Cuba which puts strict rules on trade between the countries.

The Cuban economy has been in dire straits in recent years. The coronavirus pandemic put further strain on the cash-strapped nation of 11 million people,

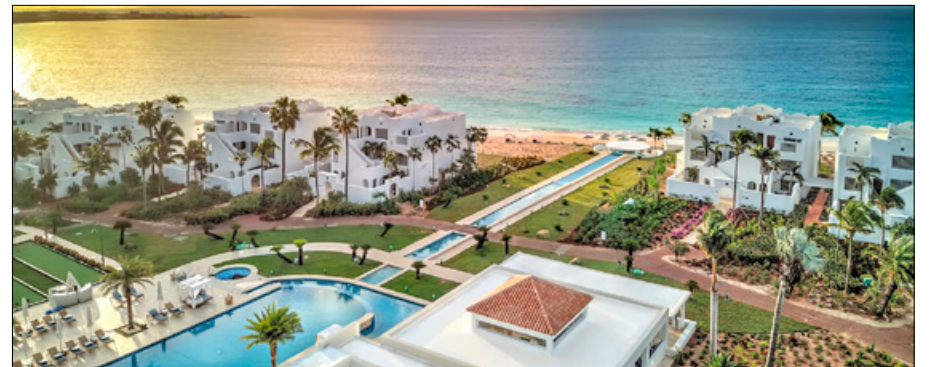
which has led to vast shortages of food, fuel and medicine.

In February, the government asked the UN's food programme for help with food shortages, sending an unprecedented request for assistance in providing powdered milk to children under the age of seven.

But tensions have soared in recent weeks as power generators fail to get the fuel they need for electricity in people's homes and for storing food in fridges and freezers. Record-breaking numbers of Cubans have migrated to the US because of the economic conditions.

Cuba's President Miguel Diaz-Canel acknowledged the protests on social media and said the "disposition" of his government and authorities was "to attend to the complaints of our people, listen, dialogue, explain the numerous efforts that are being carried out to improve the situation".

Anguilla cashes in on unique domain name

Anguilla is a tiny island in the Caribbean but it is enjoying a fortunate financial boost simply from having its unique domain name.

In 1988, the Internet Corporation for Assigned Names and Numbers (ICANN) assigned two-letter domains for every country. Spain was given .es, .mx for Mexico and .uk for the United Kingdom. Anguilla didn't realise it at the time, but the tiny island was fortunate to get the .ai top-level domain. Decades later the artificial intelligence boom is bringing in much needed income to Anguilla, all because of the .ai domain extension. Big and small companies want to build AI websites using Anguilla's .ai domain, which charges for the privilege. Domain registrations and investments now make up a third of Anguilla's revenue in this British Overseas Territory about 155 miles (250 kilometres) from Puerto Rico.

Blue seas, white sand beaches and coral reefs are the main attractions of the island, which depends largely on tourism. In

2020, the most expensive domain on the island, expert.ai, sold for US\$103,000. The real breakthrough came with the launch of ChatGPT in November 2022. Within five months, .ai domain registrations soared. Sales nearly quadrupled, says Vince Cate, who manages domain registrations for the Anguillian government. "We already represent approximately a third of the government budget," he said.

Anguilla earned \$3 million from domain registrations in January 2024 alone, and the estimates are that figure will double by the time they're due for renewal in two years' time.

Some AI companies like stability.ai and character.ai have already claimed their domain names. Big players like Google, Meta and X (formerly Twitter) have also staked their claims in the AI domain. Despite the island's small size and population of only 16,000, domain registration revenue is significant. Estimates indicate registrations could bring to \$78.3 million by 2025.

Better than crunches for flat abs

Although the basic crunch is still popular, by now it's pretty well known that this outdated exercise not the most effective way to flatten and strengthen your abs. It simply doesn't activate your core muscles to the extent that other exercises do, it can hurt your back, and the small motion doesn't do much by way of calorie burning.

So why are you still doing crunches?

What the basic ab crunch does have going for it is its no-equipment, on-the-go nature. You could plop down onto the ground in a park, a hotel room, at the beach or at the gym to crank out a round of crunches wherever you happen to be.

Not the most effective, but, until now, the most convenient.

It's time to upgrade your default, basic crunch to a more modern, results-driven exercise. Below I have the most cutting edge no equipment ab exercise to get you one step closer to those washboard abs that you've been dreaming about.

Better Than Crunches #1: The Plank

To perform a plank, place your forearms on the ground with your elbows aligned below your shoulders, and your arms parallel to your body shoulder-width apart. Squeeze your core and pay attention to keeping your back flat. Focus on pulling your belly button in as you hold the position for 2 minutes.

Better Than Crunches #2: Scissor Kick

To perform a scissor kick, lie with your back into the floor and your arms extended to the sides with your palms facing down. With a slight bend in your knees, lift your legs so that your heels are 6 inches off the ground. Lift your left leg up to about a 45-degree angle while your right leg is still lowered until your heel is about 2-3 inches from the ground. Switch movements by raising your right leg while lowering your left leg. Squeeze your midsection and focus on your breathing as you perform 60-90 seconds of the exercise.

Better Than Crunches #3: V-Ups

To perform a v-up, lie down on your back on the floor and extend your arms behind your head. The back of your hands should lightly touch the floor while your palms face the ceiling. Keep your feet close together and point your toes toward the ceiling. Lift your legs up, keeping them straight at the same time that you raise your upper body off the floor and reach for your toes. Exhale and squeeze your abdominal muscles as you reach for your toes before slowly lowering yourself back down to the starting position. Repeat a series of 12-20 repetitions.

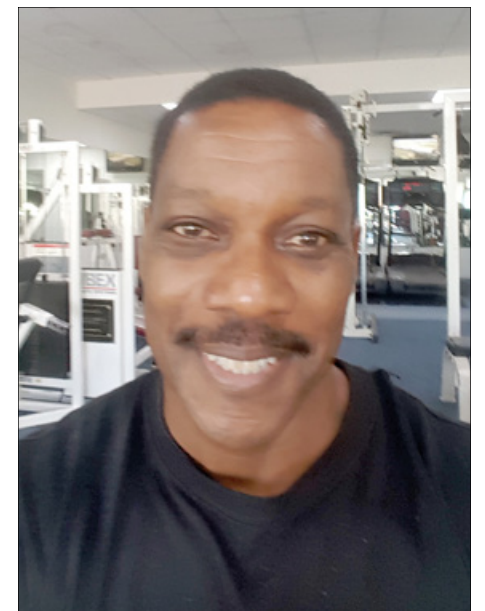
Better Than Crunches #4: Reverse Crunch

To perform a reverse crunch, lie on the floor with your feet flat on the floor and hands behind your head. Press your lower back into the floor and pull in your belly button as you lift your feet off of the floor. Keep your knees bent at a 90-degree angle and pull into your chest so that your tailbone raises off of the ground, and at the same time lift your shoulder blades off of the floor. Focus on squeezing your abs to perform the movement. Slowly lower your shoulders, hips and legs to the starting position, keeping your feet just above the floor. Repeat the movement for 12-20 repetitions while squeezing your abs and focusing on your breathing.

Better Than Crunches #5: Russian Twist

To perform a Russian twist, lie on the floor with your knees bent at a 90-degree angle while raising your upper body off of the ground. Exhale while you twist your torso to the right side until your arms are parallel with the floor. Pull your belly button in and squeeze, then slowly move back to the starting position. Repeat on the left side and continue to repeat both sides for 60-90 seconds.

There you have it, 5 modern, results-driven abdominal exercises that you can perform anywhere! Aim to work your abs at least twice a week for the best results.

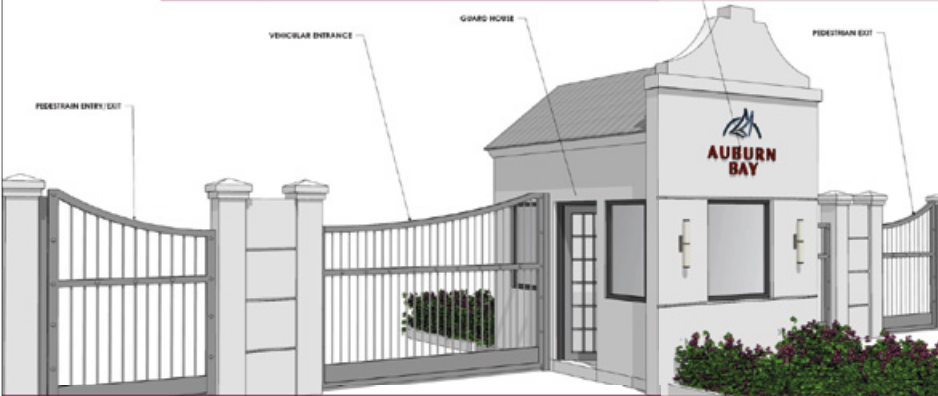
