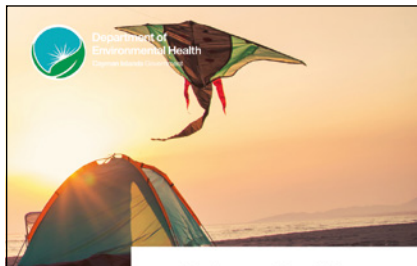

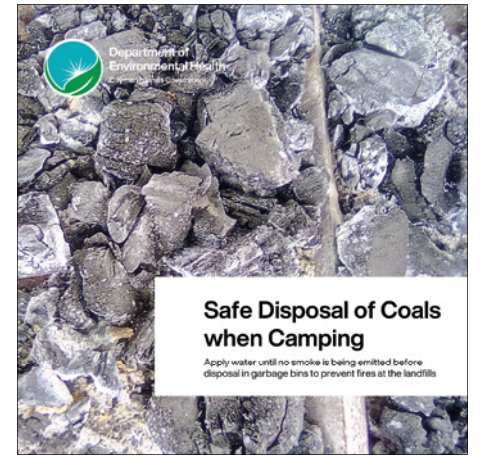

Food Safety & Garbage Disposal Tips When Camping



With the Easter holiday just around the corner and many getting ready to participate in the Caymanian long-stand tradition of camping, the Department of Environmental Health (DEH) reminds the public of the following food safety and garbage disposal tips when camping:

1. Food safety first

The DEH urges campers to take the necessary precautions to prevent food-borne illnesses.

- **Clean.** Wash hands thoroughly with liquid soap, after using the bathroom, before and after handling raw foods. An antibacterial liquid can be used in other instances where hand cleaning is needed and hands are not visibly dirty. Wash utensils, plates, and trays after each use.

- **Store** all clean utensils and food items in containers that are tightly covered, or in cupboards.

- **Separate.** Pack raw meat, poultry, and seafood in separate coolers from food that is

already cooked or ready-to-eat such as dairy items, fruits, pastry, and beverages to avoid cross-contamination during storage.

- **Cook.** By cooking your food to a safe internal temperature you can destroy harmful bacteria. Precook and chill meat at home when possible and reheat on site to 74°C or 165°F. Always pack a food thermometer. Serve hot foods hot.

- **Chill.** Refrigerate or freeze food, if possible, the day before you pack it. Carry extra ice or ice packs to maintain cold temperatures in refrigerated foods. Serve cold foods cold.

Plan ahead to avoid leftovers and organize your meals having in mind the portion sizes. You can also reduce your ingredients and packing list by planning your menus with common ingredients.

2. Keep it clean!

During this Easter, the DEH is partnering with the Recreation, Parks and Cemetery section of the Public Works Department (PWD) responsible for parks and cemetery clean-

ups, in an effort to contribute to the creation of a greener and litter-free environment. Containers for the disposal of litter will be available at popular camping sites. All persons should use these for disposal of any litter or garbage or in the absence of these; persons should bag and take their waste materials home and dispose of there.

However, keeping the environment clean is everyone's responsibility. Here are some tips for campers to properly dispose of their waste while protecting the environment:

- Dispose of all trash (diapers included) properly in the proper bins if available. If bins are not available at the campground, all trash should be removed and disposed of at home.

- Return the campsite to its original condition for the next camper if you disturb it in any way.

- Don't forget your good recycling habits on vacation. They are just as important during camping as they are at home.

Be reminded that improper garbage disposal and littering are liable to penalties under the Litter Act and the Public Health Act, including a fine of up to \$500. Campers should, therefore, avoid such practices. All waste and garbage should be properly disposed of.

Human waste can pollute the waterbodies and provides food for disease-transmitting insects/vermin such as flies and rats. There-



fore every effort must be made to dispose of all such waste in a sanitary manner. Campers should rent a portable toilet or camp at locations with bathroom facilities. Improper disposal of human waste is also an offense under the Public Health Act 2021 (Revision), part III, punishable by fines (up to \$1000) and six months imprisonment.

The DEH wishes the community a safe Easter weekend and thanks the public for their ongoing collaboration in protecting the environment.

A notable absence on this year’s Cayman CARIFTA team is that of Long Jump Champion Andrew Jones, who officials had hoped would defend his title for a third consecutive CARIFTA Games competition. However, he was unable to attend due to scholarship commitments to his school and a track meet scheduled during the time that the Games in Grenada will be taking place.

“He still has another year of eligibility and so we hope he will be able to join us in the future,” noted Mr. Murray, who encouraged the youngsters who would be traveling to Grenada, especially newcomer Delora Johnson, who will be participating in her inaugural CARIFTA competition.

“Every man puts on his pants one foot at a time,” said Mr. Murray, adding that

the Cayman Islands had now come to the point where they were seeing great success in international competition.

Mr. Richard Hew, President and CEO of Caribbean Utilities Company (CUC), said he was honoured to be at the introduction of this year’s Caymanian CARIFTA hopefuls and send them off on a successful trip.

“This is the 45th year we have been involved with track and field, starting from the time I myself was an aspiring athlete in the 400 meters,” said Mr. Hew, adding that track and field availed youngsters of great benefits such as travel, networking, as well as opportunities for further education.

“This means a great deal to CUC, who have been in Cayman since 1966 and we believe in the strength of community,” he explained, adding the he wished the athletes every success and “personal bests”.

Cayman Islands Athletic Association 1st Vice President/Treasurer, Mr. Osbert Francis told the athletes, “...We travel as a team. Team Cayman and everything that happens will reflect on your country.”

He reminded the team of CARIFTA athletes that they should be mindful of that responsibility and trust in their training.

Mr. Francis also expounded on the travel logistics which meant that Cayman would not have a relay team for this CARIFTA Games.

He said travel arrangements were very tight and that ideally, CIAA tries to send their athletes to events two days in advance, adding that the difficulty in getting to Grenada was something they just had to work with.

“It’s usually the other way around for the Eastern Caribbean countries and now we are feeling a little bit of what they have had to go through,” he remarked.

The 51st staging of the CARIFTA Games at the Kirani James Athletics Stadium in Grenada is scheduled for 30th March to 1st April.

Athletes representing the Cayman Islands include, Team Captain Jaiden Reid, who will be competing in the Under 20 - 100 meters, Davonte Howell will com-

pete in the Under 20 - 100 and 200 meters, Michail Michelin (Under 20 - 200 meters), Anthony Chin Jr. (Under 17 - Long Jump), Team Vice captain, Brianna Smith (Under 20 Shot Put) and Delora Johnson (Under 17- High Jump and Long Jump).

Accompanying the team are CIAA Head of Delegation Maxine Anglin and Head Coach Tyrone Yen.

Cayman Brac residents got to enjoy another great Agricultural Show last Saturday, held at the Agricultural Grounds on the Bluff.

From as early as 5:30 in the morning, residents and visitors began assembling at the venue, taking advantage of the early morning cool weather which turned humid as the day went on.

As with previous Agricultural Shows, this year's event highlighted a variety of talent and efforts of the residents of the Brac when it comes to food production and self-sufficiency. Backyard gardening was a stand-out this year, as more residents have been involved in this aspect of agriculture than has been the case in past years. A good deal more young people

were also visibly involved in the variety of different booths and displays.

plans when it comes to food security in the islands.

In his address, The Minister for Planning, Agriculture, Housing, Infrastructure, Transport and Development, Jay Ebanks, expressed his delight at what he had seen at the event. He commended all the farmers and others involved in agriculture and asked them to stay the course, and not waver in their determination to play their part in putting food

production at the forefront of these trying times. Local foods, fruits and drinks were also on sale and attracted a large participation by all present.

The local Cadet Core also made a presentation that captured the hearts of the attendees, as was the viewing of the Security Helicopter, with which children enjoyed having pictures taken. The grand event concluded around 4:30pm in the afternoon.

Stop Noise Disturbance/Nuisance

The Department of Environmental Health (DEH) is advising residents, visitors, and individuals conducting events to refrain from loud noise activities within or in close proximity to schools, health care facilities, and residential premises.

The Department's Environmental Health Officers (EHOs) have been conducting several investigations following an increased number of complaints in relation to noise from various sources including large events, construction or renovation activities, vehicle repairs, gym activities, homes, churches, and loud music from vehicles.

The DEH is also advising all that the failure to comply with an EHO's request makes the offender liable in accordance with the following laws in the Cayman Islands:

a) The Public Health Act (2021 Revision) PART III-Nuisances Section 7 Subsection (2) (w):

For the purposes of this law any noise or vibration (other than noise or vibration caused by an aircraft), which is a nuisance, is a statutory nuisance.

b) The Town and Communities Law (Cap. 169) (1995 Revision) section 13 subsection (1) gives the Environmental Health Officer (EHO) the authority to re-

quire that a noise nuisance be abated. The subsection states that:

Any person who generates noise or is the occupier of premises from which such noise is emitted in excess of the prescribed levels shall reduce such noise to within such prescribed levels if required to do so by a constable or an environmental health officer.

Furthermore, there is concern that in addition to the direct effect on hearing, there are other related health conditions including sleep deprivation/prevention of sleep which is particularly dangerous for ill individuals and professionals such as pilots, surgeons and others for which a specific amount of sleep is required to allow for optimal functionality, and mental health effects. Additionally, social activities may be affected and students (at all levels) as well as persons working from home may be disturbed and this is undesirable.

Any resident or visitor to the Cayman Islands who becomes ill from these activities is encouraged to contact their medical provider immediately.

No Alcohol Sales, Music Playing or Dancing on Good Friday

Liquor licence holders, and music and dancing licence holders, are reminded of their legal obligations regarding Good Friday activities. This year, Good Friday is 29 March.

Liquor Licence holders:

- On Thursday, 28 March, the last serving of alcohol must be done 10 minutes prior to the end

of the establishment's permitted hours.

- Selling alcohol is prohibited on Good Friday.
- Only hotels and restaurants with the appropriate licenses are exempted.
- Please refer to Section 11(8) of the Liquor Licensing Act (2019 Revision), and Section 11 (1) of

the Liquor Licensing Law (2019 Revision).

Music and Dancing licence holders:

- At 11:59 pm on Thursday, 28 March, music playing and dancing must cease.
- Music playing and dancing are prohibited on Good Friday.
- This restriction applies to

all license categories except for hotels, restaurants, airports and 'port areas', as stipulated in Section 3(1) and 3(2) of the Music and Dancing (Control) Act (2024 Revision).

NRSC Calls for Redoubling of Efforts Amid Road Fatalities

The National Road Safety Committee has called for urgent action and the redoubling of efforts from motorists and other stakeholders to reduce road accidents across the Islands following two

road fatalities last week in Cayman Brac and Grand Cayman and a recent incident today (Tuesday, 26 March) along the Linford Pierson Highway in which a speeding motorist injured workers on the road development site.

Details on the Linford Pierson Highway incident is still forthcoming.

Members of the Committee expressed condolences to the families of the deceased in the fatal accidents noting that every life lost on the road is one too many. "These tragic deaths were entirely avoidable," stated Eric Bush, Chair of the Committee and Chief Officer in the Ministry of Planning, Agriculture, Housing, Infrastructure, Transport and Development. "Each loss is devastating and leaves an irreplaceable void in families, communities and society at large. We cannot afford to overlook the gravity of this situation. It is imperative that we all take proactive measures to ensure road safety for ourselves and those around us."

Chief Officer Bush further stated, "We must acknowledge that only through community support and a lack tolerance

for this type of behaviour will we start to bring about meaningful change. Each of us must make a commitment to safe driving practices and cultivate a culture of respect, mindfulness and care on our roads."

In response to the recent fatalities and road accidents, the National Road Safety Committee is urging citizens across all three Islands to take the pledge for safer roads. "We encourage everyone to slow down, to make a "Let us honour the memory of those we have lost by ensuring that such incidents do not recur. Together, we truly can save lives and make a difference."

Statistics from Public Safety Communication 911 indicates that over 600 individual motor vehicle accidents have been recorded since the beginning of the year. Speeding, drunk driving and use of phone while driving are said to be key factors causing accidents across the Islands.



The National Road Safety Committee is actively working with the private and public sector as well as community groups to reduce road fatalities and reckless driving. Members of the public can join the Committee in taking the

pledge to support the Road to Zero campaign by visiting gov.ky/roadsafety and learn more about road safety initiatives and how to contribute to making our roads safer for everyone.

By taking the pledge, drivers, pedestrians and passengers agree to drive responsibly, stay vigilant, educate others and respect the road.

Derri Lee said that "this has been an initiative by the Lean of Me Foundation since 2008. Over the past 9 years they have included contestants and titleholders from the Miss Universe Cayman pageant as many of them are inspiring motivational speakers that have touching backstories and endless aspirations."

Derri Lee added that "as we aim to champion women with a purpose in Cayman we feel that visiting the prisons with messages of hope will somehow change the inmates mindsets and their lives which may ultimately help them to encourage others not to make the decisions that led them to be incarcerated. We all have a purpose in life and we as women have to rise above our adversities"

Theresa Pitcairn was one of the guest speakers. Theresa was Miss Cayman Islands 1982 and Cayman's most successful contestant ever, having placed in the top 15 of the 1982 Miss World contest and taking the Miss Congeniality crown at the Miss Universe pageant in the same year. Theresa is a lawyer, she has served on many Government boards and associations, writing some of our legislations but more importantly she is an advocate for Caymanians in particular Caymanian women. Theresa expressed that "No matter what happens to us, no matter how ugly and awful, no matter how hurtful, it's what you do about it that counts."

Ileann Powery Miss Universe Cayman Islands 2023 was also

a guest speaker. Ileann is an entrepreneur and advocate for all things Cayman. Ileann shared "Our recent visit to the Northward Prison was one of the most memorable experiences for me thus far in this role, and now I can add my visit to Fairbanks as well. During this visit, I reminded the ladies that I am no better than them, but instead, my life story was just written differently and we all serve a different purpose. I briefly shared the different life experiences I've had up to this point of my life and how I maneuvered through them in a way that allowed me to be a better person instead of a bitter person. I also reassured them that their current circumstances does not mean it is the end because their story is still unfolding, so they must keep going and keep striving for better. I am truly grateful for these opportunities and I trust that God has used me to plant the necessary seeds into these ladies lives so that they can be reminded and act on the fact that this is not the end of their story"

Also joining the team was Diane Chung and Belinda Augustine of the Lean On Me Foundation. Both ladies have been heavily involved in community service over the years.

Driver Arrested in Serious MVA on Linford Pierson Highway

Yesterday, Tuesday 26 March, shortly after 3:00PM, police and emergency services responded to a report of a single vehicle collision on Linford Pierson Highway.

Initial investigations indicate that the incident occurred when the driver, who was traveling in the westerly direction, on reaching the round-a-about, lost control of the vehicle, which left the road and collided with a pole, also striking two men who were

working in the area. The vehicle came to rest on the eastbound lane.

The two men were transported to the hospital to receive treatment for their injuries. One man is in a stable condition, the other is in critical condition.

The driver, a 35-year-old man of George Town, was arrested for dangerous driving offences. A breath test was conducted, and returned a negative result.

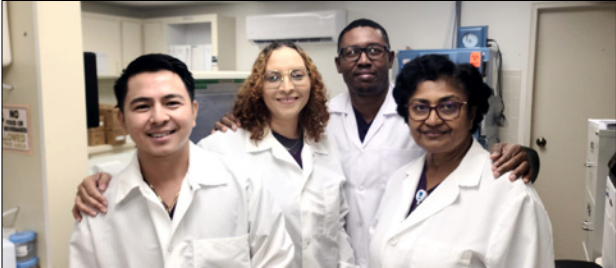

Event goers were requested to pay just CI\$5 to attend the event and sellers paid CI\$30 per spot for a table and space to sell their clothing, shoes, housewares and lots more. The charity received all the CI\$5 entrance fees and half of the CI\$30 stall holder fee (the remainder paying for the rental of the space at the George Town Yacht Club). Stall holders were free to keep any money they made from the sale or donate to the charity. Organiser Kathryn Tarr said she was delighted to take on reestablishing the popular Shop for a Cause monthly sale.

“After my good friend Cindy had to step back from organising the Shop for a Cause event last year due to a busy schedule, I offered to take on the responsibility and am thrilled to say that it was a huge success!” Kathryn advised. Working closely with 20 different sellers, they managed to create a strong turnout for the event, she confirmed. “The morning was well-organised, and we had more than 100 enthusiastic shoppers in attendance. It was heartwarming to hear positive feedback from everyone, with many leaving the event with fantastic bargains.” Kathryn said she had to give credit to the staff at the George Town Yacht Club who were incredibly helpful and lovely to work with. Their support played a significant role in the event’s success, she stated. “One of the highlights of the experi-

To meet the strict accreditation standards of the JCI accreditation survey, the laboratories within HSA had to fulfil several prerequisites to ensure a safe environment that reduces risks, ensures quality improvement, enhances patient outcomes and experience, improves efficiency, and reduces costs through standardised laboratory processes.

JCI surveyors conducted an extensive review of several areas from the prevention and control of laboratory infections and quality control processes to facilities management, safety and staff qualification/education. Surveyors commended the laboratory for being technically strong and proficient, with accurate and reliable test results backed by robust quality control processes.

Commenting on the accomplishment, Laboratory Manager Judith Clarke stated, “This reaccreditation affirms our commitment to delivering high-quality healthcare services. It reinforces the dedication and teamwork of our entire staff, from governance to housekeeping. We have strengthened our team with doctors and consultants overseeing critical areas, and every staff member played a role in the preparation and execution of the accreditation survey.”

The survey is conducted on a triennial basis and HSA laboratory has a distinguished accreditation history, having been accredited since 2015 and successfully reaccredited in 2018, 2021, and now 2024.

Both HSA pathology laboratories are the only two medical laboratories in the Cayman Islands independently accredited by JCI.

“Laboratory accreditation, which is separate from hospital accreditation, is a stringent and in-depth survey that drills down into the greater details of our laboratory processes. A more detailed assessment is carried out in all disciplines of the laboratory which demonstrates laboratory quality and competence,” explained Ms. Clarke.

The Health Services Authority laboratories remain committed to excellence, ensuring the highest quality of care for the community they serve. The laboratory (phlebotomy) service at the George Town Hospital operates Monday to Friday 7:00 AM to 6:30 PM and on Saturday at 7:00 AM to 12:30 PM.

The HSA also offer on-site laboratory services at the Smith Road Medical Centre, 2nd Floor Monday – Friday 7:00am – 5pm.
