

CIFS Brings Fire Under Control


Firefighters have brought a bush fire between the Agriculture Pavilion and Pedro Castle Road in Bodden Town under control.

PARLIAMENT TO SIT FOR FOURTH MEETING BEGINNING 24TH JUNE

The Speaker of Parliament, Hon. Sir Alden McLaughlin, has notified Members of Parliament (MPs) that the Fourth Meeting of the 2023-2024 Session will commence on Monday, 24th June, 2024, at 10:00 a.m.

The Business Committee will meet on Wednesday, 19th June, in order to confirm the order of business for the Meeting. As of 9th May, two Business Papers have been sent to the Members since the previous Meeting in February, for business to be dealt with in the forthcoming

On the two business papers circulated to Members so far included the 2023 Supplementary Plan and Estimates for the Financial Year ended 31 December 2023; two reports from the Office of the Auditor General; an own-initiation report from the Office of the Ombudsman; two reports from the Commission for Standards in Public Life; and, a report from the Human Rights Commission.

Members have until 5:00 p.m. on 13th June to submit Parliamentary Questions for the Ministers, Attorney General, and Deputy Governor, and until 5:00 p.m. on 14th June for any Government or Private Members' Motions to be filed in the Clerk's Office. Any new Bills or proposed legislative amendments must be published in the Gazette by 5:00 p.m. on Friday, 24th May in order to be eligible for consideration at the Fourth Meeting, in accordance with Section 77 (2) of the Cayman Islands Constitution Order (2009) as amended in 2020. House documents will be made available on the Parliament's website at parliament.kv.

BTMI business analysis drives changes to airlift strategy

The Barbados Tourism Marketing Inc. (BTMI) advises that direct services between Barbados and Grand Cayman provided by Cayman Airways will conclude on July 3rd, 2024, with the service being initially reduced to once weekly after May 17th, 2024 when the Thursday/Friday rotation will cease.

Chief Executive Officer (CEO) of the BTMI, Andrea Franklin, stated "The board and management of the BTMI conducted a comprehensive review of airlift into Barbados for the just concluded winter season. Following the evaluation of the route's performance the BTMI and Cayman Airways mutually agreed to terminate the arrangement."

Franklin explained that the Cayman Airways route was initially established to enhance airlift between Barbados and the northern Caribbean, as well as the West Coast of the USA. However, over the past six months, the BTMI has made significant announcements regarding increased seat capacity from its key markets. These announcements will realize a 60,000 seat capacity increase for Barbados from the next winter season. Furthermore, Copa Airlines, a popular choice for connecting travellers from the West Coast of the USA to Barbados, has increased its weekly flights from three to four since January 2024.

"The strategic increase of airlift to Barbados from existing and new gateways in our key source markets is critical to BT-



MI's growth plan," emphasized Franklin. "Thanks to our intensified marketing efforts in these markets, we have witnessed a surge in demand for Barbados which resulted in a 74 % growth from the USA, while capacity from the Caribbean market increased by 63%."

Franklin concluded, "We express our gratitude to Cayman Airways for their support and indicated that the possibility of future partnerships remains open."

Minister of Tourism and Transport for the Cayman Islands, the Hon. Kenneth Bryan, said: "As Minister of Tourism, I acknowledge the decision of the Management and Board of BTMI to discontinue the Cayman Airways service to Barbados. The Ministry of Tourism understands the

need for flexibility in the ever-evolving landscape of air travel and the mutually agreed termination of this contract allows both parties to explore new opportunities and strategic destinations. Throughout the contracted period, Cayman Airways has diligently fulfilled its commitment to provide reliable, quality service between our countries. Moving forward, our national airline will continue to prioritise tourism and domestic routes, utilising our aircraft to support these vital connections. We thank the BTMI for their partnership and wish them the best in their future endeavours."

Cayman Airways will continue to operate until July 3rd, 2024, to facilitate increased activity for the 2024 ICC Men's T20 World Cup. Passengers with bookings for travel after July 3rd will be contacted by Cayman Airways for assistance with rerouting or refunds as needed. Funding Approved by Cabinet to Securely House Irregular Migrants



In a significant move to enhance national security and humanitarian response, on Tuesday, April 30th, the Cayman Islands Cabinet approved a \$2.4 million investment in the construction of a new detention facility.

This decision follows an extensive process that includes business case assessment, design and engineering, and consultation with detention experts. The funding's allocation reflects the government's proactive approach to the escalating risk associated with the potential mass arrivals of irregular migrants, emphasiz-

ing the need for a robust infrastructure to manage such situations effectively and humanely.

The increase in migrant flows around the region, and the number of migrants that arrived on our shores in the recent past have heightened the urgency for adequate, secure housing facilities.

The existing Bodden Town Civic Centre, which was once fully operational and intact, has sustained extensive destruction inflicted by migrants, especially from their makeshift modifications on the inside of the structure.

Cementing these concerns is the fire at the Detention Centre in Fairbanks in September of 2023, which was started by migrants in detention and has rendered the facility uninhabitable. Collectively, these developments pressed the need for urgent and resilient solutions.

The funding will facilitate the construction of a state-of-the-art facility designed to securely house and monitor 180 persons in permanent structures, ensuring their safety and dignity. Additionally, the design includes surge capacity to accommodate an extra 144 persons in short-

term housing, addressing potential spikes in migrant numbers. This facility is not only a response to current inadequacies but also a forward-thinking measure that strengthens the Cayman Islands' ability to manage future challenges in migration.

The new detention centre will be equipped with modern security systems and constructed using resilient materials capable of withstanding extreme conditions, ensuring long-term serviceability. The government's unwavering commitment to upholding high standards of humanitarian care while ensuring public safety is at the core of this initiative.

Seven Migrants in a Vessel Continue On

The Cayman Islands Customs and Border Control Service (CBC) confirms that on Wednesday, 8 May 2024 seven (7) migrants in a vessel were sighted off Queens Highway, East End at approximately 5:30am.

CBC and their partner agencies responded to the scene and the vessel with

all male migrants expressed that they wanted to continue on their journey.

At approximately 9:30am the vessel was headed WNW off Cobalt Coast, West Bay approximately 2 miles from shore headed West at around 2-3 knots. The vessel was monitored by CBC from land until it was outside the line of sight.

scale property marks Dart's second hotel with IHG Hotels & Resorts, joining the award-winning Kimpton Seafire Resort + Spa, which is within walking distance of its sister property. It is also the first Hotel Indigo to be opened in the Caribbean region.

Dart Executive Vice President, Active Investments, Enrique Tasende, said plans for the hotel gained traction following an alltime high in visitor arrivals to the Cayman Islands in 2019, indicating rapid growth in the hospitality industry.

He recalled that the onset of the COV-ID-19 pandemic a few months later brought doubts about whether to proceed with the project. "However, despite those initial difficult months for the world and with a high degree of uncertainty about the future of the travel industry, we had the determination to forge ahead with this idea."

Adding that much of the design work was done remotely because of COVID-19 restrictions, Tasende noted that once that stage of the work was completed, "[w] e encountered a new problem for both the hotel's construction and the procurement process: the supply chain delay issue, which we are still experiencing to this day. That said, we are very proud that in just over four years, including almost two years of a total paralysis in the global tourism industry, we are here today to announce the opening of the first Hotel Indigo in the Caribbean."

Dart Executive Vice President, Development Gary Gibbs indicated that more than 100 local construction companies, vendors and service providers were engaged, totalling more than 3.5 million manhours to safely complete the project.

"Against all the odds, during an unprecedented global pandemic and supply chain issues, I am so proud to be able to say that this amazing hotel was delivered largely on budget and on time," Gibbs said, noting that the partnership with IHG was instrumental from the outset. "In the midst of charting recovery from the devastating impact of the pandemic to their global business, IHG

was committed to ensuring the Caribbean's first Hotel Indigo is a 'must visit' from day one."

As with every one of our projects, we seek to innovate and Hotel Indigo is no exception featuring the islands' very first geothermal ice storage chiller system," he said, explaining that the geothermal cooling system runs during the night to create ice, which is then used during the day to provide the air conditioning for the hotel, helping to reduce peak demand loads.

Minister of Tourism and Ports, Hon. Kenneth Bryan, said he was both proud and excited that IHG partnered with Dart to introduce IHG's fastest growing lifestyle brand to the Cayman Islands.

"This magnificent Hotel Indigo property represents a strategic investment with benefits that will ripple throughout our community for decades - creating employment opportunities, stimulating visitor arrivals, and generating revenue for local businesses and attractions. Furthermore, beyond its economic impact, Hotel Indigo will serve as a platform to showcase our cultural heritage, culinary delights and artistic expressions, to visitors from around the world," he said moments before cutting the rope, another nod to Cayman's rich maritime heritage, to signal the opening of the hotel.

General Manager of Hotel Indigo Grand Cayman, Steven Andre, stated, "We are incredibly excited to share Hotel Indigo Grand Cayman with the world. Cabinet Approves Local Companies (Control) (Fees) Regulations, 2024

Following extensive consultation with businesses, associations and government entities, the cost of local companies control license and processing fees - unchanged for 17 years - shall be revised via regulations approved by Cabinet.

Published on 1 May, the Local Companies (Control) (Fees) Regulations, 2024 contain the revised fees for processing, grants, and renewals of local companies control licences. The additional revenue will help to cover increased administrative costs for service delivery and fund government programmes and initiatives.

To facilitate the Regulations, in February 2024 Parliament passed amendments to the Local Companies (Control) Act (2019 Revision). The amendments are in keeping with the Cayman Islands' modern legislative convention to include fees in regulations rather

than in Acts, which allows more efficient adjustments for policy, operational, budgetary or market forces as necessary.

The revised fees are in the table below.

"I thank all stakeholders who took the time to give feedback during this process,"

said the Deputy Premier and Minister for Financial Services and Commerce, the Hon. André Ebanks.

He said the Ministry will also incorporate the feedback into its commerce framework reform project. Now under-

way, the project is focused on enhancing efficiency and effectiveness and continuing to foster a business enabling environment.. Further consultations on commerce reform will be held throughout this year.

The Cayman Islands Reaches Accommodations Milestone, Surpassing 8,000 Rooms


Visitors to the Cayman Islands now have more choices on where to stay as the destination has reached a major accommodations milestone surpassing more than 8,000 rooms for the first time with a current room stock of 8,022.

This milestone was achieved with the licensing and opening of Hotel Indigo Grand Cayman, the first Indigo branded hotel in the Caribbean, which adds 282 rooms to the destination. The opening of Hotel Indigo further expands the presence of IHG brand hotels in the Cayman Islands, joining the Kimpton Seafire Resort + Spa and Holiday Inn Resort Grand Cayman. The Cayman Islands Hotel Licensing Board, chaired by Director of Tourism Rosa Harris, approved the licensing of Hotel Indigo Grand Cayman.

"This is a significant moment for the tourism industry in the Cayman Islands as we are seeing increased demand for the destination and our visitors have a new option for where to stay," said Director Harris. "Hotel Indigo Grand Cayman is a stunning property with unique attributes that will appeal to visitors and is an excellent complement to our diverse accommodations portfolio, which includes hotels, villas, condos and guesthouses."

The Cayman Islands is slated to add more than 600 hotel rooms in the coming years between in-progress and committed developments in George Town including ONE GT, Grand Hyatt, and Kailani, a Curio Collection by Hilton hotel. The destination also anticipates a steady increase of Airbnb properties across all three islands with 646 properties available as an Airbnb listing.

The additional room stock also complements the destination's plan for avia-



tion development including a proposed extension to the runway at Owen Roberts International Airport on Grand Cayman to accommodate flights from long haul destinations.

"The increased capacity of our room stock supports our drive for more airlift into the destination as we now have the ability to accommodate more visitors," continued Director Harris.

"The opening of Hotel Indigo Grand Cayman is the start of an exciting few years for the Cayman Islands tourism industry as we anticipate more hotel developments

to be completed and open their doors in 2025. Our goal is to develop new markets and flatten our seasonality, while maintaining quality experiences for visitors and residents. Increased accommodation and airlift are crucial to achieving this goal."

Caribbean Week 2024 Set to Sparkle in New York City

Reimagining Tourism: Sustainable economic development through Maritime Heritage



As Caribbean nations continue to endure the impacts of climate change, tourism, upon which so much of the regional economy is based, must transition from an exploitative and extractive practice to one informed by sustainability, localism, and resilience. One way the Cayman Islands can create a unique, sustainable, and resilient tourism market is by combining its rare and prided maritime heritage with its current sea-based tourism sector, generating opportunity for locals and a diverse tourist experience unseen in the rest of the Caribbean.

Reimagining Cayman's cruise ship industry as a sustainable, ethical, and creative economic proposition can be difficult when faced with the industry's destructive impacts. The Environmental Protection Agency reports that in one day, a typical cruise ship creates 21,000 gallons of sewage, one ton of garbage, 170,000 gallons of wastewater, 6,400 gallons of oily bilge water, and four plastic bottles per customer. Furthermore, the industry's largest ships demand the construction of a cruise berthing port, yet Cayman's proposed site is covered in 35 hectares of well-developed, near shore, shallow water reefs. In addition to being valued between \$23 and \$26 million in yearly revenue, they provide invaluable protection by breaking incoming waves, particularly during storms, and preserving sediment. If the proposed cruise terminal was constructed, the dredging would severely impact the surrounding water quality by releasing sediment which would cause degradation of Cayman's famously clear, blue waters.

With the seemingly unending list of negative impacts of the cruising industry, it is necessary for Cayman to divest from emission-rich and exploitative industries, if only to maintain its beauty and endure the predicted effects of climate change. So, what do sustainable alternatives to the cruise industry look like for the Cayman

The key words are resiliency and localism. Although there is no single path for the sustainable transition of Cayman's tourism industry, it could begin by reinvigorating our historic seafaring heritage. Older generations learned the ways of ship building and sailing as children, and by passing on this skill to younger Caymanians, a renewed industry of ship building and sailing could return, building a bridge across ages and preserving the craft of which our ancestors were so proud. This could open new educational and collaborative opportunities between other small island nations, as well as new job opportunities for many Caymanians, including



those who already have expertise operating within the tourism sector.

Larger schooners could be utilised as a local form of cruise-type tourism, offering weeklong sails between Grand Cayman, Cayman Brac and Little Cayman, emphasising our islands crystal-clear waters, highly developed reefs, marine life, and diverse mangrove ecosystems, enticing visitors with our island's natural beauty. For those looking for a longer trip, Jamaica, Cuba, Nicaragua, or Florida could be further destinations, tracing the historic trade and turtling routes of the Caymanian sailors. Larger schooner cruises could open even further to other Caribbean islands, creating relationships by offering alternative forms of tourism made by the people for the people, as opposed to the corporate enterprises that run the global cruise industry. Trips could also feature cultural preservation elements, indulging tourists in 'period piece' type reenactments, with cruises showing off Cayman's unique foods, dress, and rituals like telling 'duppy' stories. For those looking for a shorter adventure, mornings and afternoons could be spent out fishing on a catboat, gliding smoothly over the waves



and exploring Cayman's deep network of mangrove canals.

For those who prefer land-based activities, Cayman could revitalise its catboat regatta races. The first regatta took place in 1935, with 100 catboats participating. By increasing production of catboats, this could be a tourism marvel as many would come to witness the prowess of a new generation of highly skilled sailors. The races could draw on an international rota of professional sailors seeking to try their hand at catboat racing. Televising the event would bring in more income, as well as potential revenue from the international sports betting industry. Another option for landlubbers could entail workshop classes where visitors learn the craft of local industries such as shipbuilding and thatch rope making.

While Cayman must embrace change to create resiliency in trying times, this is an opportunity to inspire innovation, influencing other island nations to follow suit in prioritizing the protection of their environment and culture.

Ashutosh's innovative approach and technical prowess earned him the prestigious first-place title at the Rotary Science Fair.





Emancipation Day celebrated for the first time in 62 years

On the morning of May 3, 1835, a momentous event unfolded in the Cayman Islands. Captain Anthony Pack stood on a low wall overlooking Hog Sty Bay and read a proclamation that would forever change the course of Caymanian history. The Governor of Jamaica, Lord Sligo, was present to emphasize the message: "You who have been slaves and lately acting as apprentices, are by this decision made absolutely and unconditionally free." With those words, Cayman's formerly enslaved population became one of the first truly liberated black communities in the Caribbean"

While the rest of the region still suffered under an apprenticeship scheme described as "slavery by another name," Caymanians were already free.

On 6 May 2024 Emancipation Day was celebrated again, for the first time in 62 years, with a grand and spectacular display of all facets of Cayman Culture, on Seafarers Way, overlooking Hog Sty Bay. There were wonderful displays from each district, and ladies and gentleman dressed in traditional-style beautiful Caymanian clothes.

"I'm from Beautiful West Bay," said Rose May Ebanks. "I'm doing the Cayman Silver Thatch Platting making hats, making bags, making purses and whatever I can make. I learnt it from my mother, Rosalyn Ebanks."

Carlene Carter, Marcieann Hydes, Virginia Rankin where also there, and Ms. Rankin was doing some traditional needlework – making fine and many-coloured rugs from scraps of cloth. In the old days, Caymanians didn't waste a thing. Alanna Warwick-Smith was there, too showing cultural artifacts and books: "It's important that we all take an active role in preserving and nurturing our Caymanian culture," she said.

"It's a West Bay district display of our heritage which is very important because we need to display our heritage and make it thrive, because we are proud to be Caymanian," said Eziethamae Bodden, MBE.

Kendal Connor of East End said: "We are displaying all artifacts, and there are broken chains there, from slavery, and we have Mr. Jeralow Rankine and Allan Ebanks displaying and all the old-time displays of the calabans – and we have the candies you used to get in the olden daysand the we have a Water Glass - in the olden days you used to go fishing and you would put it over the side of the boat to see the fish to see if it was a good spot to fish."

"I am so happy I want to sing," said Heritage Minister Isaac Rankine "this is the first time that Emancipation Day has been recognised in 62 years. It is truly a historic day for the Cayman Islands as we acknowledge and celebrate Emancipation Day as we embrace the heritage of our people.

"Today is a proper reminder of our fore-parents' struggle, and their determination and their fight for freedom from enslavement that has paved the way for the lives we lead today. So let us honor their resilience and fortitude with a celebration that truly reflects and highlights the richness of our heritage"

Tourism Minister Kenneth Bryan said the holiday was supposed to be a celebration of a time when humankind realized how important it is not to enslave another human being.






