Cayman's dynamic art scene and there's art on sale to suit every budget.

"We're delighted to have so many artists and galleries returning for a fourth year and are also excited to see the many artist-led pop-up exhibitions participating this year," said Natalie Urquhart, who initially founded Cayman Art Week in 2021 in response to the challenges artists were facing on the back of the pandemic and lockdowns. "The creative use of both established art venues and the non-traditional spaces to exhibit art is part of what

makes Cayman Art Week so interesting for both experienced collectors and newcomers."

With more than 40 venues already confirmed for CAW24, and with multiple art events happening every day, the challenge is planning your week so as not to miss out. The best place to check the full programme of events is on the Cayman Art Week website, which also has a handy map and profiles of each exhibition. Free bus tours are designed to help visitors fit multiple stops into a single evening.

While all venues are open every day

throughout Cayman Art Week, there are a few key dates to know:

Thursday 23 May: CAW West

Free hop-on, hop-off bus tours run on a loop along the Seven Mile Beach corridor between 6pm-9pm visiting galleries and exhibitions. Stops include Camana Bay (The Hub Gallery, The Gallery by Jason Kennedy & Janine Every, John Broad at Abacus Restaurant, Dready at Tabs, and Ruby Marr at Union Grill), Galleria Plaza (Jo Austin at Ledger & Looms and Cera-Tan at Quinntessential), Kennedy Gallery at West Shore Centre, the Visual Arts Society at Piccolinos, Cayman Passion Art at The Westin lobby, Carlos V Garcia gallery at The Grove, and more.

Friday 24 May: CAW Central/ Art in the City

Start the evening at the popular 'Art in the City' happy hour event on Cardinal Ave courtesy of George Town Revitalisation, before jumping on the complimentary bus tours that run on a loop from 6pm-9pm. George Town venues include new contemporary art space Ngara Galleries, the Guy Harvey Gallery, Claire at the Beach, 3 Girls and a Kiln, and Martlet studios, pop-ups by Goodness, Le Vele, Island House, Mutiny and Cricket Square, and the Cayman Islands National Museum.

Saturday 25 May: CAW East

Curated bus tours run from 10am to 3pm to venues along South Sound and out to the eastern districts, or visitors can choose to drive themselves. Bus tickets cost \$10 and can be booked in advance on eventpros.ky to secure a spot on the bus alongside a knowledgeable CAW team

member and fellow art enthusiasts. Venues include Minds Eye Centre (Miss Lassies), Visual Arts Society (Pedro St James), Scott Swing, Kay Smith Gallery and Studio, White Dog Art, Iain McRae at Gram Bellas, and Artisan Gallery.

Cayman Art Week officially kicks off in Cayman Brac with a reception at Gordon Solomon's Studio on Wednesday 22 May. Other participating venues in Simone's Art Gallery in the Brac, and D'Art of Living, Seahorse Boutique, and Little Cayman Museum in Little Cayman.

Royal Palms Beach Club to be revitalised

Experienced operator signs agreement to give new lease of life to beloved beach bar

Dart and Caymanian businessman Handel Whittaker today announced that they have reached an agreement that will see Whittaker revitalising the storied Royal Palms Beach Club on Seven Mile Beach.

The site has sat vacant since 2020 amidst the global COVID-19 pandemic. Under the agreement between Dart and Whittaker, elements of the property will be refurbished with a wooden deck constructed to the south of the existing pool area with a targeted opening by the end of November 2024.

Whittaker said he plans to hire more than 60 staff for the new operations, the name of which has yet to be unveiled.

"When I closed Calico's a few years ago during the COVID shutdown, I promised

I'd be back," said Whittaker of comments he made when he shuttered another popular beach bar, Calico Jack's, a few miles north at Public Beach. "People have been asking me when I'm coming back. I've kept my promise and I'm delighted to get moving on bringing life back to Royal Palms in a way that people would expect of me."

He indicated his desire to keep the charm of the location with an atmosphere will be similar to what existed at both Royal Palms and Calico Jack's, including the memorable full moon and New Year's Eve parties which were synonymous with the latter.

"We're creating an attraction for cruise tourists to come and enjoy a slice of life

on Seven Mile Beach during the day, where they can lounge on the beach or relax poolside with a cocktail in hand. It will also be a spot that locals and residents can enjoy, as they know the atmosphere we've provided over the years. Our food and beverage offerings will be casual, yet appetising," he said, indicating that he envisages concierge-style service for patrons utilising lounge chairs on the beach.

Dart Senior Vice President Development Planning, Robert Weekley, explained: "As we evaluate our long-term plans for the site, we decided that in the meantime, it is best to work with someone with an established track record in the industry on possible options. Mr Whittaker expressed a desire to utilise the location and we got the ball rolling. We believe this is a win-win for all in-

involved and provides further economic stimulus during the refurbishment and operations."

Refurbishment of the site is subject to relevant Planning Department approvals. Whittaker has already initiated discussions with the relevant government agencies, including the Department of Environment, to facilitate the safe re-opening of the venue with minimal impacts on the nearby marine environment, including installing turtle-friendly lighting. He said his team is also looking at measures to mitigate any noise impacts on neighbouring condominiums and villas.

Not included in the refurbishment are the seaside deck and the upper-level dining room, with the new tenant exploring options to aesthetically enhance that area in sync with the vibe of the re-opened establishment.

On Monday, 6th May 2024, the Cayman Islands National Museum (CINM) debuted its newest exhibition, "Slavery Be Dead, We Be Free," commemorating the return of Emancipation Day in the Cayman Islands. The exhibit offers visitors a poignant exploration of this significant chapter in Cayman's history.

"Slavery Be Dead, We Be Free" vividly depicts the struggles of those who endured slavery and fought for freedom. From stirring narratives to compelling visuals, the exhibition serves as a powerful testament to the resilience of Cayman's enslaved people.

The Impact of Cayman Enterprise City's Socio-Economic Development Project Nears USD \$1 Billion

Cayman Enterprise City Publishes Socio-Economic Impact Assessment by Economist and Leading Advisor on the Caribbean, Marla Dukharan

Cayman Enterprise City (CEC) has released a Socio-Economic Impact Assessment by Marla Dukharan. The report illustrates that CEC is increasing its impact by supporting higher earnings for Caymanians and is driving a shift towards a knowledge-based economy by focusing on high productivity sectors. The release by Dukharan reads, "Caymanian resourcefulness and private sector-led innovation have been the driving force behind the islands' outstanding socio-economic success. Cayman Enterprise City underpins the next generation of Cayman innovation and dynamism."

With an economic impact of USD \$130 million in 2023, contributing just under USD \$1 billion to the local economic activity in 12 years since inception, "CEC is helping the nation to diversify economically, in terms of sectors and jobs, ensuring locals have economic and employment

opportunities that match the nation's progress," the report reads.

The CEC socio-economic development project is now home to 352 Special Economic Zones Companies (SEZCos), many of which are globally recognised institutions led by top executives and industry experts. "CEC member companies are providing high-value employment with salaries exceeding those typically found outside of the special economic zone," said Charlie Kirkconnell, Chief Executive Officer at CEC. "The CEC community is fully invested in Cayman and the report illustrates that the CEC socio-economic development project is making a very significant impact on Cayman's economy and community."

"As CEC continues to grow, it continues to create significant employment and entrepreneurial opportunities for Caymanians and we encourage anyone that might

be interested in finding out how they might get involved, whether as a member of the community and/or as a volunteer in our Enterprise Cayman non-profit organisation (NPO)."

77% of Caymanian-held jobs at CEC member companies, are in sectors with high social returns and increasing global demand. "By putting skills first and prioritizing learning, CEC is enabling new industries to take root," the release by Dukharan reads.

CEC, through its Enterprise Cayman NPO, is a first-mover in private sector-facilitated education and training in the Caribbean, making it a leading force to boost youth participation in the economy. By offering training in specialised skills, Enterprise Cayman is helping to close the gap in higher education and earnings for Caymanians. "Through Enterprise Cayman we've set out to strategically support meaningful employment and entrepreneurial opportunities for Caymanians, by providing internship and mentorship opportunities, by hosting skill-building and career focused training, and by providing inval-

able networking and community engagement opportunities," said Kirkconnell.

In 2023 individuals took advantage of 4,226 opportunities to participate in education, training, and career development events and, since launching entrepreneurial programming in 2021, Enterprise Cayman has worked with 41 new Cayman-born business ventures. "We're helping to develop a local talent pool that meets the demand of Cayman's growing digital innovation and technology sectors while, in parallel, offering exciting opportunities for individuals to launch new business ventures within an innovative business environment," said Kirkconnell.

With CEC's new campus and state-of-the-art facilities, Signal House, the project "holds the promise of deep, continued economic impact," the report concludes.

The Government has abandoned the cruise sector

Despite the Government's positive talk about tourist arrivals, the fact is we haven't even recovered to 2019 numbers. Meanwhile, our competitors have recovered and are surpassing us - attracting thousands of tourists away from Cayman. This loss means missed opportunities and millions of dollars in tourism spending that could have supported Caymanian families and small businesses.

The slow recovery in stay-over tourism mirrors the Government's catastrophic failure in the cruise sector.

The Government has abandoned the cruise sector and the Caymanians who work there. Their inaction is a failure and a dire situation that demands immediate attention and action.

Last year, cruise visitor numbers in Cayman were the lowest since 2002 — lower than after the financial crash and lower than in 2004, when Hurricane Ivan decimated our cruise business.

The Government's most recent data show that cruise visitor numbers slumped



even further in the first three months of this year and were 14% lower than the same period last year.

This is taking place against a backdrop of solid performance by our competitors.

Across the Caribbean, cruise numbers have set a new record for the region.

But the ships carrying those record numbers of visitors are passing Cayman by.

Amazingly the recent Government press release on Tourism was utterly silent about the slump that beset the cruise sector. Pretending that it is not happening,

The PACT/UPM Government just does not know what it wants to do about the cruise sector. Cruise numbers continue to dwindle in that vacuum, and Caymanian businesses and livelihoods are threatened. No wonder Caymanians in Tourism feel worse off under this Government.

The Government has adopted an 'abandon ships' strategy, doing nothing for cruise tourism while the cruise companies decide the future of Cayman's cruise business by increasingly removing us from their itineraries.

Cayman's elected Government should set the pace, not passively watch while the market and the ships leave us behind.

For three years, the Progressives Opposition has argued that Cayman's tourism sector needs a rethink. The Government and industry must come together to plan for the future of cruise tourism.

If the cruise sector is going to be reshaped with fewer passenger numbers, then the Government needs to manage the transition, helping businesses and workers adjust, not just abandoning the sector to the whims of the market.

The urgency of this work is such that it cannot wait another year for a new government after the election. It needs action now. The Progressives are willing to use the experience and the networks we built up through eight years in Government to help this Government find a better path for tourism.

I hope the Government will put selfish electoral interests aside and work with us. Cayman deserves better, and we all need to come together to find the best strategy for the future of our tourism industry.

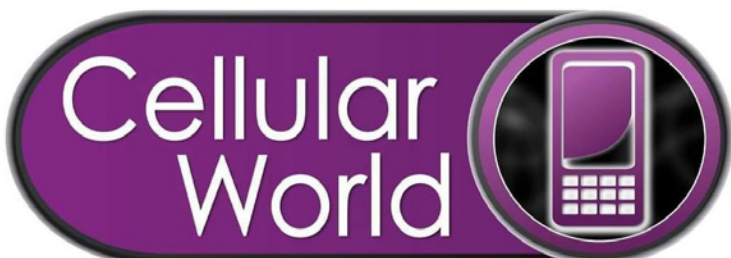

National Trust hosts intimate screening of “Saving the Blues”



Members of the National Trust hosted an intimate screening this week of ‘Saving the Blues’ a film produced by the Cayman

Islands Government Office in the UK, and which first aired during London Climate Action Week 2023. A small group of 50 invited

guests, who were also able to sample Blue Iguana gin cocktails during the evening, which included Her Excellency Governor Jane Owen, Deputy Premier Andre Ebanks and Minister of Sustainability and Climate Resiliency Katherine Ebanks-Wilks.

“Saving the Blues” chronicles the inspiring journey of Fred Burton, a young British Scientist, who dedicated himself to the monumental task of saving the blue iguana, a virtually prehistoric creature endemic to Grand Cayman. The documentary highlights the critical conservation efforts led by Fred Burton, the Department of Environment, and the National Trust for the Cayman Islands, which resulted in the recovery of the blue iguana species from critically endangered to endangered status. Presented by Dr Tasha Ebanks Garcia, Representative to the UK for the Cayman Islands and featuring interviews with Fred Burton, team members from the Blue Iguana Conservation Facility, and global thought leaders, the film underscores the importance of preserving planetary species from a biodiversity perspective.

The keynote speaker for the evening was Ian Redmond OBE, a distinguished wildlife biologist and conservationist, who is currently on island attending screenings of the film and visiting schools. With over 45 years of experience in wildlife conservation, Ian is renowned for his work with great apes and elephants, spanning research, filming, tourism, and conservation advocacy. His impactful contributions to

environmental conservation have earned him international recognition and respect.

Ian Redmond spoke eloquently about the similarities between Diane Fossey saving the critically endangered Mountain Gorillas and the Cayman Islands’ rescue of the Blue Iguana. He explained that everything is connected and if we look after our indigenous species we are not only saving them, but through their very existence the iguanas propagate indigenous plants by spreading seeds and in this way help to maintain the environments in which they and many other creatures thrive. He stressed the value of our remaining areas of virgin forest and wetlands and all the plants and creatures that live in them, who together help sustain each other in balance to make our beautiful beaches, crystal clear waters, corals and sea life.

Following the screening of Saving the Blues, there followed a lively and engaging Q&A panel session featuring Ian Redmond, Fred Burton and Sangeeta Laudus (co-producer of Saving the Blues and interviewer featured in the documentary). Other speakers of the evening included Melanie Carmichael, Chair of the National Trust Council and Frank Roulstone, Director of the National Trust.

Ian Redmond has been visiting schools all this week and will address a free to the public screening of ‘Saving the Blues’ event to celebrate International Blue Iguana Day at The Ritz-Carlton, Andiamo at 6:30pm this evening (Wednesday 8 May).

Police investigate Fatal Collision on Shamrock Road

At about 12:15AM ton Monday, 13 May, the 9-1-1 Communications Centre dispatched officers to a report of a collision involving five vehicles, including a black Honda Accord, a white Toyota Tundra, and a black Honda Fit, which occurred on Shamrock Road, in the vicinity of Coral Bay Village.

Officers from the Cayman Islands Fire Service attended the location and extinguished two vehicles, the Toyota Tundra and the Honda Fit, which had caught fire.

The three occupants of the Honda Fit were subsequently pronounced dead by the attending doctor. As at press time, these victims have not yet been identified and police are appealing for information that may assist with the identification processes.

Two other persons were injured in the collision. They were transported to the Cayman Islands Hospital by ambulance, for treatment for what appear to be non-life-threatening

injuries.

The roadway was later cleared and opened for public use.

The matter is currently under investigation by the Traffic & Roads Policing Management Unit. Police have declared this a major incident involving the RCIPS, CIFS and HSA. Investigators are aware that numerous calls are being made to HSA and funeral homes, and we ask that all enquires relating to possible victims are directed to the RCIPS Casualty Bureau at 1-345-649-4354, for this incident.

The man, a 27-year-old of George Town was arrested for Burglary and Possession of an Imitation Firearm and

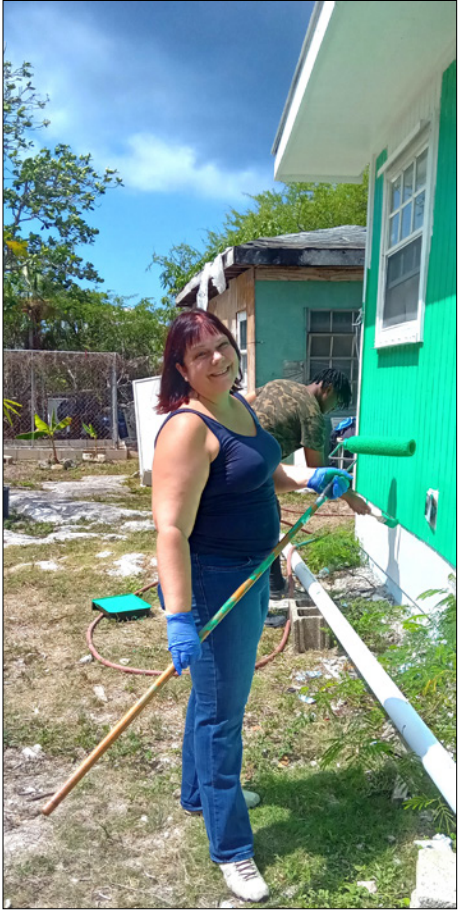
transported to the detention center.

Passport Office Urges the Public to Prepare

The Passport and Corporate Services Office is advising the public to check their passports to ensure all is in order ahead of the upcoming hurricane season, which begins Saturday, 1 June 2024.

As part of the general hurricane season preparedness plan, the public should:

- Check their passport expiry date to ensure validity for the dates of travel,
- Check that their passport is valid according to the country's entry requirements. For example, when travelling to the United States, the British Overseas Territories passport must be valid for at least six months after the date of intended departure from United States,
- Apply for/renew passports ahead of travel time (during peak periods processing time can increase to 10 to 12 weeks), and



- Apply for and process any necessary visas as required for their travel.

In commenting, a representative of the Office explained, "a crucial part of hurricane preparedness is checking travel documents to ensure they are valid in case the need arises for emergency travels."

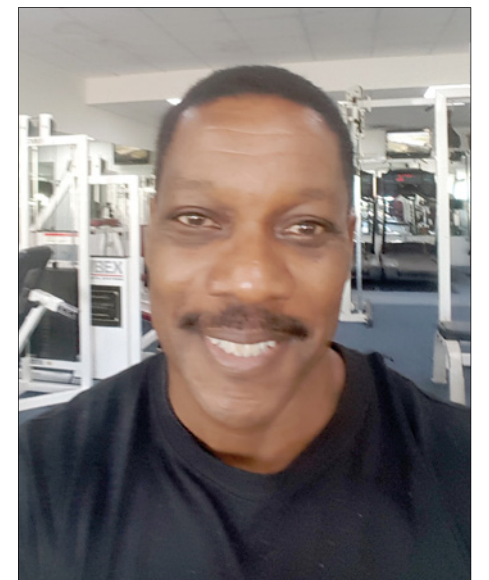

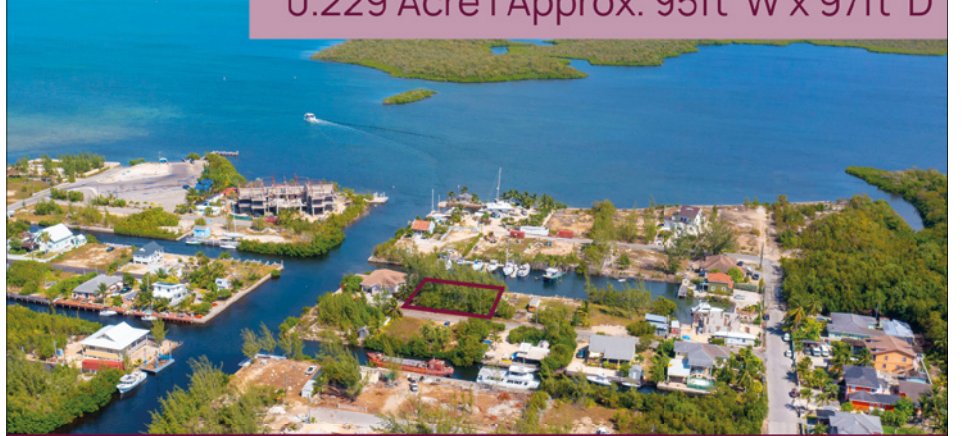
