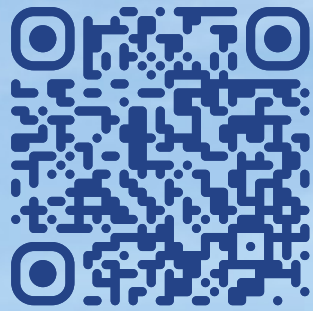

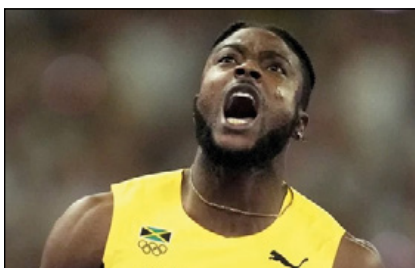

# EDITORIAL: BACKYARD GARDEN INITIATIVE TICKS ALL THE RIGHT BOXES

Our front page for Wednesday August 6th features an initiative by the Ministry of Planning, Lands, Agriculture, Housing & Infrastructure (PLAHI) about the national Backyard Garden Program.

Commendations are in order for Hon. Min Johany S. “Jay” Ebanks for leading this drive as a key component towards achieving food security in the Cayman Islands.

This new community-driven effort aimed at increasing household-level food security and sustainable gardening ticks all the right boxes - including the ‘grow-boxes’. It effectively sows the seeds for a fresh approach to the long-standing mantra of ‘growing what we eat and eating what we grow’.

Not only is this initiative timely, it’s also very necessary especially in a world of tariff wars and supply chain disruptions which contribute to higher prices for the essentials we import.

Applications remain open until 30 August or until supplies last. The Ministry encourages all eligible Caymanians to apply early and be part of a growing movement toward sustainability.

“This pilot initiative, delivered in partnership with the Department of Agriculture, provides participating households with free Grow Boxes, soil, seeds, and basic guidance to start their own backyard garden. The program targets a wide range of Caymanians — from retirees and families to urban residents and eco-conscious youth.”

# Spirit Airlines Launches New Weekly Service from Fort Lauderdale to Grand Cayman

## *Flight will run 3x weekly starting 4 December 2025*



The Cayman Islands is expanding its airlift from Florida with the return of Spirit Airlines nonstop service from Fort Lauderdale (FLL) to Owen Roberts International Airport (GCM) in Grand Cayman. Beginning 4 December 2025, the route will operate three times a week on Thursday, Friday and Saturday.

Expanded airlift is a key goal of the Cayman Islands Department of Tourism (CIDOT)'s aviation strategy, led by Director of Tourism, Rosa Harris. The return of this route is the result of strategic meetings between the Cayman Islands Airports Authority (CIAA) and Spirit Airlines, which were initiated at the recent CAPA Airline Leader Summit hosted by CIDOT at Hotel

Indigo Grand Cayman in April of this year.

"We are pleased to welcome Spirit Airlines to the Cayman Islands," remarked the Hon. Gary Ruddy, Deputy Premier and Minister for Tourism and Trade Development. "Spirit has distinguished itself with its excellent service and value for money. # Caribbean Utilities Company, Ltd. Announces Agreed Path Forward for Grand Cayman's Energy Future

Caribbean Utilities Company, Ltd. ("CUC") is committed to advancing the renewable energy transition, ensuring it is secure, affordable, and beneficial for households, businesses, and communities.

On August 1, 2025, CUC and the Cayman Islands Utility Regulation and Competition Office ("URCO") agreed on an approach to address the urgent need for additional generating capacity requirements for Grand Cayman. As part of this agreement, CUC has voluntarily withdrawn its Certificate of Need ("CON") originally submitted on June 7, 2024. Concurrently, URCO has rescinded its Final Determination issued on April 24, 2025.

CUC will submit a new CON to URCO by September 5, 2025. This updated submission will define the generation resource requirements necessary to support Grand Cayman's projected energy demand from 2027 onward.

CUC and URCO have also agreed that Condition 31 of CUC's Transmission and Distribution ("T&D") Licence, does not preclude the provision of firm capacity generation from renewable sources. Both parties have acknowledged that hybrid solar photovoltaic systems integrated with battery storage may qualify as firm capacity, subject to Effective Load Carrying Capacity analysis.

In addition, both parties are actively engaged in the modernization of the CUC Transmission and Distribution Licence to align with evolving regulatory, infrastruc-

ture, and operational needs. Both parties will apply all reasonable efforts to finalize this process, including establishing milestone dates and deliverables to be agreed upon as soon as practicable.

In support of the broader diversification of Grand Cayman's energy portfolio, URCO issued a Dispatchable Photovoltaic Request for Proposals on July 3, 2025. All eligible bidders, including CUC, are invited to submit proposals by October 2, 2025. This initiative represents an important step in expanding distributed renewable generation capacity.

"We are proud of our strong track record of continuous improvement in reli-



ability with our average annual interruption duration now under 2 hours, and in line with North American benchmarks. We are dedicated to maintaining and improving energy reliability and resilience as we transition to Grand Cayman's clean energy future. The CUC team is fully committed to working closely with URCO to ensure that affordability, reliability, and safety remain at the heart of our clean energy transformation," said President and CEO, Mr. Richard Hew.

to generate, transmit and distribute electricity in its licence area of Grand Cayman, Cayman Islands, pursuant to a 20-year Transmission & Distribution ("T&D") Licence and a 25-year non-exclusive Generation Licence (the "Generation License" and together with the T&D Licence, the "Licences") granted by the Cayman Islands Government (the "Government", "CIG"). The T&D Licence, which expires in April 2028, contains provisions for an automatic 20-year renewal and the Company has reasonable expectation of renewal until April 2048.

## MRCU Ramps Up Response to Mosquito Emergence



While you'll likely notice improvements in the next few days, another spike is likely mid-month due to the recent rainfall. The black salt marsh mosquito (*Aedes taeniorhynchus*) — the main species currently causing discomfort — can also transmit heartworm to dogs and cats. Pet owners are encouraged to speak with their veterinarians to ensure their animals are protected with appropriate preventive medication.

Heavy rains and high tides have led to a surge in mosquito numbers across Grand Cayman — and the Mosquito Research and Control Unit (MRCU) is taking action.

Crews have increased both aerial and ground spraying to bring mosquito levels back down. Right now, we're in the middle of one emergence, and another is expected to begin around 15 August, following Saturday's downpour that left water pooling in areas that were previously dry.

MRCU teams are working extended hours to target adult mosquitoes (the ones that bite) and treat standing water to prevent larvae (baby mosquitoes) from hatching.

"We're doing everything we can to reduce mosquito numbers as quickly as possible," said Dr Alan Wheeler, MRCU Director. "While you'll likely notice im-

provements in the next few days, another spike is likely mid-month due to the recent rainfall."

### What You Can Do

The black salt marsh mosquito (*Aedes taeniorhynchus*) — the main species currently causing discomfort — can also transmit heartworm to dogs and cats. Pet owners are encouraged to speak with their veterinarians to ensure their animals are protected with appropriate preventive medication.

If you notice unusual mosquito biting, please let us know by emailing [mrcu@gov.ky](mailto:mrcu@gov.ky) — include the location and the time of day when it occurred. Your feed-

back helps us target problem areas more effectively.

### A Closer Look at the Mosquito Situation

So far this year, mosquito trap counts have more than doubled compared to the same period in 2024.

- **2024:** Average of 5.8 mosquitoes per trap per night
- **2025:** Average of 13.9 mosquitoes per trap per night

There have been 23 nights so far this year with high mosquito counts — that level was only seen four times last year.

# URCO Confirms Agreement on Certificate of Need: A Practical Outcome for Grand Cayman’s Energy Future

The Utility Regulation and Competition Office (URCO) confirms that it has reached an agreement with Caribbean Utilities Company, Ltd. (CUC) and have settled the legal proceedings initiated by CUC relating to the Certificate of Need (CON) determination issued by the URCO in April 2025. This settlement is reflected in a Consent Order which sets out the agreed way forward for initiation of the competitive bid process (‘the Generation Solicitation Process’) in respect of firm generation needed in the future, as required by CUC’s T&D Licence, and has resulted in CUC withdrawing its application for Judicial Review.

As part of this approach, CUC has committed to submitting a revised CON, this time in the prescribed format, by 5 September 2025, covering projected firm generation requirements from 2027 onward. Concurrently, the Office has rescinded its 24 April 2025 CON Determination, which is effectively made redundant by the withdrawal by CUC of its original CON.

This will now enable the Generation Solicitation Process to move forward in an expeditious manner with the objective of securing Grand Cayman’s future firm generation needs by way of a fair and transparent competitive bidding process, so as to obtain the best reliability and value for money for Grand Cayman’s electricity consumer base.

“We welcome this practical resolution,” said **Sonji Myles, Interim CEO of URCO.**

“While the Office stands by the principles underpinning its original determination, we have always believed that regulatory clarity and process integrity can and should be achieved without protracted litigation at the cost of the people. We are grateful that CUC has agreed to focus its efforts on resubmitting the CON rather than pursuing court action, which we both agree would not have served the public interest.”

The initial CON submission from CUC (June 2024) included multiple generation options, with the 90.1 MW proposal being considered by URCO to be the most suitable. The Office’s April 2025 determination acknowledged the importance of advancing firm generation capacity



planning, so as to ensure reliability of the grid, but noted that the format of the submission did not fully comply with the established requirements.

More importantly, both parties have reaffirmed their shared understanding that renewable technologies which are proven to be capable of meeting firm capacity standards, such as through effective hybridisation and battery integration, can be considered alongside traditional generation options.

“The Board of URCO remains committed to practical, principled regulation,” said **Mr. J. Samuel Jackson, Chairman of the Board.** “This outcome protects the integrity of the regulatory framework vis-à-vis a competitive bidding process for firm power generation, while allowing for renewables to prove their viability as firm generation, which has always been enshrined in the CUC T&D Licence since its inception in 2008. URCO remains committed to enabling the progression of cleaner energy generation in a way that is practical, secure, accountable and fair to consumers, whilst maintaining the necessary reliability of the grid.”

This settlement of the Judicial Review proceedings underscores URCO’s role as a forward-looking regulator that is both principled and pragmatic. It also reflects a mutual interest between URCO and CUC in avoiding unnecessary delays and the significant costs of litigation whilst ensuring that the consumer base of the Grand Cayman benefits from reliable,



well-planned, and cost-effective energy infrastructure. This development comes at a critical time, as URCO con-

currently leads other key initiatives, including the 22.5 MW Dispatchable Solar RFP issued on 3 July 2025, with bid submissions due by 2 October 2025.

“This resolution clears the path for us all to move forward,” said **Mr. McCleary Frederick, Executive Director of Energy.** “The Office remains firmly focused on ensuring energy security, affordability, and a responsible transition to sustainable energy. We appreciate CUC’s engagement on this matter and look forward to reviewing their resubmission.”

As is custom, the Office will evaluate the revised CON in accordance with the terms of CUC’s Licence, applicable legislation and best practices and then publish a new determination and RFP in due course.

Unable to join in person, her mother, Angelyn Hernandez, accepted the Bullish-sponsored STEM Award on her behalf and brought greetings from Gabriella.

"I am truly honoured to receive this award and to be nominated alongside the other winners. I'm grateful for the support

# New Egg Facility Opens at Department of Agriculture to Support Local Production



The Ministry of Planning, Agriculture, Housing, Infrastructure, Transport & Development (PAHITD), in collaboration with the Department of Agriculture (DoA), is proud to announce the official opening of the Cayman Islands’ first government-operated **Egg Production Facility**.

The newly unveiled facility is a key step in strengthening food security and supporting the growth of sustainable agriculture across the islands. Designed to bolster local egg production and reduce reliance on imports, the initiative aligns

with the Ministry’s ongoing efforts to empower farmers and create resilient food systems.

**Minister Hon. Johany “Jay” Ebanks**, who officially opened the facility, remarked:

*“This is more than just an egg facility — this is an investment in our future. It demonstrates government’s commitment to agricultural development, greater local food security, and support for Caymanian farmers.”*

The Egg Facility will be used for:

- Demonstration and training purposes

for local poultry farmers

- Supplying fertilized eggs to support backyard farming initiatives
- Enhancing national food resilience and agricultural education

In addition to supplying eggs, the facility is expected to offer technical support and workshops, equipping Caymanians with the tools and knowledge to engage in small-scale poultry farming.

**Director of Agriculture Wilbur Welcome** stated:

*“This facility represents a long-term*

*vision for the DoA. It allows us to model best practices in poultry care, health, and productivity while supporting Cayman’s broader food sustainability goals.”*

## POLICE NEWS

### Three Persons Charged for Multiple Violent Robbery Incidents

Two men, both age 34, residing in Bodden Town and West Bay respectively, and one male juvenile, age 17, residing in George Town, have been arrested and formally charged in relation to multiple violent robbery incidents which occurred on 14 February 2025, in the George Town area.

**Background**

On 14 February, officers responded to multiple robbery incidents involving a group of masked men.

Shortly before 8:20PM officers responded to a report of a robbery at a barber shop on Eastern Avenue, near the intersection with School Road. It was reported that masked men entered the location, brandishing machetes and demanded cash from the occupants there. They fled the location with a quantity of cash and personal items, travelling in a small vehicle. One man received a minor injury during the incident, which did not require medical attention.

At about 8:40PM officers responded to a report of a robbery at a convenience store on Prospect Drive. It was

reported that three masked men with machetes, entered the location and demanded cash. The men stole a quantity of cash from the register and then fled the location. One man at the location was struck by a machete and received minor injuries. He was treated on the scene by EMS personnel.

Additionally, at about 7:25PM, officers responded to a report of an attempted robbery and wounding at an address on Holmes Turn, George Town. It was reported that a group of masked men with machetes had attended the location in a vehicle, and attacked a man there. They then ransacked the yard before leaving the location. The man received injuries to his hand and arm and attended the Cayman Islands Hospital for treatment. He has since been discharged.

The three have been charged with three counts each of Robbery, one count of Attempted Robbery, and one count of Wounding each.

They appeared in court on 5th August. The two men were remanded in custody, while the juvenile was granted bail, all pending a further appearance on 27 August.

Police can now confirm the identity of the deceased in the fatal collision which occurred on Monday morning, 28 July, on Shamrock Road. He is 31-year-old Durvin Norales Mejia, a Honduran national residing in Cay-

The other occupants of the vehicle remain in hospital.

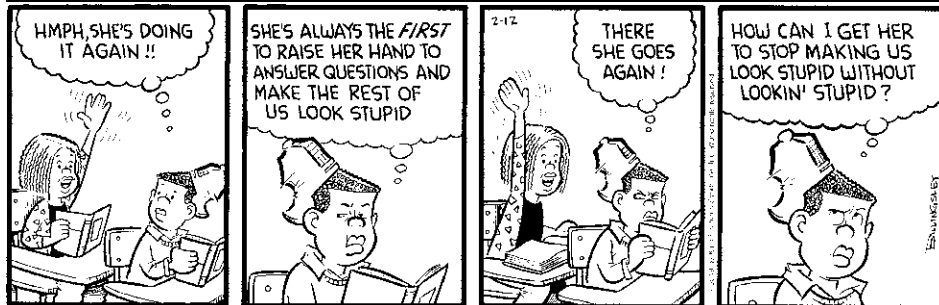
