Batabano Honors Our Carnival Matriarch: Reba Dilbert



With hearts full of love and immense admiration, the Batabano family celebrates the life and legacy of a woman who embodied the very soul of our Carnival—Reba Dilbert, lovingly known as the Mother of Batabano.

A Life Devoted to Carnival

Born on June 15, 1954, Reba graced our world with a spirit as vibrant as the costumes she would come to create. For 42 magnificent years, she blessed our streets with her passion, her artistry, and her unwavering devotion to Caymanian culture. She missed just one parade in all that time—a testament to her deep com-

mitment and fierce pride in our traditions.

Even this year, knowing it would be her final lap, Reba went down the road with dignity and grace. Despite facing significant health challenges, she showed up with strength and determination, gifting us one last moment of her magic in May 2025. Her courage in the face of adversity exemplified the indomitable spirit that made her such an inspiration to all who knew her.

Master of Her Craft

Reba was more than a designer—she was a storyteller, a cultural ambassador, and a keeper of our island's soul. Her

costumes didn't just adorn bodies; they told the stories of our people, our land, and our heritage. Through fabric and feather, colour and creativity, she brought our natural world to life on the carnival road.

Her designs were love letters to the Cayman Islands. You would see going down the road the magnificent Cayman Parrot in all its emerald glory, the noble Iguana basking in sequined splendour, the humble Mosquito transformed into art, the ancient Turtle swimming through crowds, the towering Silver Thatch Palm swaying in the breeze, the delicate Banana Orchid blooming with pride, and the iconic Conch shell echoing our maritime heritage. The list is endless, for Reba's imagination was boundless.

This is what her designs were about - making the relatable beautiful, taking the everyday wonders of Caymanian life and elevating them to carnival royalty. Every stitch carried meaning, every color told a story, and every creation was a celebration of who we are as a people.

A Legacy of Leadership

Reba designed and produced costumes for both Junior Batabano and Adult Batabano, nurturing the next generation while continuing to inspire her peers. Her West Bay revellers knew they had something

special in their midst. Like Ted, who was always her King, they understood that to walk with Reba was to feel the very essence of Batabano coursing through their veins.

Her presence lifted every soul around her. She was a heartbeat, a visionary, a guide who showed us all what it meant to truly live our culture rather than simply perform it. In her hands, carnival became more than entertainment—it became a sacred celebration of our identity.

The Heart of Community

Beyond the glitter and glamour, Reba was the beating heart of our carnival community. She mentored countless designers, inspired generations of masqueraders, and created a legacy that will continue

CIG RECORDS SECOND QUARTER SURPLUS

Unaudited financial results for the second quarter of 2025 show a \$194.0 million year-to-date surplus for core Government operations and a \$201.5 million surplus for the Entire Public Sector (EPS). Net assets of the Government were \$2.6 billion, with overall bank account balances of \$494.8 million in cash and deposits.

According to the 'Quarterly Financial Report for the Six-Month Period Ended 30 June 2025', the overall EPS surplus of \$201.5 million was \$42.1 million, or 26 per cent, greater than the projected year-to-date operating surplus of \$159.4 million.

It says: "This favourable position was due to actual revenues being higher than budgeted by \$61.4 million for the period, primarily due to coercive revenues being \$53.0 million higher than expected and investment revenues showing a positive variance of \$7.3 million."

Revenue exceeds expectations

The new report also explains that the higher-than-expected revenues were complemented by lower levels of expenditure in personnel costs, which were \$8.8 million less than budgeted, as well as lower spending on supplies and consumables which was \$8.2 million less than budgeted.

However, comparing year-on-

year numbers, the EPS surplus was \$14.9 million lower than that achieved for the same period in 2024.

Statutory Authorities and Government-owned Companies' (SAGCs) results through the second quarter of 2025 showed a negative variance of \$5.7 million when compared to the same period in 2024.

Compared to the same period in the prior year, total revenues of Core Government have increased by \$51.5 million, while total expenses of Core Government have risen by \$60.7 million for the comparable period.

The first six months of 2025 generated total revenues of \$766.3 million, which was \$61.4 million more than budgeted expectations and \$51.5 million higher than the 2024 year-to-date actual results, mainly due to coercive revenues being \$53.0 million higher than budgeted.

The bulk of this is credited to strong performances in the financial services sector.

Shortfalls

But the report also notes that, notwithstanding the overall favourable results, when compared to the 2025 Budget, there were certain areas that fell short of projected expectations. These include some key import duties, which amounted to \$14.3 million less than anticipated, and \$2.0 million less than the prior year-to-date amount.

Significantly, under the category of Total Investment Revenue, income of \$12.0 million, which was \$7.3 million more than anticipated for the six-month period, the report stated.

Government expenses for the first six months of 2025 amounted to \$572.3 million, \$27.8 million more than the year-to-date budget of \$544.5 million. Com-

pared to the prior year-to-date actuals, expenses for the second quarter of 2025 are \$60.7 million higher.

The Government recorded some savings against budget in Personnel Costs by \$8.8 million and Supplies & Consumables by \$8.2 million. However, these savings were offset by higher-than-budgeted levels of expenditure in Outputs from SAGCs by \$12.1 million, Outputs from Non-Governmental Suppliers by \$20.3 million, and Transfer Payments by \$21.3 million.

Outlook

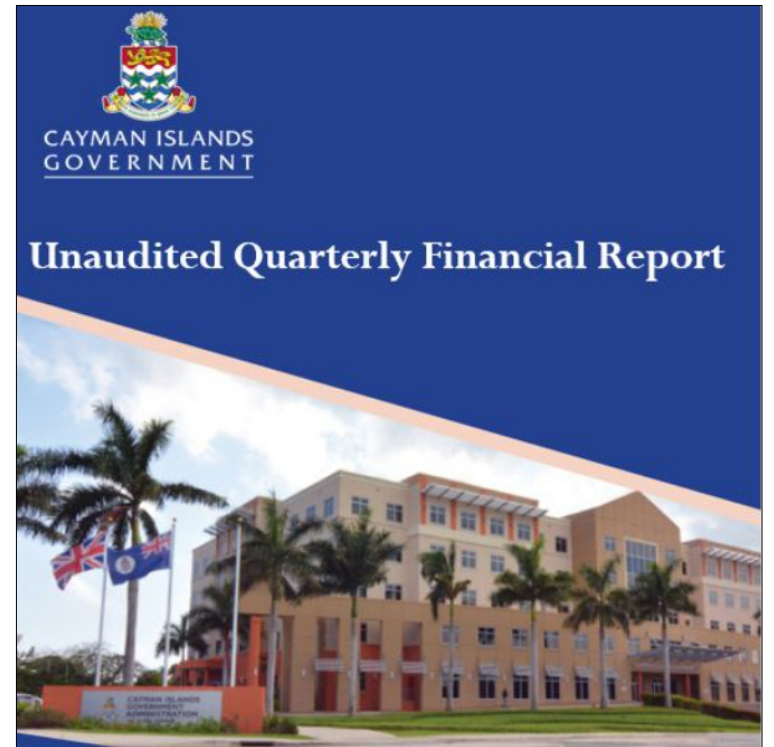
The report concluded that while the Second Quarter's performance has positioned the Government to be optimistic about its performance for 2025, costs will continue to increase as more personnel vacancies are filled and projects come online over the remaining two quarters

of 2025.

"These costs will have to be diligently monitored to ensure spending is not incurred unnecessarily. If the planned increases in operating activity occur during the remainder of 2025, the surplus as of 30 June 2025 is expected to be significantly reduced," the report said.

This data, gazetted on Friday August 8th, suggest a trend contrary to the Pre-Election Financial and Economic Update produced by the Ministry of Finance and Economic Development in April this year and which was a main issue in the election campaign. That report had projected the likelihood of a KYD\$26.2 million operating deficit by the end of this year.

While the current report suggests a more optimistic outlook, it remains to be seen if the surplus trend will be sustained to the end of the year.



New Office Bolsters Cayman's Defence Against Illicit Finance and Advances FATF Effectiveness

The Cayman Islands Government has taken a decisive step forward in the global fight against illicit finance with the establishment of the Office for Strategic Action on Illicit Finance (OSAIF), a centralised authority that reinforces the jurisdiction's alignment with international standards—particularly those of the Financial Action Task Force (FATF).

Housed within the Ministry of Financial Services and Commerce, OSAIF consolidates the nation's strategic leadership, interagency coordination, and operational delivery in anti-money laundering, counter-terrorist financing, and counter-proliferation financing (AML/CFT/CPF). This move marks a strategic progression from policy development to demonstrable effectiveness—an essential benchmark under the FATF framework.

"The establishment of OSAIF reflects our unwavering commitment to effec-

tiveness, not just technical compliance," said the Premier and Minister of Financial Services and Commerce, the Hon. André Ebanks MP. "We must demonstrate that the Cayman Islands can swiftly and cohesively respond to the evolving threats of illicit finance, while meeting the FATF's expectations for tangible outcomes."

OSAIF's remit includes oversight of the national coordination team preparing for the next Caribbean Financial Action Task Force (CFATF) evaluation in December 2027 (the 2027 CFATF Evaluation). This evaluation will assess the Cayman Islands' effectiveness in achieving the FATF's Immediate Outcomes—key performance indicators used to measure how well countries prevent and combat illicit finance in practice.


In addition to national risk assessments, policy leadership, and legislative

coordination, OSAIF integrates the former Anti-Money Laundering Unit and other Ministry experts to deliver cohesive, measurable progress across all AML/CFT/CPF functions.

"The FATF's global standards continue to evolve, placing increasing emphasis on effectiveness," the Premier added. "OSAIF ensures we remain at the forefront of these developments—proactively mitigating risks, demonstrating impact, and upholding our international reputation as a country of financial services integrity, particularly as we prepare for the 2027 CFATF Evaluation."

By transitioning from fragmented functions to a unified strategic and operational centre, OSAIF solidifies the Cayman Islands' ability to deter, detect, and respond to illicit financial activity—locally and globally.

partment of Children and Family Services to sponsor the Seniors Sports Day and donating vegetable seedlings to the John Gray High School Agricultural Project.

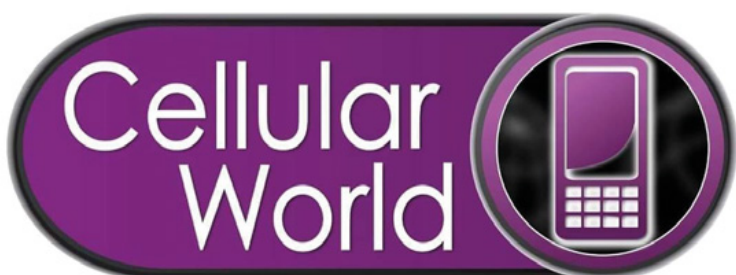

CHAMBER OF COMMERCE AND GOVERNMENT SHARE IDEAS

The Cayman Islands Chamber of Commerce and the ruling National Coalition for Caymanians coalition administration have had their first formal consultation addressing a range of issues of mutual interest.

Premier Ebanks welcomed the initiative, expressing interest in more frequent consultations and noting a key procedural change.

Key issues discussed were Sustaining Economic Growth, Building a Future-Ready Workforce and Advancing Quality of Life.

On the issue of sustaining economic growth, the Chamber Council led by President-Elect Cristina Spratt, highlighted what it described as "urgent concerns regarding planning delays and outdated regulations that affect over \$2 billion in projected development."

The Chamber called for the adoption of ICC 2021 and NEC 2023 building code

regulations, the approval of third-party inspections and the creation of a Construction Building Council.

Spratt also introduced the Chamber's proposal for a national AI strategy.

Premier Ebanks expressed full support and agreed to a follow-up meeting. He signalled his intention to revive and expand the AI committee, with an official announcement planned for October.

The Chamber additionally requested formal representation on key government boards. The Premier welcomed nominations, particularly for the Health Services Authority, and suggested observer status where full appointments aren't feasible.

Regarding building a future-ready workforce, Chamber Council Secretary Heather Halsey presented updates on workforce initiatives, including progress on the Na-

tional Human Capital Development Plan, expanded efforts in apprenticeships, VO-TECH Stars, and Mentoring Cayman.

Public transport reform was also discussed. The Premier confirmed that it remains a long-term priority, likely to be addressed in the 2026-27 budget cycle.

With respect to issues surrounding advancing the quality of life, Councillor Dr. Annette Stephenson shared insights on rising concerns about the cost of living.

In response, Premier Ebanks endorsed pension reform and a customs code review. He also supported forming a working group on affordability and recognised the need for more coordinated urban and housing development.

Outgoing Chamber President Omari Corbin introduced the concept of a Government Accountability Scorecard to enhance transparency and accountability. Premier Ebanks is said to have expressed a strong interest, particularly in its alignment with future digital governance initiatives.

The discussion also touched on upcoming partnership opportunities with both parties agreeing to maintain momentum.

Topics such as immigration, labour reform, and support for the Cayman Islands Trade Council will be priorities in future meetings.

President Corbin proposed regular Cabinet check-ins to track progress. Premier Ebanks supported the idea, recommending that the next session take place in September or ahead of the October Luncheon.

Collaboration in Action

A Chamber statement recapping the meeting with the government said it marked a strong step forward in building a more connected, accountable, and forward-thinking relationship between the Chamber and the Government. "With clear action items and an open channel for dialogue, the stage is set for a lasting and meaningful impact," it added.

Archipelago: The Fourth Cayman Islands Biennial Opens October



► 3rd Cayman Islands Biennial at the National Gallery

The National Gallery of Cayman Islands is taking the 4th edition of the Cayman Islands Biennial to new horizons by inviting U.S.-based curators for their themed exhibition, Archipelago. This multi-sited exhibition represents the best submissions from Caymanian artists across all three islands and the Diaspora to showcase the breadth of diversity and creativity in this Caribbean country.

The Biennial runs October 2, 2025-February 18, 2026, at the National Gallery and across several satellite spaces across Grand Cayman, Little Cayman, and Cayman Brac. These sites include the Cayman Islands National Museum and the Little Cayman Museum, with others to be announced along with the list of selected artists on September 1, 2025 (second press release to follow).

Admission is free to the public, as is the suite of programming that will animate the venues throughout the exhibition run.

Inspired by the scattered formation and relative isolation of islands, the theme Archipelago foregrounds the interplay of the individual and the collective, just as an archipelago is simultaneously a single conglomerate and a chain of several distinct land masses. The exhibition will be organised according to multiple sub-themes for this interplay of individuals within/against a collective. These include the cultural shift of heritage, memory, and belonging; social dynamics shaped by communication, politics, and technology; and ecological legacies as they pertain to preservation, sustainability, and environmental concerns.

This curated exhibition consists of 80 works in all media, juried from 165+ submissions by 100+ artists—a testament to the cultural growth since the first biennial in 2019, with 51 works by 41 artists. At the closing ceremony, artists will be selected for the Bendel Hydes and the Emerging Artist awards, with monetary and exhibition development for awardees.

While the first editions were juried by regional experts and curated by the National Gallery curatorial team, this edition invited Joseph L. Underwood and Davin Ebanks to co-curate the fourth edition, the latter who is a former Bendel Hydes Awardee (2nd Cayman Islands Biennial). In selecting this curatorial team, National Gallery Director Natalie Urquhart shares, “As frequent collaborators in their faculty roles at Kent State University (Ohio, USA),

professors Underwood and Ebanks bring a unique blend of curatorial, studio, and art criticism experience to this project. As co-curators, they are working with our Caymanian artists—locally and abroad—as well as our gallery staff and their curatorial assistants to develop something really dynamic. It will continue to strengthen wider mission of the Biennial project, which seeks to challenge our artists to situate their works in larger global conversations, and to address the critical issues of our time in their practice.” Underwood and Ebanks will also serve as authors and editors of the catalogue published in conjunction with the biennial, available early 2026.

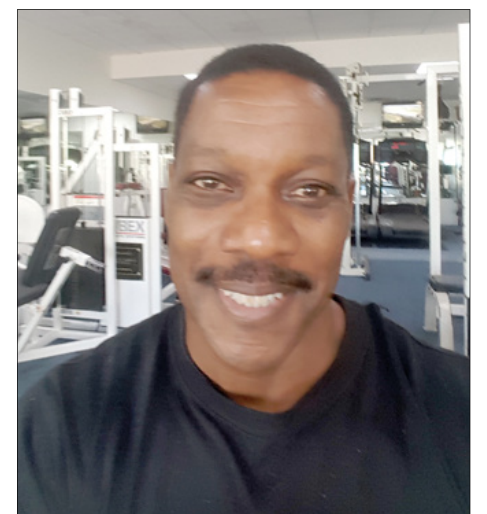

The most exciting start in years of a new Premier League kicks off in England this weekend with football fans intrigued to see who will end up kings of the most competitive league in the world.

Liverpool romped to Prem triumph last season in Arne Slot's debut reign at Anfield, mainly because all the contenders were in flux. Mohamed Salah won't have to be at his imperious best every week for the Reds to score bundles given the new supporting cast, which could also feature Alexander Isak by the time the window shuts at the end of August. Even without the Swede they look likely to repeat. Their only weakness seems lack of depth in defence and the impact Diogo Jota's death

will have on the squad. His passing may spur the players on even more to win a title for him and in his memory. If Liverpool sign Crystal Palace and England defender Marc Guehi, retaining the title looks assured. The Reds face Bournemouth at home on Friday.

Likeliest contenders will be newly crowned Club World champs Chelsea. The Blues youngsters matured dramatically around Easter after their title challenge last season waned from Christmas onwards. They finished with a flourish to gain a Champions League spot and had a fantastic summer, securing the Conference League and then smashing European champions Paris St-Ger-

main for the Club World Cup title. Enzo Maresca has amassed a huge young and talented Blues squad and the fact that he can field two teams of equal ability bodes well. Superstar Cole Palmer will benefit from the arrival of the likes of Liam Delap, Joao Pedro and Estevao Willian who have all impressed already in a handful of games. The Blues face FA Cup and Community Shield winners Crystal Palace on Sunday.

Manchester City splurging in the last two transfer windows means the latest team is drastically changed from the one that won a historic fourth straight title in 23/24. It will still be full of quality though, and perhaps the most attacking,

high-pressing version of a Pep side. City are away to Wolves on Saturday.

Arsenal, league runners-up for the last three seasons, have finally signed a striker that could lift them to that elusive title. Viktor Gyokeres was brought in after a ridiculously successful spell at Sporting Lisbon (97 goals in 102 appearances), and should he live up to expectations, he could make long-frustrated Gooners finally happy. Arsenal travel to Manchester United on Sunday. United are in transition and if Ruben Amorim can continue to instil the discipline he is imposing at Old Trafford, they will finish much better than last season's dismal 15th place.

Shai raises West Indies Hope with superb ton

The fast bowler blew away the Pakistan top order to finish with figures of 6-18 after the tourists were bundled out for just 92 in a chase of 295 to win. The Windies had reached 294-6 in their 50 overs batting first, powered by captain Shai Hope's brilliant unbeaten century.

The Windies sealed a much-needed first ODI series win against Pakistan since 1991, after being swept aside 3-0 and 5-0 in Test and T20 series respectively by Australia and being annihilated by England in recent months.

"We stress on negatives a lot in West Indies," Hope said. "So many positives to shout about. Great to see the guys pulling off history. Seales is a quality bowler. He's a class act. Anything you ask him to do, he puts his hands up."

Hope finished on 120 not out, with 10 fours and five sixes, completing his 18th one-day international century. He now sits behind only Brian Lara and Chris Gayle on the all-time list for most ODI tons for the Windies.

West Indies have bounced back from dire displays abroad to defeat Pakistan on home soil.

An inspired Jayden Seales led the West Indies to a crushing 202-run victory over Pakistan in the third and deciding One-Day International in Trinidad on Tuesday.

Teen Mboko eyes US Open inspired by Canadian show

Tennis sensation Victoria Mboko is focusing on the US Open after her unexpected win at the Canadian Open last week.

Her coach Nathalie Tauziat has backed Mboko's US Open chances as she discussed the Canadian's decision to pull out of the Cincinnati Open. Mboko stunned the tennis world with her epic Canadian Open triumph, rallying from a set down to beat Naomi Osaka in the final.

Ranked 85th in the world coming into her home event, having needed a wildcard to enter the draw, the 18-year-old has now surged up to a staggering new career-high of world No24.

That is enough for Mboko to be seeded at the US Open which starts next week, in what will be her third Grand Slam appearance. Mboko came through qualifying to make her Grand Slam debut at the French Open, reaching round three, before making the second round of Wimbledon as a lucky loser.

Mboko beat four Grand Slam champions, including Osaka, to triumph in

Montreal. She will not play between her win and her maiden US Open main-draw appearance.

Mboko's career is currently being guided by the hugely experienced Tauziat, a former world No3 and runner-up at Wimbledon in 1998. Tauziat said: "Based on the way she's playing, we know she's capable of doing something big in New York. We want to focus 100% on that tournament, arriving well prepared and injury-free."

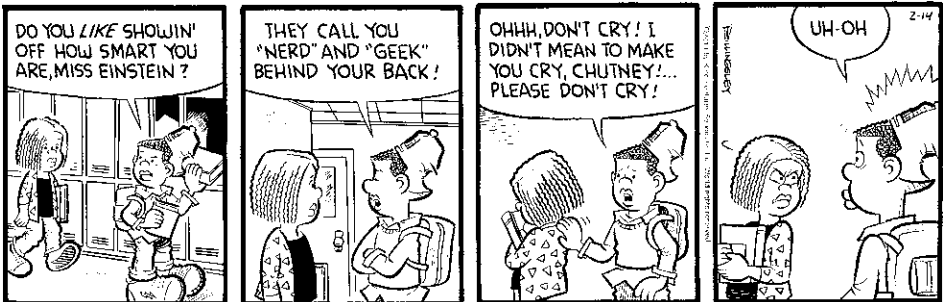


