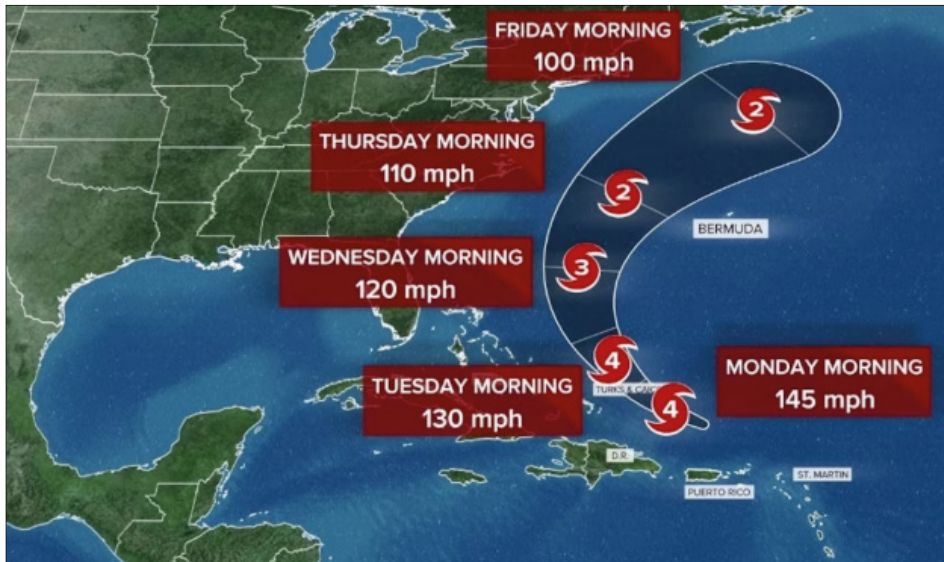

# CATEGORY 5 HURRICANE ERIN SENDS A STARK REMINDER

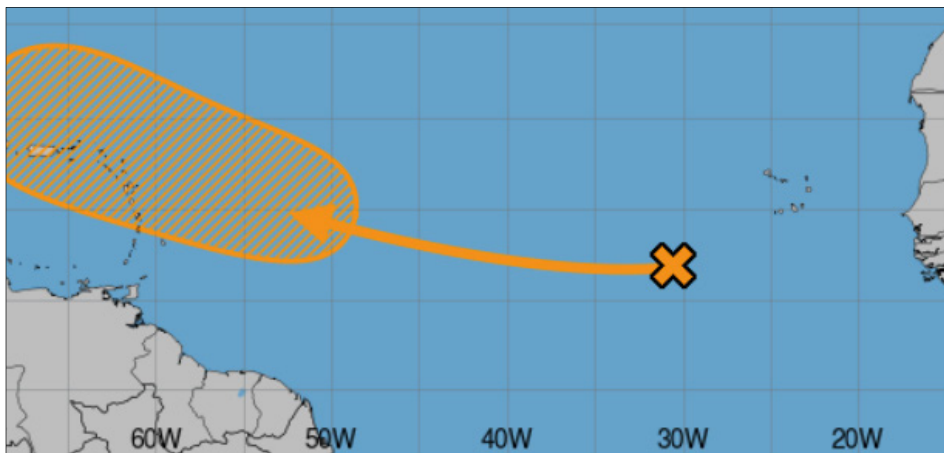
So far, yet so close – in contrast to so close, yet so far – might be one way of putting the passage of Hurricane Erin relative to the local area. Although not in the immediate vicinity of Cayman, the rapid intensification of the storm to Category 5 strength this past weekend was a sombre reminder of the need to be prepared for any eventuality, especially now that the 2025 hurricane season is nearing its peak.

Hurricane Erin churned up the seas in the Atlantic and caused shoreline damage and flooding as it swept past the North-eastern Leeward Islands this past weekend.

It was continuing on a path taking it east of the Turks and Caicos Islands and the Bahamas and passing between Bermuda and the US east coast. Erin is not expected to make landfall on that track.

With the 2025 season now reaching what's generally regarded as the most dangerous phase, we recap the outlook of the Cayman Islands National Weather Service for the 2025 season issued in April in which it stated: "We anticipate that the 2025 Atlantic basin hurricane season will have above-normal activity...We anticipate an above-average probability for major hurricanes making landfall along the con-

# Government Reports Strong Start in First 100 Days

On Friday, 15 April, the National Coalition For Caymanians Government released its' First 100 Days in Office Report, highlighting swift and decisive action across multiple sectors on the road to creating a stronger, fairer Cayman Islands.

In employment and immigration, the report highlights the Government's work to implement term limits for non-Caymanian civil servants, with implementation scheduled to start in January 2026. The Government also approved drafting instructions for amendments to the Immigration Act, introducing updates to strengthen immigration rules and promote fairness, accountability and opportunity across all sectors.

Tourism has been boosted through additional airlift capacity from Porter and Spirit Airlines, reflecting strong demand from high-value markets and demonstrating successful partnerships with international carriers.

On the economic front, Government has supported local families through stamp-duty waivers totalling CI\$1.04

million. Most of these waivers benefit first- and second-time property buyers, and they support homeownership for Caymanians and stimulate economic growth. Sound financial management also generated CI\$5.80 million in revenue from fixed deposit investments, contributing to fiscal stability.

Financial services and commerce continues to be the longstanding pillar of the Cayman Islands' fiscal stability. It significantly funds Government's ability to care for everyone, young and older, through prudent, efficiently delivered services. On Government's direction, the Ministry has therefore reviewed, revised and reinvested the Ministry's strategic and operational thrust, on both commercial and regulatory matters.

Further, the formation of the Poinciana Mental Health Advisory Council is a foundational step in ensuring our mental health system is accountable and responsive to the needs of all. Additionally, standalone legislation has been developed for mental health. These achievements

support Government's focus on building a more resilient Cayman Islands, where health, environment, and sustainability are at the heart of national progress.

The report also highlights notable success in education, with Sir John A. Cumber Primary School in West Bay receiving a good rating from the Office of Education Standards. This achievement reflects ongoing efforts to improve educational outcomes across the Islands.

In addition, all recent Caymanian graduates who completed education-related degrees have been successfully placed into roles within the education system, ensuring local talent remains to strengthen the sector. The Government also processed more than 700 student registration applications for the 2025/2026 academic year, with all Caymanian students who applied securing places in Government schools.

In housing and agriculture, Government delivered on commitments by completing the first affordable homes at the Flamingo Point Housing Development in North Side, providing new options for Cayma-

nian families. Two key agricultural projects were launched: the Red Poll Cattle Breeding Initiative to develop the livestock industry, and the Islands' first Government-operated egg production facility to provide training opportunities for local poultry farmers, while supplying fertilised eggs to support backyard farming programmes.

Speaking to the NCFC Government's work, the Premier, Hon. André M Ebanks MP said, "These initial achievements belong to all of us – the committed members of our coalition Government, dedicated civil servants who serve our country and most importantly our people, who have entrusted us with their future. Together, we have shown that a unified Government can take decisive action and deliver real results for our country."

The Deputy Governor, Hon. Franz Manderson praised the collaborative effort, saying, "The way civil servants have carried forward this charge during the first 100 days of the National Coalition for Caymanians government has been truly inspiring. I look forward to continuing the strong partnership between the political leadership and the public service in advancing the government's agenda for the benefit of the Cayman Islands."

To recognise the First 100 Days, Government hosted the first 'Strong Start: First 100 Days' Community Update on Friday, on Cardinall Avenue, George Town

The public was invited to hear directly from Ministers and Parliamentary Secretaries about their accomplishments to date, and plans for the future to improve the lives of Caymanians.

## Consumption Expenditure by Households in Cayman reached \$3.1 billion in 2023

The overall household consumption expenditure in the Cayman Islands in 2023 is estimated at \$3,055.25 million.

This is revealed in the **Household Budget Survey (HBS) 2023** Report released on Friday, 15 August 2025 by the Economics and Statistics Office.

The survey, conducted over the twelve months from February 2023 to January 2024, yielded a response rate of 71% of 1,705 households in Grand Cayman and the Sister Islands.

The Report also shows that total household consumption in Grand Cayman amounted to \$2,997.48 million, while the Sister Islands had \$57.77 million.

The per capita consumption in 2023 is estimated at \$36,284 per year, while for residents of Grand Cayman, the estimate

was \$36,581. For residents of the Sister Islands, the estimated per capita spending is \$25,536.

Ranking of the population by per capita consumption expenditure shows that the lowest 20% (Quintile 1) had an average annual consumption expenditure of \$11,739. In the highest quintile, the estimated average expenditure amounted to \$69,199.

The total consumption expenditure in 2023 is 80.0% higher than the \$1,697.07 million in 2015. The increase is partly due to population growth of approximately 41% between 2015 and 2023, and cumulative inflation of 31.3%.

Per capita consumption increased by 27.7% to \$36,284 or 3.5% annually.

The highest per capita annual increases

were estimated for health (16.9%), food and non-alcoholic beverages (11.2%), furnishings household equipment and routine household maintenance (10.2%), information and communication (4.3%), restaurants and accommodation services (4.2%), followed by housing water electricity gas and other fuels (3.4%), education (1.6%) and clothing and footwear (0.6%).

Four divisions registered annual declines in per capita expenditure: miscellaneous goods and services by 4.4%, alcohol and tobacco by 2.0%, recreation, sport, and culture by 1.8%, and transport by 1.7%.

The report highlighted that the largest share of household expenditure was on housing and utilities, 32.7%; transport,

11.0%; food and non-alcoholic beverages, 9.9%; restaurants and accommodation services, 8.8%; insurance and financial services, 6.8%; furnishings, household equipment and routine household maintenance, 6.0%; personal care social protection and miscellaneous goods and services, 5.0%; information and communication, 4.2%; recreation, sport and culture, 4.0%; and education services, 3.4%.

Clothing and footwear, as well as alcoholic beverages and tobacco products, had the lowest household expenditure shares in 2023, at 2.8% and 1.5%, respectively.

The highly qualified staff at the facility are certified in Advanced Cardiovascular Life Support (ACLS), ensuring that patients receive the best possible care in the event of an emergency. "With its modern equipment and skilled staff, our new dialysis unit is fully equipped to provide high-quality dialysis treatment to those in need," said HSA's Dialysis Unit Nurse Manager, Erlin McLeod.

The opening of the dialysis unit is part of a major initiative by the HSA to continue improving quality and accessibility for patients across districts. Speaking at the opening of the unit on 7 August 2025, Acting CEO of HSA, Dr. Delroy Jefferson stated, "The opening of this new dialysis unit is another significant step in HSA's commitment to equitable access to care for all residents, regardless of their district."

Deputy Chair of the HSA Board Joy Vernon said, "This is an important occasion. For too long, patients living in our outer districts have faced the burdensome challenge of travelling to and from George Town several times a week to access vital dialysis treatment. That is no longer the case, from today onward, our patients can receive high-quality, life-sustaining care in the district of West Bay. Let us move forward together, with the assurance that distance should never be a barrier to access and quality care. May the new Dialysis Unit serve the West Bay community with excellence, compassion, and pride for many years to come."

Hon. Katherine Ebanks-Wilks, Minister for Health, Environment & Sustainability, said the opening carries personal meaning for her. "My late father passed away from renal failure, so seeing expanded dialysis services in West Bay is profoundly meaningful to me and he would have been immensely proud. I extend my thanks to the dedicated staff, the Senior Management Team and Board of the Health Services Authority, and every partner who helped bring this project to life. This facility will greatly enhance the quality of life for patients in the district."

HSA Nephrologist Dr. Ikechi Okpechi noted, "There were several dialysis patients from the West Bay area accessing services at the Anthony S. Eden Hospital. The opening of our new facility will greatly benefit both existing and future patients in terms of convenience and travel."

He added that patients can expect the same high-quality care at the new facility as they do in all HSA facilities.

The hours of operation are Monday, Tuesday, Thursday and Friday from 8:30 AM to 4:00 PM, and on Wednesday from 12:00 PM to 8:00 PM.

The HSA is continuously expanding to cater to the growing local population. Some of its recent initiatives include the expansion of its Ophthalmology, Orthopaedics and Sports Medicine teams, as well as the ongoing development of its Accident and Emergency Department. The Authority also continues to improve access to important medical care by providing residents of the Sister Islands with remote consultations with clinicians in Grand Cayman and investing in medical technology such as the recent installation of a new cone beam computed tomography (CBCT) scanner at Faith Hospital.

"Our strategic plan is to not only aug-

HSA operates the largest dialysis unit in the Cayman Islands, providing services to residents and visitors, including cruise passengers, who can schedule ahead of their visit. The Dialysis Unit at Anthony S. Eden Hospital can accommodate up to 13

dialysis patients at a time and dialyse an average of 33 to 39 patients per day. A dialysis chair is also available at Faith Hospital in Cayman Brac for residents and visitors from the Sister Islands.

tinental United States coastline and in the Caribbean.

The CINWS had also advised that "as with all hurricane seasons, coastal residents are reminded that it only takes one hurricane making landfall to make it an active season." It also urged that thorough preparations should be made every season, regardless of predicted activity.

"It only takes one," was the sage and

sombre reminder of John Tibbetts, Director General of the Cayman Islands National Weather Service, speaking on Cayman Conversations with Ralph Lewis, publisher of Caymanian Times newspaper.

Erin is the fifth named storm and first hurricane of the 2025 Atlantic Hurricane season.

### NEW SYSTEM DEVELOPING

Meanwhile, as Erin exits the area, all eyes are now on another patch of disturbed weather that's just come off the coast of West Africa and is heading towards the Caribbean.

Initial projections have it taking a more

southerly track towards the islands of the Caribbean than Erin did, and possibly moving into the Caribbean Sea.

The US National Hurricane Centre (NHC) is predicting some gradual development during the second half of this week with a 50 per cent chance of a tropical depression forming.

According to the NHC, "Environmental conditions appear conducive for gradual development of this system, and a tropical depression could form during the latter part of the

week. This system should move westward to west-northwestward at about 20 mph across the central tropical Atlantic

and approach the vicinity of the Leeward Islands toward the end of the week."

This new system will continue to be monitored for further development and movement.

Residents of Cayman are urged to get their weather updates from the official, verified and trusted sources.

In an early August update to its 2025 predictions, the US National Hurricane Centre updated the number of expected named storms to "13-18 (with winds of 39 mph or greater), of which 5-9 could become hurricanes (winds of 74 mph or greater), including 2-5 major hurricanes (winds of 111 mph or greater)."

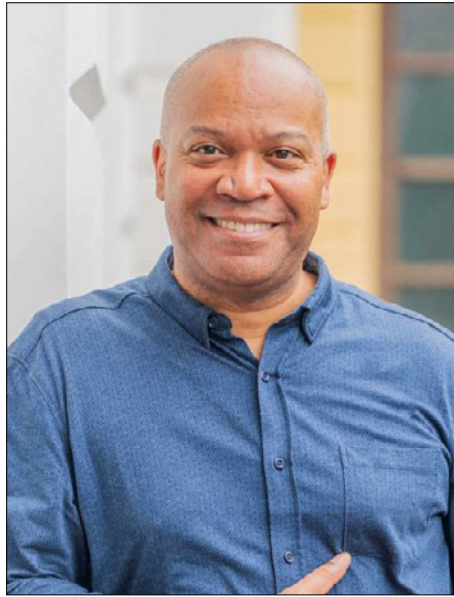

# Small Business Bootcamp Powers Up Women Entrepreneurs Across Cayman

In a landmark year marking its **60<sup>th</sup> anniversary** and the **30<sup>th</sup> anniversary of its Training Centre**, the Cayman Islands Chamber of Commerce is doubling down on its commitment to local business with a powerful initiative aimed at women entrepreneurs.

On Wednesday, 6 August, the Chamber — partnering with the SheTrades Caribbean Regional Hub and the Cayman Islands Centre for Business Development (CICBD) — officially relaunched the **Small Business Bootcamp**, a three-part series packed with practical insights and regional expertise. The revamped boot camp drew a standing-room-only audience each night, attracting an enthusiastic crowd of women entrepreneurs and small business owners eager to grow and compete in a rapidly changing market.

## Real-World Tools for Real Business Growth

The series kicked off with **“Financing Your Business for Growth,”** led by renowned financial strategist **Linval O. Johnson**. With over 20 years of experience in economic empowerment, Johnson delivered more than just tips—he challenged entrepreneurs to shift their mindset.

“When it comes to entrepreneurship, people are neither good nor bad—they’re either trained or untrained,” Johnson told the audience. “Confidence must be grounded in real belief, backed by skill.”

Johnson’s session offered a potent mix of strategy and motivation. Key takeaways included:

- **Believe in your business** – Self-doubt kills growth; mindset is your foundation.
- **Sharpen your skills** – Ongoing learning separates the dreamers from the doers.
- **Clarify your offer** – If you can’t explain it clearly, you can’t sell it.
- **Act consistently** – Progress isn’t about perfection—it’s about momentum.
- **Sell value, not just products** – Focus on offers that generate income and solve real problems.

The evening concluded with a lively Q&A and networking session, providing participants with an opportunity to delve deeper and connect with their peers.

## Marketing That Means Business

On Thursday, 7 August, **Lynn Markoff** of Convey Communications took the stage with **“Marketing & Branding in the Digital Age.”** Markoff broke down the essentials of modern marketing—everything from the four Ps (Product, Price, Promotion, Packaging) to digital tools like email marketing and e-commerce platforms.

She pushed participants to move beyond surface-level branding:

- Research your market and understand your competition.
- Define your target audience and craft a clear, compelling message.

- Build a marketing plan with purpose—not panic.

“It wasn’t just ‘pick a logo and post frantically,’” said **Roz Griffiths**, owner of Chatterbox. “It was about thoughtful, strategic messaging.”

**Ms. Knight**, founder of E-Naturals Hair Care, added:

“It reminded me why a strong vision statement matters—and how your brand has its own identity, separate from you.”

## From Operations to Export

The final session on Friday, 8 August, led by Gregory Fletcher of Clear Consulting, focused on the nuts and bolts of operations, sales, and service exports.

Fletcher focused on aligning back-end systems with front-end experience, highlighting the importance of internal consistency, effective sales strategies, and scalable business models for regional growth.

“Your operations need to deliver on your brand promise,” Fletcher said. “And your market isn’t just local—it’s regional, and potentially global.”

# BERMUDA TAKES ANOTHER SHOT AT MEDICAL TOURISM INDUSTRY

Bermuda has announced plans for a major investment as it seeks to revive efforts to launch a medical tourism sector.

Premier David Burt has announced a landmark partnership between the Government of Bermuda and Medical Concepts Consulting and Management (MCCM) through the signing of a Memorandum of Understanding. The project will see the creation of a state-of-the-art medical facility on the island and the launch of Bermuda's first medical tourism industry.

"This marks a significant step toward making Bermuda a world-class medical tourism destination," said Premier Burt. "This new healthcare medical facility will bring patients from overseas to our shores, creating new economic activity in Bermuda. It will not compete with, but instead enhance, local healthcare access for Bermuda and its residents."

The Bermuda Premier also said the new facility will create hundreds of jobs in both its construction and operational phases.

According to a statement from the



Bermuda government, "MCCM, an internationally recognised leader with experience in over 300 healthcare projects worldwide, has chosen Bermuda for this privately funded development—requiring no government funding or loans."

It said the facility will attract overseas patients, generate significant economic activity, enhance local healthcare access, and create hundreds of jobs during construction and operation.

The first phase of construction of the

facility, to be called the Bermuda International Healthcare Centre, will cost around \$400 million to complete.

Lou Maroun, the chairman and founder of Medical Concepts Consulting Management(MCCM) said: "The first phase begins with three cornerstone developments: an intermediary-stay behavioural health centre which addresses the ever-urgent and growing need for specialised, compassionate and high quality mental health services; a medical hotel designed to provide comfort and convenience for patients and families; and an ambulatory surgery centre equipped with leading-edge technology to deliver same-day surgical care efficiently, safely and at the highest international standards today."

It was also noted by Premier Burt during the signing of the MOU between his government and the MCCM that a previous medical tourism project initially earmarked for Bermuda some 20 years ago was instead developed in Cayman.

In the coming weeks, awardees will participate in a storytelling campaign and mentoring initiatives to inspire other women entrepreneurs. # Fraud Alert: TrustFinance Not Authorised by CIMA

The Cayman Islands Monetary Authority (the "Authority") is aware of recent fraudulent news and promotional materials circulating on social media claiming that TrustFinance has been approved by the Authority to operate in the Cayman Islands. These claims are entirely false.

The Authority confirms that TrustFi-

nance is not, and has never been, registered, licensed, regulated, or otherwise authorised by the Authority to conduct financial services business in or from within the Cayman Islands.

Members of the public are strongly advised to exercise caution when engaging with TrustFinance or any similar invest-

ment offerings. While some entities may be legitimately licensed and regulated in the Cayman Islands, others may make false or misleading claims about their regulatory status. Individuals should therefore verify such representations with the relevant authorities as necessary.

Those who have concerns, or wish to

file a complaint regarding TrustFinance, should contact the financial crime or regulatory enforcement authorities in their respective jurisdictions.

### Vessel Intercepted: 1500lbs of suspected ganja seized

The Cayman Islands Coast Guard (CICG) can confirm that, at about 2:40AM on Thursday, 14 August, while on patrol, the CICG, supported by the RCIPS Air Operations Unit, intercepted a vessel, with 4 persons onboard in our territorial waters, engaging in what appeared to be illicit maritime activity.

The occupants of the vessel were detained on suspicion of committing the following offenses:

- \* Illegal Entry into the Cayman Islands,
- \* Possession of Controlled Drugs, and
- \* Importation of Controlled Drugs.

The vessel, its contraband and the persons found onboard have since been handed over to the RCIPS for further investigation.

The items recovered were subsequently found to contain over 1500lbs of suspected ganja.



### UPDATE: Charges for Rex Crighton Boulevard Assault Incident

A charging decision has been made in relation to the assault incident which took place on Rex Crighton Boulevard on 19 February, 2025, involving a 17-year-old male and a man age 72.

The 17-year-old is being charged with Inconsiderate Driving, while the 72-year-old man is being charged with Common Assault.

Both will be summonsed to court at a later date.

### Police Investigate Collision Involving Stolen Vehicles

Shortly after 4:20AM on Friday, 15 August, officers responded to a report of a collision involving two vehicles at the intersection of Shamrock Road and Hirst Road. Police attended the location and observed that one vehicle, a silver Honda Civic, had left the roadway and collided with the wall of a plaza. The other vehicle, a black Honda Civic, had come to a stop in the roadway, crossing between two lanes. The occupants of both vehicles had fled the location prior to the ar-

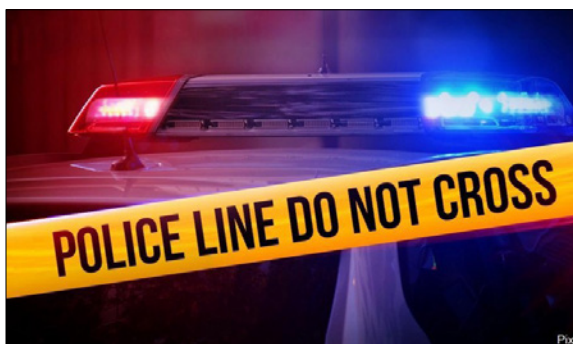
rival of the police.

The vehicles were recovered by police for processing, and it was later ascertained that both vehicles had been stolen.

The occupants of the vehicles are described as being males, possibly in their teens.

The matter is under investigation and police are appealing for anyone who may have witnessed the collision, or the persons who fled the vehicles, to contact the Bodden Town Police Station at 947-2220.

### Water-Related Death in North Sound



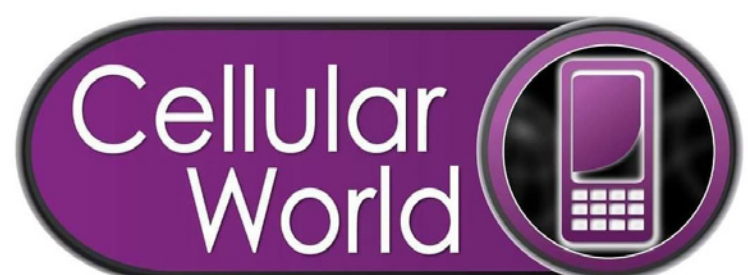
Shortly after 11:10AM on Monday, 11 August, the Cayman Islands Coast Guard (CICG) responded to a distress call from a vessel at Coral Gardens, in the North Sound, which reported that one of the vessel's passengers had encountered difficul-

ties while snorkeling.

Upon arrival at the location, Coast Guard officers assisted crew members from the other vessel in taking the male aboard the CICG vessel, and immediately began administering chest compressions while travelling to shore. They were met on shore by EMS, and the man was transported to hospital, where he was later pronounced de-

ceased.

The deceased, a man aged 68, is a visitor from the United States. The Cayman Islands Coast Guard and RCIPS express condolences to the family and friends of the deceased.

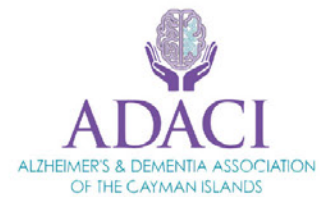
