UK AND CAYMAN REAFFIRM STRONG PARTNERSHIP

The first official visit to the Cayman Islands of the UK Minister for Overseas Ter-

ritories has helped to "reaffirm the relationship that exists between Cayman and the UK". This assessment by Hon. Premier Andre Ebanks was made during a meeting

with the British Minister of State for Europe, North America and Overseas Terri-

Spectrum 2025 to Convene Cayman's Senior Leaders for Strategic Dialogue on the Future of Financial Services

Cayman's senior financial services leaders, regulators, and policymakers will gather Oct. 8 at the Kimpton Seafire Resort + Spa for Spectrum 2025 for a full day of big-picture discussions on the forces shaping the jurisdiction's future.

Now in its fifth year, Spectrum remains the only forum where the entire financial services ecosystem - government, regulators, industry, and innovators - meets to examine long-term structural shifts, policy developments, and global trends.

"This event is about perspective," said Paul Byles, Spectrum founder, economist, and consultant. "We bring together leaders from across the spectrum to connect the dots

and look ahead strategically, not just react to immediate challenges."

Spectrum 2025 will mark a significant milestone with an agenda featuring Cayman's Premier, Hon. André M. Ebanks, delivering closing keynote remarks on the future of the industry. For the first time, the Hon. Chief Justice Margaret Ramsay-Hale will address the conference, speaking on judicial developments that will shape Cayman's legal and financial services framework.

"Having both the Premier and the Chief Justice on this year's agenda speaks to the maturity of Spectrum as a platform," Byles said. "It reflects our commitment to hosting

a truly national conversation about direction and strategy."

The event concludes with Premier Ebanks' keynote remarks and a networking cocktail reception.

Launched in 2021, Spectrum has grown into a must attend fixture on Cayman's financial services calendar. Its hallmark is breadth - convening leaders from across all sectors for a single day of candid, strategic discussion.

"This is where we step back, take stock, and think about the future together," Byles said. "The value comes from the diversity in the room and the willingness to tackle the issues that matter most to Cayman's competitiveness."

The full-day event takes place on 8 October at the Kimpton Seafire Resort + Spa. Registration is open to all financial services professionals, including regulators, funds specialists, bankers, insurance and reinsurance providers, attorneys, accountants, and fintech innovators. tories, Stephen Doughty and Her Excellency Governor Jame Owen.

Addressing the broad scope of the UK-Cayman relationship, Premier Ebanks made the point that across the range of issues the depth of collaboration reflects “a symbol of how much the relationship has grown”

He said: “It’s a constitutional relationship which has benefited from its stability and its familiarity. It helps us legally, economically and also culturally. But it’s gone beyond legal definitions. It’s gone to truly meaningful collaboration and discussion, and I think you’ll find in this visit that we have a mature dialogue now based on mutual interest.”

Mr Doughty, who was appointed in July 2024, retained his position in the recent wide-ranging Cabinet reshuffle in the Labour Party government of UK Prime Minister Sir Keir Starmer.

“I really second what the Premier said about the relationship,” he stated in response to Premier Ebanks, describing it as one of respect, cooperation, mutual collaboration and shared priorities.

Mr Doughty further underlined this by highlighting specific areas he felt showed the depth of the cooperation, listing among them: “our mutual prosperity and wellbeing of citizens in the Cayman Islands or in the UK, security, mutual challenges we all face around irregular migration, climate change and nature protection.”

He also referred to issues which he said “are fundamental to any good society; good governance, transparency and those things which Cayman is known for”. According to the UK’s Overseas Territories minister: “We want to work together to ensure firm foundations for the future.”

Those sentiments were echoed by Governor Jane Owen, who spoke of a ‘partnership’ between the UK and Cayman evidenced through her office.

“I do feel that it’s all about partnership,” she stated. “I feel my day-to-day work is about partnership with the government, with the security services, with people who are looking after governance. We do it all together, and that’s the whole point of it. And increasingly, when we’re having these discussions, we’re looking forward.”

Governor Owen also characterised those in the wider context of the links with the UK government coming out of the meetings between Min. Doughty and Premier Ebanks. “I think quite a lot of the discussions have been about, what does the future hold? Where are we going? And that’s where having that strong link with the UK, I do believe can really make a massive difference.”

She also said the relationship between Cayman and the UK benefits from what each partner brings to the table.

“You’ve got all of the experience of Cayman here in the Caribbean, but you’ve also got a lot of the clout you get from the UK, through the UN with Europe as a global player in so many areas, and what we want to do is to really leverage that in our partnership.”

Governor Owen went on to elaborate on the expertise in Cayman in the various sectors which she feels puts the territory in a strong position.

“We have so much talent on these islands and that’s why we are able to be so successful and look to the future with so much confidence... the sort of talent you get in government, in the private sector, and people have the right values and the right desire to create a future that works for everyone.”

The Governor also advocated exploring closer ties for training and other areas of cooperation between the Cayman and the British civil service establishments.

SPECIFIC ISSUES

Min. Doughty praised the role Cayman has been playing in supporting the British government’s policy position on key international issues. He cited “the excellent work that’s been done on sanctions in very difficult geopolitical circumstances” as an example, saying that “the work that Cayman has done has been absolutely excellent.”

He also credited Cayman for working along with the UK on the global environment and climate change agenda, referring to innovations that Cayman developed not only locally, but also “showing leadership across our wider family on those issues.”

Another area singled out by Mr Doughty for Cayman’s strong external leadership is its support for sister UK overseas territories.

“Cayman has done a lot also to support other overseas territories in the Caribbean, in particular at some really difficult times, I think, it’s really to be commended. And I think the more we can have resilience within our family to those challenges, the better.”

On the issue of constitutional reform, Mr Doughty, who hails from Wales (part of the devolved Nations and Regions in the UK), explained: “I’m hugely respectful of devolution of powers being at appropriate levels. It’s fundamentally for people in the Cayman Islands and the government to talk about what changes and developments they would like to see going forward. We believe in the principle of self-determination. It’s a modern partnership. Partnerships evolve through time, and so I’m always open to conversations on those matters. The questions are: does that lead to better governance, better delivery of services, better outcomes for people in the Cayman Islands and the sustainability of our relationship going forward?”

Regarding the controversy surrounding implementing the UK law on Public Access to Registers of Beneficial Ownership of Business in Cayman and other Overseas Territories: “We’ve been very clear about wider UK expectations, and we believe that transparency and accountability in the financial services industry is an important thing. It’s a foundation of a strong industry, and it also helps you guard against risks, threats and challenges. You’d be aware there’s a very lively debate on this in the UK as well. This isn’t just about transparency and accountability in the territories, but it’s also about it in the UK. It’s in our own backyard, and there’s a lot of things that would have been going on in London in recent decades that need reform and change too, and so this is a challenge to the whole system.” Mr Doughty added that he was “really pleased” with the progress of Cayman introducing the legitimate interest register in February.

Another issue is the call for decriminalisation of cannabis, supported in the local referendum in April, but which clashes with existing UK legislation.

“We have international obligations as well, and this is obviously a live debate in a number of the OTs, but pretty much the (British) government’s position is very clear on that.” (Ed. Possession of cannabis for recreational use is illegal in the UK)

With regional security in the Caribbean now even more of a frontline topic, the UK Overseas Territories Overseas Minister gave this strong assurance: “We need to make sure that all the territories are able to be resilient and ready for any challenges that might come their way. This very naturally fits with some of the priorities of the UK Government. These are absolutely shared priorities, and we have a responsibility in our strategy...and that means close cooperation with the Premier and the Governor, and making sure the resources are in place.” He also said Cayman actually has a unique role to play, “not just protecting its people directly, but actually across the region.”

Concerning climate change and protecting the environment, Mr Doughty announced that funding has been secured for the continuation of two major programmes. “On a very positive note, I can say we’re able to confirm additional funding for the Blue Belt (global marine biodiversity) Program 2030, and on top of that the Darwin (conservation and climate resilience) program as well. And I think that builds on the evidence of success that we have here in Cayman. I’m really keen to highlight that as well across the OTs family, but also making sure that the OTs are heard as voices at the Global Forum on this.”

Mr Doughty also commended Cayman via the Premier’s Office and the Government’s UK Office for producing “an absolutely fantastic film that the Cayman team did promoting the marine environment which was shown in the UK Parliament, describing it as “very inspiring”.

CDB Backs New Small Business Policy to Boost Cayman Islands' MSME Sector

The policy development process will leverage regional expertise and technical resources to conduct a comprehensive assessment of the current MSME landscape. It will identify key challenges, explore opportunities for expansion, and offer actionable recommendations to create a more enabling environment for small businesses to thrive.

All-Female Class Makes Waves at 2025 Scuba Diving Hall of Fame Ceremony

The 22nd Annual International Scuba Diving Hall of Fame (ISDHF) Induction Ceremony made history this weekend, honouring an all-female class of international inductees for the first time since its founding. Held at the elegant Hotel Indigo, the event brought together global pioneers, local legends, and emerging talent in a celebration of ocean advocacy, innovation, and legacy.

“Tonight we gather to celebrate a legacy — one that lives beneath the waves and stretches across oceans. This year’s ceremony is especially significant, as — for the first time in its history — the Hall of Fame welcomes an all-female class of inductees,” said Hon. Gary Ruddy MP, Minister for Tourism and Trade Development.

Steve Broadbelt, Chair of the ISDHF Board, echoed the sentiment, calling the moment “groundbreaking” and praising the honourees as “extraordinary individuals, from pioneering founders to visionary trailblazers.”

Early Pioneers

The ceremony paid tribute to two Early Pioneers whose influence shaped the very foundations of scuba diving.

Simone Melchior Cousteau of France was remembered through archival footage of the Calypso and her husband, Jacques Cousteau. Widely recognised as the first female scuba diver and aquanaut, Simone played a pivotal role in co-inventing the aqualung — revolutionising underwater exploration.

Women Divers Hall of Fame (WDHOF), a U.S.-based non-profit honour society, was also inducted. Founded by Jennifer King, Patty Newell Montana, and Carol Rose, WDHOF has championed women’s contributions across science, medicine, exploration, education, and the arts.

2025 International Inductees

Michelle Cove (Bahamas) transformed Stuart Cove Dive Bahamas into one of the Caribbean’s largest dive operations. Her

leadership brought in major partners like Atlantis Resort and Carnival Cruise Lines, while her advocacy for shark safety and marine conservation remains central to her mission.

Anne Hasson (USA) revolutionised live-aboard diving with the launch of the Cayman Aggressor in 1984. As Vice President of Aggressor Adventures, she oversees a global fleet of dive yachts and eco-tourism lodges, promoting sustainable travel across premier destinations.

Rosemary E. Lunn (UK) became the first British woman inducted into the Hall. A journalist, educator, and technical diving innovator, she co-founded EUROTEK and TEK Dive USA, and broke barriers as the first civilian female diver to join the UK Ministry of Defence's Diving Standards Team.

Trailblazer Honouree

Hidy Yu Hiu-Tung (Hong Kong), an actress and model with 19 years of diving experience, was honoured for her ocean advocacy. As Miss Scuba International's spokeswoman and ADEX ambassador, she has led ghost net cleanups

and co-founded the Bling Bling OCEAN foundation to promote marine conservation through education and charity.

The ceremony also spotlighted five Cayman-based honourees whose work has elevated the islands' reputation as a world-class diving destination.

Jason Belpert, General Manager at JEM Holdings, oversees Little Cayman Beach Resort, Cayman Brac Beach Resort, and Reef Divers. His lifelong dedication to diving began at age 12 and has since shaped the region's dive tourism.

Courtney Platt, a commercial photographer and conservationist, has completed over 5,000 dives and contributed to eight National Geographic assignments. His advocacy for reef restoration and sustainable seafood choices has made him a leading voice in marine protection.

Michael Schouten, Dive Manager at Southern Cross Club, has logged over 12,000 dives in Little Cayman. Known for his encyclopaedic knowledge and mentorship, he's guided countless divers through the pristine reefs of Bloody Bay Marine Park.

Peter Hillenbrand, owner of Southern Cross Club and co-founder of the Central Caribbean Marine Institute (CCMI), was recognised for his commitment to

Police Investigate Fatal Collision in Cayman Brac

Shortly before 10:00PM on Sunday night, 21 September, officers responded to a report of a single-vehicle collision, involving a Hyundai I-10 which had left the roadway and overturned, on West End East Road, Cayman Brac.

Police, Fire, and EMS attended the location and assisted in removing the driver from the wreckage. He was subsequently pronounced deceased on the scene.

A section of West End East Road was closed following the incident and has since been reopened. The matter is currently under investigation and accident reconstructionist from Grand Cayman have travelled to Cayman Brac to assist with the investigation.

The deceased is a 34-year-old Honduran national, residing in Cayman Brac. The RCIPS expresses condolences to the family and friends of the deceased.

Police conduct coordinated search to apprehend wanted man

This past weekend, police made a concerted effort to locate and arrest a wanted man, who was the subject of multiple reports of violent crimes, threats to kill and cause serious harm. The man was believed to be dangerous, and his behaviour was believed to have been escalating and a danger to the public.

The man was seen on Sunday, 21 September, driving a blue Honda Fit in the Prospect area of George Town. He refused to stop for the police, and due to his violent history, the police carried out a coordinated effort to apprehend the wanted man, utilising the various units available on duty.

The man abandoned his car and fled into nearby bushes, where he was surrounded by Air Support, Firearms Unit & K9 searched until he was found.

As a result, the man, age 35, of East End, was located and arrested in the Prospect area of George Town, and his vehicle was seized as evidence. He remains in custody pending further investigations.

Police Investigate Sudden Death in Bodden Town

Just before 6 PM on Sunday, 21 September, police and other emergency services were dispatched to a report of an unknown male found unresponsive in the Lookout Gardens area of Bodden Town.

It was reported that a man was seen on the side of the road and was in an unresponsive state. The Cayman Islands Fire Service, along with the Emergency Medical Services, were dispatched to the location and attended to the man. A medical practitioner also attended, and the man was subsequently pronounced deceased.

Although no formal identification has been made so far, police are working with the assumption that the deceased is a 32-year-old man who resided in North Side.

The RCIPS offers condolences to the family of the deceased.

Police attended the location and carried out investigations. The circumstances of this death are being investigated by the police, and detectives are encouraging anyone with information to call the Bodden Town Police Station at 947-2220.

Police Investigate Two Incidents of Suspected Arson of Vehicles

Shortly after 8:15AM on Monday 22 September, officers responded to a report of a vehicle fire at an address on Linwood Street in George Town. Officers from the Cayman Islands Fire Service arrived at the location and were able to extinguish the fire. No one was injured, and no other property was damaged in the incident.

Officers conducted inquiries and determined that the vehicle, a Honda CR-V, had previously been reported stolen.

Shortly after 1:00AM on Tuesday, 23

September, officers responded to a report of a fire at an address on Parkview Crescent in West Bay, where it was reported that two jet skis were on fire. The owner was able to extinguish the fire prior to the arrival of Fire officers. Other jet skis at the location received minor damage, however no one was injured during the incident.

Fire officers have determined that both fires appear to have been deliberately set. As such, both matters are being investigated by police.

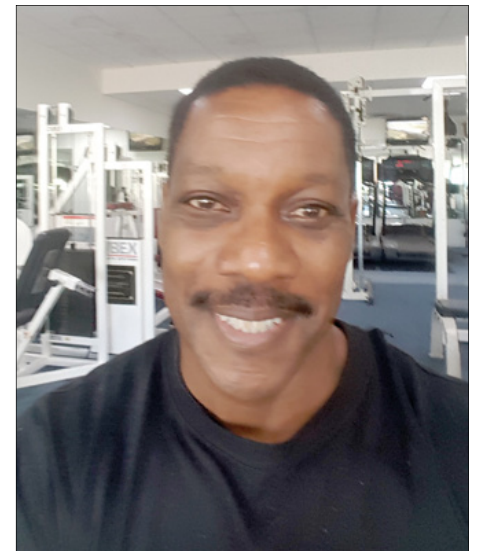

PPM Calls for Government to End Uncertainty and Publish Clear Immigration Plan

The People's Progressive Movement (PPM) commends the Government's commitment to prioritising Caymanians in employment and reinforcing the integrity of the immigration and residency framework. These objectives closely align with our own commitment to equipping Caymanians with the skills, training, and pathways necessary to thrive in today's economy.

The PPM supports a **clear and balanced approach**: strengthening immigration and residency rules to protect Caymanian opportunities while simultaneously addressing broader priorities such as fair wages, workforce development, and phased, sustainable implementation. **Strong enforcement MUST**

go hand-in-hand with practical solutions so that employers can fill genuine gaps and Caymanians can build lasting careers.

At the same time, we note a **growing divergence in tone and approach within the Government**. While Premier André Ebanks has emphasised a measured and pragmatic path forward, Minister Michael Myles has proposed sweeping measures — such as very long waits for Caymanian status and rigid work-permit rules — that have caused anxiety among businesses and the broader community.

The Cayman Islands Chamber of Commerce has also urged the Government to adopt a practical, phased, and consultative

approach to avoid disruption, particularly for small and medium-sized businesses navigating these changes.

This divergence highlights the urgent need for **coherent policy, clear guidance, and transparent communication**. Immigration reform is too important to become a source of division or uncertainty. The Government must lead with facts, not fear, and avoid rhetoric that creates an "us versus them" divide between Caymanians and expatriates.

We call on the Government to urgently publish a statement clearly outlining the Cabinet's position regarding proposed changes to the current immigration and work permit legislation. **The present uncertainty and spec-**



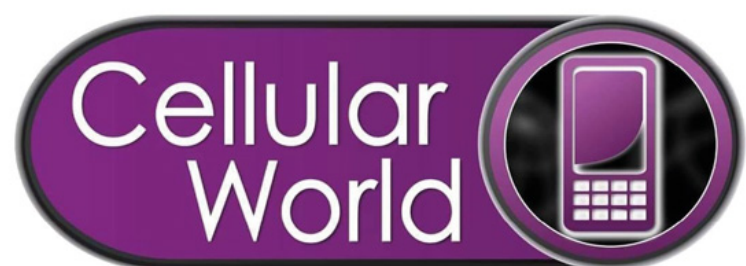
