# Brian Myers makes freediving history

Cayman Islands freediver **Brian Myers** made history at the **Azul Freediving Challenge 2025**, held at the stunning Cenote Yum-Kin in Mexico from September 26 to 28. Competing against elite freedivers

from around the world, Myers achieved a depth of **35 metres in the Constant Weight Bi-Fins (CWTB) discipline,** setting a new national record for the Cayman Islands.

"Setting a new record for Cayman was very surreal," Myers said. "I actual-

ly set out to do that from the start. I was aiming pretty high in the beginning, but then I readjusted my goal for this challenge — and once I did that, I just went for it."

## Cayman Airways Updates Bag Fees. Rates Remain Lowest

Cayman Airways Limited (CAL) will implement updated checked baggage fees for tickets purchased on or after November 1, 2025. Baggage fees for tickets purchased before that date will be unchanged. While representing a small increase, the new fees will continue to allow Cayman Airways to offer passengers the lowest baggage rates of any airline serving the Cayman Islands. Additionally, the airline will maintain its longstanding 55lb weight allowance per checked bag, which exceeds the industry standard of 50lbs.

The updated fee structure applies to checked bags on international jet flights and offers a discounted rate for purchases made through the Cayman Airways mobile app or website. The first and second checked bags will cost US\$30 each when purchased online or via the app, or US\$35 each when paid over the phone via the CAL call center or at the airport during check-in (the usual size and weight restrictions apply). Fees for



additional bags (Bags 3–8) will also be revised but will continue to be the lowest among airlines serving the Cayman Islands.

There are no changes to the baggage fee structure for Sister Islands domestic flights at this time.

Cayman Airways last adjusted its bag-

gage fees in 2022, when it standardized its rates across routes, and has since continued to absorb rising operational costs while facing intensified competition on international services. The updated fees will support the airline's ongoing commitment to providing affordable, reliable, and high-quality air service for the Cayman Islands.

Passengers are encouraged to purchase their bags via the new Cayman Airways mobile app or online at www.caymanairways.com to enjoy both savings and a smoother check-in experience at the airport.





## OPPOSITION LEADER RESPONDS TO GOVERNMENT'S STRATEGIC POLICY STATEMENT

The Strategic Policy Statement (SPS) of the National Coalition For Caymanians (NCFC) government was subjected to thorough and critical scrutiny during Friday's sitting of Parliament.

Presented on Wednesday October 15th by Hon. Minister of Finance and Economic Development, Rolston Anglin, the SPS was debated on Friday October 17th.

The document shows projected revenue for the 2026 to 2028 period totalling KYD3.864 billion with new revenue-rais-

ing measures of KYD209.5 million. Spending is forecast at KYD3.83 billion with a surplus projection rising from KYD6.6 million in 2026 to KYD9.4 million in 2027 and reaching KYD13.8 million in 2028.

That outlook contrasts with the hotly-debated official projection earlier this year of a possible deficit but which is now expected to result in a surplus of KYD10.2 million following the recent government interventions

The previous forecast surplus for fiscal year 2025 was KYD53.2 million as outlined in the 2024-2025 budget.

The SPS also gives a broad overview of a range of policy proposals across the general economy and ministerial portfolios, reflecting the campaigning priorities of the coalition partners. Those have now been cemented in a formal coalition agree-

ment - the first of its kind in Cayman politics

In one of its first major policy moves, the NCFC government rescheduled the SPS from its traditional June presentation to October on the grounds that a six-month window following an April election was more practical than the standard three months.

#### **HEW WIELDS THE AXE**

Hon. Leader of the Opposition and party-leader of the main opposition People's Progressive Movement(PPM), Joseph Hew, kicked off scrutiny of the SPS by challenging the government's financial projections. He referenced an issue that was central to the last phase of the 2025 election campaign, and which he felt might have shifted the outcome. That was the much-referenced Pre-Election Financial Update(PREFU).

"When we look at the Government's financial position, we see that revenues continue to rise and the country continues to operate with a surplus. The deficit that was incorrectly forecast prior to the election simply did not happen. We doubted that it would! —but this did not stop the Government from using that flawed forecast to attack the Opposition...With additional borrowing taking us up to a record 650 million dollars...perhaps the deficit is in the not-too far future."

Mr Hew felt the SPS was delayed because the Minister of Finance "could not trust the Government's own projections".

That set the tone for his discourse, which in part challenged the NCFC government's fiscal plans and contrasted what he regarded as risks to the economy compared to the stability he attributed to the PPM/Progressives period in office.

"The current strength of our economy is built on the sound foundations laid by previous administrations. The recent reaffirmation of our AA3 credit rating by Moody's, placing us on par with major global economies, is a testament to Cayman's long-term stability."

### SAFEGUARD THE ECONOMIC PILLARS

However, on the government's broad fiscal policies, including the proposed additional revenue measures and the cost of living implications, Mr Hew stated: "Taxes are up, but real relief is still absent."

He framed the importance of the financial services and tourism industries to the economy, urging the government to safeguard them by exploring diversification in the exploding global digital sector.

Welcoming the NCFC government's National Digital Transformation Strategy Taskforce, the Leader of the Opposition, stated: "However, the taskforce's sixmonth timeframe to deliver recommendations means we won't see concrete action until well into 2026...We need action now, not just studies."

He said such action includes ensuring that Caymanians are trained and qualified to capitalise on the new growth sector linked to his theme of Preparing Caymanians to Lead.

#### **IMMIGRATION CAUTION**

Regarding the government's key platform policy of immigration reform, Mr Hew expressed concerns about how it's being presented.

"While the rhetoric sounds bold, the reality behind these announcements is far less clear and far more risky," he cautioned.

"The Government claims that their coming immigration changes will 'make way' for Caymanians. But as a strategy, this is deeply flawed. You cannot build a Caymanian workforce by merely sending people away. You build it by building Caymanians up. And that requires a long-term, coordinated, and credible plan."

The PPM/Progressives and Opposition Leader also challenged the government on a range of other issues while putting forward his party's plans to address them.

These include education and pathways into careers, healthcare, food security, "environmental stewardship" including the landfill and beach erosion, policing with more funding for the RCIPS, traffic management, pensions, social care and support for the elderly.

The scrutiny of the SPS included presentations by former PPM/Progressives finance minister Roy McTaggart, the party's Deputy Leader Kenneth Bryan, PPM MP Roy Tatum, independent Chris Saunders and NCFC minister of tourism Gary Rutty.

NCFC Minister of Finance Rolston Anglin strongly defended his government's SPS, while Premier Andre Ebanks gave the official rebuttal.

The presentation of the Strategic Policy Statement (SPS) in mid-October comes just a matter of weeks before the annual Budget Statement on November 5th. Many of the issues raised are expected to be further debated in more detail during the budget.

## NCFC Signs History Making Governance Agreement

All 11 members of the National Coalition For Caymanians (NCFC) Government on Thursday signed a history-making coalition agreement that demonstrates to the Caymanian people how this Government of three political groupings shall cooperate as well as its shared values and decision-making processes, and standards of conduct.

The NCFC Coalition Agreement makes public the team's:

- core values;
- decision-making process;
- conflict resolution framework;
- · mediation process;
- commitment to the Ministerial Code of Conduct; and
- commitment to enact an enforceable Parliamentary Code of Conduct.

"This has never happened in this manner in our Islands – an agreement among the members that comprise a coalition Government, which expressly sets out to the public how we will come together to resolve longstanding problems, unify our people and create a stronger, fairer Cayman," acknowledged the Premier, the Hon. André M Ebanks MP.

"Publishing this agreement demonstrates responsible, transparent leadership and unity in service to the people of the Cayman Islands," said the Deputy Premier the Hon. Gary Rutty MP. "The public should be able to trust its elected leaders because of our integrity."

Independent Minister the Hon. Rolston Anglin MP highlighted the coalition's practical focus: "Good governance requires steady hands, clear communication, and a shared vision. The NCFC brings together

our different experiences to work as one for Cayman."

NCFC Members signed the agreement on 16 October – the same date the Cayman Islands Sex Disqualification (Removal) Bill was introduced in 1958 in the then-Legislative Assembly (now Parliament), which resulted in women being allowed to vote. Like that law, Members said the agreement is a public demonstration of faith and commitment by each coalition member in a shared vision.

It is also significant that this Coalition Agreement has been signed and published after the NCFC Government has had time to govern, rather than immediately following the General Election on 30 April 2025.

"Having worked together on the Strategic Policy Statement for 2026-2028, and budget documents for 2026-2027; and on several pressing areas of reform, our

bonds of fellowship and working relationship as well as knowledge of the current state of public affairs have all deepened," the Premier said. "This provided us, among other things, the ability to express our coalition agreement with a higher degree of specificity and certainty than would have been possible at the outset."

"The people of these Islands deserve more than rhetoric," Minister Rutty said. "They deserve utmost confidence that this Government will provide long-term stability, coherence, and unity. These qualities are not optional; they are the foundation upon which responsible governance and national advancement must rest."

Other countries, including the UK, Canada and Germany, have elected coalition governments that have entered into similar agreements. Research again shows that the NCFC Coalition Agreement is on par, or

more robust in certain cases, by comparison.

"Because this NCFC Government is committed to delivering on its promises, we have created a strong accountability framework that reinforces values-based leadership and asks the Caymanian people to hold us to the highest standards," Minister Anglin said.

- The Caymanian Community Party (TCCP): Ms Heather Bodden, Hon. André Ebanks, Hon. Kathy Ebanks-Wilks, and Hon. Wayne Panton.

- Independent Members: Hon. Rolston "Rollie" Anglin, Hon. Johany "Jay" Ebanks and Hon. Isaac Rankine.

### Public Consultation Begins for Immigration Bill, 2025

The Immigration (Transition) (Amendment & Validation) Bill, 2025 ("the Immigration Bill") was Gazetted on 17 October 2025 and is now open for public consultation. Persons can visit www.gov.ky/labour to review the Bill.

The publication of the Immigration Bill marks a decisive crucial point in national policy with the launch of sweeping immigration reforms designed to realign the system with the priorities of Caymanians, while preserving our competitiveness and social cohesion. After decades in which work-permit rules and status pathways remained essentially unchanged despite demographic, economic, and infrastructure pressures, the 2025 government and opposition manifestos converged around the urgent need for change.

Through the 37 clauses, the Immigration Bill seeks to address various matters; one of which is the timeframe during which a person married to or in a civil partnership with a Caymanian or a permanent resident has to hold their Residency and Employment Rights Certificate before they are able to apply for Naturalisation or an open-ended permanent residency. This timeframe has been extended to

fifteen years. The aim of which is to cutdown on marriages of convenience. Information will be shared seamlessly with WORC and other necessary agencies to ensure that Caymanians are considered first for employment and to also inform decision-making on applications for permanent residency, Residency and Employment Right Certificate and Cayman Status. Also, in an effort to curb job-hopping and encourage stability within the labour market, work permit holders who change employers within the first two years of their employment must leave the Islands

and cannot reapply for a work permit for a year. Exemptions from this requirement are available however under certain circumstances. These and other proposed changes are intended to refine aspects of the existing legal framework to ensure it remains responsive to evolving social and economic circumstances.

Minister for Caymanian Employment & Immigration, Hon. Michael Myles says, "Public consultation of a bill is a cornerstone of good governance. This process ensures that every voice is heard and that the Immigration Bill reflects the realities, needs, and aspirations of the people it will serve. By engaging with the public, we can craft a fair, transparent, and effective immigration system that upholds our national values and supports both our citizens and those who wish to contribute to our society."

The consultation period starts from 17 October to 14 November 2025 and allows persons to review the proposed amendments and provide their feedback via email to immigrationconsultation@gov.ky.

## Brian Myers Makes Cayman History at Azul Freediving Challenge

### Cayman-born athlete sets national record in Constant Weight Bi-Fins, elevating the islands on the international freediving map

During the dive, Myers remained calm and focused, visualizing each moment of his descent. "I knew I'd hit freefall soon, and I just focused on enjoying the glide all the way from 15 to 35 metres. Before I knew it, I was there," he shared.

The achievement comes after months of disciplined training. "In preparation for this milestone, I've been consistently diving three days a week," Myers explained. "Earlier in training, I was chasing numbers, diving anywhere between 35 and 40 metres each time. Eventually, I focused on being completely comfortable at 35 metres, and that's where I set the record. So in the future, I'll be able to break it, no problem."

For Myers, the record is both a personal triumph and a milestone for Cayman's presence in the sport. "Personally, this is a huge milestone," he said. "I wanted to start breaking records for Cayman and bring attention to the island — being the first Caymanian-born diver to take the Constant Weight Bi-Fins record for Cayman and set it where it is now. Looking ahead, I plan to take on all of the records set by Richard Collette and keep pushing the boundaries every single time. For Cay-

man, it means we now have a deep diver
— and I'll continue to represent the islands in freediving wherever I go."

The **Azul Freediving Challenge** is recognized for its high standards of safety and competition, drawing freedivers from beginners to elite athletes worldwide. **PranaMaya Freediving**, the event organizer, hosts workshops, official training, and competitions in multiple disciplines, including Free Immersion (FIM), Constant Weight (CWT), Constant Weight Bi-Fins (CWTB),

and Constant Weight No Fins (CNF). Divers compete in **Cenote Yum-Kin**, a crystal-clear freshwater sinkhole with depths reaching up to 87 metres, offering ideal conditions with no waves or currents.

Looking ahead, Myers is already setting his sights on future competitions. "Next for me is a pool competition in Tampa this December, and I'm focusing on distance rather than depth. This will help in upcoming depth competitions. I also have some events planned for next year, and I'll



be organizing my training around them. Freediving requires a lot of physical and mental effort, especially in building CO2 tolerance. My family and fellow freedivers have been incredibly supportive, and now it's about staying consistent and putting in the work."

Brian Myers' record-setting dive is more than a personal accomplishment; it's a historic moment for Cayman's sporting community and highlights the islands' growing reputation on the international freediving stage.

The qualifiers mark the start of the new Concacaf W women's national team cycle — the opening phase of regional qualification for both the 2027 FIFA Women's World Cup and the 2028 Olympic Games.

The 2025/26 W Qualifiers feature 33 nations divided into six groups. Each team will play one match per FIFA international window, alternating home and away, for a total of four matches during the qualifying phase. Group winners advance to the 2026 Concacaf W Championship (the "W Gold Cup"), where they will join Canada and the United States, both of which received automatic byes.

Cayman will look to build on its recent progress in women's football, competing on home soil against Bermuda before facing some of the region's top sides later in the qualifying cycle. Information on Cayman's remaining fixtures will be released at a later time.

CIFA encourages fans and members of the media to come out and support the women's national team as the players begin their qualifying campaign.






The motion, tabled by McTaggart in **June 2024**, called for banks to adopt stronger standards of fairness and transparency — including requiring advance

"I am pleased to see this motion result in meaningful action to protect consumers," said McTaggart. "It is important that our financial institutions operate with transparency and provide customers with fair warning of any changes that affect them."



## WORC Announces Updated Requirements for Online Portal

Workforce Opportunities & Residency Cayman (WORC) advises all employers and job seekers of important updates to advertising and recruitment feedback requirements on the WORC Online portal that will take effect on 1 November 2025. These updates are designed to improve promote greater transparency in the hiring process and to strengthen opportunities for Caymanian job seekers.

Beginning 1 November 2025, employers must comply with the following key changes:

- Broader scope of mandatory advertising: o All positions, including part-time roles for annual work permits, must be advertised on the WORC Online Portal for at least 14 consecutive days, unless specifically exempt (e.g., domestic helpers, caregivers, pastors/ministers, or positions granted a waiver).
- <u>Greater detail required in advertisements:</u>
- o Job postings must now include: job title, duties, qualifications, salary and all benefits, work hours, job type, location, and any special conditions or requirements.
  - Caymanian applications:
- o When a Caymanian applies, employers are required to log the outcome in the portal. If a Caymanian applicant is not hired, structured feedback must be provided.



Should the employer proceed with a work permit application, additional mandatory documentation must accompany the submission.

Employers will be obligated to record application outcomes and provide feedback for all Caymanians who apply directly through the WORC Online Portal.

Caymanian Job seekers, in turn, are encouraged to actively update their records to indicate whether they were inter-

viewed, not selected, or successfully hired as this will be used by Boards and Administrators in work permit considerations. Where feedback has been received, applicants should confirm the outcome in the portal within three (3) business days. By actively monitoring and updating their applications in the WORC Online Portal, Caymanian job seekers will be able to follow the recruitment process more transparently and strengthen their participation in

the local labour market.

WORC remains committed to promoting fair and transparent employment practices that prioritise Caymanian talent, while ensuring employers have a clear and structured recruitment process.

### Trinidad fears US sites may be targeted there

The United States Embassy in Trinidad and Tobago has cautioned Americans to stay away from American government facilities on the twin-island

It was an unusual warning that came as tensions grow between the United States and Venezuela over deadly US strikes in Caribbean waters targeting suspected drug traffickers. It has led to Trinidadian fishermen fearing they might be killed by US forces targeting drug dealers.

The embassy didn't specify why it issued the warning, saying only that, "due to a heightened state of alert, please avoid and refrain from visiting all US government facilities through the holiday weekend," as it urged people to "be aware of your surroundings." Monday 20 October was a holiday to celebrate Diwali, a Hindu festival of lights widely celebrated in Trinidad and Tobago, where 35% of its 1.4 million people identify as East Indian.

Venezuela is located just miles away from Trinidad, where people in one coastal community are mourning the disappearance of two local fishermen believed killed in a US strike last Tuesday.

The alert is based on threats directed at American citizens in the Caribbean nation, with US authorities saying "it could be linked" to ongoing tensions in the region,





Trinidad and Tobago's minister of homeland security, Roger Alexander, said. However, local authorities declined to share specific details about the reported threats.

Authorities in Trinidad and Tobago have responded to the threats by implementing security measures to deal with any situations that may arise, Alexander said. With six strikes killing at least 29 people since September, the tense situation in the region was mentioned by US officials in a briefing with authorities in Trinidad and Tobago, Alexander said.

Following the most recent attack, the US government took survivors into custody, after the military struck a suspected drug-carrying vessel in the Caribbean, officials said Friday. The Trump administration has said it considers alleged drug traffickers as unlawful combatants who must be met with military force.

## MONTSERRAT'S MEADE WANTS OECS TO 'FREE-UP' FREE MOVEMENT

The Premier of Montserrat, Reuben T Meade, has called on member countries of the Organisation of Eastern Caribbean States(OECS) to remove any remaining restrictions preventing their citizens from moving and working freely among the islands.


He was speaking in Montserrat last week where the UK Overseas Territory was hosting a meeting of OECS trade ministers

"We should be able to operate across the OECS as if it is one unitary state

where we do not need a passport to travel, but a simple identification card and that our driver's licenses be acceptable across the entire sub-region," Mr Meade declared.

He said, "Anyone coming from any part of the OECS should not only be given a sixmonth stamp by the immigration department or immigration departments across the OECS, but be given an indefinite stamp so that they can remain wherever they wish to go and work within the OECS."

Of the UK Overseas Territories, Montserrat is the only full member of the two



blocs with Anguilla and the British Virgin Islands as associate members.

Premier Meade also reminded delegates that Montserrat was a founding member of both the OECS and the wider Caricom (Caribbean Community) group of nations.

The issue of free movement, though contained in the OECS charter, is yet to be ratified and implemented by all member states.

The Montserrat Premier also urged his colleague OECS member states to remove the remaining barriers to travel and resettlement.

"We've heard discussions about the professionals being able to move and work freely, the doctors, the lawyers, etc. We also need to ensure we broaden that to include our farmers, our labourers, our construction workers, no matter who they are or what skill they represent; they should be able to travel in the

same manner as our professionals. Let us not discriminate."

Established in 1981, the OECS list among its core objectives 'making it easier for any citizen and their family members of the seven Protocol Countries: Antigua and Barbuda, Commonwealth of Dominica, Grenada, Montserrat, St Kitts and Nevis, St Lucia and St Vincent and the Grenadines to travel and live in any member state with a valid form of ID like a driver's licence, national identification card, voters registration card, social security card or passport'.

The 1981 Treaty was replaced in 2010 with a Revised Treaty of Basseterre (the capital of St Kitts and Nevis where it was signed), creating an economic union. The updated agreement calls for reducing or removing barriers to trade for a single market with a customs union between the seven full member states.

The sub-regional group comprises 12 members; seven of which are founding or protocol members, with the other five being associate members. Those five are the UK Overseas Territories of Anguilla and British Virgin Islands, along with the French overseas departments/départements et territoires d'outre-mer-(Dom-Toms) Guadeloupe and Martinique and the collectivite of French St Martin.




## BRITAIN'S PRINCE ANDREW ABRUPTLY RELINQUISHES MORE ROYAL TITLES

In a development that has sent tongues wagging throughout all levels of British society, Prince Andrew has announced that he will be giving up more of his royal titles

However, while he is expected to retain the title of Prince, there's increasing speculation that he might be under pressure to relinquish that as well.

The Prince, who according to royal protocol is eighth in line to the throne, has been at the centre of several controversies. The most recent and potentially most damaging are allegations of sexual impropriety made against him by the deceased American Virginia Giuffre.

Ms Giuffre took her own life earlier this year. Now, a book she had written which is being posthumously released this month, is said to contain further potentially damaging details about their alleged relationship.

The Prince had previously made an outof-court settlement of millions of dollars to her but has vehemently denied the allegations she had made against him.

That was also linked to his friendship with the late disgraced high-profile American financier and convicted paedophile Jeffrey Epstein.

Prince Andrew had already stepped back from public life after he was stripped of the title His Royal Highness by his mother, the late Queen Elizabeth II over that matter..

In the unexpected statement on Friday, released via Buckingham Palace, he said he was now handing in all the remaining titles, including that of Duke of York.

His decision is being linked to the upcoming publication of the book by the late Ms Giuffre.

Prince Andrew has maintained his innocence in the new statement, which has been the subject of detailed and ongoing media and public scrutiny and comment.

There are now reports of a police investigation surrounding allegations of a planned smear campaign against Ms Giuffre possibly involving Prince Andrew and members of the London Metropolitan




