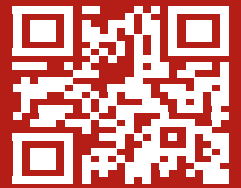

NEW GOVERNMENT REVENUE MEASURES DETAILED

A slew of new revenue-raising measures have been detailed by the Cayman Islands Government (CIG) following the Budget Statement.

The extensive series of new and increased fees, some of which have more than doubled, was central to the Budget Debate and Finance Committee Meeting.

The new measures are being published in their entirety by Caymanian Times as a public service to our readers and the entire Cayman society.

They are calculated to generate approximately an additional KYD\$172.4 million in revenues with \$72.5 million in 2026 and \$99.9 million in 2027.

That will come from additional fees on the financial services sector - Cayman's main economic pillar and several targeted domestic fees mainly from Stamp Duty on high-end land transfers, immigration and work permit fees, along with various trade and business licence fees such as Special Economic Zone Trade Certificate Fees and

Local Companies Control Licence Fees.

In explaining the justification for the increases, Hon. Min. for Finance and Economic Development, Rolston Anglin, said that in recent years, the country has faced growing fiscal pressures - from rising global inflation, increased costs of critical infrastructure needs, and the expansion of public service demands.

"It is against this backdrop that the Government has carefully reviewed the balance between revenues and expenditures, and determined that targeted, well-designed revenue adjustments are necessary to ensure the continued delivery of essential services and the sustainability of our public finances."

Mr Anglin also stressed that before finalising the new revenue measures, the Government engaged in discussions with stakeholders, especially those in the financial services industry. "We listened carefully to their feedback and made adjustments where appropriate to ensure that the measures are realistic, proportionate, and do not compromise Cayman's competitiveness as a leading international financial centre."

He also sought to deflect concerns about

the extent of the measures with the reassurance that the measures are carefully designed to strengthen our fiscal position, maintain compliance with the Framework of Fiscal Responsibility (FFR) and reduce the risk of future deficits as global economic pressures and local demands continue to rise.

According to Finance Minister Anglin: "The vast majority of the new revenue measures outlined are not intended to put further burden on the ordinary Caymanian. They are primarily concentrated in areas where the economic activity and capacity to absorb such costs are strongest - in particular, within the large, internationally focused segments of our economy."

It was also pointed out during the Finance Committee meeting that several of the announced measures, especially increases in vehicle licence and related fees, do not apply to Caymanians.

Mr Anglin also spoke of ongoing stakeholder consultation on some of the measures, saying "they are not hard and fast and are therefore subject to adjustment, either up or down."

Poinciana Rehabilitation Centre Wins Design Award: Puts Cayman Ahead of the World in Mental Health Care Treatment

and drug rehabilitation facility has already won an international award for its design, which offers a safe and supportive space for recovery and reintegration into society.

The European HealthCare Design Institute, which is the internationally recognised entity/body for health care architecture around the world, awarded Cayman's PRC with the first place prize for 2025.

Part of that winning design are several features that pay homage to Cayman seafaring heritage and mirrors designs from buildings such as Elmslie Memorial Church, where the roof is made in to mimic a ship's hull.

The cottages where residents live on the Site are also made in the likeness of the traditional Caymanian style cottages of long ago.

Sitting on 15 acres of land, with over 50,000 square feet of programmable space, the facility includes an activity area, a basketball court, a labyrinth (for meditation), a gym and a track.

"It is the first of its kind in the Caribbean; specialising in residential rehabilitation for individuals who require ongoing

therapeutic care and support to aid in their recovery in a structured environment," noted Psychiatrist Dr. Marc Lockhart M.D., who also serves as the Chairman of the Poinciana Advisory Council.

He said the facility is not a prison or detention centre but a therapeutic residential programme where clients participate voluntarily or through a referral under the Mental Health Act (2021 Revision) via a treatment order.

If someone has a serious and persistent mental illness, which affects their ability to recognise the need for treatment and they are a potential harm to themselves or others, they can be placed in care. However, after being examined by a government psychiatrist, those individuals still have the right for a second or third opinion.

Persons can also end up at the PRC via a Court order from the Drug Court or the Mental Health Court.

Up to 50 percent of people with serious and persistent mental illness also have drug use, according to PRC Officials. That number tends to increase with persons from lower economic and social support such as living on the street, no supervision with treatment or they cannot afford medication and are not taking it on time.

"Once individuals are stabilised and settled at a hospital such as HSA, Doctor's Hospital or Health City and can understand and accept what is happening to them in terms of their mental illness or drug use, they would then begin their residency here," noted PRC Director, Mrs. Marcia Mullings-Thompson.

She noted that there are currently 16 residents at PRC, which has a capacity for 54 residents.

"One of the major challenges facing the programme is staffing, which is the next step in progressing the facility to be at full residential capacity.

Dr. Lockhart explained why staffing a facility is particularly difficult in the mental health field:

"Staffing is a universal problem for mental health facilities because we don't have the requisite number of young persons and professionals going into this field.

"In the United States for example, there are only 30,000 psychiatrists and worldwide there are a few hundred thousand for billions of people. It's a very hard thing to get these professionals.

"Psychiatric trained nurses and occupational therapists that focus on mental health treatment are difficult to find."

Dr. Lockhart pointed out that during a recent recruitment drive and interview process, none of the occupational therapists who came forward had a mental health background.

"We have the funds, we have the ability to hire persons, we are approved by the government to hire someone for this role and we simply cannot find somebody to fill it."

"...We are trying to establish relationships on Islands with UCCI and other training entities to identify young people who are studying things like psychology and encourage them to come back for us to set up training programmes to open this up as another pillar in a sense," he remarked.

Budgetary constraints also add to challenges in terms of hiring, according to officials at PRC. However medical tourism is another option that may assist in supplementing the funding for the facility.

The original business case for the PRC facility highlighted medical tourism as a possibility for one or two of the cottages.

"Mental health facilities generally do not make money and in the case of PRC,

the programme is a non-profit entity but if we are able to bring in extra income and it is not a huge part of our offering, it is definitely worth considering," said Dr. Lockhart.

"Community support is also welcome," he added, explaining that we are currently behind in that regard.

"Very few hospitals can stand on their own; government or private," he said.

For decades the idea was floated that Cayman needed some type of long term health care facility to treat mental illness.

Dr. Lockhart noted that the idea for the model that now exists in Cayman was crystallised in his mind after Hurricane Ivan when - as the only psychiatrist on the Islands at the time - he observed that those with the least, persons who were marginalised, unemployed and not participating in society, had a new found sense of belonging to the community because the community relied on them in the clean up and help after the storm.

"I ran into some of my patients who were going out in a little canoe to feed the stingrays and some who were cleaning the sand off the West Bay Road.

"One day I was getting some ice at the Lion's Centre after the devastation of the storm and two guys who were there singing and laughing were patients of mine. These guys were full of life. They were needed by their community and had dignity.

"I realised then that we have to have a proper facility that will not be based on the typical medical model," he said.

"We need to have a community," he exclaimed, "..... a place isolated from the city and the noise with enough land and space that replicates the home and town and societal set up on a smaller basis to give our people the skills and preparation so that it's real rehabilitation and prepares them to go back out into the community and be productive citizens," said Dr. Lockhart.

The approach starts with the design of the facility, which has nine cottages in pods of three that have an entrance area, a seating and living room area with a refrigerator and television.

"The idea is to promote dignity and replicate any other housing set up that would

be available in the real world and not a typical hospital setting," Dr. Lockhart noted.

He said each individual has their own room to avoid institutionalising them or make them reliant on an institutional setting, where in many cases they wouldn't even have to make their own beds.

"That's not preparing you to go home and take care of yourself and wash your clothes and clean your place," said Dr. Lockhart. "Here you have to do a little



basic care. It's guided by the staff," he added.

Each cottage also has a washer and dryer.

"The first step is what we call activities of daily living. That's a part of the design where you have some basic requirements on a daily basis to start to get the right habits.

"The second thing is that we have a large enough compound. In typical medical settings everything is more compact. You are not moving around, getting fresh air, etc. Here, the residents have to move around. Exercise is built into the design," he remarked.

Thirdly, there is training for the residents from different companies on the Islands. There are also rooms for Alcoholics Anonymous and Narcotics Anonymous programmes.

The facility also has a gift shop and coffee shop, with the former being stocked with creative items made by residents



of the facility and the coffee shop being stocked with baked goods also made by the residents.

These activities will give the residents skills to go back into the community and also teach them how to manage money, how to organise and work as a group, how to resolve conflicts and differences, according to PRC Officials.

Persons will also be rewarded with profits from their input.

Dr. Lockhart said there are currently

rehabilitation. However, they do not have the medical detox and management component or the mental health treatment component. As a result many people have to be sent overseas for rehabilitation, which can cost up to C\$30,000 per month.

Currently The pines are for late stage dementia but the person who is just diagnosed and dealing with wandering and forgetfulness often needs care for which many families hire a helper with no expertise in these areas.

Some of the cottages at PRC will also be used as a dementia, memory care, day hospital for short term stabilisation treatment.

"It can take weeks to get dementia patients adjusted. To put them in the mental health care ward at the hospital is not ideal," according to Dr. Lockhart.

He said, "Our thought here is that we use one or two of our cottages to stabilize such persons. Admit them for two or three weeks, we can have activities for them, start the treatment, give the family time to prepare their house, hire a caregiver, etc.

One of the issues affecting the likelihood of persons accessing the services at the facility is the stigma surrounding mental health.

However, Dr. Lockhart, the staff at PRC and the Advisory Council of PRC have gone above and beyond to make sure the structure, design and programmes offered at the facility are world class and serve every facet of the community's needs.

PRC is a place where persons can heal with privacy and dignity in a setting that is structured and safe.

STATEMENT BY MINISTER FOR FINANCE & ECONOMIC DEVELOPMENT'S
DETAILS OF REVENUE MEASURES FOR 2026 and 2027**

Honourable Members of Finance Committee, Governments do not introduce revenue measures lightly. Governments, by nature, prefer to create the conditions for growth and opportunity rather than to impose additional financial obligations.

However, responsible fiscal management requires us to face realities head-on and make measured, sometimes difficult, choices to protect the Country's long-term financial health.

In recent years, Honourable Members, the Country has faced growing fiscal pressures - from rising global inflation, increased costs of critical infrastructure needs, and the expansion of public service demands.

It is against this backdrop that the Government has carefully reviewed the balance between revenues and expenditures, and determined that targeted, well-designed revenue adjustments are necessary to ensure the continued delivery of essential services and the sustainability of our public finances.

Honourable Members, before finalising the new revenue measures, the Government engaged in discussions with stakeholders, especially those in the financial services industry. We listened carefully to their feedback and made adjustments where appropriate to ensure that the measures are realistic, proportionate, and do not compromise Cayman's competitiveness as a leading international financial centre.

This collaborative approach reflects our ongoing commitment to partnership, transparency, and maintaining confidence in our fiscal and regulatory environment.

Honourable Members, for the upcoming Budget, the Government has introduced new revenue measures in 2026 and 2027. These measures are carefully designed to strengthen our fiscal position, maintain compliance with the Framework of Fiscal Responsibility and reduce the risk of future deficits as global economic pressures and local demands continue to rise.

Honourable Members, details of the revenue measures are as follows:

1. **Bank and Trust Licenses** increases will yield an additional \$1.9 million in 2026 and \$3.25 million in 2027:
 - a. licensees with assets between US\$1 billion and US\$3 billion, the annual fee increases from \$1,000,000 to \$1,200,000 in 2026 and to \$1,500,000 in 2027; and
 - b. licensees with assets exceeding US\$3 billion, the annual fee increases from \$1,000,000 to \$1,500,000 in 2026 and to \$1,750,000 in 2027;
2. **Insurance Licence Fees** will increase to yield an additional \$0.7 million starting in 2026:
 - a. Domestic Insurance license fees will increase from \$9,500 to \$10,450; and
 - b. Captive Insurance license fees will increase from \$10,500 to \$11,550; and
 - c. Reinsurance license fees will increase from \$13,500 to \$14,850.
3. **Exempt Companies (under the Trade and Business License Act)**, fees will be increased to yield an additional \$1.17 million in 2026 and 2027, with the annual fee increasing from \$800 to \$12,500.

4. **Annual operational licence fees for accounting firms** will yield an additional \$3.48 million in 2026 and 2027, with:
 - a. the License Fee for firms with 6–10 accountants being removed – this fee was previously \$20,000;
 - b. Licences Fees for firms with 11–15 accountants will increase from \$40,000 to \$50,000;
 - c. for firms with 16–20 accountants, the licence fee will increase from \$60,000 to \$75,000;
 - d. for firms with 61–70 accountants, the fee will increase from \$200,000 to \$500,000;
 - e. for firms with 71–80 accountants, the annual operational licence fee will increase from \$400,000 to \$600,000;
 - f. for firms with 81–90 accountants, the fee will increase from \$400,000 to \$700,000;
 - g. for firms with 91–100 accountants, the fee will increase from \$400,000 to \$800,000;
 - h. for firms with 101–110 accountants, the fee will increase from \$400,000 to \$900,000; and
 - i. for firms with 111 and more accountants, the annual operational licence fee will increase from \$400,000 to \$1,200,000.

5. **Special Economic Zone Trade Certificate Fees** will increase to yield an additional \$0.3 million in 2026 and 2027, with:
 - a. the initial application fee increasing from \$123 to \$500;
 - b. the Annual Renewal Fee increasing from \$492 to \$750; and
 - c. Amendment Fees increasing from \$50 to \$250.
6. **Fund Annual Return (FAR) Filing Fees** will increase to yield an additional \$11.1 million in 2026 and 2027, with:
 - a. Mutual Funds fees increasing from \$300 to \$450; and
 - b. Private Funds fees increasing from \$150 to \$225.
7. The introduction of an annual \$100 fee for **Exempted Limited Partnership and Corporate Service Providers Fees** is estimated to yield an additional \$4.1 million per year.
8. The introduction of a **Virtual Assets (Service Providers) Fee** is estimated to yield an additional \$0.3 million per year; and
9. Increases to **Registration and Annual Company Fees** are estimated to yield an additional \$20.3 million commencing in 2027 with:
 - a. Registration fees increasing by \$100;
 - b. Annual fees for Exempt Companies increasing by \$200; and
 - c. Annual fees for Other Companies increasing by \$100.

Honourable Members, with respect to new revenue measures related to the **Legal Profession** – these measures are estimated to yield an additional \$10.2 million in 2026 and \$6.3 million in 2027. These increases are expected from the following sources:

10. **Practising Certificate Fees:**
- a. for in-house counsel, will increase from \$1,000 to \$2,500;

b. for law firms with non-Caymanian affiliates, Practising Certificate Fess will increase from \$2,500 to \$7,500; and

c. for law firms with Caymanian affiliates, fees will increase from \$2,000 to \$2,500.
11. The one-time **Admission Fee for non-Caymanian Attorneys** will increase from \$2,000 to \$10,000.
12. **Law Firm Operational Licence Fees:**
- a. for firms with 1-10 attorneys, licence fees will be nil;

b. for firms with 11–15 attorneys, licence fees will increase from \$40,000 to \$50,000;

c. for firms with 16–20 attorneys, licence fees will increase from \$60,000 to \$75,000;

d. for firms with 21–25 attorneys, licence fees will be \$200,000;

e. for firms with 26–30 attorneys, licence fees will be \$250,000;

f. for firms with 31–40 attorneys, licence fees will be \$300,000;

g. for firms with 41–50 attorneys, licence fees will be \$350,000;

h. for firms with 51–60 attorneys, licence fees will be \$400,000;

- i. for firms with 61–70 attorneys, licence fees will increase from \$400,000 to \$500,000;

j. for firms with 71–80 attorneys, licence fees will increase from \$400,000 to \$600,000;

k. for firms with 81–90 attorneys, licence fees will increase from\$400,000 to \$700,000;

l. for firms with 91–100 attorneys, licence fees will increase from \$400,000 to \$800,000;

m. for firms with 101–110 attorneys, licence fees will increase from \$400,000 to \$900,000; and

n. for firms with 111 and more attorneys, the operational licence fees will increase from \$400,000 to \$1,200,000
13. Increases in **Court Fees** are estimated to yield an additional \$0.1 million per year; and
14. Increases in the Court’s **Website Recovery Fees**, are estimated to yield an additional \$0.1 million per year.

Honourable Members, with respect to the new revenue measures related to **Immigration** – these measures are estimated to yield an additional \$15.4 million in 2026 and \$17.1 million in 2027. These increases are expected from the following sources:

15. In relation to **Work Permit–related Fees**:
- a. Most administrative and amendment fees for work permit grants, continuation, and dependent additions will increase by 150% to 400%, with the **standard work permit administration fee** increasing from \$100 to \$500;

- b. **Temporary work permit fees** will increase by 150% to 200%, depending upon the income band; and

c. New **annual and express work permit fees** are going to be introduced, ranging from \$100 to \$300, based on the level of the main permit fee.
16. In relation to **Permanent Residency and Caymanian Status Fees**:
- a. There will be new or increased fees for permanent residency holders, including:

i. new **dependent fees**, which will increase from \$500 to \$750 per dependent per year; and

ii. the **annual declaration filing fees for permanent residency holders**, increasing from \$100 to \$500.

b. **Right to be Caymanian** applications and grants are also going to increase:

i. The grant fee for the Right to be Caymanian by **marriage**, will increase from \$1,000 to \$3,000;

ii. The grant fee for the Right to be Caymanian by **naturalisation** will increase from \$1,000 to \$5,000; and

iii. The fee for the Right to be Caymanian granted **by the Governor in Cabinet** will increase from \$1,000 to \$5,000.
17. In relation to **Residency Certificates**:
- a. The issuance fee for a **Residency Certificate for Persons of Independent Means** will increase from \$20,000 to \$50,000;

b. The Issue fee for a **Certificate of Permanent Residence for Persons of Independent Means** will increase from \$100,000 to \$200,000; and

- c. The application fee for **Direct Investment Certificates** will increase from \$20,000 to \$50,000.
18. **Other Immigration Administrative Fees** will also increase:
- a. Routine items such as document copies, duplicate certificates, and re-entry permits will increase by 100% to 150%; and

b. Business Visitor Permit fees will increase by 250% to 600%, depending upon the category.
19. There will be an introduction of an annual **Work Permit Fee** for work permit holders that is estimated to generate additional revenue of \$1.5 million.
20. Honourable Members, there are plans to increase **Special Economic Zone Fees**, which are estimated to yield an additional \$7.0 million per year.
21. Honourable Members, with respect to the new revenue measures related to **Stamp Duty on Land Transfers** – these measures are estimated to yield an additional \$11.7 million in 2026 and \$11.2 million in 2027. These increases are expected from the **Stamp Duty** rate on the sale of property of \$2.0 million and above, increasing to 10%.
22. Honourable Members, the new revenue measures related to **Local Companies Control Licensing Fees for Realtors and Developers** are estimated to yield an additional \$260,000 in 2026 and 2027:
- a. Real Estate licences increasing from \$12,500 to \$15,000; and

b. Property Developer licences increasing from \$12,500 to \$20,000.

NB. In respect of LCCLs, a decision has also been taken to place a moratorium on the issuance of new licenses in these categories.

23. New revenue measures related to **Liquor Licences Fees** are estimated to yield an additional \$1.6 million in 2026. These measures involve:

- a. Fees for Distributors are increasing from \$4,800 to \$25,000;
- b. Liquor Licence fees for Hotels:
 - i. with 50 beds or fewer, fees are increasing from \$2,000 to \$5,000
 - ii. with 51–100 beds, fees are increasing from \$4,800 to \$10,000
 - iii. hotels with 101–199 beds, fees are increasing from \$4,800 to \$15,000
 - iv. with 200–299 beds, liquor licensing fees are increasing from \$4,800 to \$17,500;
 - v. hotels with 300–399 beds, fees are increasing from \$4,800 to \$20,000; and
 - vi. hotels with 400+ beds, liquor licensing fees are increasing from \$4,800 to \$25,000.
- c. Liquor Licence fees for Restaurants, will increase for:
 - i. those with fewer than 50 seats, from \$1,500 to \$3,000;
 - ii. for restaurants with 50–99 seats, liquor licensing fees are increasing from \$1,500 to \$5,000;
 - iii. 100–199 seats, fees are increasing from \$1,500 to \$8,000;
 - iv. 200–299 seats, fees are increasing from \$1,500 to \$10,000; and
 - v. restaurants with 300–500+ seats, liquor licence fees are increasing from \$1,500 to \$15,000.

24. **Traders Licences** will increase to yield an additional \$1.1 million in 2026 and 2027. These measures involve:

- a. the licence fee for property developers with 15 or fewer employees, will increase from \$750 to \$10,000;
- b. the licence fee for property developers with 16 or more employees, will increase from \$750 to \$20,000;

- c. the licence fee for real estate agencies with non-Caymanian agents, will increase from \$750 to \$10,000;
- d. the licence fee for self-employed Local Companies Control License (LCCL) holders will increase from \$750 to \$10,000; and
- e. the Traders Licence fee for Accountants, including auditors, actuaries, bookkeepers and statisticians, will increase from \$2,000 to \$2,500.

25. Finally, Honourable Members, Motor Vehicle Drivers Licences, Motor Vehicle Charges and private and rental vehicle licences for Non-Caymanians will be increased to yield an additional \$9.6 million in 2026 and 2027. These measures involve:

- a. For Driver Licence Fees for Heavy equipment and special vehicles for Non-Caymanians:
 - i. A 3-year licence will increase from \$120 to \$750;
 - ii. A 5-year licence will increase from \$200 to \$1,250; and
 - iii. A 10-year licence will increase from \$400 to \$2,500.
- b. For Driver Licence Fees for Motorcars and trucks up to 3 tons for Non-Caymanians:
 - i. A 3-year licence will increase from \$75 to \$600;
 - ii. A 5-year licence will increase from \$125 to \$1,000; and
 - iii. A 10-year licence will increase from \$250 to \$2,000.
- c. For Driver Licence Fees for Motorcycles (both under and over 125cc) for Non-Caymanians:
 - i. A 3-year licence will increase from \$75 to \$600; and
 - ii. A 5-year licence will increase from \$125 to \$1,000.
- d. For Driver Licence Fees for Trucks over 3 tons and buses (up to 25 passengers) for Non-Caymanians:

- i. A 3-year licence will increase from \$120 to \$750;
- ii. A 5-year licence will increase from \$200 to \$1,250; and
- iii. A 10-year licence will increase from \$400 to \$2,500.

e. Vehicle Licence Fees for **Non-Caymanian Owned Private vehicles**:

- i. For Cars up to 2,500cc, the licence fee will increase from \$180 to \$200; and
- ii. For Cars over 2,500cc, the licence fee will increase from \$200 to \$225.

f. Vehicle Licence Fees for **Non-Caymanian Owned Rental vehicles**:

- i. for Cars up to 2,500cc, the fee will increase from \$365 to \$400;
- ii. for Cars over 2,500cc, the fee will increase from \$400 to \$500; and
- iii. for Rental trucks (4,001–8,500 lbs), the fee will increase from \$500 to \$600.

g. Vehicle Licence Fees for **Non-Caymanian Owned Trucks and trailers**:

- i. for trailers up to 2,000 lbs, the fees will increase from \$50 to \$75;
- ii. for trailers 10,001–66,000 lbs, the fees will increase from \$420 to \$430; and
- iii. for Trade plate holders, the vehicle licence fees will increase from \$1,408 to \$1,600.

Honourable Members, the vast majority of the new revenue measures that I just outlined are not intended to put further burden on the ordinary Caymanian. They are primarily concentrated in areas where the economic activity and capacity to absorb such costs are strongest - in particular, within the large, internationally focused segments of our economy. In addition, with respect to some of the fee increases mentioned in the commerce space, there is ongoing stakeholder consultation so they are not hard and fast and are therefore subject to adjustment, either up or down.

At the same time, Honourable Members, these new revenues are sustainable and ensure that the needs of our people are being met – that the Government

continues to invest in the infrastructure, healthcare, education, housing, and public safety services that directly benefit our people.

Honourable Members, these decisions are not about raising revenue for its own sake; they are about maintaining balance - between growth and responsibility, between opportunity and sustainability. The Government remains firmly committed to fiscal prudence, transparency, and fairness in everything we do.

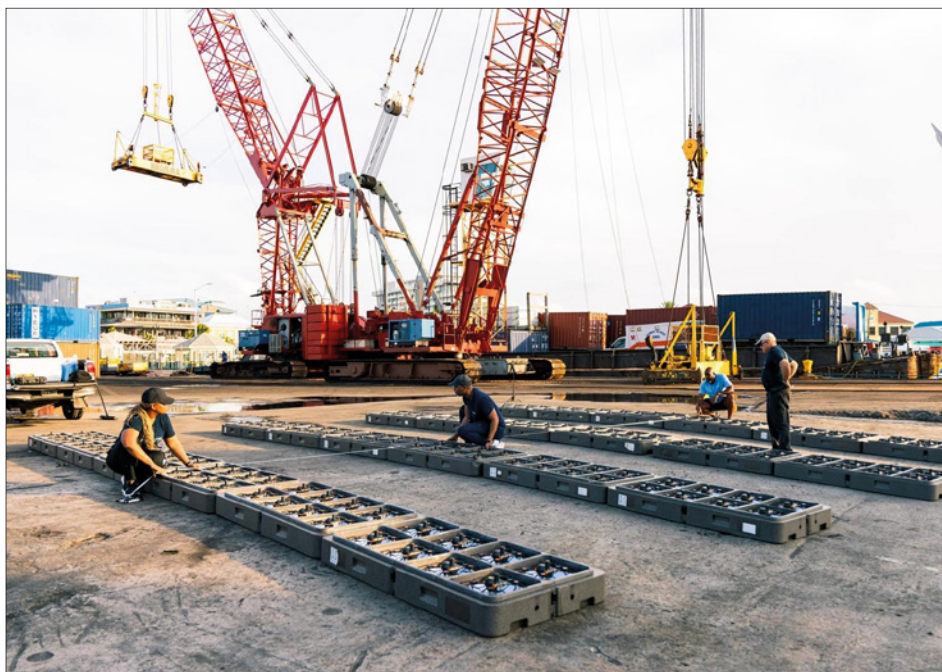
uration of the vessel, it does not possess the technology or systems capable of interfering with drone signals.

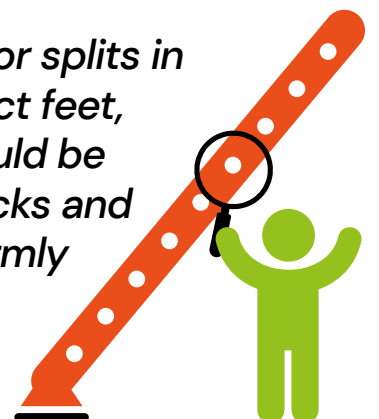

CAYMAN JAMAICA HUMANITARIAN OUTREACH RAISED IN FINANCE COMMITTEE

The harrowing scenes of the devastation in western Jamaica caused by historic Hurricane Melissa are being matched by an international outpouring of support for the country's stricken areas.

With Cayman leading off the international response with the first government-organised aid flight into the country, more relief is already underway and other humanitarian outreach steps are being considered.

Following a government-organised Cayman Airways aid mission led by Hon. Premier Andre Ebanks, a team of engineers from Caribbean Utilities Company (CUC) has been dispatched for a month-long deployment to Jamaica to assist their counterparts with restoring electricity to some of the hardest-hit areas.

Now, another gesture of Caymankind for Jamaica has been raised in a meeting of the Cayman Islands Parliament Finance Committee.

Hon. Deputy Opposition Leader, Kenneth Bryan, asked if the government was considering relaxing visa requirements for eligible Jamaicans seriously affected by the hurricane to be hosted by relatives in Cayman for an interim period.

"Is the Minister aware or concerned about any hindrances in the visa application for persons who may want to come over as a way of relief, if they have persons here that can help from an affordability perspective, take care of them until their circumstances back home are in a better state? I'm specifically talking about the elderly and children."

Addressing the matter, Hon. Min. for Home Affairs, Nikolas Da-Costa, said the existing visa provisions allow for such steps to be taken.

"As it relates to the elderly and children, there's no hindrance," he explained. "Children under the age of 15 and elderly persons above the age of 70 do not need



a visa to come, so there's no hindrance on them entering Cayman."

Deputy Opposition leader Bryan (Progressives), expanding on his question, wondered if that facility extended to hurricane-impacted persons with disabilities whose situation in Jamaica would have worsened because of the disaster.

"I was thinking about persons... who would still be considered to be a dependent in some capacity on the fringes of those age brackets," he stated, asking if there are "provisions for them to visit for a short period of time."

Cayman has longstanding historical family and cultural ties with Jamaica and shares a further empathy, having itself suffered the severity of Category 4 hurricane Ivan in 2004. The neighbouring island was among the first to come to Cayman's assistance.

COUNTING THE COST

The extent of the devastation in the western areas of Jamaica caused by Hurricane Melissa, becomes more visible with each passing day, seen in numerous videos, media reports and official updates.

The death toll continues to rise, with over 45 persons known to



have perished according to recent figures, with another 14 unaccounted for. The damage estimate is already spiralling with updated official estimates of US\$7 billion and mounting. Thousands of homes, businesses, key infrastructure and services have been either destroyed or severely damaged, with villages literally obliterated - some submerged in extensive flooding.

Amidst signs of desperation in some of the most severely-affected and hard-to-reach communi-

ties, a massive relief programme is underway with huge amounts of international aid flowing into the country. That's in addition to the relief and recovery programmes of the Jamaica government, a network of community organisations and individual efforts.

CONTRAST

The trail of destruction across most of south western Jamaica - mainly the St Elizabeth parish, including Black River and other impacted areas - is contrasted by

an aura of 'business-as-usual' in the other two-thirds of Jamaica.

Already, in parts of the key tourism north coast, which were not as severely affected as previously feared, moves are underway to revive the vital tourism sector. Hotspots such as Ocho Rios and the Port Antonio hub are up and running, aiming to capitalise on the upcoming peak winter tourist season, while the bustling activity continues in the west coast capital and commercial centre, Kingston and elsewhere.

Following the shocking devastation left by Hurricane Melissa in Jamaica CIBC Caribbean has mobilized its partners to respond to the call for relief for people affected by the hurricane.

Through CIBC Caribbean's ComTrust Foundation, and in association with the CIBC Foundation, the bank has committed the funds towards projects on several levels: assisting its employees in Jamaica affected by Melissa, with immediate relief supplies through Food for the Poor, and funding the deployment of a Field Hospital Unit by the Barbados Defence Force, which will be set up in Savanna-La-Mar, one of the hardest hit regions of Jamaica.

The bank's Chief Executive Officer, Mark St. Hill, who also chairs the Caribbean bank's charitable foundation, noted: "Viewing the photos of the hard-hit areas of the western part of the island has caused us distress because we can empathize with the sense of despair the people of Jamaica are feeling, because we all know that any Caribbean country is but a heartbeat away from the same experience every hurricane season."

The bank began its relief efforts by ensuring the safety of its 670 employees and providing those who needed with food, and

assistance repairing their homes, simultaneously turning its attention to assistance for hurricane survivors through a cash donation to Food for the Poor.

Head of Country, Annique Dawkins, praised her team in Kingston for its efforts, which started as soon as the "All Clear" was given for the country. "Our colleagues in Kingston, too, sprang into action to help their fellow Jamaicans by distributing food and other necessities, and in even risking their safety to salvage some access to banking services that will provide for our clients what is often so critical after a crisis like this – cash – when we brought the ATM in Savanna-la-Mar back online."

Chief Country Management Officer, Donna Wellington, noted the bank has "provided short term relief, but helping Jamaica is a long-term project and CIBC Caribbean is up to the task," as she outlined the bank's package of relief which includes:

- USD\$100,000 which has already gone to Food for the Poor, for the purchase of relief supplies ranging from sanitation equipment, tarpaulins, feminine and baby care supplies, first aid kits, burner stoves, solar fans etc.

- We have provided funding to the Barbados Defence Force's Emergency Medical

Team (BDF EMT) and a Type 2 Field Hospital's deployment to Savanna-La Mar-Regional Hospital in Westmoreland, Jamaica as part of the Hurricane Melissa response. The facility will be staffed by personnel from the Barbados Defence Force, and volunteers from across Barbados and the eastern Caribbean, coming from the public health sector and private medical clinics. This is the first time the facility is being fully deployed after a disaster, with CIBC Caribbean being the major donor, committing USD\$250,000 to outfit the facility, so it will be a self-managing unit when it arrives in Jamaica.

- And our Jamaica CMC will use funds in the local CIBC Caribbean ComTrust account to provide care packages for persons in communities who have been impacted by Hurricane Melissa.

- Our Cards and Payments team are also stepping up, offering USD \$150,000 in donations to be disbursed as the Country Management team deems fit. Pre-paid cards are being made available to provide funding to impacted individuals where they are able to use these to help them buy essentials.

- We've also agreed with the University of the West Indies to donate unused funds

from our scholarship programme for this year and last year to their Student Hardship Fund to assist Jamaican students who are trying to recover from the effects for the hurricane.

Additionally, the bank has put together a package of assistance for clients needing extra support during this difficult period. These include:

- Payment moratoriums on existing loans, mortgages and credit cards
- Temporary revolving or working capital financing options for our Corporate Banking and Business Banking clients.
- Additional financing facilities to support rebuilding efforts pending insurance settlements
- Other special credit relief or waiver considerations to address specific client requests

Mr. St Hill added: "We have more than 670 team members in Jamaica, and each one of them has family, friends and other stakeholders as part of their circles. Our response to the appeal for assistance to Jamaica is because we are part of one Caribbean region, which is susceptible to natural disasters each year. We must be our brother's keeper."

Individual Sentenced to Three Months Imprisonment for Forged Documents Offences

Authorities have secured a conviction resulting in a three-month prison sentence for an individual who pleaded guilty to multiple counts of possessing forged documents.

In October 2024, Customs and Border Control Service (CBC) officers intercepted an individual at the Owen Roberts International Airport with a suspected fraudulent work permit. Following a thorough investigation by Workforce Opportunities & Residency Cayman (WORC), it was determined that Mr. Aashish Thapa, a relative of the individual, was responsible for preparing and supplying the fraudulent documents.

The matter was referred to the Office of the Director of Public Prosecutions, resulting in, Mr. Thapa pleading guilty to five (5) counts of possessing fraudulent documents and being sentenced to three (3)

months' imprisonment. The court, having heard of CBC's intention to remove Mr. Thapa, recommended that a deportation order be made following the completion of his sentence.

Minister for Caymanian Employment & Immigration, Hon. Michael Myles said, "The successful prosecution in this case sends a clear and unequivocal message: fraudulent activity will not be tolerated in the Cayman Islands. Those who attempt to undermine our systems through deception will be investigated and prosecuted under the law. I commend WORC for their unwavering commitment to justice and integrity."

"I want to express my appreciation to our officers for their professionalism, diligence, and unwavering commitment throughout this investigation," said WORC Director Jeremy Scott. "Their me-

ticulous work and collaboration with partner agencies were pivotal in ensuring that justice was served. I am proud of the dedication and integrity demonstrated by our team."

The public is reminded that the use or creation of forged documents is a criminal offence under section 76 of the Immigration (Transition) Act (2022 Revision) and sections 283A and 283B of the Penal Code (2024 Revision) and will be met with appropriate legal action. Offences under this section of the Immigration (Transition) Act (2022 Revision) are punishable on summary conviction by a fine up to CI \$5,000 and/or imprisonment for up to 12 months.

WORC remains steadfast in its commitment to upholding the integrity of immigration processes and protecting the public from fraudulent activity.

POLICE NEWS

Police Investigate Serious Assault Incident in George Town

Just after 10 PM on Saturday, 15 November, police and other emergency services were dispatched to a report of a serious assault incident that took place at the Pirates Week event in George Town.

It was reported that two men had a verbal altercation in the area of the main courthouse building on Edward Street. This altercation escalated to a physical fight, which led to one of the men sustaining a stab wound to the area of his chest.

The victim left the scene in a private vehicle as officers responded and was met by the ambulance en route. The injured man was treated by the hospital overnight for serious but non-life-threatening wounds.

He has since self-discharged from the hospital following his treatment.

The suspect involved in this incident fled the location before the police arrived. He was described as being tall and dark skinned and wearing black clothing. A search was carried out by the police for the suspect throughout the night with negative results.

The incident took place during the Pirates Week event, where there was a large number of people present at the time of this altercation. Detectives are encouraging anyone with information to call the George Town Police Station at 949-4222 and assist with this ongoing investigation.

RCIPS report recovery of two Firearms and other illicit items

On Friday, 14 November, a police lead multi-agency operation was conducted at a residence in West Bay under the Firearms Act. The search team consisted of personnel from the Royal Cayman Islands Police Service, Customs and Border Control, Department of Agriculture and the Cayman Islands Fire Service.

During the search, two handguns, a quantity of firearm ammunition, a large quantity of ganja, a liquid substance believed to be hash oil, and other items be-

lieved to be of value to the investigation were recovered.

As a result, a man, age 40, and a woman, age 34, both of West Bay, were arrested on suspicion of possession of an unlicensed firearm, possession of an unlicensed firearm (ammunition), possession of ganja with intent to supply, possession of ganja and consumption of ganja.

The arrested man remains in custody, while the woman was bailed pending further investigations. The investigation is being carried out by the police.

Police Investigate incident of Attempted Murder in West Bay

Just after 12:30 PM on Saturday, 15 November, police and other emergency services were dispatched to a report of a disturbance at a residence located on Hell Road in West Bay.

When the officers arrived at the location, they met with a woman who appeared to be in distress. She recounted to the officers that a man who is known to her assaulted another man who was at the location, using a machete. Officers located the injured male, who had lacerations to his head and face. The officers provided the wounded man with first aid until the ambulance arrived and

transported the man to the hospital, where he is being treated for what is believed to be serious but non-life-threatening injuries.

The woman involved in the incident reported minor injuries to the police and declined medical attention.

A 46-year-old man of West Bay was located and arrested on suspicion of Attempted Murder. The man remains in custody pending further investigation. Detectives are encouraging anyone with information pertaining to this incident to call the West Bay Police Station at 949-3999.

Police Report on Recent Uptick in Burglaries in George Town

Between 10 November and 13 November, officers with the RCIPS have responded to seven reports of burglaries. Of these reports, six have been carried out at commercial premises along the Waterfront in the district of George Town.

One man, age 34, of George Town, was arrested on suspicion of burglary yesterday, 13 November, and remains in custody pending further investigation.

The RCIPS has prioritised safeguarding the community from these types of incidents but is also reminding businesses of the importance of having working

CCTV activated at all times and to ensure premises can be adequately secured after hours. Investigators have found that the perpetrator(s) of these burglary incidents have been stealing cash from the locations and urge business owners to take proper precautions to protect their businesses, such as refraining from leaving cash overnight and making regular cash deposits.

Detectives are encouraging anyone with information regarding any of these incidents of burglary to call the George Town Police Station at 949-4222.

Man Arrested During Burglary in Progress in George Town

Just after 4:45 AM on Saturday, 15 November, police were dispatched to a report of a burglary in progress at a commercial property on South Church Street in George Town.


When the officers arrived at the location, they found a masked man inside the property, and when approached by the police, he fled the location on foot. Following a short

foot chase, the man, age 34, of George Town, was arrested on suspicion of burglary.

The man remains in custody pending further investigation.

Police are currently investigating whether there is a possible connection between last night's incident and the increase in burglaries in the George Town district.

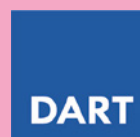
