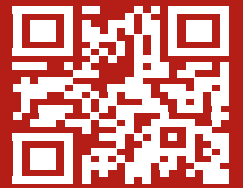

Black Friday deals bring out the shoppers

On Friday, 28th November, customers gathered at Cost-U-Less on the West Bay

Road for Black Friday deals ahead of the Holiday Season.

Black Friday in the Cayman Islands like many other destinations has traditionally

been a time of much excitement, as shoppers queue at stores vying for an opportunity

Inflation Rate was 0.1% for the Third Quarter of 2025

The third quarter inflation rate was 0.1 percent, and among the leading contributors was an 8.1 percent rise in the communication division. The upward movement of the communication index was primarily due to a 10.3 percent increase in the telephone and telefax services index.

There was also a 5.2 percent rise in education, and increases of 0.2 percent in clothing and footwear, 0.3 percent in health, 4.5 percent in food and non-alcoholic

beverages, 2.1 percent in alcoholic beverages and tobacco, 0.3 percent in recreation and culture, 2.2 percent in household equipment, and 0.7 percent in miscellaneous goods and services. Housing and utilities declined by 2.0 percent.

A comparison of the third quarter of 2025 with the second quarter of 2025 indicates that the CPI increased by 0.4 percent, as the index for food and non-alcoholic beverages went up by 2.7 percent. The upward movement of food

and non-alcoholic beverages is mainly due to the 12.2 percent increase in the index for fruits, the 5.2 percent rise in vegetables, and the 4.7 percent increase in meat and meat products.

There was also an increase in restaurants and hotels (1.3%), household equipment (1.0%), clothing and footwear (0.5%), miscellaneous goods and services (0.5%), and housing and utilities (0.4%). Recreation and culture (1.5%), health (0.7%) and

alcoholic beverages and tobacco (0.4%) declined over the quarter. More information from the Cayman Islands' Consumer Price

Temporary Increase to Duty-Free Allowance

Temporary Increase to Duty-Free Allowance for Returning Residents

From 29 November 2025 to 11 January 2026, the duty-free allowance for Cayman Islands residents returning by air will temporarily increase from CI \$500 to CI \$1,000. This applies only to personal and household goods, not merchandise or items for resale. Items exceeding the CI \$1,000 limit must be declared and will attract duty on the excess. The standard CI \$500 allowance resumes after 11 January 2026.

Cabinet has approved an Order under Schedule 2 of the Customs Tariff Act (2023 Revision) authorizing a temporary increase to the duty-free allowance for Cayman residents returning by air during the upcoming holiday season.

From 29 November 2025 through to 11 January 2026, returning residents may bring in personal and household goods, valued up to CI\$1,000 duty-free, an increase of CI\$500 from the standard allowance.

The carefully considered temporary measure is intended to provide meaningful financial relief for families during a time when many residents traditionally shop for holiday celebrations. While also supporting efficient and smooth airport operations at the Owen Roberts International Airport and Charles Kirkconnell International Airport, during one of the busiest travel periods of the year. Additionally, the temporary adjustment will simplify the passenger declaration process.

However, this Order does not apply to merchandise or goods intended for resale.

Who the allowance applies to:

- Residents of the Cayman Islands who are returning by air during the designated period.

- This allowance is strictly limited to personal and household goods and does not extend to merchandise or items intended for resale.

How it works:

- Goods up to CI\$1,000 may be admitted as duty-free at the Officer's discretion.
- Goods exceeding CI\$1,000 must be declared and will incur duty on the excess.
- Travelers should retain receipts and declare items accurately; CBC officers may verify information where necessary.

Honourable Nickolas DaCosta, JP, MP, Minister for District Administration and Home Affairs, said the initiative reflects the Government's commitment to supporting Caymanian families, while maintaining strong border operations. "As a Government, we want to ease some of the pressure families feel during the holidays. By temporarily increasing the duty-free allowance, residents will have a little more flexibility to prepare and celebrate

the season", he said. "This change will also help keep airport processing smooth and efficient during our busiest weeks. It's a simple, people-focused step that supports families while ensuring our border operations continue to run fairly and effectively for everyone".

Residents are reminded that items exceeding the CI\$1,000 allowance must be declared on the Customs & Border Control (CBC) Declaration Form. CBC Officers may verify decla-

rations as part of their standard procedures. Items intended for resale remain subject to full duty.

This temporary increase in allowance ends on 11 January 2026, after which the standard CI\$500 duty-free allowance will resume.

CRUISE LINES ON BOARD WITH CAYMAN’S PLAN

Cayman can look forward to continued growth in the cruise sector, notwithstanding the ‘No’ vote against a cruise pier in the April referendum (and election). That was the message delivered during the recent sitting of the Parliamentary Finance Committee.

Strong commitments from the Florida Caribbean Cruise Association are now being channelled into new strategies to improve the cruise visitor experience in Cayman, according to Hon. Minister for Transport (also Planning, Lands, Agriculture, Housing and Infrastructure), Johann ‘Jay’ Ebanks.

Both Mr Ebanks and Hon. Min. for Tourism, Gary Ratty, represented Cayman at a recent FCCA convention in Puerto Rico during which they were assured by cruise lines that Cayman will remain a preferred port of call despite the absence of a cruise pier.

Transport Minister Ebanks said there are many opportunities to be capitalised on to further grow the industry with a unique Caymanian flavour. These include expanding the cruise ship tender services, better utilising the main passenger facilities in George Town at the Royal Watler Pier, the North Terminal, and the South Terminal, as well as looking at opening up the Spotts area for occasional cruise ship calls.

While updating that cruise passenger pick-up and drop-off points in George Town will be enhanced and beautified, he said stricter controls will also be put in



place, including revoking licences of some bus and taxi operators who fail to comply. That received an immediate supportive reaction from the MPs present.

TENDERING TO GET BIGGER

He reported that they heard from the cruise ship companies “how we can improve now that they know that the people’s mandate is that they do not want to build piers and how we can improve and enhance the safety of our guests, disembarking off the ship,” Min. Ebanks stated, responding to a question from the previous tourism minister Kenneth Bryan.

Crediting Mr Bryan for his efforts during his tenure, Min. Ebanks went on to detail how the National Coalition For Caymanians (NCFC) administration is now proceeding with developing the sector, guided by Minister of Tourism Gary Ratty.

“One thing that we are looking at now is that we are going to do all the pre-checks directly on-shore,” he stated. “Instead of the Customs and Immigration at the ship, we will have everyone disembark as quickly as possible and go through the checkpoints on shore.”

Much emphasis will also be placed on encouraging more investment in cruise ship tendering services, Mr Ebanks said, which

further opens up opportunities to grow that sector supporting the cruise industry.

“One of the reasons why we are limited to the amount of ships that we have in harbour is because we don’t have enough tenders for all of the ships. So the mandate is going to be going forward, is that either we are going to look at making new millionaires in the country, or the people are going to make bigger investments.”

Doubling down on the urgency of the situation and the opportunities it presents, Mr Ebanks insisted, “We are not going to be held back by only having a certain amount of tenders in this country. We are going to enhance the tender process that we need to be able to get the people off the ships. The investments need to be made, because if that investment isn’t made, the member for tourism (Ed. Minister for Tourism) cannot bring the numbers up.”

Further explaining that the larger cruise ships need at least five tenders for passenger transfers, Transport Minister Ebanks said that would require “significant investments”.

“We are looking forward to working that out in the new year,” he added, stressing the return on investment not only for the tender operators but rippling through the wider economy.

REVENUE MEASURES

Mr Ebanks also disclosed that the cruise lines accepted that some increase in government fees was under consideration, but asked that they be advised well in advance for their own budget planning and scheduling.

“We are selling our product too cheap. I’ve made it known to all of the cruise lines with the Deputy Premier there that we are going to be looking at the way that we sell our product. They are happy about looking at the numbers. They just said, ‘Please don’t drop it on us within the next month or two...as we are already pre-booked out for a long period of time.’”

CRUISING TO SPOTTS

Further cross-party table-pounding approval came when Mr Ebanks announced that opening up the Spotts area in the east for occasional cruise visits is being seriously considered.

“We are also going to be looking at how we can enhance the Spotts Dock so that improvements can be done there. In the future, we can actually have ships there on days when there is good weather, so that we can push the ‘Go East Initiative’ to get more tourists to the eastern side of the island.”

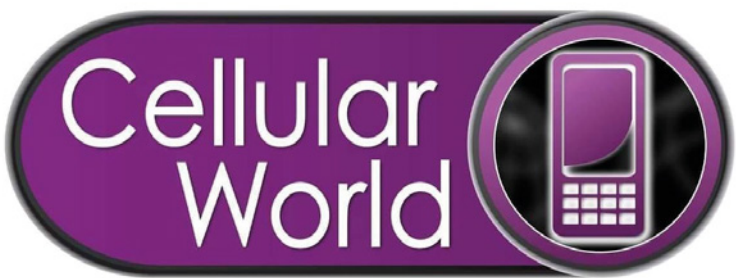

UK AND TERRITORIES WRAP-UP 2024 SUMMIT WITH NEW COMMITMENTS

"That's a wrap! Overseas Territories leaders and Ministers have made clear that we are stronger together, as we tackle illicit finance, challenges of migration, barriers to biodiversity, and more."

That declaration by UK Foreign Secretary Yvette Cooper at the end of the 2025 Joint Ministerial Council(JMC) summed up the relationship between the UK and its Overseas Territories.

Phrased in diplomatic language, the communique at the end of the three-day annual London session (November 24th to 24th) cut through elements of friction between the UK and some OTs over several issues, including constitutional reform.

"NOTHING ABOUT YOU WITHOUT YOU"

Underlined by a principle of "nothing about you without you", the UK pledged

to a "Partnership with the Overseas Territories based on mutual respect and inclusion, applying to all UK Government departments - rights come with responsibilities, including the responsibility to uphold our common values."

Emphasising good governance and ensuring proper democratic accountability and regulation, the document also speaks of "defending the Overseas Territories' security, autonomy and rights, including the right of self-determination".

A NEW 'PARTNERSHIP COMPACT'

Another key outcome from this year's JMC is the joint commitment to develop what have been referred to as "Partnership Compacts between the UK and any Territory that wishes to". A new construct, these Partnership Compacts are intended to provide tailored, practical frameworks for advancing shared priorities and to

signal a renewed commitment to partnership.

Also noted is the development of a UK Government Charter on Engagement with the Overseas Territories, "which seeks to reinvigorate and strengthen how the UK Government engages with the Territories."

'PARBO' LAW

While territory-specific issues are addressed, much of the attention falls on the UK's insistence on the OTs to enact the law on public access to registers of beneficial ownership of companies(PARBO), which the UK is threatening to impose by decree.

It refers to steps already taken by individual territories to enact the relevant legislation locally. The Cayman Islands, St Helena, the Falkland Islands and the Turks and Caicos Islands are listed as having processes in place and working to a timeline for completion.

Regarding Cayman specifically: "We welcome the introduction of legitimate interest access to existing registers of beneficial ownership by the Cayman Islands in February 2025...and note Cayman Islands' June 2025 commitment to further improve user access." Cayman is also listed among the OTs "to hold further technical discussions starting in the coming weeks to ensure that we deliver the maximum possible degree of access and transparency whilst protecting the right to privacy in line with respective constitutions."

HEALTH, PENSIONS AND EDUCATION

A recurring theme at the annual JMC in recent years has been access to the UK's National Health Service(NHS), which has been restricted to a quota. OT governments have been lobbying to get that re-

moved or expanded. However, it's clear from the communique that not much, if any, headway has been made in that regard except for emergency care, jobs and training.

On the other hand, there is encouraging movement on full access to UK pensions by all OT/British citizens retiring in the islands. The UK has now committed to expanding that to islands not previously included, although a timeline has not been indicated.

A request for financial support for OT students in the UK did not make any traction with the British government, only saying. "We note the Territories' continued request that Overseas Territories students attending university in the UK are eligible for maintenance loans with the understanding that policy for maintenance loans outside England is a devolved matter."

ACTION ON ENVIRONMENT

A welcome development was recorded on protecting the territories' unique biodiversity system - the UK's largest - along with climate change issues and disaster mitigation. Overseas Territories Minister Stephen Doughty announced a new Climate Finance Support Programme.

Alongside the publication of the UK Overseas Territories Biodiversity Strategy, he said, "This marks the beginning of a new journey towards improvements in policy, legislation, support, collaboration and engagement, for the benefit of our flora and fauna, habitats and ecosystems."

TRADE AND AID

For territories receiving UK aid such as Montserrat in the Caribbean, the UK said it "remains committed to meeting the reasonable needs of Territories where financial self-sufficiency is not possible. The Overseas Territories continue to have the first call on the UK's aid budget to facilitate sustainable economic growth and development."

With trade between the OTs and the UK valued at around US\$22 billion annually, including tariff-free access for exporting to the UK, the British government said it is committed to expanding this relationship through deeper engagement and economic cooperation.

DEFENCE AND SECURITY

The UK also offers the reassurance of "defending the Overseas Territories' security, autonomy and rights, including the right of self-determination". This is seen as particularly timely for the Caribbean OTs at a time of increased military tension in the region led by the US Trump administration in a bellicose stand-off with Venezuela. It also extends to the wider global unease, especially with the UK's support for Ukraine, in its ongoing war with Russia. Cayman and other Overseas Territories are acknowledged for their role in imposing UK sanctions on Russia.

"We recognise that the Overseas Territories have frozen assets worth well over US\$11bn," the communique noted.

tunity to be the first in line to enjoy discounts and deals on merchandise in the run-up to Christmas.

However, since the restrictions imposed by Covid-19, store managers have learnt many valuable lessons about crowd control that have served them well in making this time of year less calamitous and more accessible to all - without the usual chaotic rush Black Friday has come to be known for around the world.

The event at Cost-U-Less was well attended, orderly in nature and easy for shoppers to manage.

General Manager of Cost-U-Less, Mary Reynolds explained how the store was able to make the occasion so seamless for customers and staff:

"After Covid everyone kind of changed their strategy. We've extended the sales to 11 days, which spreads out the time rather than it being condensed into one day. What that does is give everyone an opportunity to get to the store.

"Folks can take their time and come after work rather than having only one chance and if they miss that, then that's it."

Mrs Reynolds noted that spreading out the time that customers have to make it to the store and lengthening the window for specials was not a disadvantage for the business.

"The shopping has been good this year. Lots of people are buying things to send to Jamaica. That's a different dynamic than the usual and people have been responding to that."

According to Cost-U-Less management the store had to be restocked over the course of the promotion and sales leading up to Black Friday but they were ready for the influx of shoppers.

"It's hard to know what to expect regarding what people will buy and every year there are surprise items that perform well, alongside the products that are always crowd favourites," noted Mrs Reynolds.

"Sometime we don't know what the 'hot' item will be.

"For instance, this year there was a little karaoke machine that flew off the shelves," she chuckled, adding that the Nike slides (slippers) had been a favourite as expected," she remarked.

Staff at the wholesaler echoed the sentiments of the management team with cashiers expressing gratitude for the strategies implemented to curtail the frantic rush of previous years.

"We are very thankful. The strategy managers have put in place have been very effective. It's a fun event and everyone can have a good time. It's something we can look forward to every year," observed cashier.

Customers also chimed in and explained

how Black Friday had changed.

"It's not like it used to be. The push is not the same for people to try to get into the supermarket first. So it's much better," said a shopper who explained she was there to buy a tent and other supplies to

send to Jamaica.

Deals included specials on a variety of items including shoes, appliances and cleaning supplies, with the first 50 shoppers also receiving a 40 bottle case of water.

Containment Efforts Continue Following H5N1 Avian Flu Detection

Government teams continued coordinated containment and monitoring activities on Sunday 30 November, following the confirmed detection of H5N1 Avian Influenza in a limited number of birds at a farm in West Bay. Samples collected from various birds on the farm tested positive for H5N1. All remaining poultry at the site have been removed, and all carcasses are being managed and disposed of in accordance with established public and animal health protocols.

Routine surveillance and sampling continued today across farms and nearby areas, including checks by the Department

of Agriculture. Teams are also responding to reports received from the public as part of standard monitoring procedures. These checks do not indicate any additional confirmed sites at this time.

Out of an abundance of caution, additional sanitisation measures in some areas of West Bay. These steps are purely preventative and do not indicate a positive case at these locations. Vehicles and footwear are being disinfected before exiting the area in order to reduce the risk of spread. Members of the public are asked to follow all instructions at these points and to allow extra time if travelling through the area.

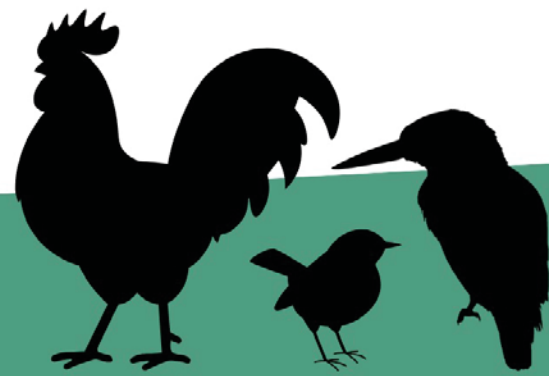

in initial response work have been tested and all results to date have been negative. The overall risk to the general public remains low.

Mosquito control operations stepped up in Little Cayman

In response to the increased need for mosquito control, teams will now travel to Little Cayman each Friday to carry out enhanced treatments and respond to service requests.

The Mosquito Research and Control Unit (MRCU) is increasing operations in Little Cayman following reports of higher mosquito activity on the island.

MRCU teams are in Little Cayman today conducting service requests, swamp inspections and thermal fogging. In response to the increased need for mosquito control, teams will now travel to Little Cayman each Friday to carry out enhanced treatments and respond to service requests.

A service request is when a resident contacts MRCU to report increased mosquito biting or mosquito larvae. To make a service request, simply send an email to mrcu@gov.ky.

Port Authority of the Cayman Islands Receives New Purpose-Built Maritime Cargo Crane

The Ministry of Planning, Lands, Agriculture, Housing & Infrastructure (MPLAHI), together with the Port Authority of the Cayman Islands (PACI), announces the arrival of a new purpose-built maritime cargo crane — a significant advancement in the ongoing modernisation of the Cayman Islands' cargo operations. Delivered on Saturday, 29 November 2025, the crane represents a strategic national investment designed to enhance safety, accelerate cargo movement, and strengthen the Islands' supply chain.

This multi-million-dollar investment was manufactured by **Konecranes**, a global leader in lifting equipment with more than a century of engineering expertise. Konecranes is recognised worldwide for its commitment to safety, innovation, and sustainability — developing energy-efficient, environmentally responsible equipment engineered for long-term reliability.

The Port Authority has purchased a **Konecranes Gottwald harbour crane**, shipped to the Cayman Islands from the Port of Antwerp in Belgium. The company supports major ports across the globe with advanced technology and lifecycle maintenance solutions tailored to maritime cargo environments.

Healthy Eating and Exercises to Reduce the Risk of Dementia



A diet high in fresh fruit and vegetables, wholegrains, pulses, fish, nuts, seeds, oils such as olive oil and exercises such as walking, swimming, cycling and lifting weights have positive effects on the brain.

Overview

Dementia, including Alzheimer's disease is a major and growing health concern all over the world. Most of our lives are touched by it and many of us will have family members, relatives, friends or acquaintances who are affected.

The World Health Organisation defines dementia as a term for several diseases that affects memory, thinking and the ability to perform daily activities. The National Health Service UK, describes dementia as a syndrome (a group of related symptoms) associated with an ongoing decline of brain functioning.

The World Dementia Council noted that over the next few decades, the growth in the number of people with dementia in Latin America and the Caribbean (LAC) is projected to be higher than the growth of dementia cases in high-income countries.

Globally, the World Health Organisation (WHO) estimates that there are 50 million people living with dementia and by 2050, there will be 135 million. Meanwhile, in the UK, according to the Alzheimer's Society,

approximately 982,000 people are living with dementia, a figure set to rise to 1.4 million by 2040.

What causes dementia?

Several genes have been linked to an increased risk of dementia. Other factors such as environment and lifestyle choices play a major role in the risk of dementia.

In 2024, the Lancet Commission on dementia, identified 14 modifiable risk factors, many which link directly to diet and exercise. They include high blood pressure, high cholesterol, obesity, diabetes and physical inactivity.

According to the National Health Service (NHS), a diet that is high in saturated fat, sugar, salt and low in fibre can increase your risk of high blood pressure, high cholesterol, becoming overweight or obese and type 2 diabetes.

WHO noted that dementia may develop after a stroke or in relation to certain infections such as HIV, as a result of harmful use of alcohol, repetitive physical injuries to the brain or nutritional deficiencies.

Research reflects that eating a nutritious and balanced diet and physical activity play an integral role in reducing the risk of dementia. The World Health Organisation (WHO) and other experts recommend that regular physical activity can significantly lower the risk of dementia by improving blood flow to the brain, helping blood vessels to function better and slowing age related cognitive decline.

TYPES OF DEMENTIA

The British Dietetic Association noted that there are various forms of dementia with the four primary types being Alzheimer's disease, vascular dementia, frontotemporal dementia and dementia with Lewy bodies.

DIET AND REDUCING THE RISK OF DEMENTIA

The Alzheimer's Society UK recommends eating a nutritious and balanced diet that

includes:

- Fruits, vegetables, pulses – for (example leafy greens, berries, beans, peas and lentils), nuts and seeds.
- Include wholegrain starchy foods in most meals – for example wholemeal bread, quinoa, oats and brown rice.
- Eat less red and processed meats – for example lamb, beef, sausages and bacon.
- Choose lower fat dairy foods where possible.
- Eat fish regularly- particularly oily types like salmon, herrings and sardines.
- Limit the amount of salt in your diet – try not to eat more than 6g (about a teaspoon) a day.
- Use plant and vegetable oils for cooking and dressing – for example olive oil and rapeseed oil. Try to avoid solid fats like butter, lard and ghee.
- Try to make sugary foods only occasional treats – such as pastries, sweets biscuits and cakes.
- Consume alcohol in moderation.

Nutritionist Tips:

- Eat the Rainbow, which involves consuming a wide variety of fruits and vegetables of different colours to get a broad spectrum of vitamins, minerals and antioxidants essential to good health.
- Reduce salt and use herbs and spices to increase flavours. Herbs can be used fresh or dried example thyme, sage and basil. Spices such as coriander seeds, turmeric, black pepper, cumin and paprika could be added to stews.
- Stay hydrated with water instead of sugary drinks.
- Increase your fibre intake by adding pulses like beans, lentils or chickpeas to stews, curries and salads.

EXERCISES: WALK, SWIM, RUN, CYCLE AND LIFT WEIGHTS

The World Health Organisation recommends a combination of cardiac exercise and strength and balance training. Terry Quinn, Professor in Cardiovascular Ageing

and chair of Geriatric Medicine at the University of Glasgow asserted that when we engage in cardio exercise (eg swimming, running and cycling) we are strengthening our hearts by making them pump harder, lowering our resting heart rate and improving our blood pressure.

The National Health Service UK suggests that individuals should do strength activities that work all the major muscle groups (legs, hips, back, abdomen, chest, shoulders and arms) on at least 2 days a week. It was also recommended at least 150 minutes of moderate intensity exercise or 75 minutes of vigorous intensity per week which could include brisk walking, water aerobics, cycling, dancing, hiking, skipping or running and group sports.

Stuart Gray, a Professor of Muscle and Metabolic Health at the University of Glasgow suggests that 'muscle releases several different factors which when reaches the brain can help with making new ones and neuron connection.' He further noted that stimulation occurs when we exercise, which is instrumental in reducing inflammation and oxidative stress and improving brain health.

Terry Quinn, professor in Cardiovascular Ageing, recommends engaging in any form of resistance training which includes carrying a load such as weight lifting, pilates, chair based strength circuits and carrying heavy shopping bags.

The Alzheimers Society (UK) highlighted the benefits of physical activity in reducing the risk of dementia. Research indicates that people who take regular exercise may be up to 20% less likely to develop dementia than those who don't take regular exercise. The results were derived from analysis that combined the results of 58 studies into exercise and dementia.

Nutritionist Tip: Importantly, start exercising and be consistent. If you have a medical condition or have not exercised for some time, speak to your doctor.

REEVES BETWEEN A ROCK AND A HARD PLACE ON UK BUDGET

Days after presenting the UK's annual Budget Autumn Statement, the main budget address - the other being an update in the Spring - Chancellor of the Exchequer (Minister of Finance) Rachel Reeves is facing mounting calls to resign. Her critics claim that she had lied about the state of the economy in order to justify raising taxes and increasing welfare spending.

This refers to a report suggesting that the UK's Office for Budget Responsibility (OBR) had advised the government in September that the black hole of deficit inherited by the Labour Party government, which took office last year, had been considerably reduced during that period.

But now her critics, led by the main opposition Conservative Party and other political groups, along with several professional organisations, are calling for her to quit or be fired, saying that she misled the country.

However, Chancellor Reeves is sticking to her guns, stating on a main BBC Sunday television news and current affairs programme: "I know that some people are suggesting that there was a small surplus that the OBR published on Friday...But if I was on this programme today and I was saying £4bn surplus is fine, there was no economic repair job to be done, I think you would rightly be saying that's not good enough."

But the leader of the main opposition Conservative Party, Kemi Badenoch, speaking on the same programme, insisted that the Chancellor lied and must go. "The Chancellor called an emergency press conference, telling everyone about how terrible the state of the finances were, and now we have seen that the OBR had told her the complete opposite. Because of that, I believe she should resign."

The influential Institute for Fiscal Responsibility (IFR) said in its assessment of the budget: "Ensuring greater headroom is sensible, though uncertainty over future

revenue could throw Reeves off course. The welcome news from the budget was that Rachel Reeves has increased her headroom against her fiscal rules. Even

relatively small changes to the economic outlook could throw her plans off course."

The Labour Party convincingly won the 2024 election mainly on a mandate be-

cause the Conservatives, which had been in power for the previous 14 years, had mismanaged the economy and government finances, leaving a massive deficit.

Among the budget measures which have triggered strong critical reactions are an increase in inheritance tax on high-value properties, additional rates on property income, savings and dividend income, a new levy on the previously untaxed zero-emission cars and electric vehicles, as well as changes to the threshold for salary-sacrificed pension contributions.

Some taxes are being frozen for the rest of the parliament, or time to come into force gradually during that period. The government's welfare bill is due to rise, especially with the removal of the restriction limiting welfare payments to two children of unemployed or lower-paid workers.

The UK's Gross Domestic Product (GDP) is forecast to grow by 1.4 per cent in 2026, down from a previously anticipated 1.9 per cent, then levelling out at 1.5 per cent for the rest of the decade. Inflation is projected to be 3.5 per cent this year and 2.5 per cent in 2026.

ICCI Students Explore the Future of Cryptography at Cayman Enterprise City Talk

The International College of the Cayman Islands (ICCI) recently took a group of Information Technology students to Cayman Enterprise City (CEC) for a special lecture led by renowned applied cryptographer Mario Yaksetig founder of BitFashioned SEZC (Special Economic Zone Company). The event, organised and supervised by ICCI IT Instructor Christopher Balraj, forms part of the College's continued work to provide students meaningful exposure to real industry environments and emerging technologies.

Yaksetig, known internationally for his contributions to advanced cryptographic systems, walked students through the rapidly evolving landscape of cybersecurity, decentralised technologies, and post-quantum cryptography. His work spans the design and analysis of cryptographic protocols, including pioneering "quantum-secure fallbacks", an approach that allows quantum-resistant keys to be embedded within standard elliptic curve key pairs.

"Understanding cryptography is essential for anyone entering the crypto space," said Yaksetig. "These principles underpin everything from messaging apps like WhatsApp to blockchain and even AI. Giving students front-row exposure to evolving systems ensures Cayman's talent is ready for the challenges and opportunities of tomorrow's digital economy."

His academic background includes studying under Professor Alan Sherman, a notable student of Turing Award winner Ron Rivest, one of the creators of RSA encryption. Yaksetig's research has been referenced by blockchain visionary Vitalik Buterin, and he has co-authored publications with Bart Preneel, whose work includes one of the hash functions used in Bitcoin. His professional collaborations include projects with cryptography pioneer David Chaum and author Neal Stephen-

son, who coined the term metaverse.

Yaksetig's research in blockchain and cryptography has been funded by major foundations such as Algorand, Chainlink, Worldcoin, Sei, Dfinity (ICP), Polygon, and Starknet, reinforcing his influence in shaping secure digital systems across the industry.

ICCI Instructor Christopher Balraj emphasised the significance of exposing students to experts working at the forefront of innovation.

"Bringing students to talks like this allows them to connect academic theory with real-world applications," Balraj said. "Cryptography is at the heart of modern security and blockchain development, and hearing directly from someone who is shaping the field gives our students invaluable perspective."
