At the appropriate time in the future, further public statements will be made.

# TIME TO TURN THE TIDE ON PROTECTING SEVEN MILE BEACH

“Therefore, everyone who hears these words of mine and puts them into practice is like a wise man who built his house on the rock... But everyone who hears these words of mine and does not put them into practice is like a foolish man who built his house on sand.”

Cayman now faces an environmental

and economic disaster of significant proportions at Seven Mile Beach, where literal building on sand has been permitted—even in the face of clear biblical warning and technical advice.

As ominous as that warning is, and despite an acknowledgement of the seriousness of the situation, the manner in which

it's being dealt with is tantamount to throwing pebbles in the water to reclaim the land ...and the sand.

Caymanian Times highlighted the relentless erosion of Seven Mile Beach in a series of articles in 2023. Since then, the problem, devoid of any decisive action, has only gotten worse and the solution more expensive.

We are re-running these articles as a reminder that we are 'not out of the water' as far as resolving this admittedly crisis-level issue is concerned. In fact, we might be further in the water, realistically speaking, judging from what came out of (or did not) come out of the recent Finance Committee meeting.

Tourism Minister Gary Ruddy made only a passing reference to a plan for a much-talked-about beach replenishment scheme, which has spanned several governments.

"I applaud this government for its efforts to protect the southern end of Seven Mile Beach, where erosion has reached a critical stage. Inaction posed a serious threat to our environment, our tourism industry, and our reputation as a premier destination. The replenishment plan approved by Cabinet will prevent further damage to our best-known tourist attraction and preserve it for future generations to enjoy."

A later exchange between the Opposition leader, Joey Hew, quizzing Environment Minister Katherine Ebanks-Wilks, did not create much wave either, with uncertainty remaining over exactly how the beach replenishment scheme will be funded and a timeline for action.

### Feb 2023: SEVEN MILES BUT LESS BEACH

#### SEVEN MILE BEACH: TIME TO CHANGE THE GAME?

From West Bay to Jackson Point might measure seven miles as the crow flies...or as the boat sails across the bay. Just don't tell that to Seven Miles Beach.

Seven miles it isn't, and as far as the alluring stretch of award-winning beach goes, seven miles it never was.

Even the tourism brochures in their eye-catching promotions alternate be-



tween 5.5 and 6.3 miles of unparalleled tropical bliss.

But take warning. We are at serious risk of further depleting - if not destroying - this piece of paradise.

It will be a sad price to pay, the consequence of an almost unrestricted rush to development at the sacrifice of the environment - our greatest asset.

At the rate we are going, we'll soon not be able to count many footsteps in the sands of our already (less than)Seven Mile Beach.

So, how did we get here, and where do we go from here?

Seven Mile Beach is somewhat of a misnomer as the strip as we know it was never seven uninterrupted miles of pristine beach.

Historically, the area has been part ironshore, small coves and inlets but with the stretch of beach the main feature.

Ideal for beachfront development, we learnt that over the years a process of 'who came first got the best beach spots' as can be seen from the parade of properties and

their built timeline along the shoreline.

Previous ironshore areas have even been incorporated into development projects for the high-value claim of seafront vistas - if not necessarily direct beach access. After all, the beach might have only been a matter of a few minutes walk away.

It has now reached the point where property owners, business owners and developers hardly have any alternative but to resort to further manmade incursions onto the beach and into the sea to protect their investment.

But over time, sheer over-development driven by high demand, coupled with the natural ebb and flow of the tides, has resulted in Cayman's most highly-prized possession being put at serious risk.

One factor is climate change which could be a game-changer for low-lying Cayman.

But while we may be on the frontline of threats, that actually presents us with the opportunity to be in the front seat of solutions.

We accept that it's a delicate balance between development and the environment;

however, the evidence clearly shows where we need to prioritise and 'invest' our policies.

Numerous studies, reports and recommendations point this out.

One of them, a 2011 report by the Cayman Islands National Climate Change Committee, clearly warned: "Pressure from coastal development, economic dependence of the tourism industry on Seven Mile Beach, rapid population growth and insurability issues for development place additional pressures on the coastal environment."

The clock is ticking ominously.

Is it time for a moratorium on any further beachside development along Seven Mile Beach? Is it time to call time while there's just enough time and scope for corrective action?

Or, considering the issues highlighted in the recent Finance Committee hearings, is it time for both government and beachfront businesses and homeowners to finally collectively put their money where their mouth is?



# Award-winning author launches new kids' book






Hilary Lawrence is a Cayman-based author of much-loved children's books such as *Loose Lips Sink Ships* and *The Grass May Not Be Greener* and she has just released her fourth book, *The Fear of the Unknown Is the Greatest Fear of All*, just in time for Christmas.

Ms Lawrence said the inspiration for her books came from her family.

"When my girls were young, we always read together before bed, and they especially loved rhyming picture books, which always held their attention and sparked so much joy," she said. "After story time, we'd often make up silly rhymes about their day, the animals in the books, or our favourite morals. We would end up in fits of laughter."

Over time, she began jotting down some of those ideas, hoping to develop them further when she had more time.

"People often say, 'Do what brings you joy,' and for me, that joy comes from writing poetry. It has been a real pleasure — and a privilege — to take the whimsical rhymes I once shared with my daughters and shape them into poems for others to

enjoy," she advised.

Each book has a clear message for youngsters.

"Becoming a parent made me realise how important it is to have a strong sense of direction — a clear 'north' — and how vital good morals and values are, especially in a world overwhelmed by social media noise, biased news, and hidden agendas," Ms Lawrence said. "A strong moral compass is more essential than ever. Morals serve as gentle reminders of truths we already know but sometimes forget. Simple sayings like 'The grass may not be greener' teach us not to compare ourselves to others — something that, for a child, might be as small as thinking a friend's lunchbox looks more delicious than their own. These simple phrases carry timeless wisdom that guides our choices and helps us stay focused on what truly matters."

Ms Lawrence said she wanted to keep this wisdom alive.

"I write each story in a fun, relatable, and easy-to-understand way, blending my love of rhyme with my love of proverbs and idioms," she said.

One of her books, in particular, was directly inspired by Cayman.

"We've always loved the Cayman Islands and visited many times on holiday before deciding to make the island our home. On one of those trips, we happened to be here during Pirates' Week, and we were fascinated by the local legend that Blackbeard's treasure may be hidden in the caves at Treasure Pit on Cayman Brac," she said.

At the time, she was working on *Loose Lips Sink Ships*, an idiom first popularised during World War II on propaganda posters warning about the dangers of careless talk, often illustrated with a sinking ship.

"I wanted to bring that nautical spirit into my story and create a tale full of fun, adventure, and a hint of swashbuckling mischief," she explained.

## Charities benefit

All profits from the books go directly to charity, including KidsOR, which focuses on safe surgery for children, founded by friends of Ms Lawrence, Gareth and Nicola Wood. The books also support another charity close to her heart, The Reading Clinic, which helps children with dyslexia and other learning differences.

Since the books were launched a year and a half ago, they have been recognised

with several awards, including the Literary Global Children's Book Award, the International Book Award, the Golden Wizard Book Award, the BRAG Award, the Mom's Choice Award, the IAN Book Awards, and the Literary Titan Award.

The latest book, *The Fear of the Unknown Is the Greatest Fear of All*, is being released in December.

"I wrote it around the idea that we often feel most afraid when we don't know what will happen next. I wanted to help children understand that new experiences usually seem far scarier in our imaginations than they truly are once we find the courage to try them," Ms Lawrence advised. "The story is set in the jungle, where a lion, out on his morning stroll, discovers a deep, dark hole with a mysterious, rather mean-looking creature lurking inside. Puzzled and slightly unnerved, he calls on his jungle friends to help him solve the mystery: Who is the animal in the hole, and why won't it come out?"

The series is available in Cayman at Next Chapter, Book Nook, and several hotel boutiques, including the Kimpton. They can also be purchased on Amazon and shipped to the island.



## Marathon tops its stats again

The sporting community comes together this weekend for the 2025 Walkers Cayman Islands Marathon which is set to break its record again for mass participation.

It is on Sunday, 7 December, starting at 4:30am on Seafarers Way. At the start of the week, organisers confirmed 115 full marathoners, 1,050 half marathon entrants and 95 teams entered for the relay. In addition, about 100 persons are expected to sign up the day before the race. There are also around 300 visitors to the island between race participants and their

families and supporters. Overall, it's likely to be the best ever.

With registration numbers tracking strong again this year, organisers are asking for the public's support and cooperation with this event which raises funds for the Cayman Islands Cadet Corps and the Cancer Society as well as other organisations such as Jasmine, Crisis Centre, CCMI, Alex Panton Foundation, NCVO, Lighthouse School and Red Cross.

The race starts on Seafarers Way in front of Bayshore Mall and goes through South Church Street, South Sound and

Prospect Point Road, after which runners turn around and go back through South Sound and then onto Walkers and Hospital Roads, Elgin Avenue, Edward and Fort Streets and back to Bayshore Mall.

Late registration for new sign-ups and packet pick up for registered participants are at the race's new official packet pick location, Governors Village, on Saturday, 6 December between 9am and 5pm. This is also an opportunity for participants to ask the race directors any questions about race day.

The Kids Fun Run, sponsored by MILO along with Cimboco and Chicken! Chicken! will start at 10:30am at the Government Administration Building on Elgin Avenue and end at the adult start/finish line in front of Bayshore Mall. It is free for children aged between 5-11 and 200 kids are already registered.

The level of corporate support for the event continues to grow each year as companies and organisations such as PricewaterhouseCoopers, KPMG, Ogier, Ernst & Young, Health City Cayman Islands, Maples and Deloitte pay for staff to participate.

The top male and female full marathon winners will receive Breitling timepieces courtesy of Kirk Freeport as part of their prize. There are lots of other prizes in different categories.

Volunteers are competing too as the popular Cayman Airways Water Stop Challenge is on again. The most enthusiastic, encouraging, entertaining water stop, as voted for by the participants, will win free airline tickets courtesy of the national airline.

"This year's registration figures point to continued growth, even as the race enters its 23rd year," said Co-Race Director Rhonda Kelly of Kelly Holding Ltd., owner and organiser of the event.

Caymanian Cynthia Hew is back for the half marathon after several years of low mileage due to injuries and is thrilled to return for the half marathon.

For four years, Charlotte Dahan, Madison Black and Isabella Fantasia have run the Cayman half marathon together for the Red Cross. They turned their friendship into something bigger than the race itself. Now all aged 17, this event marks the girls' final run before college sends them in different directions.

Sandra Dixon will be participating in her third Cayman Islands Marathon but this year after completing two half marathons, she's taking on the full distance for the first time. Her mission is simple: to finish the race.

Surena King from Maryland is running the Walkers Cayman Islands Half Marathon in memory of her beloved sister, Terveer.

Sharon Davies (CAY) had both hips replaced 10 years ago and then walked her first half marathon and continued on to do several more. Last November she had both knees replaced, and now she's back in training, aiming to finish the half marathon.

For Danryl Franz Sarmiento (CAY), this year marks his final Cayman Islands Marathon as he prepares to leave the island to pursue a new opportunity.

# Deverine Bell Anderson Remembered: A Life of Faith, Style, and Joy

The Cayman Islands lost one of its brightest personalities with the passing



of Deverine Bell Anderson (Sunrise October 6, 1955 – Sunset November 18, 2025), more recently known as Deverine Anderson. She is remembered for her radiant smile, impeccable style, unwavering faith, and the joy she brought to everyone she encountered.

Her memorial service was held Saturday at First Assembly of God, led by Reverend Torrence Bobb, where tributes poured in

from family, friends, and colleagues. The closing hymn, “Oh I Want to See Him,” captured the spirit of the day — a celebration of a woman who lived with her eyes fixed on eternity.

Deverine’s story began in Jamaica, where St. Thomas was her home. She attended Morant Bay School and began her career as a teacher at Morant Bay Primary.

But her creativity and sense of fashion and style soon led her in a different direction. Moving to Montego Bay, she opened her own business, Pazuki Fashions, and quickly became known not simply as a seamstress

but as a sought after fashion designer. Her work was admired for its elegance and originality, and she carried that flair for style with her throughout her life.

In 1994, she moved to the Cayman Islands, first working at Edie’s Décor. She met Thomas Anderson, and two years later, in 1996, they were married in Cayman. Together they raised two children: her daughter, Ophelia Wright, and her

son, Dwayne Hariott. Cayman was also her home — the place where she built her career, nurtured friendships, and lived out her faith.

Her daughter Ophelia described her mother as her “Rock”:

“My mom – a phenomenal woman – affectionately saved in my phone contacts as my Rock – with a lot of hearts! She was my mom, my confidant, my best friend, my advisor for fashions, makeup, perfumes and life.... She prayed for me and with me through every challenge, and she celebrated all my successes as her own. It feels so surreal talking about her in the past tense, because I feel her with me every single day... She is truly in a better place (humorously) giving God ideas for Angel attire.”

Faith was the thread that ran through every part of Deverine’s life. She was deeply involved in her church community, remembered for her kindness and her boldness. Joan Johnson, speaking on behalf of her Life Group, recalled:

“I will never forget her gentle kindness and gentle care she extended to my family and me... I admired her boldness and the way she carried herself – she always remembered who she was, and more im-

portantly, whose she was.

Her flair for fashion was more than personal style — it was a gift she shared with others. As a designer, she helped people feel radiant, and as a believer, she reminded them of their worth in Christ. Pastor Bobb titled his message A Life Well Spent: “She was a great ambassador for Christ and for our church. Everyone spoke highly of her. She left a legacy, and let that legacy encourage each one of us.”

Her contributions stretched far beyond Sunday services. She helped organize the Singing Christmas Tree for a decade, supported International Day celebrations, and people lined up at Deverines’ and even turned car boot sales into fundraisers for the church — always giving back whatever she earned.

Professionally, Deverine was equally admired. Many first knew her during her years at Cayman Net News under Desmond Seales OBE, where she worked in advertising sales. She was a steady presence during the island’s recovery from Hurricane Ivan in 2004, her smile and positivity lifting spirits in difficult times.

For the past 12 years, she was a valued member of the Stingray Media sales team, where she became known not just for her skill, but for her warmth and encouragement.

Her colleague Chandra Guillifoyle remembered:

“We weren’t just colleagues or friends, we were family. Mrs. D was the Mama Bear of the office, looking out for us and always rooting for everyone. She never spoke badly of anyone... she saw the positive in everything and lived life to the fullest.”

Shavana Baxter recalled her first meeting with Deverine in 2019:

“From the beginning she took me under her wing and showed me the ropes... People’s faces would light up the moment they saw her. Not a single day passed without me hearing her worshipping and praising God.”

From Blake Rogers, General Manager of Stingray Media:

“Losing Deverine so suddenly has been heartbreaking for all of us at Stingray Media. She was more than a colleague—she was a friend, a steady presence, and someone who uplifted everyone around her. We will forever be grateful for the time we shared with her and will always cherish the lasting memories we each have of her.”

From Michael Keese, General Sales Manager:

“Deverine was a blessing to work with. She cared deeply for her Stingray family, and we cared for her too. Anyone who spent time with her saw how committed she was to her clients and how proud she was of their success. It was truly an honor to work alongside her.”

Deverine Bell Anderson lived with grace, faith, and joy. She was a mother,



wife, friend, colleague, mentor, and designer. She dressed impeccably, laughed freely, prayed deeply, and gave generously. She was bold yet gentle, stylish yet humble, and always ready to encourage others.

Her passing is a loss for Cayman, but her legacy is one of celebration. She leaves behind her husband Thomas, her children Ophelia and Dwayne, her family and church community, her Stingray Media

colleagues, and countless clients who benefited from her dedication.

Deverine has indeed “gone to a better place”—and those who knew her can picture her now, radiant as ever, and maybe — just Ophelia said - giving God ideas for angel attire.

## THE CARIBBEAN COST OF US-VENEZUELA STAND-OFF

With the peak winter tourist season beginning, caution prevails in the Caribbean, especially the southern islands, as uncertainty surrounds an American military build-up in the region amid an ongoing stand-off with Venezuela.

The southern Caribbean islands which increasingly depend on tourism, some more than traditional agriculture, are reportedly nervous following recent US actions. These actions involved high-seas targeting of alleged narco-speedboats from Venezuela.

The US Trump administration has embarked on a controversial 'shoot-to-kill' policy in which several vessels and their occupants were blown up.

The situation has become even more tense with the installation of American surveillance equipment on tourism-dependent Tobago and the recent American military exercises with local personnel on the main sister island, Trinidad. A similar request to Grenada is still be-



ing reviewed by that government.

Tourism businesses in Tobago are reporting that bookings are down from what they were hoping would have been a bumper winter tourist season. Several cruise ship calls are also said to have already been cancelled.

The Trinidad & Tobago Prime Minister Kamla Persad-Bissessar, who had earlier stated that the US presence in Tobago was to assist with improving road infrastructure, now admits that it was for the installation of hi-tech radar surveillance equipment. But she maintains that it bolsters her country's security.

The Prime Minister has repeatedly voiced support for the actions by the US forces against the alleged Venezuelan narco-traffickers.

Elsewhere, there are reports from other islands of fishermen restricting their fishing trips and being reluctant to venture too far from shore.

The American president has also unilaterally declared the Venezuelan airspace a no-fly zone as he continues to apply pressure on the country's hardline leader, Nicolas Maduro, declaring that the president of the South American country is himself facilitating drug trafficking.

With the risk of the stand-off escalating, there is added concern about what this could mean for regional and global trade, with major sea lanes traversing the Caribbean Sea.

Also close to the Venezuelan coast in the Caribbean Sea are the Dutch ABC Islands

of Aruba, Bonaire, and Curacao, the location of one of the US Forward Operating Locations (FOL) in the region.

The islands have longstanding trading ties with Venezuela, with boats from the South American country traditionally plying the islands with fruits and vegetables.

The Dutch government, which maintains military bases in Curacao and Aruba, is said to be monitoring the situation very closely, both locally and as part of its European Union (EU) mandate.

Reservations have been expressed by top Dutch military officials about the real objectives of the US mission in the area. "More military power than needed for drug enforcement," said Onno Eichelsheim, Commander of the Dutch Armed Forces, while acknowledging that concerns in the ABC islands were understandable.

Ever since the rapid 'explosion' of tensions between America and Venezuela, Caribbean leaders - with the exception of their Trinidad and Tobago counterpart - have been appealing for the region to remain a zone of peace.

The stakes are high for the island states in the area individually and collectively in both economic and security terms.

To all intents and purposes, they just happen to be in the wrong geographical location between two belligerents in an issue over which they hardly have any influence or involvement, but could be victims...or collateral damage in military parlance.

**Healthy Lunch:** It is important to plan your lunch ahead of time in order to avoid


turning to a fast food joint or vending machine. Pack your lunch the night before and carry it with you. Try these healthy options:






