## Extended Holiday Hours for Liquor Licence Holders

The Liquor Licensing Boards for Grand Cayman and the Sister Islands have formally agreed on extending operating hours during the holiday season for liquor licence holders across the Cayman Islands.

Both boards have also approved extended hours for New Year's Eve celebrations.

On Grand Cayman, bars, restaurants, and hotels are permitted to sell liquor until 2:45am and play music until 3:00am on the morning of Thursday, 1 January 2026.

Nightclubs will continue to operate within their normal hours as they are permitted to play music up to 4:00am and sell liquor up to 3:45am.

For the Sister Islands, bars, restaurants, and hotels are permitted to sell liquor until 2:50am and play music until 3:00am on the morning of Thursday, 1 January 2025.

## CBC REMINDS PUBLIC OF PROHIBITION ON IMPORTING VEHICLES EIGHT YEARS OR OLDER

The Cayman Islands Customs & Border Control Service (CBC) is reminding importers, brokers, dealers, and members of the public of the existing prohibition on the importation of vehicles eight years or older into the Cayman Islands.

Under the *Customs and Border Control* (*Prohibited Goods*) *Order* (2025 Revision), the importation of any vehicle whose model year is eight years or older is prohibited. As such, any vehicle with model year **2018 or earlier** that arrives in the Cayman Islands **after December 31, 2025** will be classified as a prohibited import. These vehicles will not be granted entry and will be seized by CBC.



#### **General Guidance:**

Any vehicles with model year 2018 or earlier arriving in the Cayman Islands after December 31, 2025 will be subject to seizure upon arrival.

a. Exemptions

- Vehicles purchased in time to arrive in the Cayman Islands before the end of the year are eligible for import and are exempt from the prohibition.
- Importers must prove that the vehicle was purchased in sufficient time to reach the Cayman Islands by December 31,
- Purchases made during the last quarter of 2025 that arrive after the end of the year will not qualify for this exemption.

#### b. Documentation Requirements

Importers must provide the following documents:

• All bill of lading, pro forma invoices, final invoices, vehicle titles, export certifi-


cates proof of payment and any other document that CBC may require pertaining to the vehicle being imported.

• Any additional documentation that may be required by CBC to support communication related to the vehicle purchase

CBC urges all importers to carefully verify shipping and arrival dates to ensure compliance. Importing prohibited vehicles after the deadline may result in the loss of the vehicle and additional costs.

# Landmark Immigration Bill: Immigration (Transition) (Amendment and Validation) Act, 2025 Published



On Friday, 12 December 2025, Parliament passed the Immigration (Transition) (Amendment & Validation) Bill, which has now been Gazetted as the Immigration (Transition) (Amendment and Validation) Act, 2025. This milestone legislation represents the most significant reform to immigration policy, reaffirming the government's commitment to placing Caymanians at the center of the nation's immigration framework.

The Act introduces strengthened legal administrative safeguards, ensuring greater clarity, transparency, and resilience against future challenges. Following extensive debate and the adoption of kev amendments, which were debated during Committee in Parliament, the Immigration (Transition) (Amendment and Validation)

Act, 2025 establishes a modernized system designed to protect the rights of Caymanians while balancing the country's economic and social needs.

Minister of Caymanian Employment & Immigration, Hon. Michael Myles, MP hailed the passage of the Act as "a defining moment for our Islands, and one which was long overdue."

A formal commencement date has not yet been set by Cabinet; however,

commencement is anticipated within the first quarter of 2026. The public will be advised well in advance of the commencement date to ensure that both employers and employees have adequate time to prepare.

# Labour (National Minimum Basic Wage) (Amendment) Order, 2025 Published

The Ministry of Caymanian Employment and Immigration (MCEI) advises the public that the Labour (National Minimum Basic Wage) (Amendment) Order, 2025, which establishes the new national minimum wage, has been published.

The Order introduces the following changes, which will take effect on **1 January 2026**:

Minimum Wage (General) – All employees must be paid a minimum of CI\$8.75 per hour (gross), unless specifically exempted and/or special provisions apply:

Minimum Wage for Service Employees– Service employees who work for a service employer with a registered gratuities scheme that has been formally approved in writing by the Director of the Department of Labour & Pensions (DLP) must be paid at least CI\$6.56 per hour (gross). Importantly, employees are still entitled to keep all gratuities earned, on top of their regular wages.

Household Domestic Employees Living in the Employ-

er's Private Home – For household domestic employees who reside in their employer's private home, no more than 25% of the CI\$8.75 minimum wage may be provided as non-cash benefits (such as accommodation and utilities). This means

that an in-kind contribution of CI\$2.19 per hour may be credited toward the minimum wage for these benefits.

**Employees Paid on Commission** – For employees who earn commission, no more than 25% of CI\$8.75 minimum

wage or CI\$2.19 per hour of earned commission may be applied toward meeting the minimum wage requirement. Applying commission toward minimum wage does not affect the employee's legal entitlement to receive all

commissions earned on top of their regular wages

# CIREBA to provide up to \$5,000 grants to first-time Caymanian Homebuyers

Responding to his call for business leaders to "lean in" with Government on community-building initiatives, CIREBA has spoken with Premier the Hon. André M. Ebanks MP and is moving forward with a proposal to provide grants of up to CI\$5,000.00 to first-time Caymanian homebuyers, to assist with closing costs and related expenses.

Caymanians who qualify for, and receive, Government's stamp-duty waiver for first-time purchases, CIREBA (Cayman Islands Real Estate Brokers Association) will be eligible for the grant. Recipients may use it toward closing costs, property insurance or, where those costs have already been met, essential furnishings for their new home.

The Premier and CIREBA are also engaging the Cayman Islands Bankers Association, to offer reduced commitment fees; and with Cayman Islands Legal Practitioners Association to offer reduced legal fees for closings and conveyancing for first-time Caymanian homebuyers.

The challenges that hard-working Caymanians faced when purchasing their first homes spurred CIREBA to develop the proposal, said CIREBA President Brian Wight.

"As Caymanian-owned brokerages, our members see firsthand the obstacles facing first-time buyers," Mr Wight said. "This fund is our way of leaning in and being part of the solution. We are proud to partner with the Government and other stakeholders to help more Caymanians achieve the dream of owning their first home."

CIREBA's proposal was launched following the Premier's keynote during the Chamber of Commerce's Annual Parliamentary Luncheon on 23 October.

In it he spoke about Sir Vassel's vision for the Cayman Islands, which laid the foundation for our financial services success; and then he challenged the country's business community to work with Government, to achieve continued and even greater heights of success while finding

ways to strengthen the community as a whole.

"At the Chamber of Commerce Annual Parliamentary Luncheon on 23 October, I called upon the business community and individuals to join a call of action, to lean in and to take Cayman to its greater potential. And CIREBA has provided an initial response to that call by moving quickly to help reduce the financial barriers that have kept too many Caymanians from achieving the dream of homeownership," the Premier said today.

"With Government's stamp-duty waiver programme; the soon-to-be reintroduced Government Guaranteed Home Assistance Mortgage Programme; the near-completion of our country's first 10-year housing plan; and private-sector led initiatives like this, Cayman is making swift progress with respect to Broad Outcome 2 on Housing, Infrastructure and Environment, specifically on affordable housing."

In early January 2026 a working group, which will include a member of Hon. Minister Rolston Anglin's Ministry of Finance and Economic Development staff, will be established to finalise CIREBA's programme details. The programme itself is expected to be launched by February 2026.

two other matters 'a mention'.

When, at the end of 2024, we editorialised '2025: A Year of Change Coming For Cayman', we knew that something was afoot. But little could we have forecast the extent and footprint of the change that was on its way.

The outcome of the April 2025 election was a game-changer, and not just for the way it remapped the political landscape. More importantly, one promised policy is already causing seismic shifts throughout the society.

The reinstatement of the Caymanian Protection Law, updated to address the politically, economically, and socially sensitive issue of migration, is a realisation of commitments straight out of the 2025 (and previous) election campaigns demanding that Caymanians get a priority slice of the economic and job opportunities pie.

Running parallel with the preferential access to jobs and opportunities for promotion is the issue of acquiring Caymanian status, a contentious issue for quite some time. The implications of the changes are far-reaching and will define eligibility for Caymanian status and Cayman identity for generations to come.

The label, National Coalition For Caymanians(NCFC), under which the present government functions, is to us more than just a title for a coalition of two parties and two independents. It's a statement of



intent...and the intention is already manifesting itself through the revised and updated Caymanian Protection Law.

But it should not be a blunt instrument. For 2026, we expect to see other wraparound policies supporting this core ideal.

In that vein, reflecting on its coalition formation in 2025, the NCFC will be under close and intense scrutiny as it takes Cayman forward in 2026 and the generational implications, especially of its immigration and other policy agenda.

#### THE REGION

When we look back at 2025, the devastation wrought on Jamaica by late season

Hurricane Melissa, has carved out its own chapter. This disaster is indelibly recorded as not just a milestone event in Jamaica's history, but a case study by meteorological experts for its intensity. Equally, disaster management professionals will be assessing the pre-impact preparation and the ongoing recovery efforts for lessons learnt.

#### THE WORLD

There is no question that the second Donald Trump presidency in the United States is having consequences far beyond the borders of the United States. From trade to conflict arbitration, the Trump

way of doing things has the world's attention for the way it appears eagle-eyed focused on rewriting the rulebooks - and even rewiring global processes.

The effects are already being felt not just as ripples but for their tsunami level impact.

For America, the Trump administration, and the world, 2026 will be decisive...especially with the US midterm elections pending.

## NOW, THE REAL 'WORC' STARTS

The single issue of amending the Immigration (Transition) (Amendment and Validation) Bill 2025 not only dominated last week's meeting of Parliament but will be the dominant feature driving Cayman's immigration policy for the foreseeable future.

Meant principally to rebalance current trends and practices in the labour market to the advantage of Caymanian nationals, the wide-ranging changes have also seen late-stage amendments to the original amendments and the introduction of new clauses.

And, there could be further changes ahead as Cayman grapples with the economically and socially delicate task of a 'managed migration' system that the pillars of its economy rely on. (Work permit fees - with increased rates and tighter oversight - are a key government revenue source from mainly financial services, tourism, construction, education and health sectors).

Cayman with its enviable first-world economy, finds itself in a dichotomy where expatriates make up more than half of the population, unemployment is trending at an equally enviable low of 2.9 per cent (where expatriates comprise more than half of the labour force), yet claims persist of Caymanians struggling to get jobs and struggling more to progress when they do get one.

The changes to the immigration laws are intended to correct that.

As was stated during the two-day session, "this is more than immigration reform, this is a reset".

This reset extends to how Caymanian citizenship is awarded to non-nationals

whether by extended length of stay and more stringent requirements surrounding marriage.

That 15 of the 19 members of Parliament voted in support of the measures across party lines is telling. It tells us that politicians have listened to voters who have told them what they've wanted over many years and elections. Four members of the main opposition were absent from the final Parliamentary vote; one due to a business conflict with the legislation, and another said to be out of the territory.

Immigration is one of the most divisive global issues of the modern era. It's an issue about borders that knows no borders. The Cayman case is more nuanced and complex in that while it's less about illegal immigration, the core issue is about managing the legal migration with its implica-



tions for 'jobs for Caymanians', the economy, culture and population growth.

Coming out of the landmark changes to the immigration law intended to 'reform and re-balance' the system to the advantage of Caymanians, a more delicate balancing act awaits. That will determine how Cayman itself navigates and manages the changes to what is expected to revert to the title of the original 1971 law (repealed in 2003) - The Caymanian Protection Law. The suggestion by Hon. Min. For Finance Rolston Anglin to consider the name 'Cayman Integration Law' as an

alternative has merit. Nuance matters in these delicate matters.

Also, with the governing coalition operating under the banner of the National Coalition For Caymanians(NCFC), and the Labour Ministry rebranded to the Ministry for Caymanian Employment and Immigration, a campaign promise will have been achieved.

It's now that the real work - especially that of the pre-coalition and equally-aptly-named Workforce Opportunities and Residency Cayman(WORC) - will begin, if this is to really work.

# CAYMAN'S ELECTION AND REFERENDUM OUTCOME 2025

In what was arguably one of the fastest government formations in recent political history, Cayman's newest government coalition was assembled within a day of the April 30th general election.

With a four-four-three formation - actually 4/4/1/1/1 - The Cayman Community Party(TCCP - 4 seats), Cayman Islands National Party (CINP - 4 seats) and three independents (Rolston Anglin, Jay Ebanks and Isaac Rankine) nailed down the majority needed to form the next government from the 19 seats in the Cayman Islands Parliament.

Their combined eleven seats pulled the rug from under the People's Progressives Movement(PPM/Progressives) which entered the campaign with what was widely seen as a winning strategy bringing in three members of the former United People's Movement(UPM) administration into their fold.

Despite securing seven seats with the inclusion of ex-premier UPM Juliana O'Connor-Connolly and two members of her then Cabinet; tourism minister Kenneth Bryan and Dwayne Seymour, early coalition overtures to others to obtain the additional three seats needed for a PPM/Progressives-led government did not materialise.

#### TCCP LEADS NEWEST COALITION

A joint statement following the commitment to form the coalition said: "This historic coalition will bring together dedicated leaders who share a common vision: building a Cayman that works for everyone. The group have confirmed they will be preparing and executing a coalition agreement which will specify the priorities, policies and projects to be adopted and completed during the 2025 administration, and this will include the Ministries that are intended. The intention of the group is to appoint an independent, non-elected Speaker."

TCCP leader Andre Ebanks assuming the role of Cayman's fifth Premier stated: "As coalition partners we are united in our commitment to form a responsible government that will work quickly to address the cost-of-living crisis, stabilise the country's finances, expand opportunities for Caymanians, and ensure sustainable development that benefits all our people. We have already begun productive discussions about how we will deliver the results our citizens demanded and deserve."

Gary Rutty speaking on behalf of the CINP added: "Yesterday, the people of the Cayman Islands voted decisively for hope. The results show a clear mandate for a new direction in our governance, with voters supporting candidates who pledged to put Caymanian interests first and tackle our pressing challenges headon.

Mr Rutty was tipped as the new coalition government's Deputy Premier. CINP leader Dan Scott failed to unseat ex-premier/UPM leader Juliana O'Connor-Connolly in the Cayman Brac East



constituency. Previously stating locally and internationally that she was retiring from politics, Mrs O'Connor-Connolly had a change of heart and contested the poll on the ticket of the opposition PPM/ Progressives, effectively relegating her then-UPM coalition to the political history books.

However, the outcome of the April 30th election means that the PPM/Progressives stay in opposition where she now joins them.

To date, there has been no further update on her political future.

Meanwhile, CINP founder and leader Dan Scott, although personally unsuccessful in his political debut, has nonetheless seen his new party in government in its first run.

He stated: "I am deeply grateful for the victories achieved by my fellow Cayman Islands National Party candidates. The overall election results present a diverse landscape and our focus remains steadfast on delivering on our promises and contributing constructively to the future of our nation. We are excited to build a government that prioritizes the needs of all Caymanians."

The swearing-in ceremony for the new TCCP/CINP/INDEPENDENTSx3 coalition government was scheduled for Tuesday May 6th as confirmed in a statement by Her Excellency, Governor Jane Owen shortly after meeting the coalition leaders who had confirmed that they had sealed the government deal.

"Mr Ebanks presented a letter confirming that he has the support of the majority of the parliamentarians who were elected at the 30th April General Election and that he intends to form the new Government. The letter includes a total of 11 signatures from elected representatives (inclusive of Mr Ebanks) supporting his leadership of a new Government with Mr Rutty as his deputy."

Governor Owens also affirmed: "I look forward to working in collaboration with the new Government. As Governor I will strive, along with the Deputy Governor and the whole public service, to support them in delivering their priorities and policies over the coming term."

#### PPM REMAINS AS MAIN OPPOSITION

With the PPM/Progressives destined to remain in the opposition benches, party leader Joey Hew issued what he framed as 'a message of unity and hope'.

At the same time, he questioned if the new government formation reflected 'the will of the people'.

"The election is over and the outcome shows that the PPM with 7, won the largest number of seats of all the parties; the CINP 4, TCCP 4, and the independents 4. Negotiations have once more chosen the government and not the will of the people. Sadly the country may find itself in the same position it was in after the 2021 elections with a marriage of convenience comprised of several mismatched partners."

Mr Hew went on to state: "As I return to the role of Leader of the Opposition, I promise you this: I will not stop fighting for the principles we believe in. You have my unwavering commitment that I will continue to serve, advocate, and champion the causes that brought us together in the first place."

The PPM/Progressives leader who was leading the party in an election for the first time, also said: "To our opponents, congratulations on your victory. I hope that you will govern with integrity, wisdom, and a commitment to the values that unite us as a nation. We may

have been divided in this contest, but the challenges ahead—building a stronger economy, ensuring equality, and safeguarding our future—demand that we work together."

#### **POLITICAL SHIFTS**

The new TCCP/CINP/INDEPEND-ENTSx3 is Cayman's fourth government formation in as many years; PACT (2012-2023), UPM-1(2023-2024) and UPM2-minority(2024-2025). The coalition leader TCCP was formed out of the departure of four members of the then UPM government of ex-premier Juliana O'Connor-Connolly. The UPM itself was created out of the remnants of the collapsed PACT coalition under then-premier Wayne Panton. Mr Panton contested the 2025 election as a member of the TCCP and was expected to take a backbench position. Ex-UPM premier Juliana O'Connor-Connolly ran with the PPM/ Progressives and will now sit with the party as an Opposition MP along with two of her ex-UPM (an ex-PACT) Cabinet members - Kenneth Bryan (now PPM/Progressives Deputy Leader) and Dwayne Seymour.

#### REFERENDUM OUTCOME

A three-question referendum was also held during the election vote on a proposed cruise pier, legalising gambling and decriminalising small amounts of cannabis.


Voters rejected the idea of the cruise ship pier but voted in favour of legalising gambling and decriminalising cannabis.

The vote on the cruise was a convincing 63.66 per cent (11,993) against - more than double those in favour at 28.75 per cent or 5,417.

The vote for a national lottery was closer with 50.76 per cent or 9,563 in favour against 41.24 per cent or 7,770 against.

The question of the decriminalisation of the consumption and possession of small amounts of cannabis won the 'yes' vote with 10,385 or 55.13 per cent in support against 36.11 per cent or 6,802 against.

The referendum also saw a concerning rate of rejected ballots: 1,262(6.70 per cent) on the cruise pier, 1,326 (7.04 per cent) on the national lottery issue and 1,474 (7.82 per cent) on the cannabis question.



#### MEDIA VETERANS ASSESS TOP PRIORITIES FACING CAYMAN'S NEW GOVERNMENT

As Cayman settles into the reality of a new government era, the pressure is on the National Coalition for Caymanians(NCFC) administration to hit the ground running.

That's one of the main takeaways coming out of a discussion between two media veterans on the Radio Cayman programme business buzz this past Tuesday.

Guest host, Orrett 'OC' Connor - regular host of the long-running popular morning talk show For The Record, and Ralph Lewis - publisher of Caymanian Times newspaper engaged in a thought-provoking postmortem of some of the key election issues.

Asked what should be prioritised by the NCFC administration, Lewis ranked the cost of living as top of the list.

"The number-one challenge, and it is very widely known, is the cost of living is too high. The cost of living has to be addressed," the former banker and financial advisor stressed. "Yes, we are living in an affluent society but there are many who are not affluent unfortunately, and there are people with good jobs but are just not making enough because the cost of living is just tremendously high, one of the highest in the world."

The cost of living was one of the main issues that dominated the election campaign with many candidates putting forward ideas - and promises - on how they would alleviate it.

With Cayman largely at the mercy of global trends and external policies such as the spin-off impact of trade and tariff policies elsewhere, Caymanian Times publisher Lewis urges the new government to focus their attention on this.





"How is it going to happen? The government needs to sit down and figure that one out," he stated underlining the scale and impact of the challenge for Cayman which is heavily reliant on imports.

Another pressing matter which was at the forefront of the election campaign is immigration reform, especially linked to concerns in some circles of a feeling of displacement by some Caymanians.

An indication of how seriously the new administration is taking this is reflected in the name it has adopted; 'The National Coalition For Caymanians', and the specific relabelling of the employment portfolio as the Ministry of Caymanian Employment and Immigration.

The immigration reform issue also came in for close attention on the Business Buzz exchange between Connor and Lewis. They agreed that it now needs to find its way into the policy priorities of the new NCFC government.

Balance is key, opined Lewis, reflecting on the nature of Cayman's economic success story especially in the financial and tourism services sectors.

"Based on the voters, it is clear that they require some sort of change to the immigration. The government is selected by the voters, so that has to be addressed. The way the Cayman Islands developed was with the help of expats," he observed, recalling his own experience of moving to the Cayman Islands over 40 years ago from Montserrat.

However, the newspaper publisher noted, "There has to be a balance."

"We can't just say, 'leave it as it is'. There needs to be some serious changes and it has to be communicated...We can't sideline our people."

It's a point on which talk show host Orrett 'OC' Connor concurs. "As we see, our population continues to grow, placing enormous pressure on our infrastructure, our schools, our medical services and everything else, so it's not going to remain stagnant."

Noting that previously the pushback on immigration reform has come mainly

from the business community, former senior civil servant Connor said that has now shifted. "Now, it's the voters who have been pushing for immigration reform. They have been promised it by the candidates, many of whom have been successful in the elections. So, what we have to look at now is their ability to deliver and their ability to stand up to that pushback that is going to come from the business community."

Well-known for 'having his fingers on the pulse of the community', OC Connor also observed a dichotomy between the profit motive within the business sector and preservation of Cayman culture and identity with a growing chorus of persons feeling that they are at risk of being marginalised.

"Immigration is going to be a big challenge and the promise was made that it is going to be addressed like yesterday," the veteran talk show show host observed.

It's a concern shared by Caymanian Times publisher Lewis: "That's why the government has a serious task on its hands," he said, again emphasising that "there has to be a balance" between the business model of the companies, the structure of Cayman's economy while at the same time, prioritising and preserving the unique qualities of Cayman's society and culture.

He said that balance must be struck between "keeping businesses here and looking after our people".

"Given the name - National Coalition for Caymanians(NCFC) - that's what they have said, I'm watching them. Everyone's watching them. They have to now live up to that."

## **HURRICANE MELISSA'S HEAVY TOLL ON JAMAICA**



Just days after being hammered by the ferocious onslaught of historic and deadly Hurricane Melissa, Jamaica is pledging not just to build back, but to build back better.

A new date has now been permanently etched in the country's history. October 28th 2025, Jamaica added another event not just to its, but also Caribbean and global meteorological history when powerful Hurricane Melissa slammed into the island with peak record winds of 185 mph. The country and the rest of the western Caribbean had been closely monitoring its slow, uncertain movement for several days before it rapidly escalated and exploded into a Category 5 monster weather system.

Hurricane Melissa which had eerily meandered off Jamaica's western coast for several days slammed into St Elizabeth parish in the western region of the country, slashing a swathe of destruction through the economically important tourism and agriculture area before exiting to smash into Cuba's south-east coast.

Much of St. Elizabeth's vital public infrastructure and services were knocked out, including hospitals, schools, electricity, water, communications, and roads, as well as private enterprises.

In the process of ripping through St Elizabeth, Hurricane Melissa literally shredded the popular Black River area, laying waste to just about everything in its path. A combination of vicious winds, torrential rainfall, massive flooding - not just from overflowing rivers, streams, but roads themselves turned into raging rivers - and a destructive storm surge bringing pounding waves from the sea deep inland.

It was a catastrophe of biblical proportions.

#### The aftermath

In the aftermath of the storm, Jamaica is counting the cost in both lives lost and property and infrastructure damage.

The death toll from Hurricane Melissa continues to rise with each passing day. At press time, it was being reported that more than 24 people had perished in Jamaica alone. The death toll from the storm including other affected areas, mainly Haiti and Cuba, was more than 40 and increasing.

Preliminary estimates of the scale of the destruction in Jamaica have been put at a whopping ballpark figure of around \$US20 billion including projected losses to the tourism and agriculture sectors, along with associated costs. It's said that the final calculation could amount to one third of Jamaica's annual gross domestic product(GDP).

Already, a massive national and global aid response is up and running for Jamaica, including the nation's extensive global diaspora, said to number around 1.2 million people. Jamaica's resident population is around 2.8 million.

#### Cayman lends a hand

The Cayman Islands Government(CIG) was among the first to respond, committing an aid package totalling \$US1.2 million, with 1,500 packages of emergency relief supplies valued at \$US200,00 already hand-delivered by a CIG aid mission led by Hon.Premier Andre Ebanks.

The United Kingdom, the United States, Caricom(Caribbean intergovernmental group of states), and many other countries are also coming to Jamaica's aid.

"The entire infrastructure and everything needed for the convenience of modern living is destroyed here," remarked Jamaica's Prime Minister Andrew Holness while touring the devastated St. Elizabeth after the storm.

But, he observed, "From what I have seen and the interaction, the people here are strong, resilient and positive in outlook."

#### Counting the cost of rebuilding

As Jamaica sets about the mammoth task of rebuilding, the country has been able to immediately activate its catastrophe fund investment, yielding \$US150 million for its recovery efforts.

Also, the Cayman Islands-based Caribbean Catastrophe Risk Insurance Facility (CCRIF) has announced that it will make a payout of US\$70.8 million to the Government of Jamaica following the passage of Hurricane Melissa. It's the largest single payout in CCRIF's history.

With Jamaica still coming to terms with the devastation caused by Hurricane Melissa, especially in the western areas, many parts of the country however escaped relatively unscathed. The government of Jamaica reports that efforts are underway to speed up relief supplies to those affected, amidst concerns of people becoming desperate and reports of looting taking place.

## CARIBBEAN ELECTIONS 2025: A YEAR OF POLITICAL DRAMA

An interesting trend has emerged in Caribbean elections this year.

In an overwhelming number of instances across the English-speaking Caribbean, winning parties have come close to obliterating the opposition. In cases where ruling parties have retained power, the opposition has been decimated and relegated to a severely reduced number of representatives - sometimes just one!

ST LUCIA(December): The ruling St Lucia Labour Party(SLU) of Prime Minister Philip J Pierre won a second term with an overwhelming 14 of the 17 seats, relegating the main opposition United Workers Party(UWP) to just one seat. The other two seats are held by independent MPs. Voter turnout was 48 per cent.

ST VINCENT AND THE GRENADINES (November): Of 15 seats at stake, the only seat not swept up by the (then-opposition) New Democratic Party(NDP) was that of now-ex prime minister Ralph Gonsalves of the Unity Labour Party(ULP). Dr Gonsalves seeking a sixth straight term as Prime Minister, was forced to hand over power to first time Prime Minister Godwin Friday(NDP). Voter turnout was 62 per cent.

GUYANA(September): President Dr Irfaan Ali led his People's Progressive Party/ Civic coalition (PPP/C) to victory consolidating its hold on power. Of the 65 seats in the National Assembly, they won 36. The new We Invest in Nationhood(WIN) grabbed 16 seats and pushed the previous opposition Partnership for National Alliance coalition into third place with 12 seats. The other seat was taken by the Forward Guyana Movement. Voter turnout was 58 per cent, down from 73 per cent in the previous election.

JAMAICA(September): The Jamaica Labour Party(JLP) under Prime Minister Andrew Holness secured a third consecutive term capturing 35 of the 65 seats, with the other 28 going to the opposition People's National Party(PNP). Voter turnout was an abysmal 39.5 per cent.

TRINIDAD & TOBAGO(April): Thenprime minister Keith Rowley had voluntarily relinquished his post just one month earlier to the relatively unknown Stuart Young who called elections in April. The main opposition United National Congress(UNC) back under the leadership of ex-prime minister Kamla Persad-Bissessar snapped up

26 of the 41 seats with the PNM only holding on to 13. The other two seats (in Tobago) went to the Tobago Peoples Party(TPP). Voter turnout was 54 per cent.

CAYMAN ISLANDS(April): Of 19 seats at stake in the April election, the main opposition People's Progressive Movement(PPP/ Progressives) secured seven but ended in opposition. The Cayman Community Party(TCCP) and the Cayman Islands National Party(CINP) - four seats each, along with three independents instead formed a coalition government with their 11 seats. TCCP's Andre Ebanks became Premier. PPP/Progressives and an independent MP form the opposition. Voter turnout was 73 per cent.

TURKS & CAICOS(February): Premier Washington Missick's Progressive National Party(PNP) held on to power with 16 of the 19 elected seats, two more than the

previous election. The other three went to the People's Democratic Movement(PDM). Voter turnout was 74 per cent.

ANGUILLA(February): New Premier and new leader of the Anguilla United Front(AUF) Cora Richardson led her party to a seven seat win in the House of Assembly, becoming that territory's first female leader. The other three seats went to the former ruling Anguilla Progressive Movement(APM) of ex-premier Dr Ellis Webster. Voter turnout was 60 per cent.

#### Meanwhile, elsewhere in the previous years...

In Barbados, the ruling Barbados Labour Party(BLP) of Prime Minister Mia Mottley again swept the polls in 2022 as it did in 2018 winning all 30 seats.

In the Bahamas (2021), the Progressive

Liberal Party(PLP) of Prime Minister Phillip Davis snapped up 32 of the 39 seats.

2018 saw the ruling Antigua and Barbuda Labour Party(ABLP) under Gaston Browne sweep 15 of the 17 seats, but lost six seats in 2023 holding on to nine to retain the government.

In Grenada, 2022 saw the National Democratic Party(NDP) under Dickon Mitchell bouncing back from a wipe-out in 2018, winning nine seats of the 15 seats to form the government.

In Dominica, the United Workers Party(UWP) boycotted the 2022 election giving the ruling Dominica Labour Party(DLP) of Prime Minister Roosevelt Skerrit having a supermajority of 19 of the 21 seats and extending its residence in office since 2004.

October 2024 in Montserrat, Reuben Meade came out of political retirement to guide his new United Alliance(UA) to power in a decisive victory over his former party, the then-ruling Movement for Change and Prosperity(MCAP). Meade, himself a former MCAP Premier, also defeated the opposition People's Democratic Movement(PDM) and brought the only victorious MCAP candidate into his government.

In the British Virgin Islands, the 2023 poll saw the ruling Virgin Islands Party(VIP) winning six of the 13 seats. The Progressive Virgin Islands Movement(PVIM) and the National Democratic Party(NDP) each won three seats, and Progressives United (PU) one. The VIP cemented its majority with the support of Lorna Smith of the ND-P(once led by her husband, ex-premier Dr Orlando Smith).

### FOUR FIREARMS AND ILLEGAL DRUGS INTERCEPTED BY CBC





The Cayman Islands Customs & Border Control Service (CBC) has intercepted four firearms, ammunition, and a quantity of illegal drugs during a recent border enforcement operation, preventing these items from entering the community.

On Thursday, 18 December 2025, CBC officers intercepted a shipment arriving from the United States during routine border control processes. Upon inspection, officers discovered four firearms, ammunition, and over three (3) pounds of ganja concealed within the shipment. Two individuals have since been arrested, and the matter remains under active investigation.

CBC confirms that, in relation to this seizure, there is no ongoing risk to the public, as the items were secured before entering circulation. Further details, including the type of firearms, concealment methods, and identities of those arrested, cannot be



disclosed at this time in order to preserve the integrity of the investigation.

Director of CBC, Bruce D. Smith, commended the officers involved, stating,

"CBC officers continue to demonstrate exceptional professionalism and vigilance. This interception underscores the critical role CBC plays in safeguarding our borders and protecting our communities. Our officers remain vigilant and continue to take decisive action against those who seek to introduce firearms and illegal drugs into the Cayman Islands."

Deputy Director Marlon Bodden, Head of the CBC Investigations Portfolio, added,

"This operation reflects the strength of our intelligence-led approach and the professionalism of our officers. Threats were identified and intercepted before reaching the public, which remains our foremost priority."

CBC continues to work closely with domestic and international law-enforcement partners to disrupt cross-border criminal activity and prevent firearms and illegal substances from entering the Cayman Is-

# Food waste recycling expands as major hotels join IWC/Beacon Farms programme

A pilot programme begun in 2023 between Foster's, Island Waste Carriers (IWC) and Beacon Farms to divert unconsumable food waste from the landfill is scaling up this month as new businesses sign up to the recycling programme that converts organic waste into compost.

Kimpton Seafire Resort + Spa, Seafire Residences, Indigo Hotel and Grand Cayman Marriot Resort are the latest additions to the programme, with food waste collections starting in November. They join Foster's supermarkets, The Ritz-Carlton Grand Cayman, Bonny Moon, Vida, Agua and Aria, and Montessori by the Sea school as organisations committed to separating food waste unfit for human consumption for recycling.

"At Seafire, caring for our environment is central to how we operate. Partnering with dedicated Caymanian partners like Beacon Farms and IWC strengthens our commitment to responsible waste management and a greener Cayman," said Yann Gillet, General Manager of Kimpton Seafire Resort + Spa. "We are also proud to support the essential work Beacon Farms is doing to advance food security and sustainable agriculture on the island. Together, we're ensuring our operations have a positive and lasting impact on the local ecosystem and community."

To date, the food waste recycling programme has diverted 256 tons of unsellable, unrecoverable and unavoidable food waste from George Town landfill. IWC collects and delivers the green waste to Beacon Farms' state of the art static aeration

composting facility in North Side, where it is mixed with brown waste such as yard trimmings and landscaping debris.

"Food waste typically accounts for around 24% of total waste in any landfill," said Jason Brown, Managing Director of Island Waste Carriers. "Even with careful inventory management, markdowns and donation programmes to non-profits like Meals on Wheels or the Food Bank, some food waste is unavoidable. Our food waste recycling programme is an example of how collaboration can deliver a real environmental solution."

Since the programme launched two years ago, Beacon Farms has produced 281 tons nutrient-rich compost to support agricultural production on the farm. With the success of the pilot programme, Beacon Farms is now expanding its compost facility, constructing more static aeration pads to triple the volume of materials processed on site.

"Next year, we expect to produce compost surplus to our needs and can start selling local compost to other farmers and landscapers," said Sandy Urquhart, CEO of Beacon Farms. "The programme would not be possible without a steady supply of brown and green waste and our partnership with the IWC team for collection and delivery. We are grateful to all our partners for committing to a recycling initiative that benefits farmers and the wider community."

## CAYMAN AND UK OFFICE FOR BUDGET RESPONSIBILITY EXPLORE COOPERATION

Cayman could be in line to benefit from closer collaboration with the influential United Kingdom Office for Budget Responsibility (OBR).

This comes out of discussions held in London between Hon. Minister for Finance & Economic Development Rolston Anglin and OBR officials during the annual Joint Ministerial Council (JMC) meeting in London between representatives of the UK government and the Overseas Territories.

According to an office, Cayman Islands Government(CIG) statement, during the meeting, which opened the door for future liaison, Minister Anglin outlined the current budgeting and forecasting process, which engages the Economics & Statistics Office in developing forecasts and estimates, as well as incorporating estimates from the



Revenue Unit - which like the OBR functions independent of the Government.

Min. Anglin said he was very pleased to engage with the OBR. Further, he was thrilled to know that they acknowledged that there were no gaps in our process. He requested involvement in any future conferences or professional development offered to their staff.

"I fully welcome any advice which helps us to further strengthen the robust estimates and forecasts currently provided by the Ministry of Finance as part of the biannual budget process. My goal as Minister of Finance is to make public finances as transparent as possible, and to ensure that the people who we serve have full trust in our projections and a full understanding of how the numbers support our policy aims to their benefit."

The meeting with the OBR was arranged by Her Excellency Governor Jane Owen to coincide with Mr Anglin's visit to the UK as part of the Cayman Islands delegation to the JMC.

The UK's OBR is an autonomous body set up in 2010 to provide independent and authoritative analysis of the UK's public fi-

This is the second part of our chat with Cultural Practitioner and PhD student Kerri-Anne Chisholm, who runs the unique art space, Gram Bella's, located in North Side, to find out more about past usage and her future plans for this brilliant community art spot.

Caymanian Times: Can you give us an idea of some of the events the space has been used for, so far?

Kerri-Anne Chisholm: The site's first activation was in 2023 for the Third Cayman Islands Biennial, through a project developed with creative and childhood friend, Latoya Francis. We focused on capturing community conversations on the unlikely but meaningful gathering spaces in North Side that no longer exist or function as they once did. As part of the project, we hosted a teen summer jam, a community conversation celebrating Emancipation Day featuring a reading from Dr Roy Bodden and performances by Nasaria and Randy Chollette and other creatives. We also received the Ministry of Culture's commitment to continue support the in-

tersection of creativity and heritage on

In May 2024, we showcased Iain Mac-Rae's series 'Another Young Caymanian' for Cayman Art Week. February 2025 marked our first formal dialogue (curated exhibition) 'Dialogue at Play', featuring Caymanian artist Iain MacRae and Jamaican artist Scott Braque. The works explored the tensions between childhood play and maturity and offered a glimpse of the beautiful intellectual and cultural possibilities between our two islands. We also launched a series of 'Netflix Nights', a series of screenings and discussions of niche, non-mainstream films, which paused over the summer due to the intense heat.

In spring 2025 we extended an open call for Cayman Art Week and hosted a diverse showcase of seven artists. To round out 2025, we held a worship night with open access to all and then opened the space to be used as a satellite venue for the Fourth Cayman Islands Biennial.

We also have some exciting projects in the pipeline for the months following the end of the biennial into 2026!

CT: Can you tell us more about how it was incorporated into the National Gallery's Archipelago Biennial?

K-A C: For the Fourth Cayman Islands Biennial 'Archipelago', the co-curators (Joseph Underwood and Davin Ebanks) have installed sculptural works by Stefan Langlois and Elizabeth Paige Smith inside the space. Individually their artworks pay homage to the Wreck of the Ten Sails and our inextricable connection to the land. The National Gallery is also organising a series of events throughout the biennial, including a wellness session on 17 January 2026 from 5 to 6pm.

During the biennial, visitors are invited to explore the artworks with 24-hour access to the space — interior lighting can be accessed using the switches located on the walls.

CT: What are your future plans for the space?

*K-A C:* I have several ambitions for the project space and the wider property. I am currently registering the space as a non-profit to strengthen its current position and future, and to formalise my commitment to our local and creative communities. A number of exciting projects are already in development, and long-term, I hope to see the entire property grow in ways that serve the community and foster a togetherness that feels authentic and reflect the hybrid nature of our islands.

CT: Anything else you wish to add?

Through dialogues (exhibitions), events, workshops and other activations, the space invites individuals to engage with art as a way of considering our contemporary local and global identities.

## Vet Vonn's return is snow joke

As sporting comebacks go Lindsey Vonn, 41, is in a class of her own. She qualified for the 2026 Milan Cortina Games, Team USA announced just before Christmas. It will be the fifth Winter Olympics that she competes in. They run from Feb. 6-22 in Italy. This is an amazing comeback considering her age and how long she was retired.

Vonn had an impressive run at the World Cup in France recently. She was third in super-G, hitting a high speed of 71 mph. It was her second consecutive podium finish after she was third in downhill. It was the 142nd podium finish in her World Cup ca-

Vonn became the oldest skiing downhill World Cup winner at St Moritz in Switzerland a month ago. She retired from the sport in 2019 because of knee problems but made her competitive return a year ago. She has collected one gold and two bronze Olympic medals in her career. She finished in one minute and 29.63 seconds - nearly a second quicker than second-placed Magdalena Egger - to wrap up her 83rd World Cup win and first since 2018.

Vonn seized skiing's oldest World Cup winner record from Switzerland's Didier Cuche, who had held it since victory in the super-G at Crans Montana, USA in 2012, aged 37. The oldest winner on the women's circuit was Austrian Elisabeth Goergl for her victory in the super-G at Val d'Isere, France in 2014, aged 33.

how these games end up, I feel like I've already won.

"I am grateful for how the season has gone so far, but I am just getting started. See you in Cortina!"

## Giannis bounces back but slams talk of leaving Bucks

Giannis kounmpo scored a game-high 29 points on his return from injury as the Milwaukee Bucks earned a 112-103 victory over the Chicago Bulls.

Antetokounmpo had missed eight games with a right calf strain, with the Bucks losing six of those matches.

The defeat for Chicago ended their fivegame winning streak, but they still sit ninth and two places above Bucks in the Eastern Conference.

After the game, however, Antetokounmpo shot down any talk of controversy about him and his future in Milwaukee. He said at a press conference: "I'm here. I'm here. I'm here. ## No West Indies batsman ranked in world's top 50

West Indies batting is so weak that there is not one batsman in the top 50 of the International Cricket Council's Test batting rankings following their disappointing performances in the recent Test series against New Zealand.

Shai Hope, who was the lone Windies player previously ranked in the top 50, has fallen 11 places to 60th and is the highest-ranked batsman from the regional team in the most recent ICC rank-

Hope, who battled an eye infection in the drawn second Test and food poisoning in the third and final Test, slipped out of the top 50 despite a decent series that saw him score 255 runs at an average of 42.50.

Justin Greaves, the regional team's highest scorer in the series with 283 runs at an average of 56.60, fell one spot to 62nd in the rankings despite his unbeaten double-century in the second

Former West Indies opener Kraigg Brathwaite, who last featured for the West Indies in July against Australia, is the next-highest batter at 65th.

In the bowling rankings, veteran pacer Kemar Roach, who had climbed to 18th after his impressive performance in the opening Test, dropped to 20th — one ahead of the injured Shamar Joseph who did not take part in the series.






