# Water Authority to Launch AMI Pilot Project

The Water Authority – Cayman is pleased to announce that it will launch an Advanced Metering Infrastructure (AMI) Pilot Project in February 2026.

The AMI Pilot Project is an important step toward modernising the Authority's water management systems and improving customer service. The project will evaluate two advanced smart metering technologies and assess the feasibility of remote meter reading under local conditions.

The results will guide future decisions about full-scale AMI deployment across the island. In the future, AMI technology will provide customer benefits such as faster leak detection and on-demand

usage insights.

The Authority is currently finalising the project's logistics—including technical setup and installation planning—and will share more details in the coming weeks. Customers selected to participate in the pilot will be contacted directly.

"Our investment in this pilot marks a significant step forward in providing enhanced services to our customers," says Dr Gelia Frederick van-Genderen, Director of the Water Authority. "By embracing advanced metering infrastructure, we aim to improve operational efficiency, strengthen system reliability, and deliver even better value to the people we serve."

# Applications open for Dart educational scholarships

The application window is open for young Caymanians demonstrating academic excellence and strong potential for future success to make their bid to become the next Dart Scholars.

High school scholarships are open to students preparing to enter Grade 9/Year 10 in the upcoming 2026/2027 academic year, while the William A. Dart University Scholarship is provided to assist the cost of earning a university-level degree at an accredited overseas institution.

Since 2011, Dart has invested more than US\$7.3 million across its educational programmes, with 46 Caymanian students receiving scholarships. Beyond financial support, Dart Scholars are given opportunities to develop themselves through structured career mentoring, targeted skills development and meaningful, hands-on work experiences that build workplace readiness and confidence as they transition from academic study to early careers.

"Dart's commitment to the Cayman community goes beyond today," said Glenda McTaggart, senior manager of education programmes at Dart. "We pride ourselves on being in a position to offer support to motivated high school and university students as they pursue their studies, build interpersonal skills and grow into confident young men and women. In turn, these are the people who will help ensure a stronger, more resilient future for generations to come."

## Dart high school scholarship

The Dart high school scholarship covers the full cost of school fees at a local institution of the recipient's choice for a period of four years, as well as additional funds for required textbooks and school uniforms.

Recipients also benefit from a well-rounded development programme that includes work experience placements during school breaks, dedicated

mentoring focused on career interests and the opportunity to participate in an annual enrichment trip abroad to visit universities.

Eligible students must be Caymanian, reside in and attend a high school in Grand Cayman or Cayman Brac, demonstrate a high level of academic achievement – particularly in science, technology, engineering and mathematics subjects – and are involved in school or community activities.

Applications are being accepted until 9 April 2026.

## William A. Dart University Scholarship

Recipients of the William A. Dart Uni-



versity Scholarship may receive up to US\$50,000 in financial assistance per

year, for a maximum of four years, while at university.

In addition to financial support, scholars are offered summer employment opportunities at Dart, providing hands-on experience and exposure to a professional working environment alongside talented industry professionals.


Eligible applicants must be Caymanian, between 17 and 25 years old and have resided in the Cayman Islands for at least four years prior to applying. Students must be accepted to a competitively ranked and accredited university and be prepared to commence studies in the upcoming academic year.

Academic requirements include a minimum of five higher level passes – including mathematics and English – or a cumulative high school GPA of 3.0 or higher.

Beyond academic achievement, interested students should demonstrate strong character, a solid work ethic, effective communication skills, a commitment to personal and professional growth and an active record of service to their community.

Applications are being accepted until 13 May 2026.

# Cancer Prevention, Treatment and Care a Top Priority

World Cancer Day is an international observation celebrated on 4 February to raise awareness about cancer, encourage its prevention, and mobilise action to address the global cancer epidemic.

"Cancer prevention, treatment and care is a top priority for me and the NCFC government," begins Honourable Katherine Ebanks-Wilks, Minister for Health, Environment and Sustainability (MHES). "As persons who are living with cancer, those who have survived it, and the numerous healthcare professionals, caretakers and family members impacted by cancer know, this work is year round. World Cancer Day provides us with an opportunity to focus on this specific issue holistically, and it is an optimal time to discuss what is being done and how it will serve our community in our fight against cancer."

The burden of non-communicable diseases (NCDs) in general, and that of cancer in particular, is both well known and felt within our community. Cancer is the second leading cause of death in the Cayman Islands after cardiovascular disease. The results of the STEPS 2023 National Health Survey, which provide nationally representative data for risk factors for NCDs, also provided important information relating to preventative action and access to care. For example, 32% of the population eligible for cervical screening (women aged 25-49 years) have never been screened, and only 30% of men between the ages of 18-69 report ever having a prostate exam.

"As we are committed to taking a data informed approach to the creation of policies, legislation and public health programming, the STEPS data has helped to shape the forthcoming National Cancer Policy, the updating of the Cancer Registry Bill, as well as specific public health campaigns, such as the HPV cancer prevention vaccination drive," Minister Ebanks-Wilks adds.

## NATIONAL CANCER POLICY

The National Cancer Policy, which is in its final stages of review and approval, outlines the national framework for the implementation, monitoring, evalua-

tion, and oversight of cancer screening programmes across the Cayman Islands. It adopts cancer quality standards and guidelines to establish standardised care pathways to guide practitioners and ensure consistency in the delivery of care.

"This policy will establish a clear national framework for organised cancer screening, quality assurance, and continuous improvement," explains Chief Medical Officer, Dr. Hilary Wolf. "The policy will be reviewed and updated as evidence advances, technologies develop, and local capacity grows."

"Our aim is simple: we want to ensure that wherever patients are getting treated, they are receiving timely and coordinated care from initial screening all the way through diagnosis and treatment," Minister Ebanks-Wilks adds.

## CANCER REGISTRY ACT

The Cancer Registry Act, which is in its initial drafting stages, will help to enable national collection of cancer-related data to inform cancer prevention, treatment and care within the Cayman Islands. A comprehensive, population based cancer registry would systematically capture in-

formation on cancer incidence, type, stage at diagnosis, treatment and survival.

"We do not currently have a national cancer registry," Dr. Wolf adds. "Without one, we cannot accurately measure incidence, track trends over time, or fully understand where prevention and early detection efforts should be focused. That is why establishing a national cancer registry is a priority for the Ministry. A registry is not just about numbers—it is about knowledge that saves lives. It allows us to guide policy, improve clinical practice, and ensure resources are directed where they are needed most. This will be done with the utmost respect for data protection, with strong privacy safeguards, clear governance, and public trust at its core."

"We all have stories about cancer," Minister Ebanks-Wilks says. "There is a perception in our community that the incidence of cancer in Cayman is high—above average high at that. Yet, we lack the data to be able to know for sure. The first step to taking meaningful action is understanding what exactly we are dealing with, and that is what this registry will provide us—the ability to take decisive action that can help to save people's lives."

Lastly, the Ministry continues its work to support the public health cancer prevention initiative through the community and school based HPV vaccination efforts. Human Papillomavirus (HPV) is linked to cervical, anal, penile, vulval, vagina and some types of mouth, throat, head and neck cancers. The HPV vaccine, which is heavily promoted in September and October each year as a partnership with the Cayman Islands Cancer Society and the Public Health Department, is actually available year round.

## STUDIES

"There are studies from countries with robust vaccination programmes, screening programmes and registries that show that the HPV vaccine is essentially erasing cervical cancer among those who have been vaccinated," explains Felicia McLean, Chief Nursing Officer. "As we work to strengthen our vaccination programme, standardise screening programmes and introduce the registry, we too will be situated to measure the real impact of the vaccine within our community. However, the global data is compelling and I continue to urge parents and young people to get vaccinated. The vaccine is available free of cost via the public health department and can be administered at schools upon request with written parental consent."

More information on the HPV vaccine, including the school vaccination programme, can be obtained from the Public Health Department on 244-2648.

"Our Ministry team has been working hard to modernise and strengthen the framework that will support all aspects of this work," Chief Officer Tamara Ebanks adds. "The National Health Strategy and Plan, for example, will pull together all cancer related work under a national workstream, as well as make connections with work relating to other non-communicable diseases (NCDs), care pathways, and standards of practice. Along with improving the overall quality of care, this work will reduce costs and the overall financial burden on not only individuals, but the nation as a whole."

# Young Caymanian Overcomes Cervical Cancer at 27

## *Shares Story of Faith and Resilience on World Cancer Day*

A 27-year-old Cayman resident is now cancer-free after battling stage 2B cervical cancer and is sharing her story of resilience and faith as World Cancer Day is observed on February 4.

Diagnosed on January 7, 2025, just weeks after being told she had only precancerous cells, Amy Connor underwent intensive treatment at Health City Cayman Islands, including radiation therapy, brachytherapy, chemotherapy, cold capping and supportive medications that caused significant physical changes.

"At 27, life was about building dreams, growing in my career and cherishing my family. Cancer was the last thing I expected," she stated. "When most people my age were dreaming of the future, I was fighting for mine."

The rapid progression shocked her. "In that moment, everything shattered. Suddenly, I wasn't thinking about tomorrow's plans, I was thinking about death, about my son, about how I had to fight to survive for him, and why this was happening to me," she recalled. "It is rare for someone in their 20s to be diagnosed with cervical cancer. My mind spiraled with questions — how much time do I have left? How did this progress so quickly?"

Cervical cancer is uncommon in women under 35, according to the American Cancer Society. It is most often diagnosed between ages 35 and 64, with an average age of 50.

Treatment days were difficult. "There were days I felt weak, scared and even unrecognizable," Connor said.

She drew strength from those around her: "Yet deep inside, I carried a calmness because I was holding on to my faith," she said. "I wasn't walking alone. I had God, my family, my friends, my amazing work family and, of course, the excellent doctors and nurses at Health City with me."

Health City Cayman Islands, a Joint Commission International-accredited hospital within the Narayana Health network, delivered her care across its East End Campus, Camana Bay Clinic and the Gene Thompson Radiotherapy Centre at Camana Bay. Health City offers oncology services including risk assessment, screening, chemotherapy, immunotherapy and advanced radiation, including brachytherapy for precise, high-dose treatment of locally advanced cervical cancer.

"Health City provided not only excellent treatment but compassionate care in everything they did and reminded me I wasn't just another patient — I was a person worth fighting and they were with me every step of the way," she said.

Her faith anchored the journey. "Above all, my faith in God kept me anchored. I prayed, I trusted, and I believed that He would see me through — and He did," she said. "I truly believe God didn't give me this disease, but He allowed it to come across my path to draw me closer

to Him, to give me a testimony, and to encourage others walking through the similar battles. Your life is worth fighting and surviving for. Hold on to faith."

Now, she embraces renewed life. "I see life differently now. Today, I can say with confidence: I am cancer-free. I'm back to exercising, playing with my son, laughing with those dearest to me, making memories with family and living the healthy, happy lifestyle I deserve," she said.

She encourages others facing cancer. "To anyone facing this fight, know this: you are not alone. Lean on your faith with God and never give up! Find someone or something that gives you strength to keep pushing forward," she said, encouraging others to surround themselves around other cancer 'Survivors, Thrivers and Alivers.'

"Cancer tried to stop my story but it did not succeed. By the grace of God, the unwavering support of my loved ones, and the extraordinary care of the Health City medical team, I am here and continue to move forward with gratitude and strength," she added.

Her recovery highlights the World Cancer Day 2025-2027 theme, "United by Unique," led by the Union for International Cancer Control (UICC). The campaign places people at the center of care, emphasizing individual stories to foster compassionate, personalized approaches to prevention, treatment and support while uniting communities for equitable cancer care.

warehouse to designated district drop-off points and operates every Tuesday and Thursday between 9:00 a.m. and 3:00 p.m. Deliveries on Tuesdays will cover Lower Valley to West Bay, while Thursday deliveries will serve Lower Valley to East End.

A flat delivery fee of CI\$25 per delivery applies. All orders and payments must be completed at least one day prior to the scheduled delivery. A minimum or-

der of more than one pallet is required, and only items currently available at the Department's warehouse are eligible for delivery.

Designated drop-off points have been established in Bodden Town, North Side, East End, and West Bay. Customers are required to collect their items using personal vehicles at the assigned locations.

Minister for Planning, Lands, Agriculture, Housing & Infrastructure, Hon. Johany "Jay" Ebanks, stated:

"This delivery service reflects our con-

tinued focus on strengthening local food production and improving access to essential agricultural inputs. By reducing logistical barriers for farmers, we are supporting a more resilient agricultural sector and reinforcing national food and nutrition security through practical, service-driven action." that enable domestic food production.

Director of the Department of Agriculture, Mr. Wilbur Welcome, said:

"The Agricultural Delivery Service is part of our broader efforts to improve ef-

ficiency and customer service at the Commercial Centre (originally known as Sales Warehouse). This structured approach allows us to better manage deliveries while providing farmers with a reliable and predictable service."

The initiative supports the Government's Food and Nutrition Security Policy by improving access to agricultural supplies and strengthening the operational conditions that enable domestic food production.

The Agricultural Delivery Service forms part of the Department of Agriculture's ongoing efforts to enhance operational efficiency and customer service at the Commercial Centre, formerly known as the Sales Warehouse. The structured delivery schedule supports improved planning and provides farmers with a reliable and predictable service.

The launch was marked by a visit from the Minister on the morning of 27 January, underscoring the Ministry's commitment to supporting the farming community through responsive and service-driven initiatives.

## Man Charged Following Incident near Seven Mile Beach

Police are currently investigating reports of a man behaving inappropriately, including instances of indecent exposure, in the vicinity of Seven Mile Beach, north of Raleigh Quay, during the month of January. In one such incident, it was reported that, on 21 January, a man exposed himself to a woman who was walking on a public path in the area.

Police conducted enquiries and, on Thursday, 29 January, arrested a man age 25, residing in George Town, in relation to the 21 January incident.

The man was subsequently charged with Idle & Disorderly Person, Penal Code (2024). He appeared before the Summary Court on Monday, 2 February, during which an interim Sexual Harm Order was imposed, placing strict conditions on the man, pending a further appearance on Tuesday, 24 February. Police enquiries continue.

## The Police Respond to Armed Robbery in Newlands

Around 8:00pm, Monday, 2 February, police responded to report of a robbery at a convenience store on Hirst Road. It was reported that two men entered the store and one of the men brandished a knife. The men stole a quantity of cash and fled on foot toward the rear of the building.

There were no injuries reported during

the incident.

The suspects are described as medium-built and wearing black clothes; one was wearing a red mask and red slippers.

## Man charged with Rape in Cayman Brac

A 31-year-old man who resides in Cayman Brac was arrested and formally charged with Rape following an incident that took place in the area of Cemetery Road in Cayman Brac on 31 January 2026.

It was reported that a man and another man, who are known to each other, were at the location sometime after midnight on Friday, 30th January, into the early hours of Saturday morning, 31st January, when the incident occurred.

The victim involved in the incident was transported to the hospital, where he was examined by the attending doctor and released.

The accused man was arrested on Monday, 2 February, and transferred to Grand Cayman, where he was formally charged and appeared in court today, 4 February. He was remanded in custody to reappear on Friday, 6th February.

The investigation into this incident is still ongoing, and police are encouraging anyone with information to call the Criminal Investigations Unit at 949-4222.

## Police Arrest Three for Robbery Incidents in Bodden Town and George Town

Police responded to two separate robbery incidents on Tuesday night, 3 February, one in the Savannah area of Bodden Town, and the other on Walkers Road in George Town.

The first robbery took place at a store on Hirst Road. It is reported that just before 8:30 PM, two men entered the store armed with knives and stole a quantity of cash and a bottle of wine before fleeing the location.

One suspect is described as of medium build, and the second suspect is described as slim. The police were also advised of a third suspect, described as female. She fled in the same area where the two men ran.

During the second incident that took place just before 10:00 PM, police arrested three persons in relation to an attempted robbery that took place at a store on Walkers Road.

It is reported that two men, wearing masks and armed with knives, entered the establishment and attempted to rob a cashier who resisted the perpetrators.

During the altercation, the cashier sustained injuries but was eventually able to escape, leaving the two male suspects in the store. Members of the public outside assisted by holding the door shutters closed.

Officers arrived on the scene shortly after the incident and arrested two men, ages 18 and 28, both from West Bay, along with a female juvenile who is also believed to be involved in the robbery.

The victim was transported to the hospital, where he was treated for serious but non-life-threatening injuries and later released.

As part of the investigation, the police seized a quantity of cash and an abandoned vehicle believed to be connected to the incident.

All three suspects remain in police custody as investigations continue. Police believe that these incidents are linked at this time.

Police would like to commend the actions of the store employee & the public who assisted, but would stress that personal safety should always be a priority.

# Registered Land (Amendment) Bill, 2026 Aims to Improve Transparency in Secured Lending

The Ministry of Planning, Lands, Agriculture, Housing & Infrastructure (MPLAHI) has confirmed that the **Registered Land (Amendment) Bill, 2026** was published in the Gazette on February 5, 2026, introducing targeted updates to Cayman's land registration and secured lending framework.

The Bill amends the **Registered Land Act (2018 Revision)** and focuses on improving clarity, transparency, and engagement in how secured loans over land are entered into and managed. The amendments place particular emphasis on owner-occupied residential properties and the steps that apply before enforcement action is taken.

At its core, the legislation is intended to ensure that borrowers receive clearer information before entering into secured lending arrangements, and that lenders and borrowers engage earlier and more constructively where repayment challenges arise.

#### Key features of the Bill include:

- clearer **pre-lending disclosure requirements**, helping borrowers better understand the terms and implications of secured loans before they are finalised;
- strengthened **pre-action engagement requirements**, encouraging communication and the exploration of resolution options before enforcement proceedings are pursued;
- clearer notice requirements where in-

#### terest rates change;

- updated provisions relating to **insurance, leasing, redemption rights, and powers of sale**; and
- more clearly defined processes for the sale of property where enforcement is required, including the use of recognised multiple listing systems supported by independent valuations.

The Bill also introduces clearer notice requirements, structured pre-action documentation, and defined timelines in cases



of default, supporting transparency, consistency, and procedural certainty for all parties involved.

Commenting on the publication of the Bill, the Minister for Planning, Lands, Agriculture, Housing & Infrastructure, **Hon. Johany "Jay" Ebanks**, said:

*"These changes are about clarity and fairness. They help ensure people understand what they are agreeing to, encourage earlier conversations when challenges arise, and set out clearer processes where action is required. This is about improving transparency while maintaining*

*confidence in Cayman's land and financial systems."*

The **Registered Land (Amendment) Bill, 2026** will come into force on a date to be appointed by Cabinet. Transitional provisions ensure that existing loans and transactions already in progress are not adversely affected.

# Published - Traffic (Amendment and Validation) Bill, 2026



The Ministry of Planning, Lands, Agriculture, Housing & Infrastructure (MPLAHI) has confirmed that the **Traffic (Amendment and Validation) Bill, 2026** was published in the Gazette on February 5, 2026.

The Bill amends the **Traffic Act (2023 Revision)** to clarify key statutory definitions and to validate certain administrative actions taken by the Director of Licensing,

ensuring legal certainty, consistency, and continuity in the application of the law.

#### Purpose of the Bill

The Bill has two primary objectives:

- to clarify the legal definition of a pedal cycle under the *Traffic Act*; and
- to validate specific fees previously charged and collected in relation to vehicle registration plates, where those fees

were imposed in good faith.

#### Key highlights of the Bill include:

**Clarification of "pedal cycle"**

The Bill amends the definition of pedal cycle by removing references to speed. This provides a clearer legal distinction between pedal cycles and other motorised vehicles, supporting consistent classification and enforcement under the Traffic Act.

#### Validation of registration plate fees

The Bill validates fees previously charged and collected by the Director of Licensing for the provision of single registration plates and single trade plates for motorcycles and trailers. This confirms the legality of those administrative actions and removes uncertainty surrounding past collections.

#### Protection of court decisions

The validation provisions expressly preserve the effect of any court orders already made, ensuring that judicial decisions remain unaffected by the amendments.

#### Continuity of administration

By validating past actions and clarifying statutory definitions, the Bill supports the orderly and uninterrupted administration of vehicle licensing and registration services.

#### Road safety governance context

Legislative clarity within the Traffic Act supports the broader objectives of the National Road Safety Strategy (NRSS), which relies on clear, enforceable laws to support consistent regulation, education, and enforcement. The National Road Safety

Committee (NRSC), which oversees implementation of the NRSS, continues to emphasise the importance of a sound legislative framework as a foundation for safer road use across the Cayman Islands.

Commenting on the publication of the Bill, the Minister for Planning, Lands, Agriculture, Housing & Infrastructure, Hon. Johany "Jay" Ebanks, said:

*"This Bill brings clarity where it is needed. It confirms actions taken in good faith, strengthens certainty in the Traffic Act, and supports the consistent administration of vehicle licensing and registration across the Cayman Islands."*


Mr Eric Bush, Chief Officer for the Ministry of Planning, Lands, Agriculture, Housing & Infrastructure and Chairman of the National Road Safety Committee, said:

*"Legislation must continue to evolve to remain effective. Clear law supports consistent enforcement. When definitions are precise and administrative processes are legally sound, the system works more effectively and road users can have confidence in how the law is applied."*



## EPSTEIN SCANDAL ROCKS UK POLITICAL LEADERSHIP

British Prime Minister Sir Keir Starmer is in a desperate fight to retain his job as the fallout from the American Epstein Files scandal rocks his leadership.

Although not directly implicated in the Epstein saga, Starmer finds himself at the center of controversy over his decision to appoint Peter Mandelson as Ambassador to the United States, despite knowing of the now high-profile ex-ambassador's close association with Epstein.

Despite sacking Mr Mandelson soon after the Epstein connection emerged, the extent of their friendship only became public with the latest batch of the so-called Epstein files released by US authorities.

British police are now also investigating allegations that Mandelson may have shared sensitive UK trade information with Epstein while he served as Business Secretary during the 2008 global financial crisis.

A clearly infuriated and distressed Mr Starmer is now under pressure from within his own party over his judgement in proceeding Mandelson's appointment to the influential ambassadorial position.

Facing one of the toughest moments in

his tenure during this past week's weekly Prime Minister's Questions (PMQs) in the British Parliament's House of Commons, Mr Starmer repeatedly voiced his regret over the appointment.

He said Mandelson had "betrayed our country, our parliament, and my party". He accused his former top man in Washington of lying repeatedly about his close ties to the deceased, disgraced financier and convicted paedophile Jeffrey Epstein.

"All appropriate steps had been followed; had anyone known what we

know now, he would never have been anywhere near government," the Prime Minister said on Wednesday.

Starmer had fired Mandelson last September, when information surfaced showing that the former ambassador had retained close personal ties with Epstein even after the financier's conviction in 2008 on sex crime charges.

Mandelson, who has also served as UK Business Secretary and European Commissioner for Trade, and was elevated to the UK House of Lords as a life peer, was only in the Washington job for

seven months before he was sacked by Starmer.

Just last week, amidst pressure on the Prime Minister to withdraw his Labour Party membership, Mandelson voluntarily stepped down from the party and also avoided the ignominy of being thrown out of the House of Lords by also choosing to give up that position. There was an ongoing discussion over the process to remove the associated title from him, which is subject to complex procedures and traditions.

Meanwhile, the pressure continues on Mr Starmer over what many critics in the Opposition and within his own party question as his poor judgement in appointing Mandelson, with some accusing him of prioritising political pragmatism over personal principles.


It's being said that despite knowing enough of Mandelson's connections with Epstein when he appointed him, Starmer persisted with the decision. According to some reports, he was persuaded that Mandelson was the best choice to navigate relations with the notoriously unpredictable American president, Donald Trump.

This latest threat to Prime Minister Starmer's leadership follows what's widely seen as him dodging another recent potential internal leadership challenge.


